DESCRIPTION

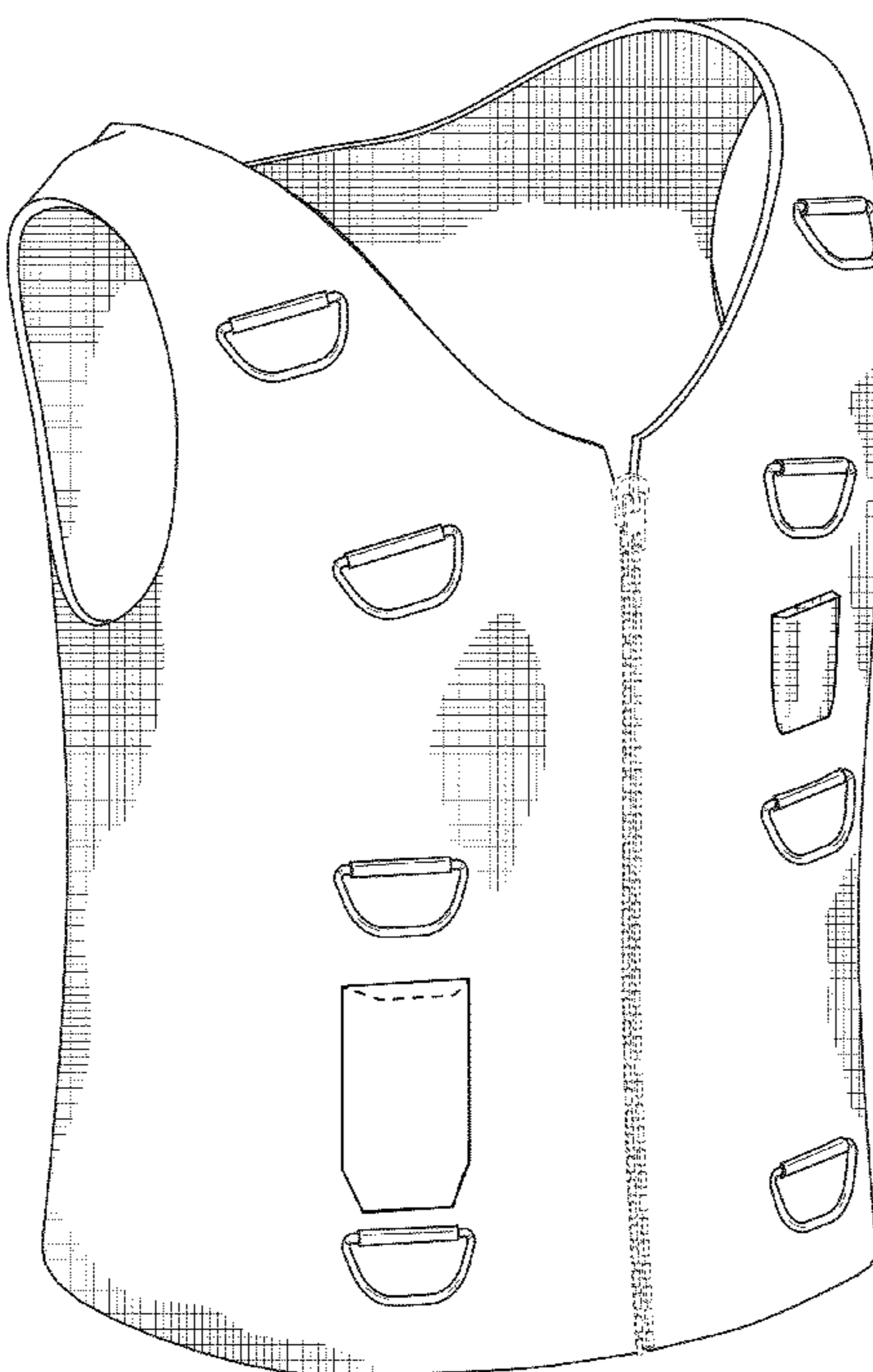
FIG. 1 is an isometric view of an exercise vest with stretch cord attachment means;

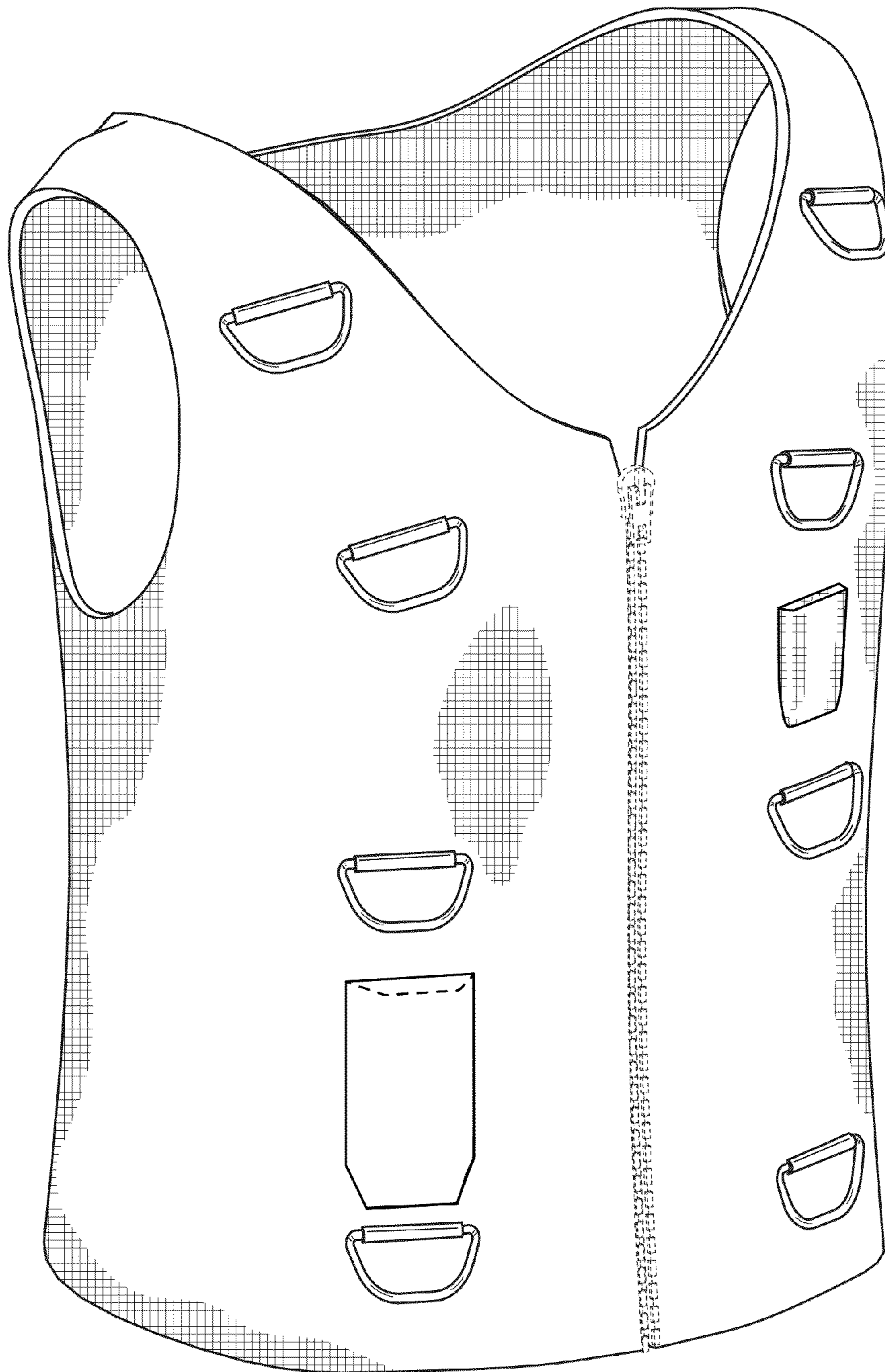

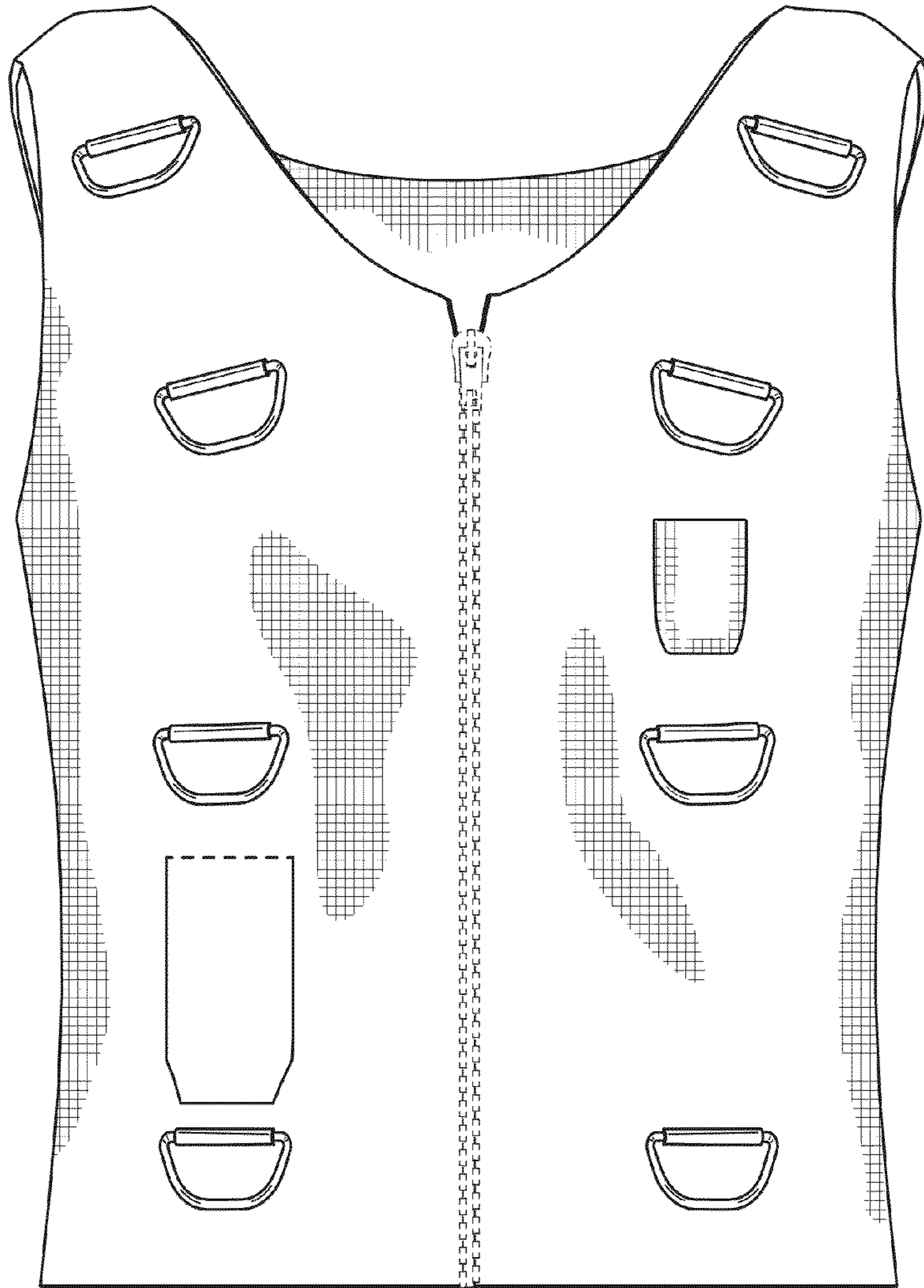

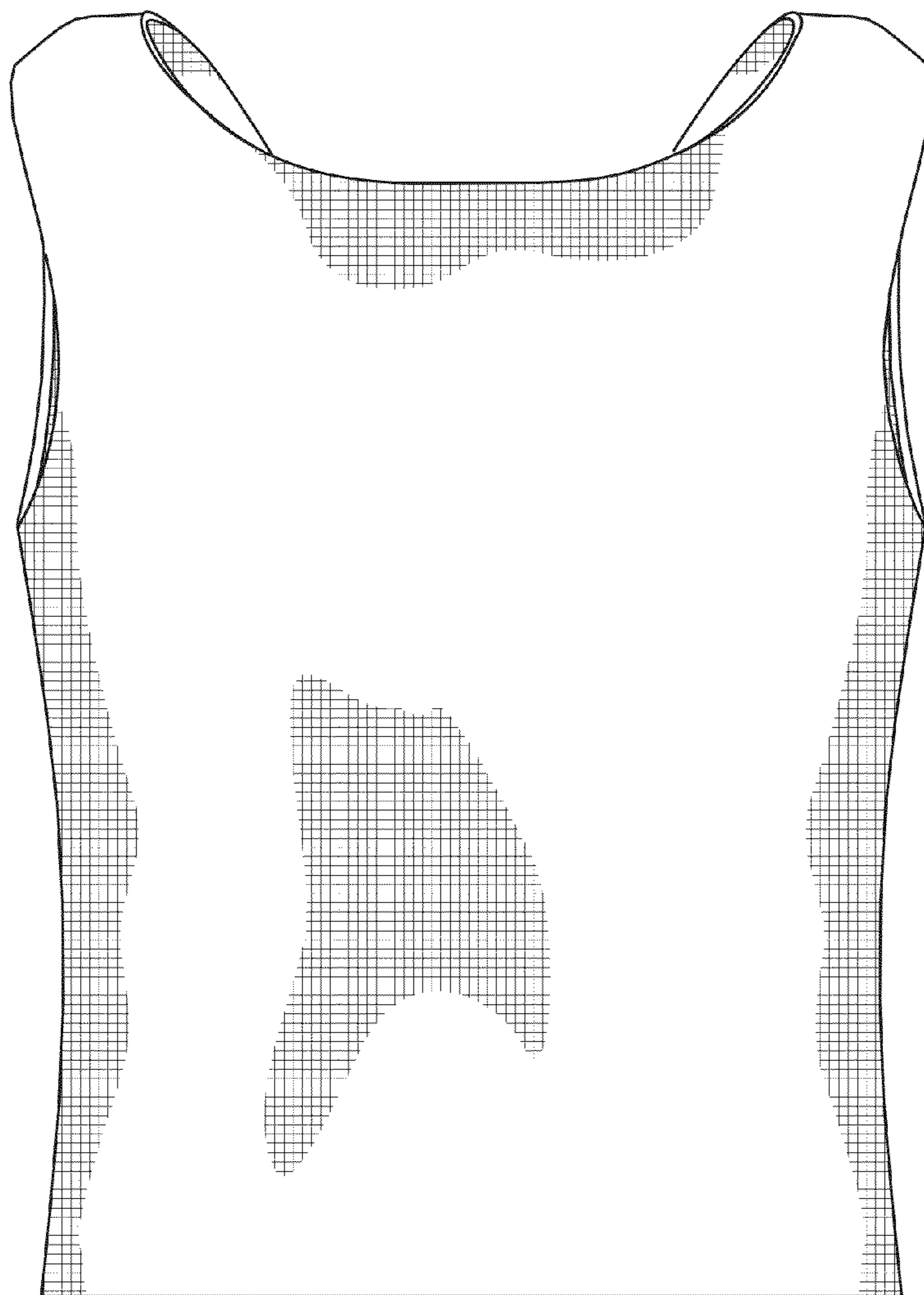

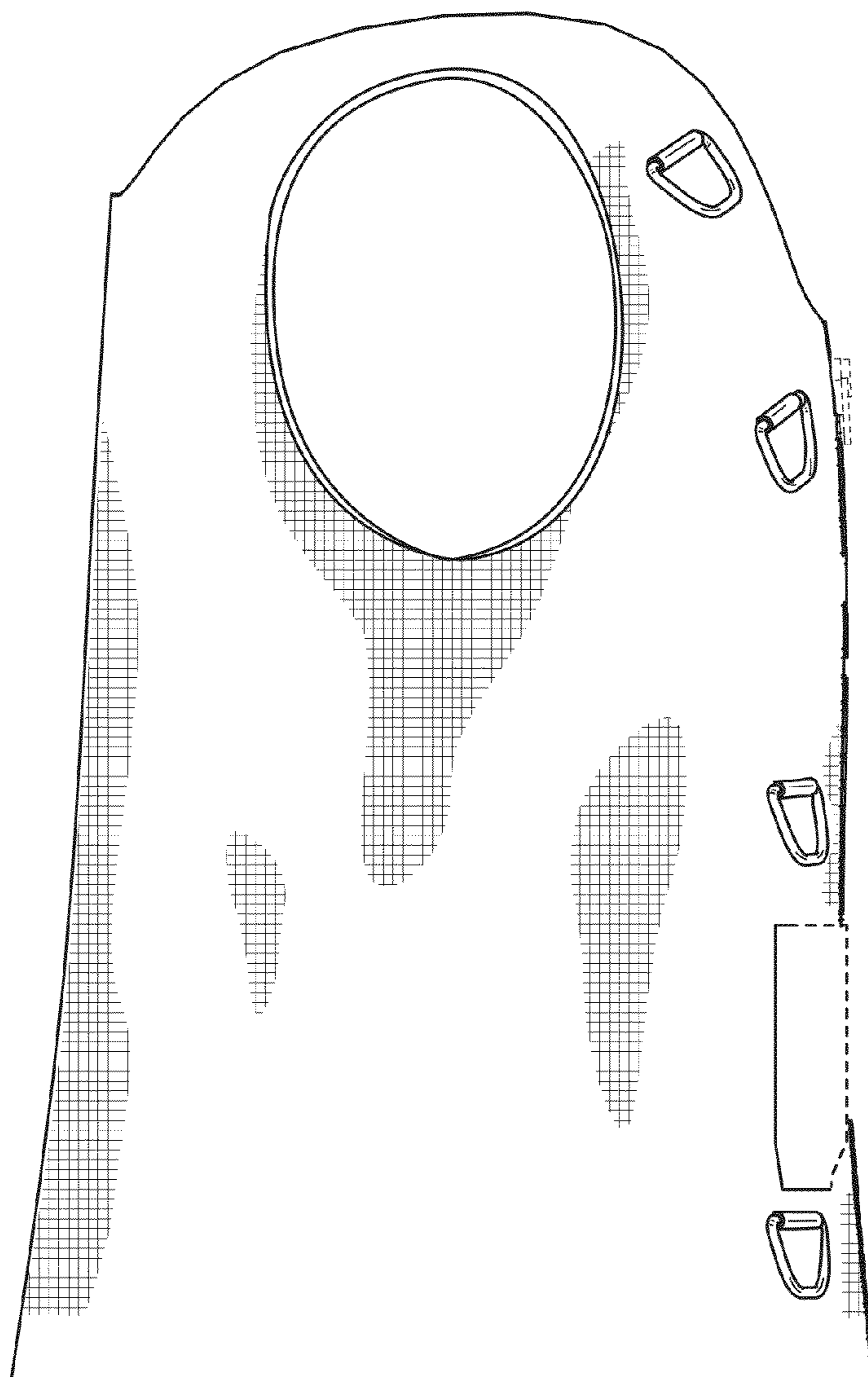

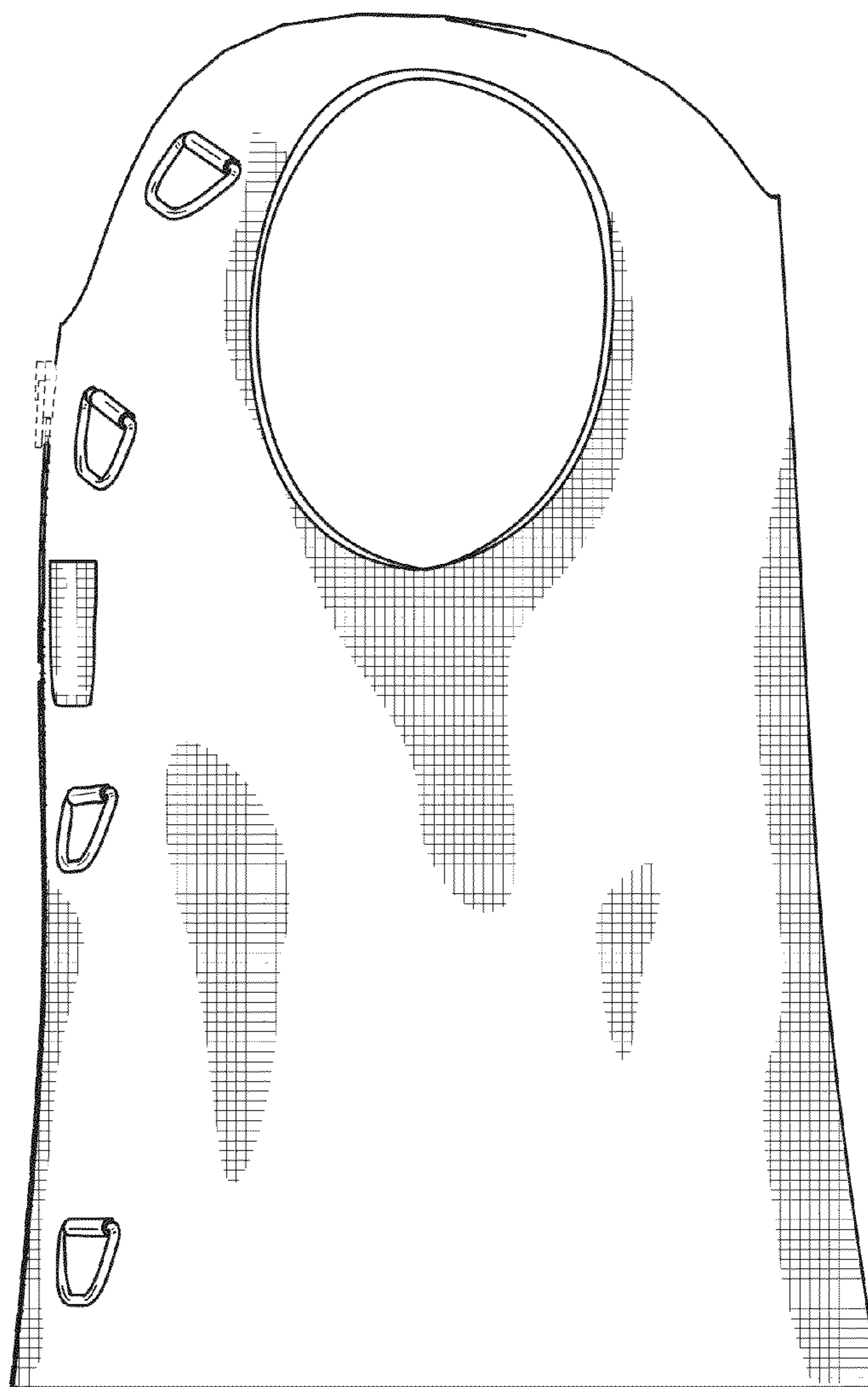

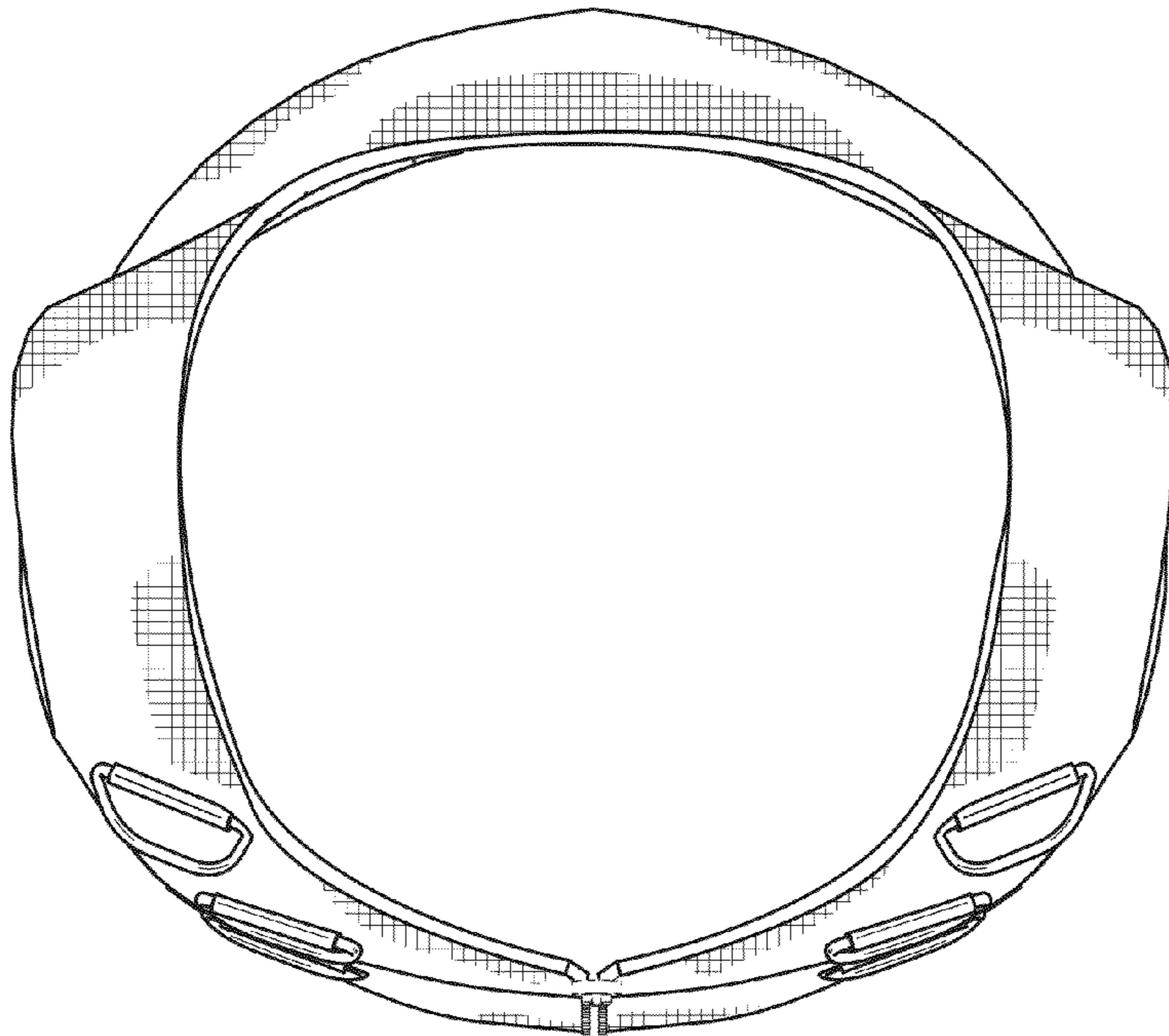

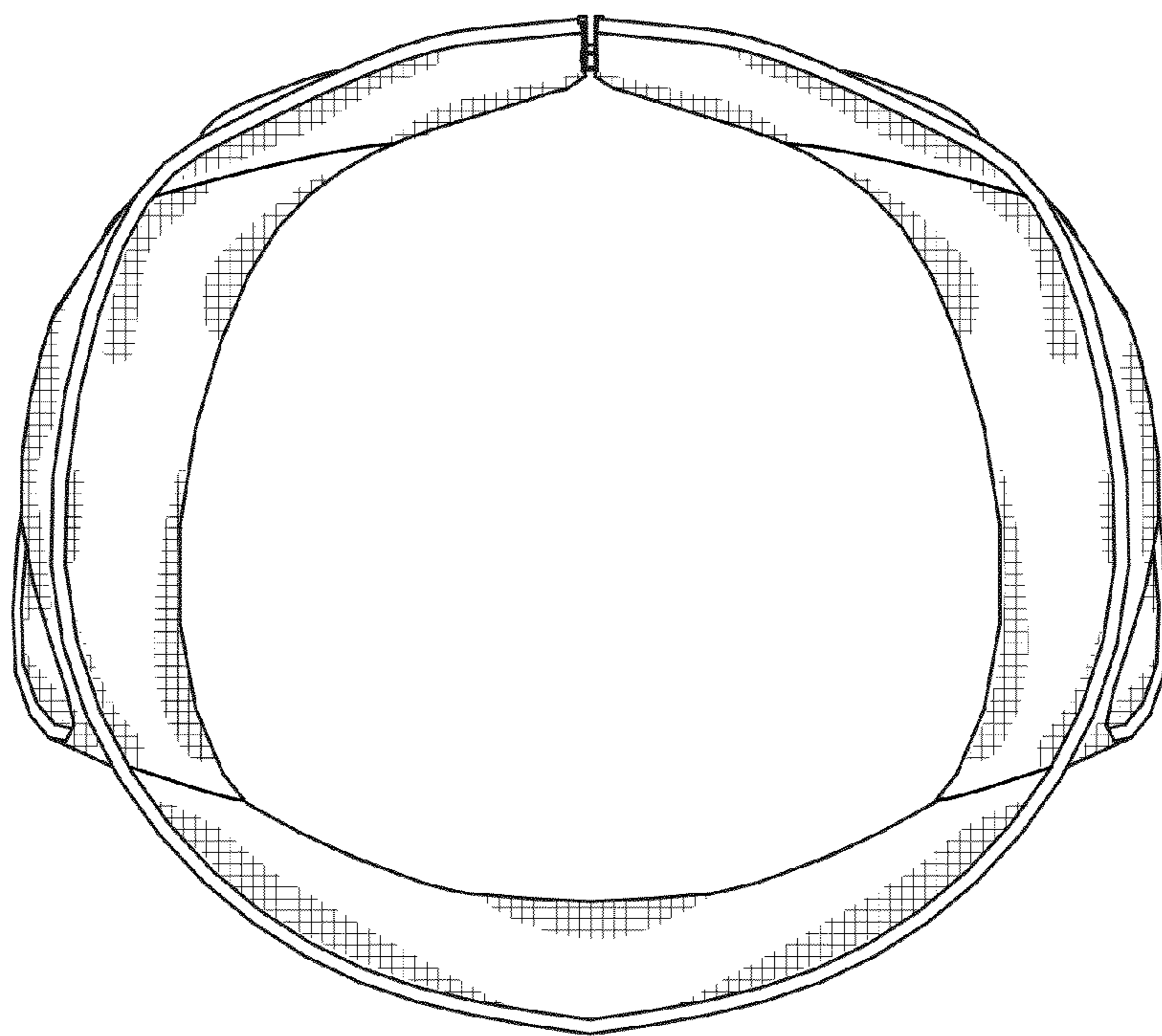

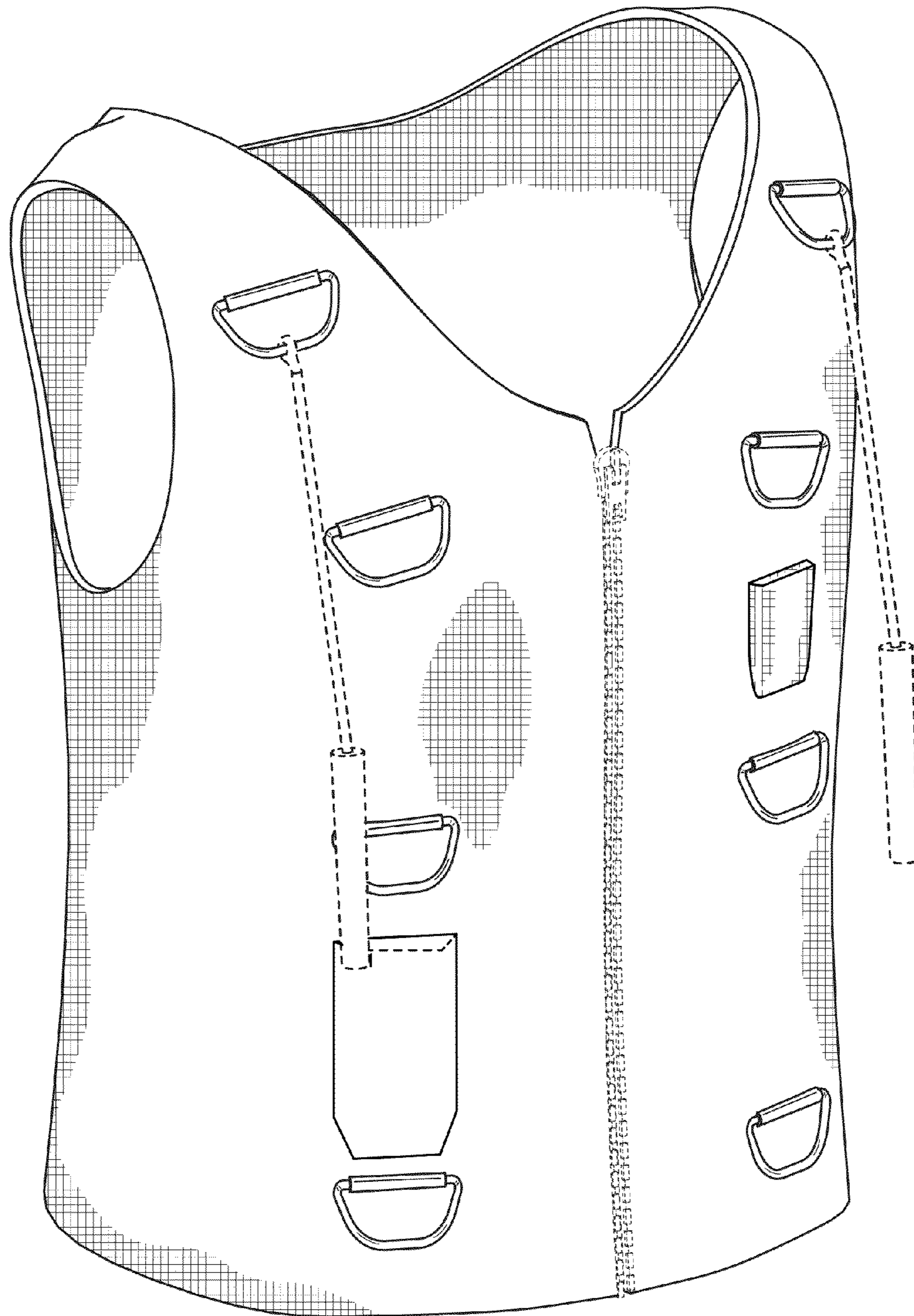
