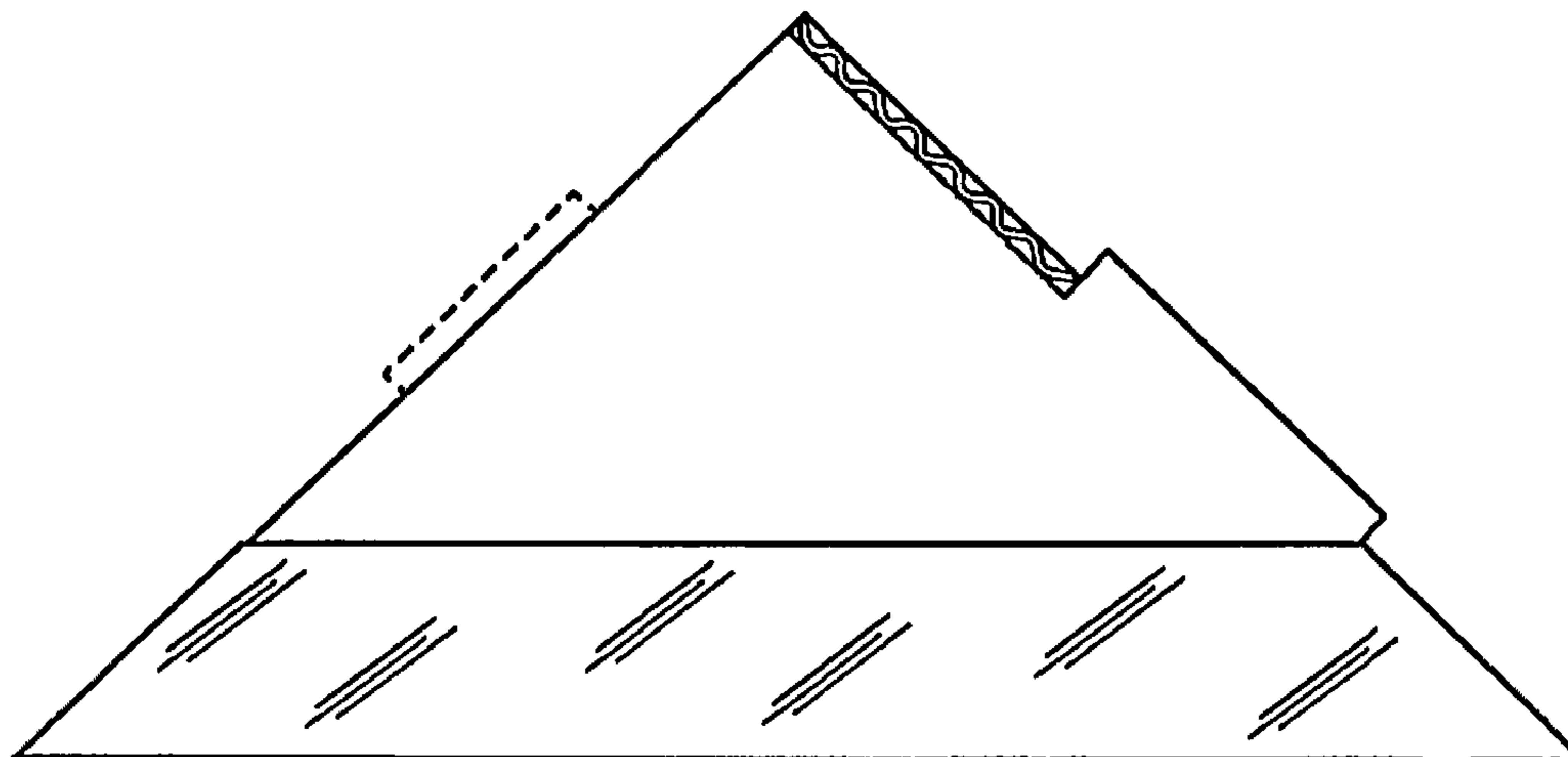
(57) **CLAIM**

The ornamental design for a vaporizer for tobacco, medications, and the like, as shown and described.

DESCRIPTION

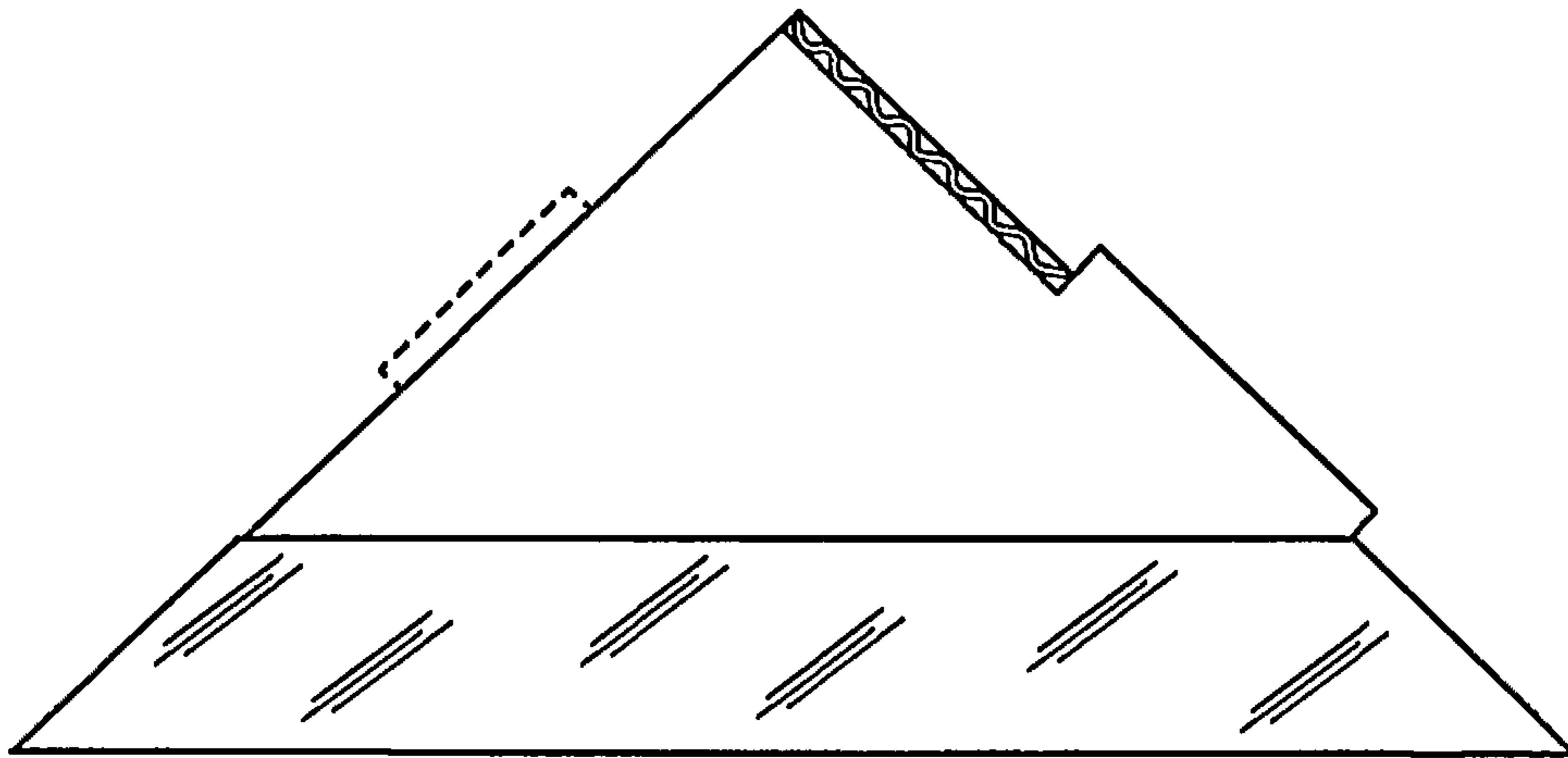

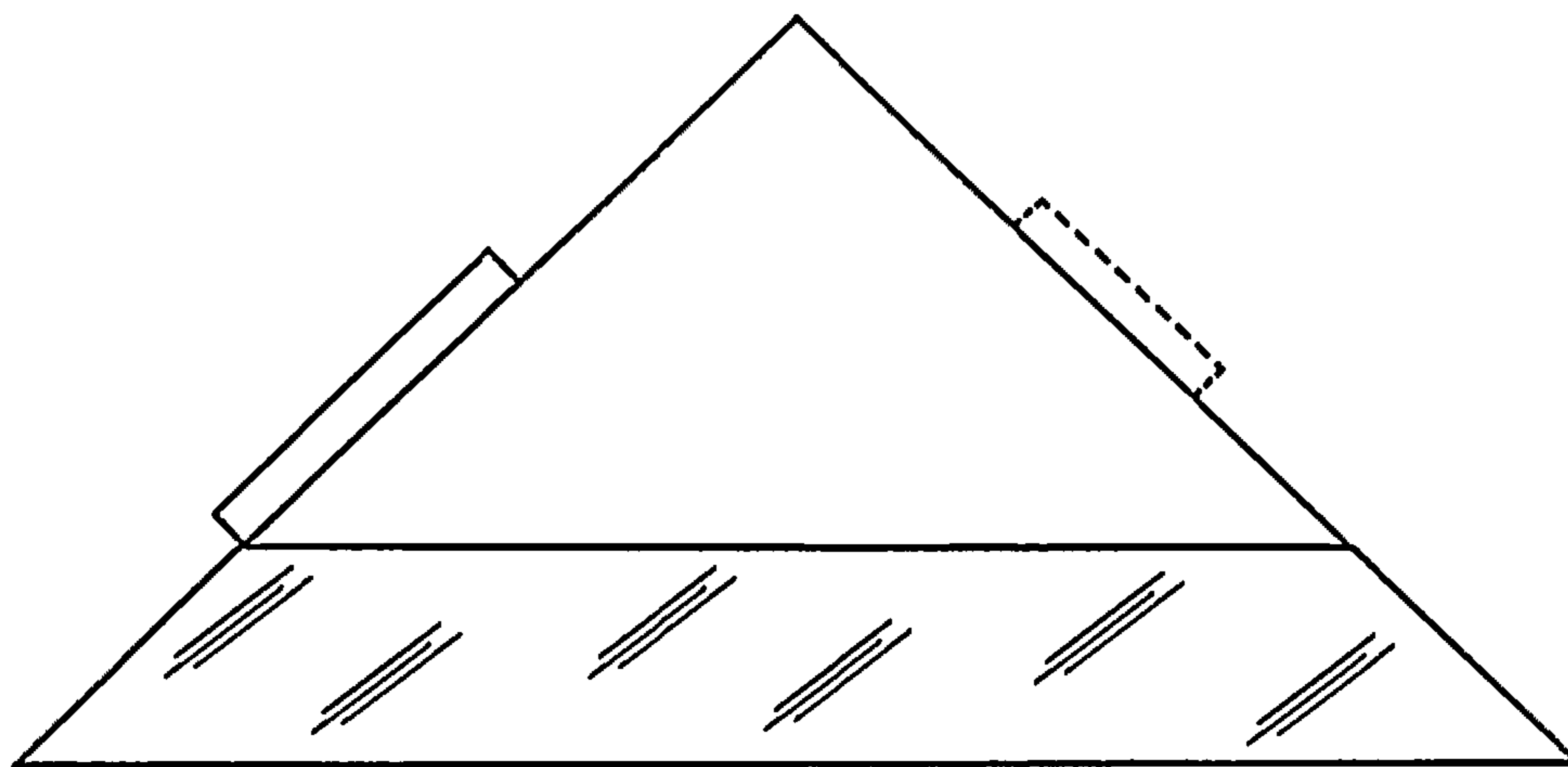

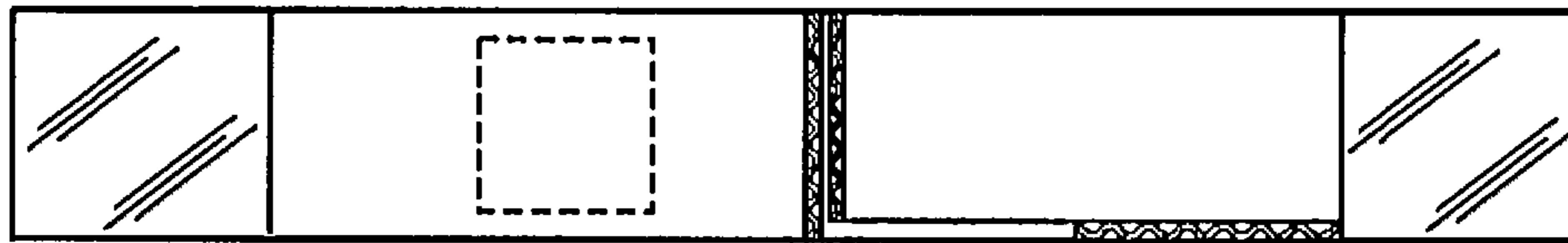

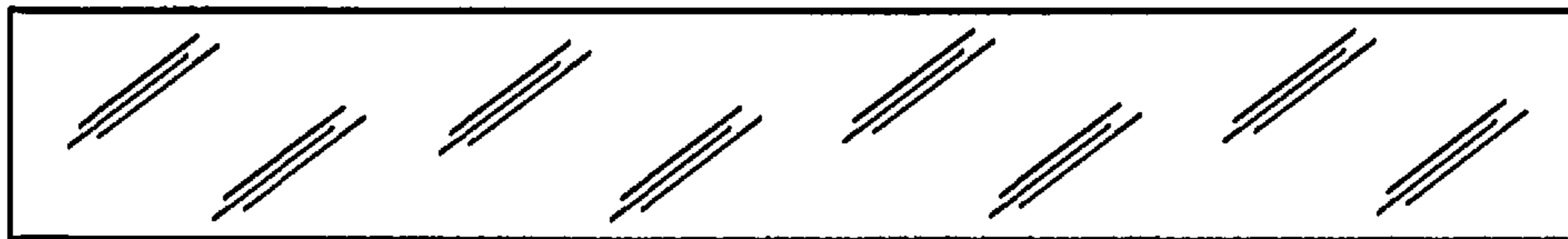

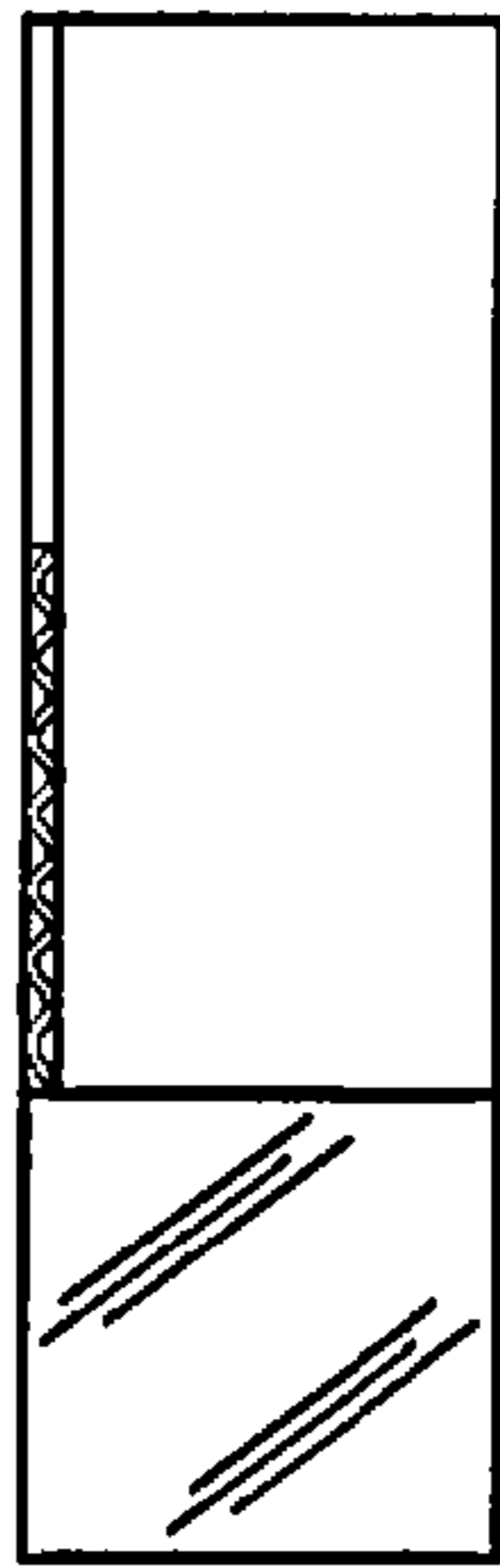

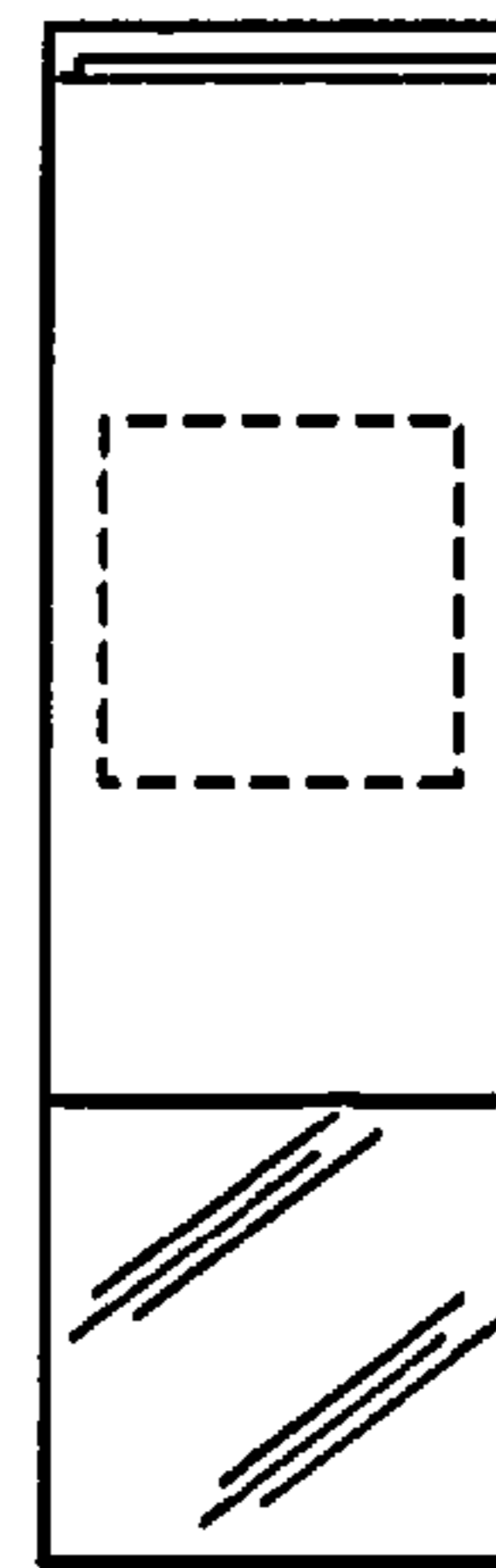
