**DESCRIPTION**

FIG. 1 is a perspective view of a combined milling tool and attachment for a surgery instrument for prosthetic surgery operations;

FIG. 2 is a left side view thereof;

FIG. 3 is a front view thereof, the rear view being a mirror image of the front view;

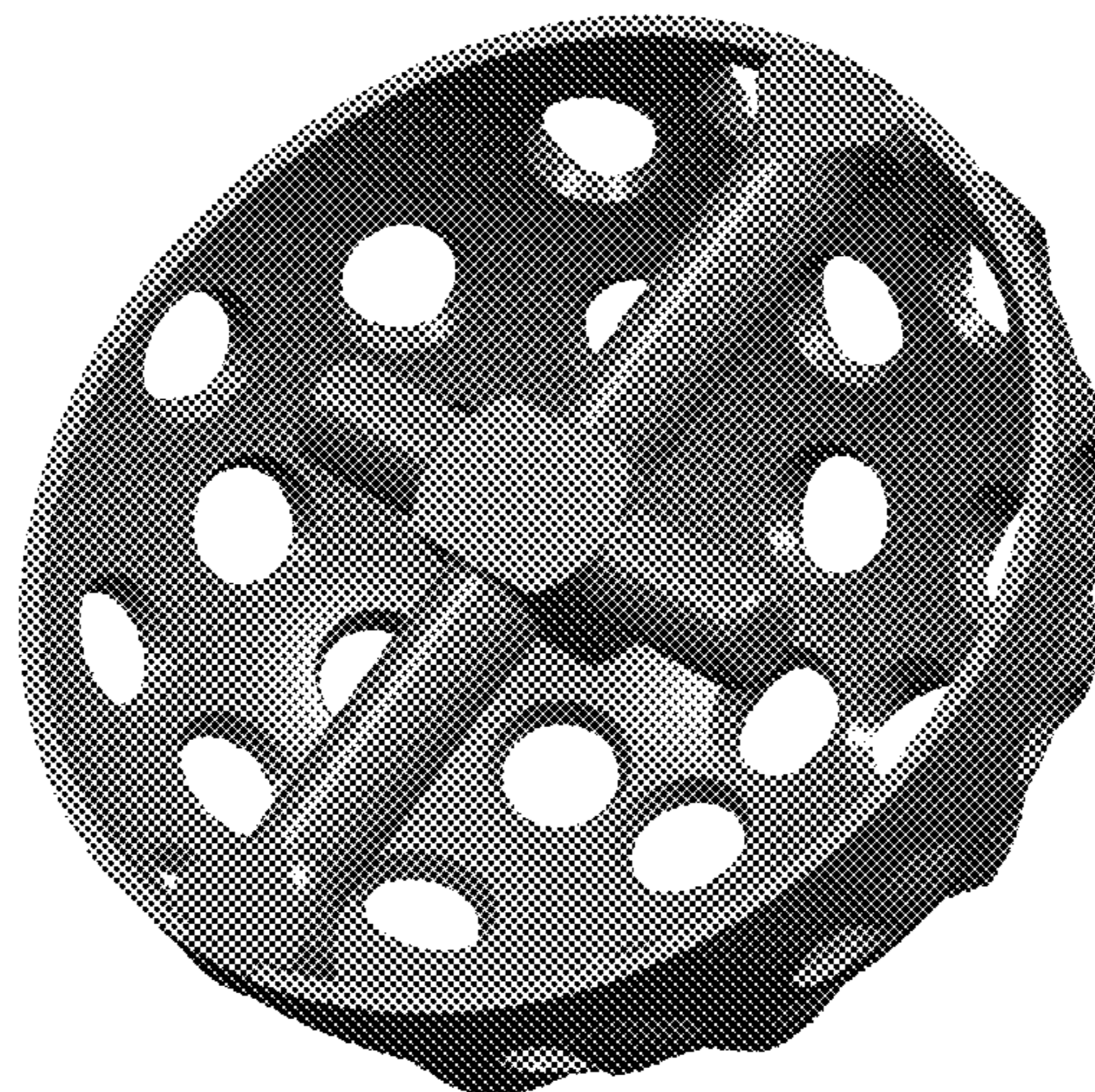
FIG. 4 is a right side view thereof;

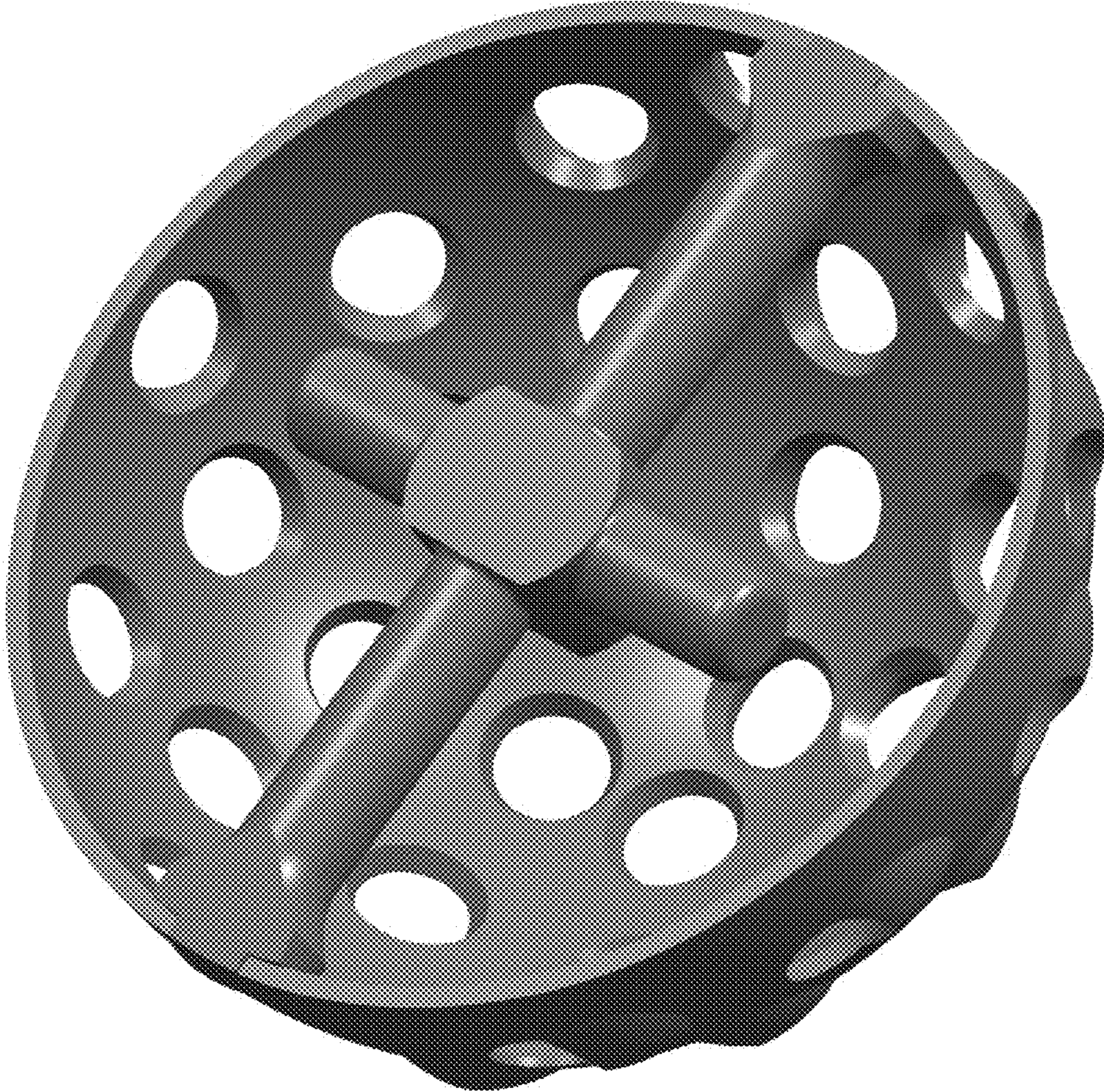

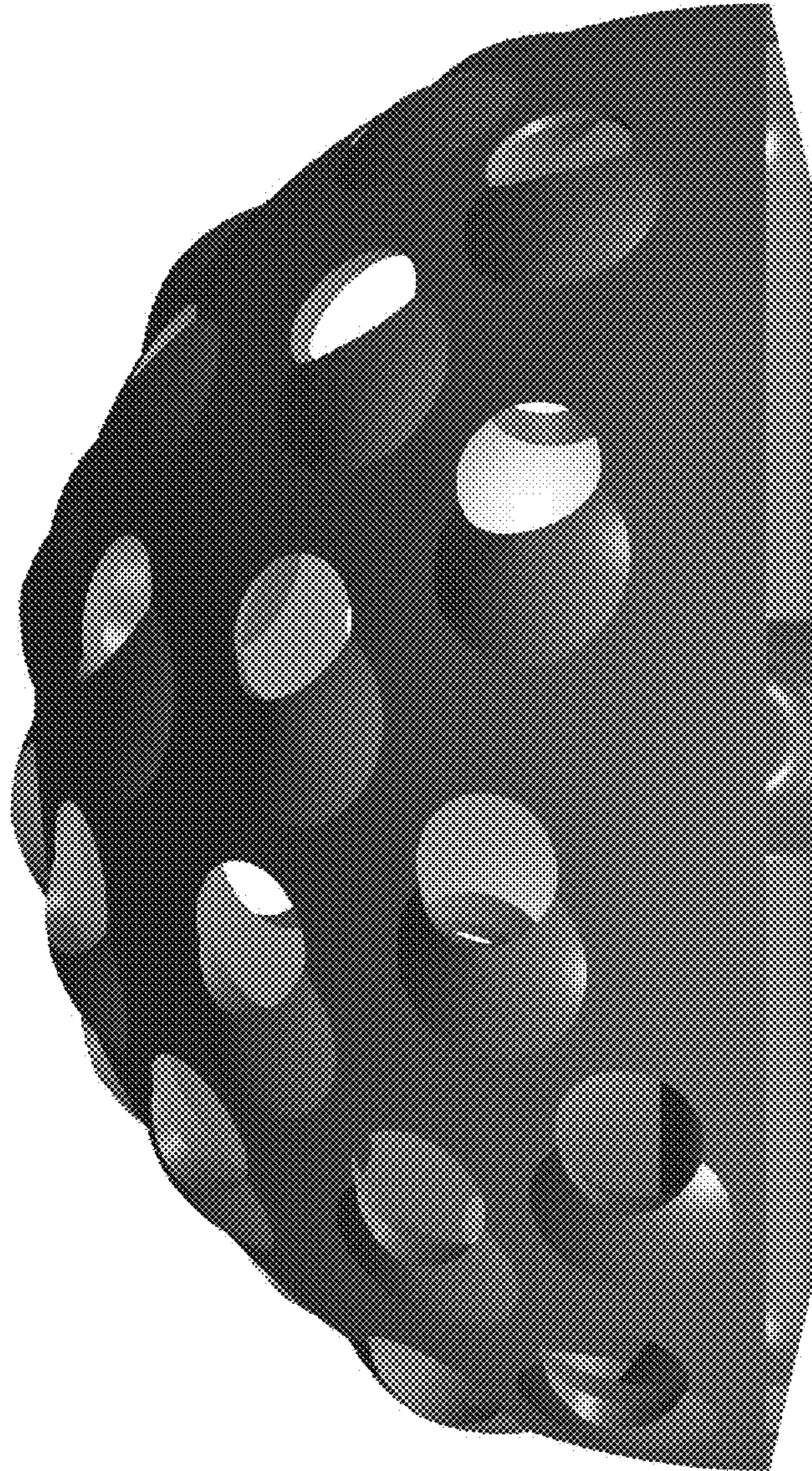

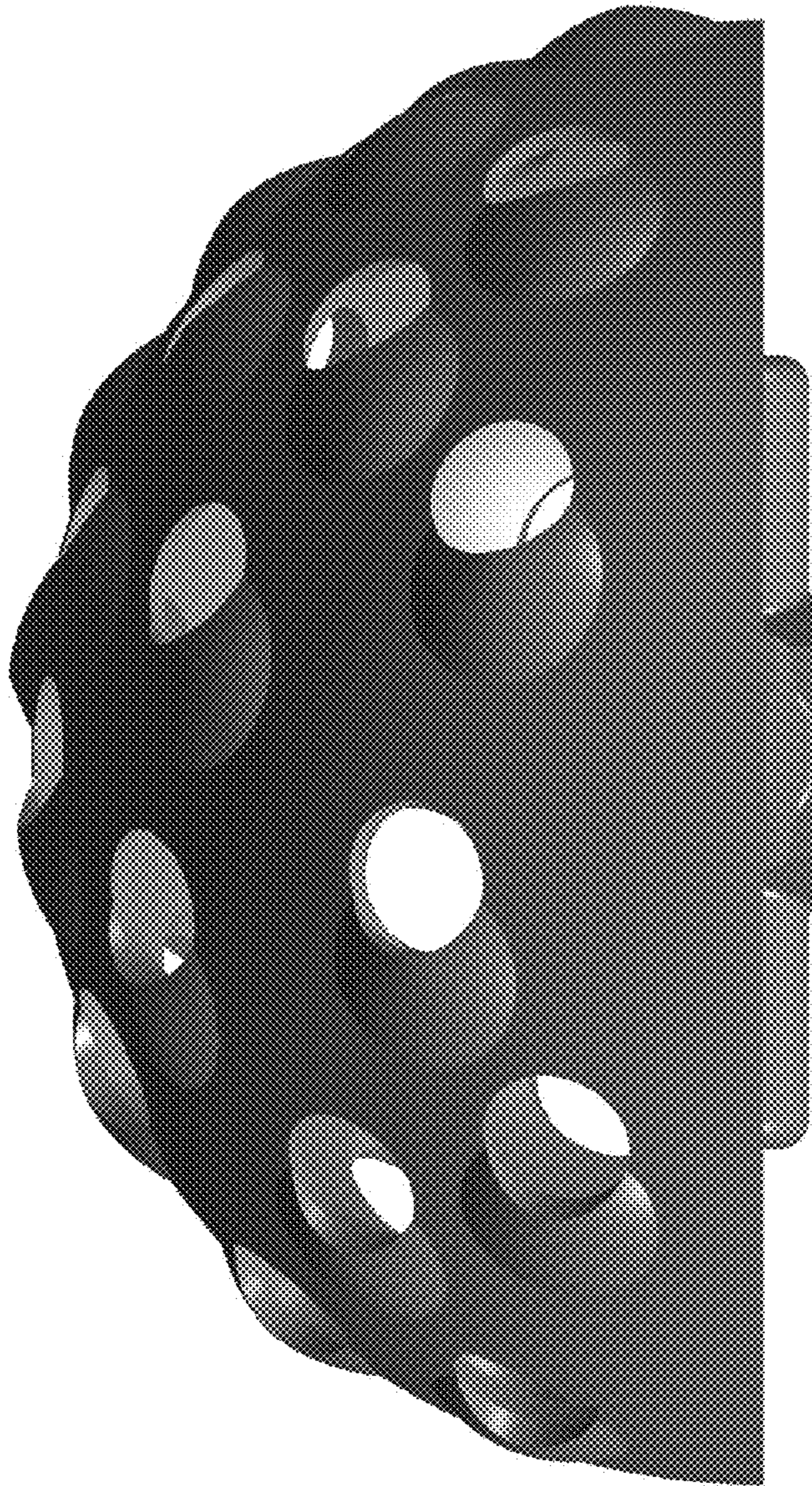

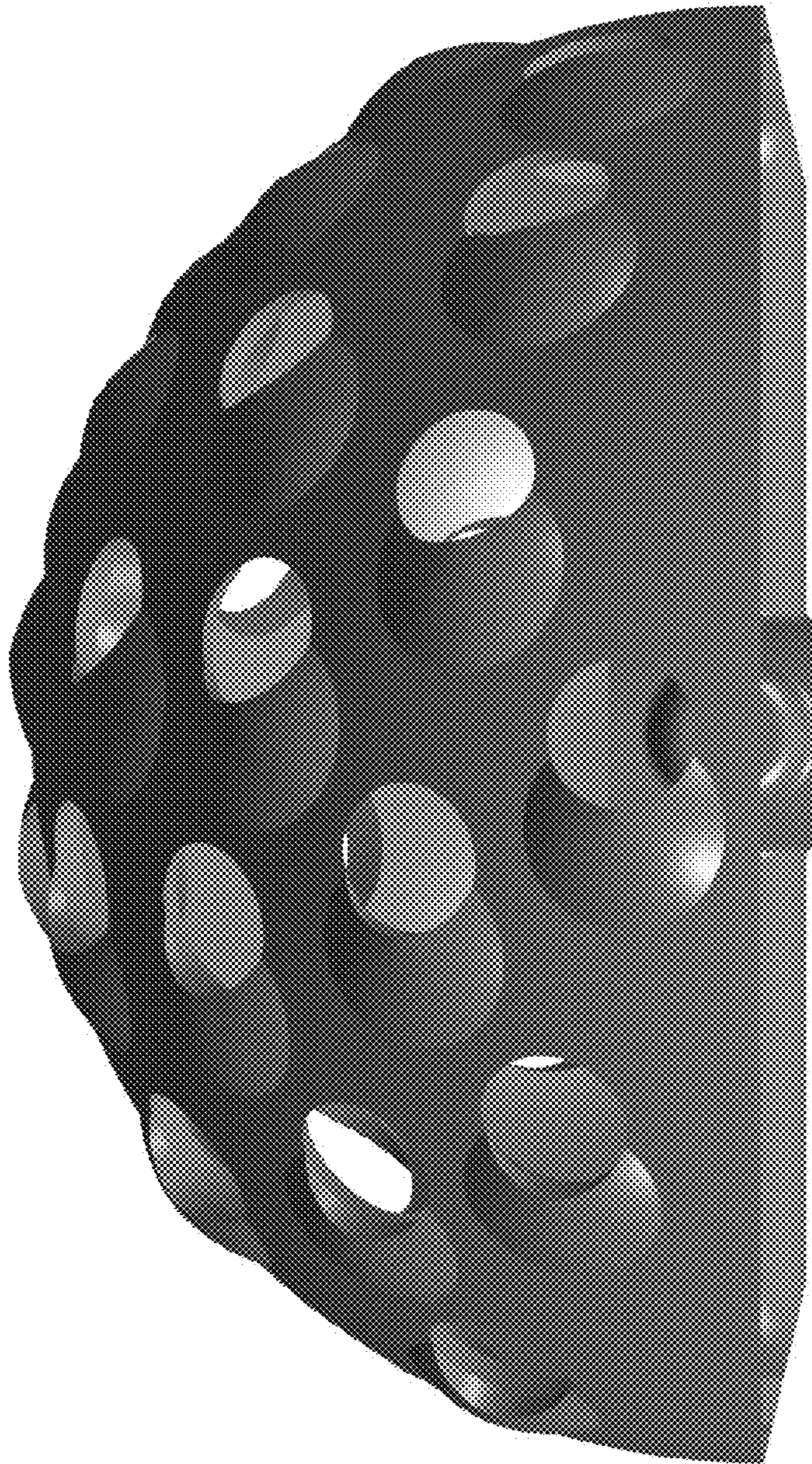

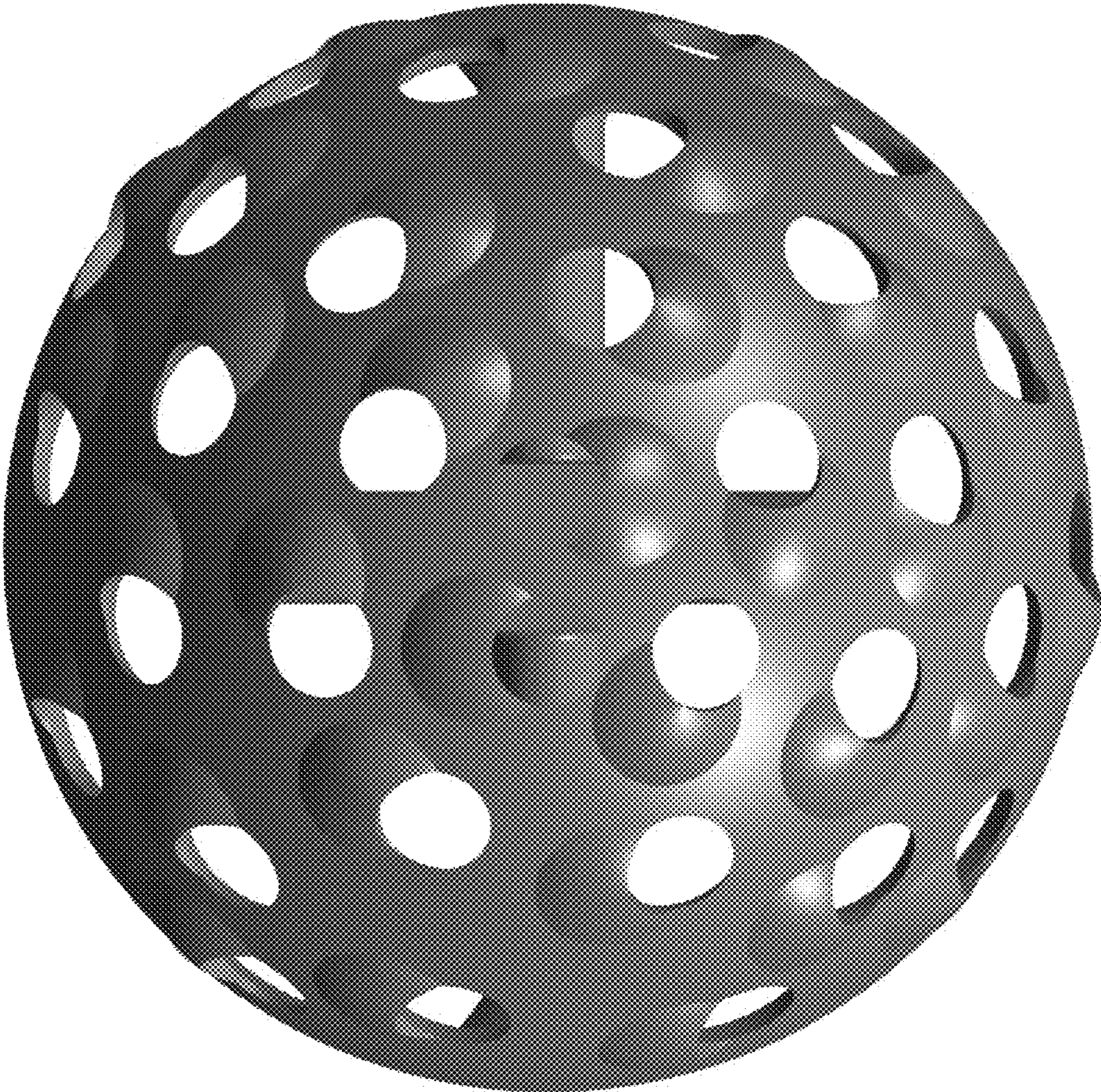

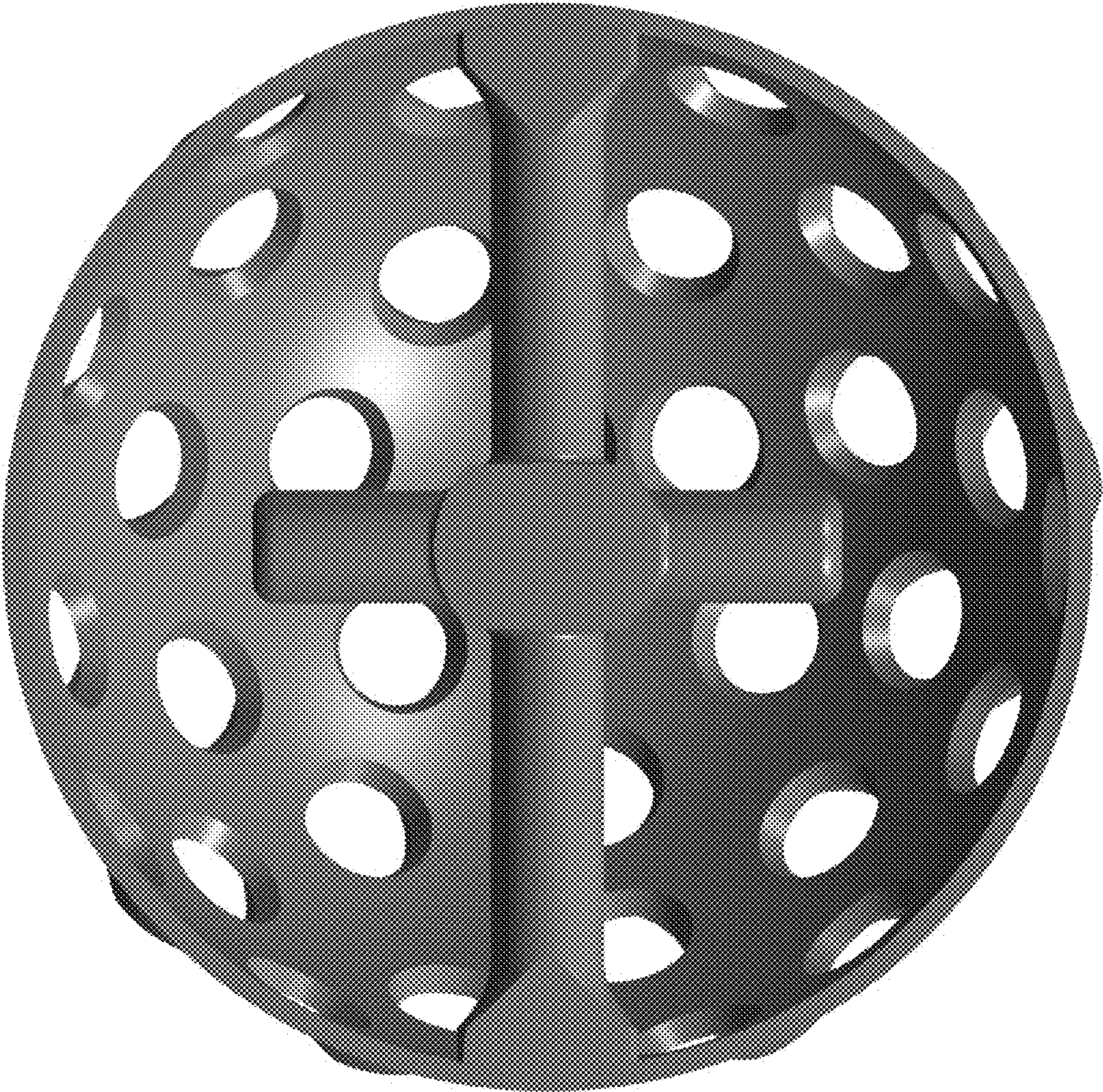

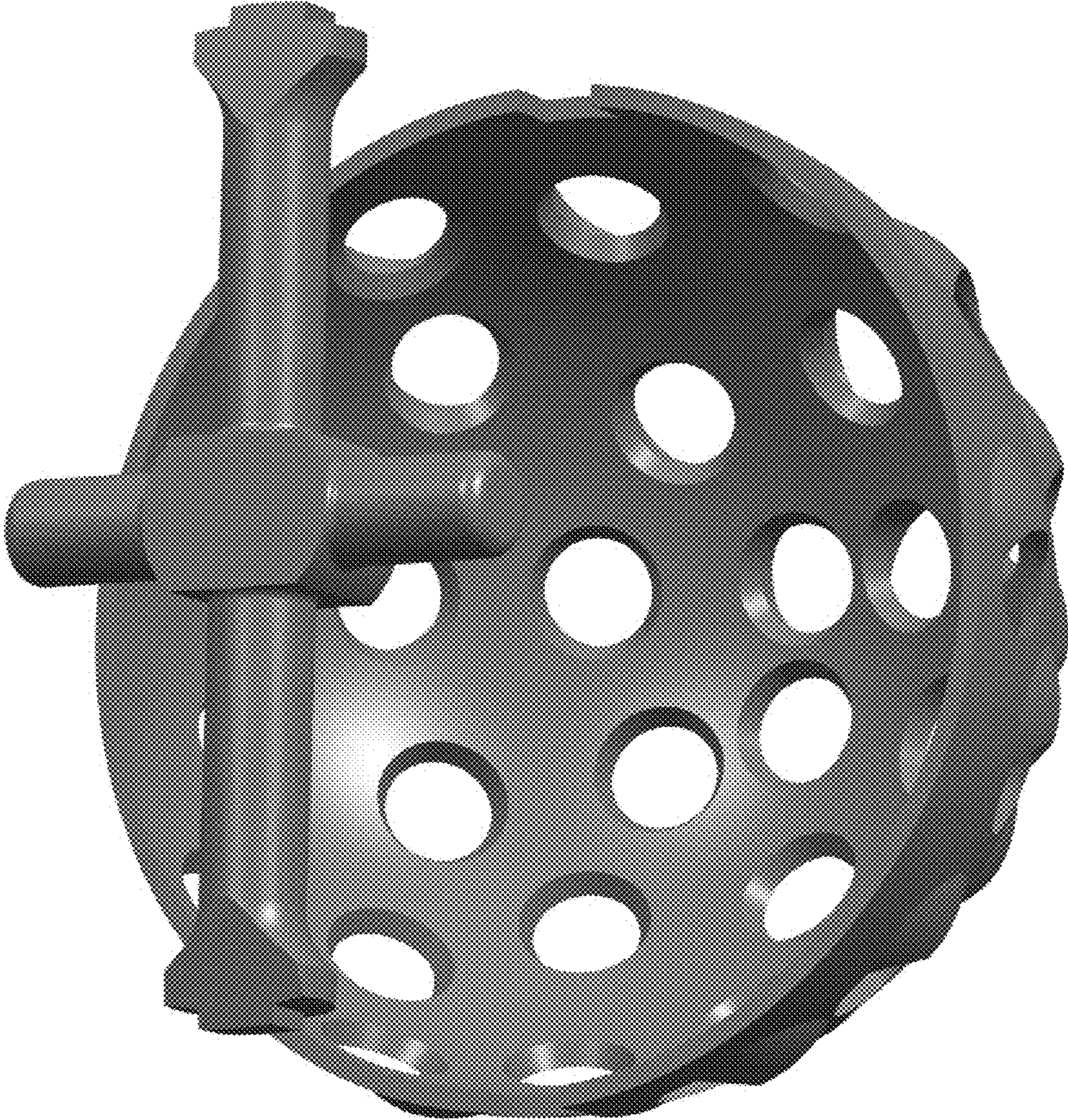
