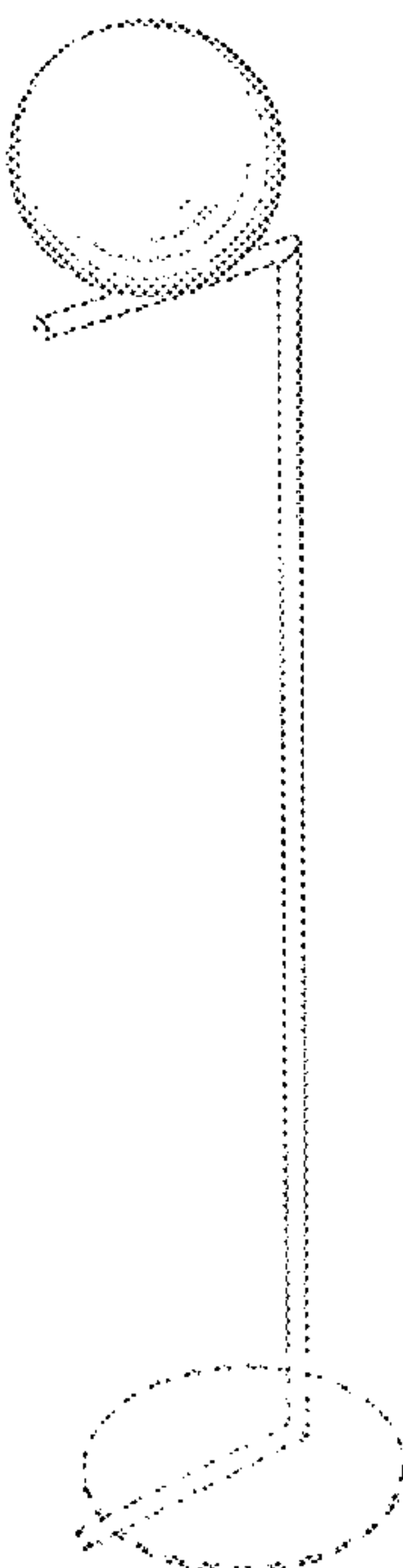
(57) **CLAIM**

The ornamental design for a floor lamp, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of my new floor lamp;
FIG. 2 is a side elevational view of my new floor lamp;
FIG. 3 is another side elevational view of my new floor lamp
from a side opposite that of FIG. 2;
FIG. 4 is a front elevational view of my new floor lamp;
FIG. 5 is a rear elevational view of my new floor lamp,
opposite that of FIG. 4;
FIG. 6 is a top view of my new floor lamp; and,
FIG. 7 is a bottom view of my new floor lamp.

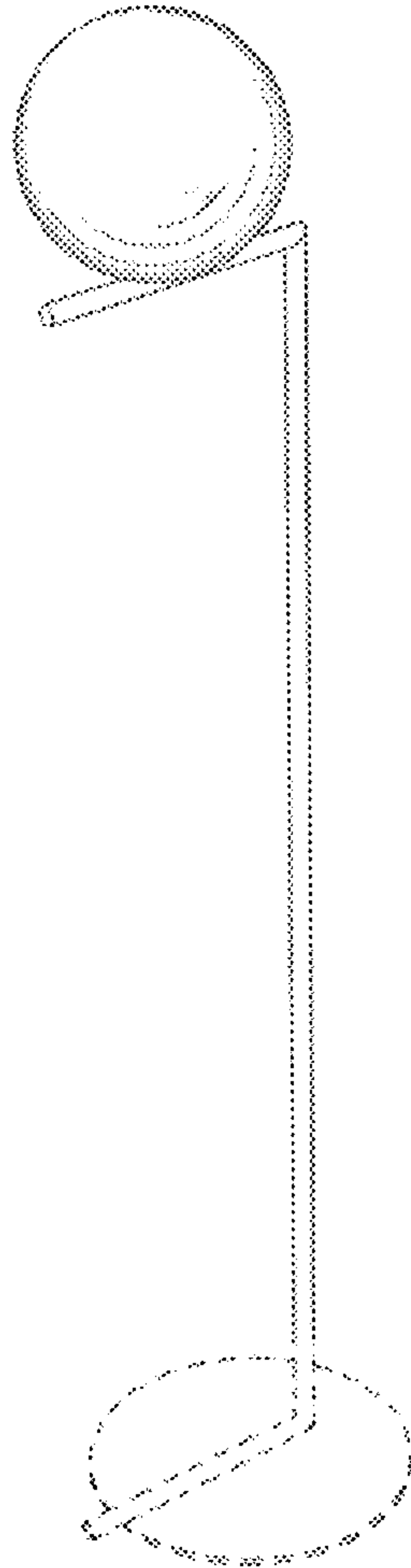

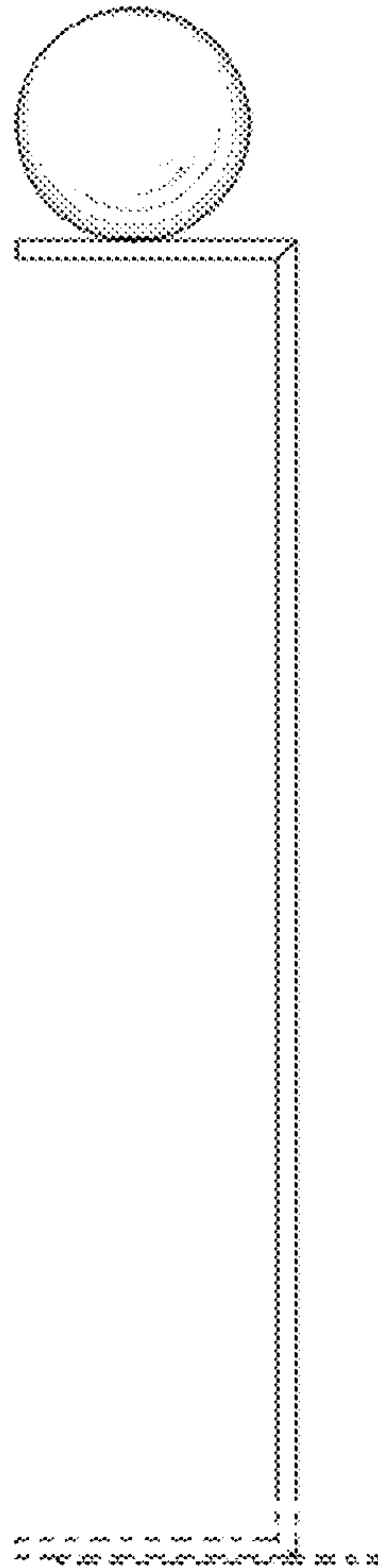

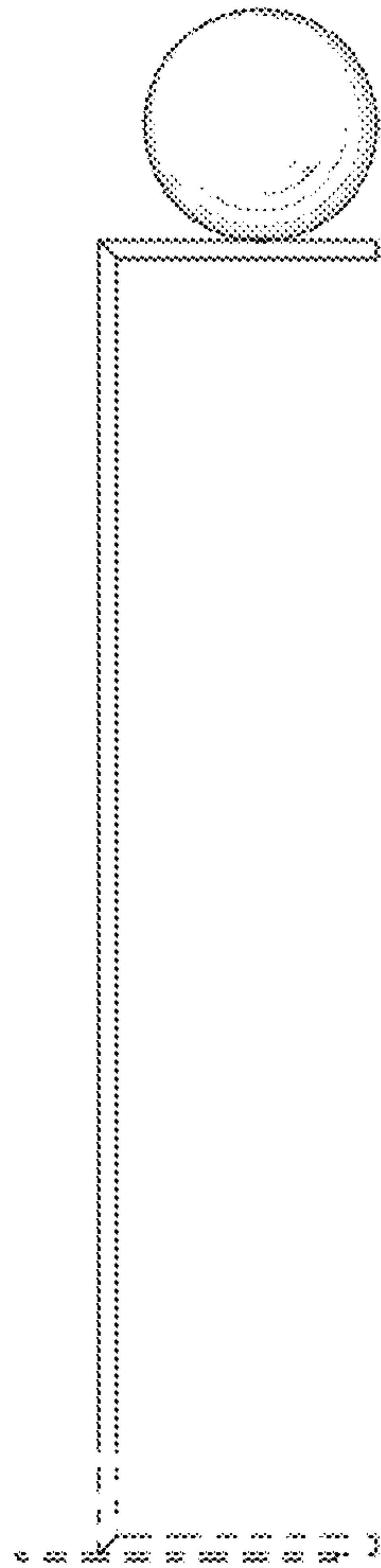

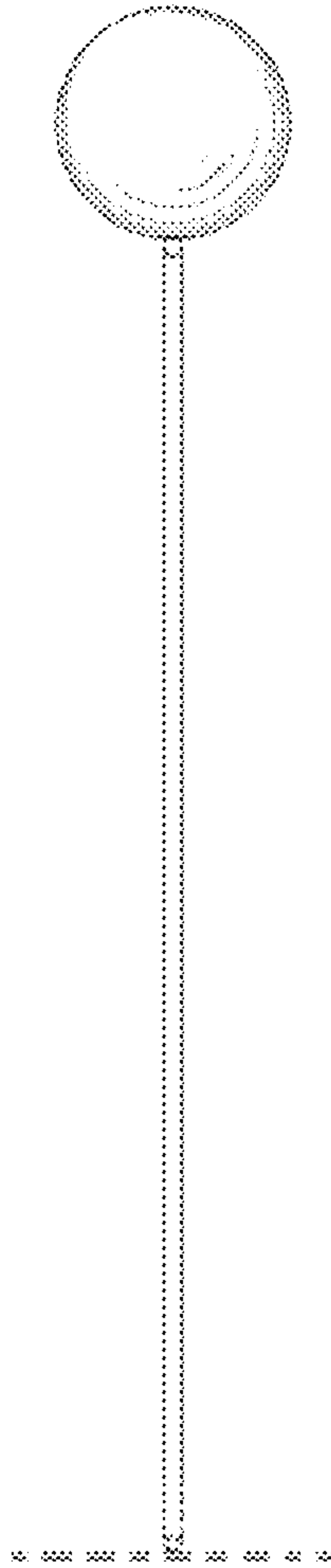

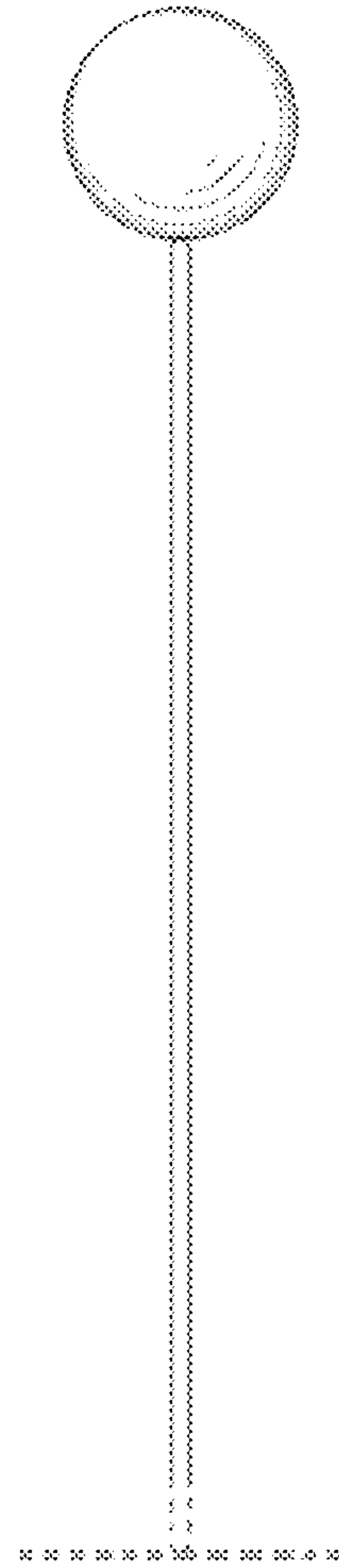

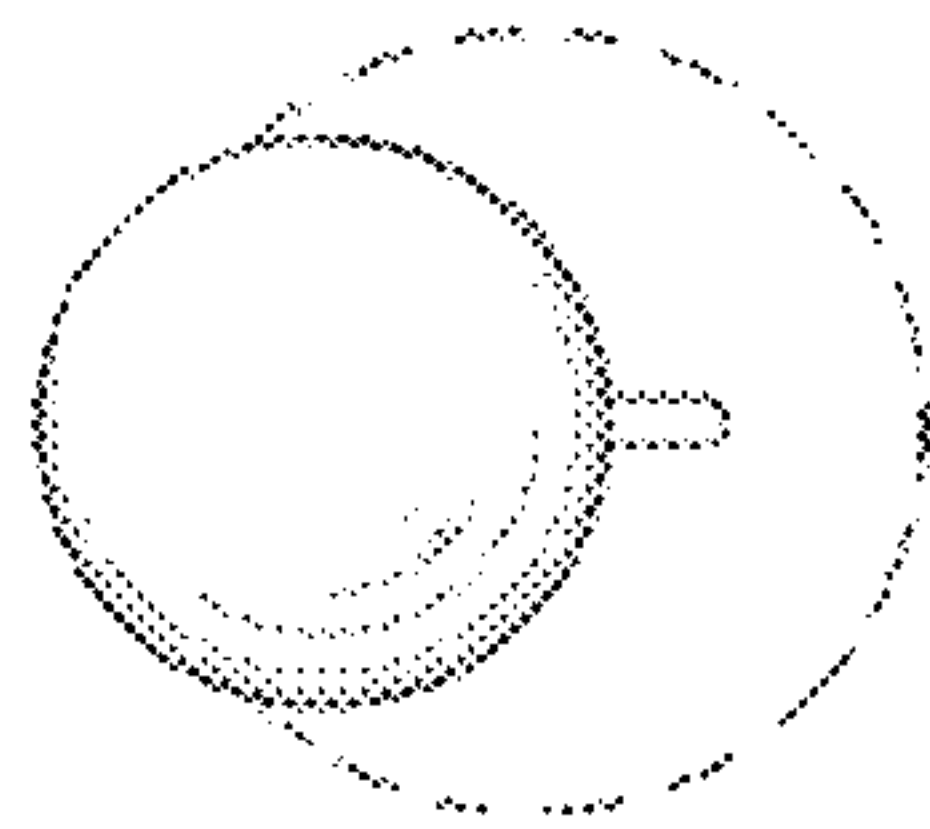

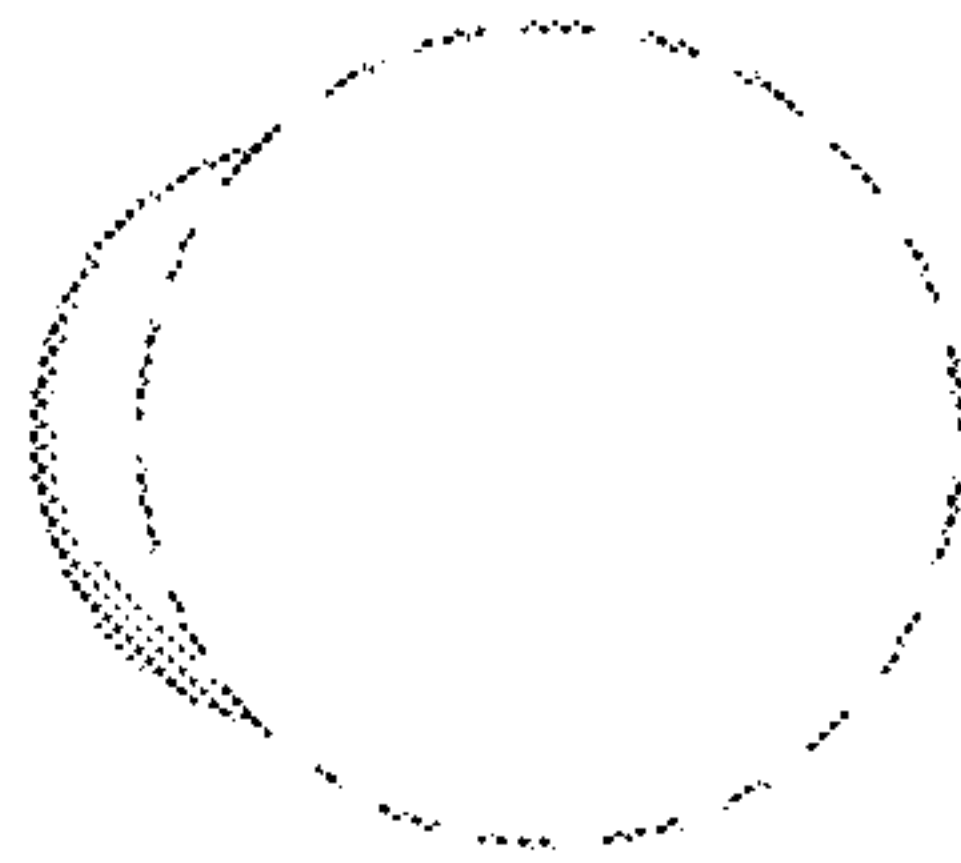
