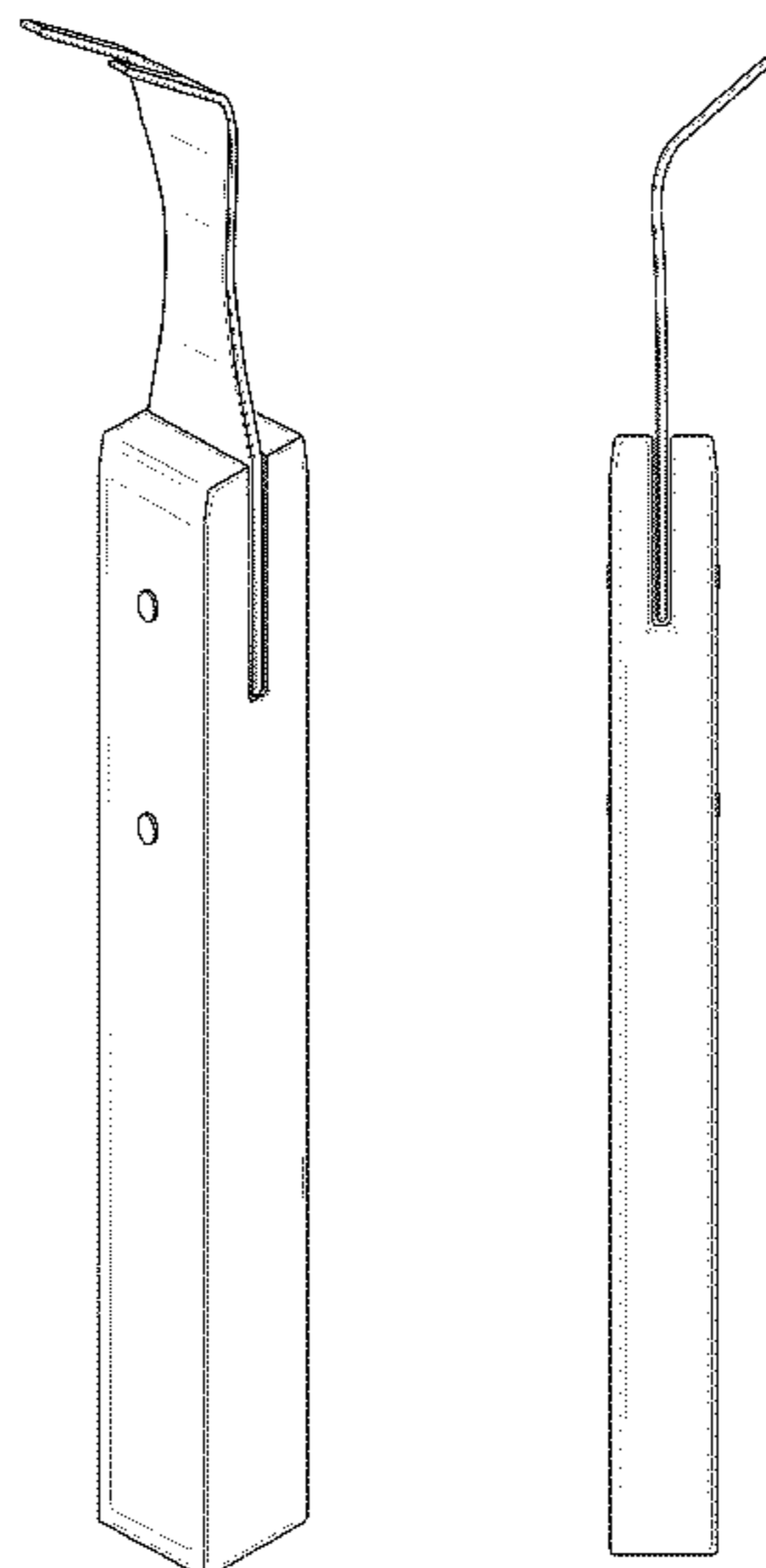
(57) **CLAIM**

I claim the ornamental appearance of a grill rod cleaner tool, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the grill rod cleaner tool, FIG. 2 is a front view of the grill rod cleaner tool thereof; FIG. 3 is a back view of the grill rod cleaner tool thereof; FIG. 4 is a left-side side view of the grill rod cleaner tool thereof; FIG. 5 is a right-side view of the grill rod cleaner tool thereof; FIG. 6 is a top view of the grill rod cleaner tool thereof; and, FIG. 7 is a bottom view of the grill rod cleaner tool thereof.

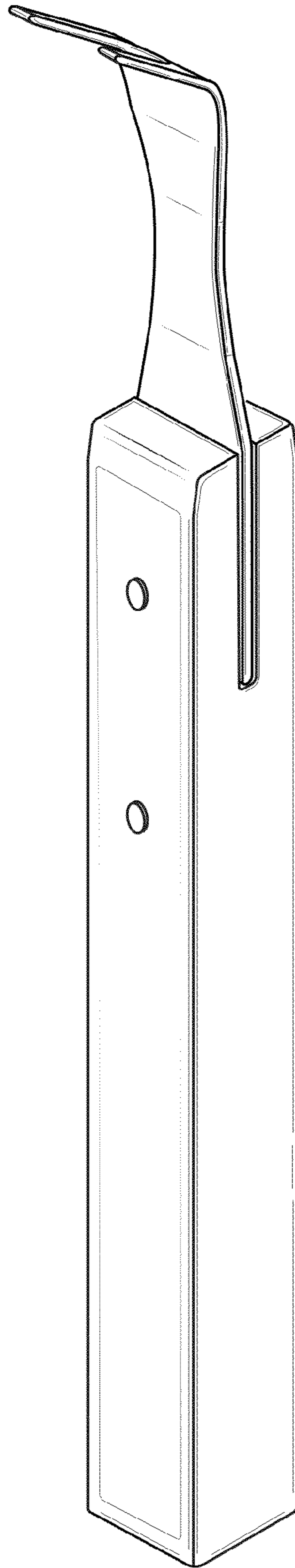

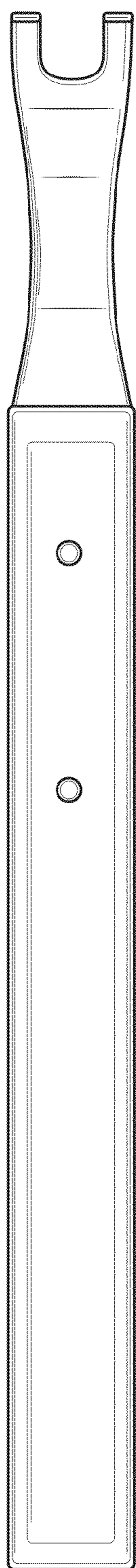

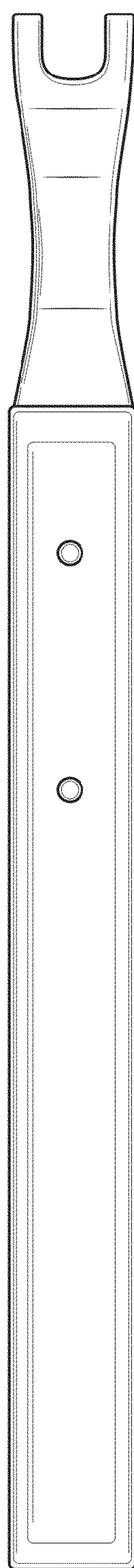

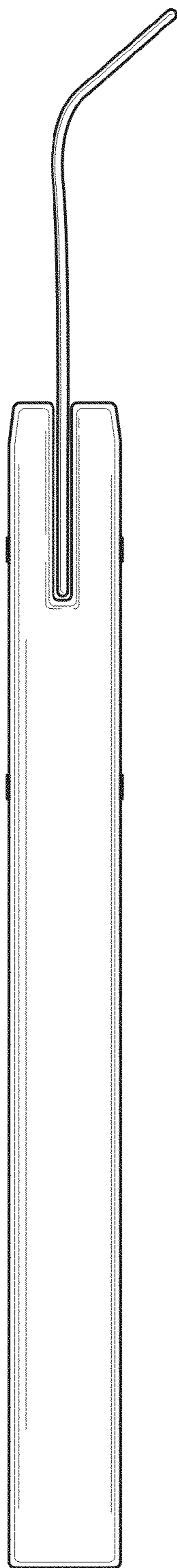

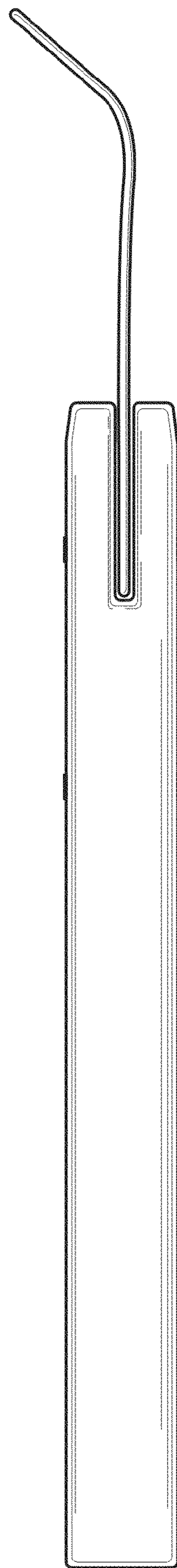

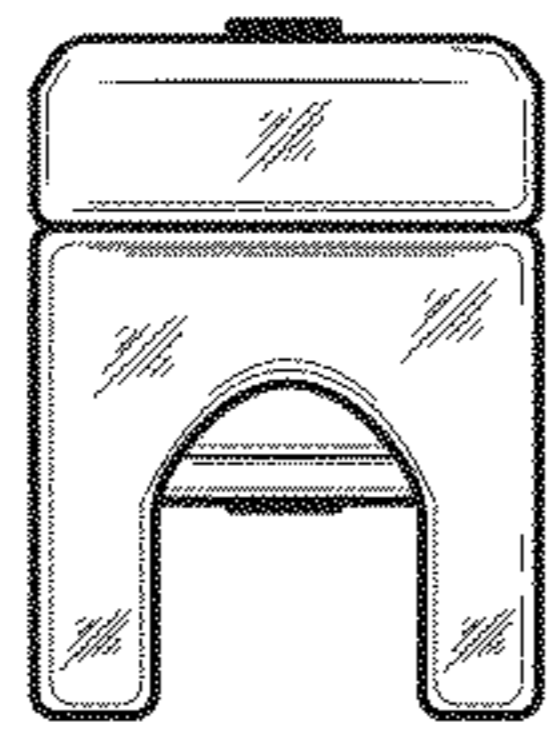

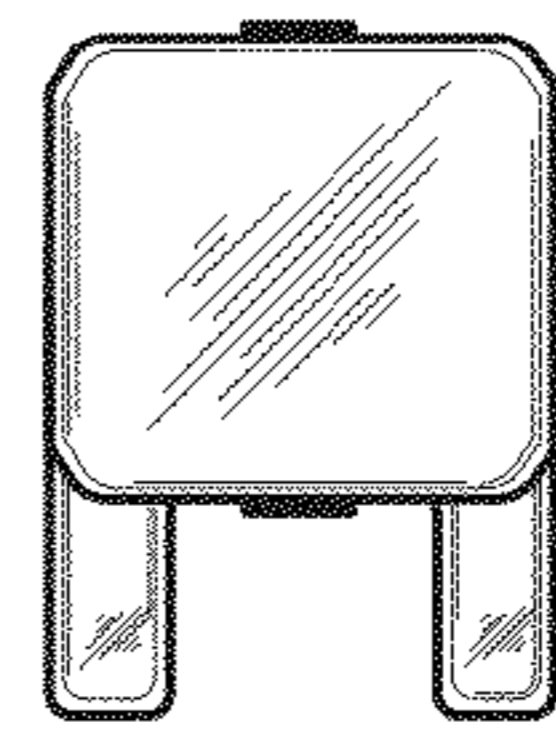
