The ornamental design for an athletic garment, as shown and described.

**DESCRIPTION**

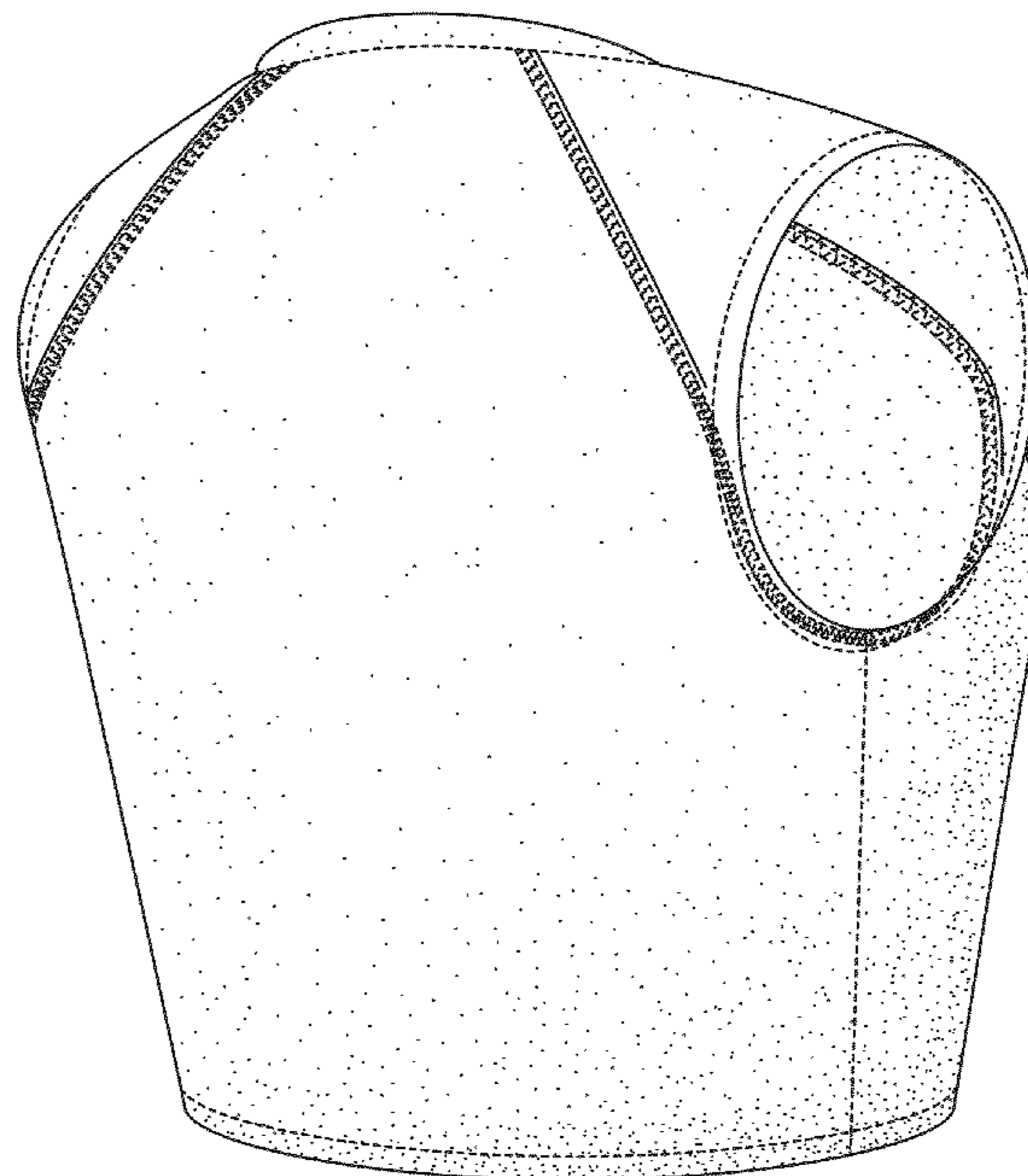
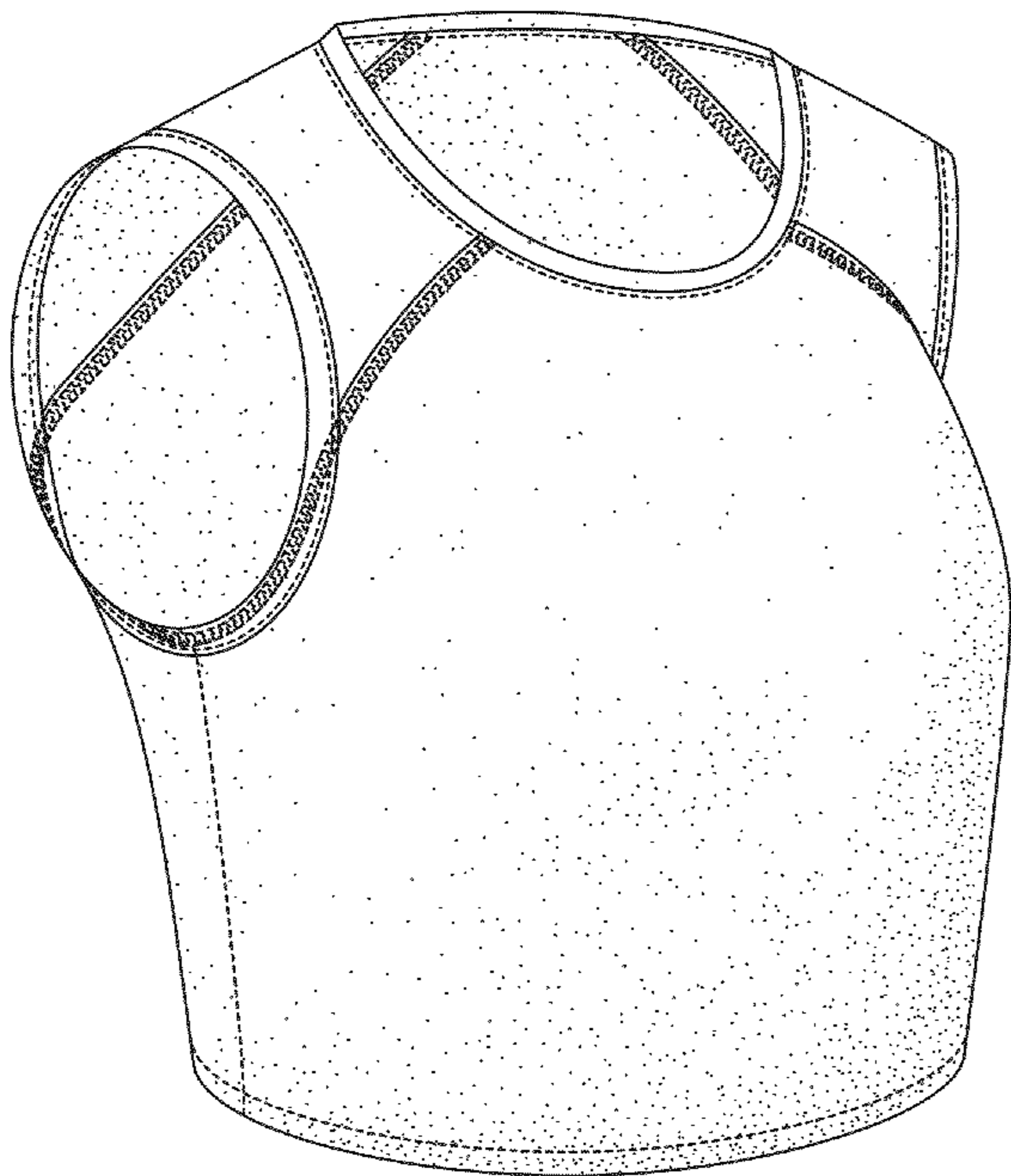
FIG. 1 is a front perspective view of my new design; FIG. 2 is a rear perspective view of the design of FIG. 1; FIG. 3 is a front elevational view of the design of FIG. 1; FIG. 4 is a rear elevational view of the design of FIG. 1; FIG. 5 is a right side elevational view of the design of FIG. 1; the left side elevational view being a mirror image thereof; and,

FIG. 6 is a front perspective view of the design FIG. 1 with a representation of a human body wearing the garment shown for reference only;

The broken lines in FIG. 6 depict a representation of a human form wearing the garment, are shown for reference only and form no part of the claimed design.

The uniformly spaced broken lines on the surface of athletic garment, in FIGS. 1-6, represent stitching.

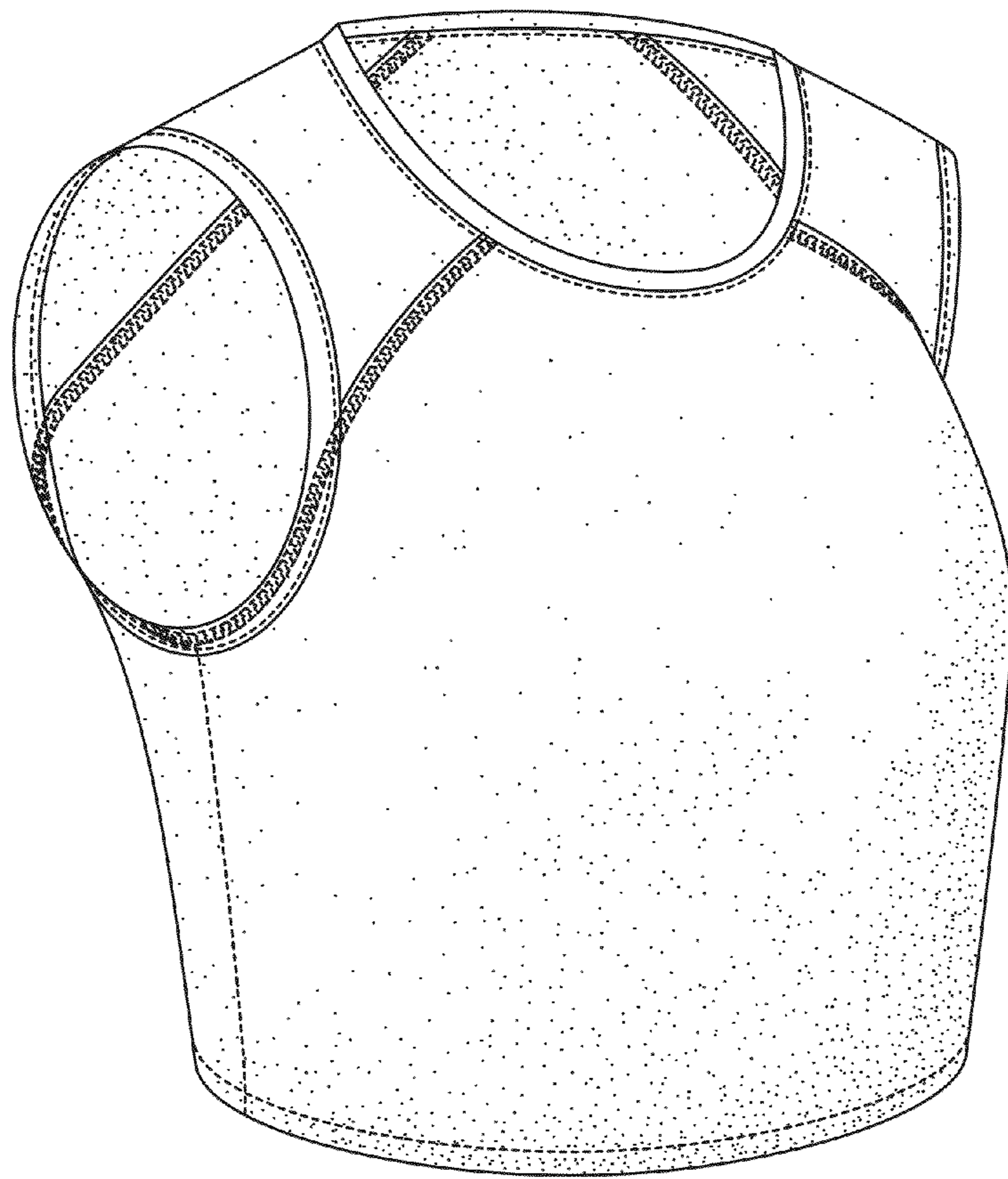

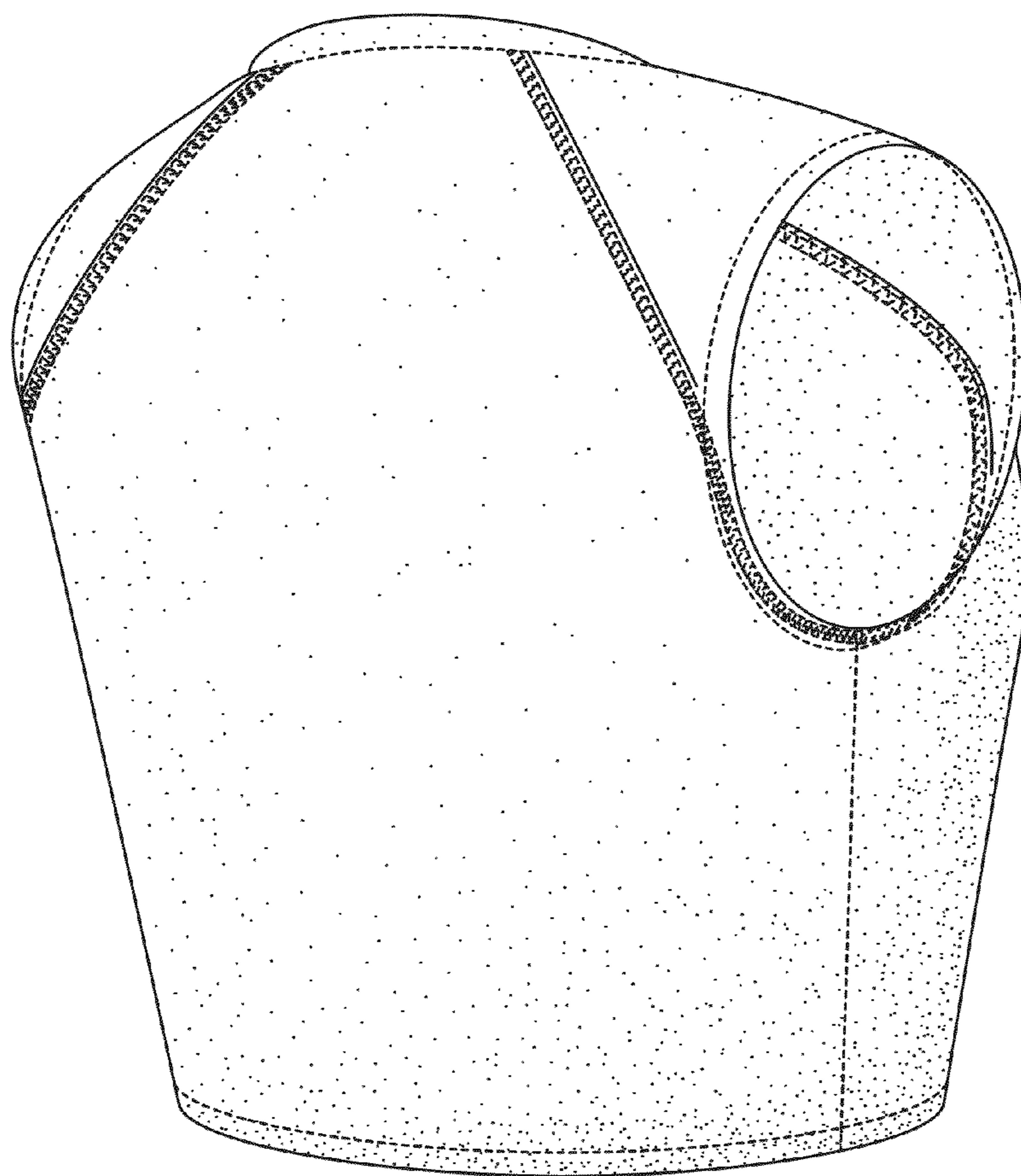

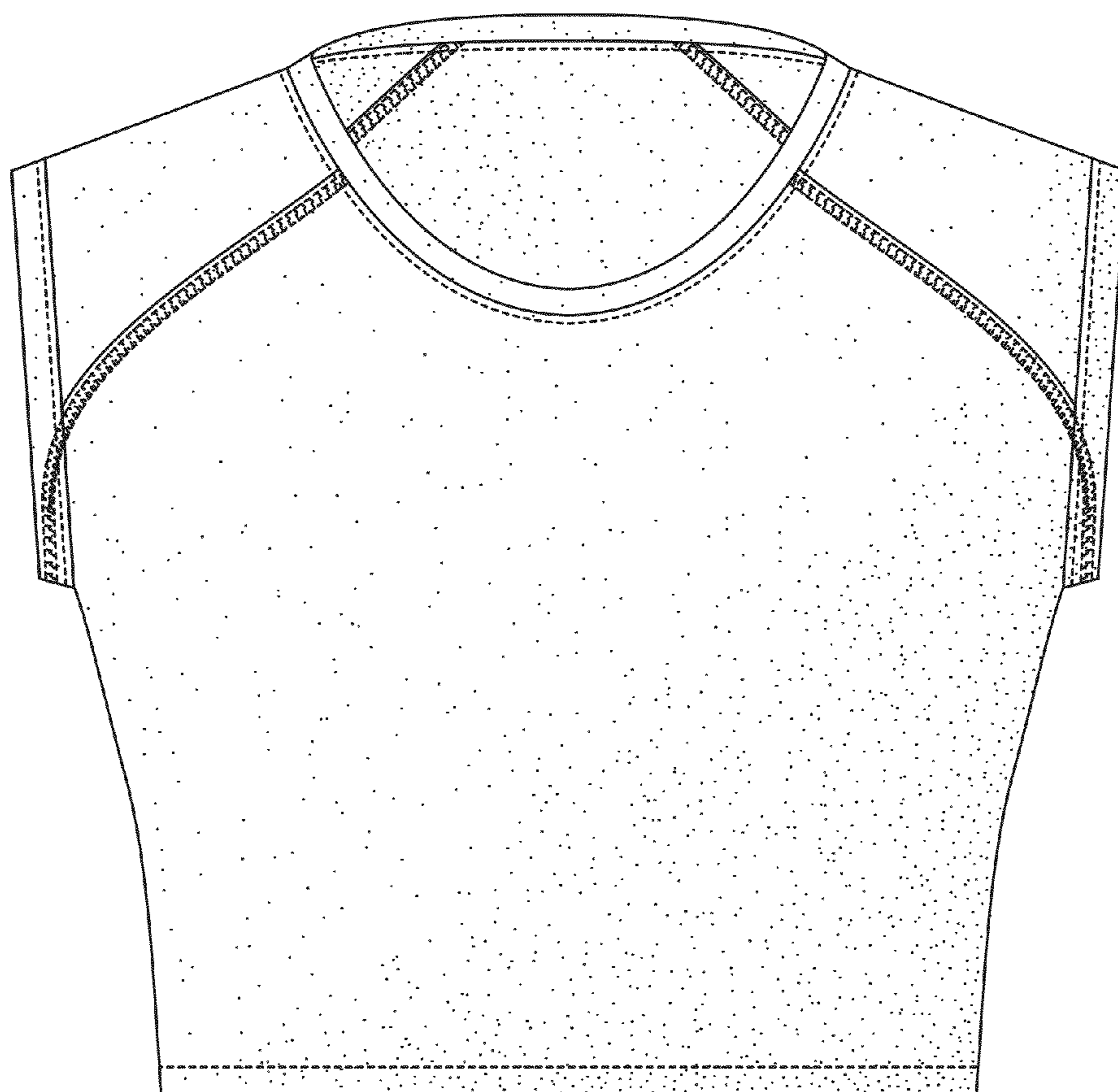

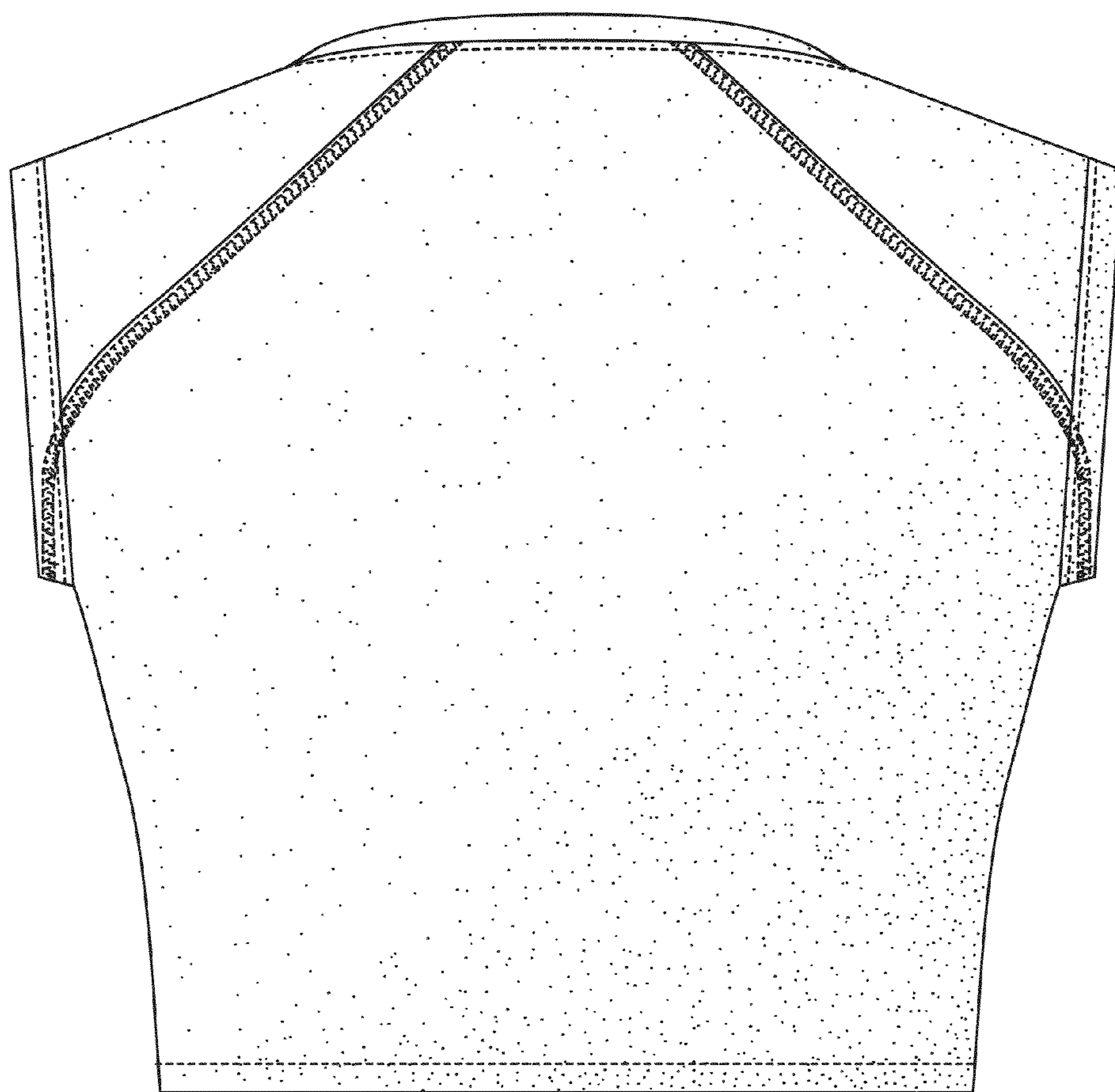

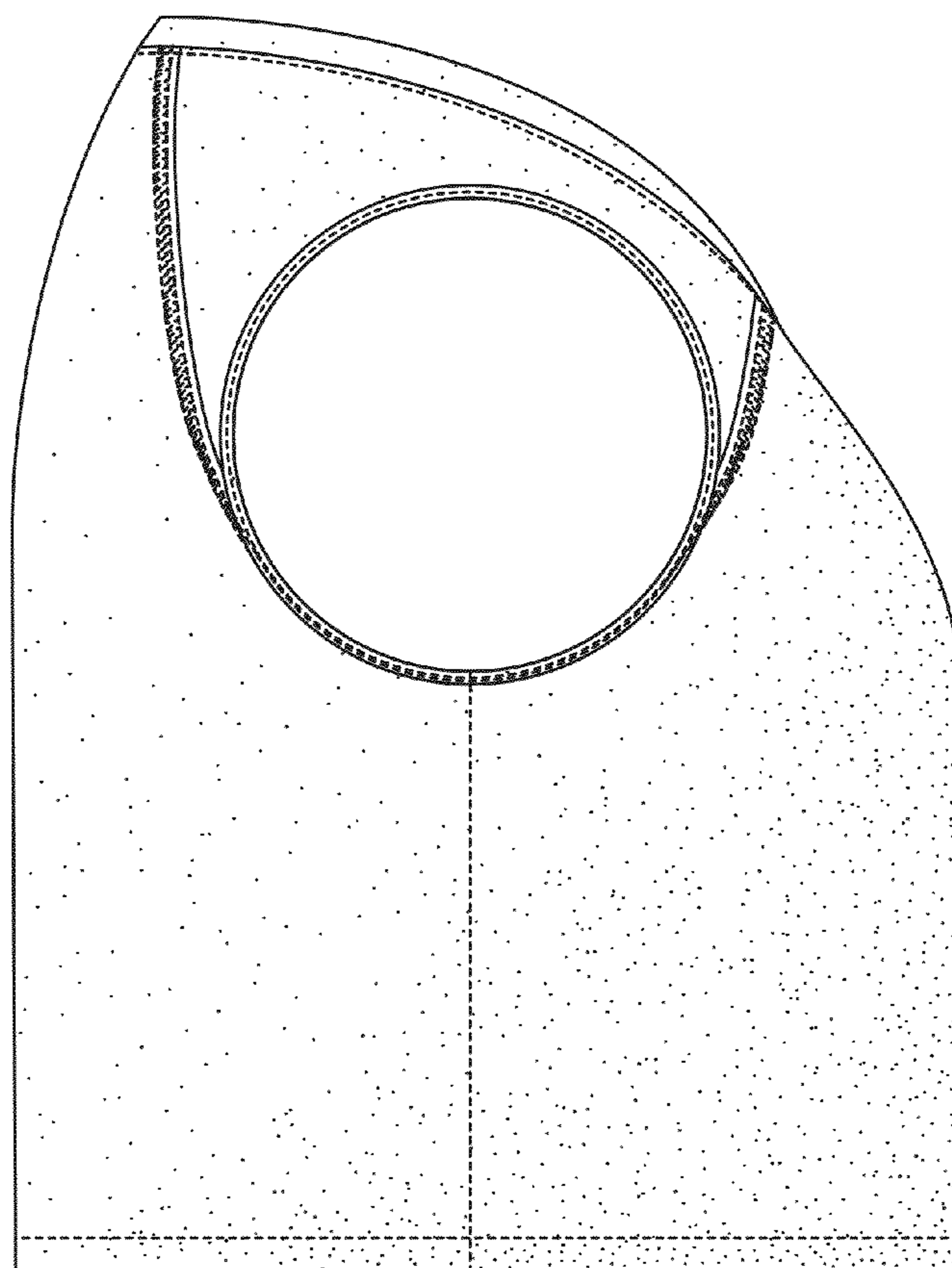

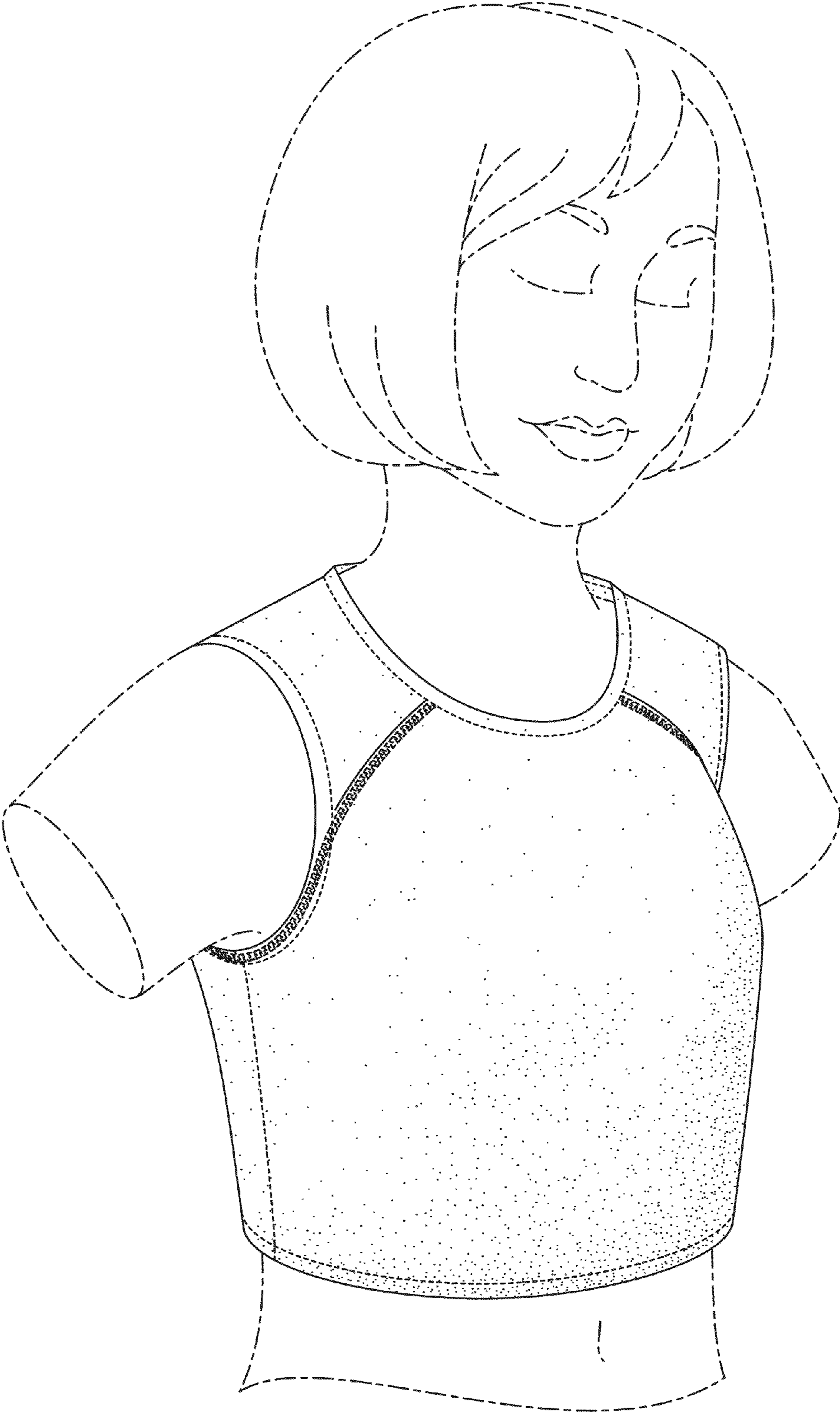
