**DESCRIPTION**

FIG. 1 is a perspective view of a peak for crampon showing my new design.

FIG. 2 is a front elevational view thereof.

FIG. 4 is a left side elevational view thereof, the right side elevational view being a mirror image.

FIG. 7 is a bottom plan reference view thereof shown in a used condition.

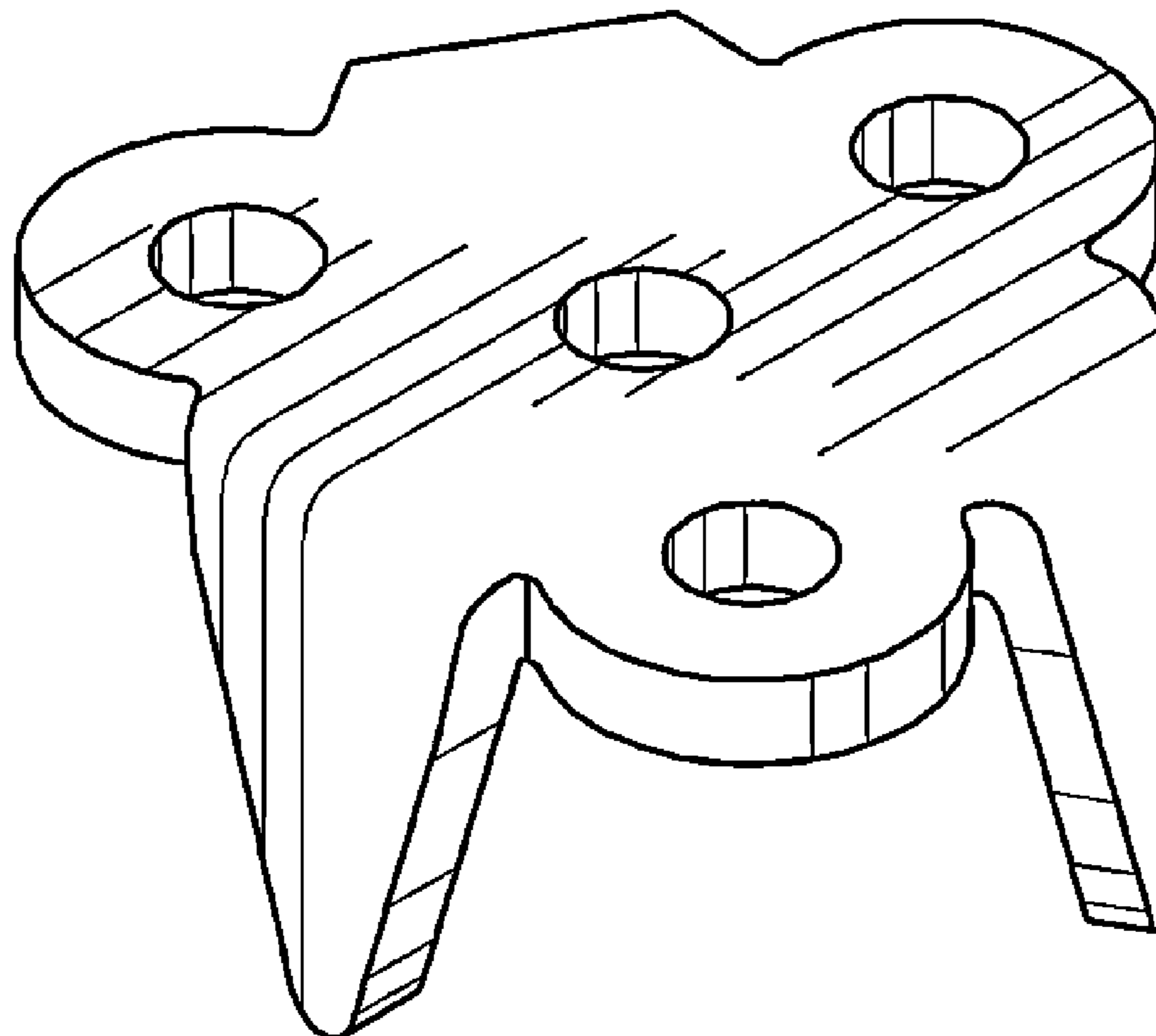

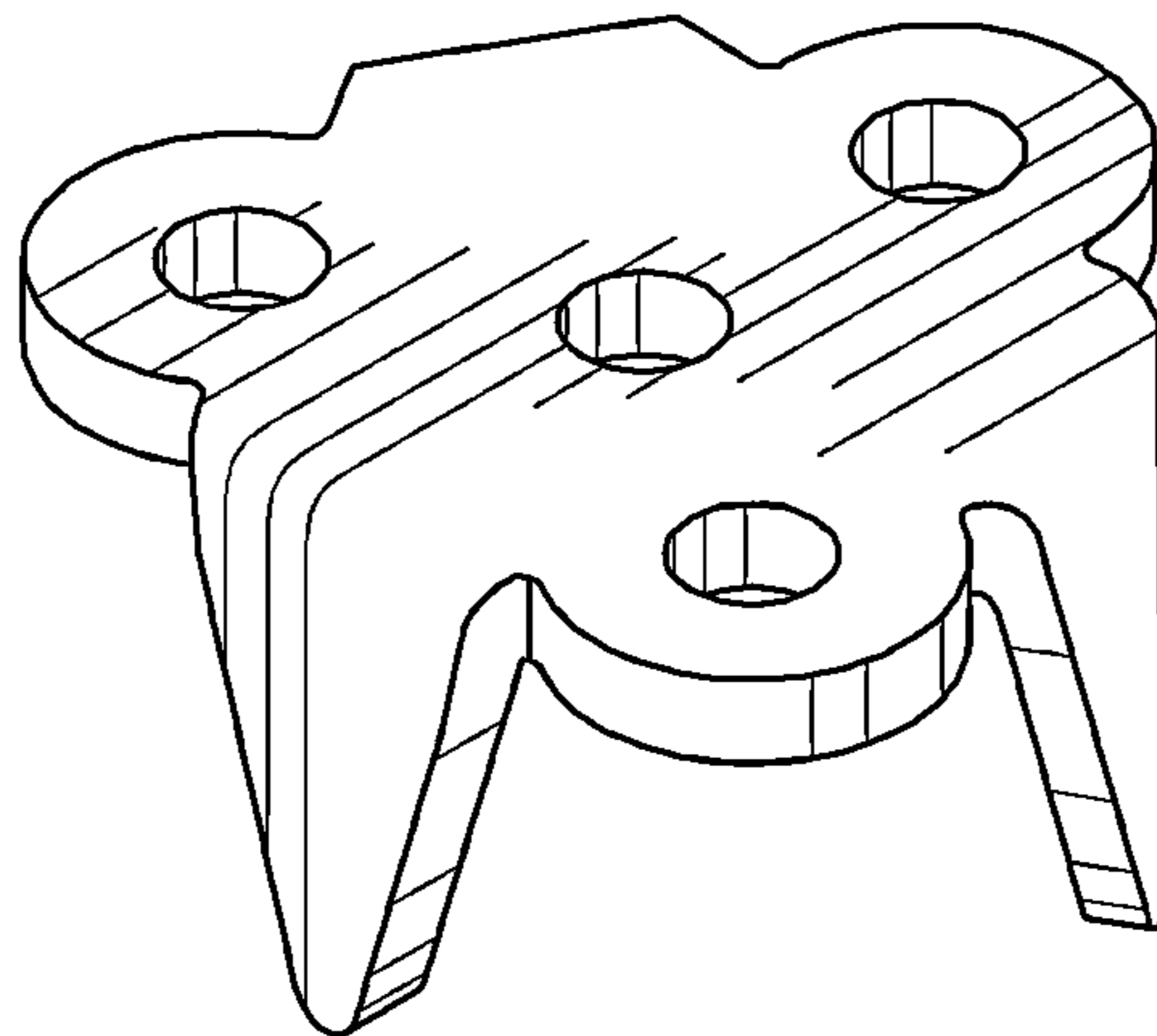

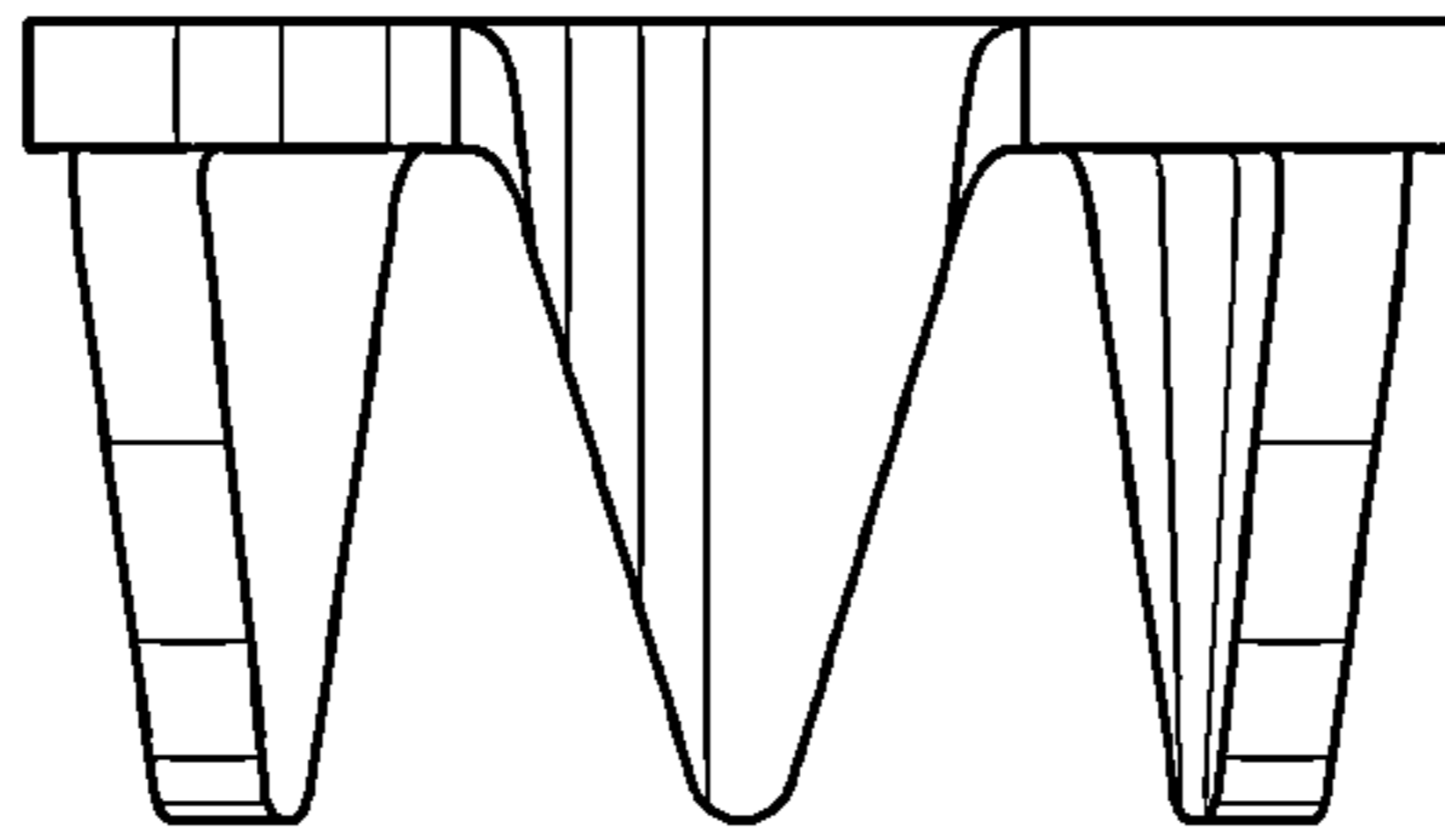

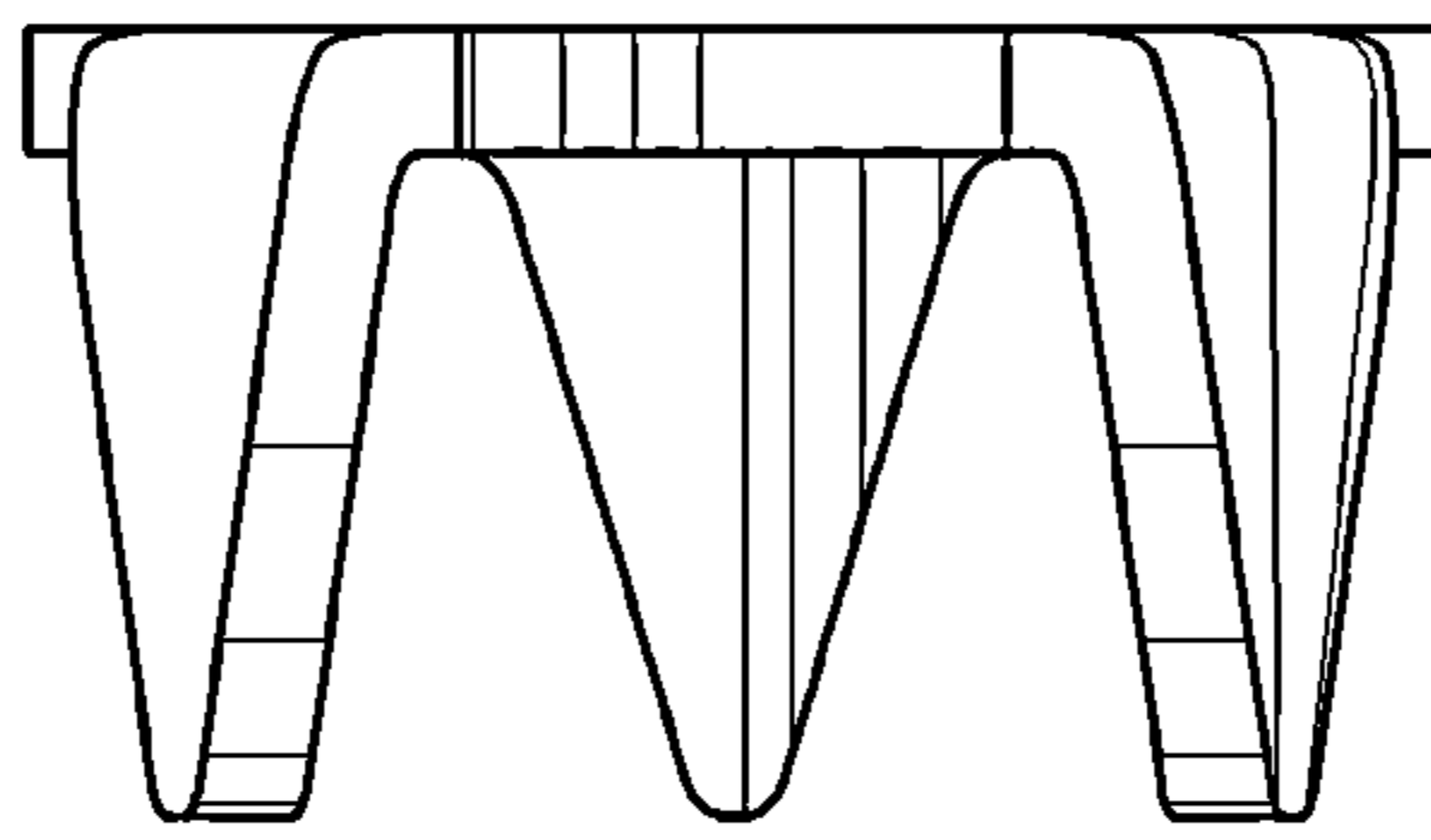

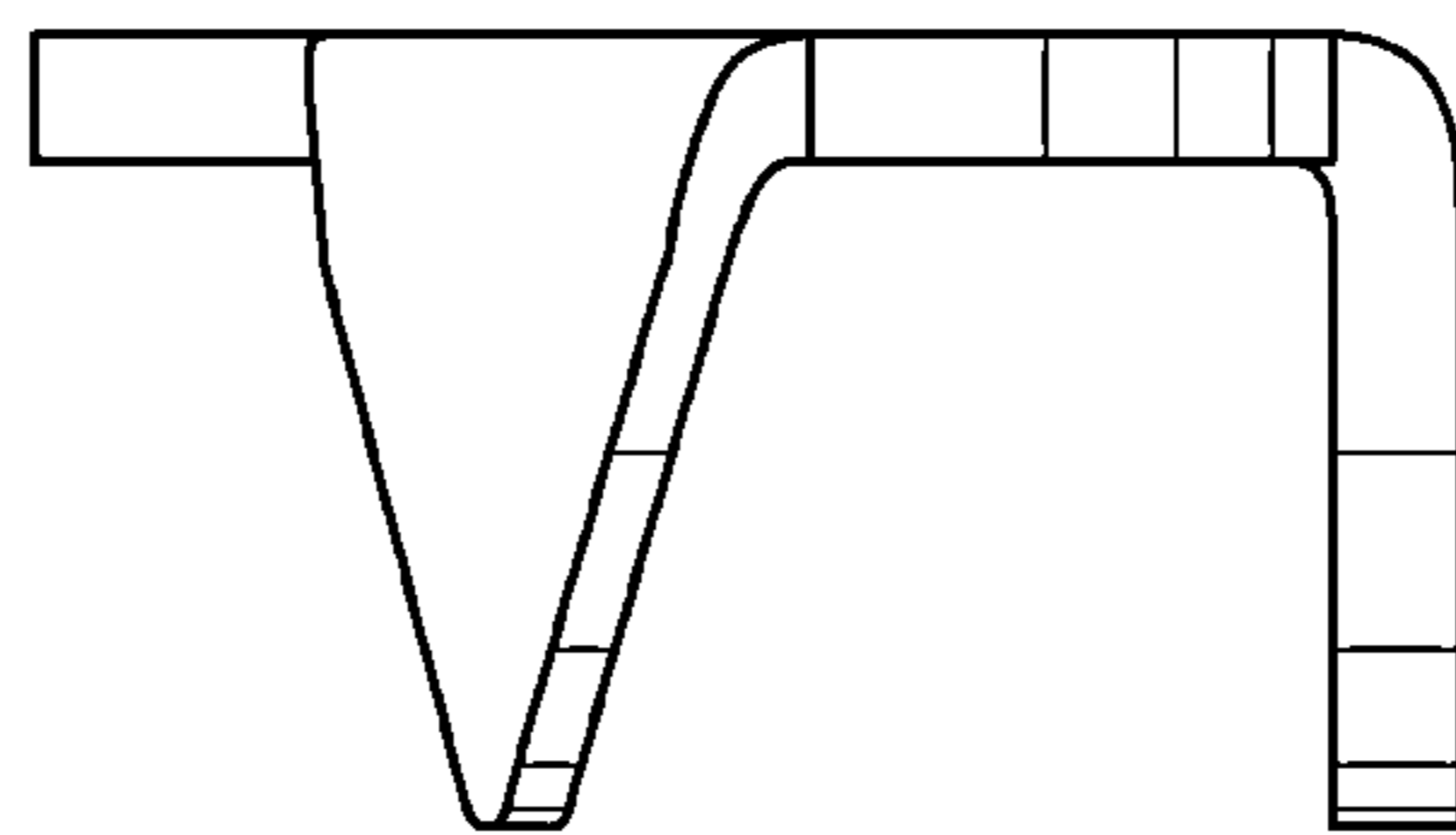

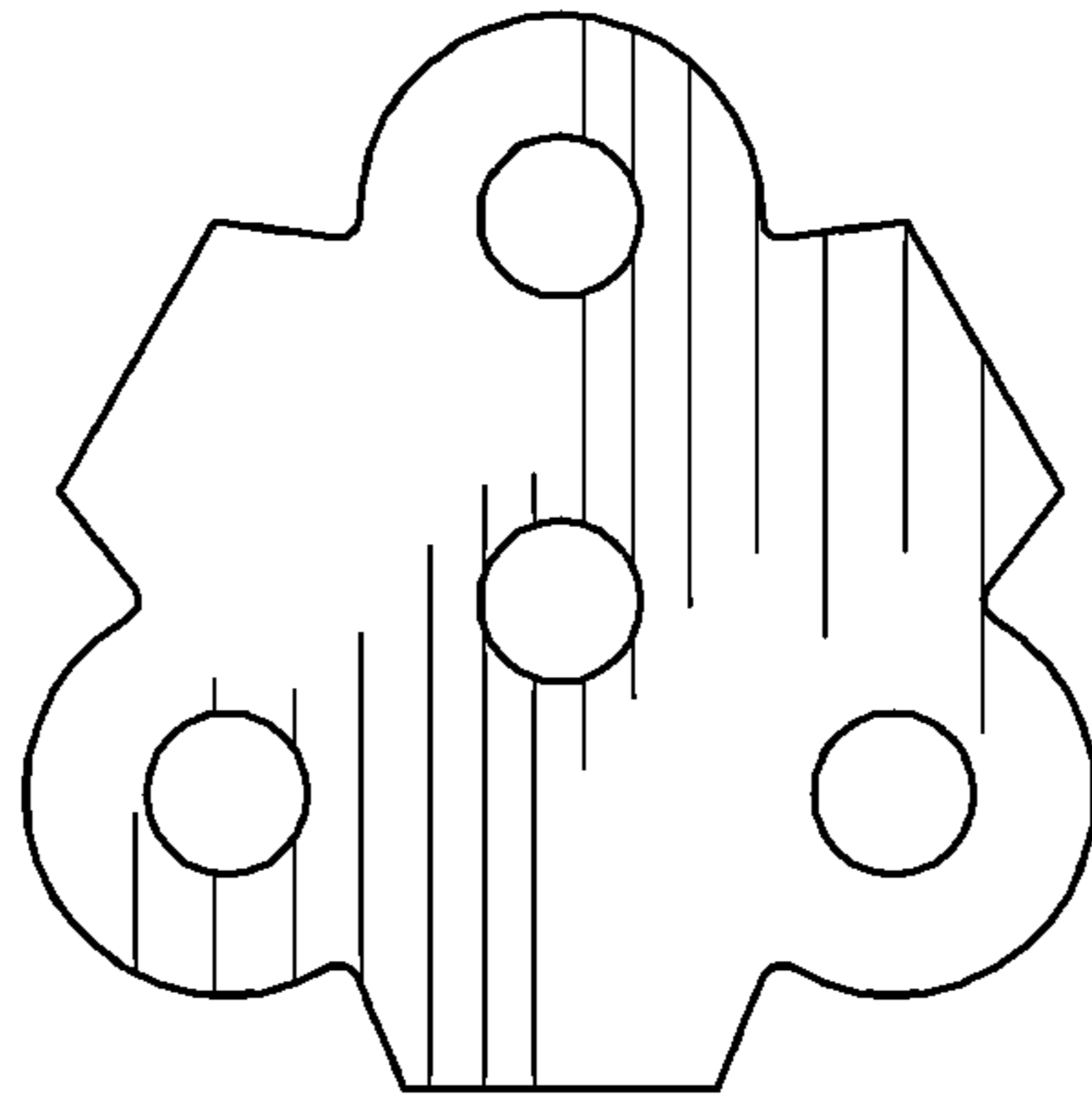

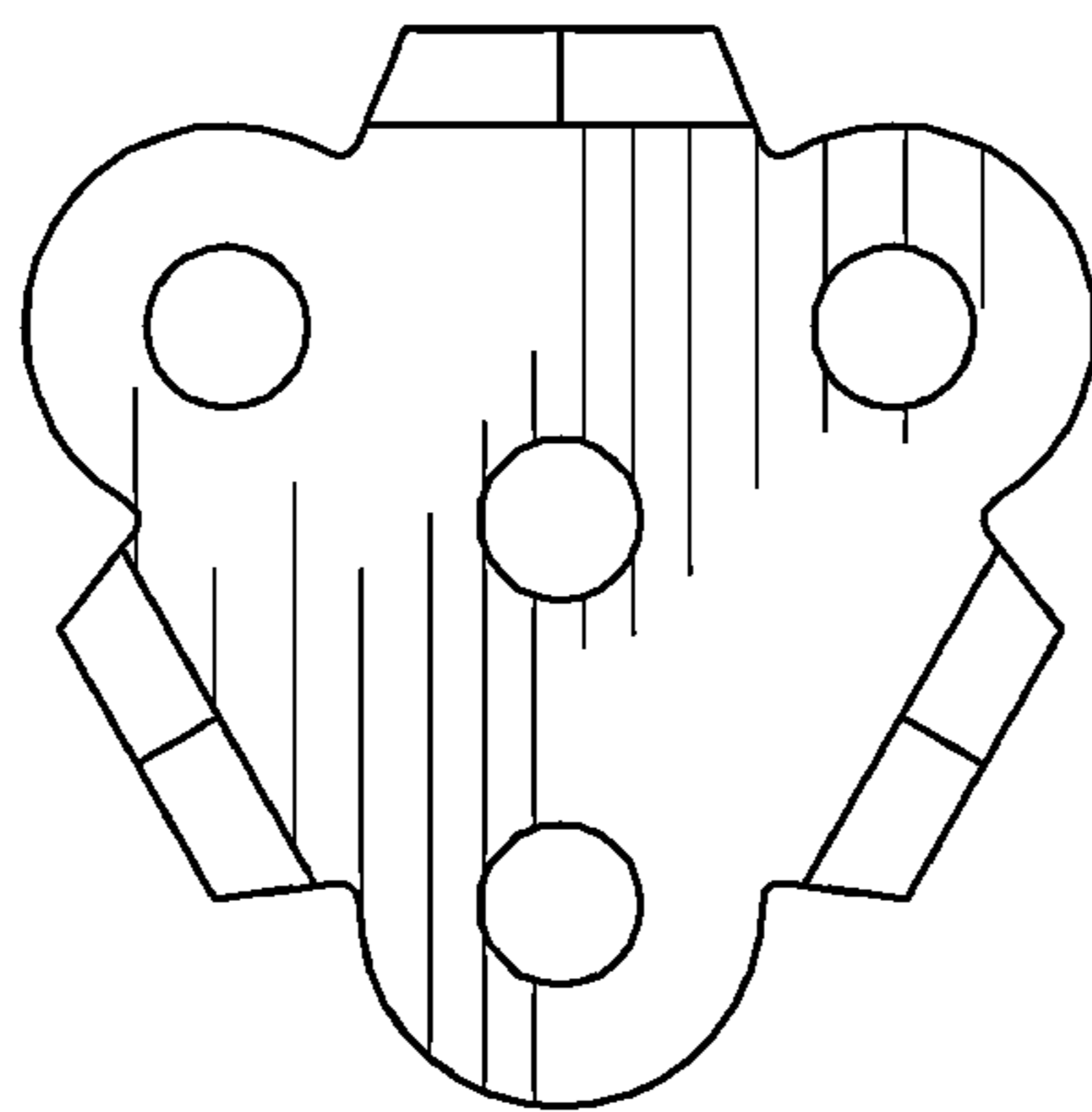

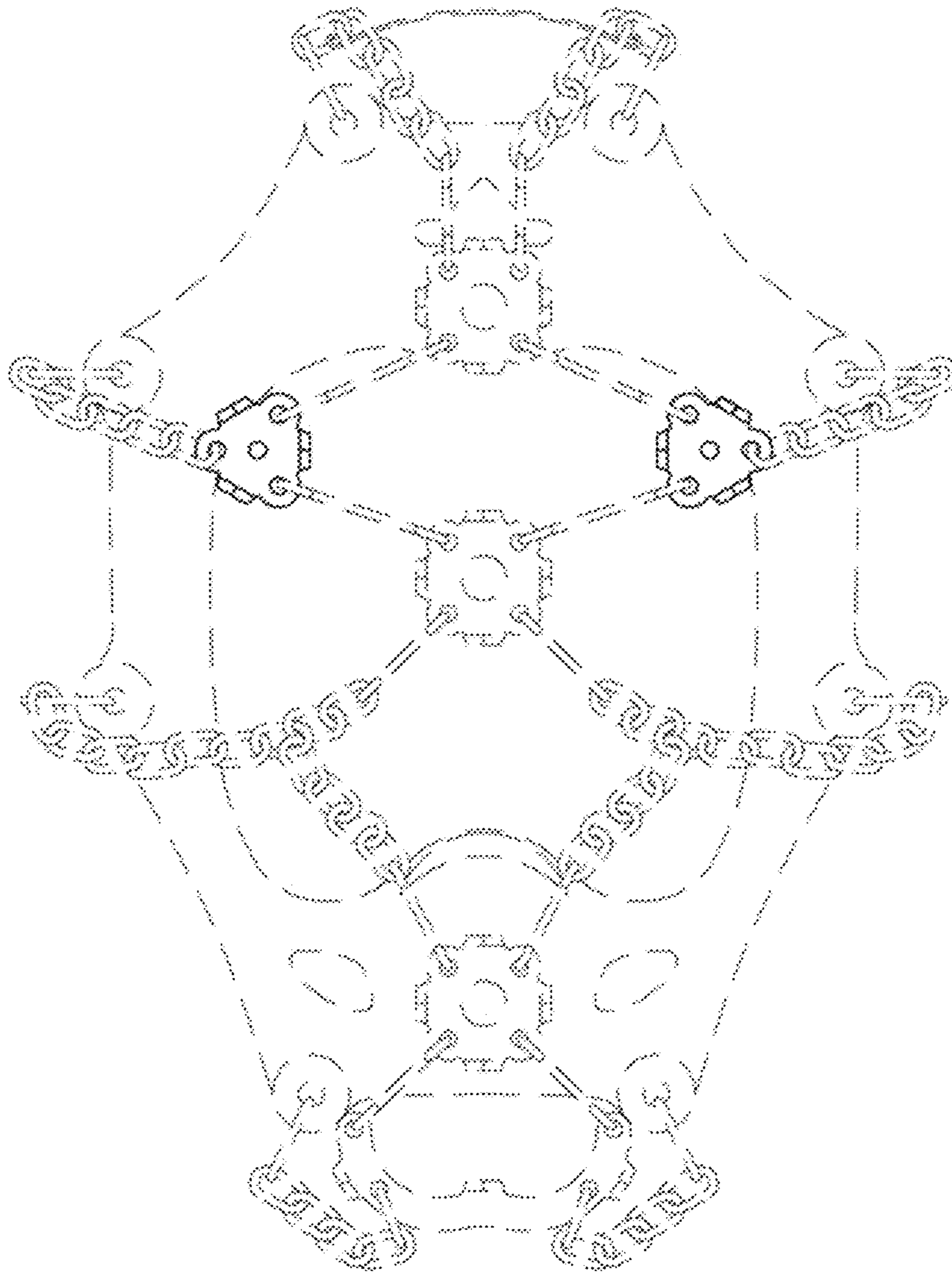
