(57) **CLAIM**

We claim the ornamental design for the clothing cabinet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the clothing cabinet according to the claimed design, represented in a partially opened configuration;

FIG. 2 is a front elevational view of FIG. 1;

FIG. 3 is a rear elevational view of FIG. 1;

FIG. 4 is a right side elevational view of FIG. 1;

FIG. 17 is a rear elevational view of FIG. 15;

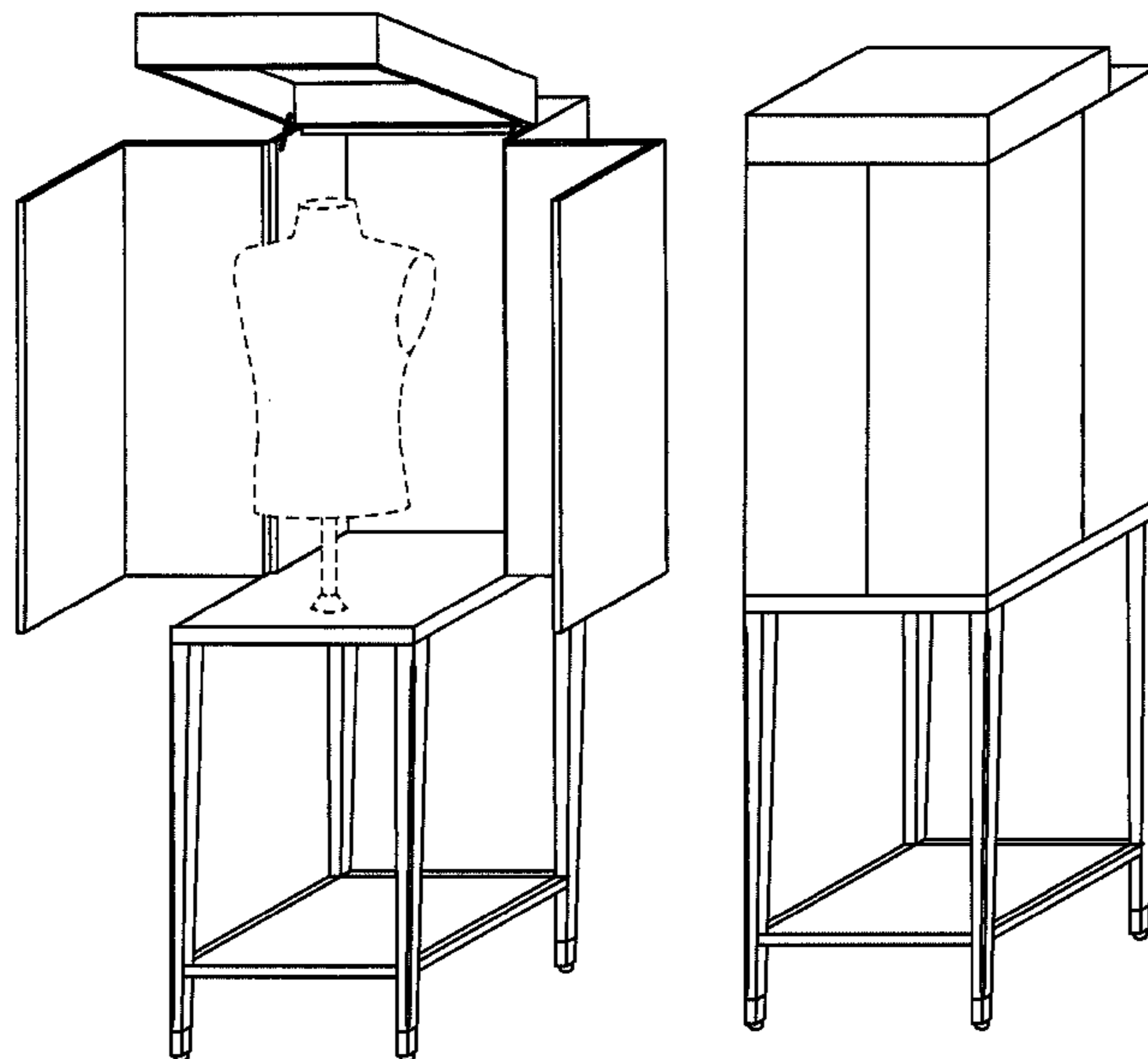
FIG. 18 is a right side elevational view of FIG. 15;

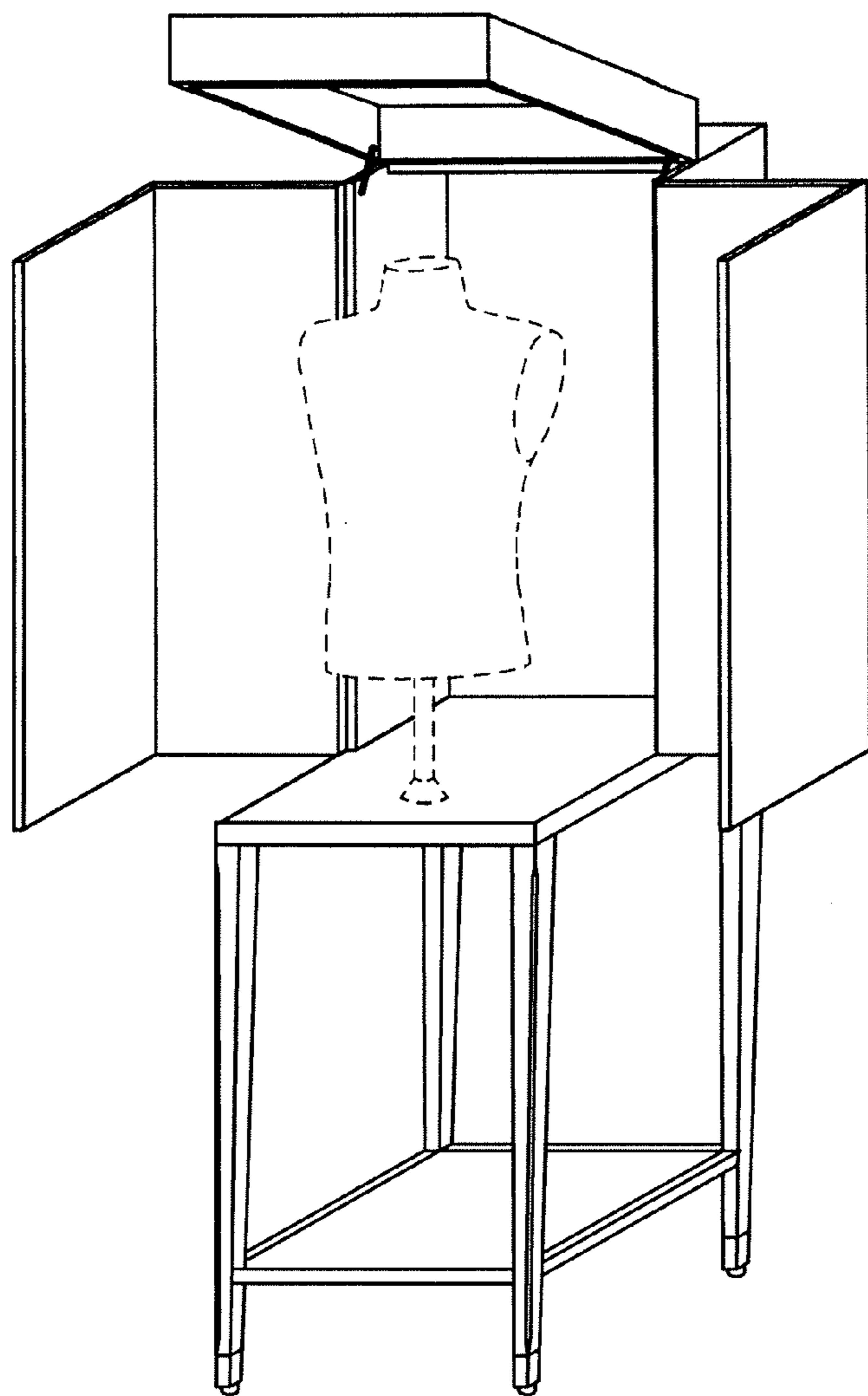

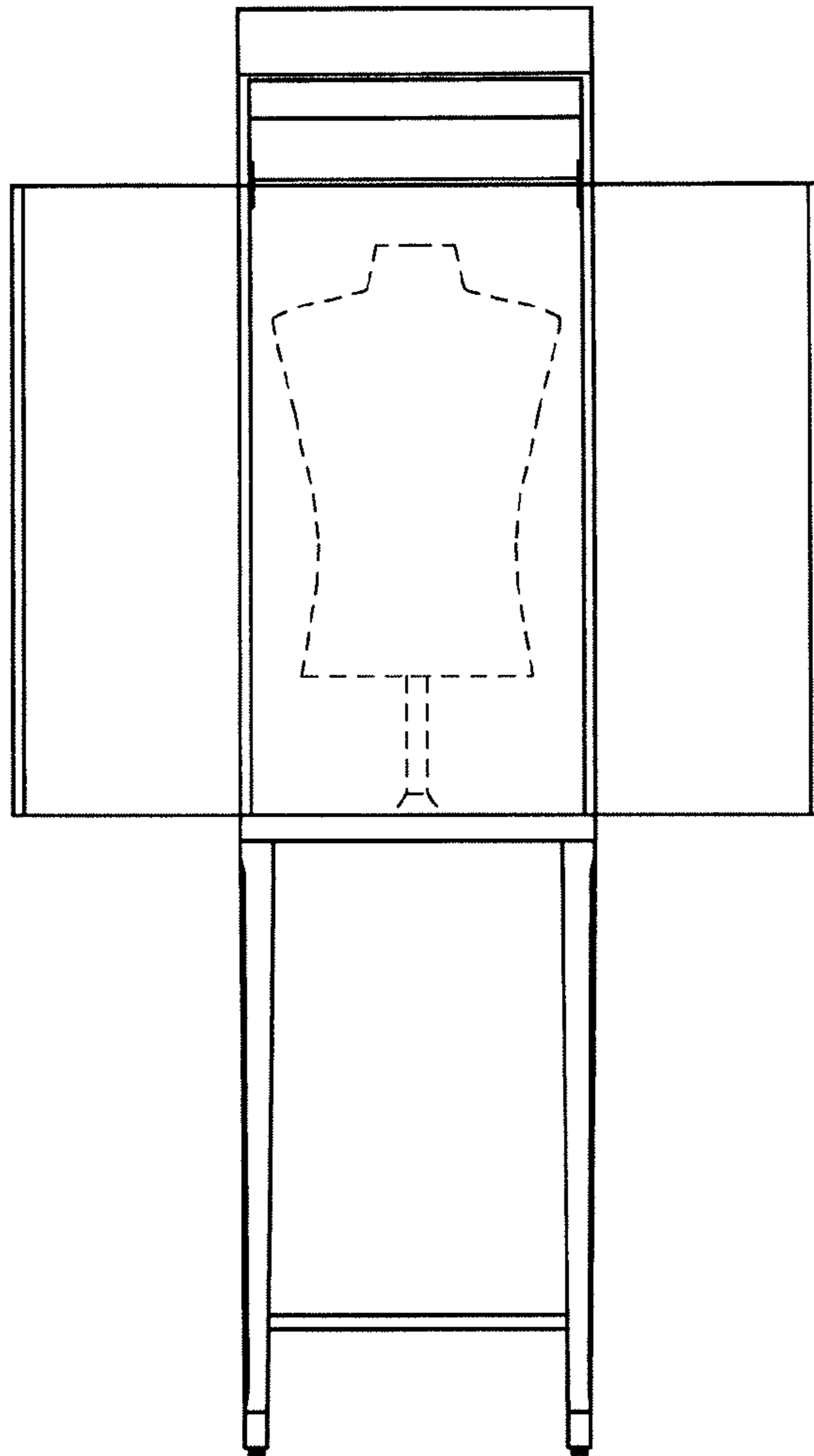

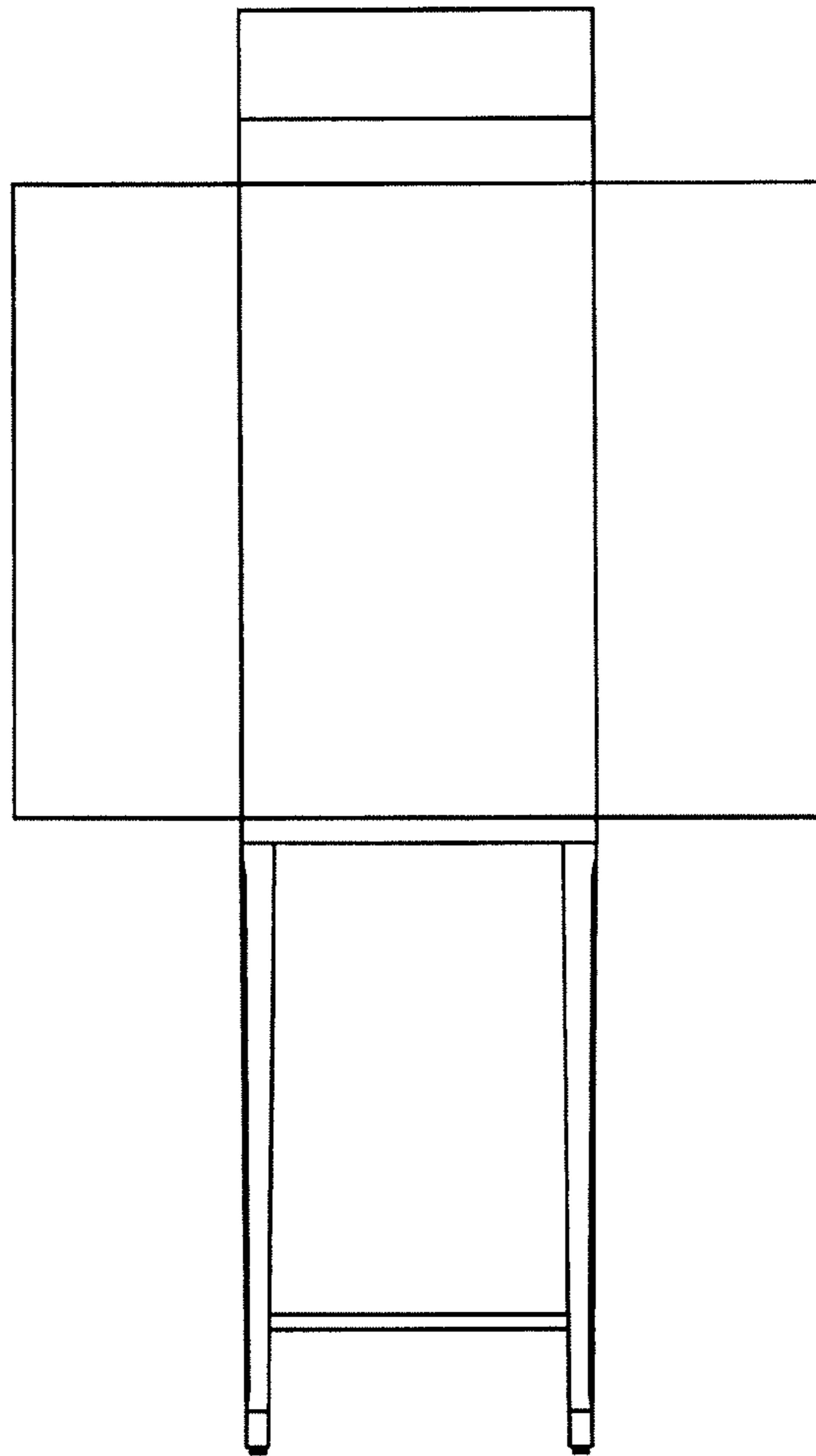

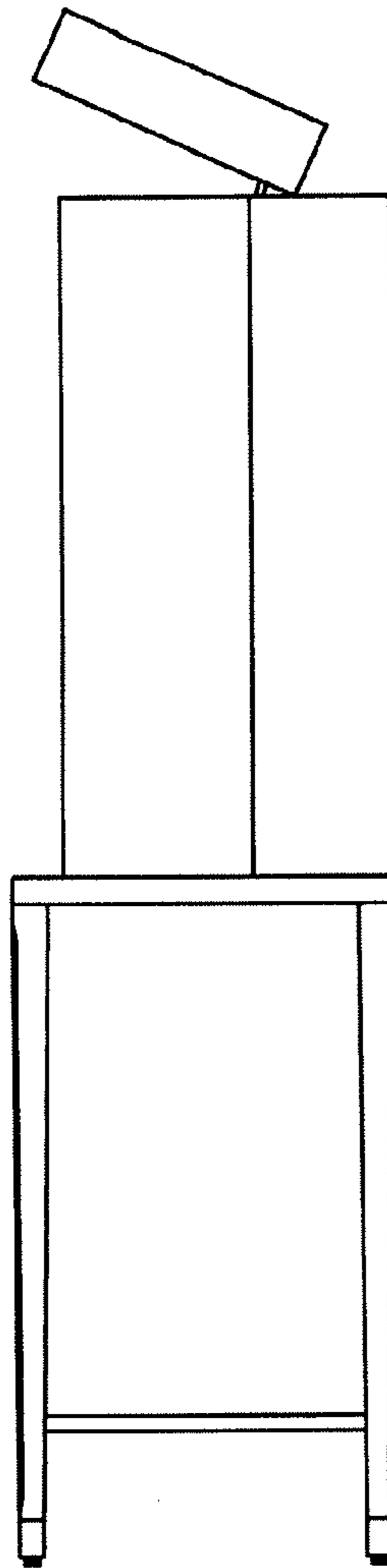

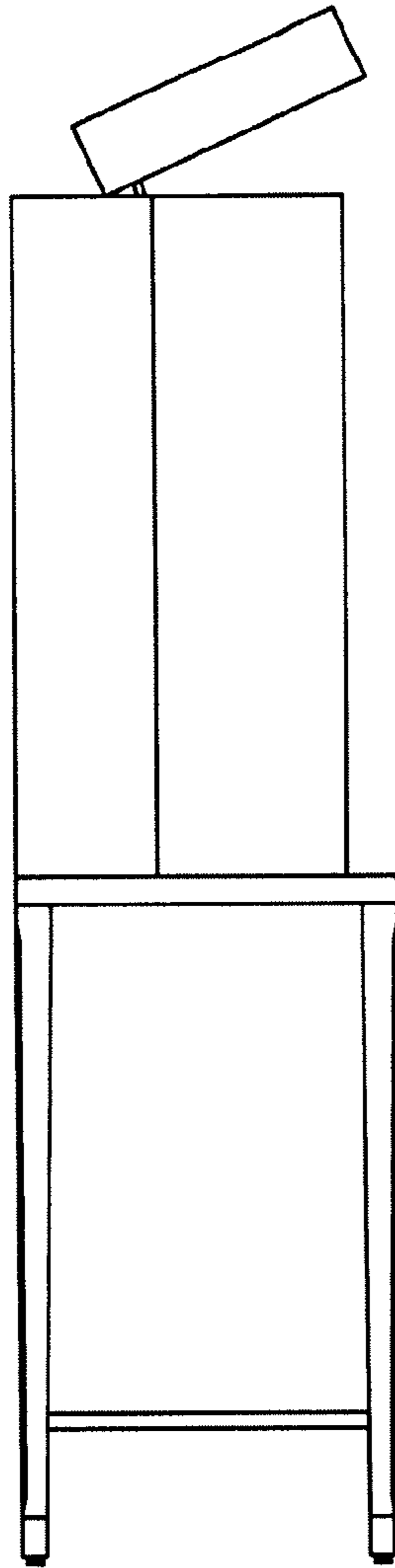

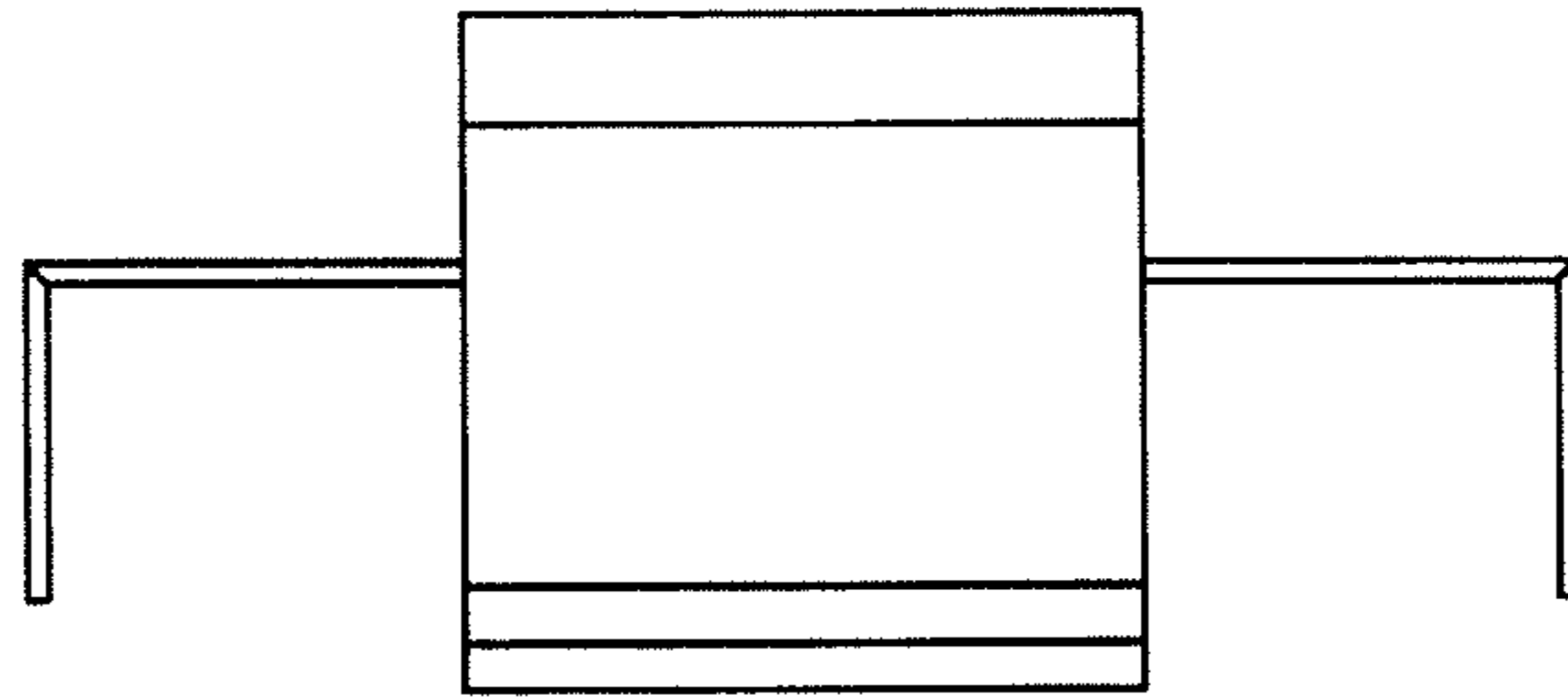

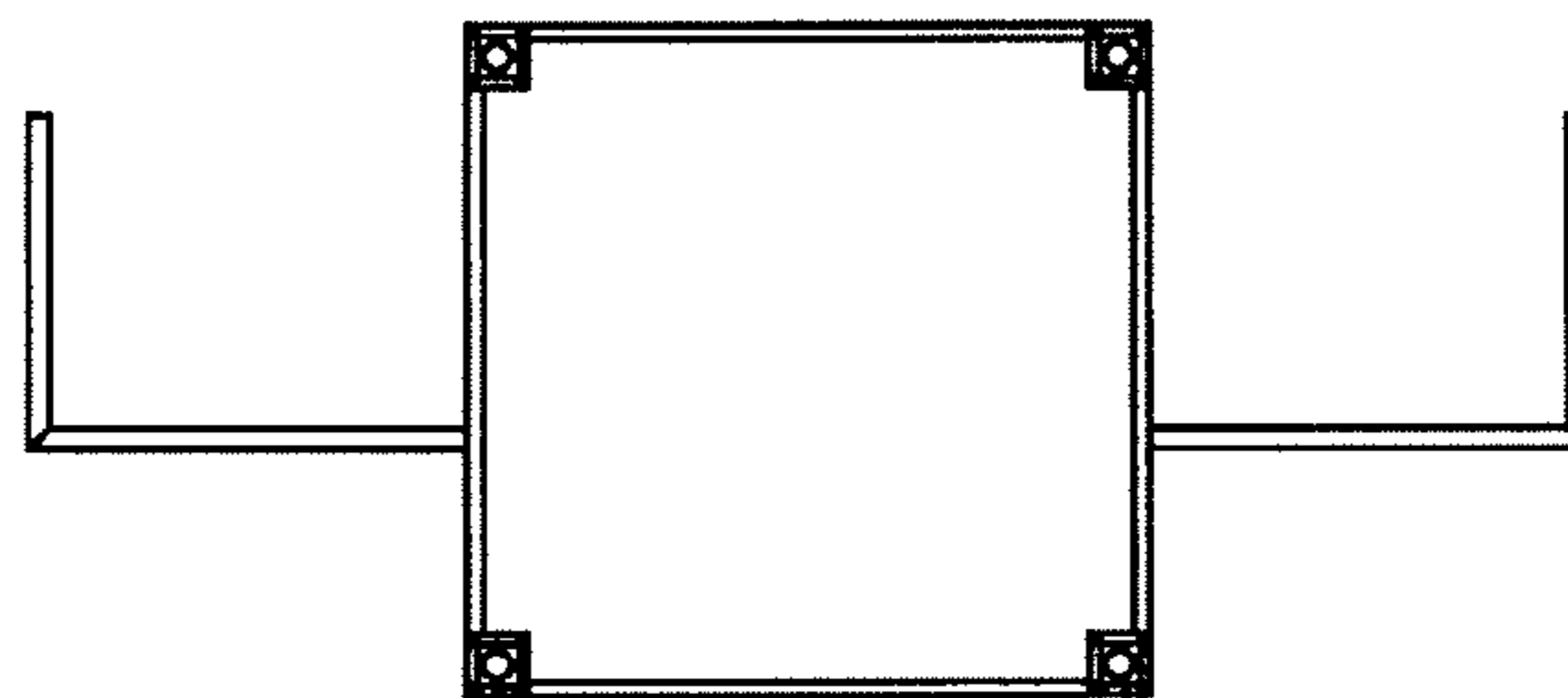

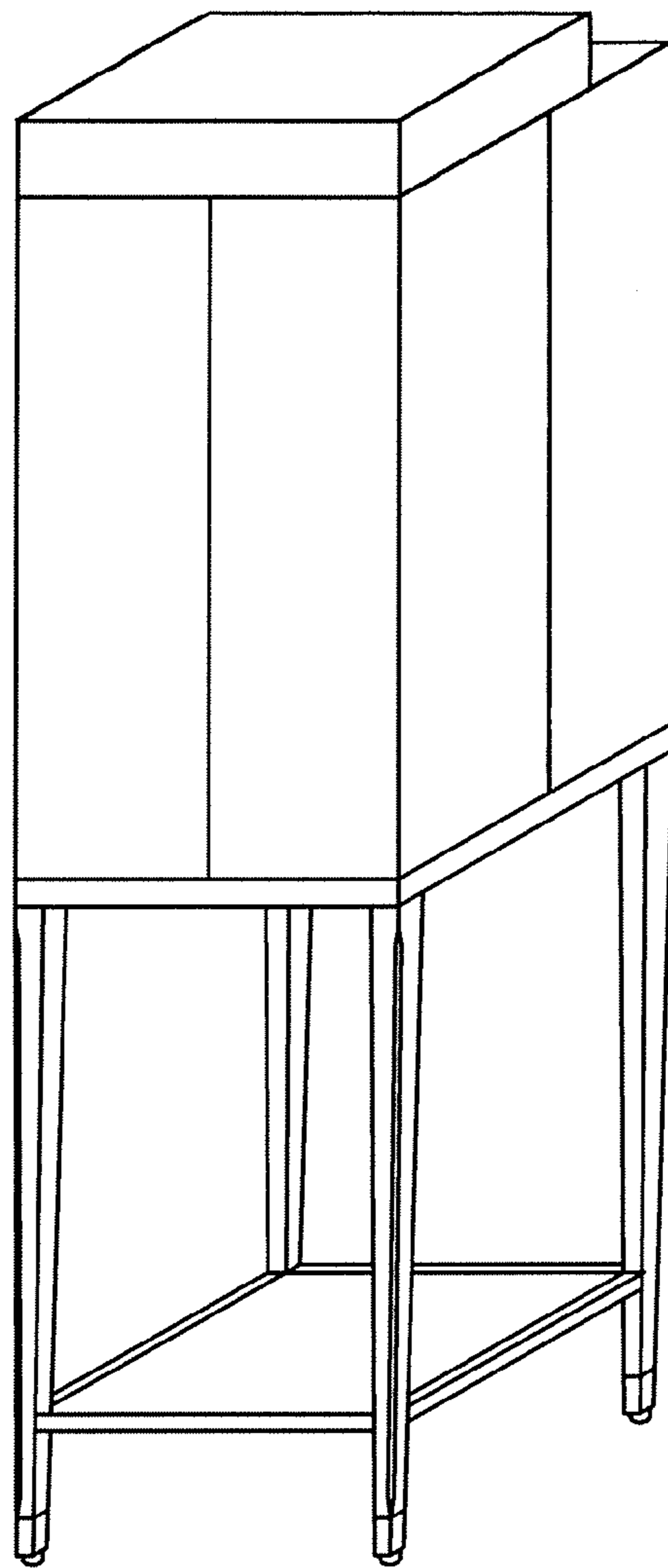

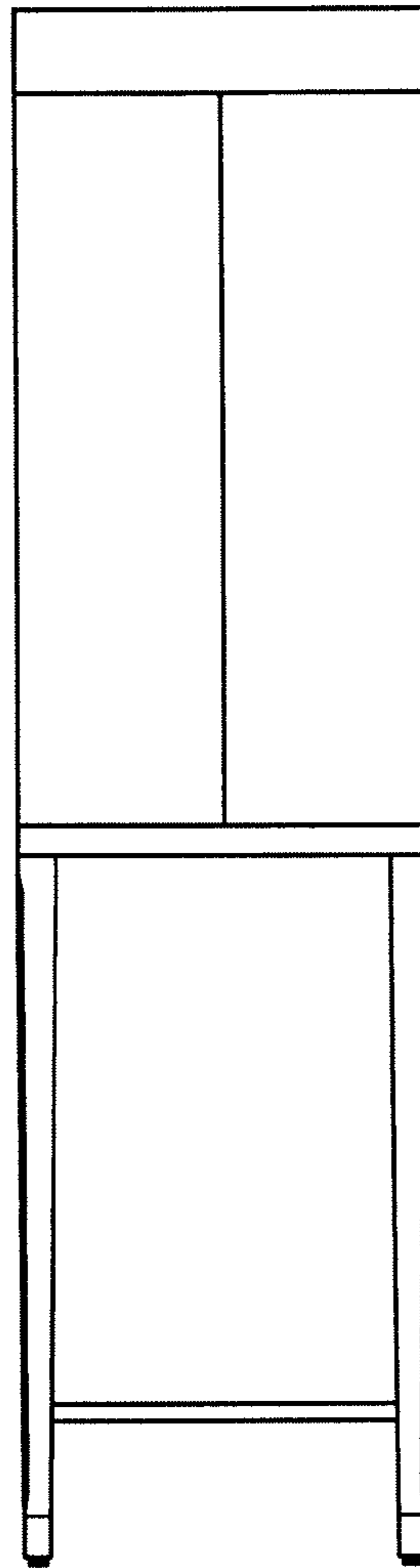

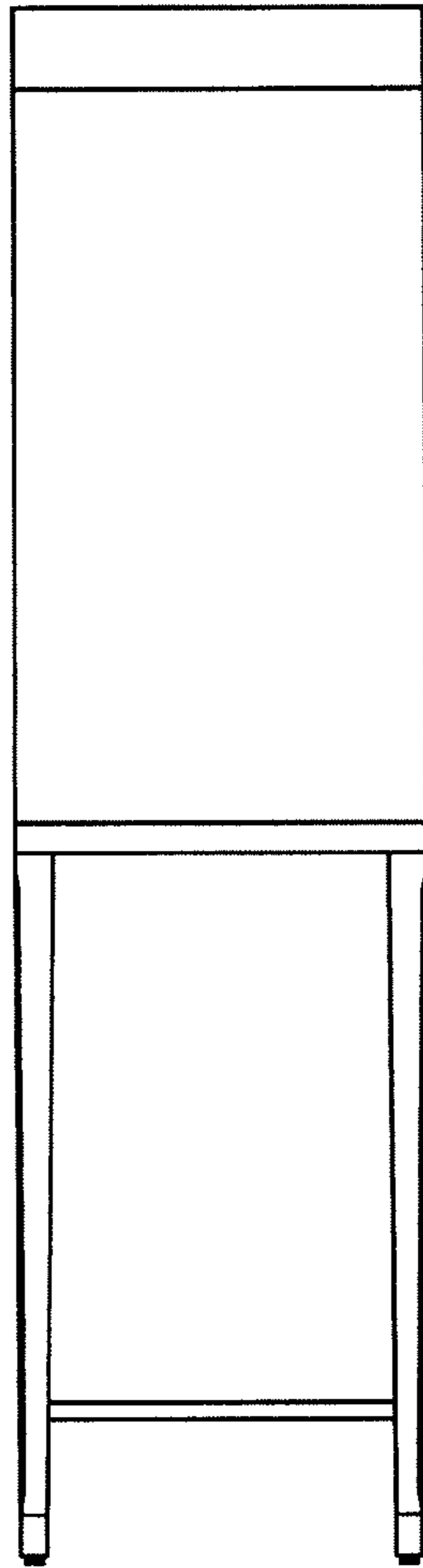

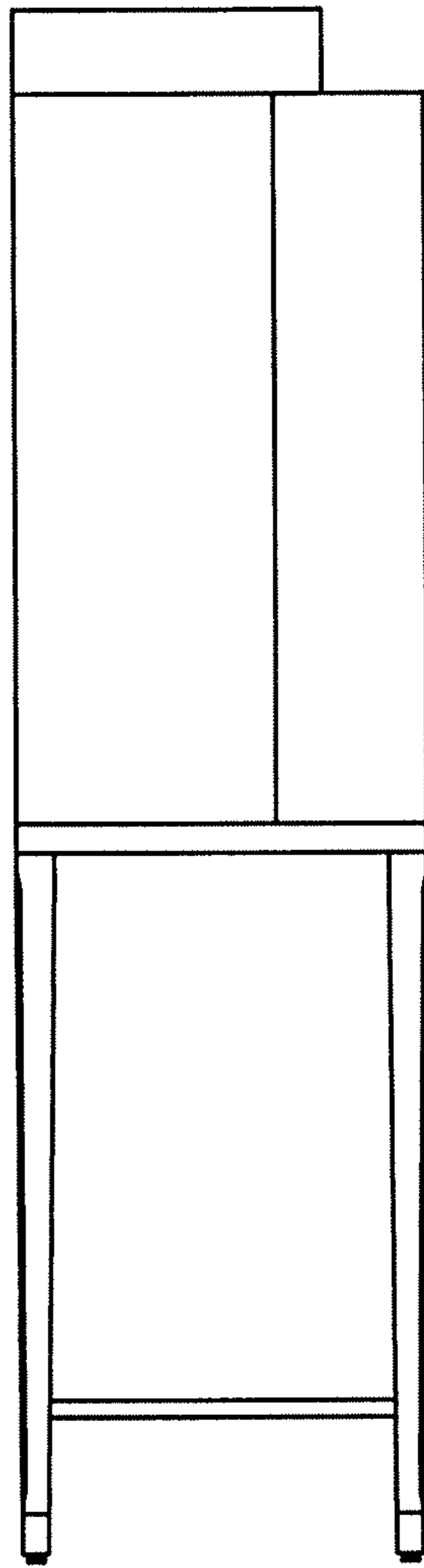

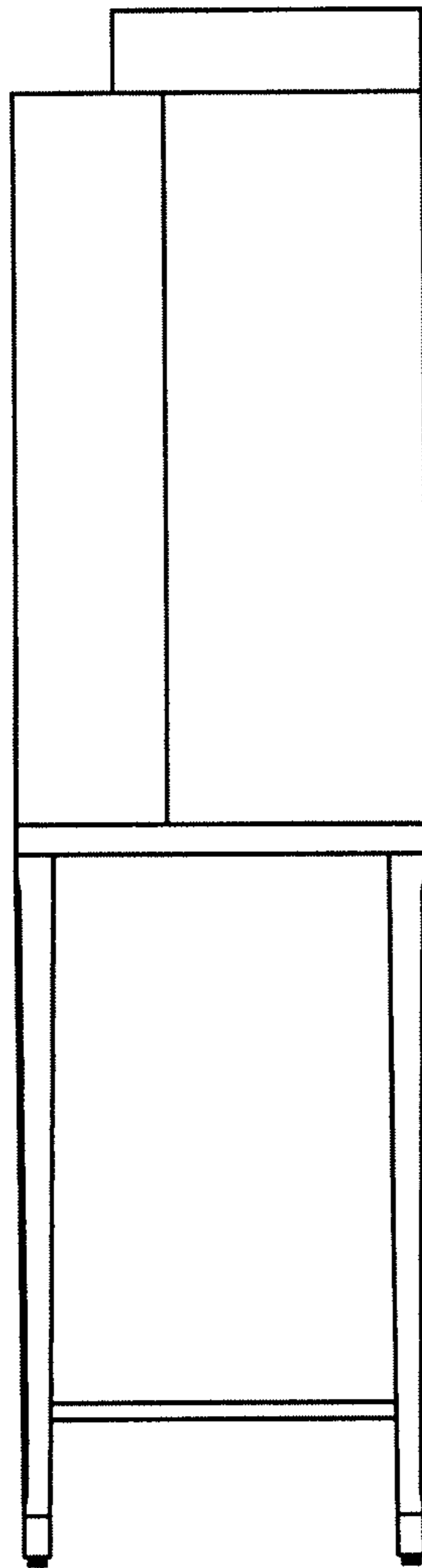

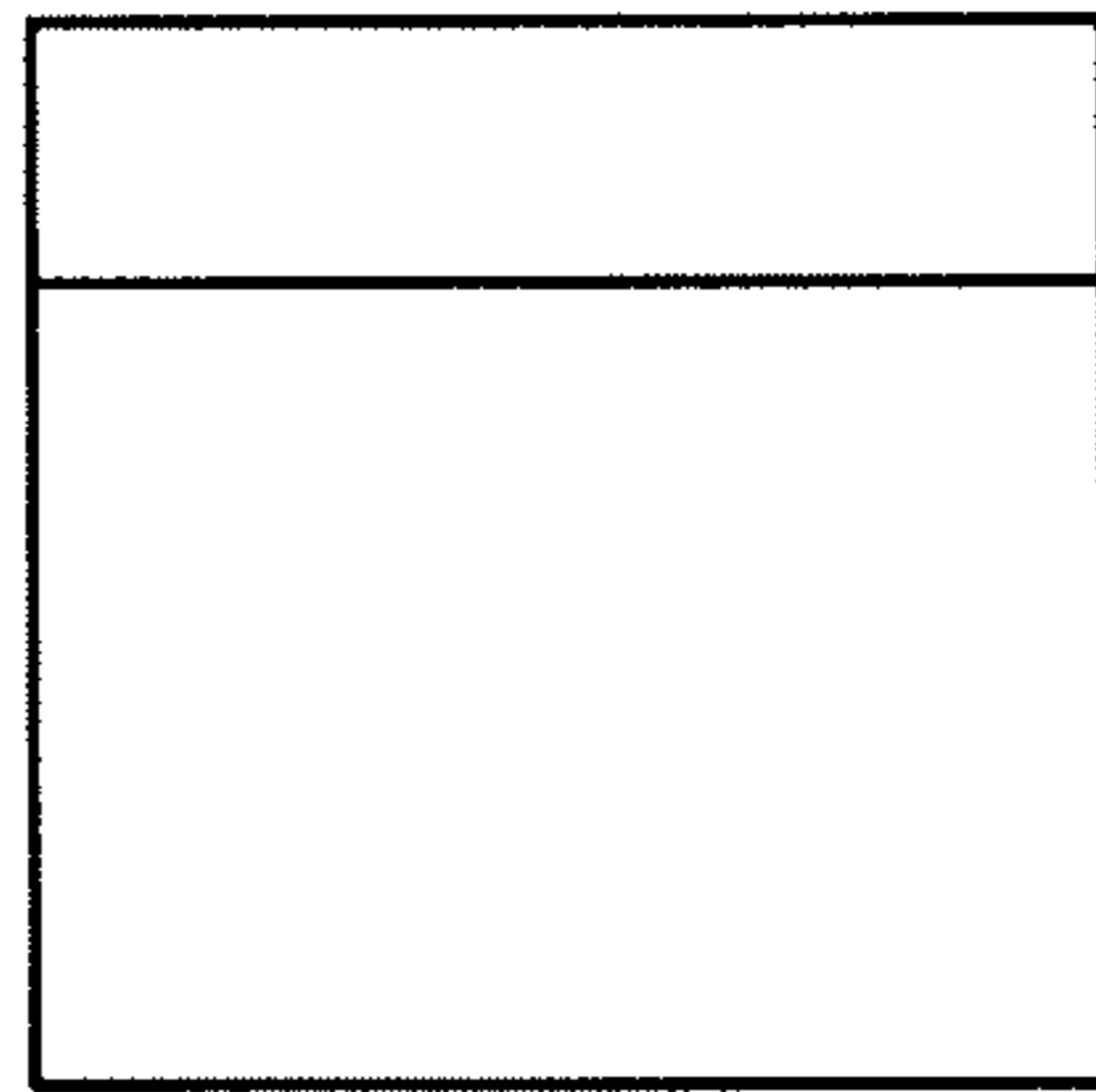

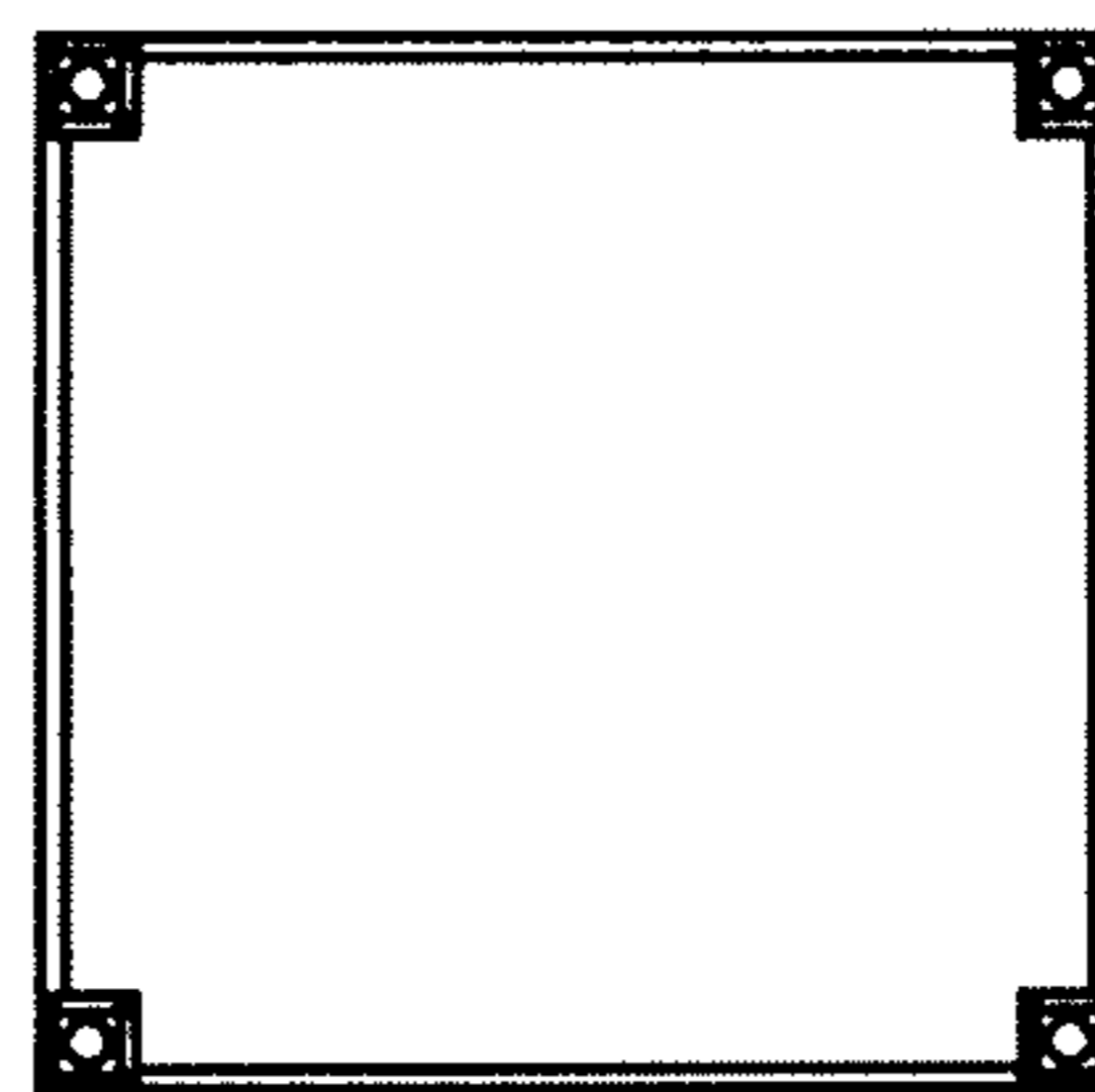

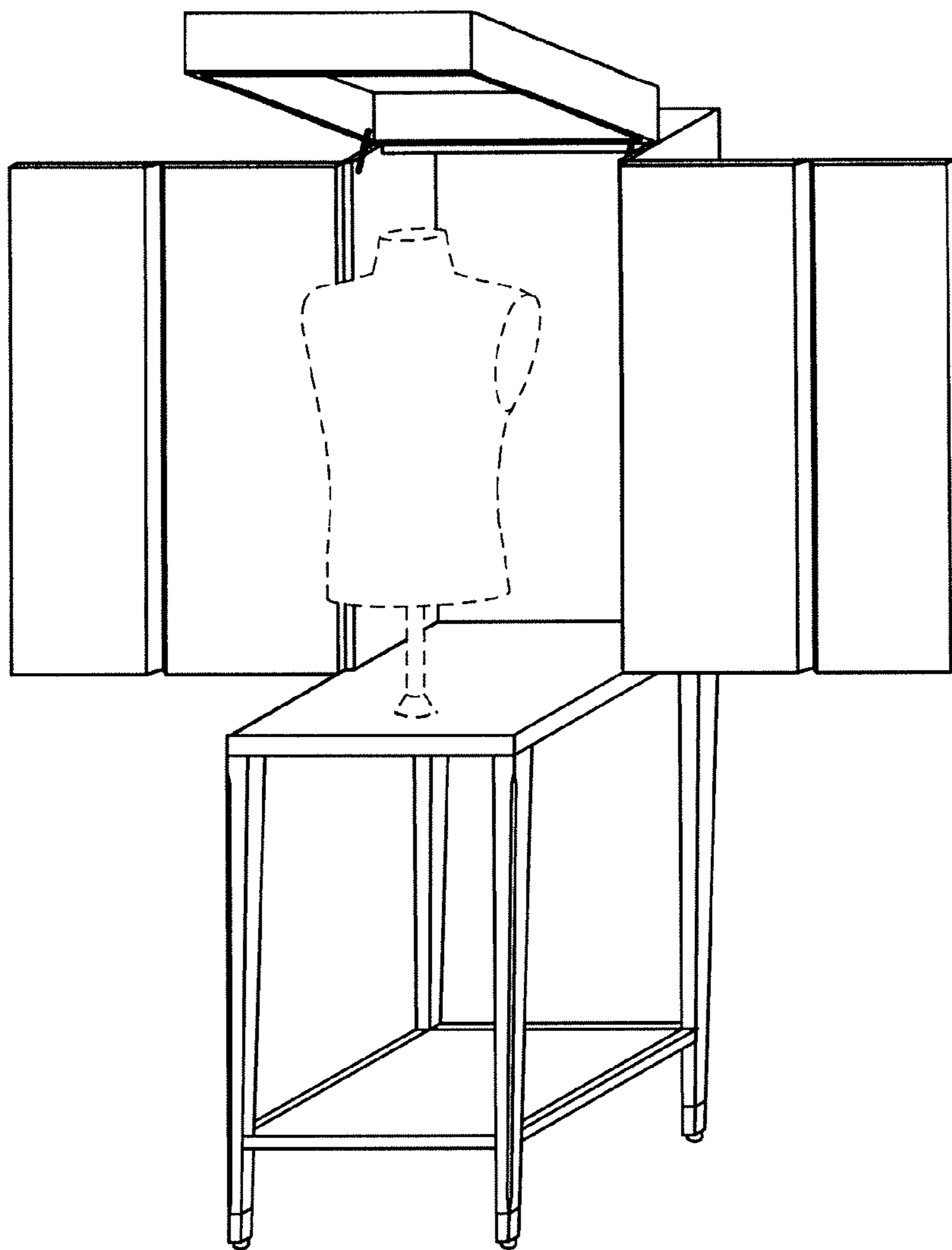

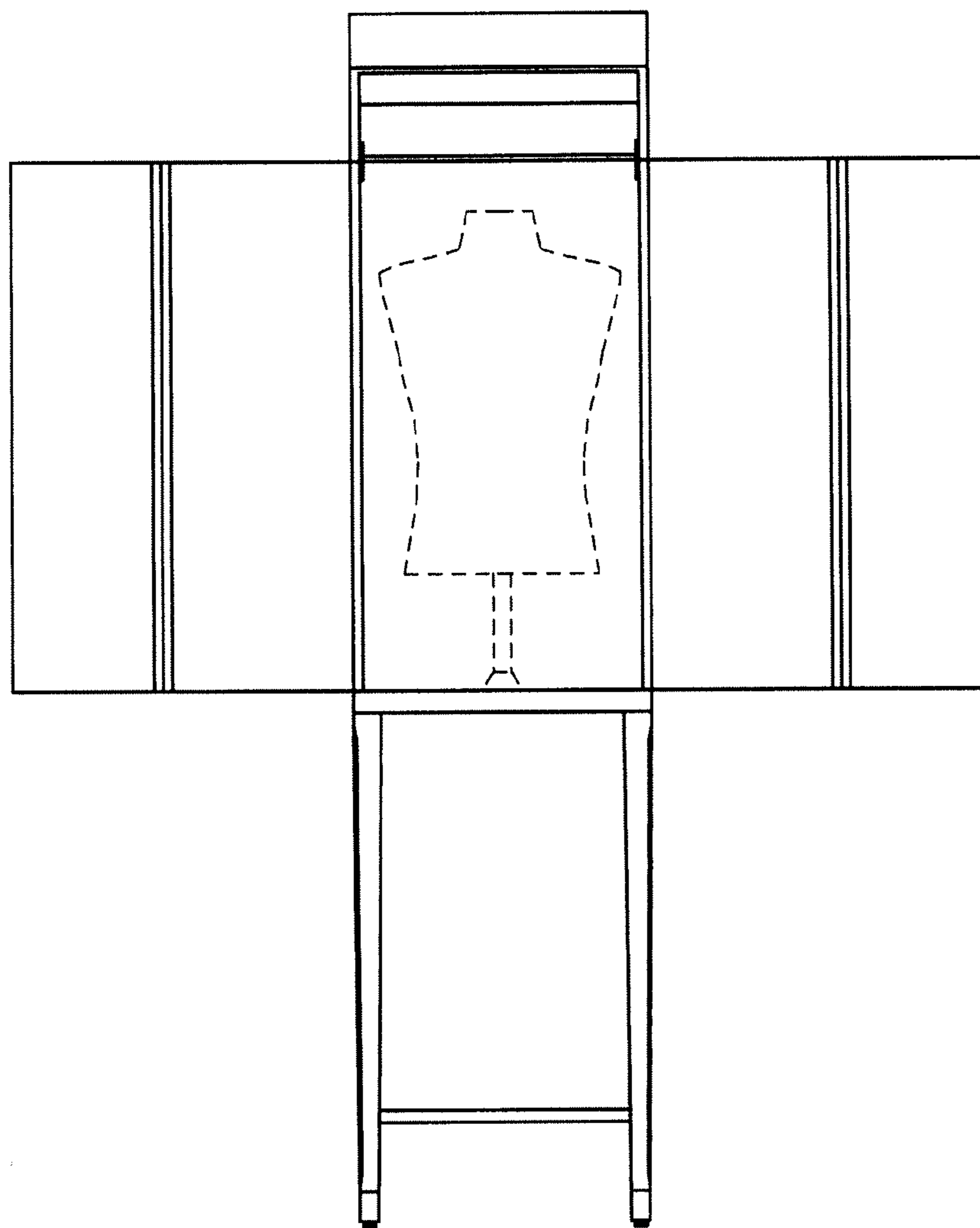

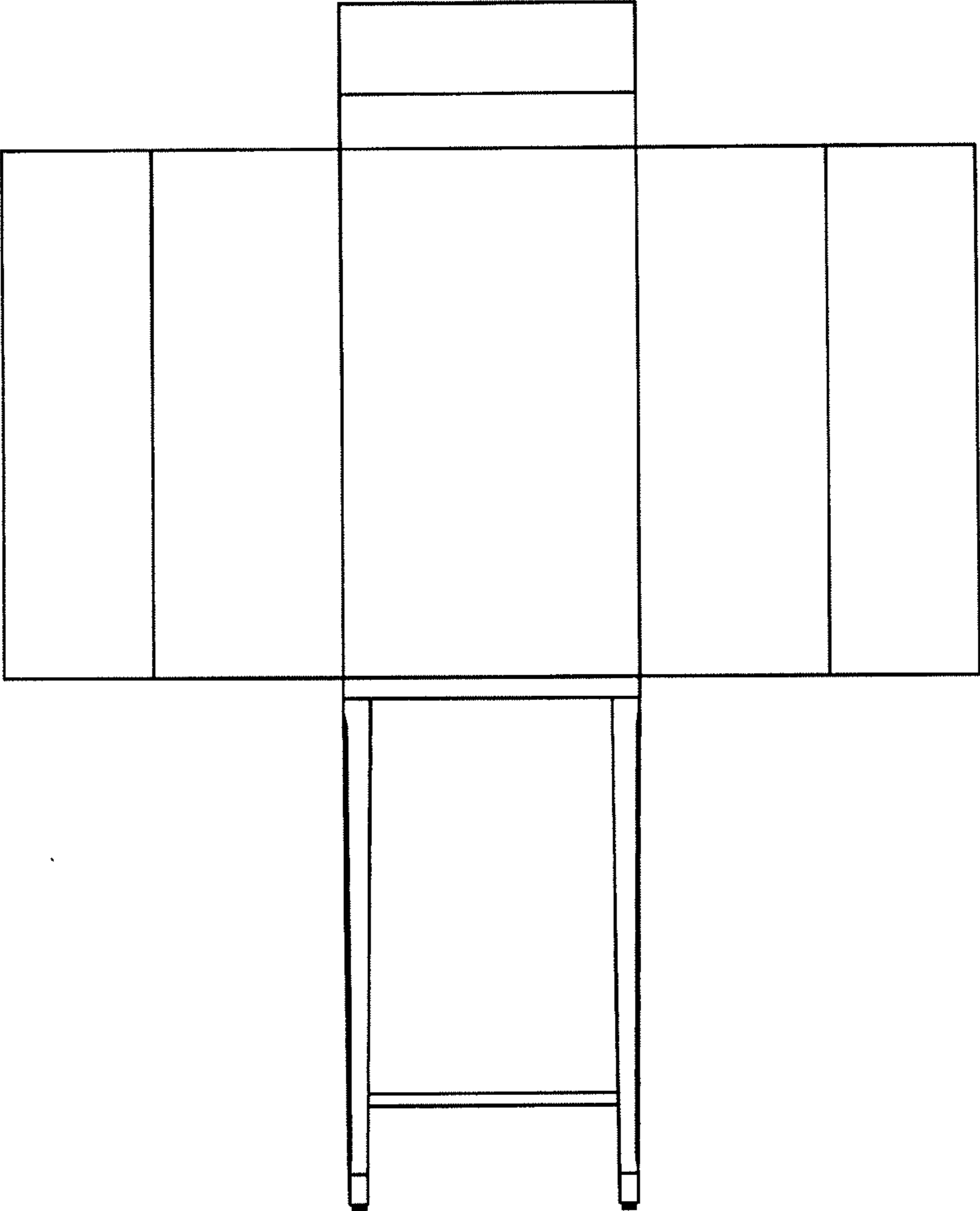

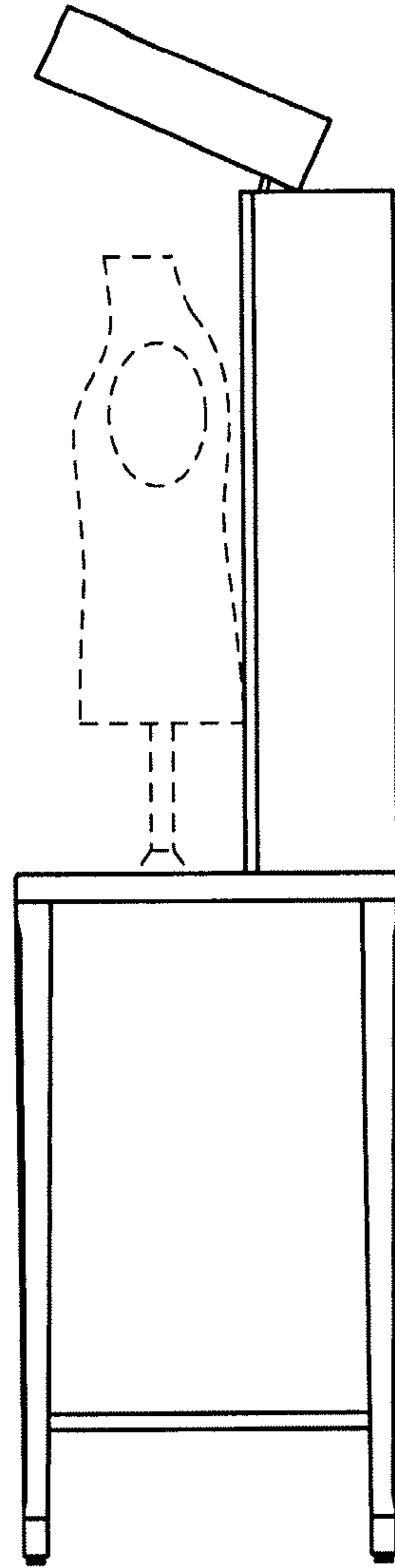

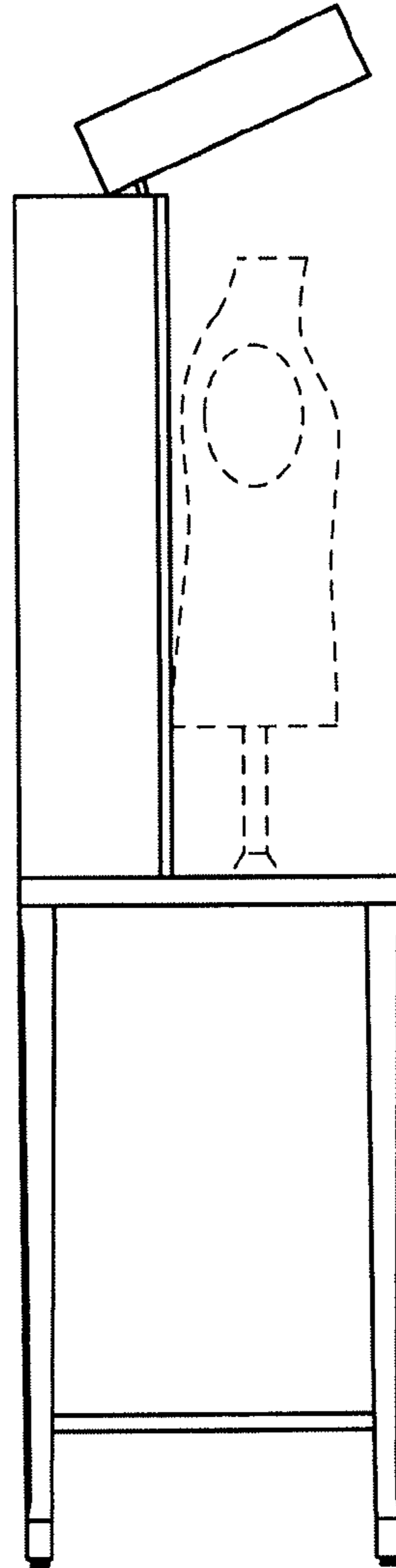

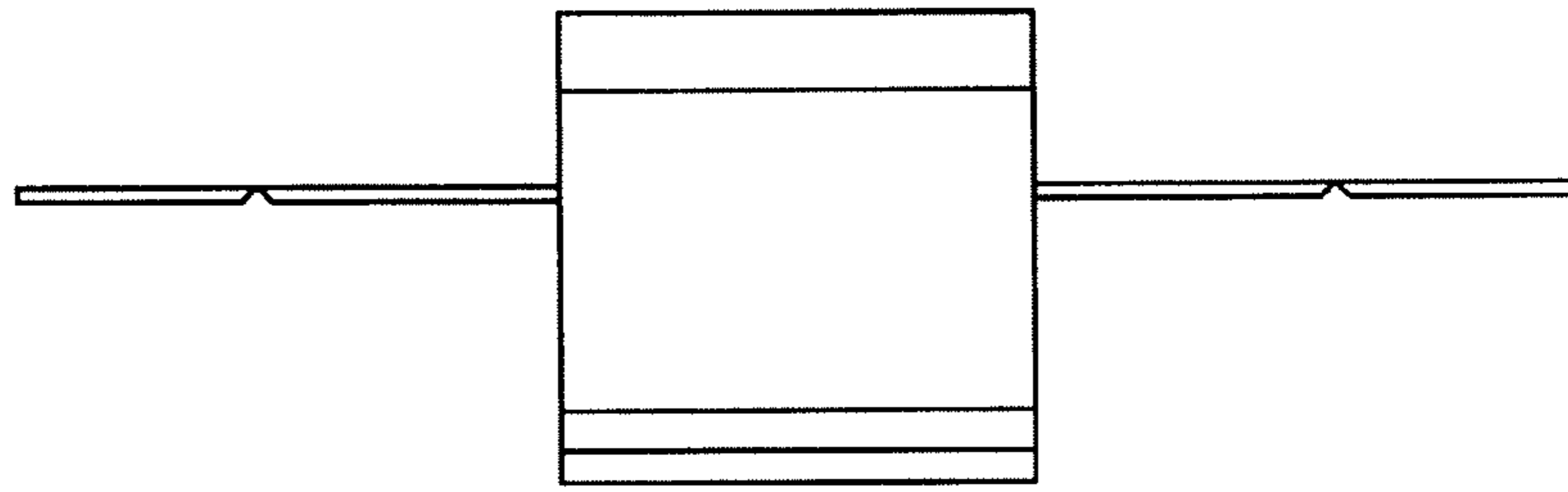

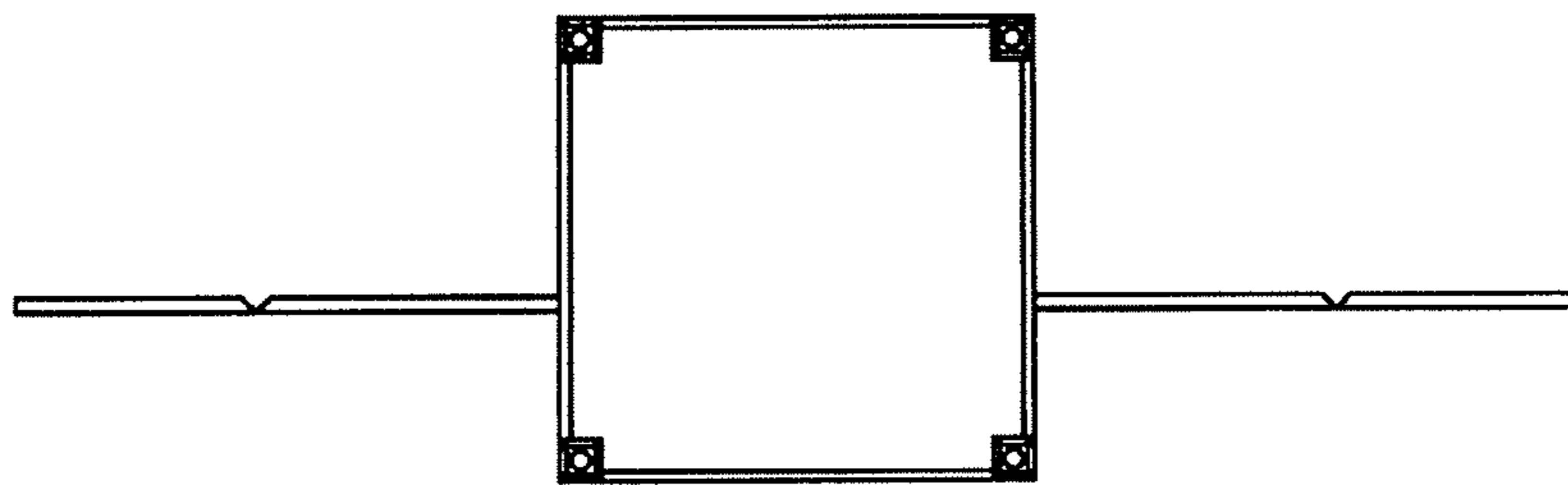
