**DESCRIPTION**

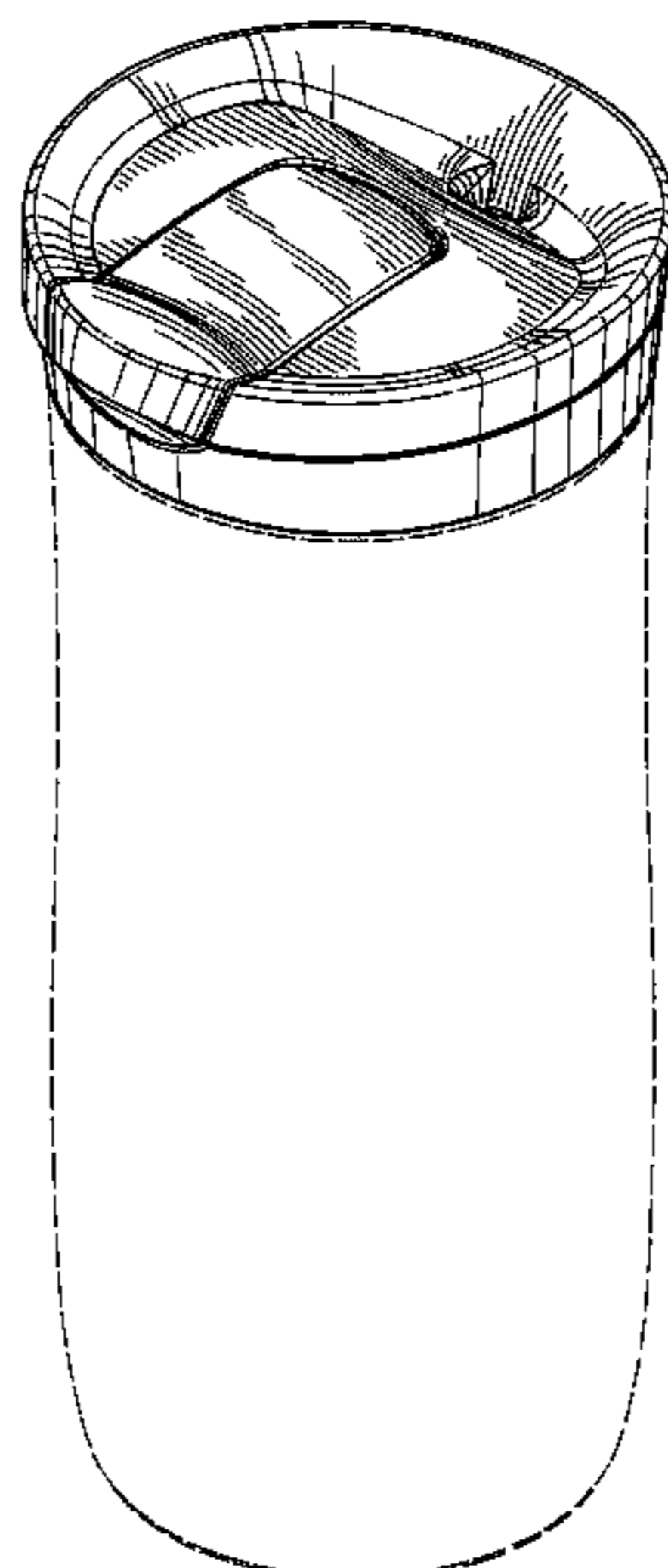
FIG. 1 is a perspective view of a lid for a beverage container according to the new design;

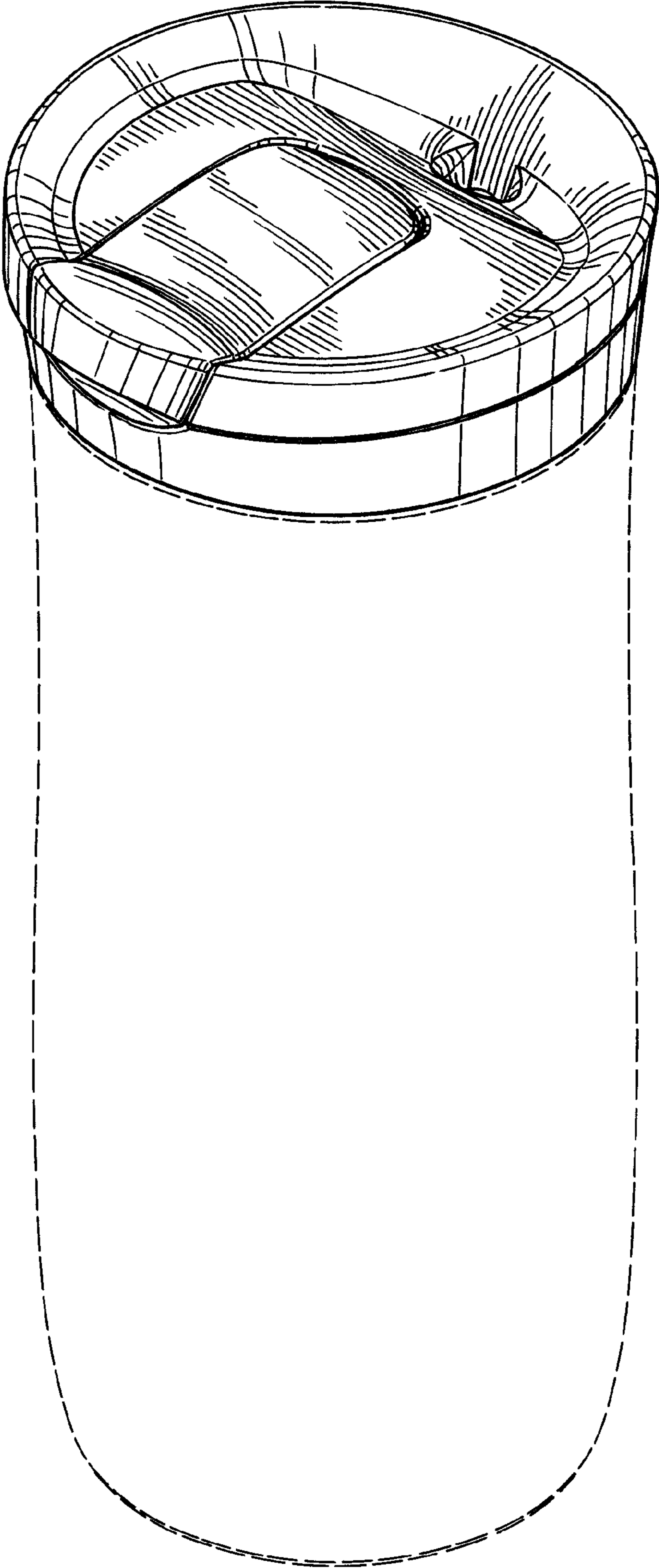

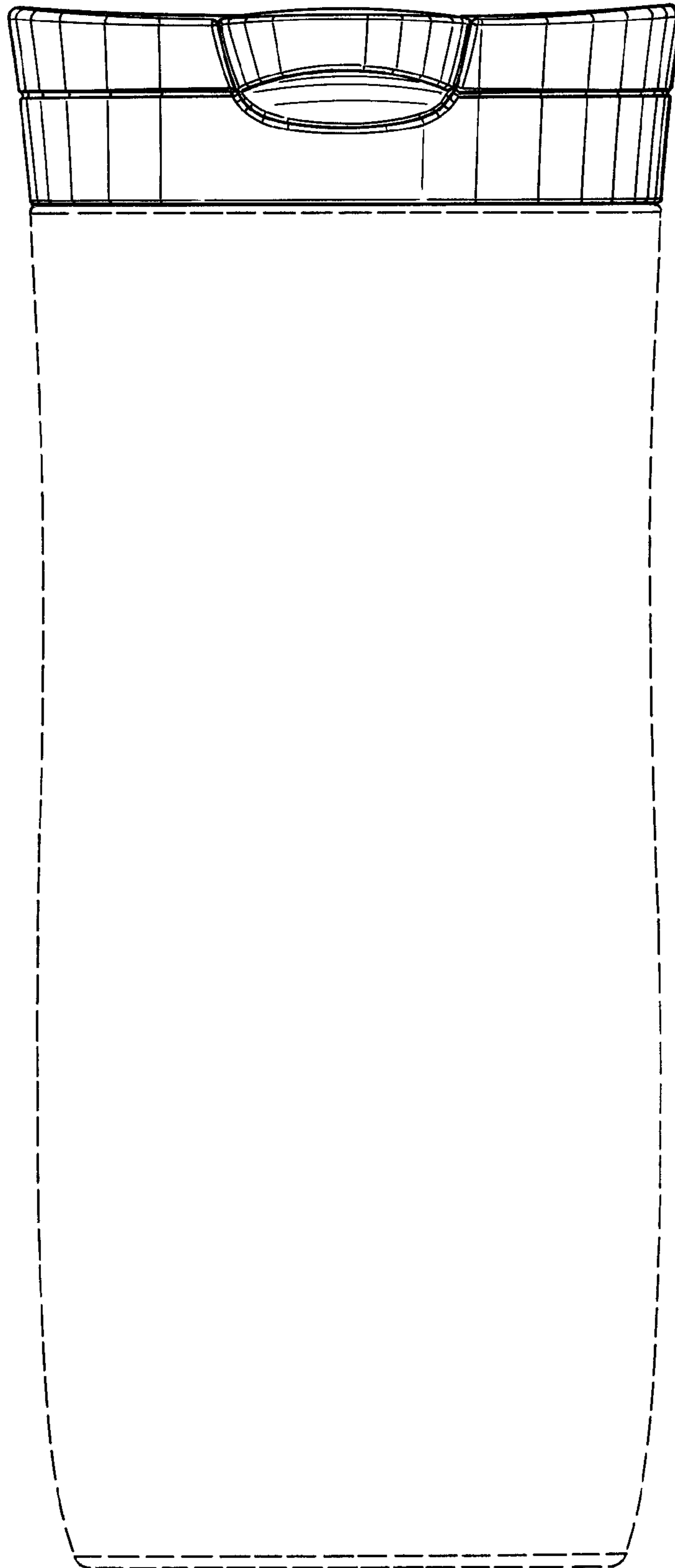

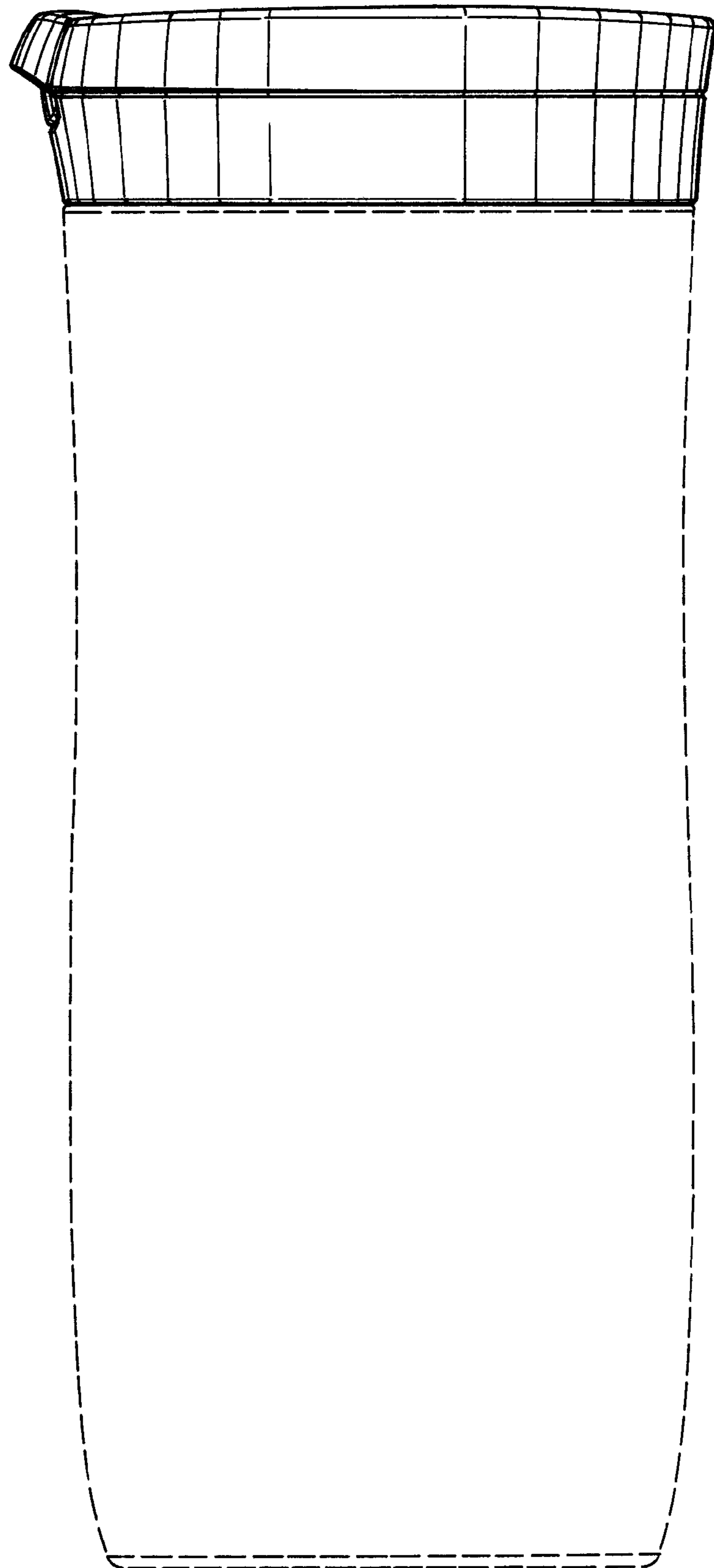

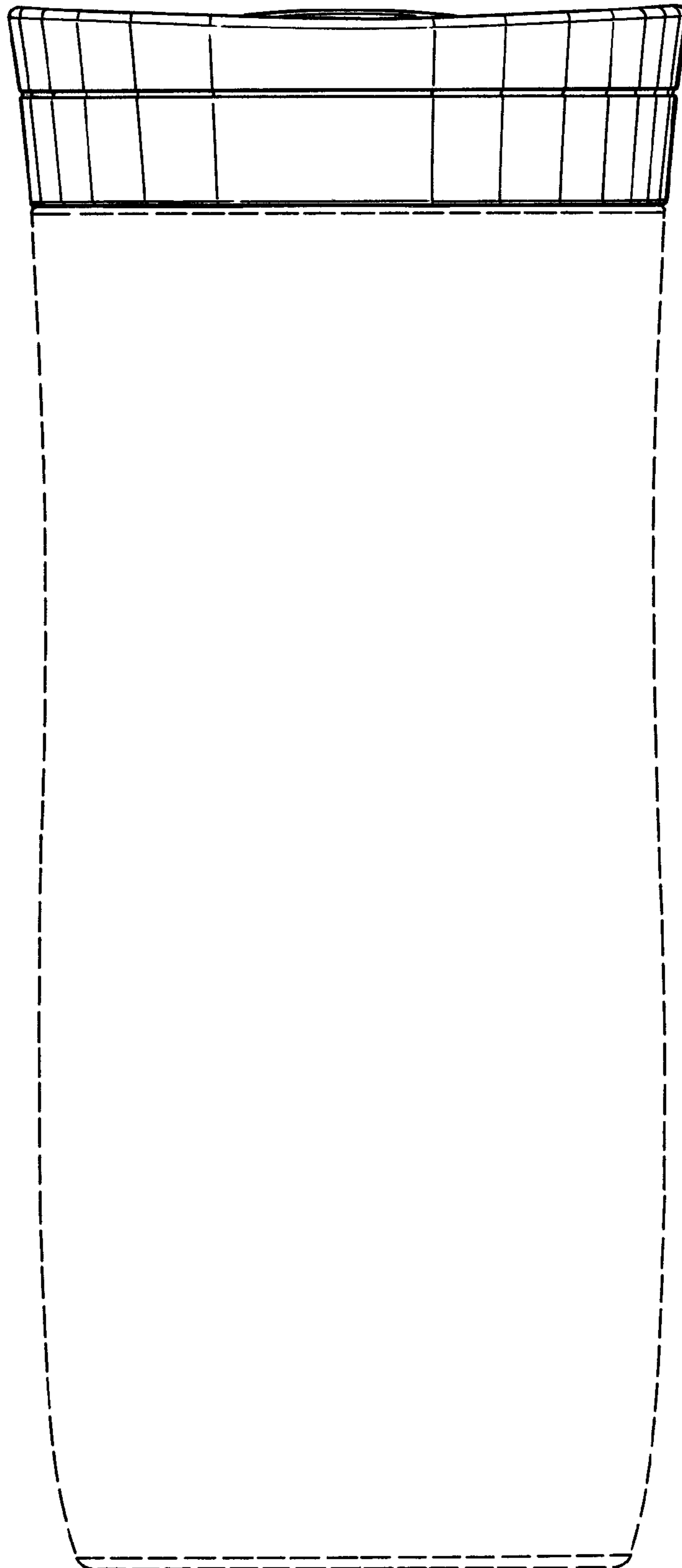

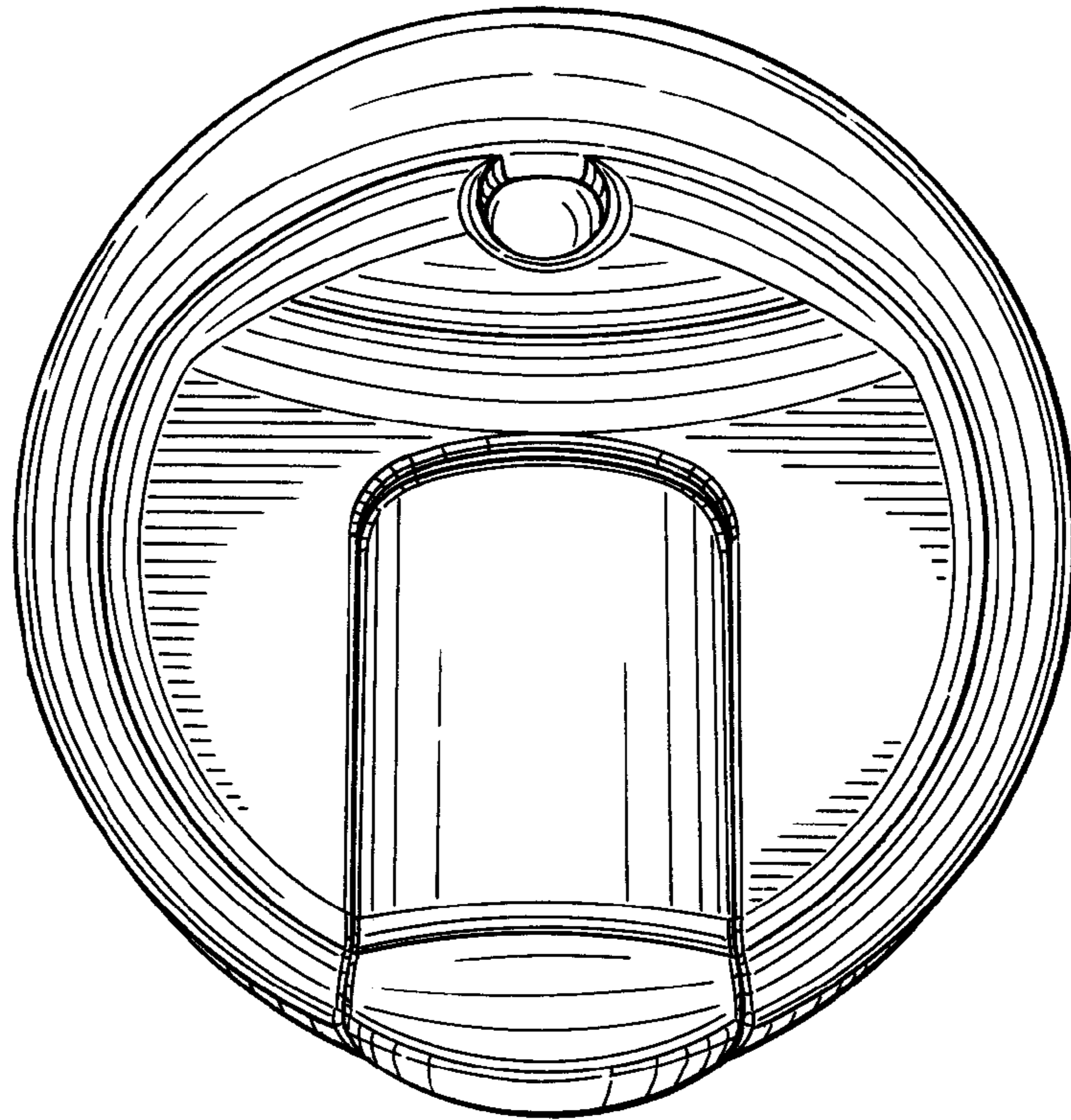
