(57) **CLAIM**

The ornamental design for an insulated beverage cup, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front perspective view of an insulated beverage cup embodying the new design, with a portion in dotted lines representing portions of a matching lid that form no part of the claimed design;

FIG. 2 is a side view of the insulated beverage cup of FIG. 1; FIG. 3 is a side view of the insulated beverage cup of FIG. 1; FIG. 4 is a front view of the insulated beverage cup of FIG. 1; FIG. 5 is a rear view of the insulated beverage cup of FIG. 1; FIG. 6 is a top view of the insulated beverage cup of FIG. 1; FIG. 7 is a bottom view of the insulated beverage cup of FIG. 1;

FIG. 8 is a sectional view of the insulated beverage cup taken along cut line 8-8 of FIG. 6;

FIG. 9 is a top view of the insulated beverage cup of FIG. 1 without the unclaimed portion representing of the matching lid; and,

FIG. 10 is a top front perspective view of the insulated beverage cup of FIG. 1 without the unclaimed portion representing the matching lid.

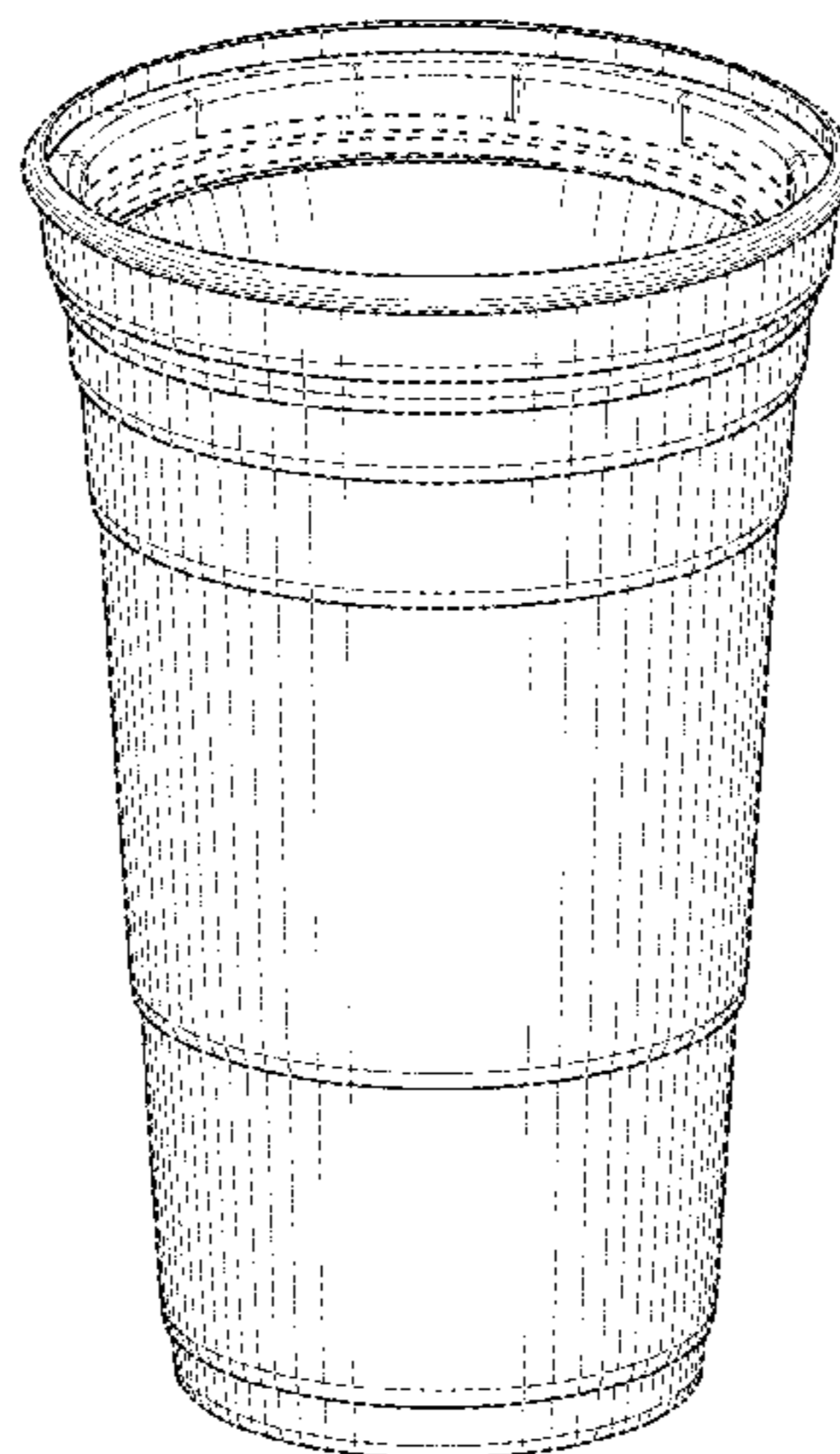
A lid assembly for the insulated beverage cup is shown in broken lines for illustrative purposes only and forms no part of the claimed design.

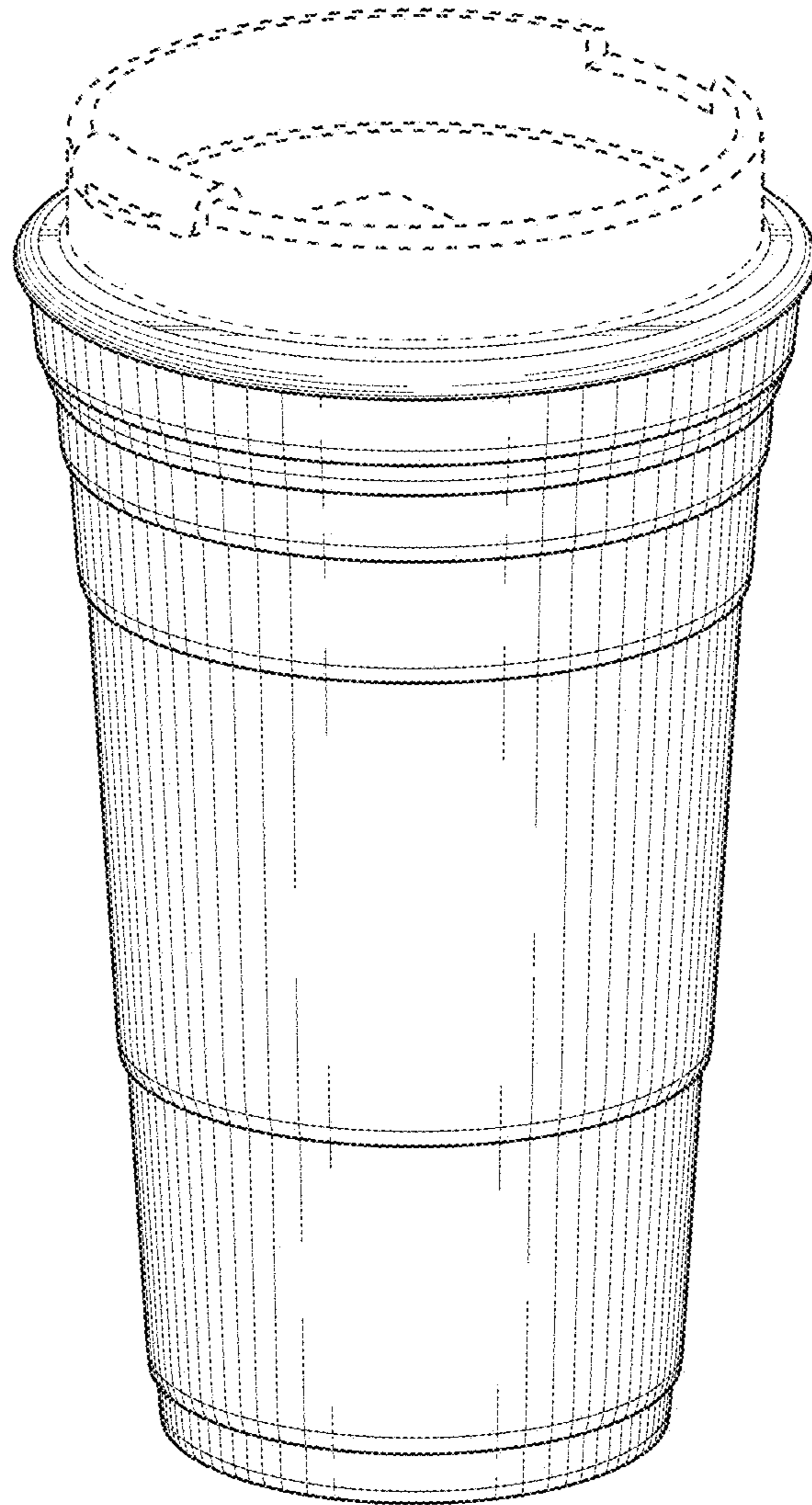

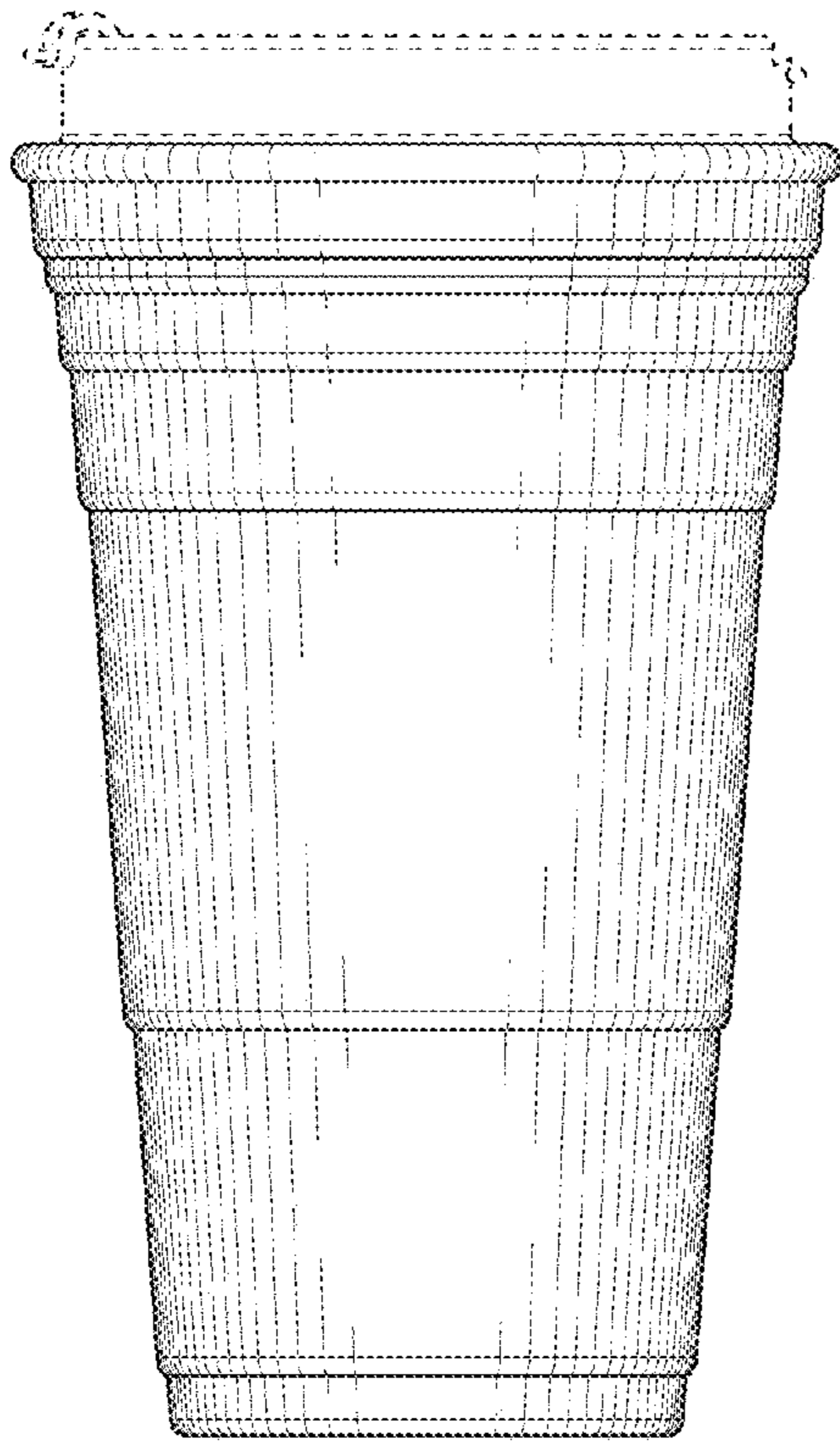

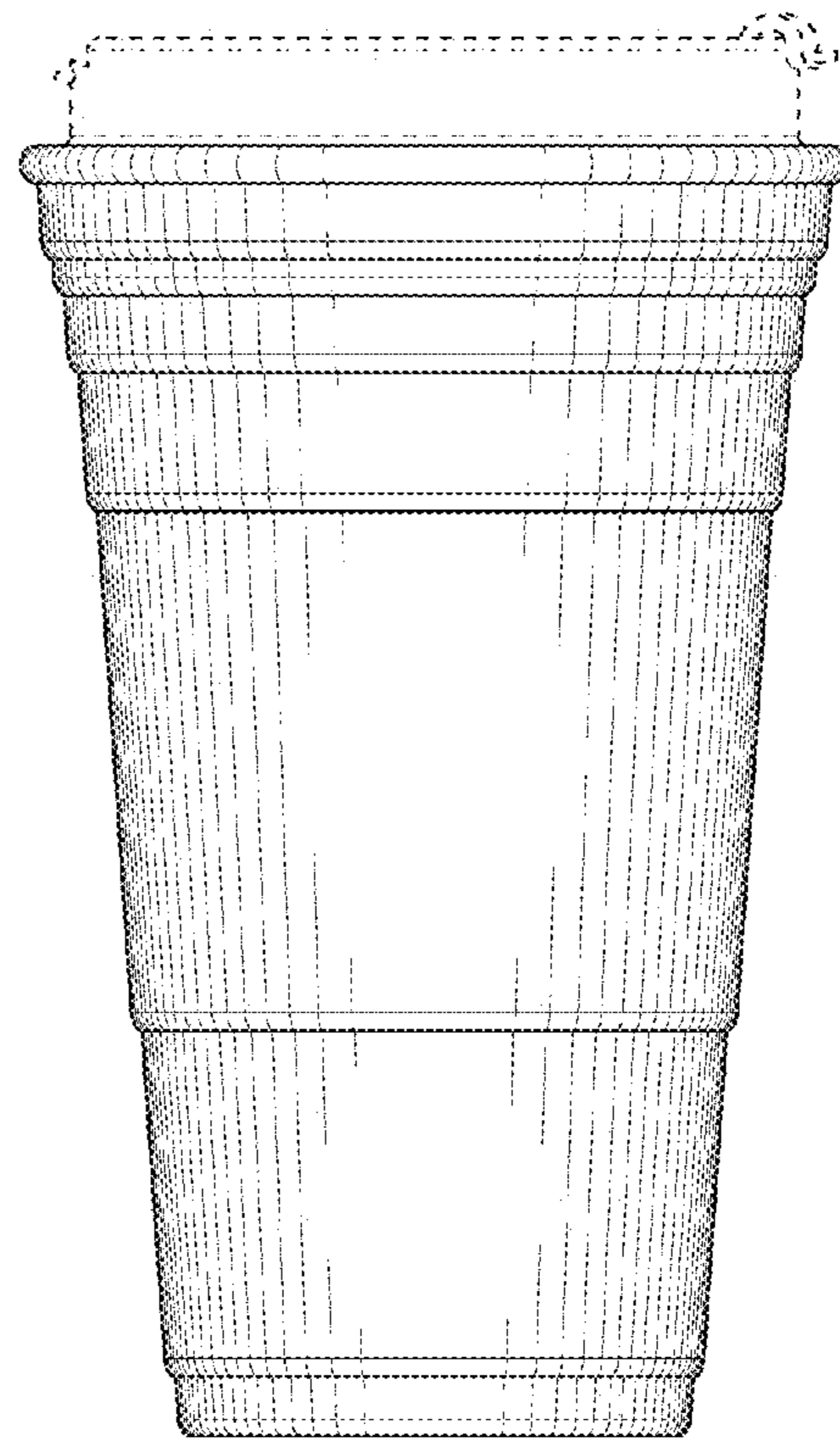

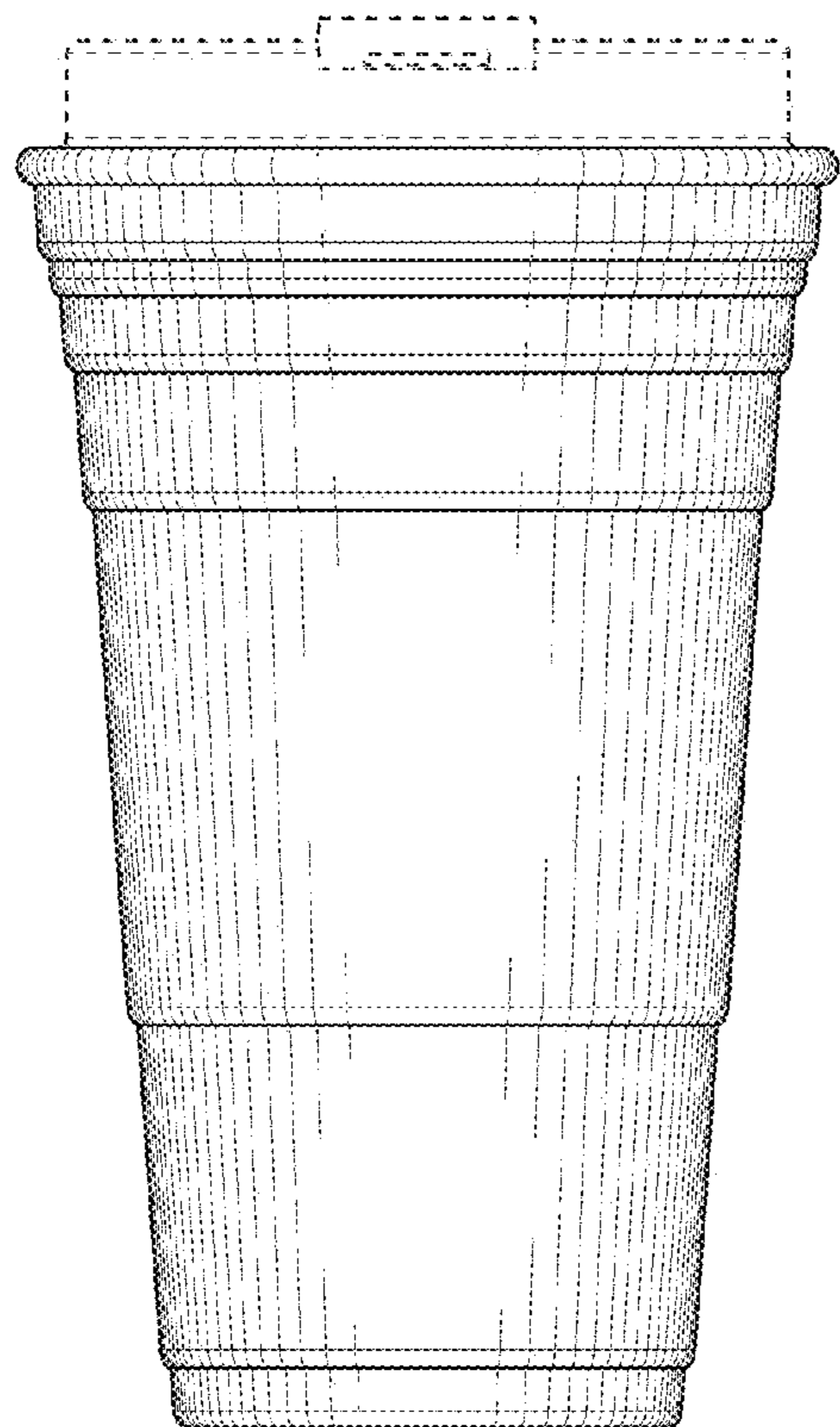

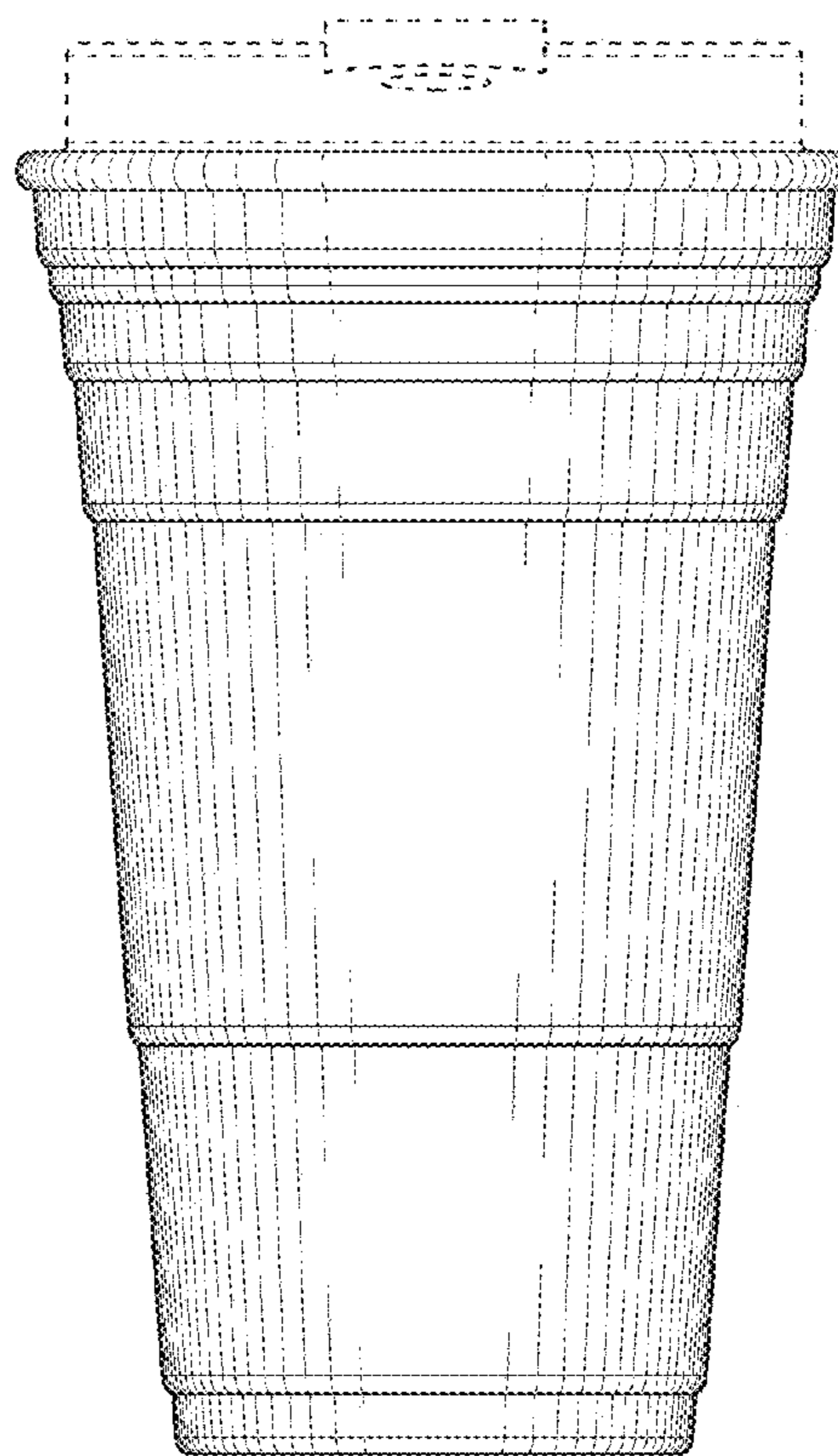

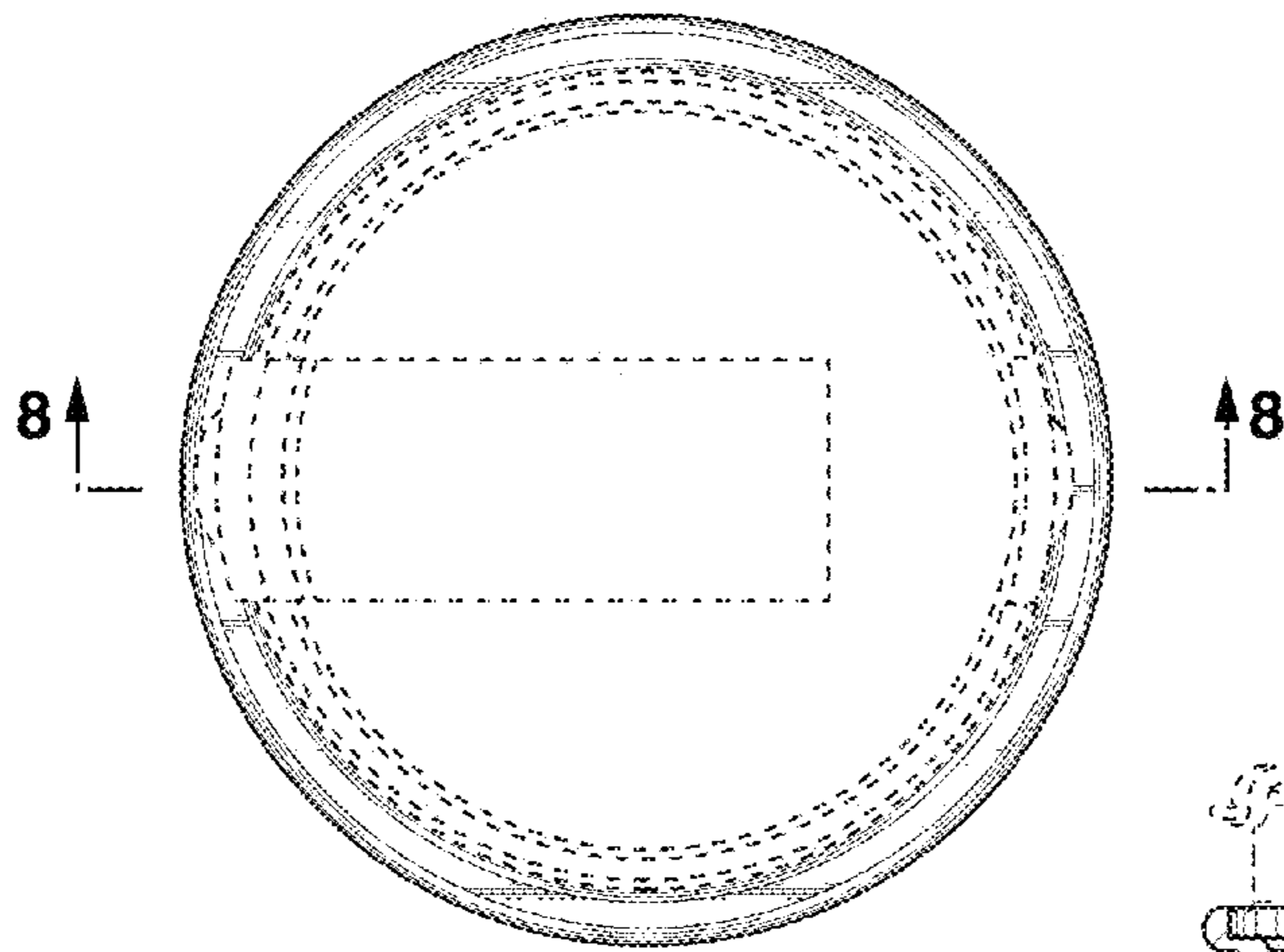

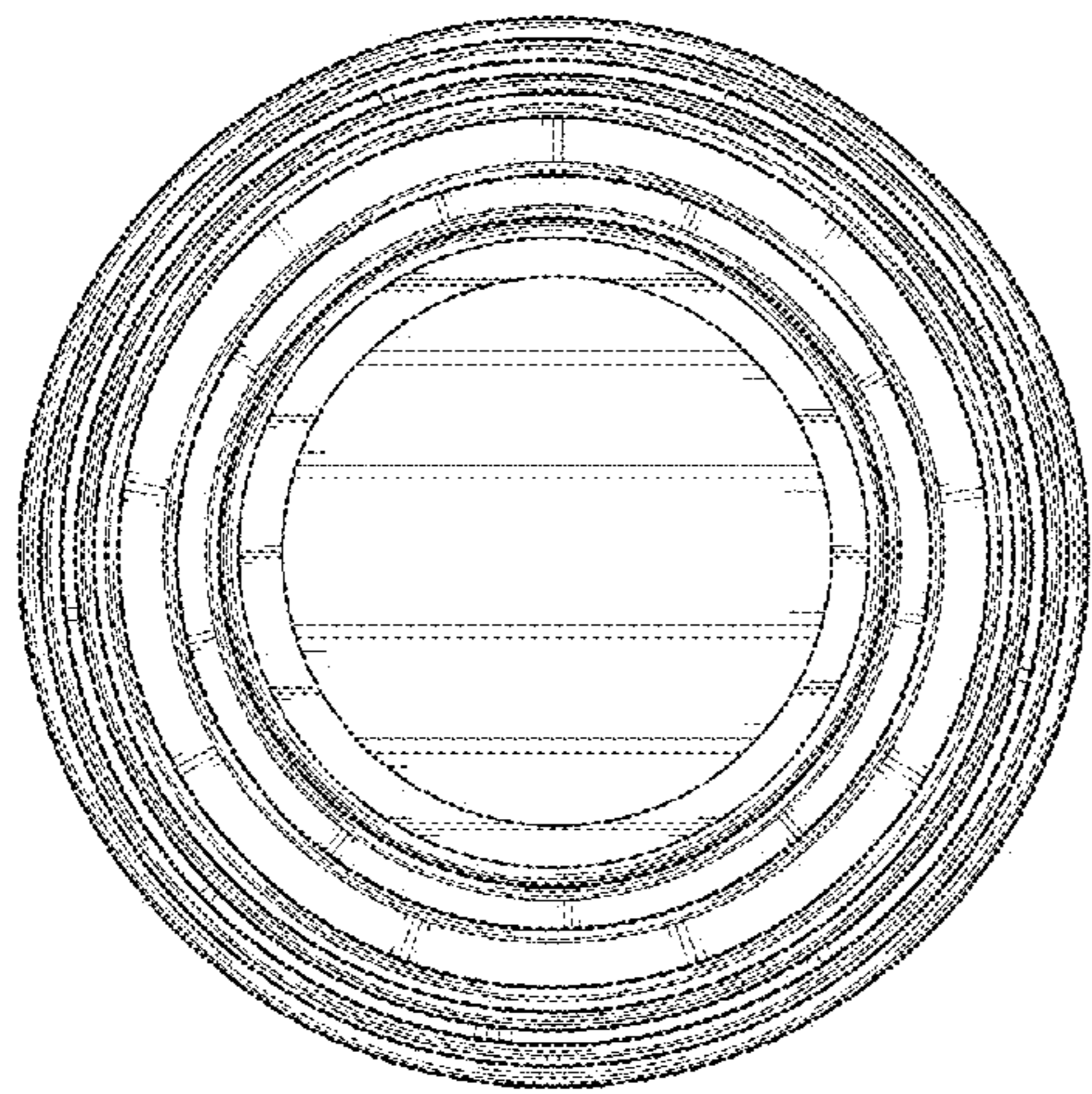

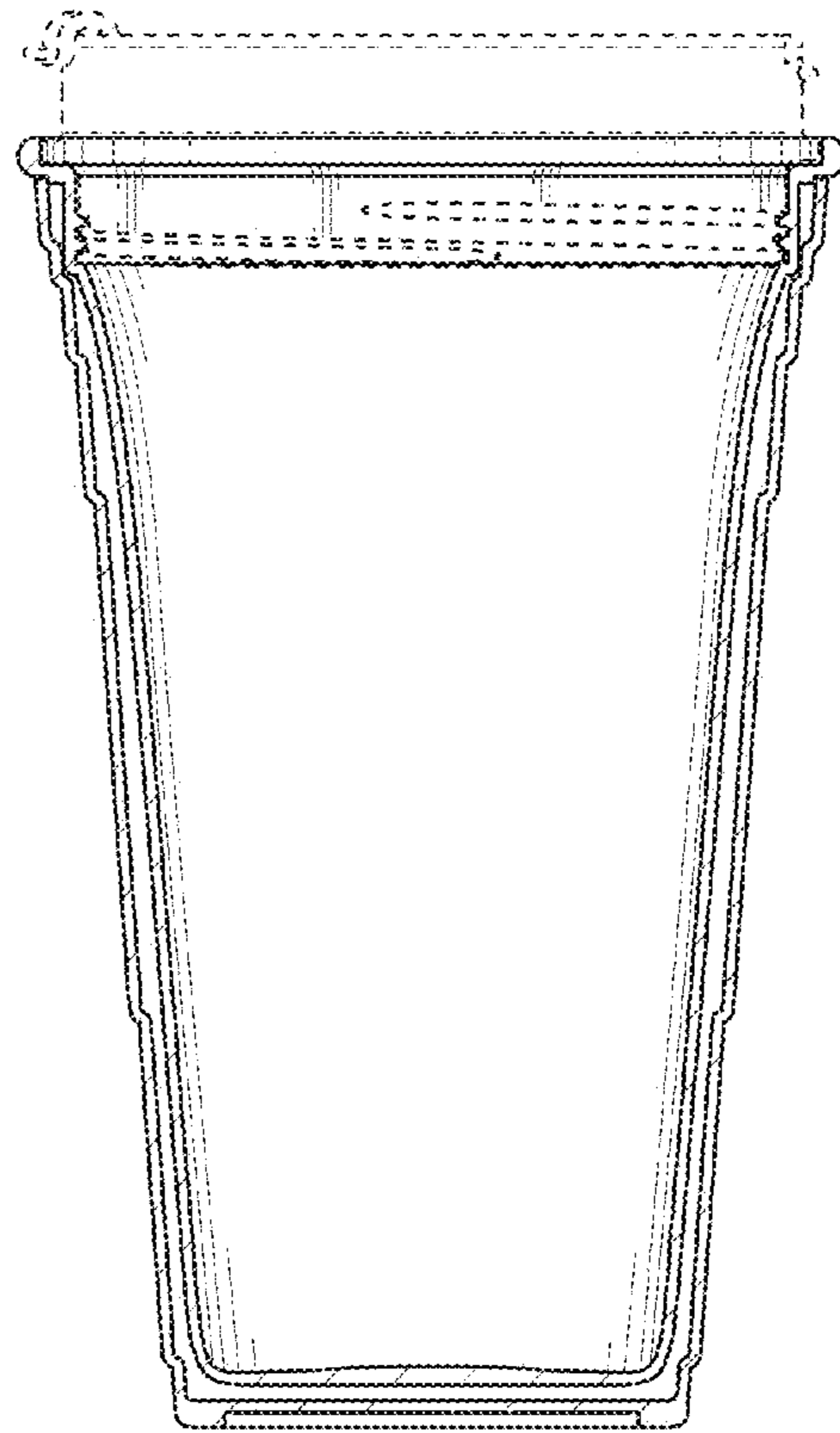

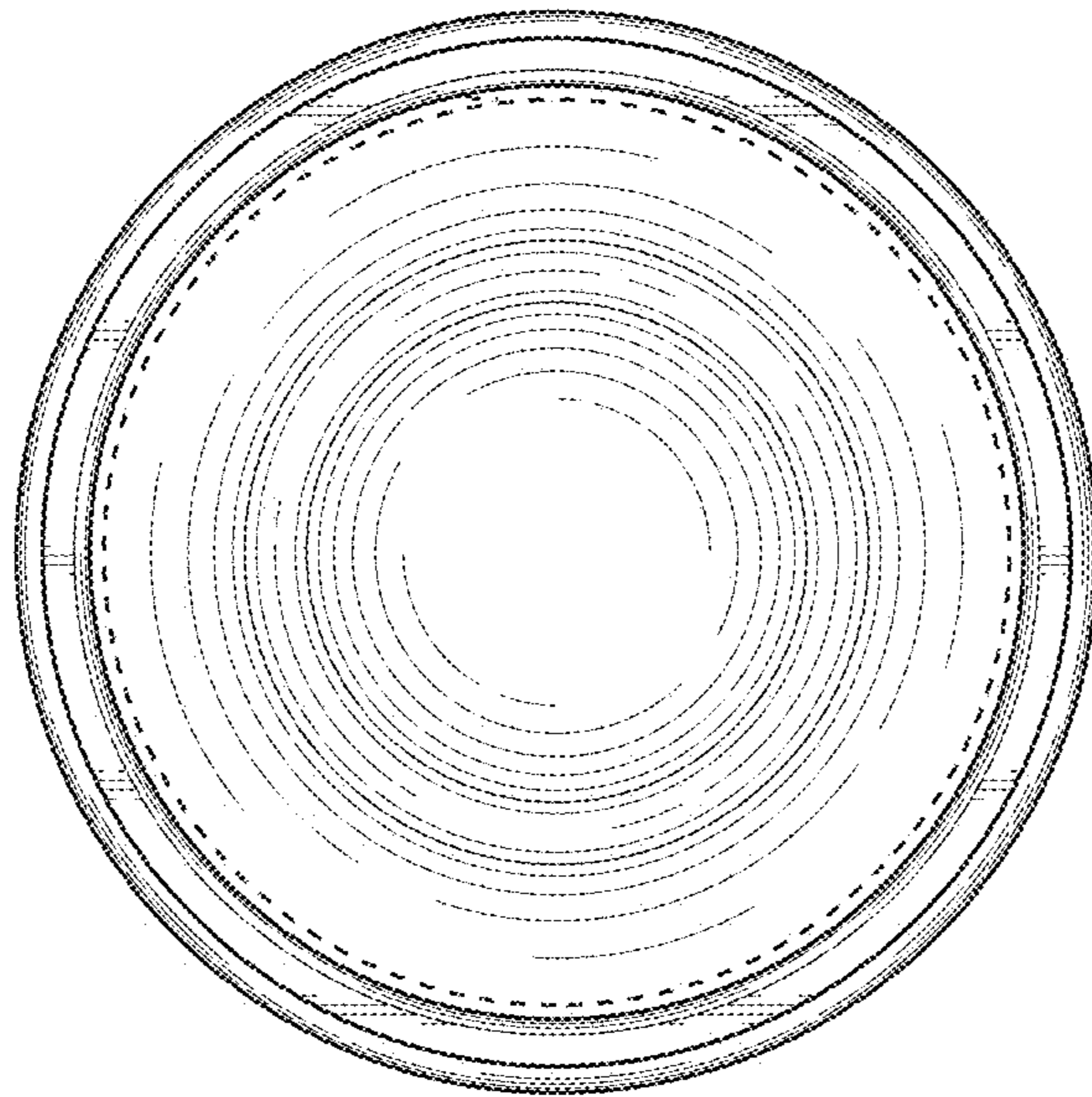

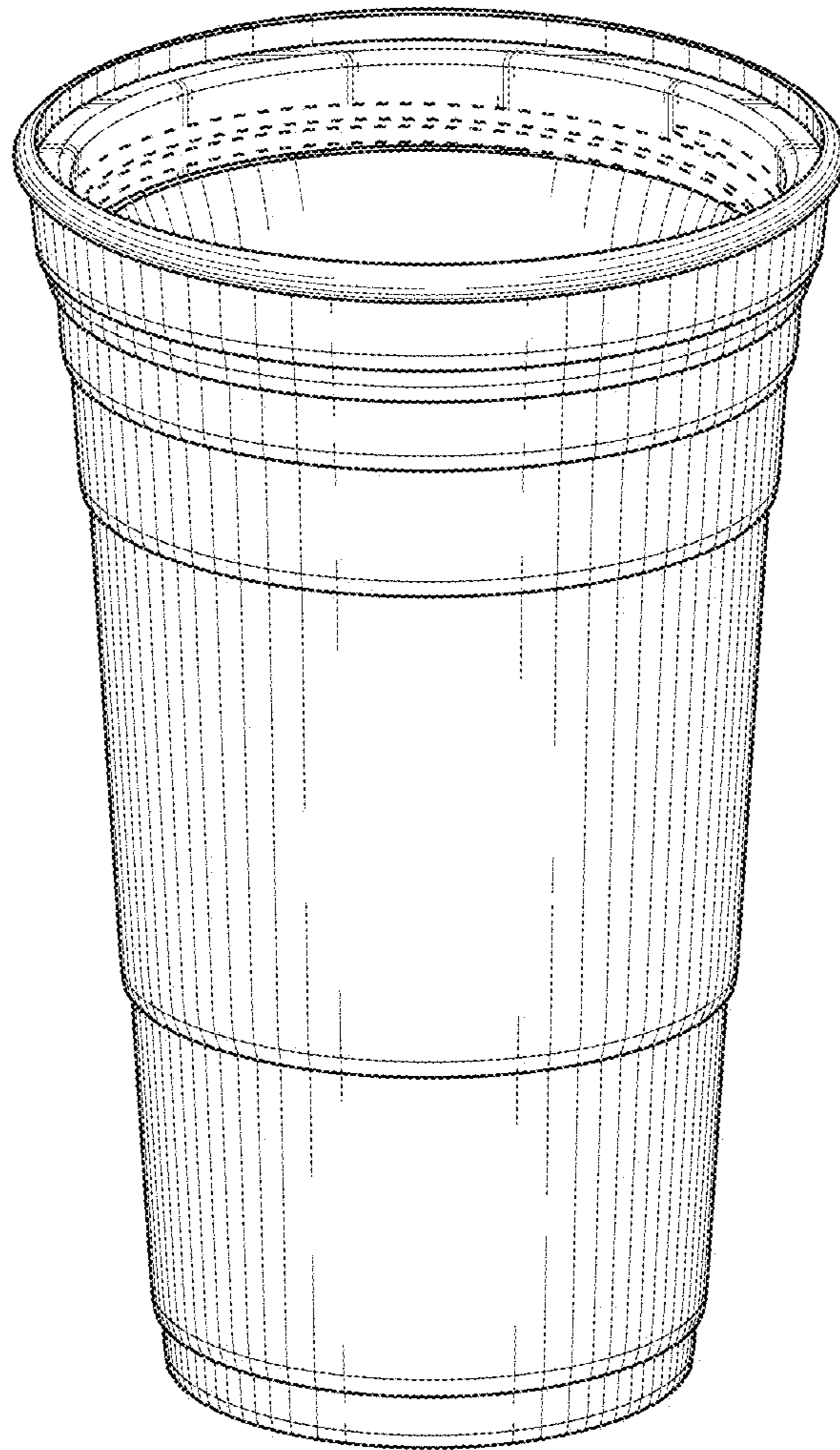
