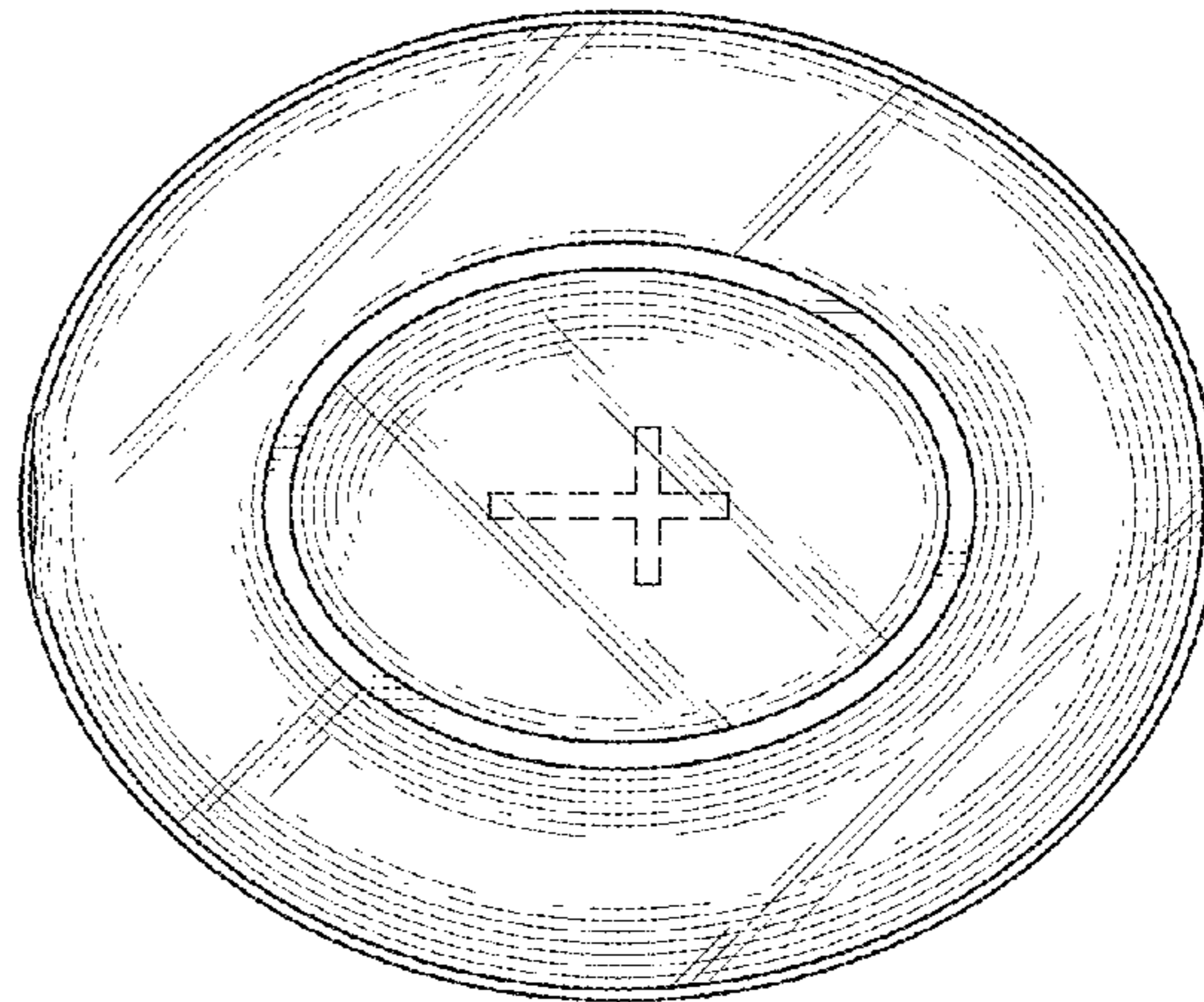
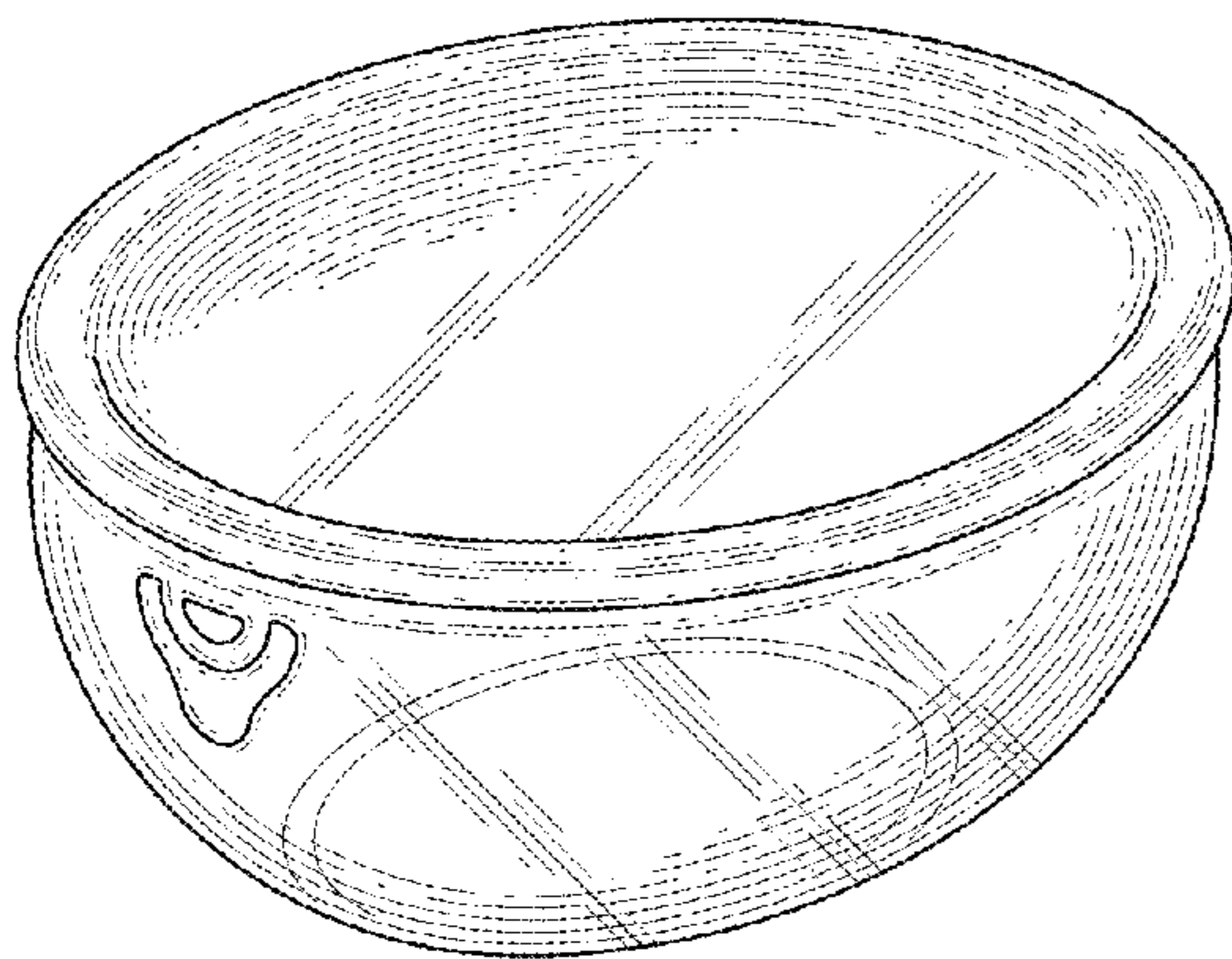
(57) **CLAIM**

The ornamental design for a mezcal snifter, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the mezcal snifter.
FIG. 2 is a right side view of the invention, the left side view being a mirror image.
FIG. 3 is a top plan view of the invention.
FIG. 4 is a front elevation view of the invention.
FIG. 5 is a bottom plan view of the invention; and,
FIG. 6 is a rear elevation view of the invention.

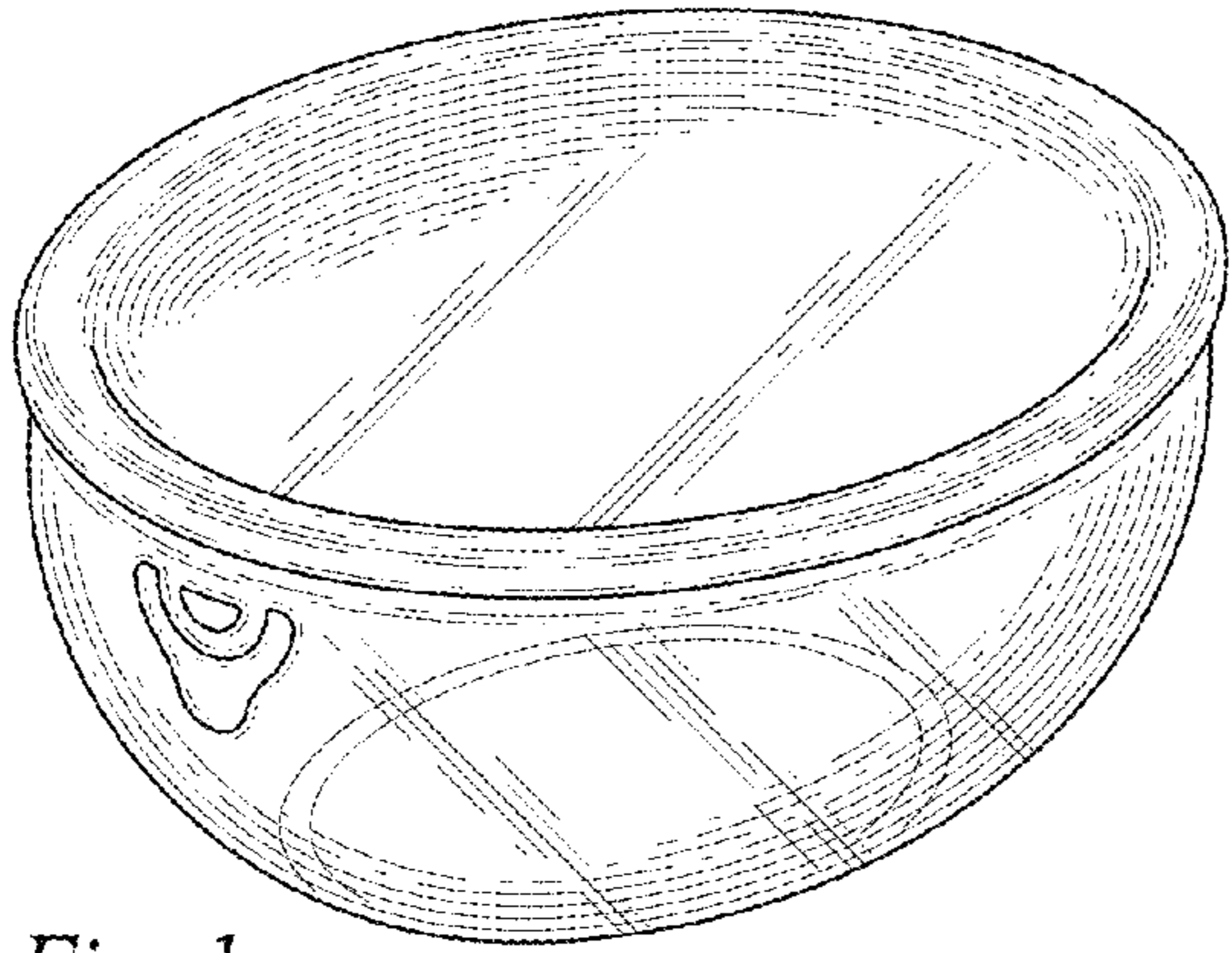

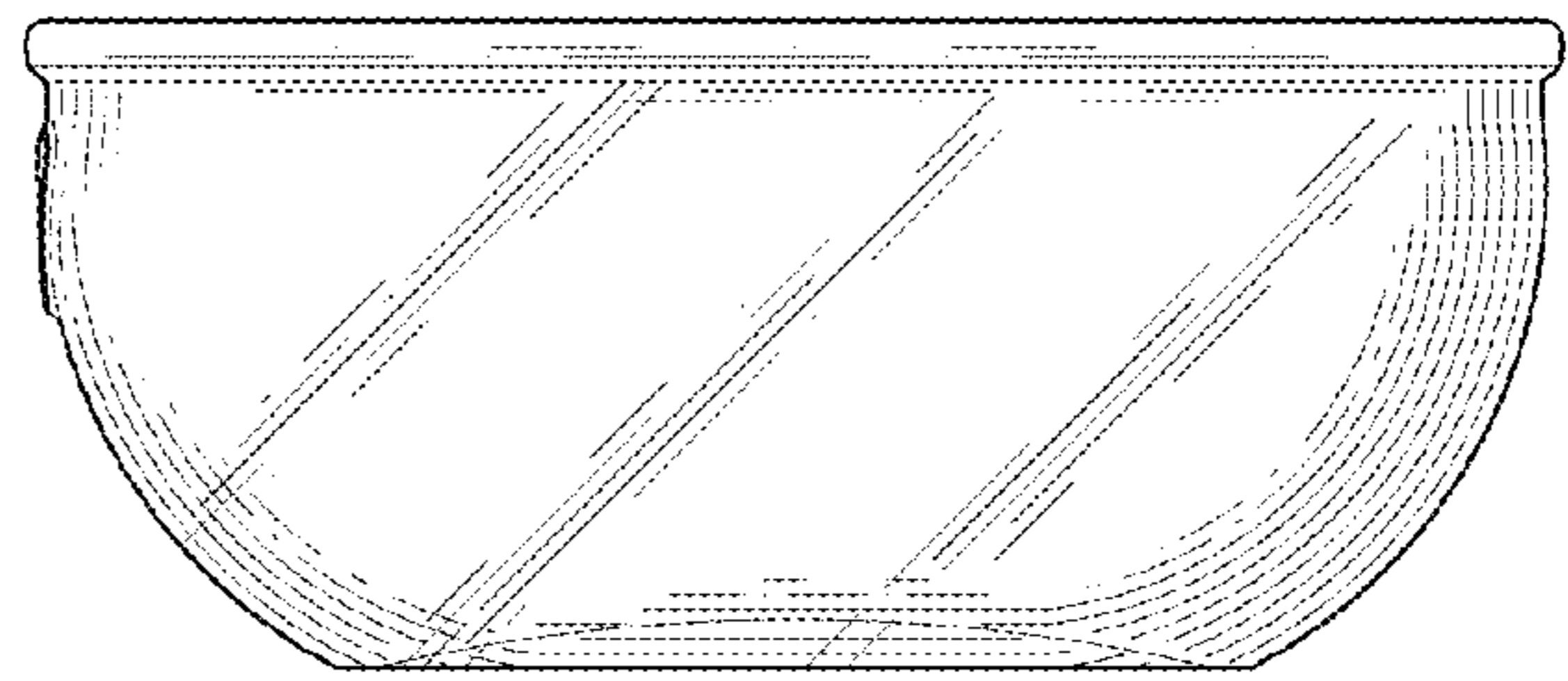

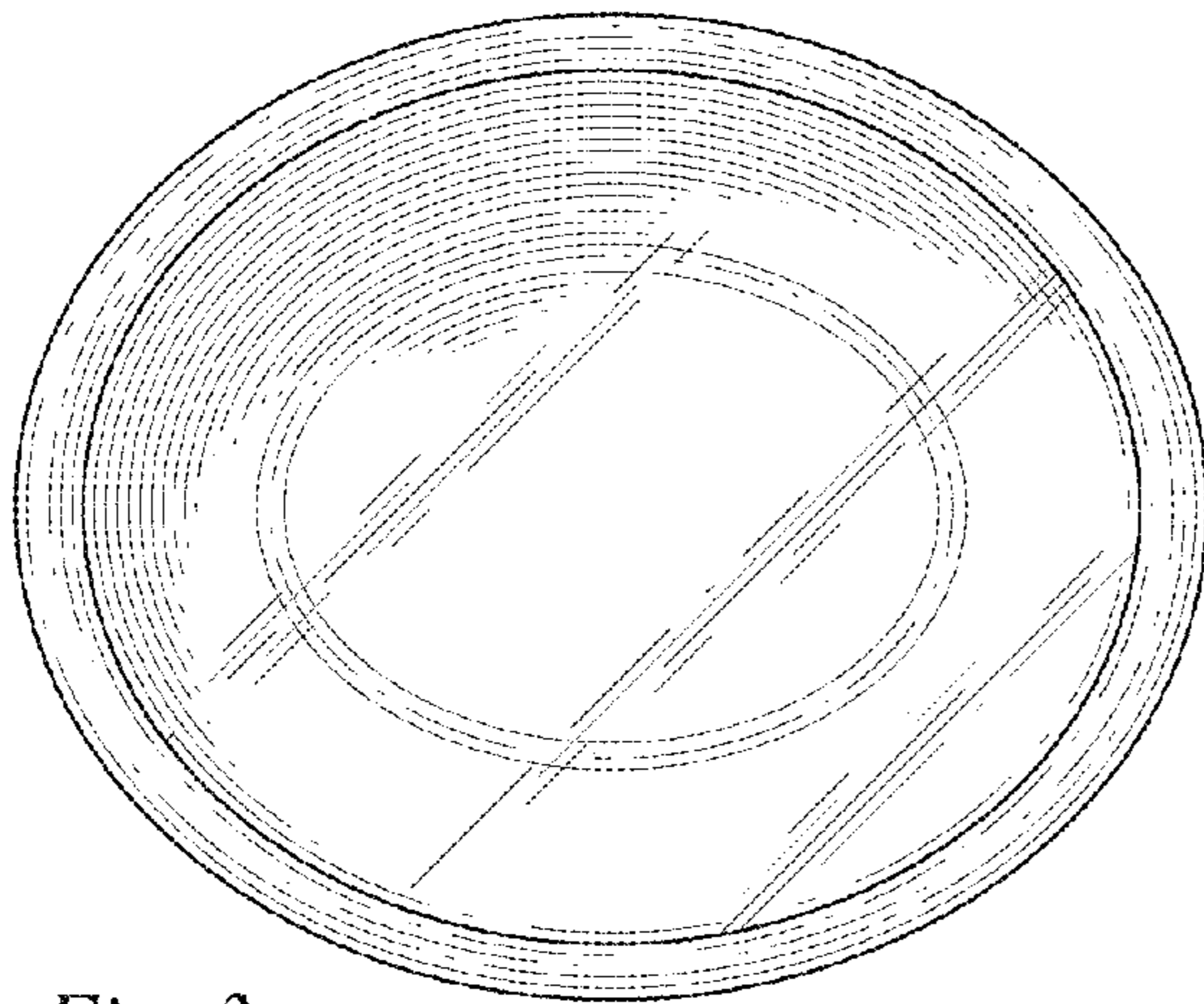

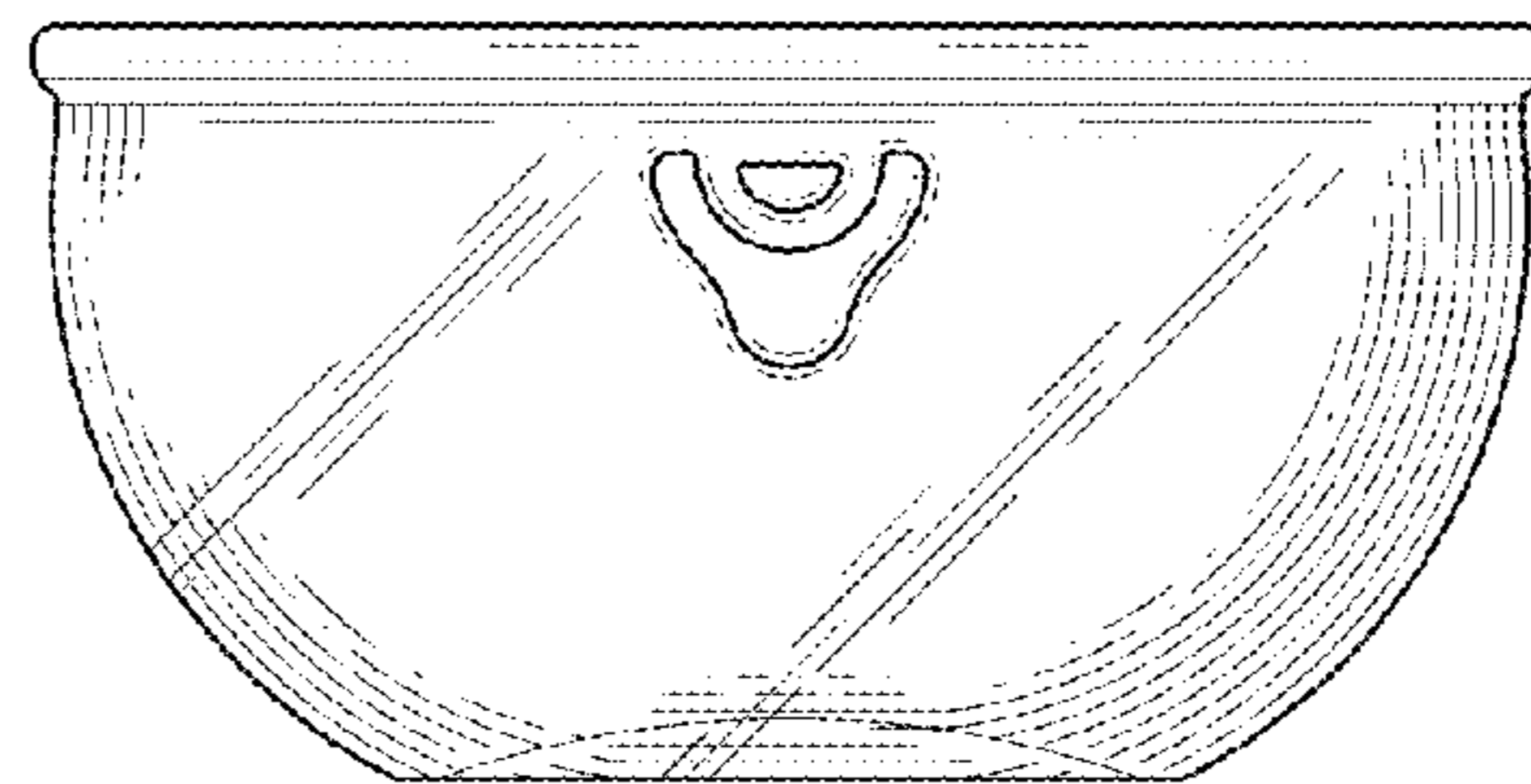

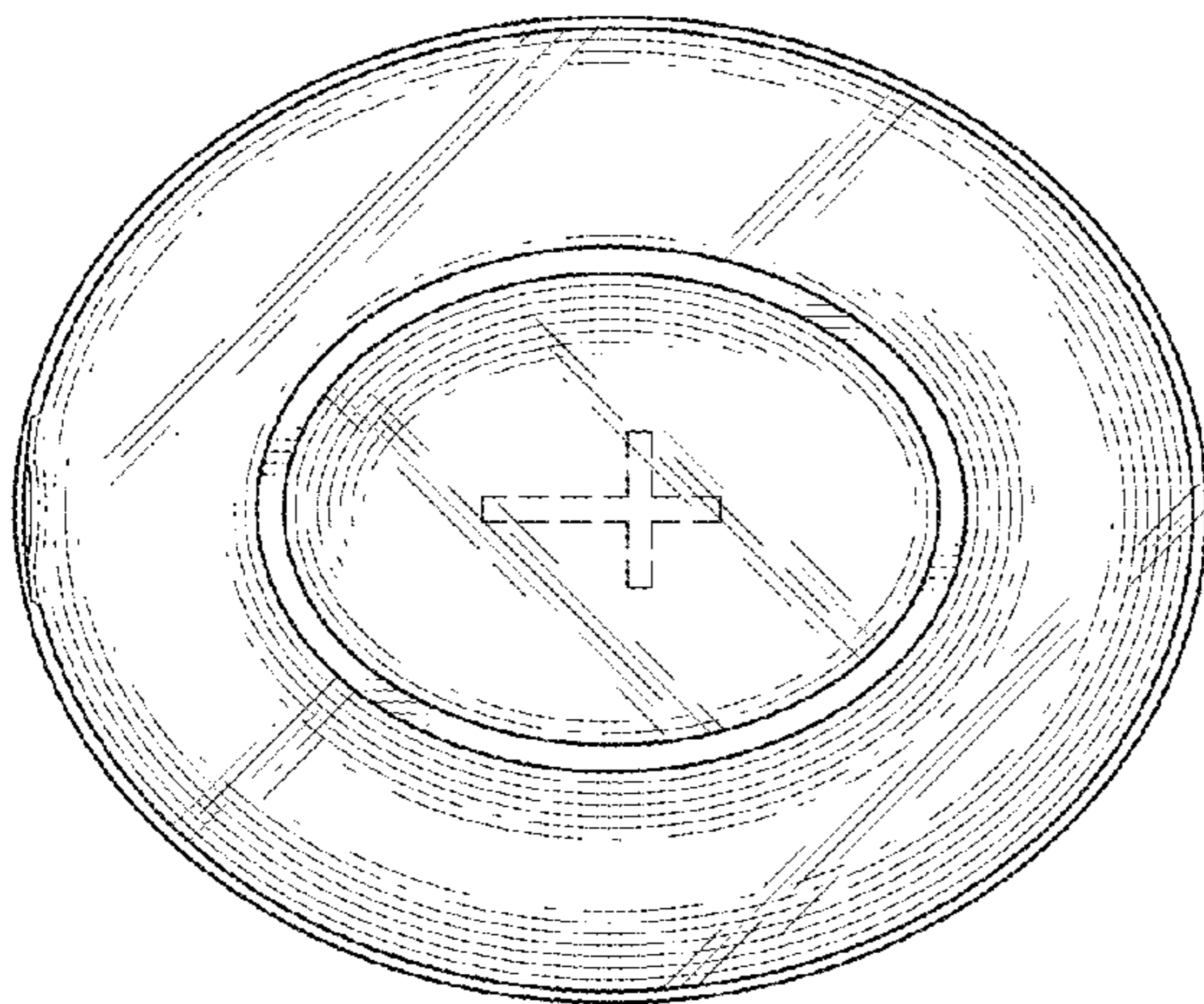

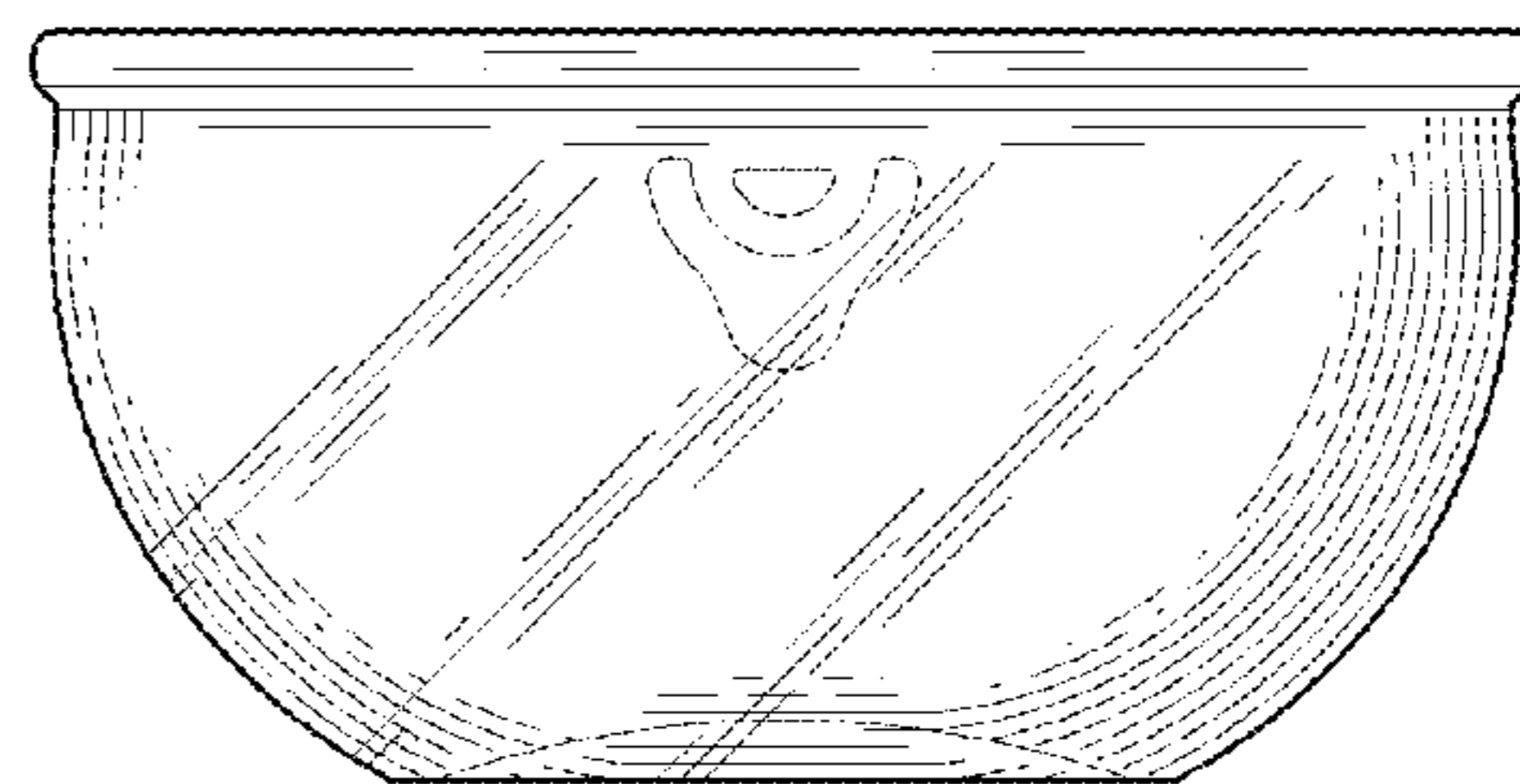
