DESCRIPTION

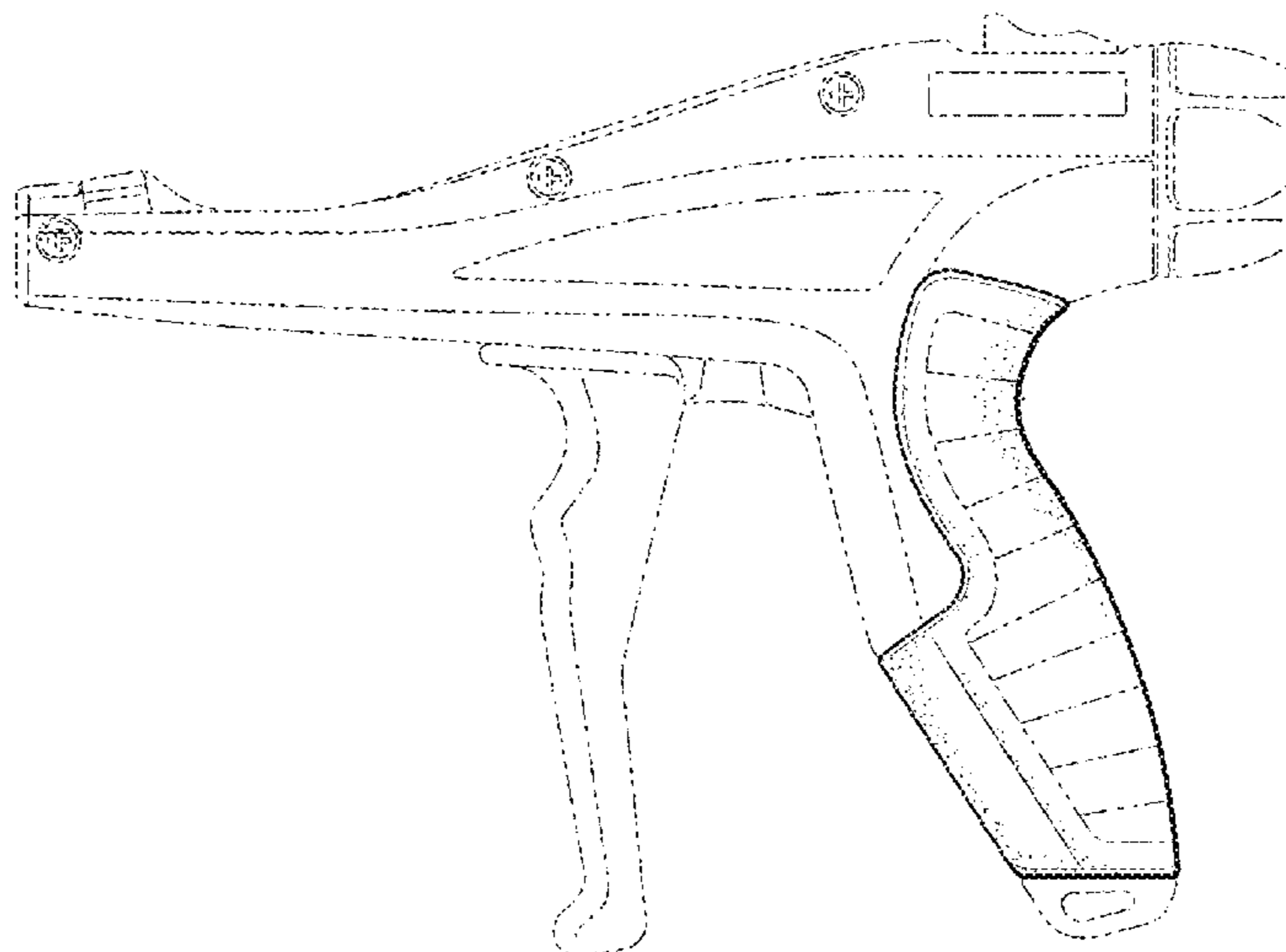
FIG. 1 is a left side perspective view of the cable tie tensioning

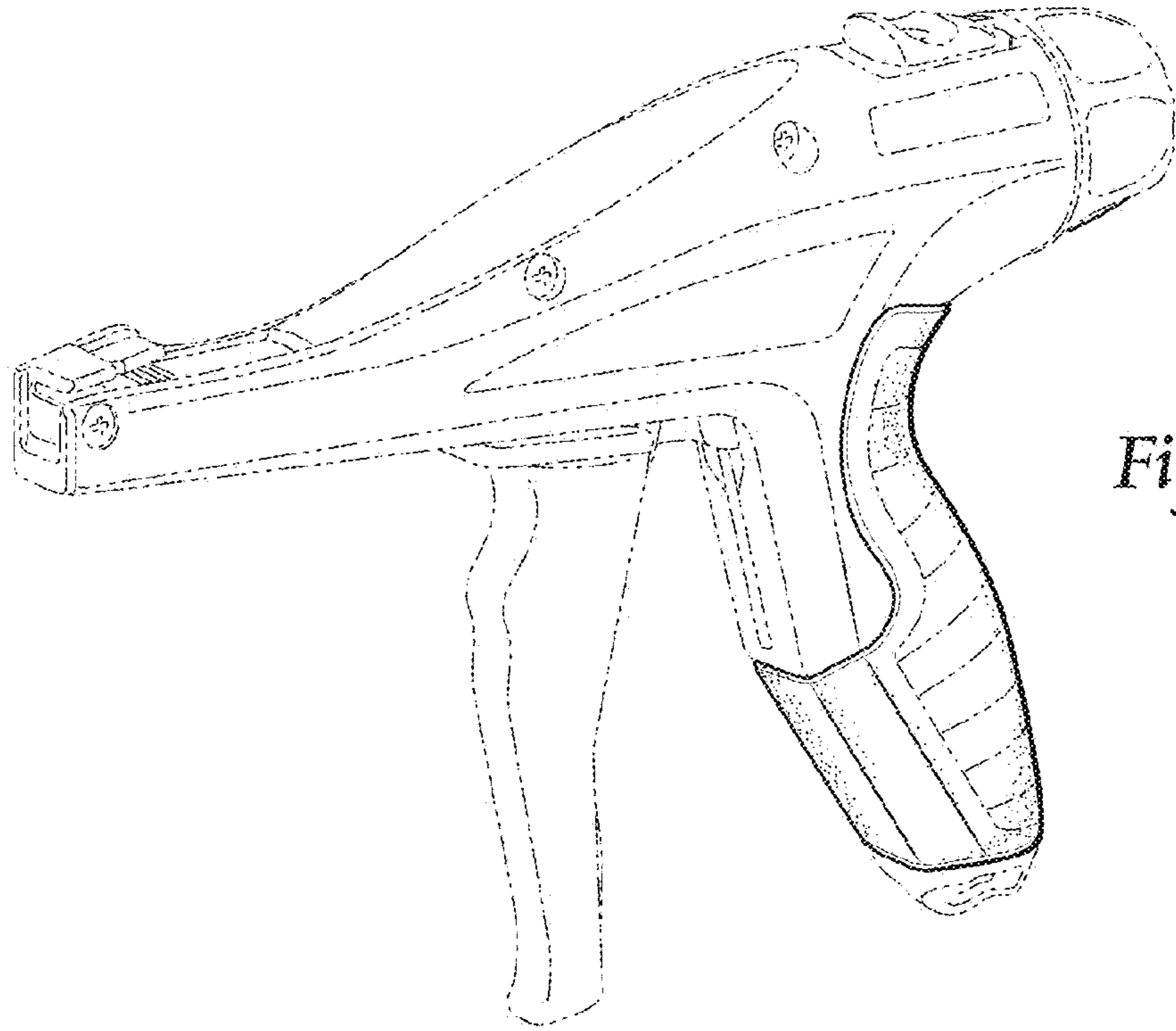

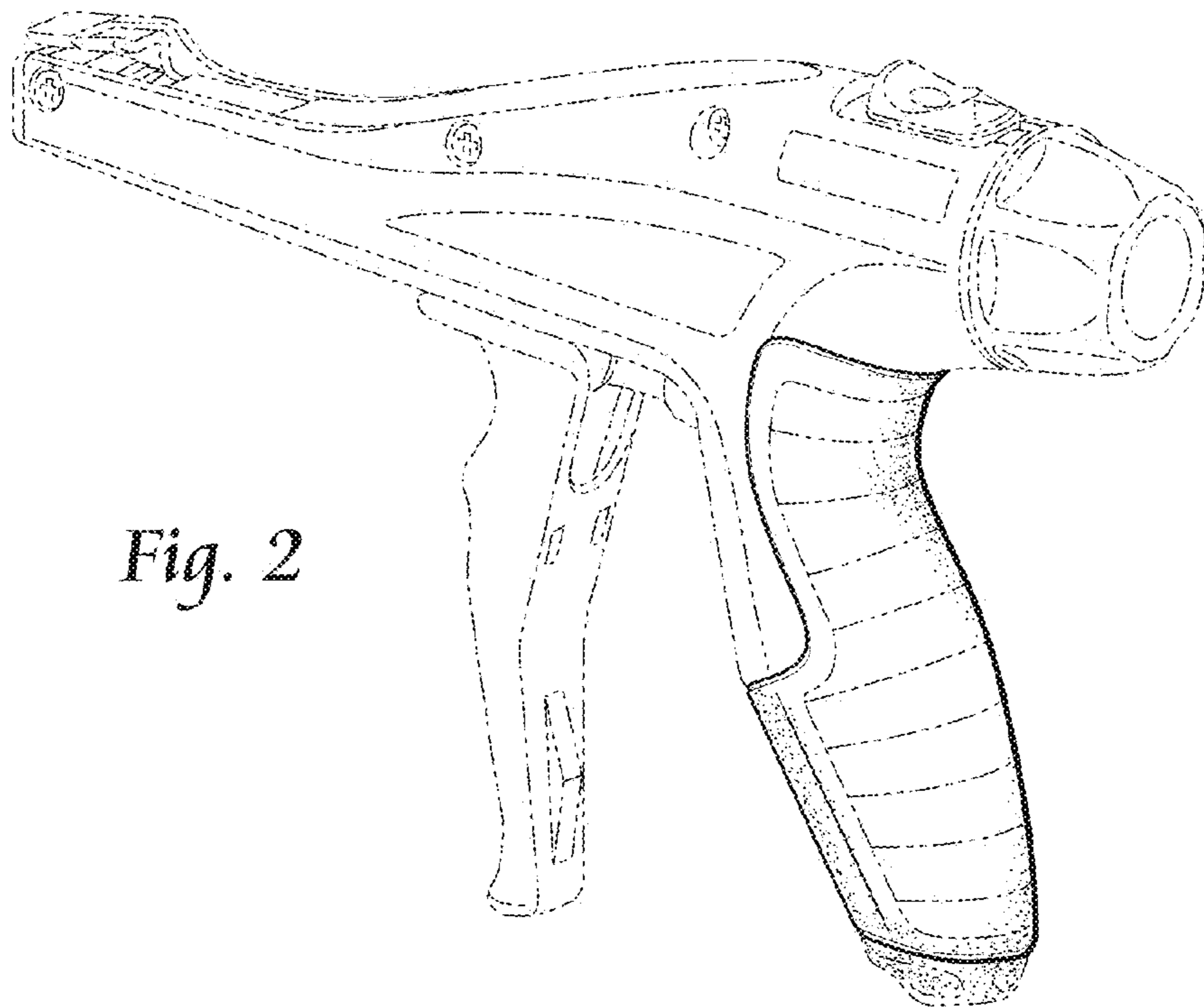

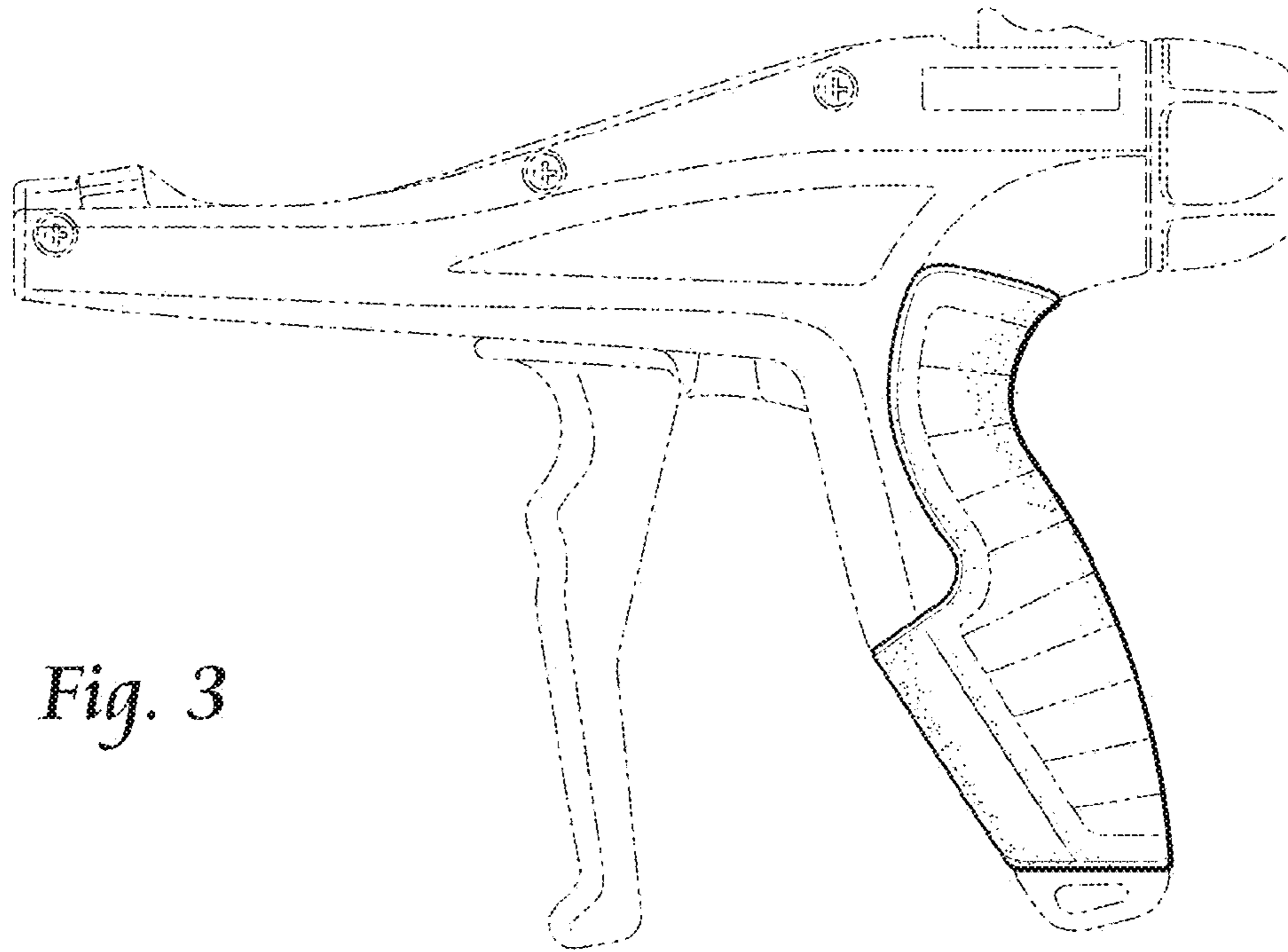

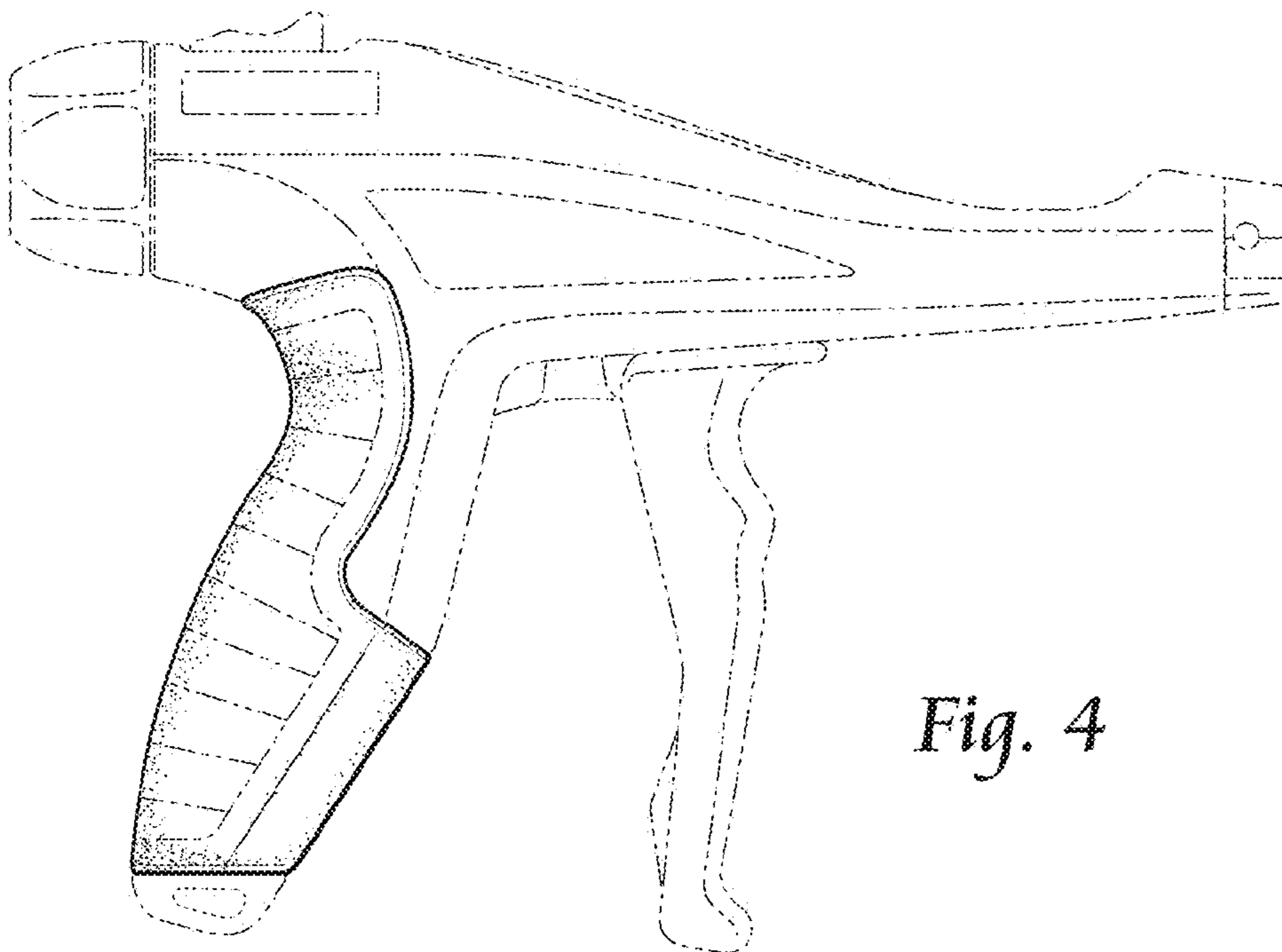

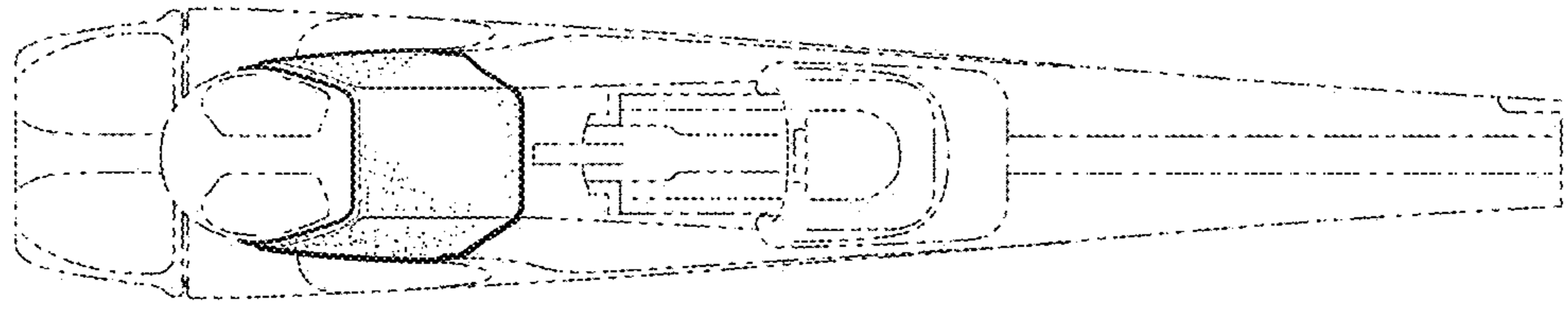

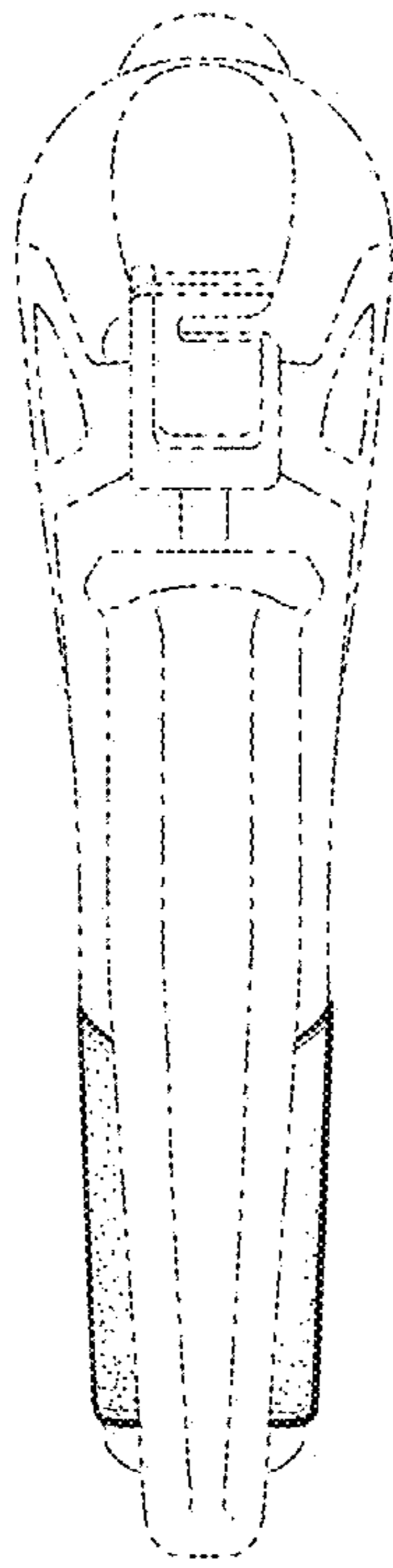

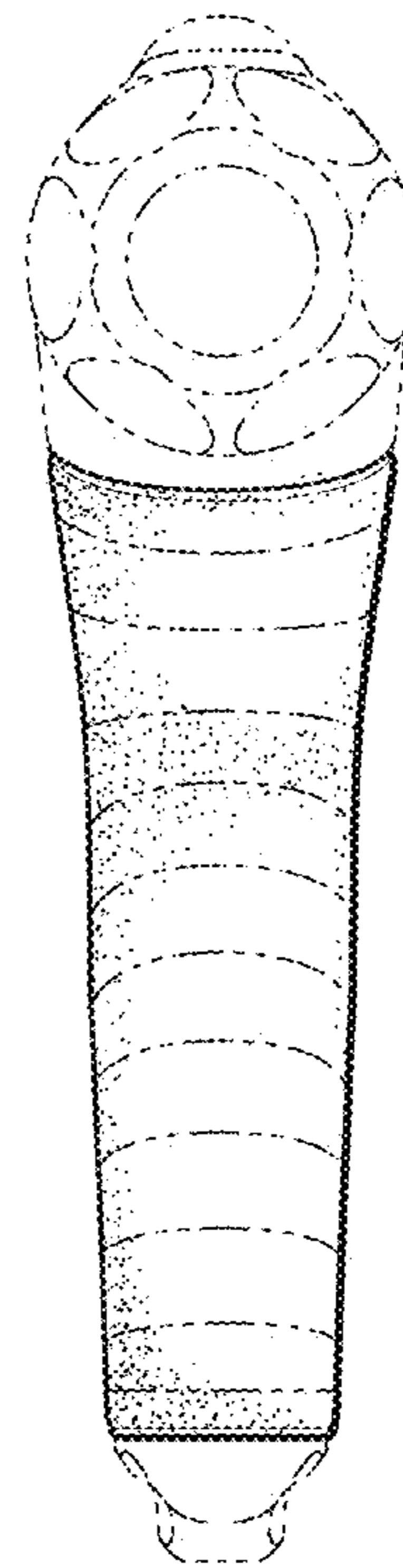
