(57) **CLAIM**  
 The ornamental design for a switch plate assembly, as shown and described.

**DESCRIPTION**

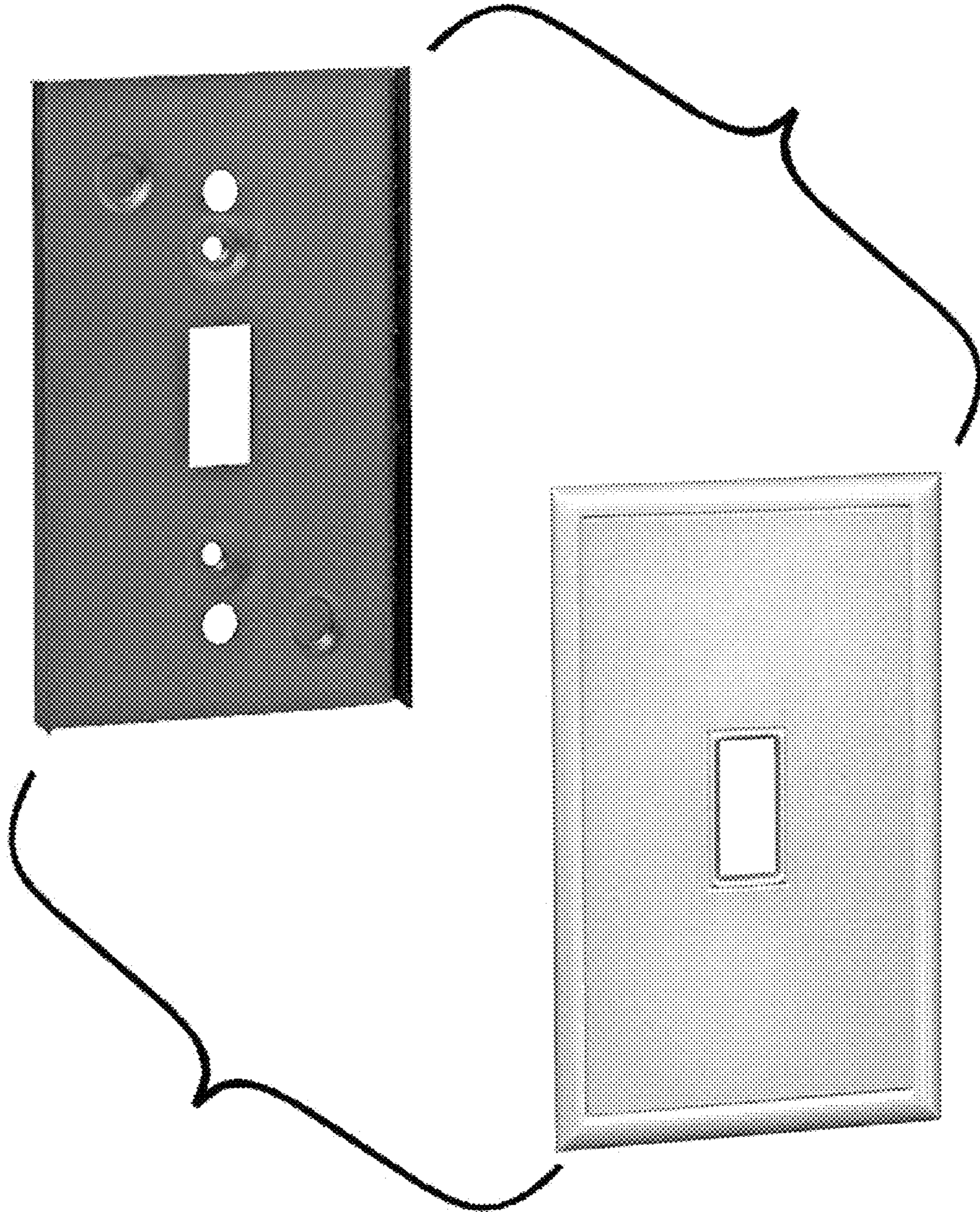

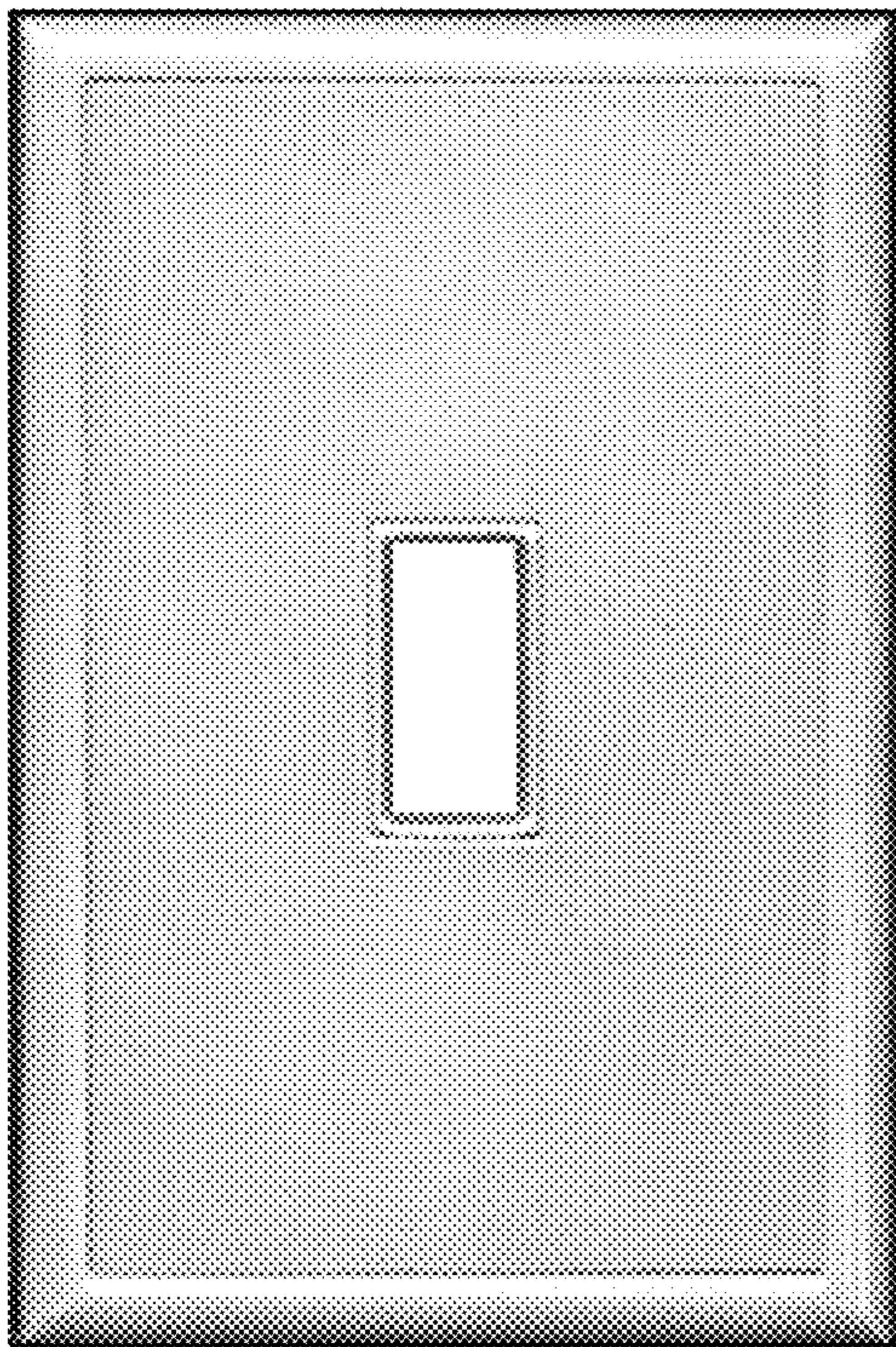

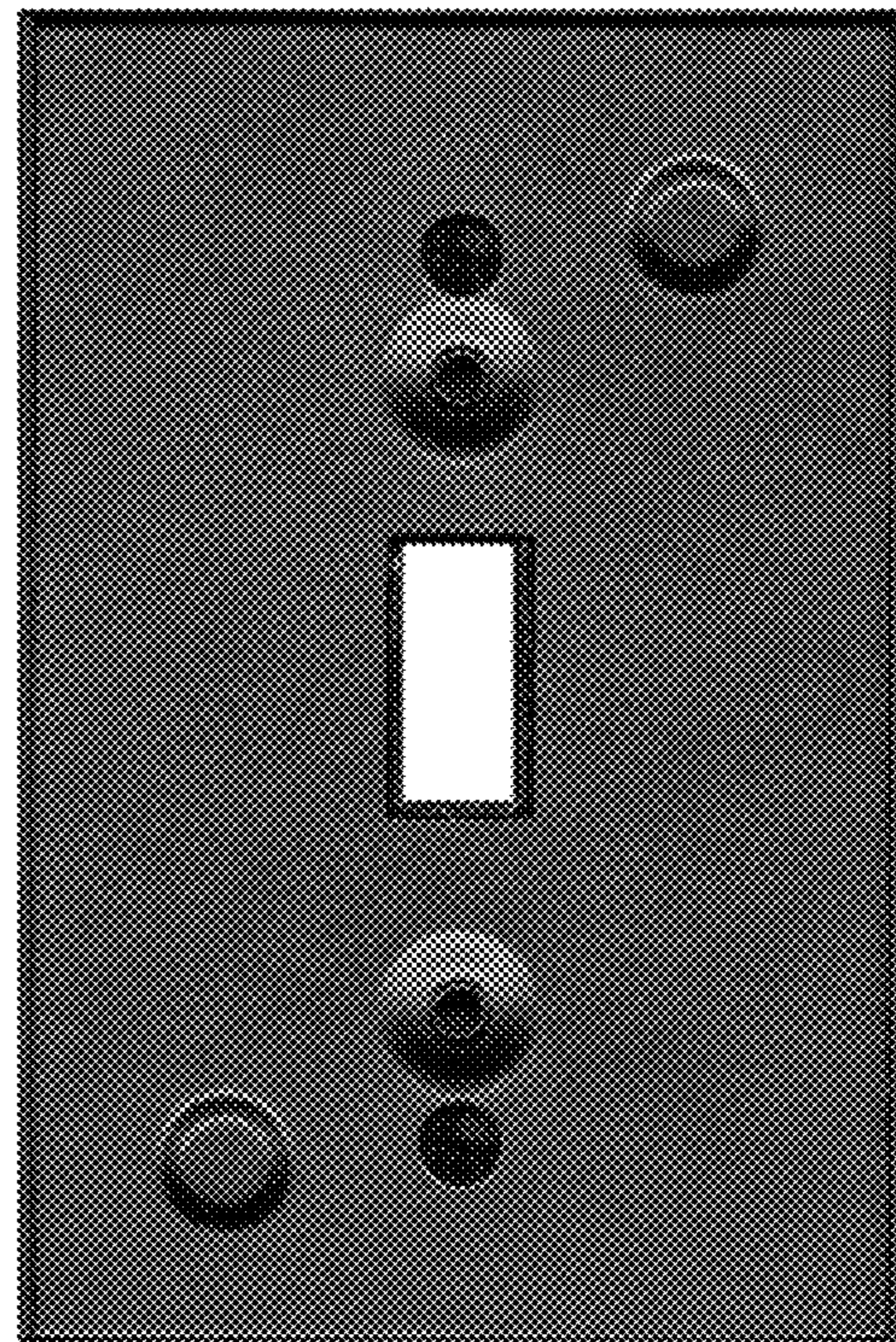

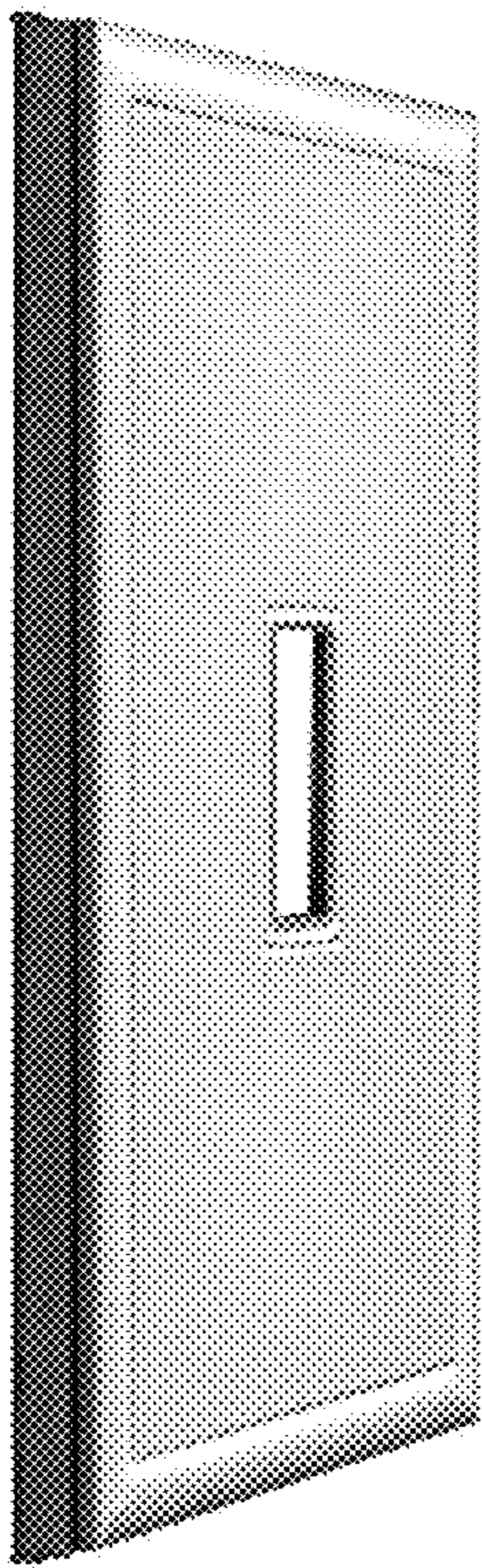

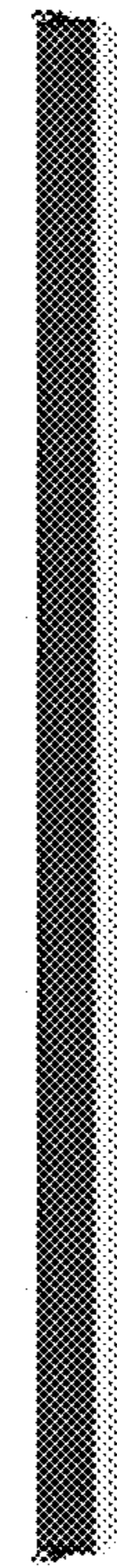

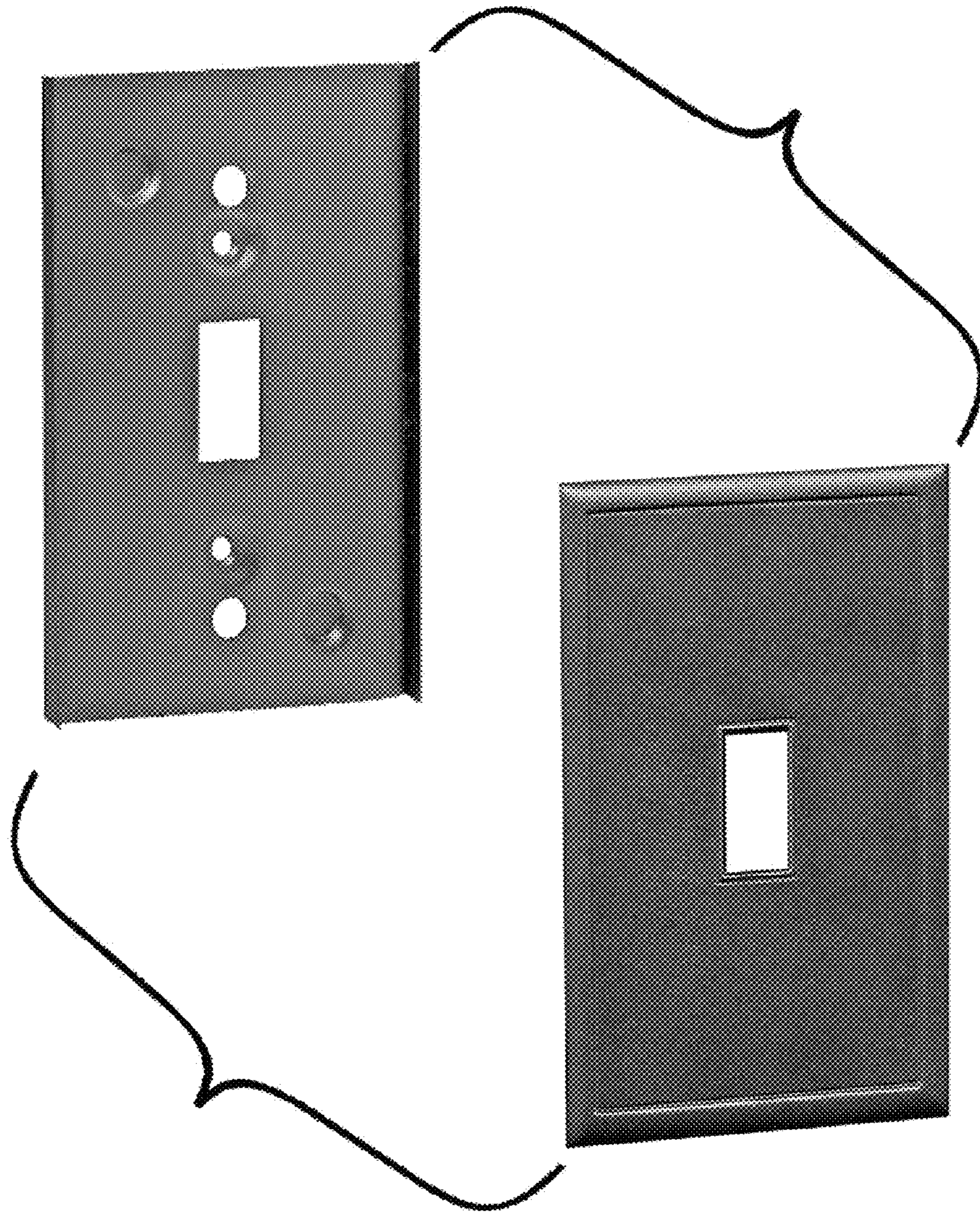

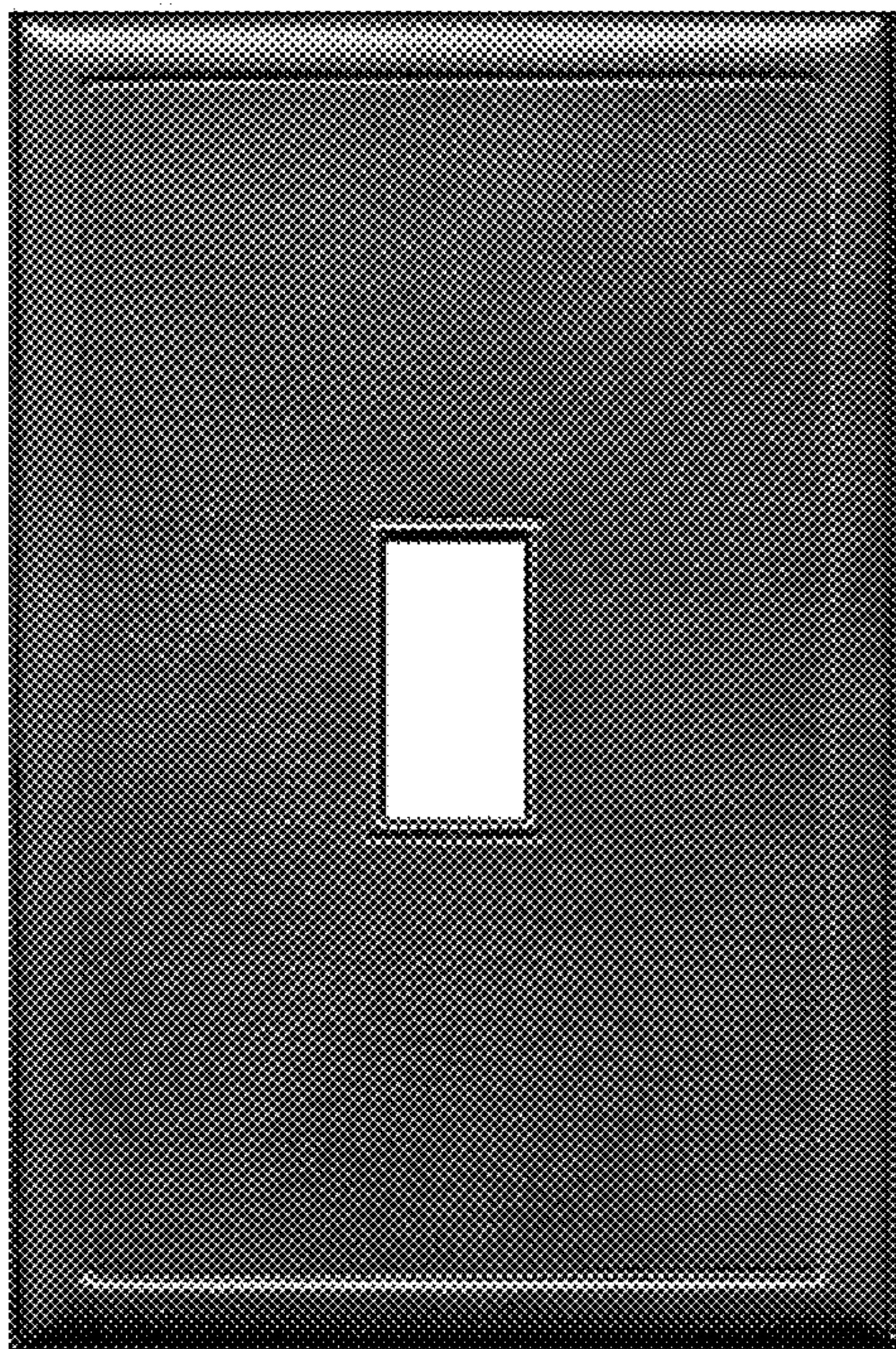

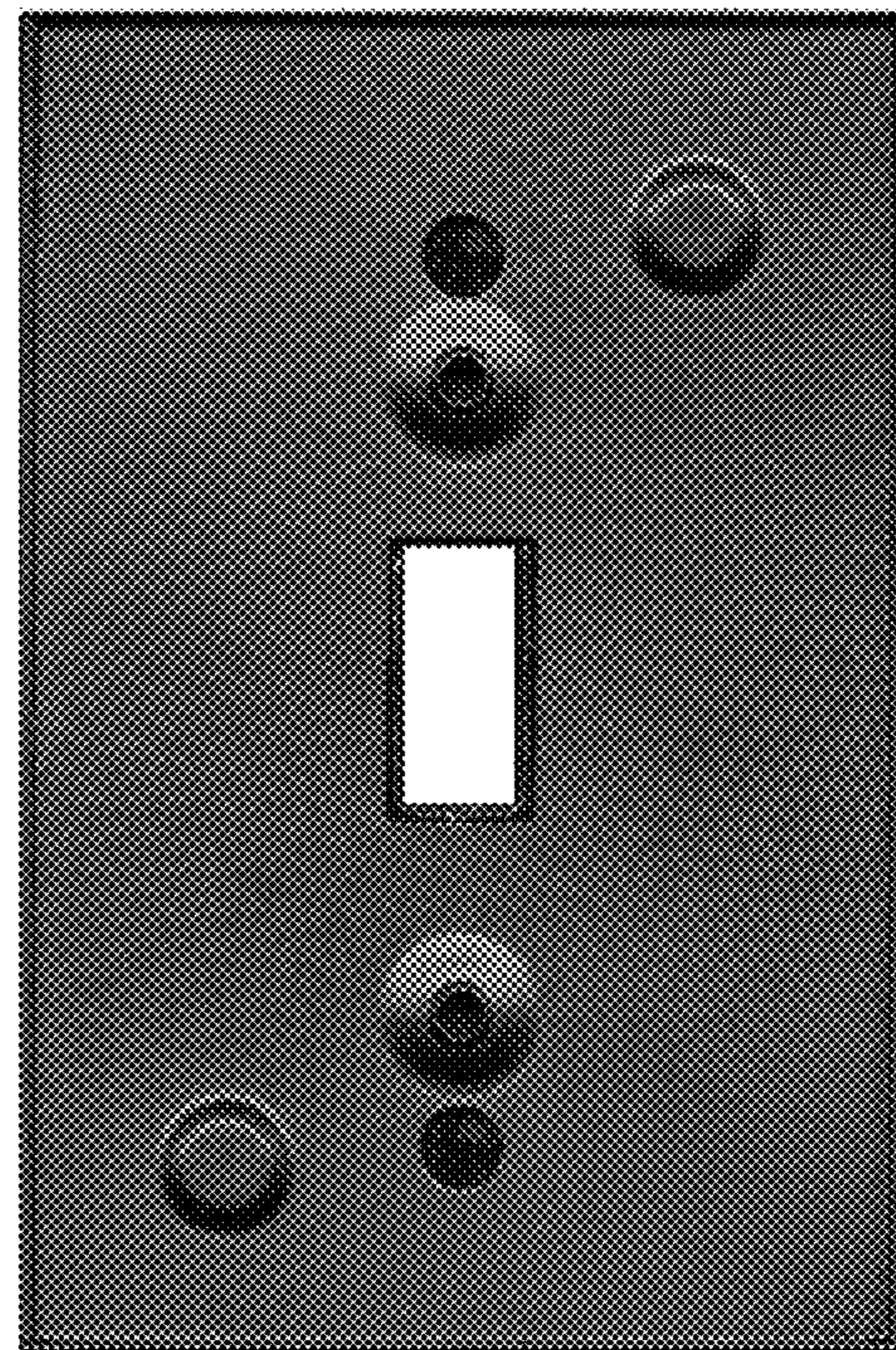

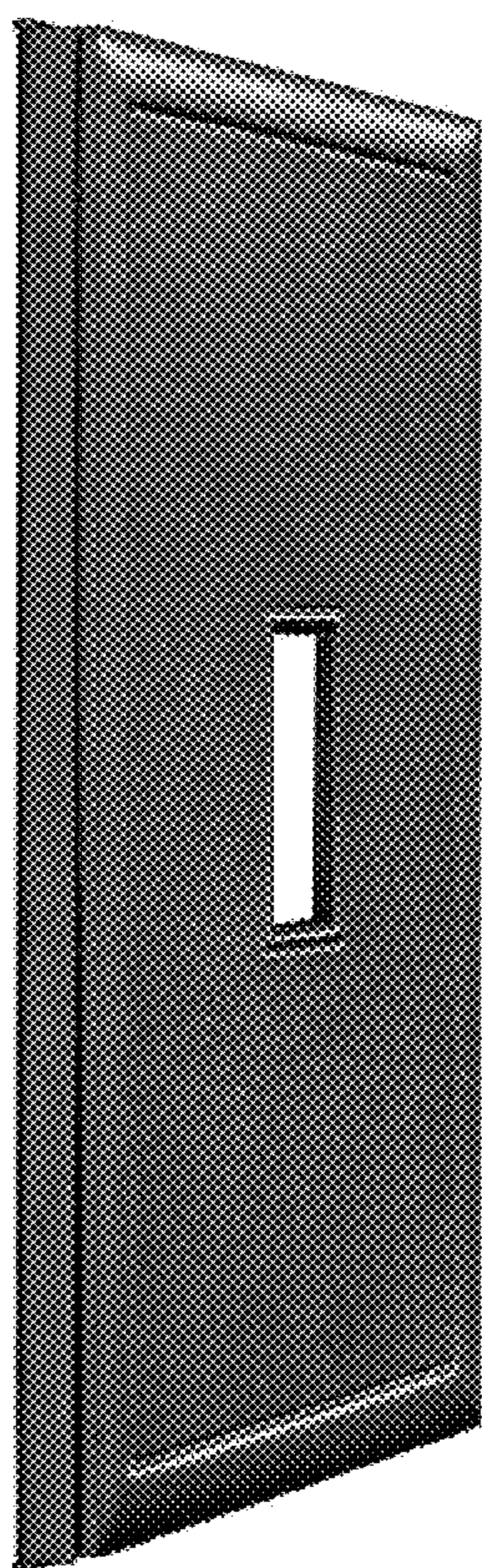

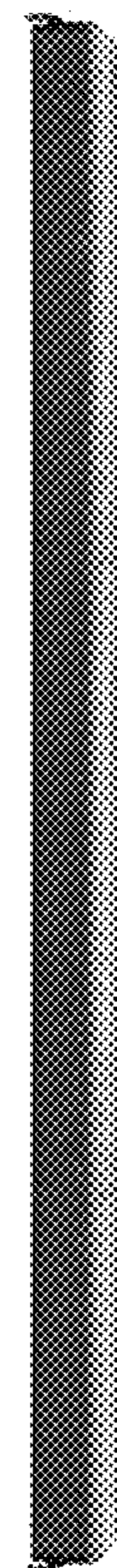
