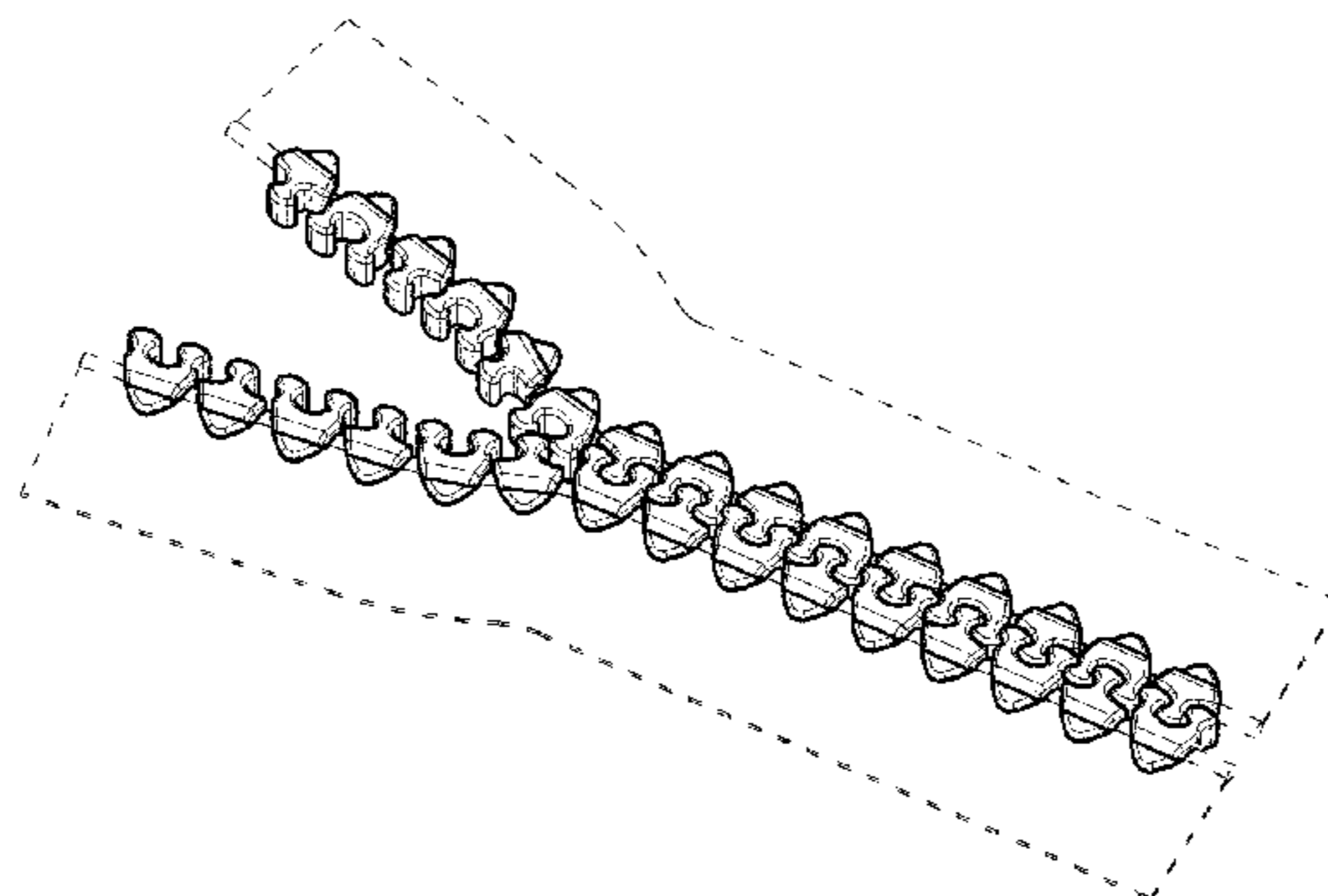
(57) **CLAIM**

The ornamental design for a slide fastener, as shown and described.

DESCRIPTION

FIG. 1 is a left side view of a first element of my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a rear elevational view thereof; FIG. 7 is a perspective view thereof; FIG. 8 is another perspective view thereof; FIG. 9 is a left side view of a second element of my new design; FIG. 10 is a front elevation view thereof; FIG. 11 is a right side view thereof; FIG. 12 is top plan view thereof; FIG. 13 is a bottom plan view thereof; FIG. 14 is a rear elevational view thereof; FIG. 15 is a perspective view thereof; FIG. 16 is another perspective view thereof; FIG. 17 is a front elevation view of a plurality of first and second elements of my new design interlocking with each other in a closed position; and, FIG. 18 is a perspective view of a plurality of first and second elements of my new design interlocking with each other in a partially open position. The broken line showing of the planar surfaces where the elements are attached in FIG. 18 illustrate environmental matter which form no part of the claimed design.

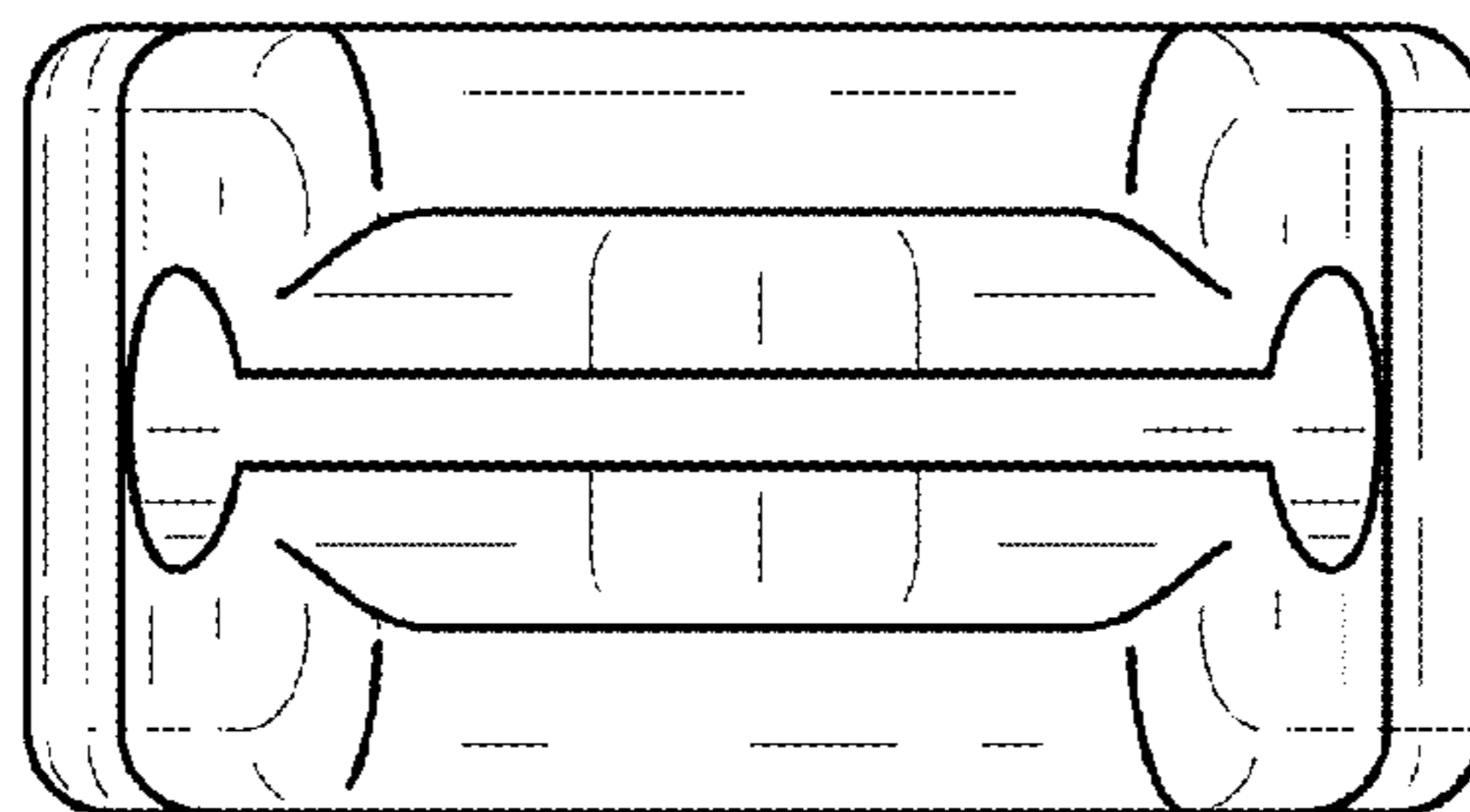

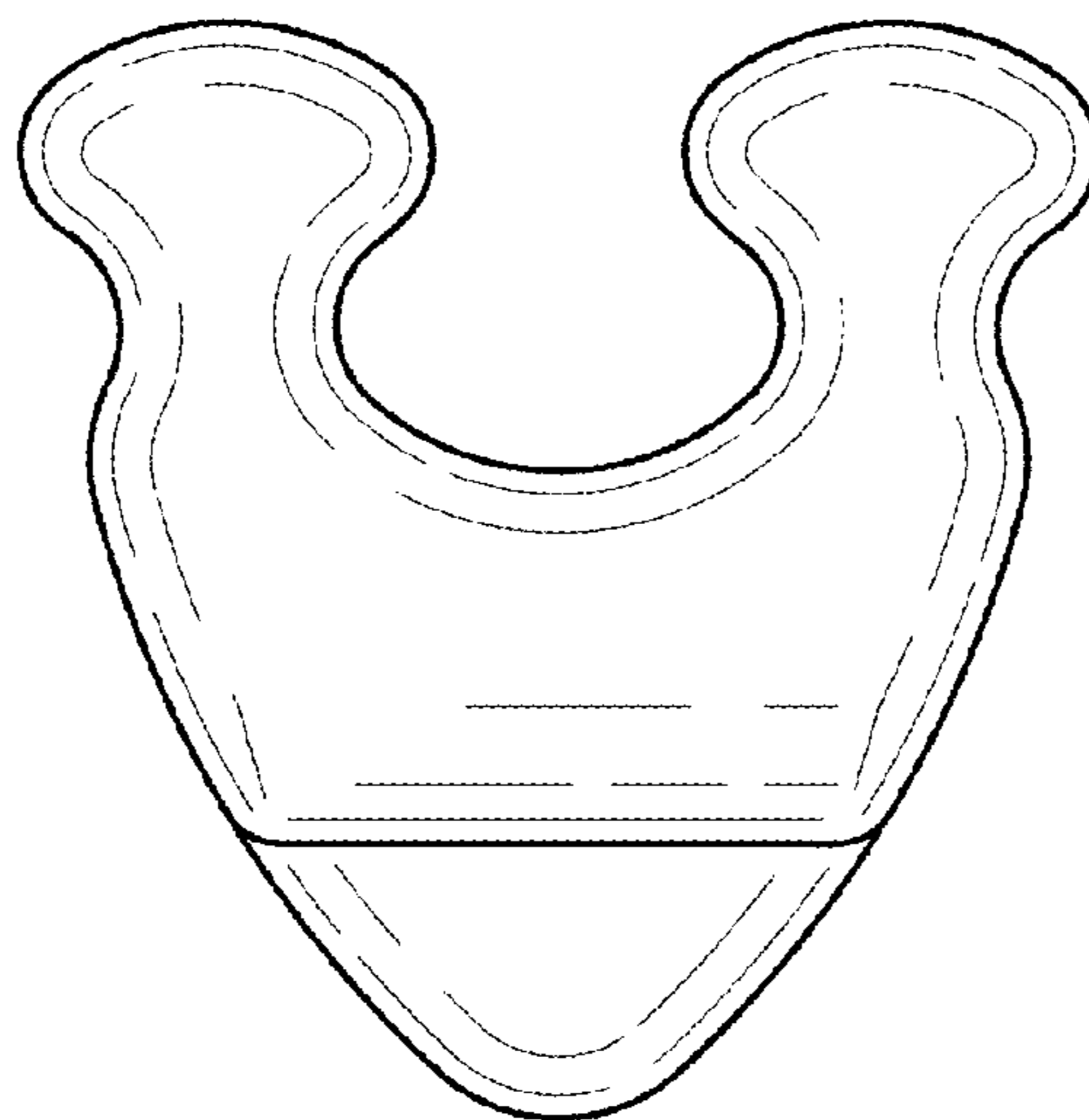

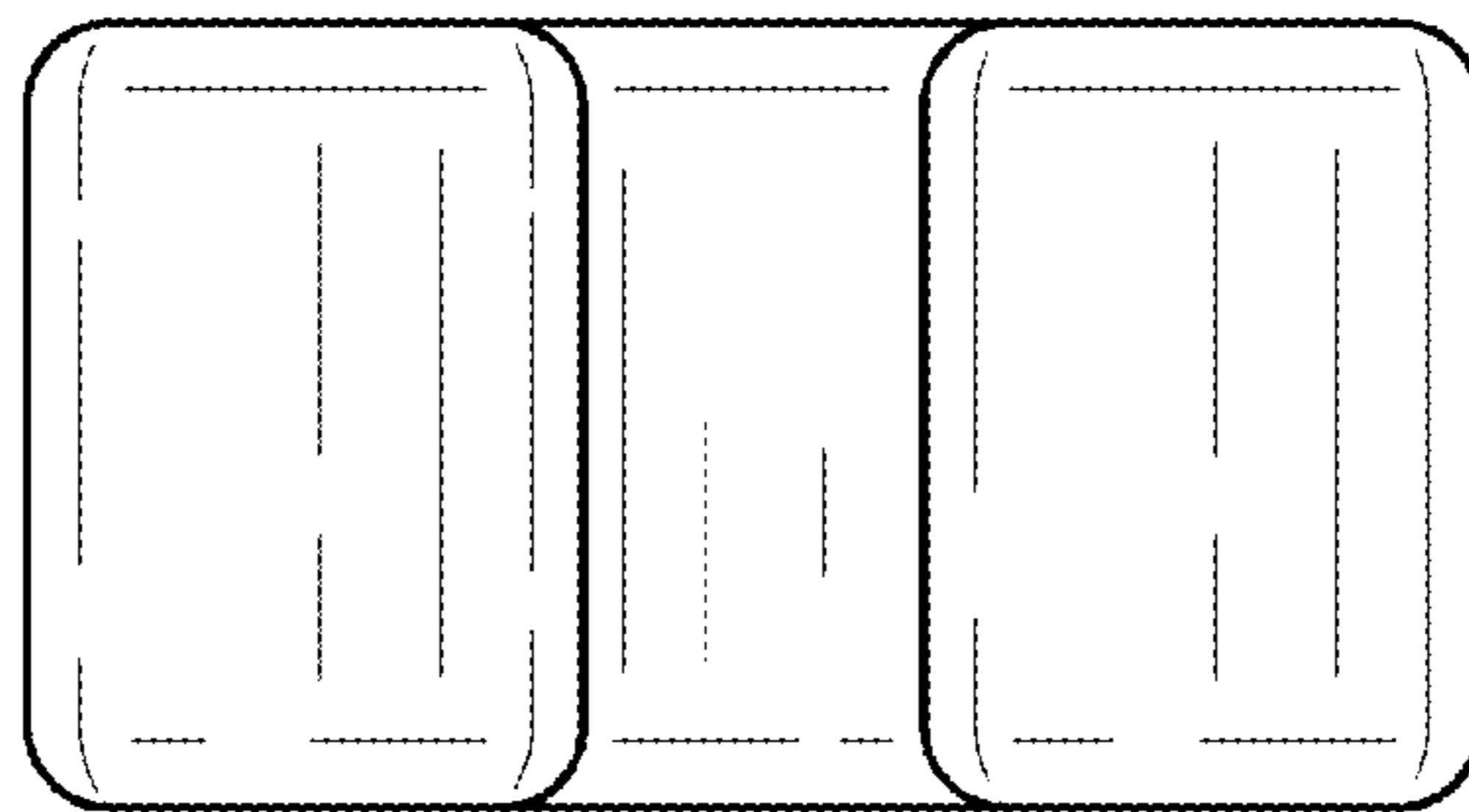

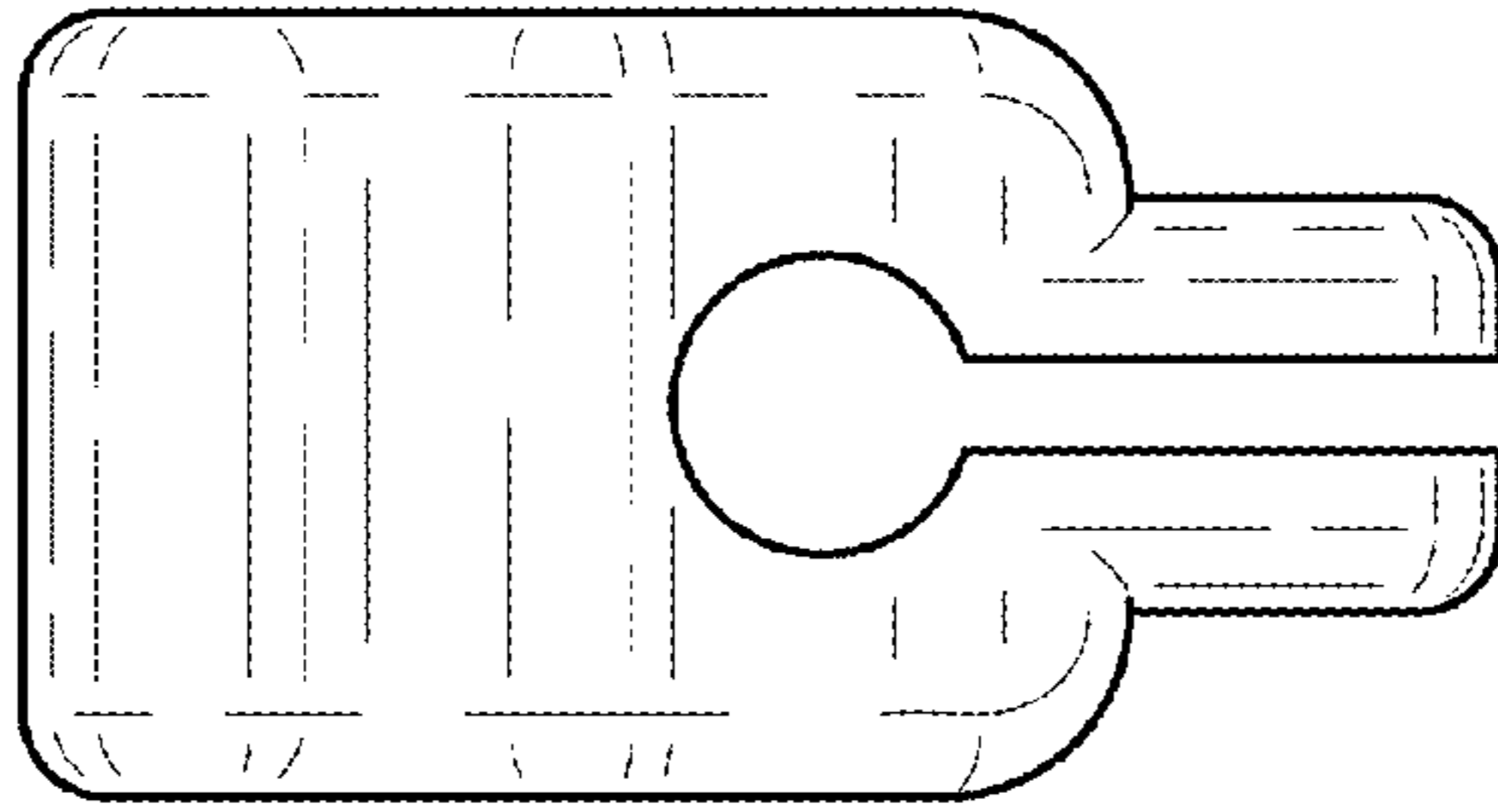

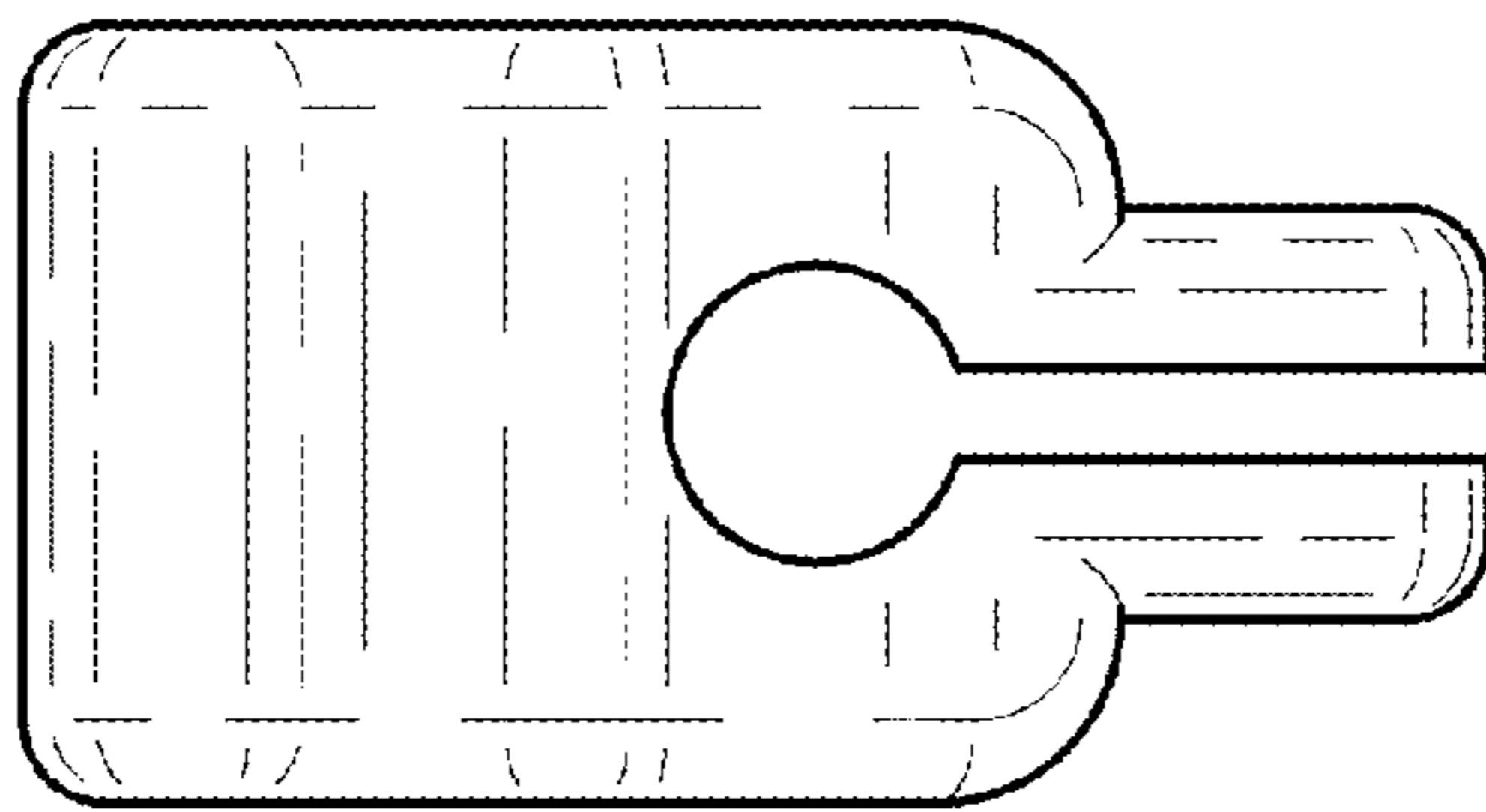

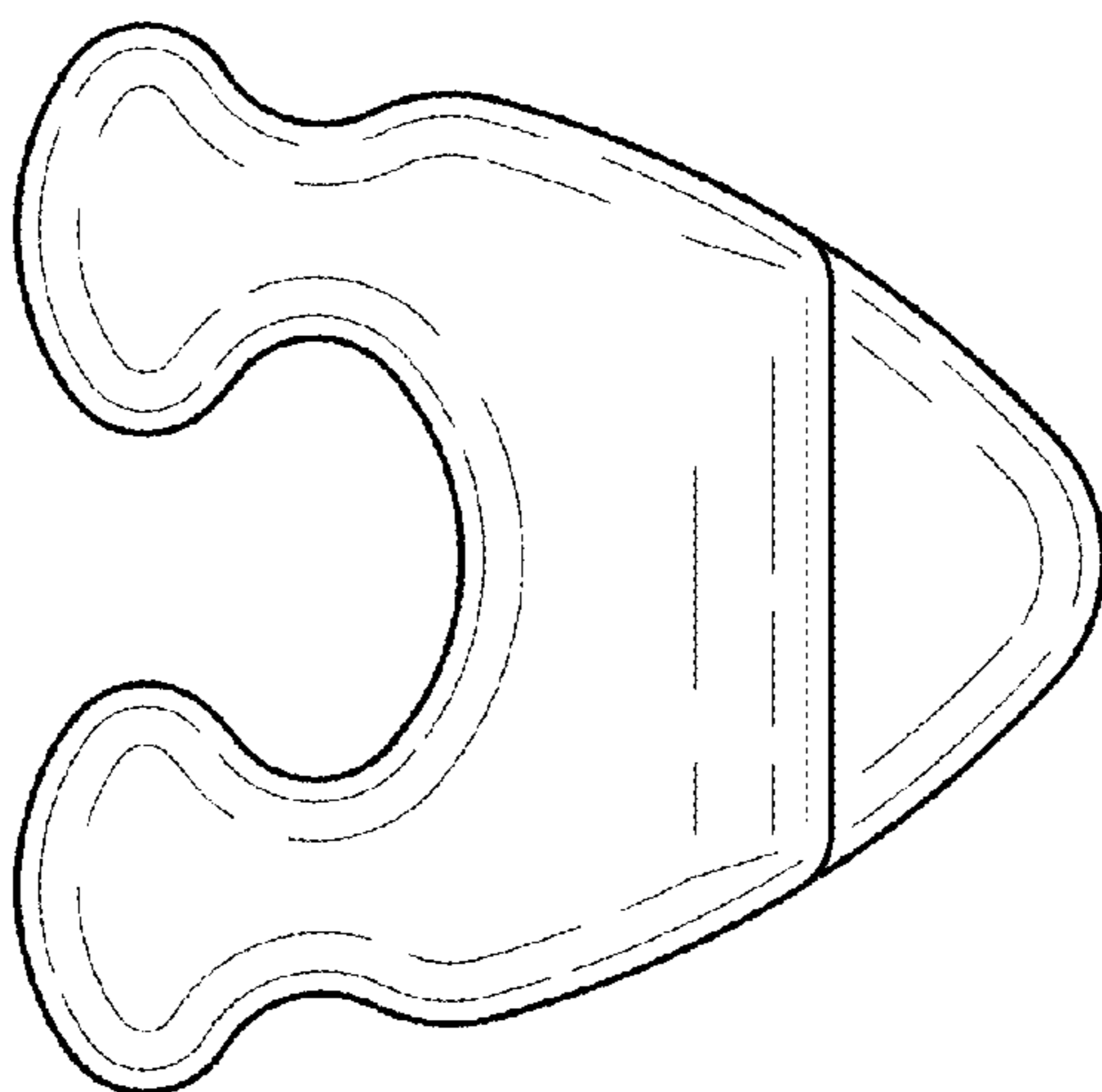

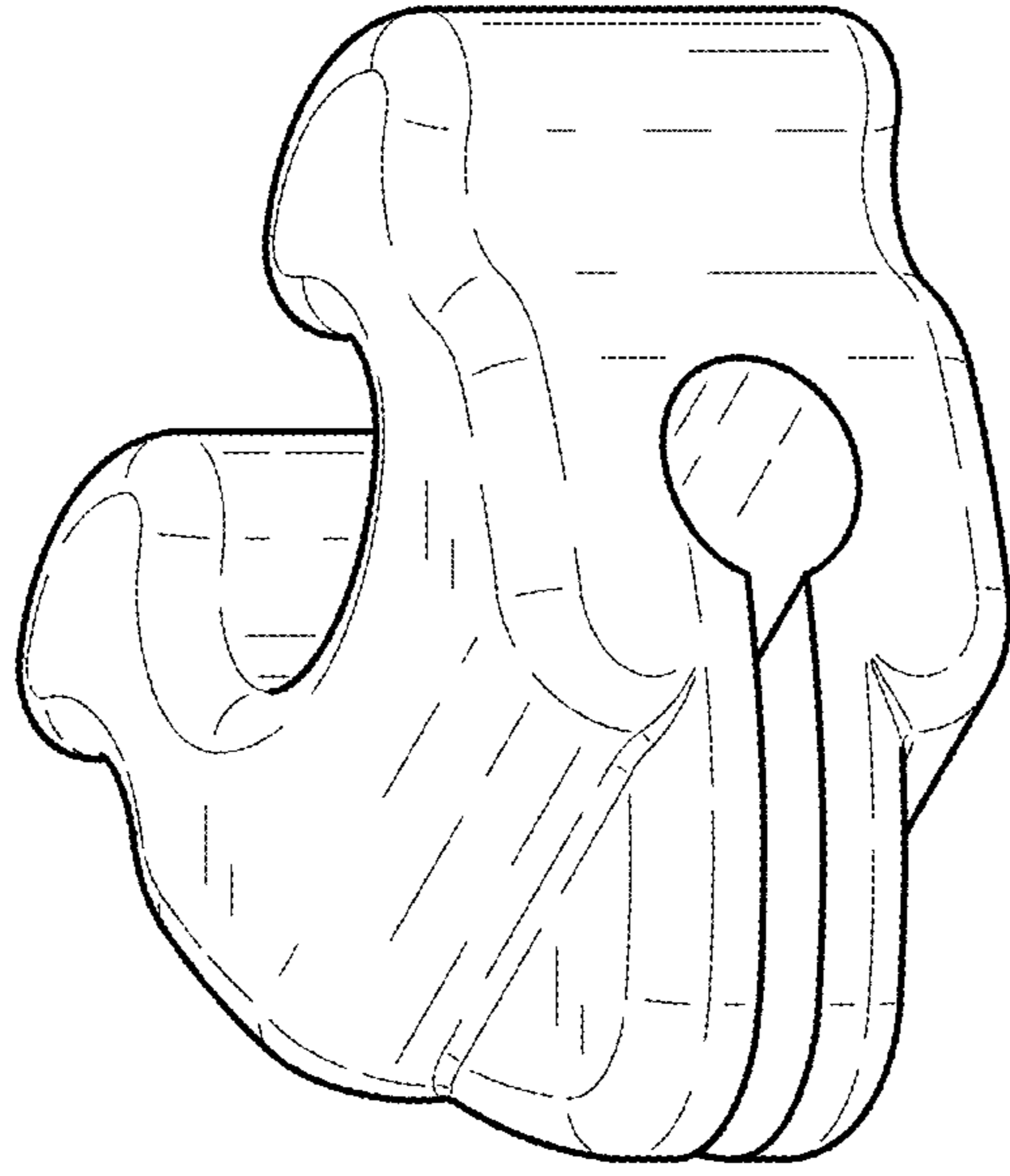

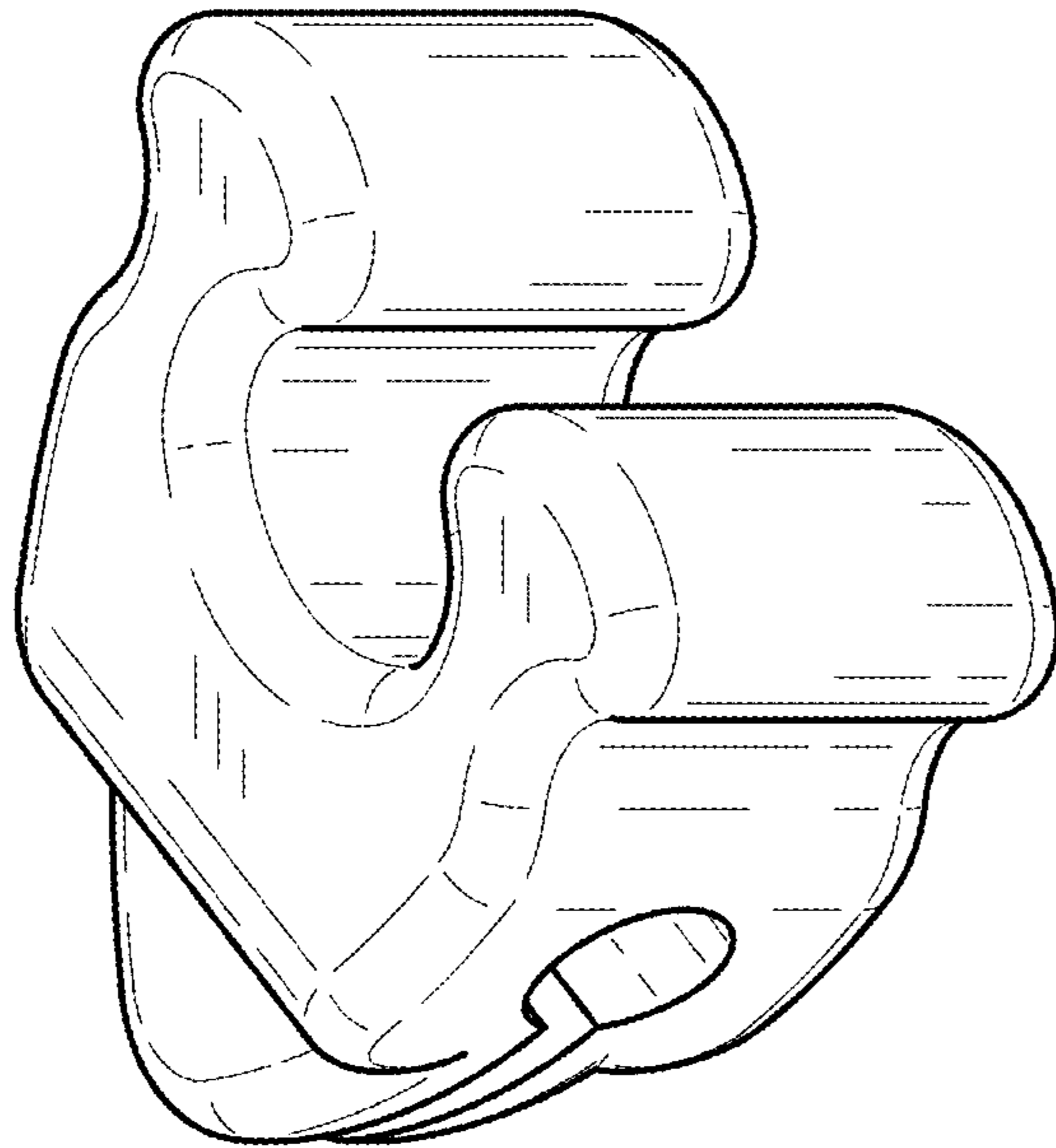

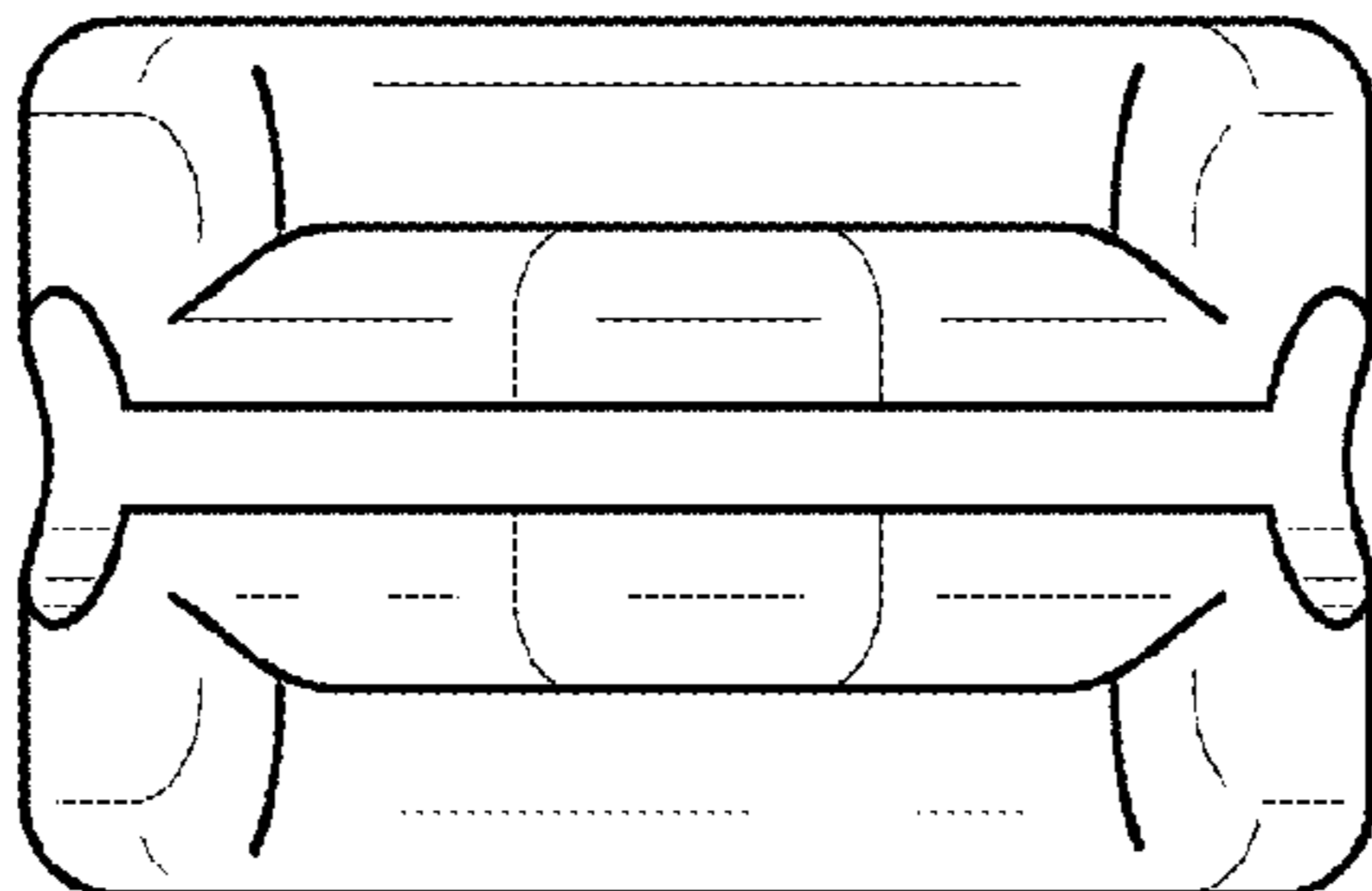

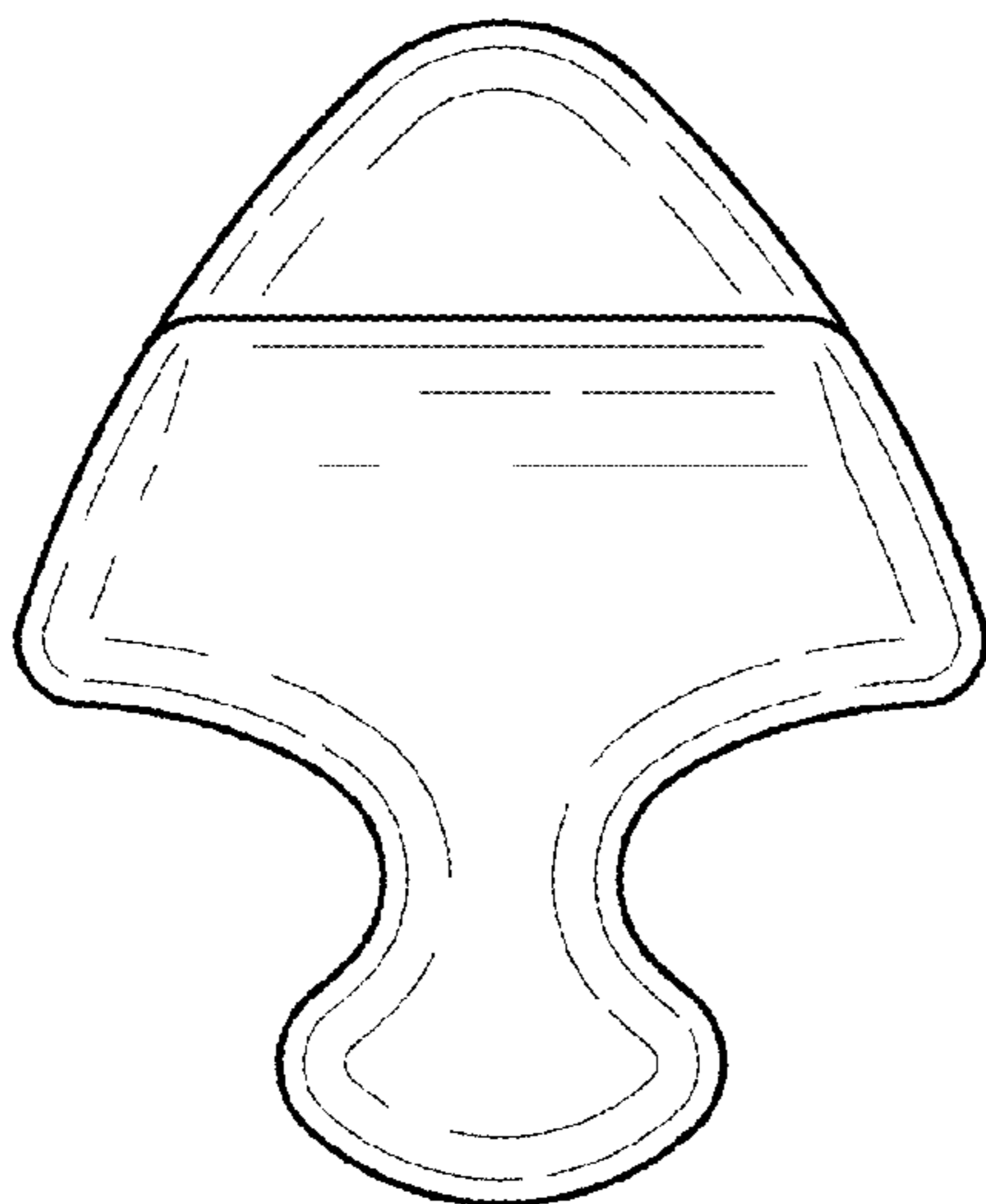

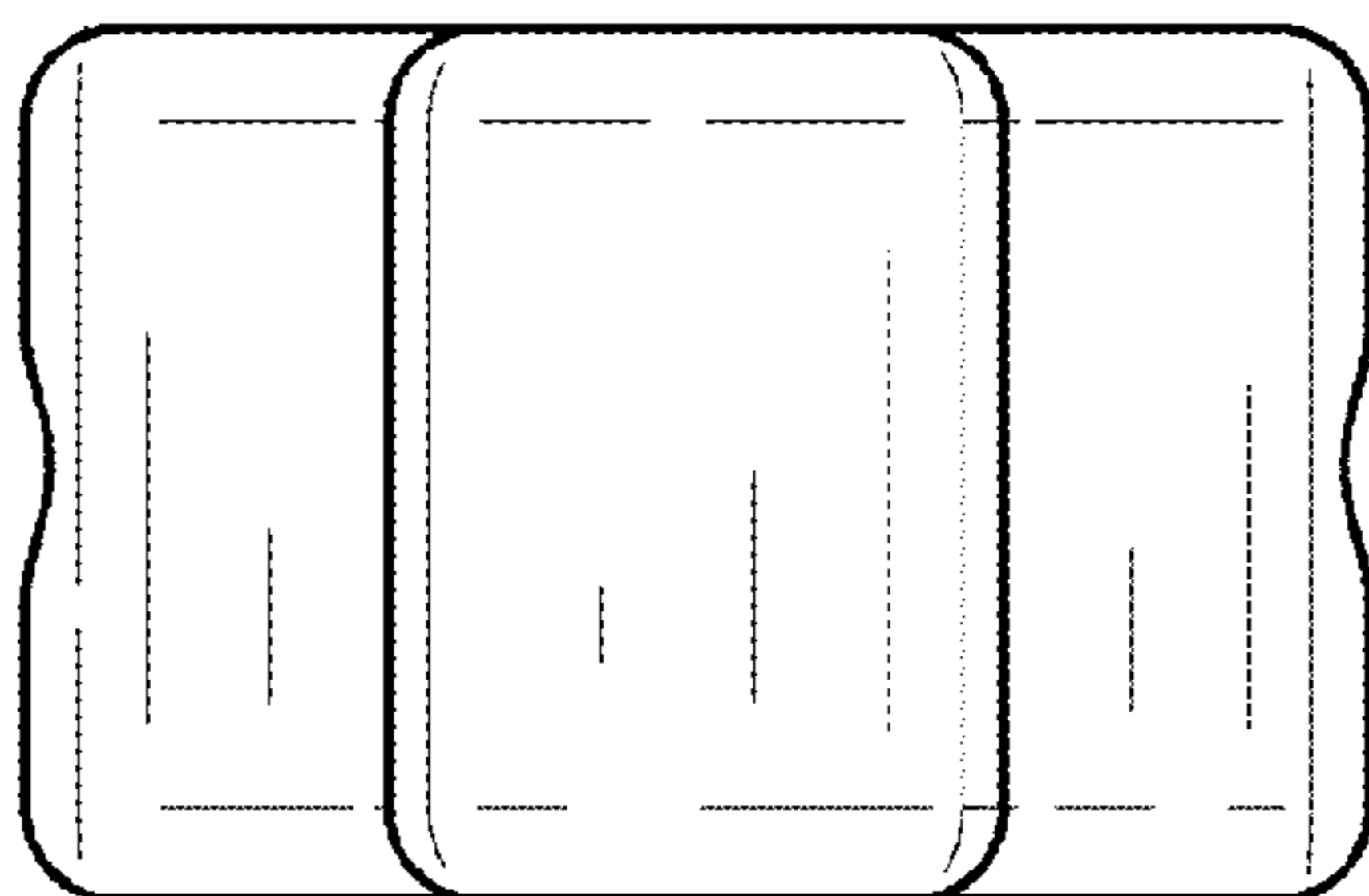

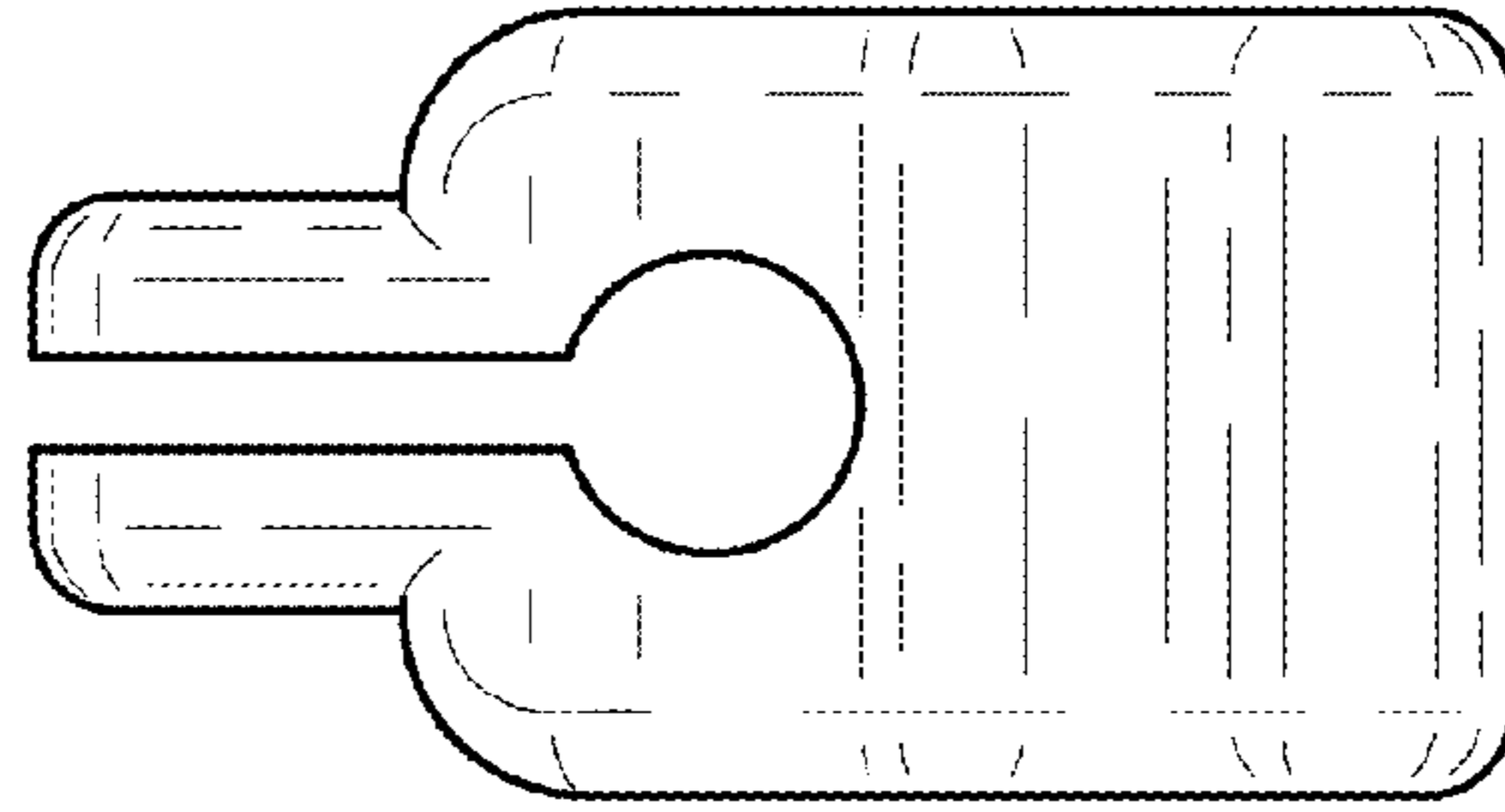

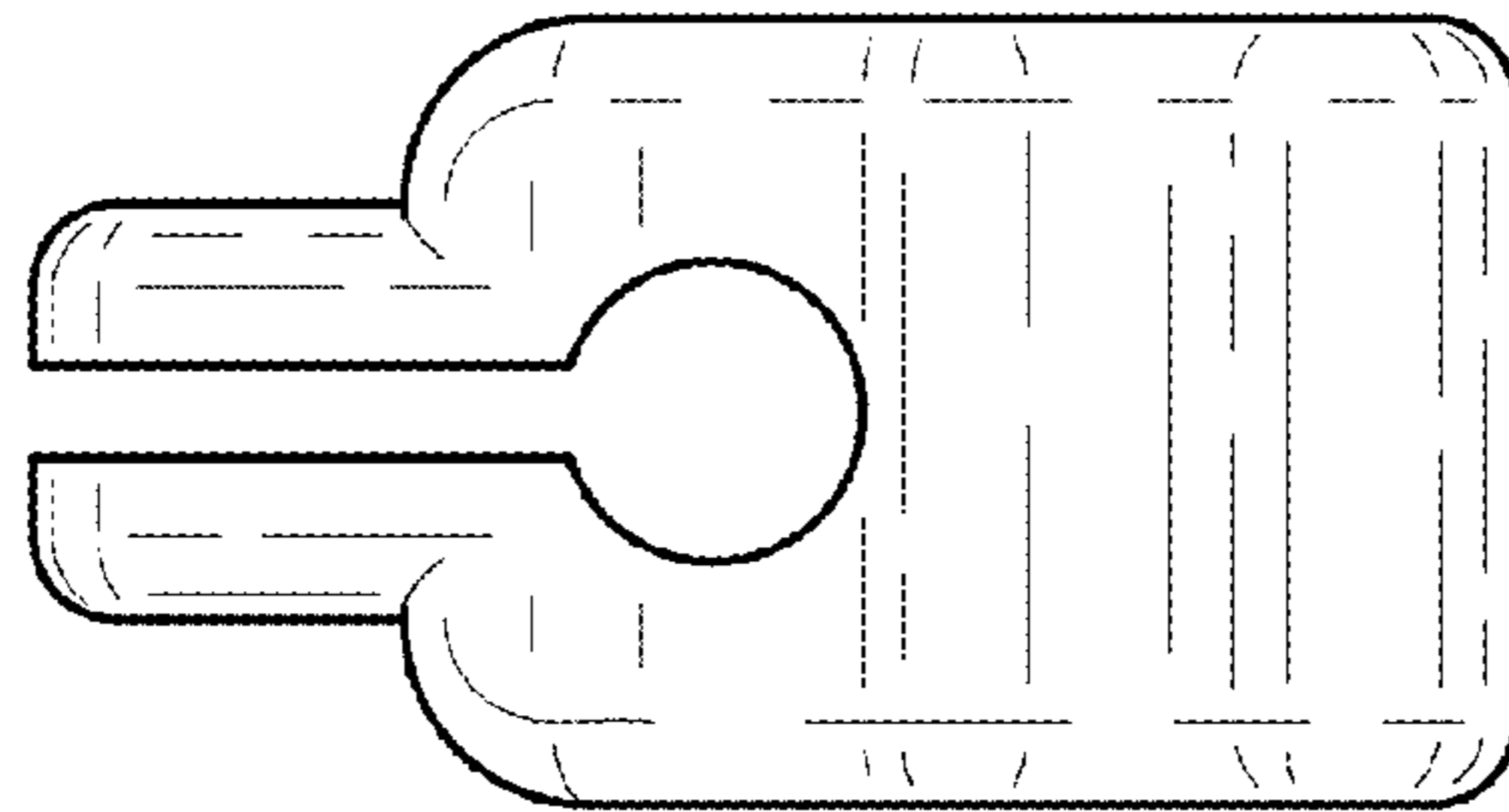

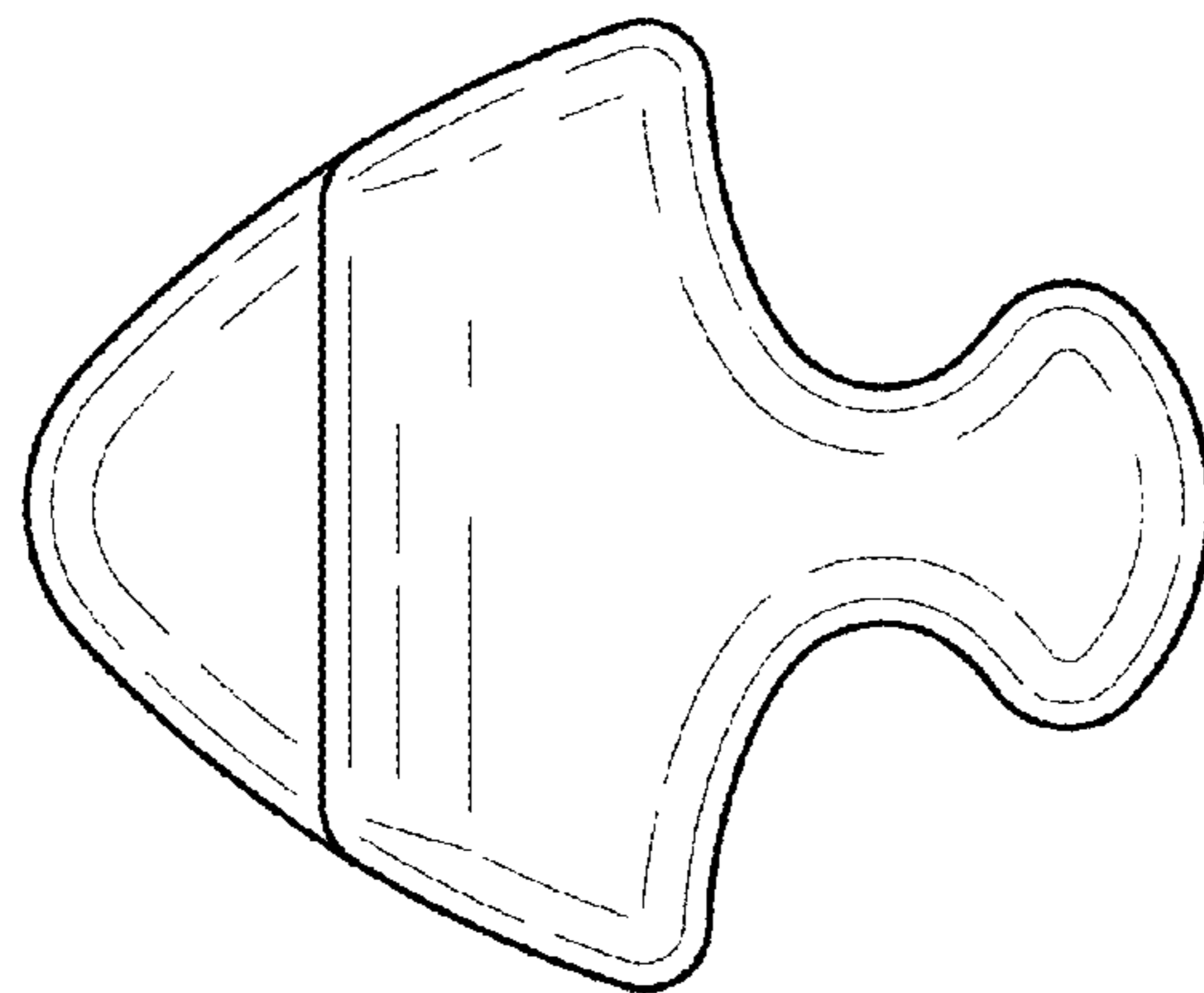

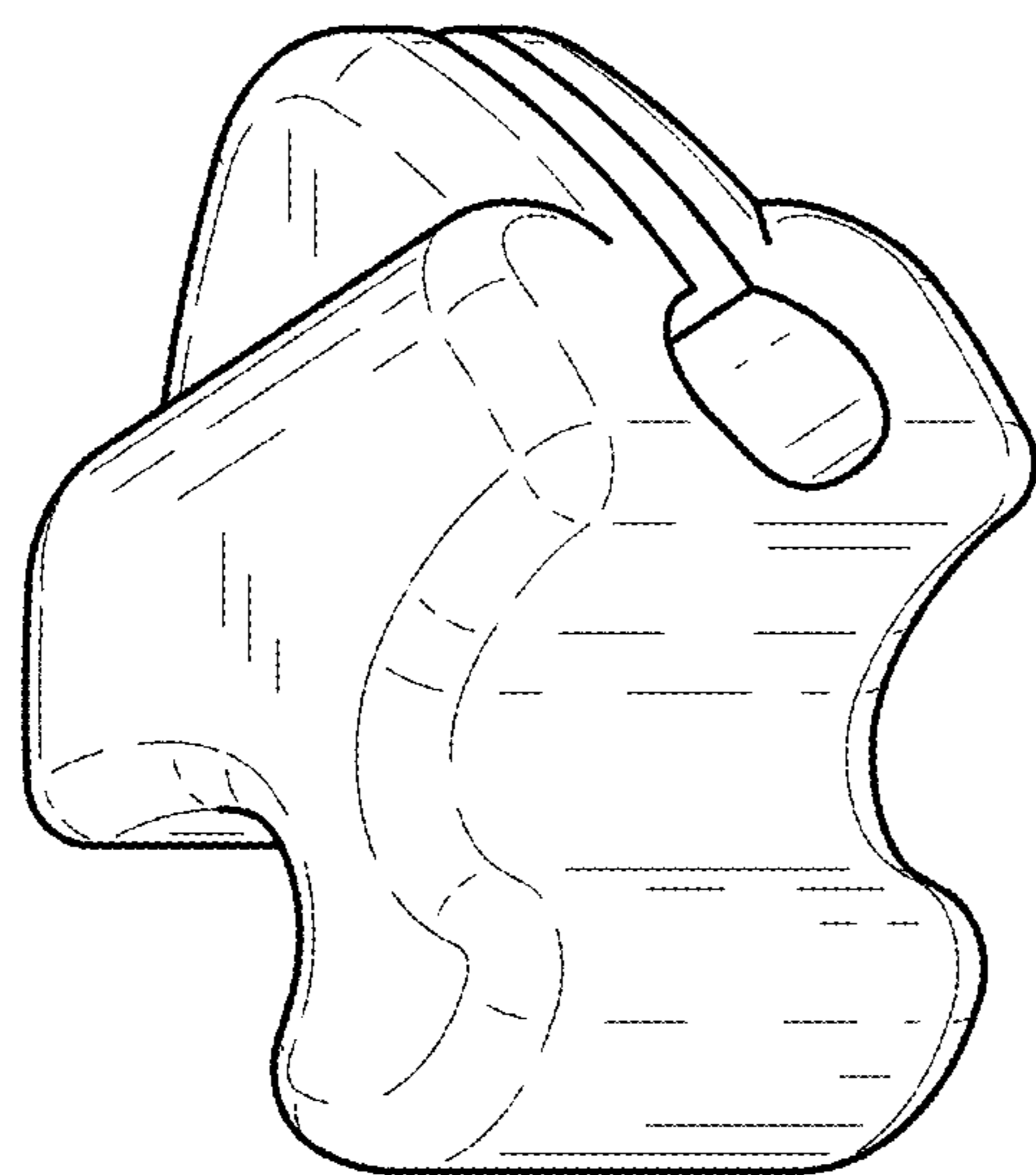

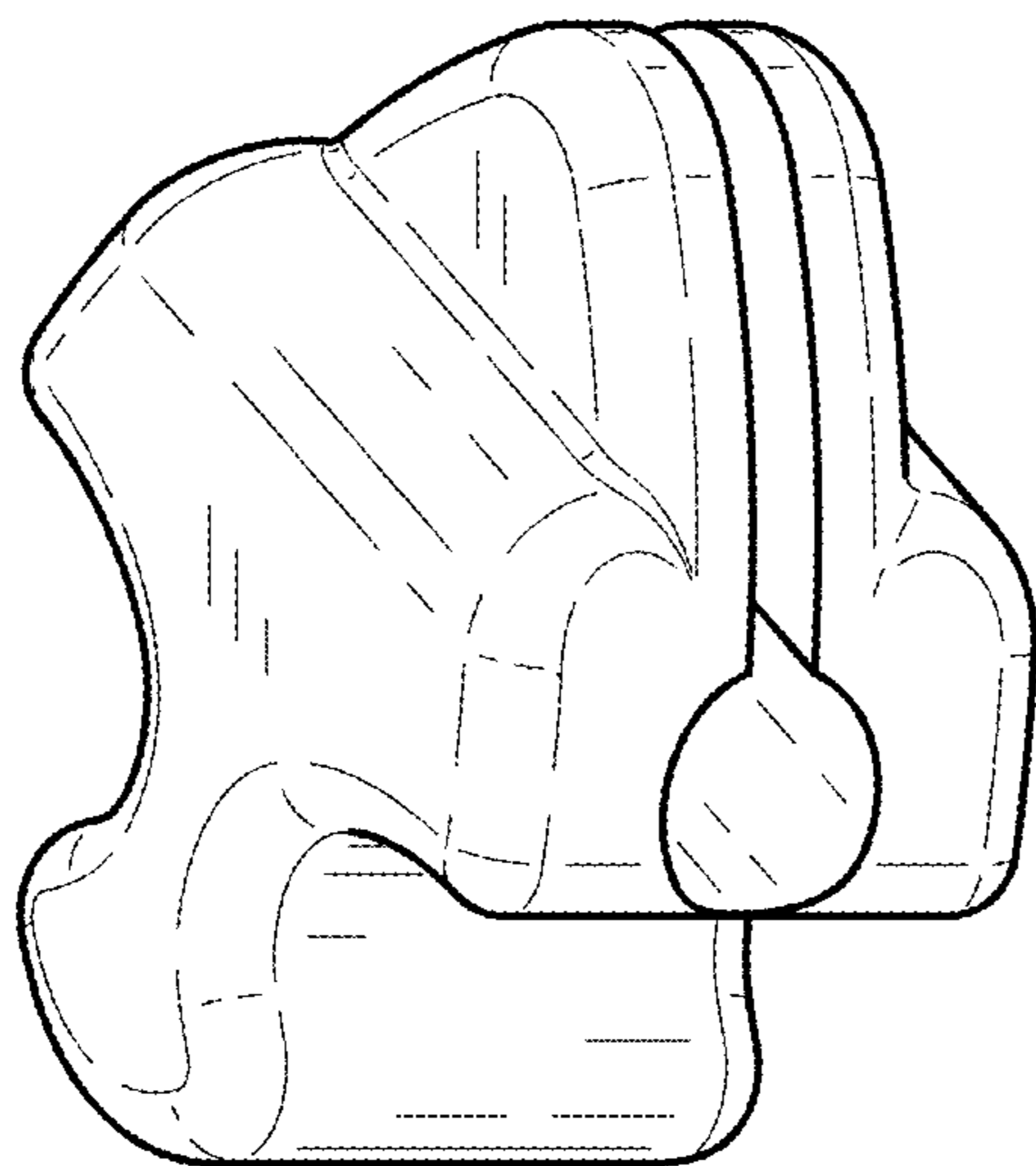

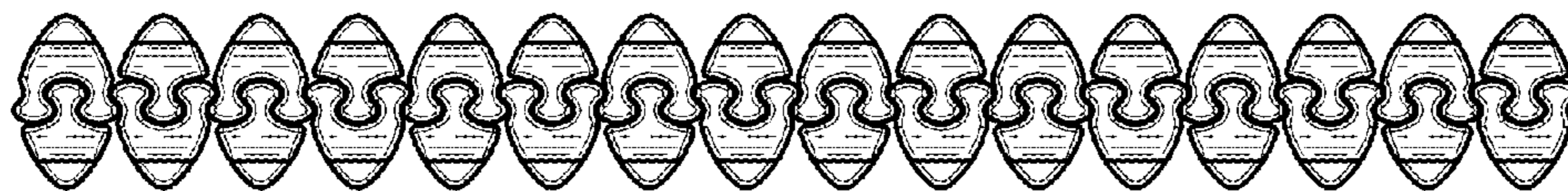

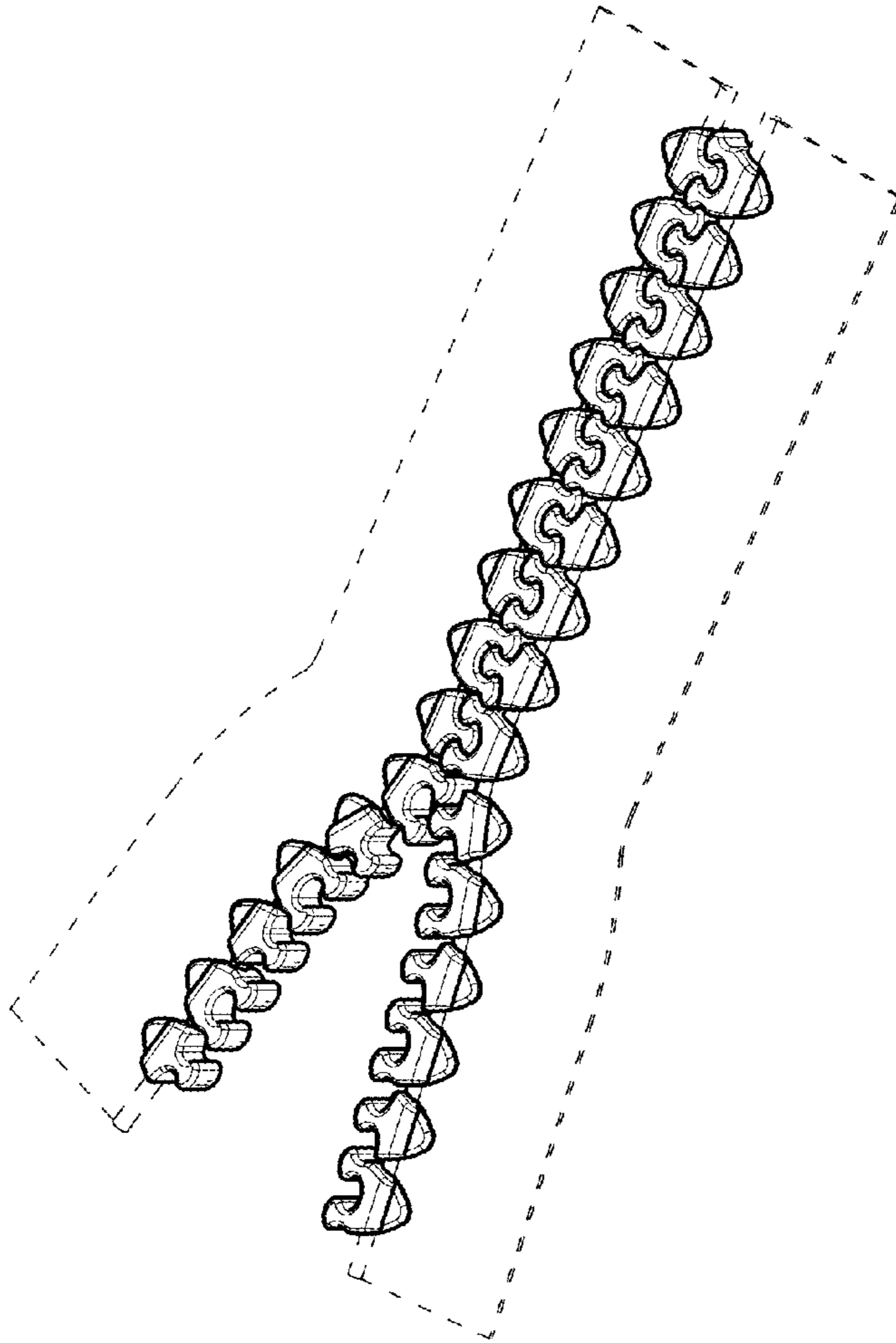
