(57) **CLAIM**

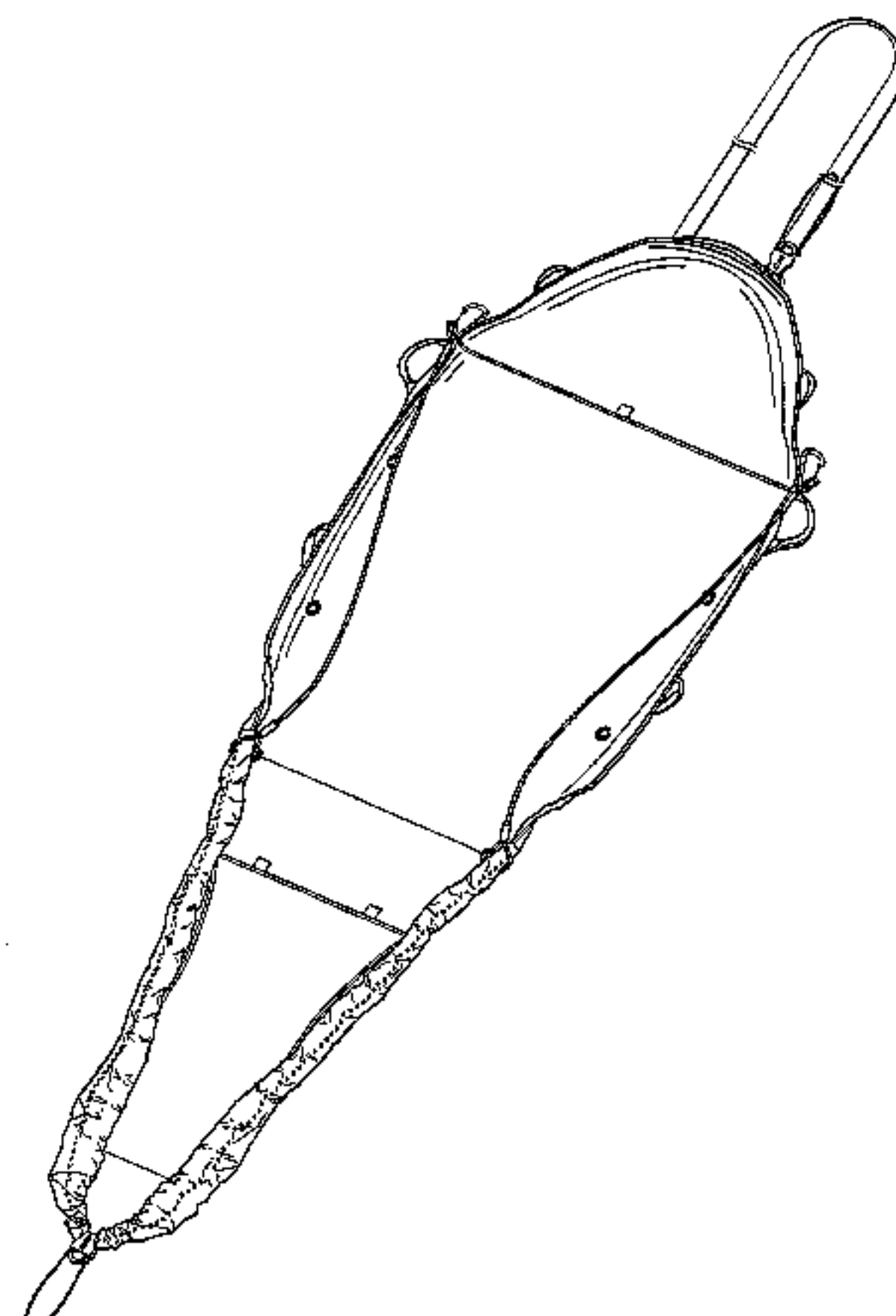
We claim the ornamental design for a field stretcher, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a field stretcher embodiment showing our new design;  
 FIG. 2 is a front elevation view thereof;  
 FIG. 3 is a back elevation view thereof;  
 FIG. 4 is a side elevation view thereof;  
 FIG. 5 is the opposite side elevation view thereof;  
 FIG. 6 is a top elevation view thereof;

 FIG. 8 is a front perspective view of a modified embodiment of the embodiment of FIG. 1;  
 FIG. 9 is a front elevation view thereof;  
 FIG. 10 is a back elevation view thereof;  
 FIG. 11 is a side elevation view thereof;  
 FIG. 12 is an opposite side elevation view thereof;  
 FIG. 13 is a top elevation view thereof;  
 FIG. 14 is a bottom elevation view thereof;  
 FIG. 15 is a front perspective view thereof, in a drawn condition;  
 FIG. 16 is a front elevation view thereof;  
 FIG. 17 is a back elevation view thereof;  
 FIG. 18 is a side elevation view thereof;  
 FIG. 19 is an opposite side elevation view thereof;  
 FIG. 20 is a top elevation view;  
 FIG. 21 is a bottom elevation view thereof;  
 FIG. 22 is a front perspective view thereof, in a partially drawn condition; and,  
 FIG. 23 is a front elevation view thereof, in a partially drawn condition.

Broken lines or dotted sections in any of the foregoing Figures are for illustrative purposes only and form no part of the claimed design. The top hand strap shown broken in the middle to indicate indeterminate length, with the understanding that the “indeterminate” portion of the strap forms no part of the claimed design. Patentability is based only on those portions of the article shown in solid lines.

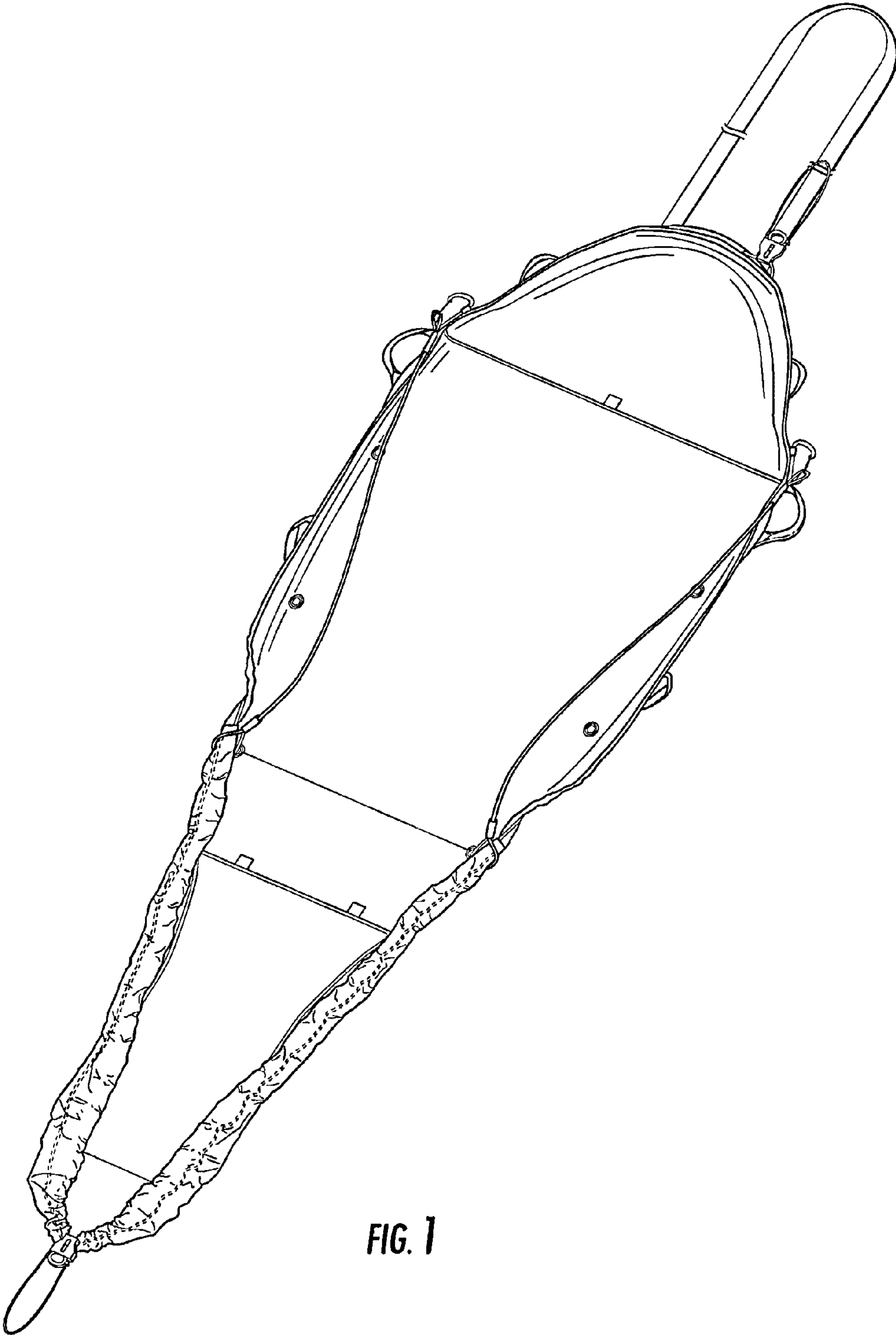

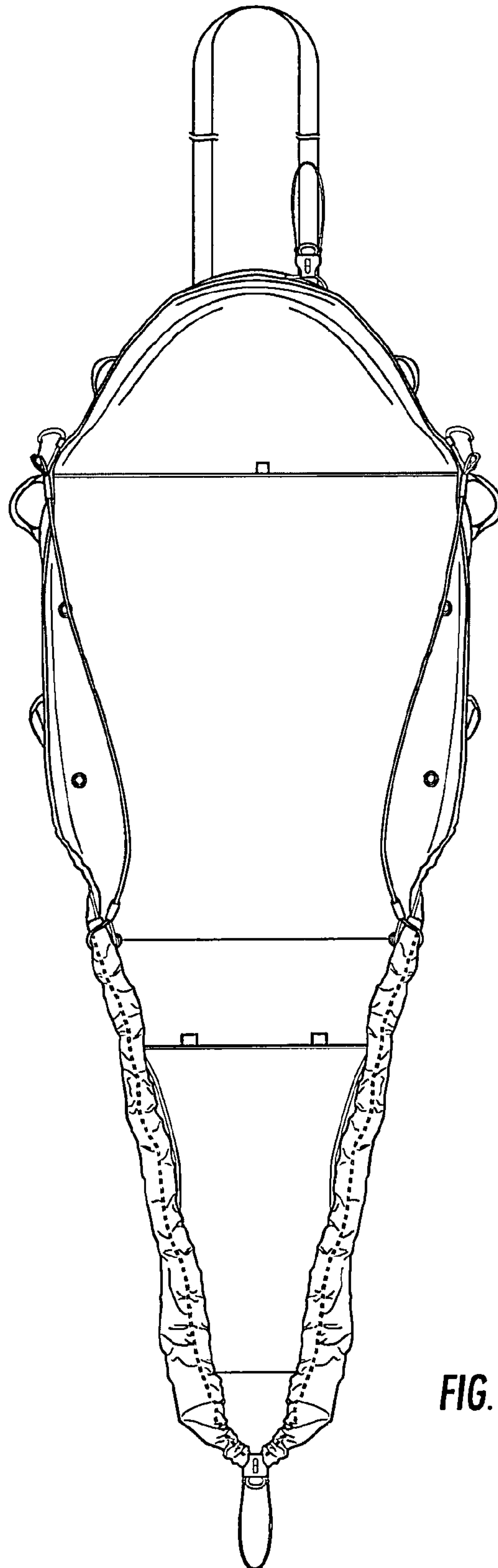

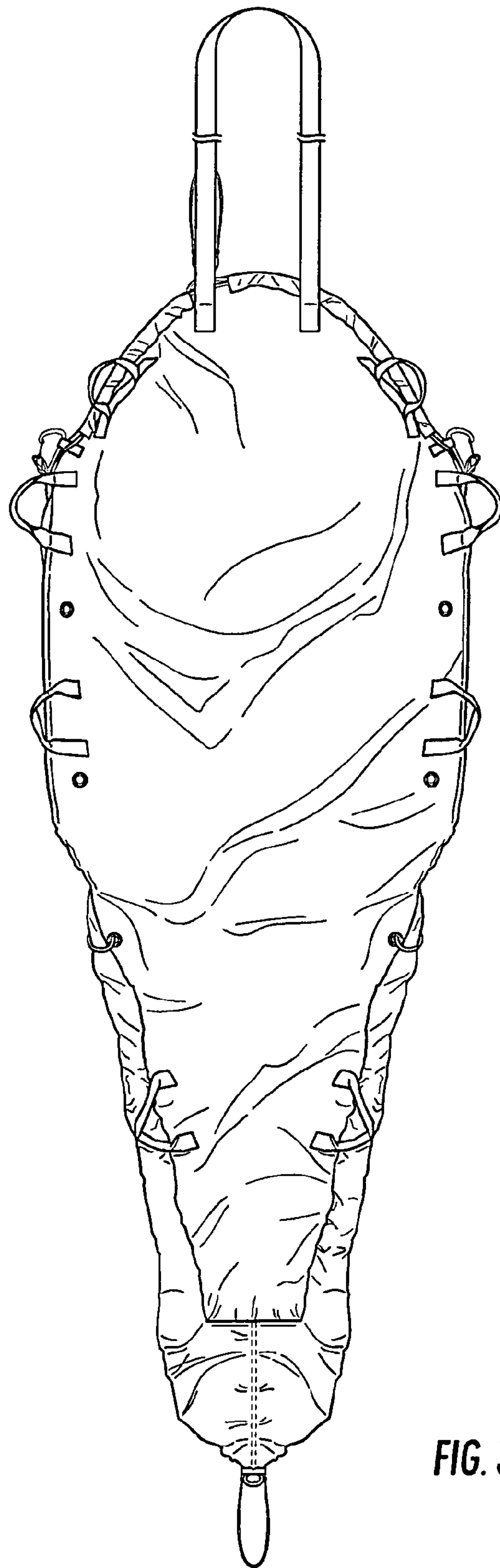

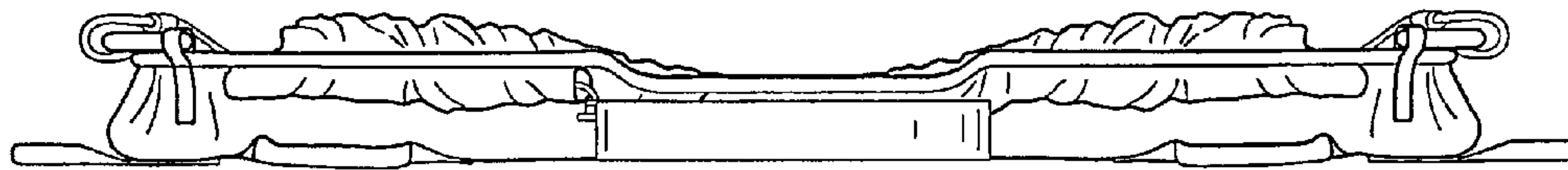

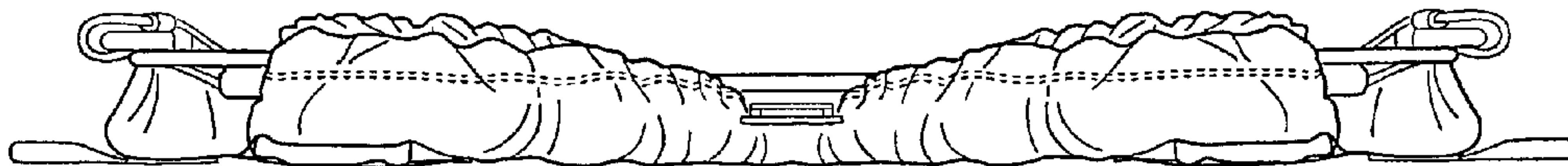

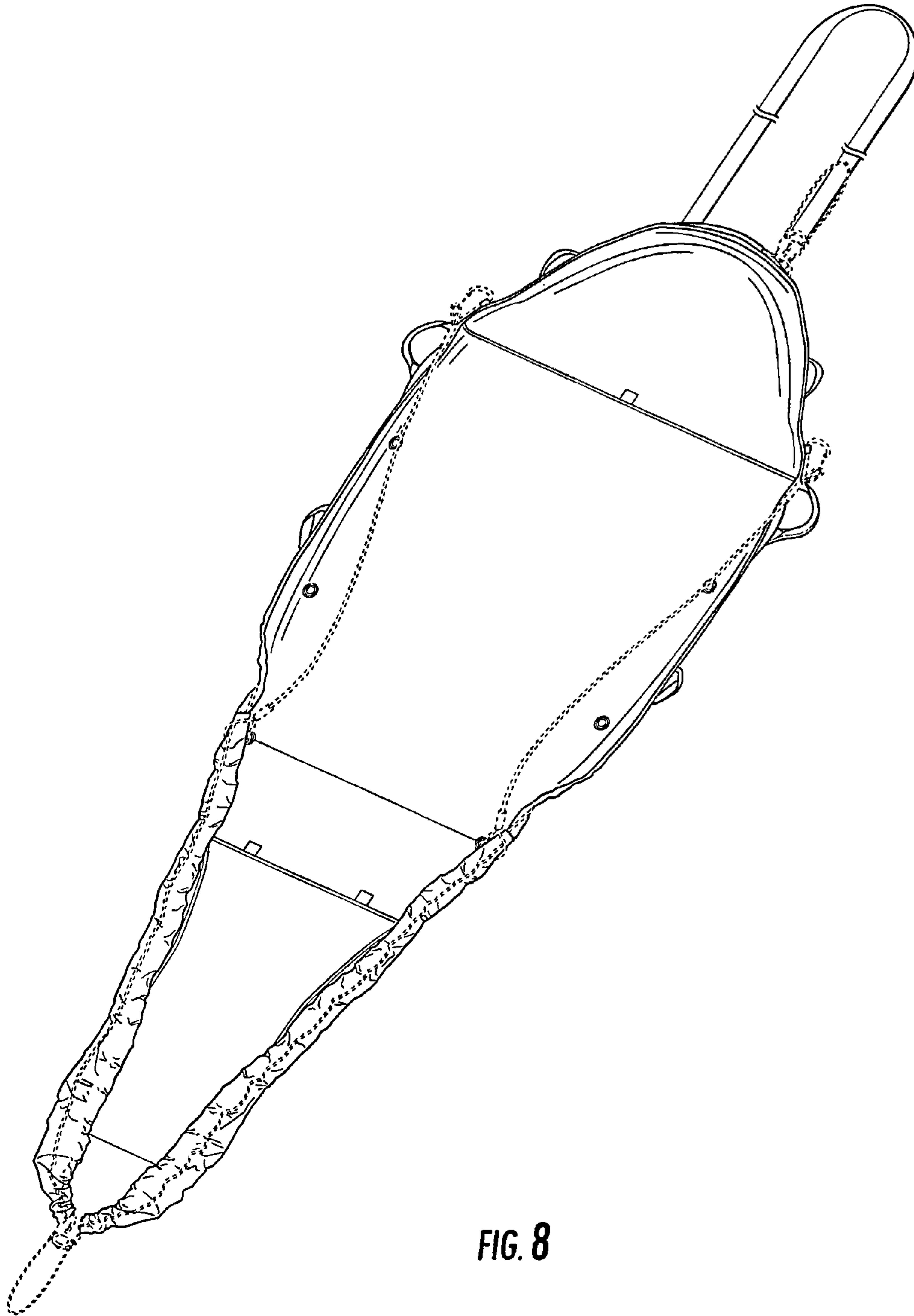

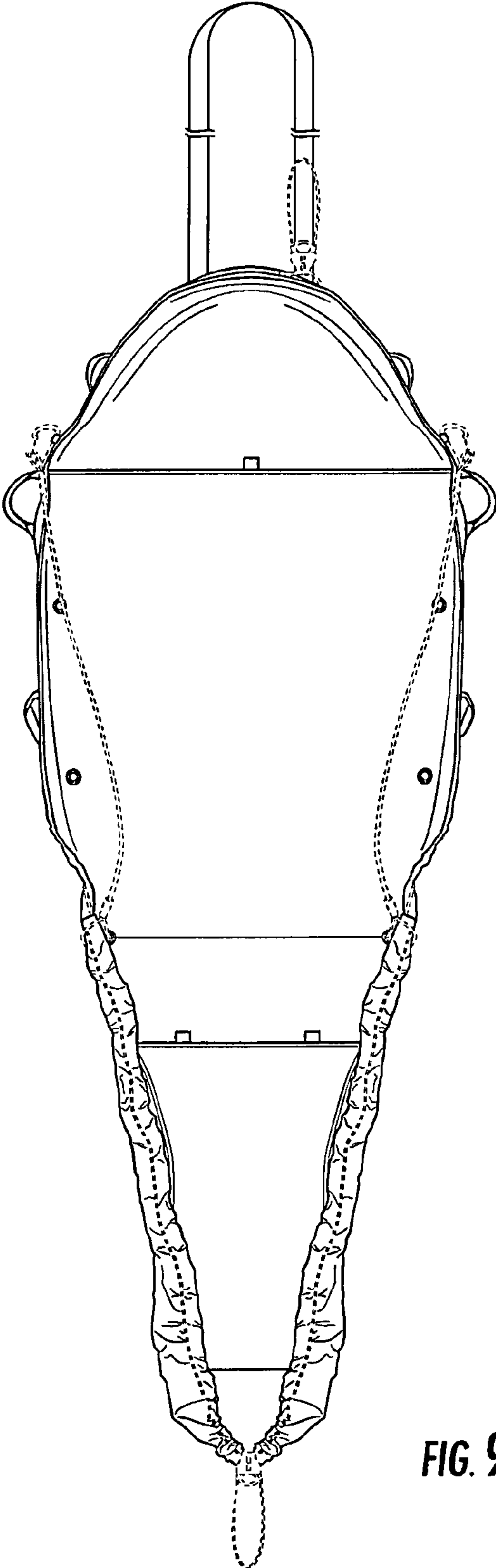

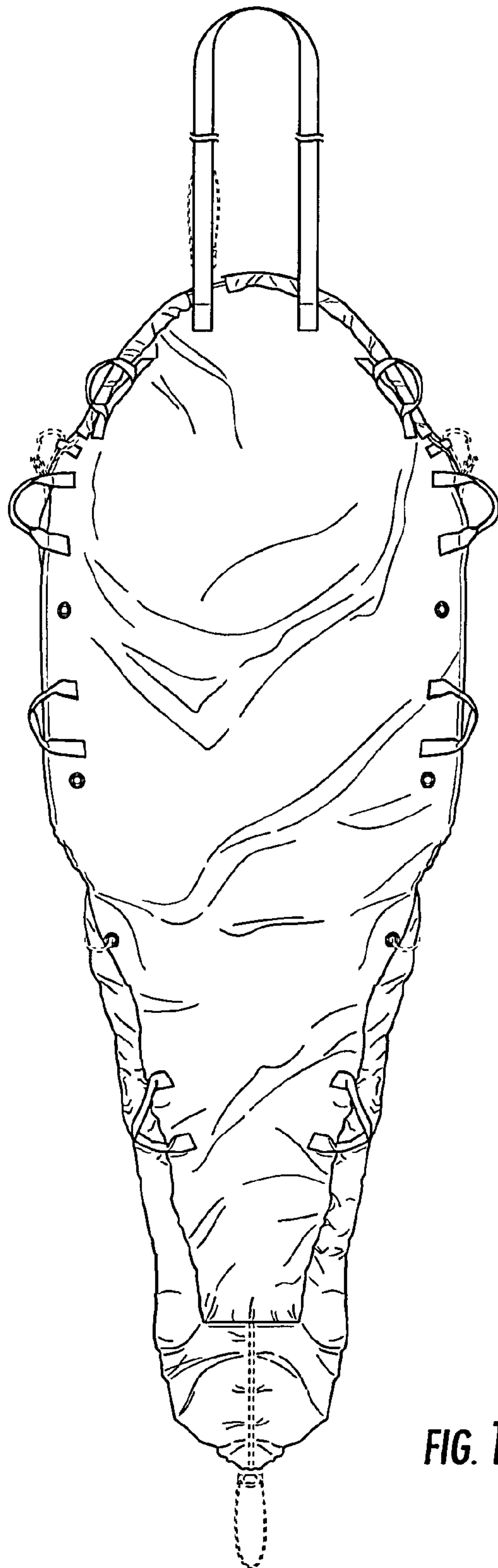

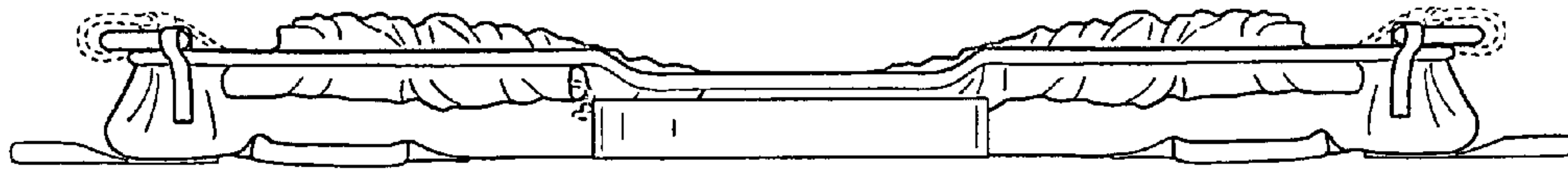

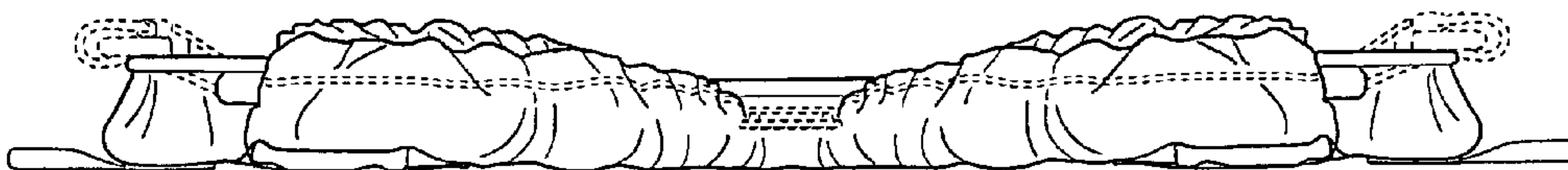

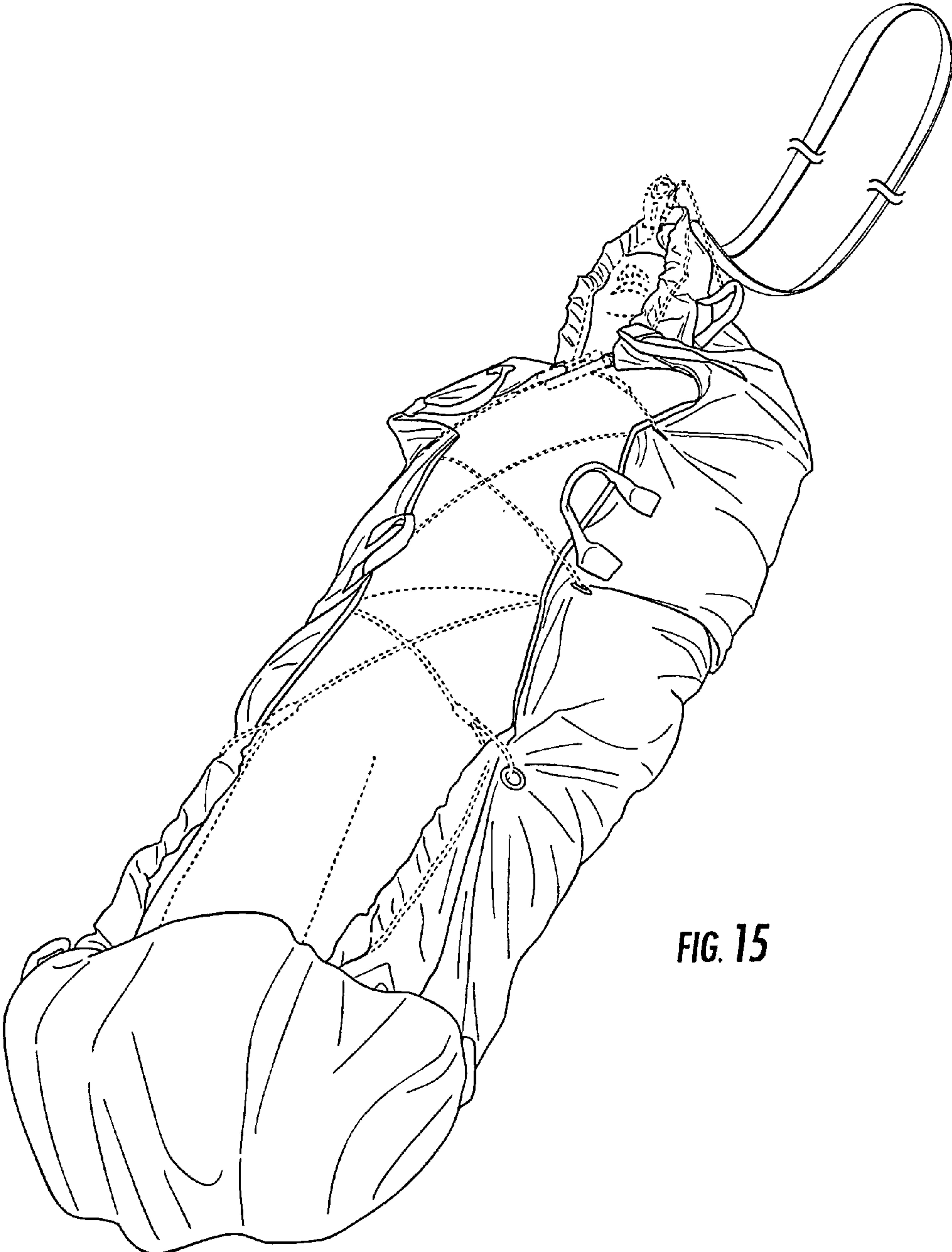

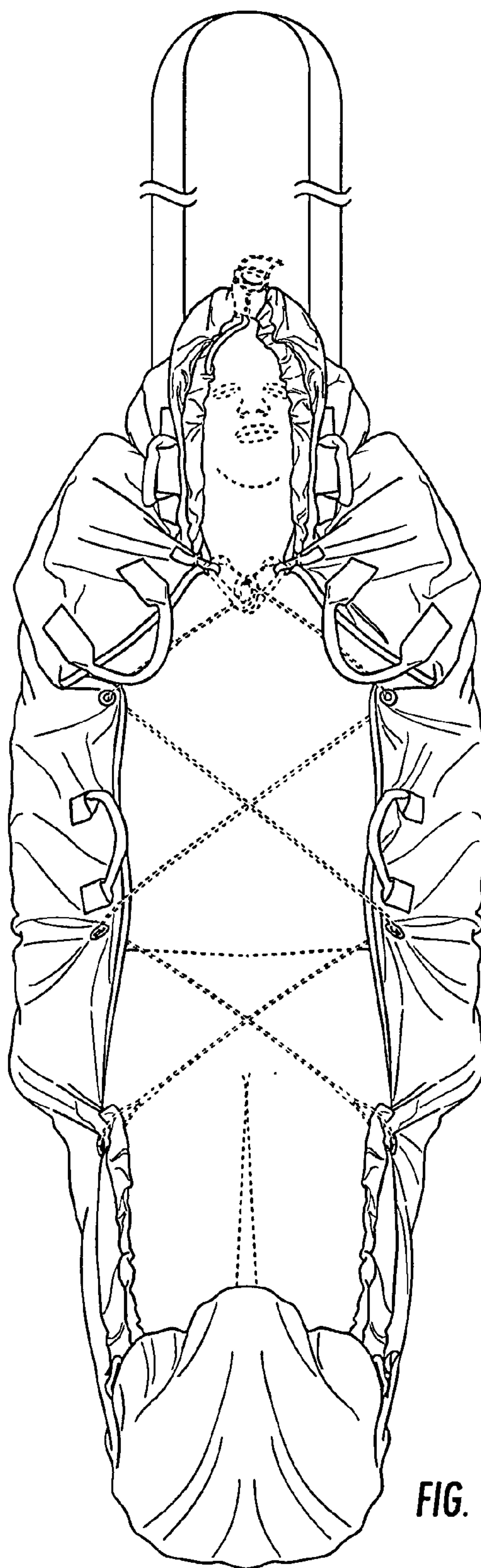

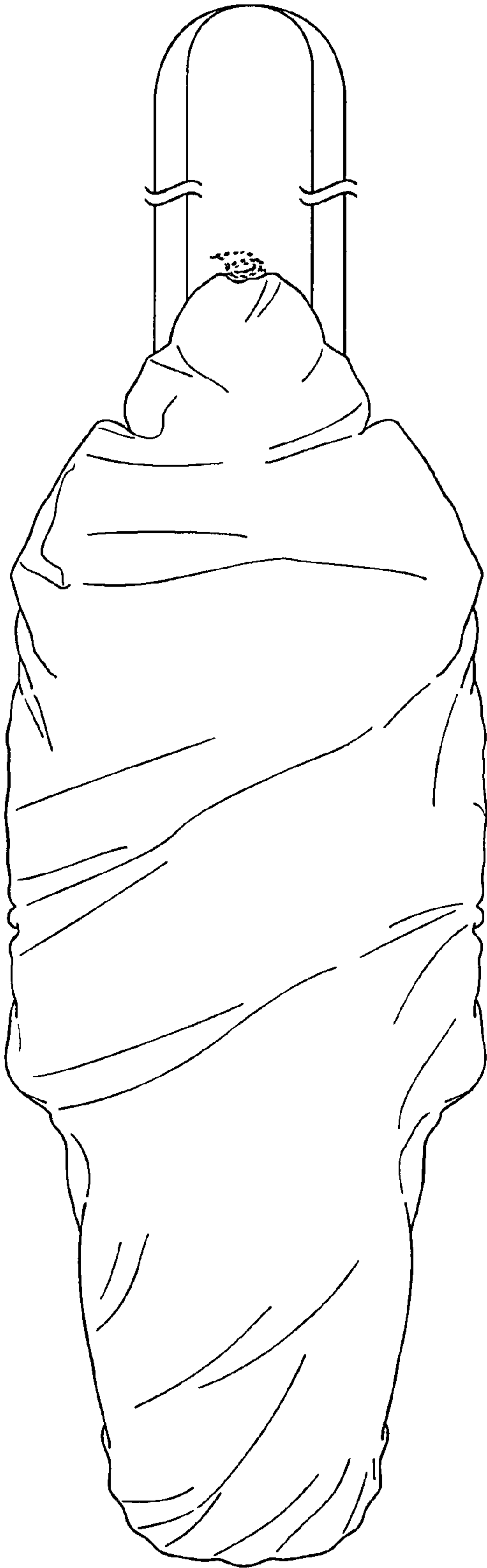

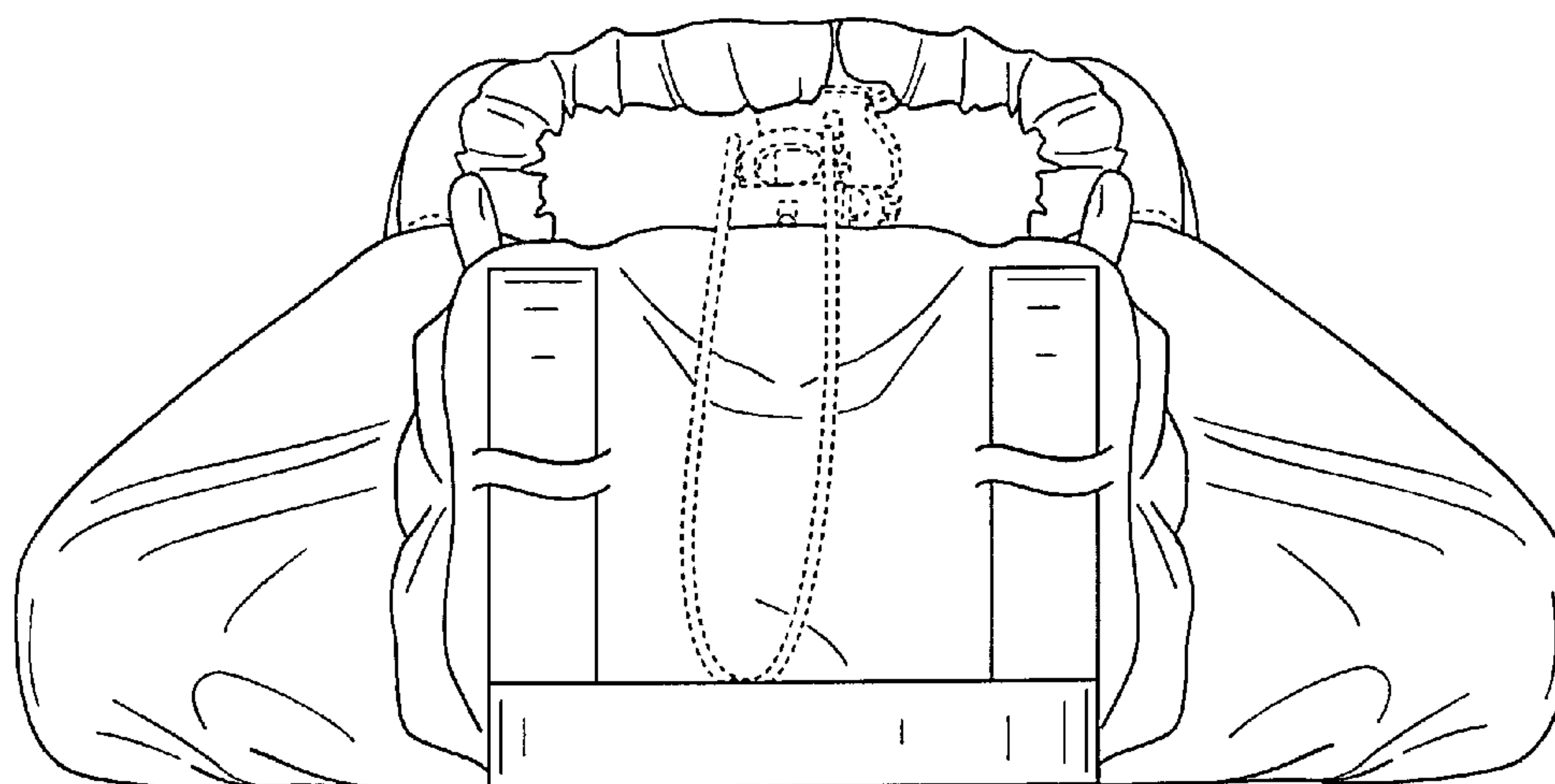

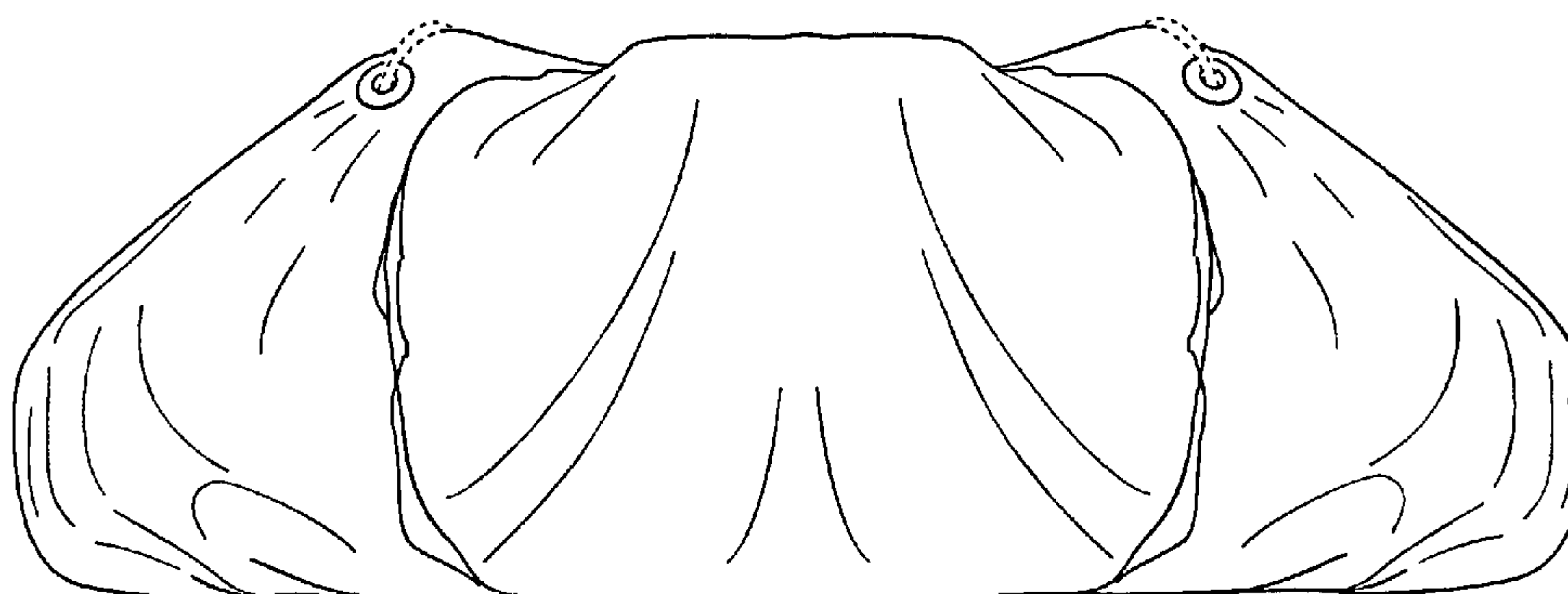

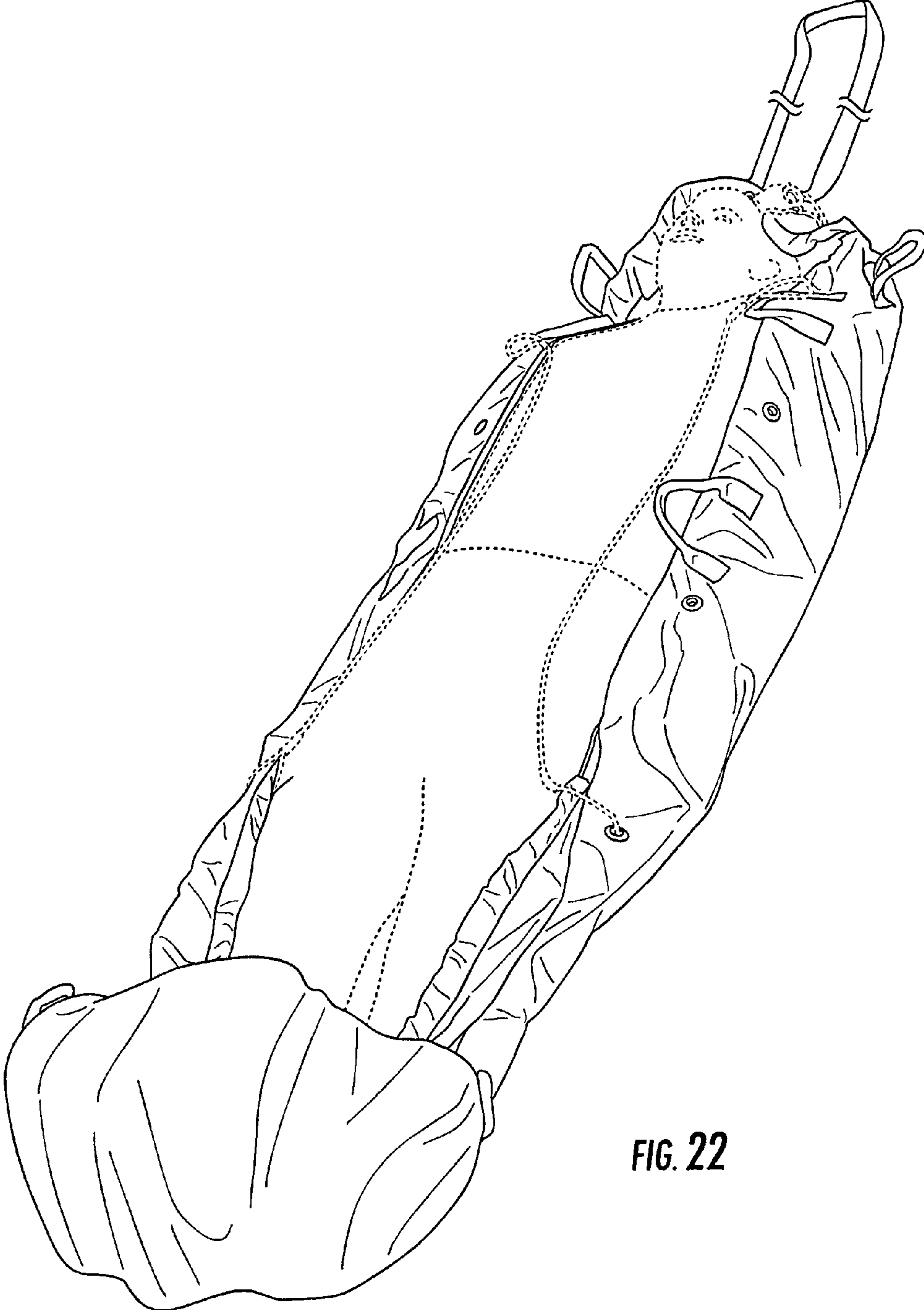

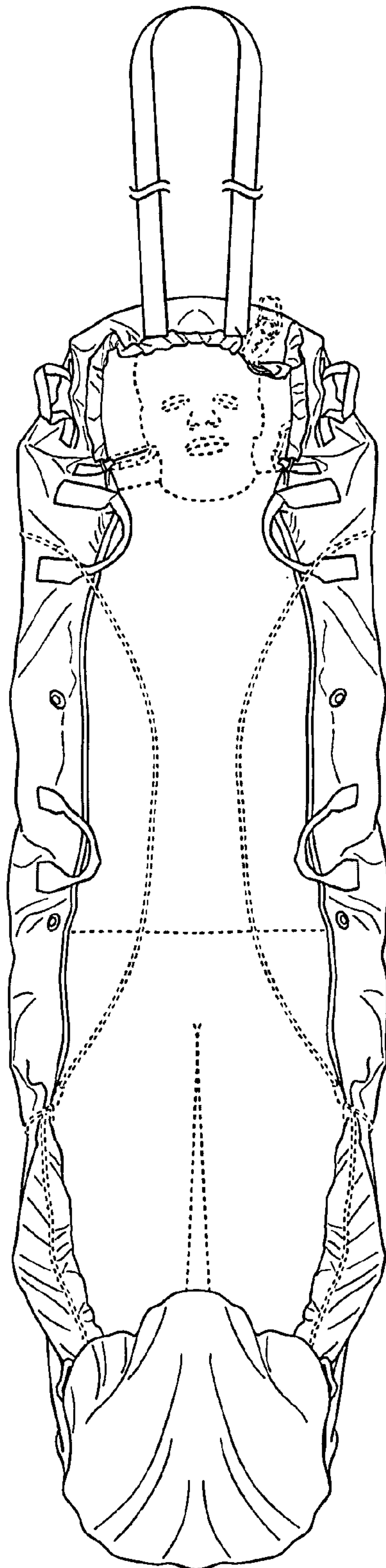
