DESCRIPTION

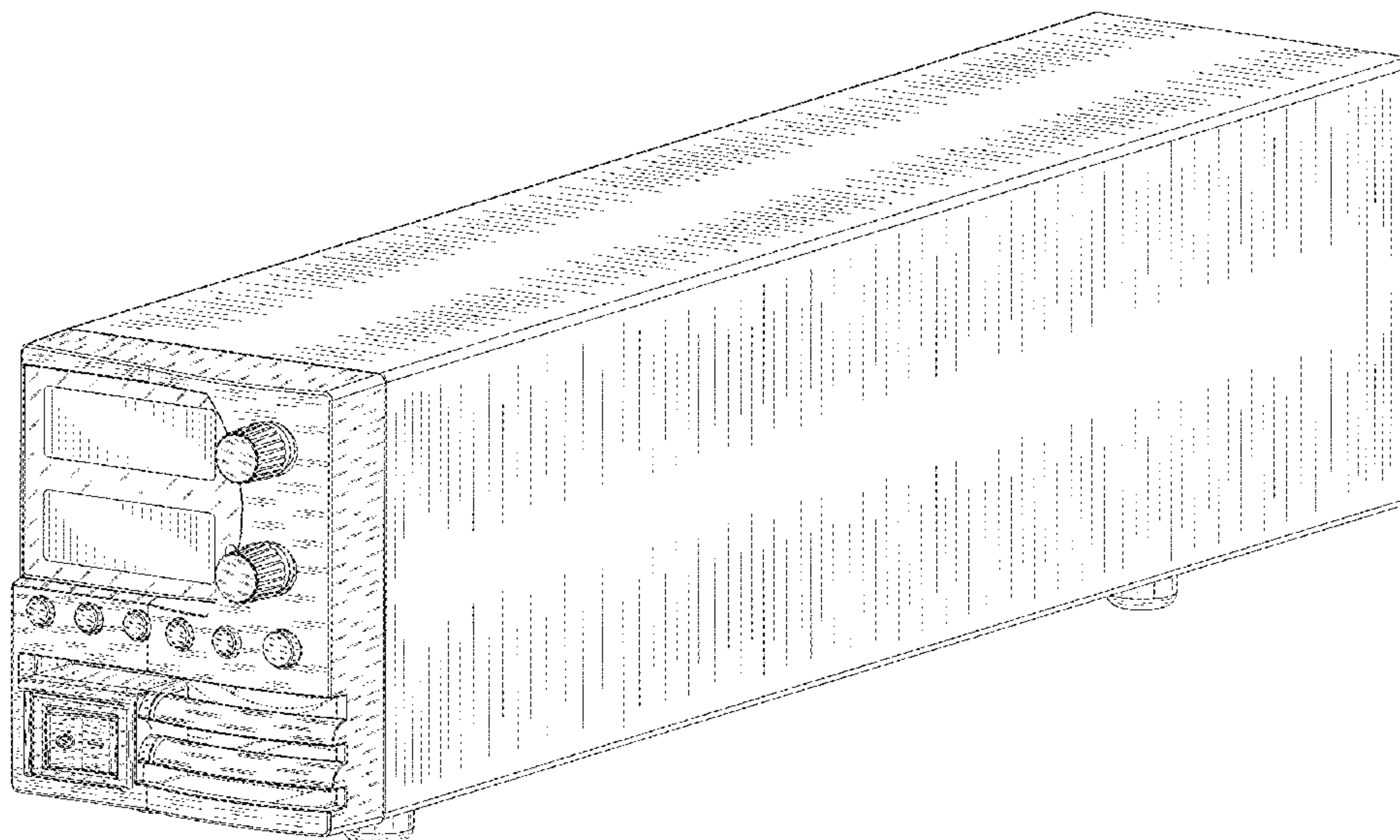
FIG. 1 is a front view of a power supply device showing our new design;

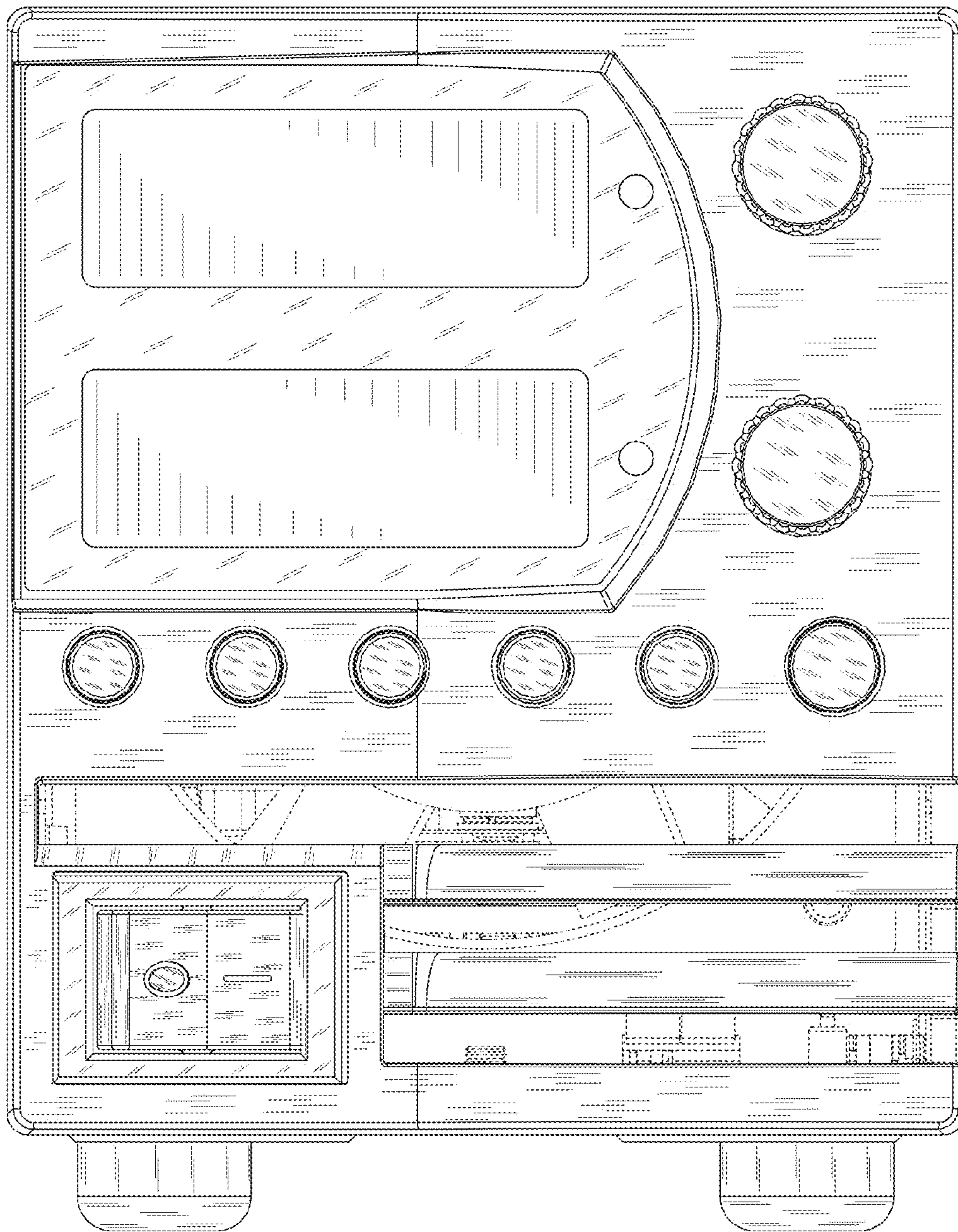

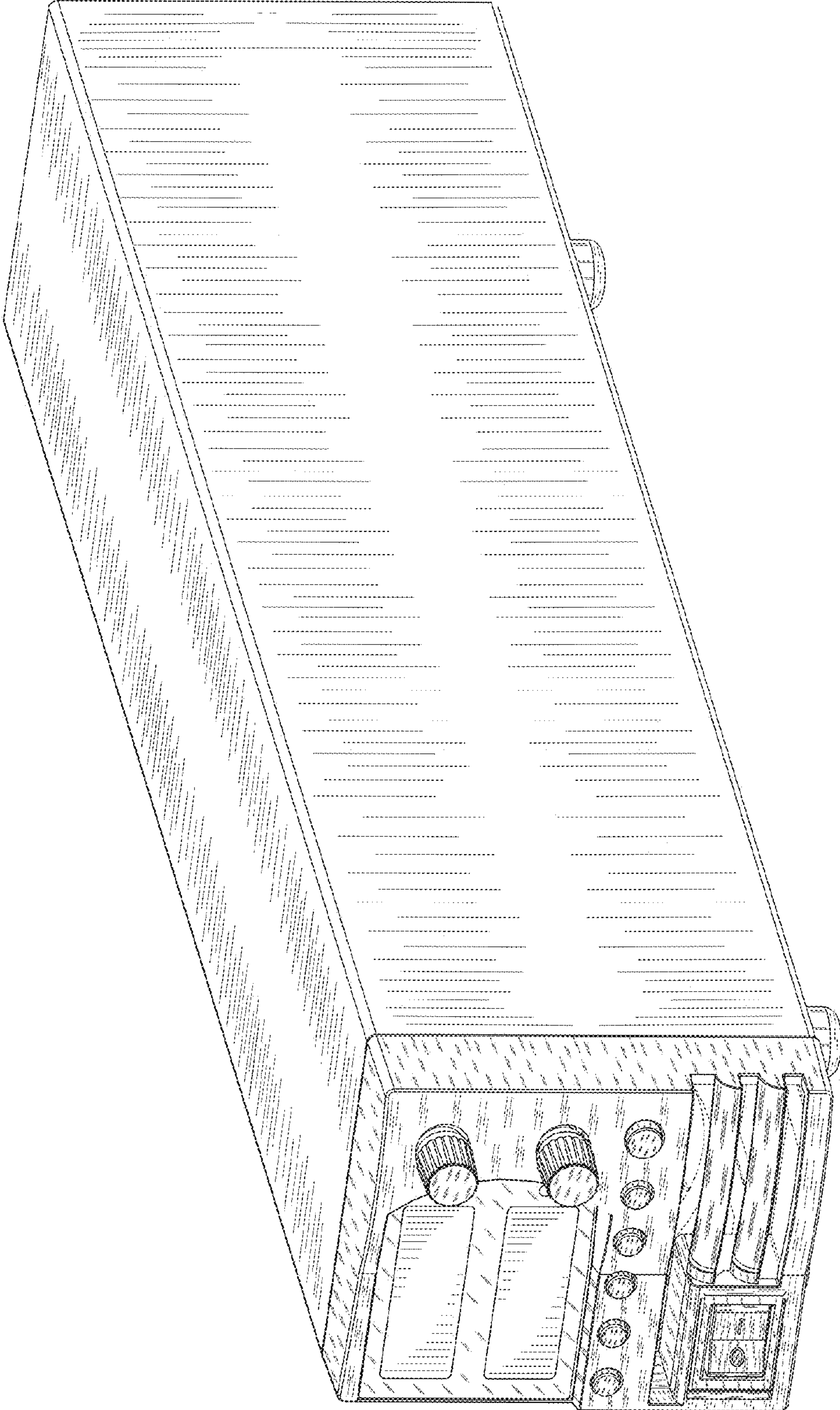

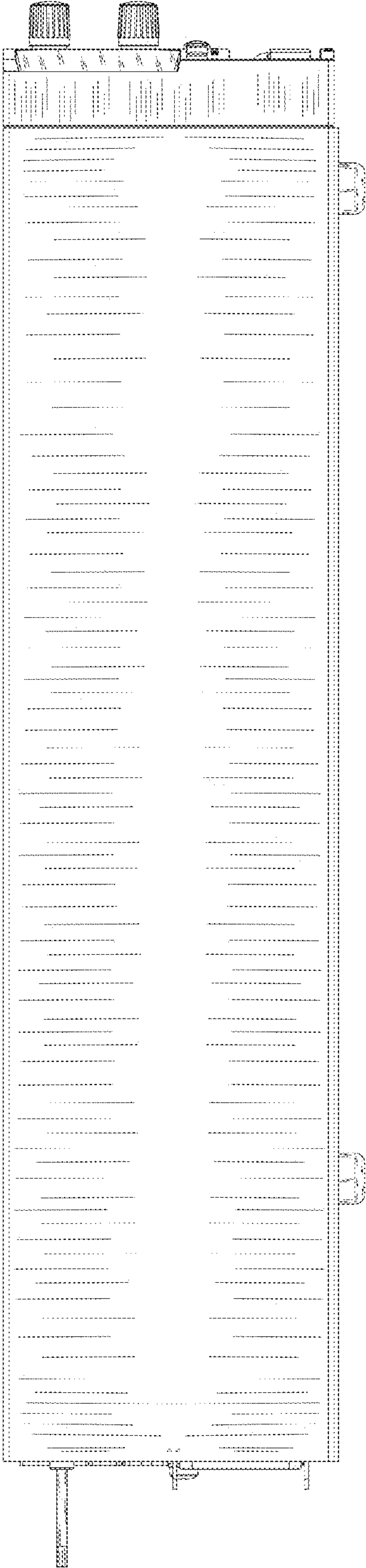

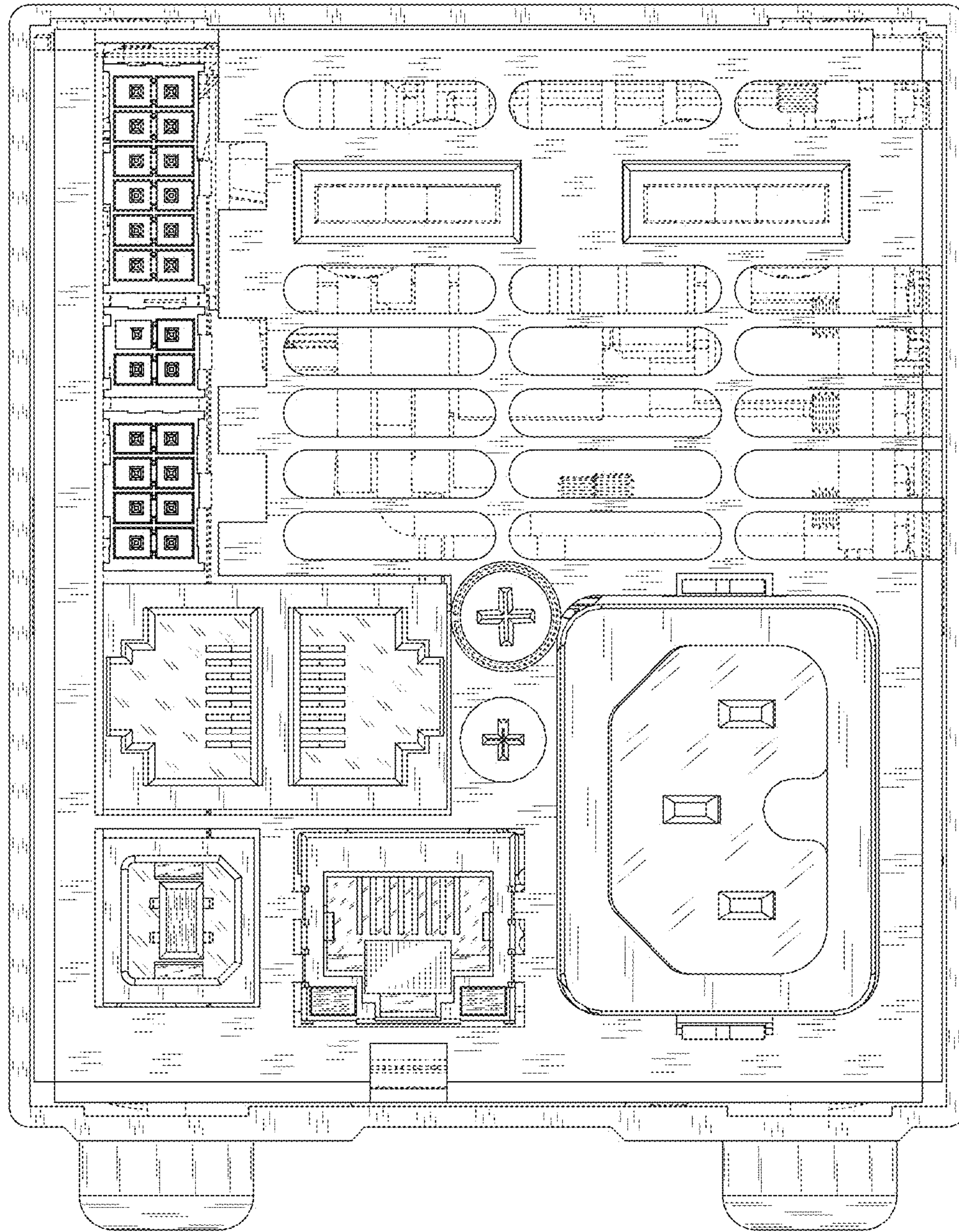

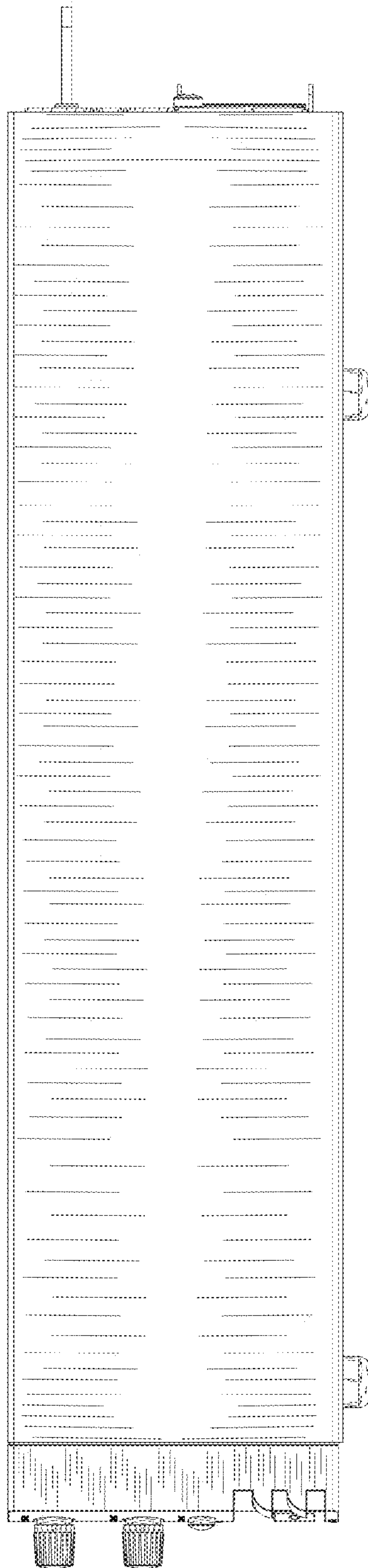

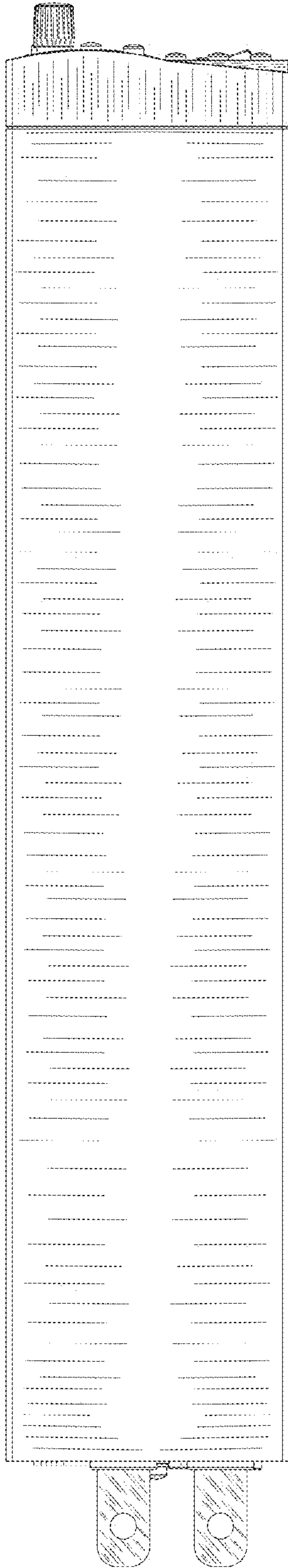

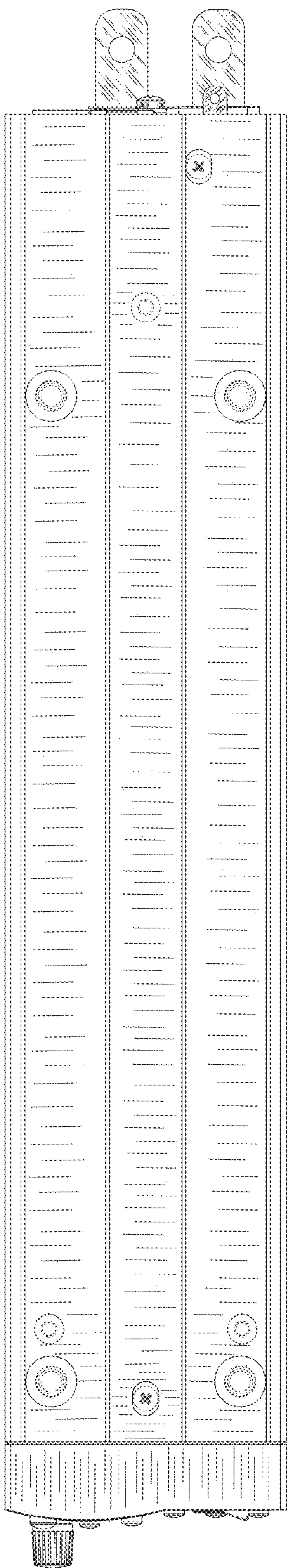
