described.

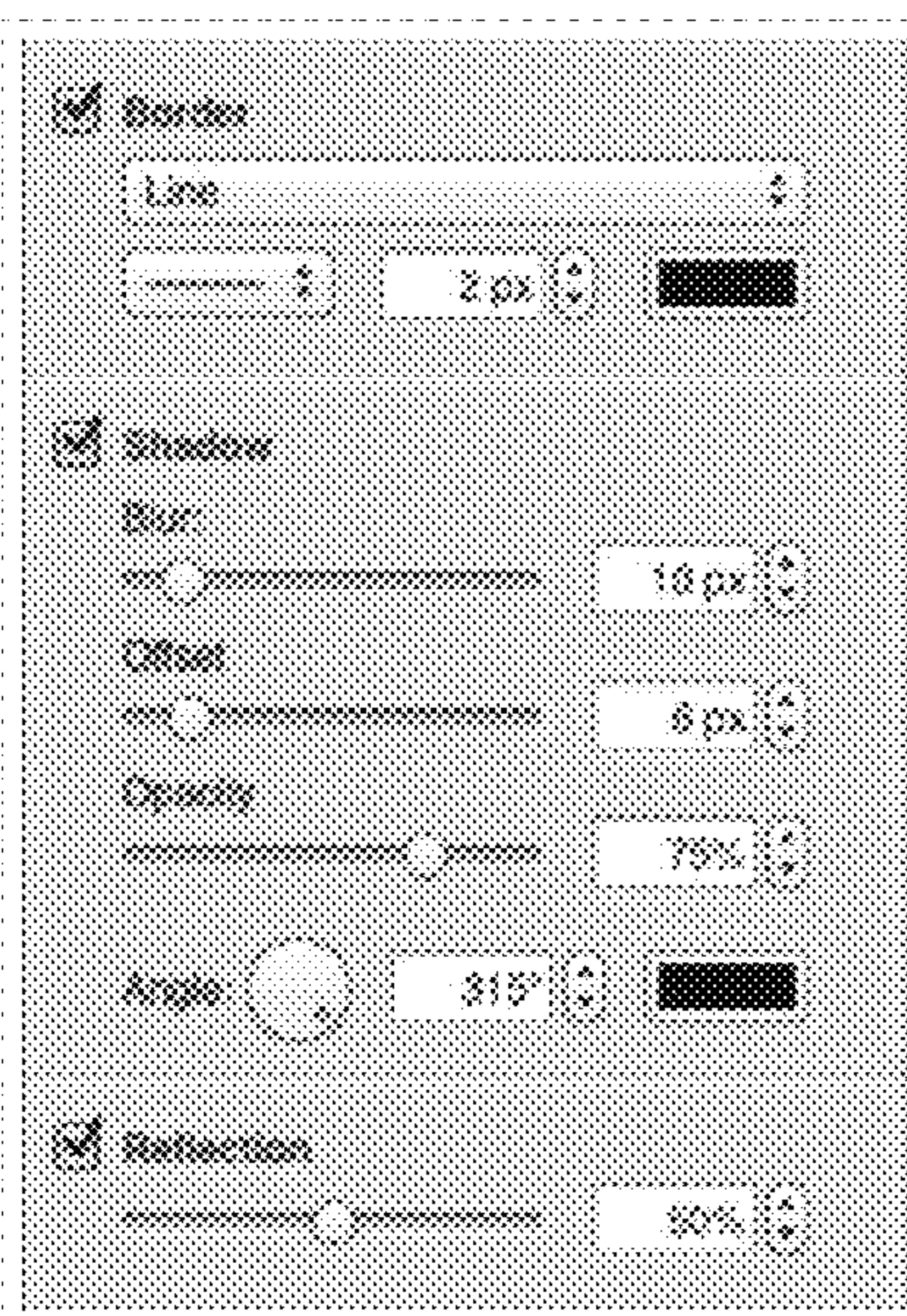
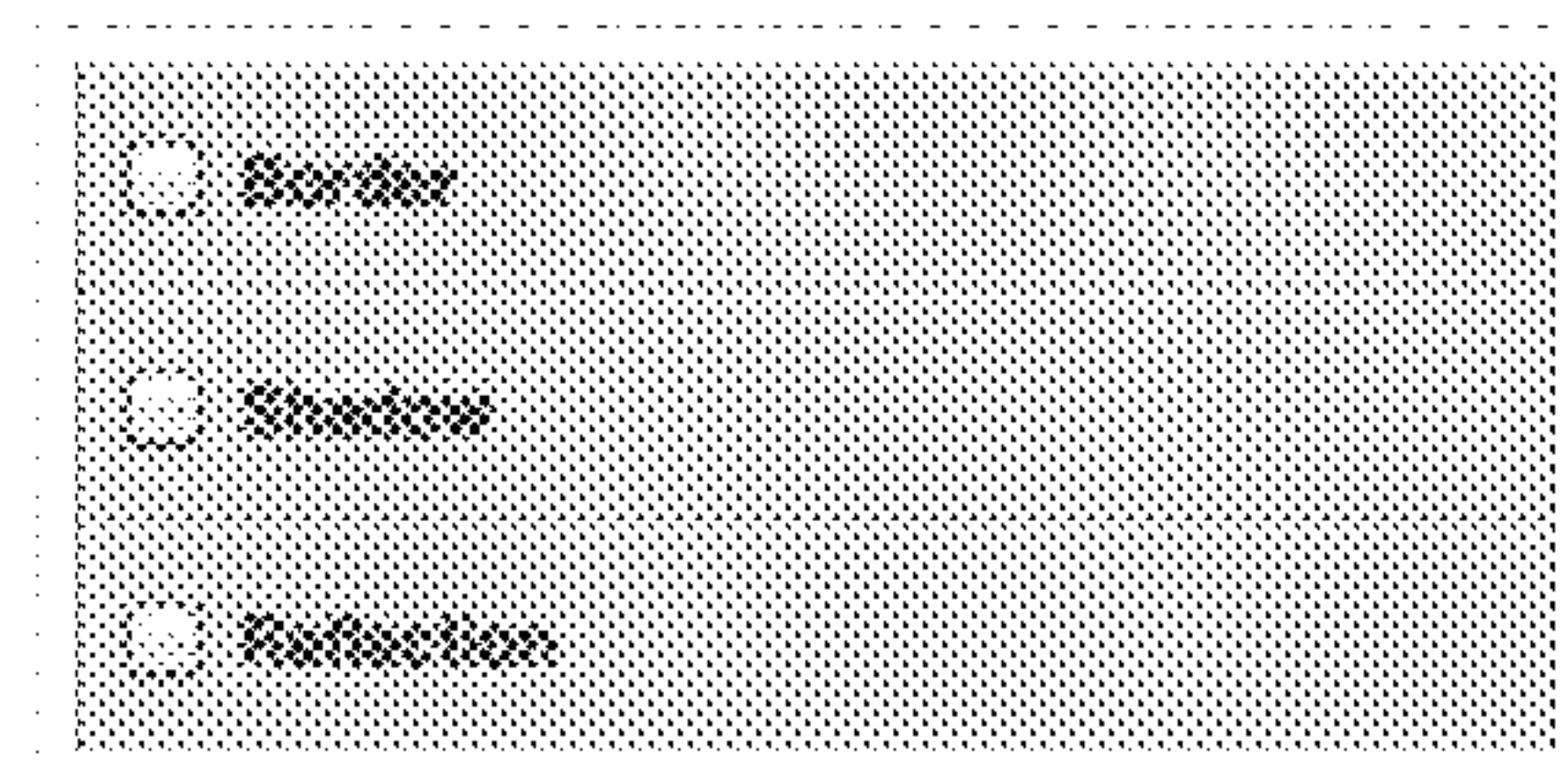
DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof
with animated graphical user interface showing a first image
in the sequence showing our new design; and,
FIG. 2 is a second image thereof.

The broken lines around the Figures show a display screen or
portion thereof, and form no part of the claimed design.

The appearance of the animated images sequentially transi-
tions between the images shown in FIGS. 1 and 2. The process
or period in which one image transitions to another forms no
part of the claimed design.

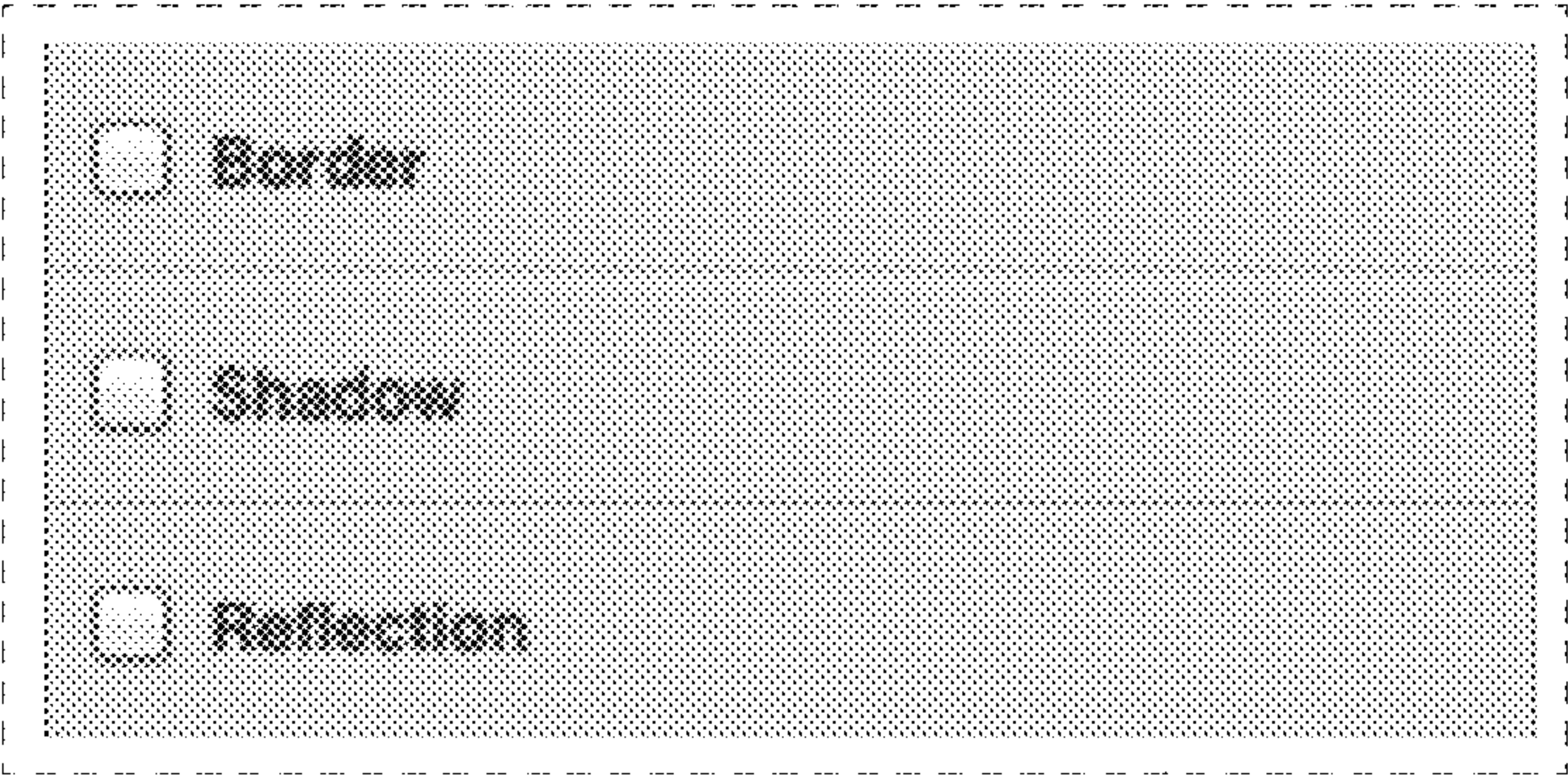

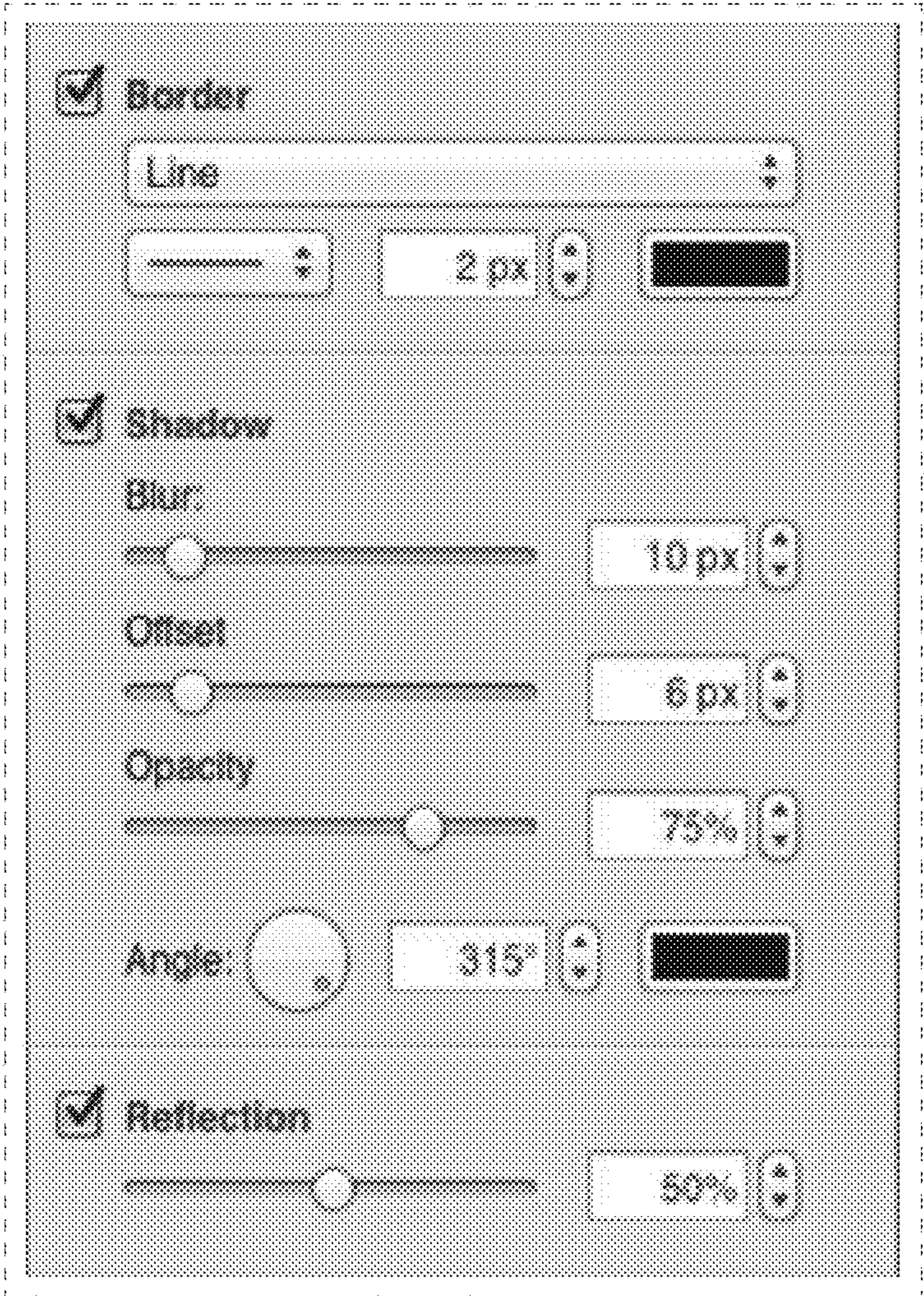
