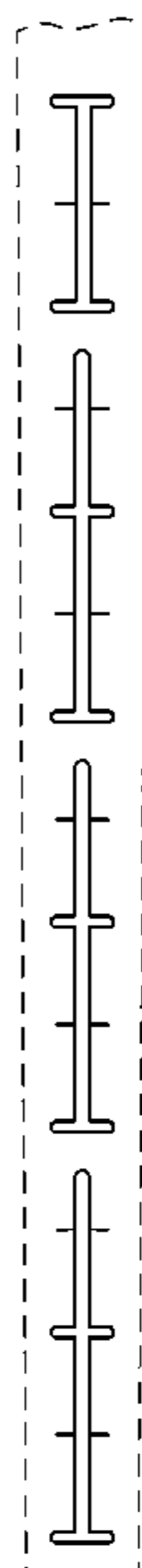
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a right perspective view of the golf club shaft; FIG. 2 is a left perspective view of the golf club shaft of FIG. 1; FIG. 3 is a front view of the golf club shaft of FIG. 1; FIG. 4 is a rear view of the golf club shaft of FIG. 1; FIG. 5 is a right side view of the golf club shaft of FIG. 1; and, FIG. 6 is a left side view of the golf club shaft of FIG. 1. The broken lines shown in one or more of the figures are for illustrative purposes only and form no part of the claimed design.

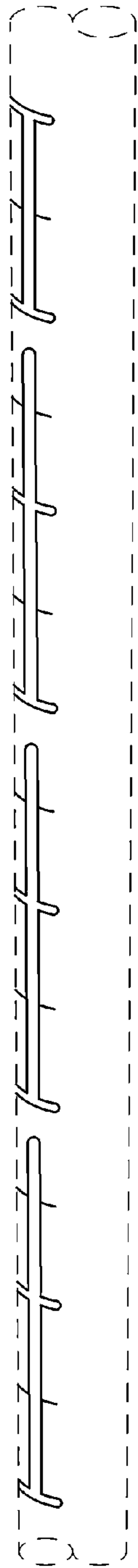

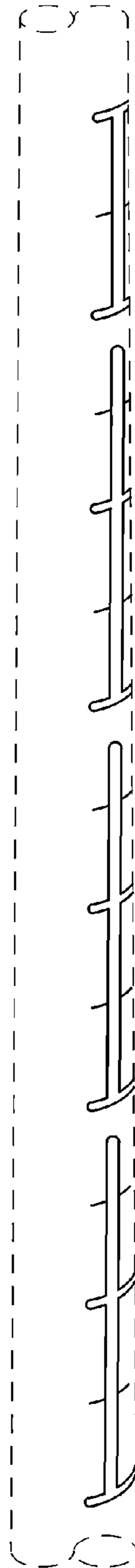

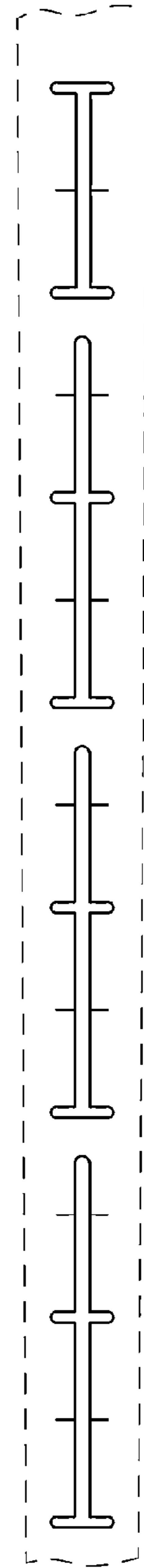

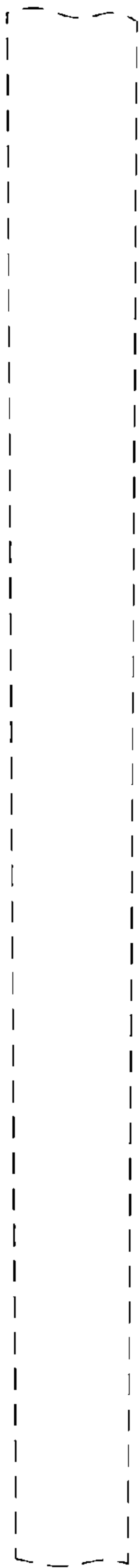

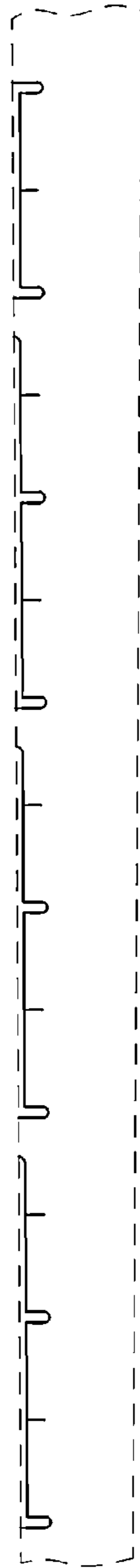

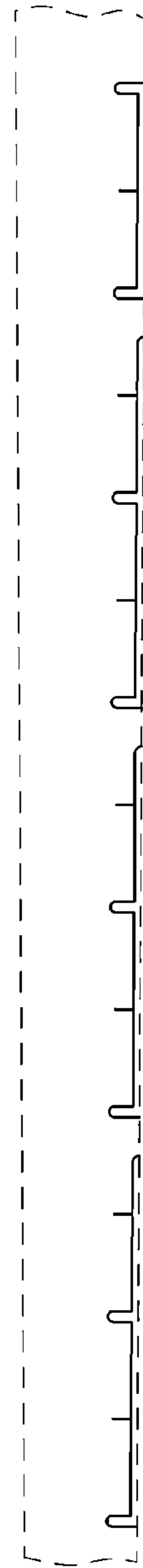
