DESCRIPTION

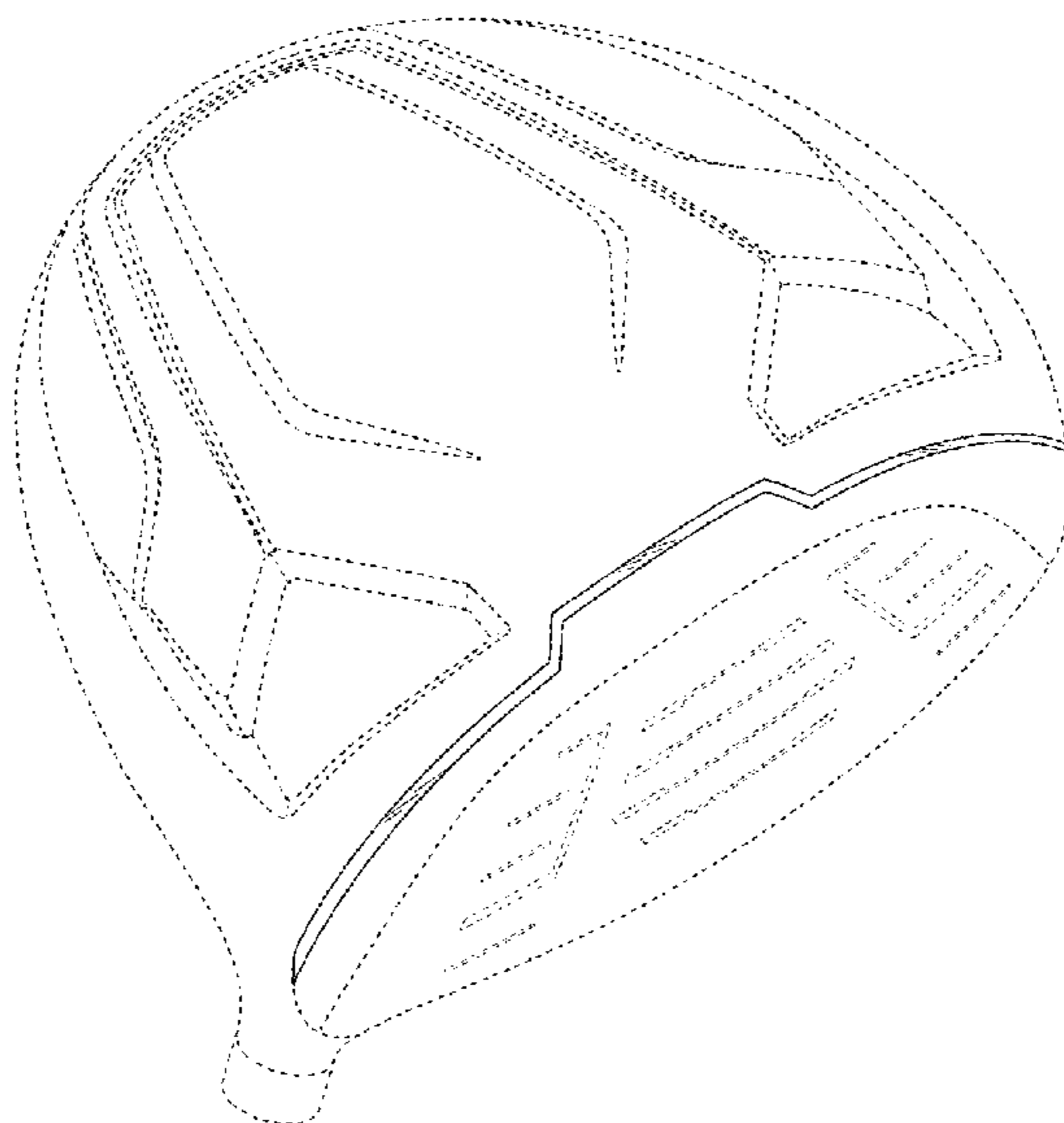
FIG. 1 is a bottom, perspective view embodying the inventive design;

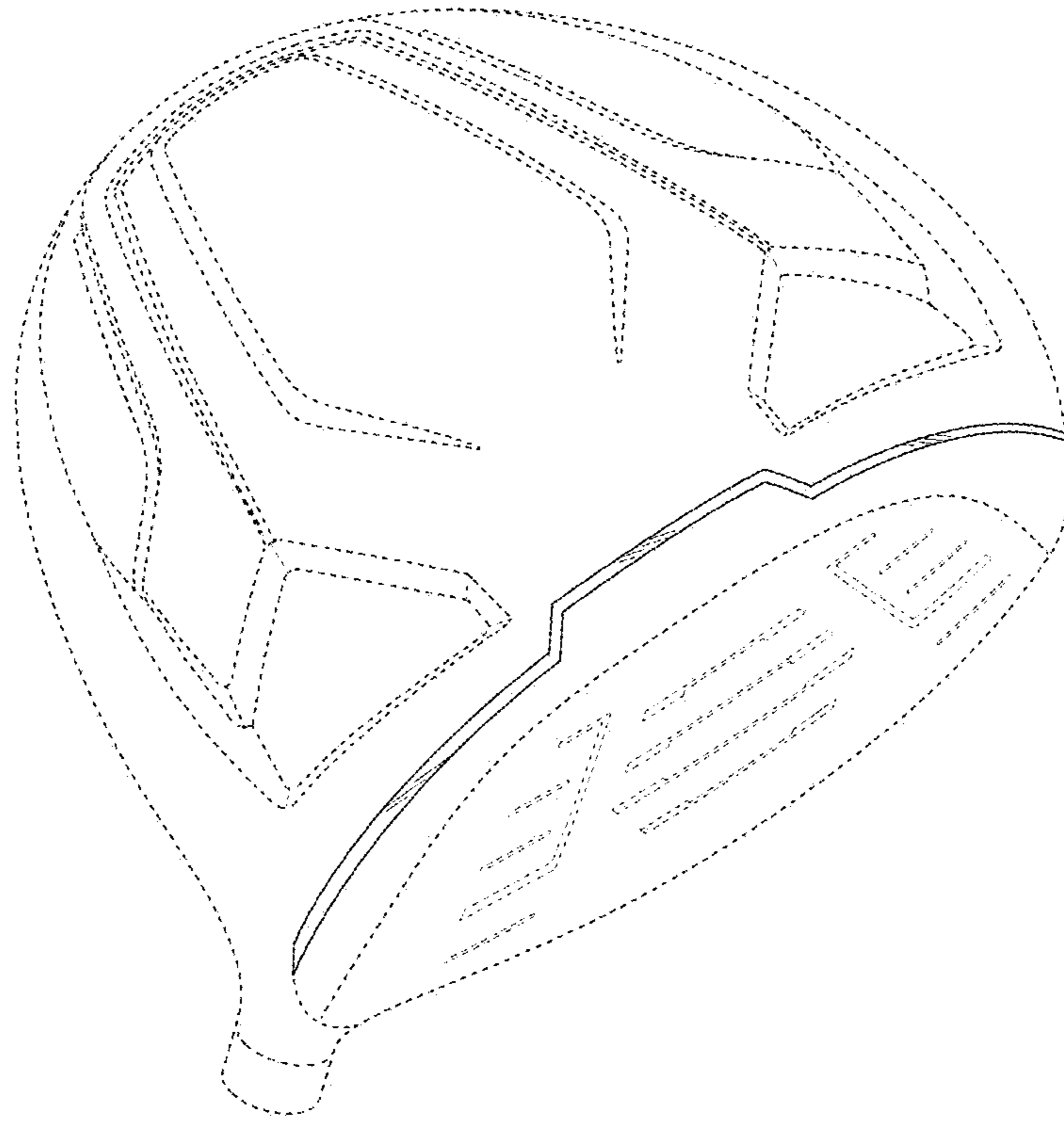

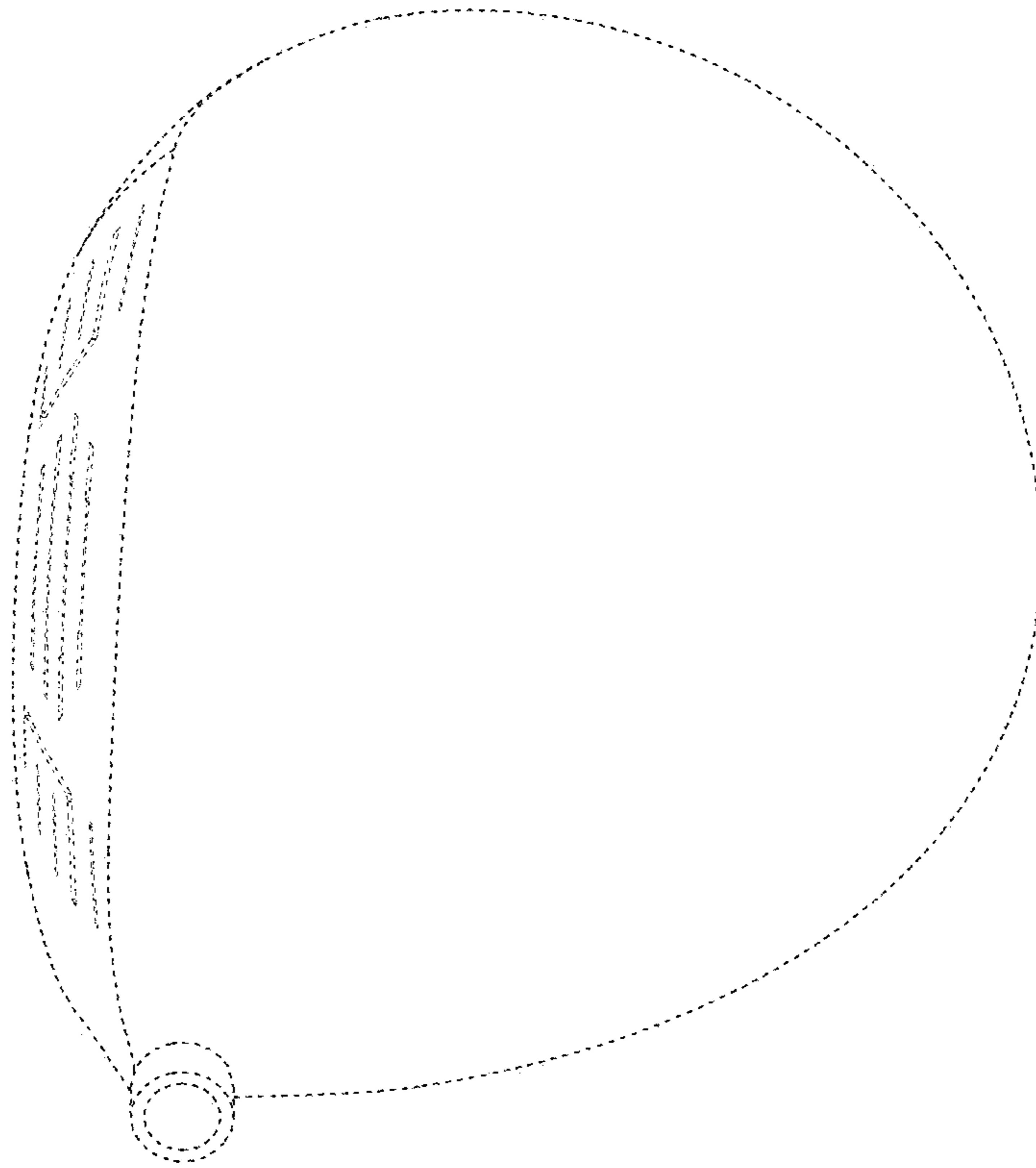

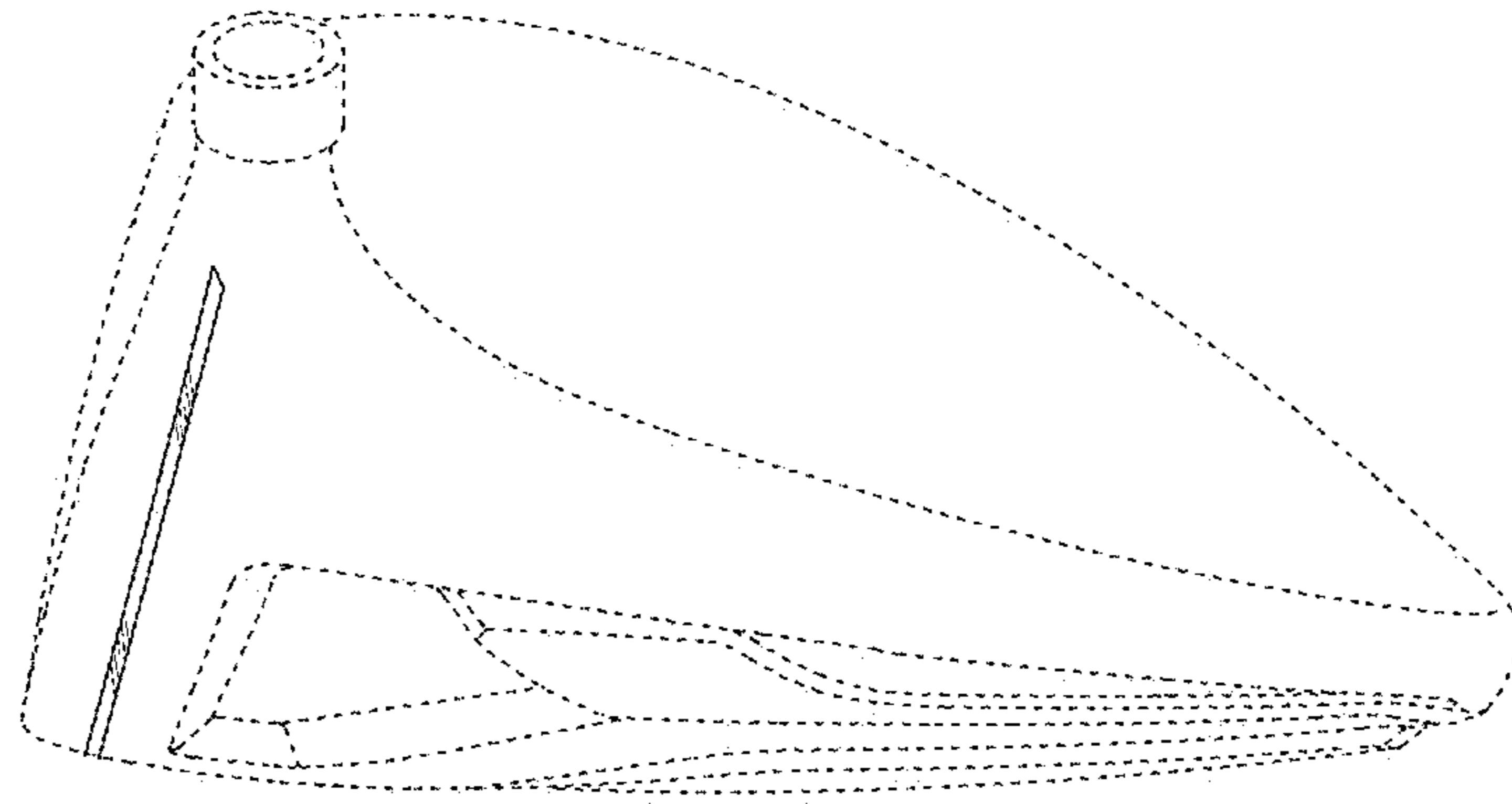

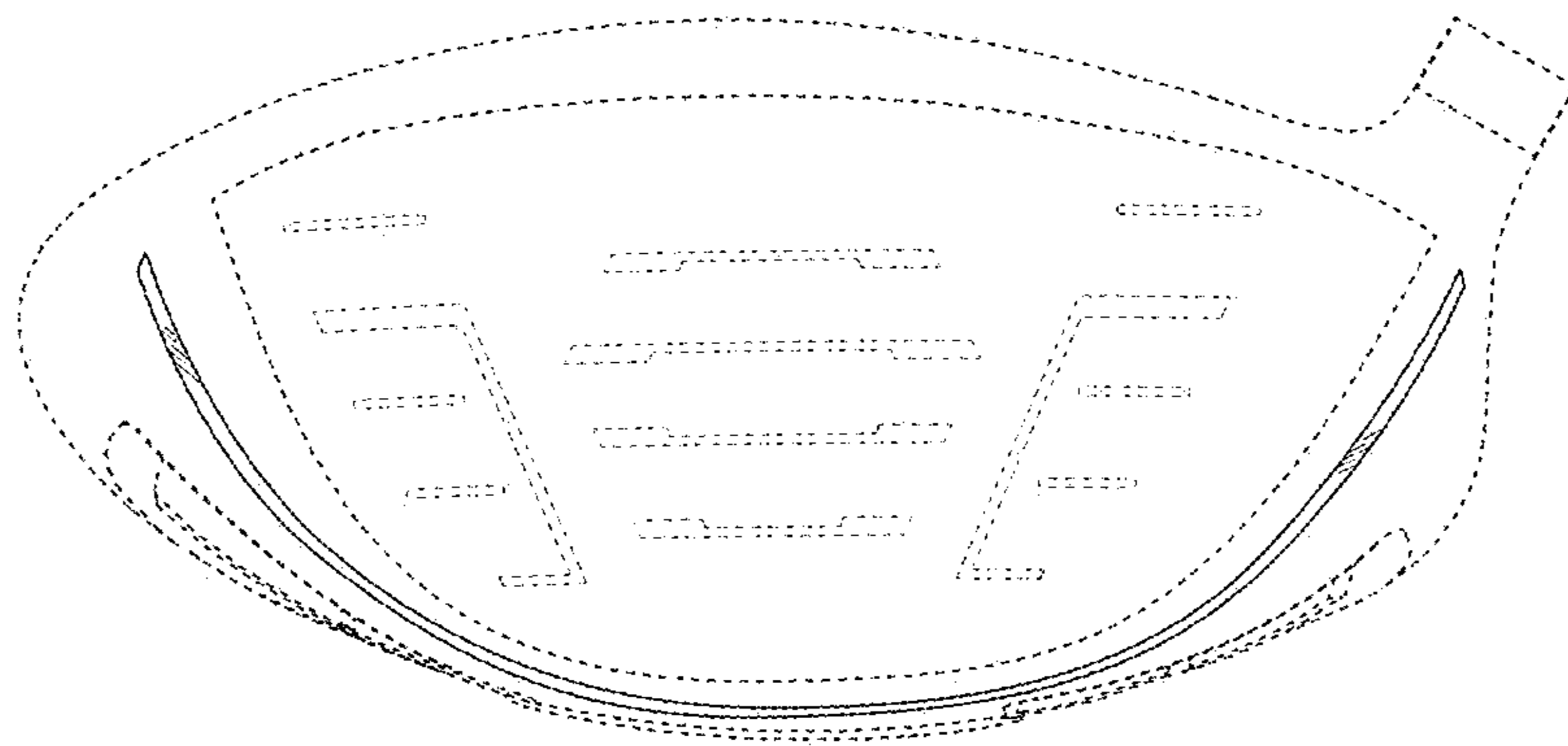

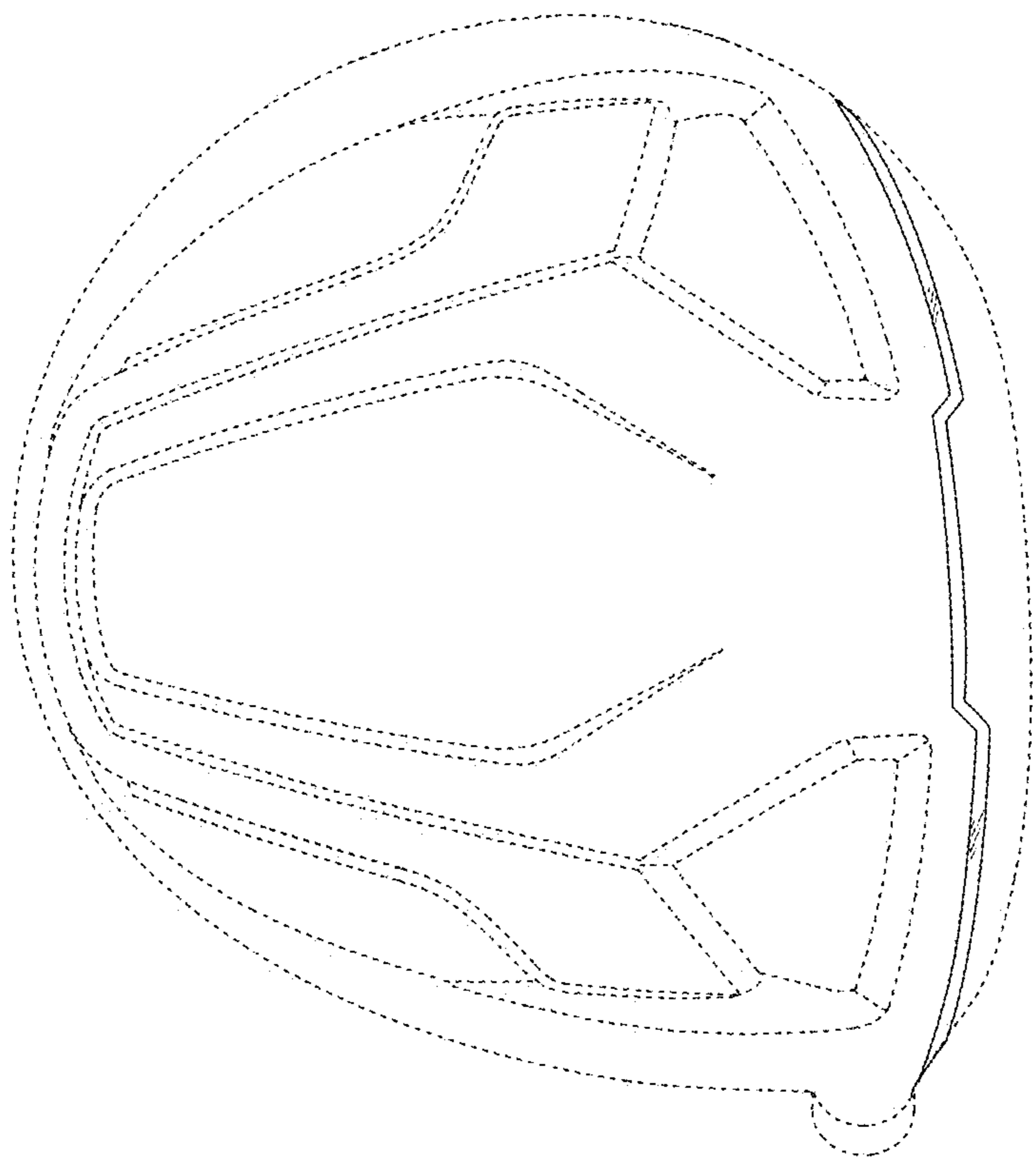

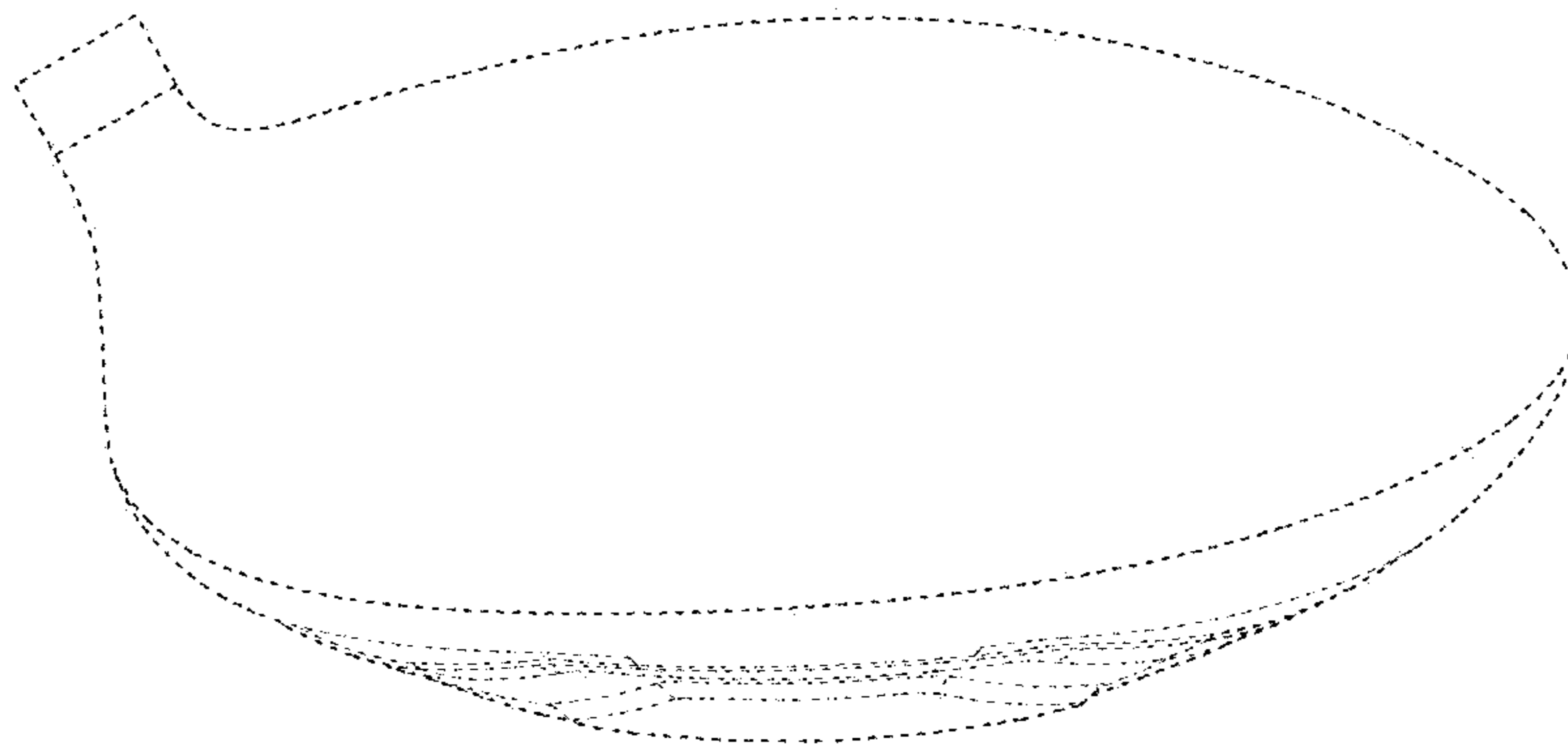
