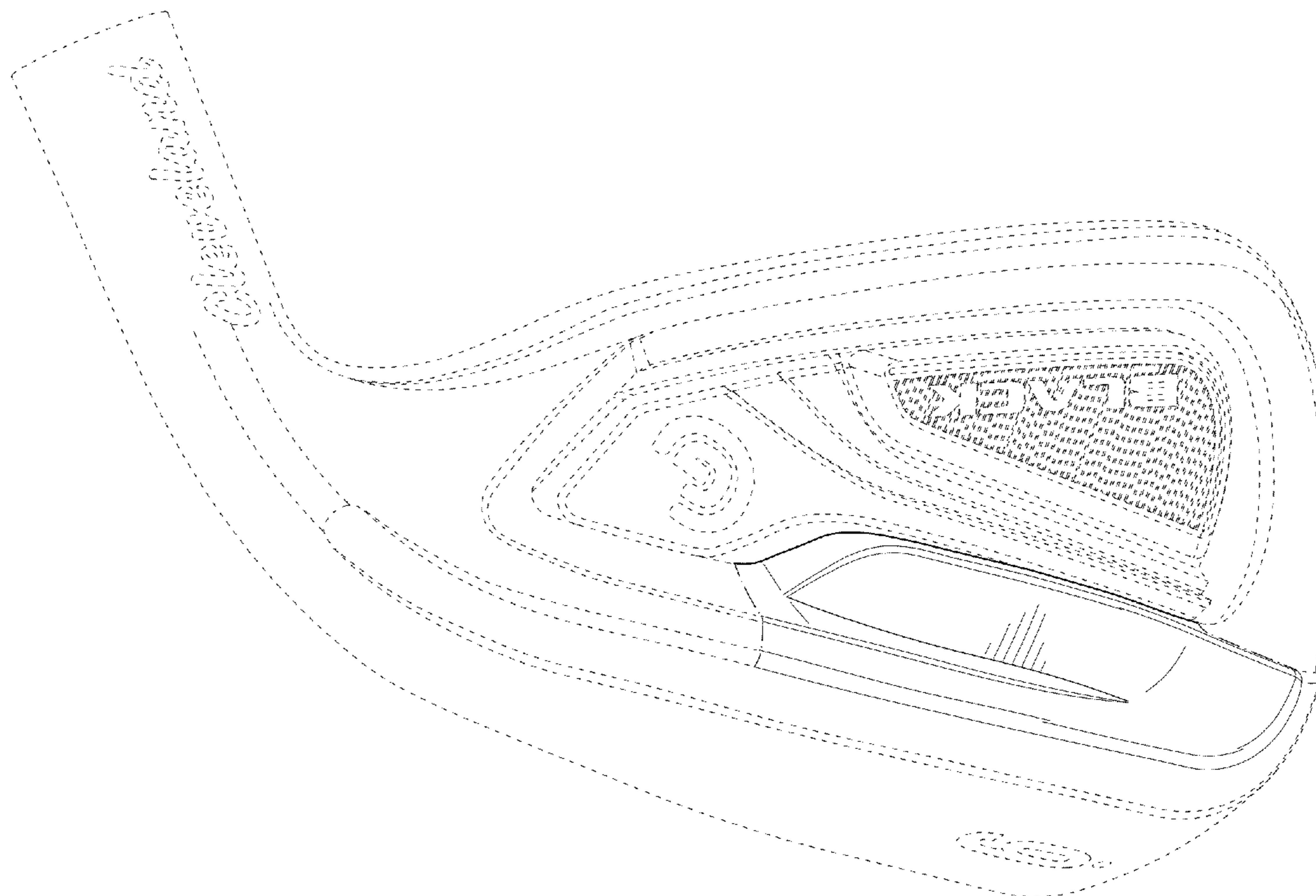
(57) **CLAIM**

The ornamental design for a golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear elevational view of the golf club head;  
FIG. 2 is a toe-side elevational view thereof;  
FIG. 3 is a heel-side elevational view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a rear, toe-side, top perspective view thereof;  
FIG. 6 is a rear, heel-side, top perspective view thereof;  
FIG. 7 is a rear, bottom perspective view thereof; and,  
FIG. 8 is a rear, toe-side, bottom perspective view thereof.  
The dot-dash chain lines immediately adjacent the shaded surfaces represent a boundary of the claimed subject matter and the broken lines depict environmental subject matter. The dot-dash chain lines and the broken lines form no part of the claimed design.

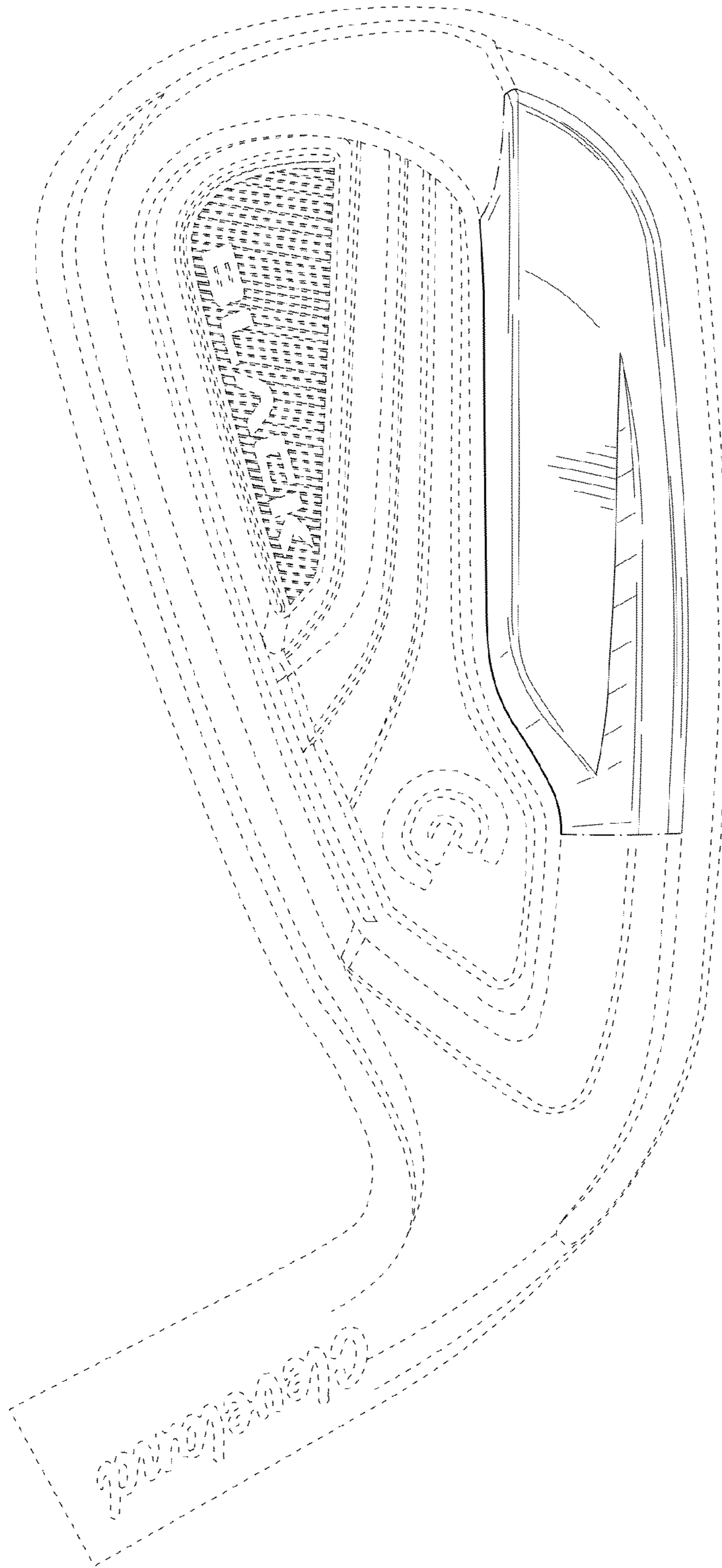

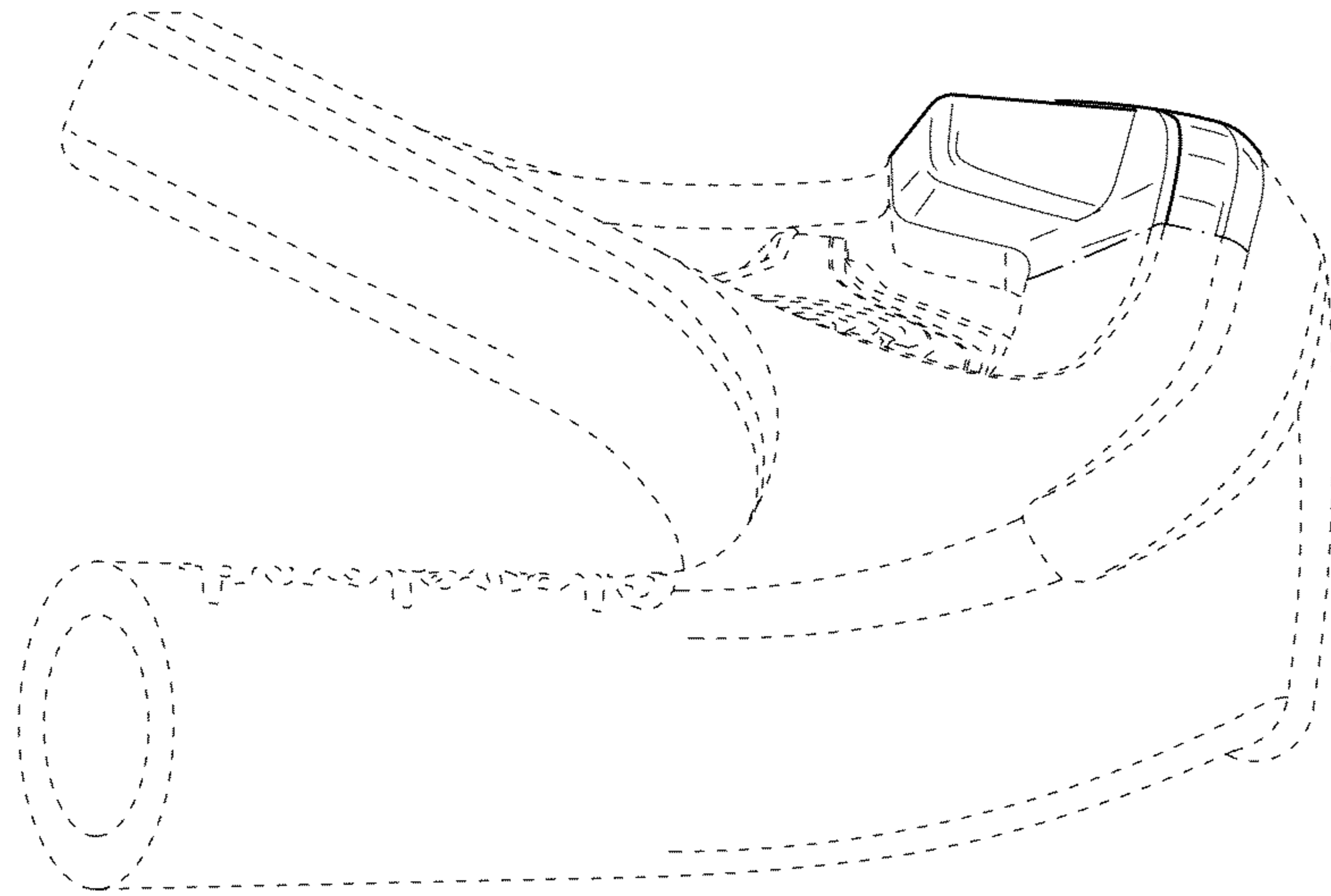

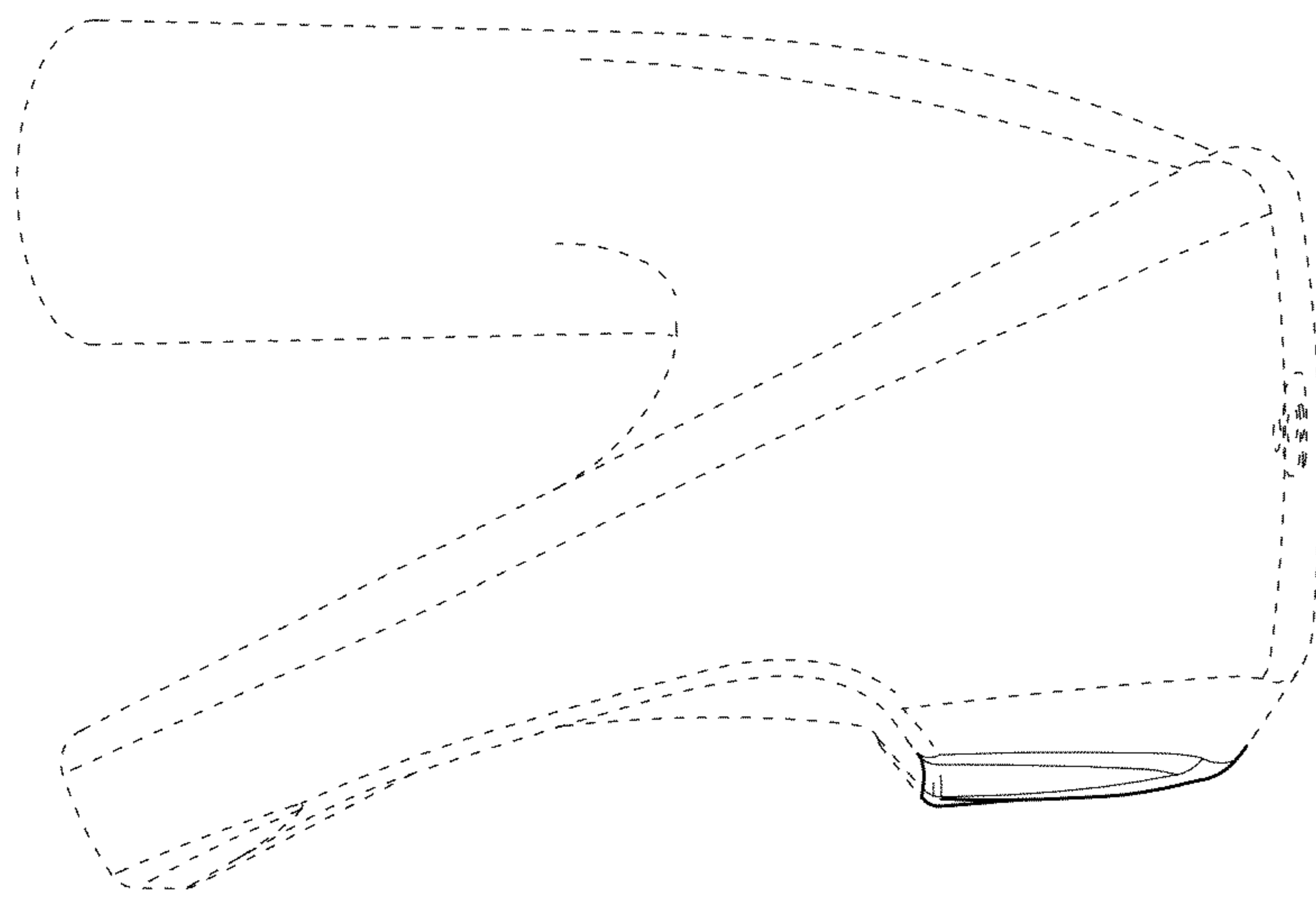

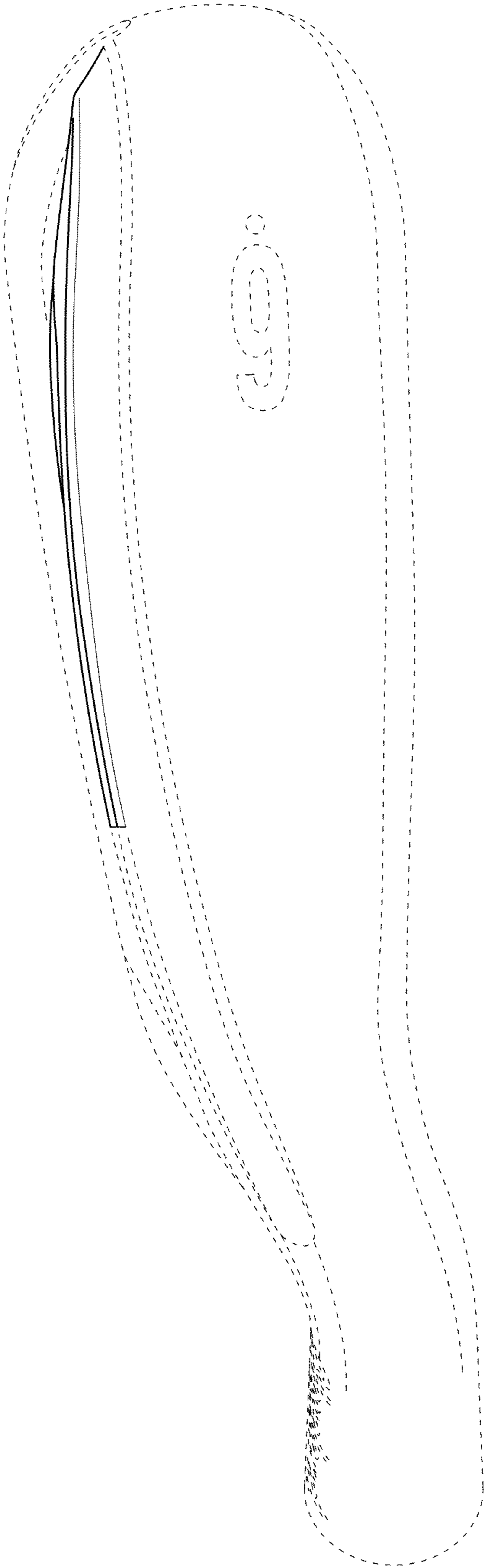

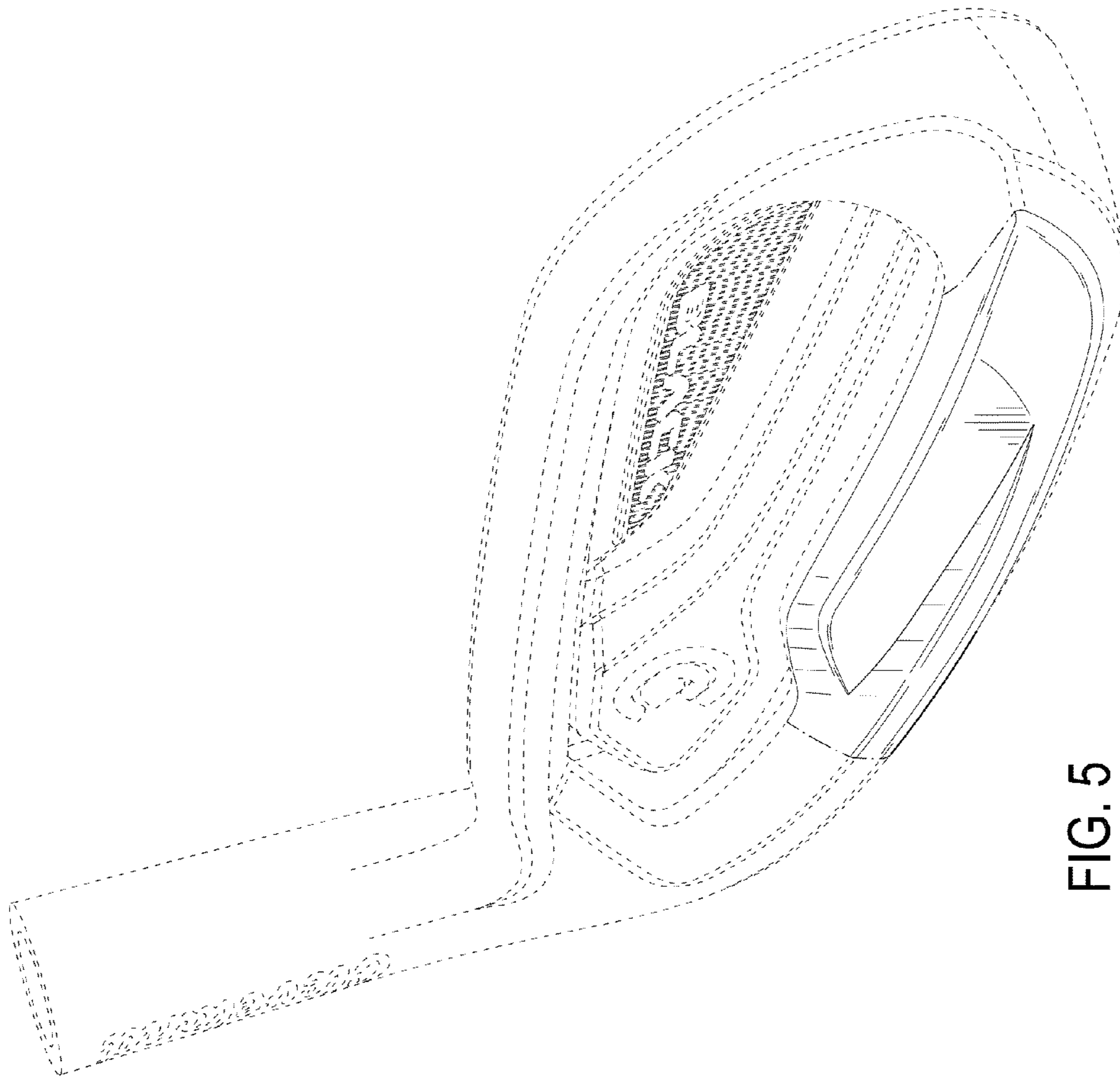

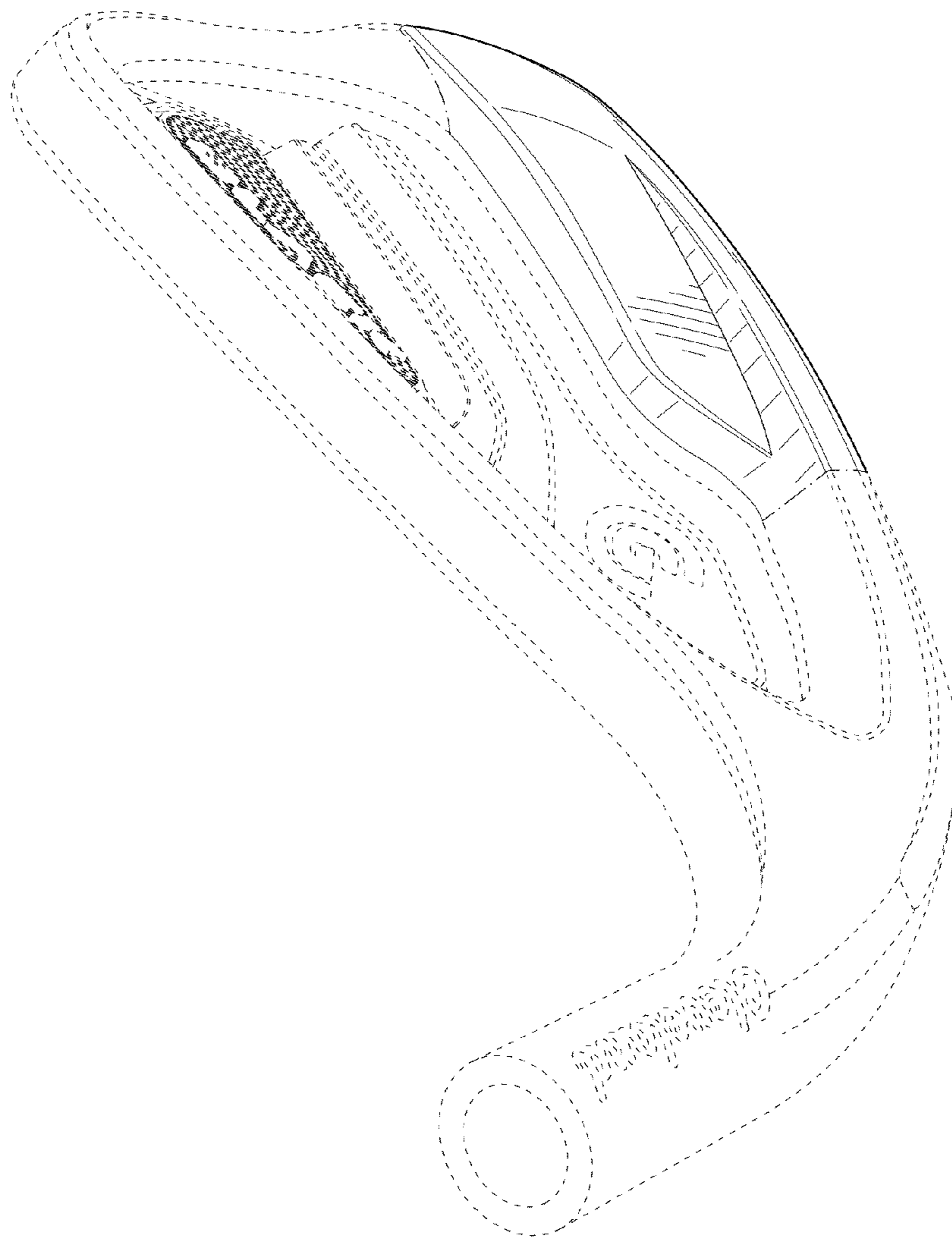

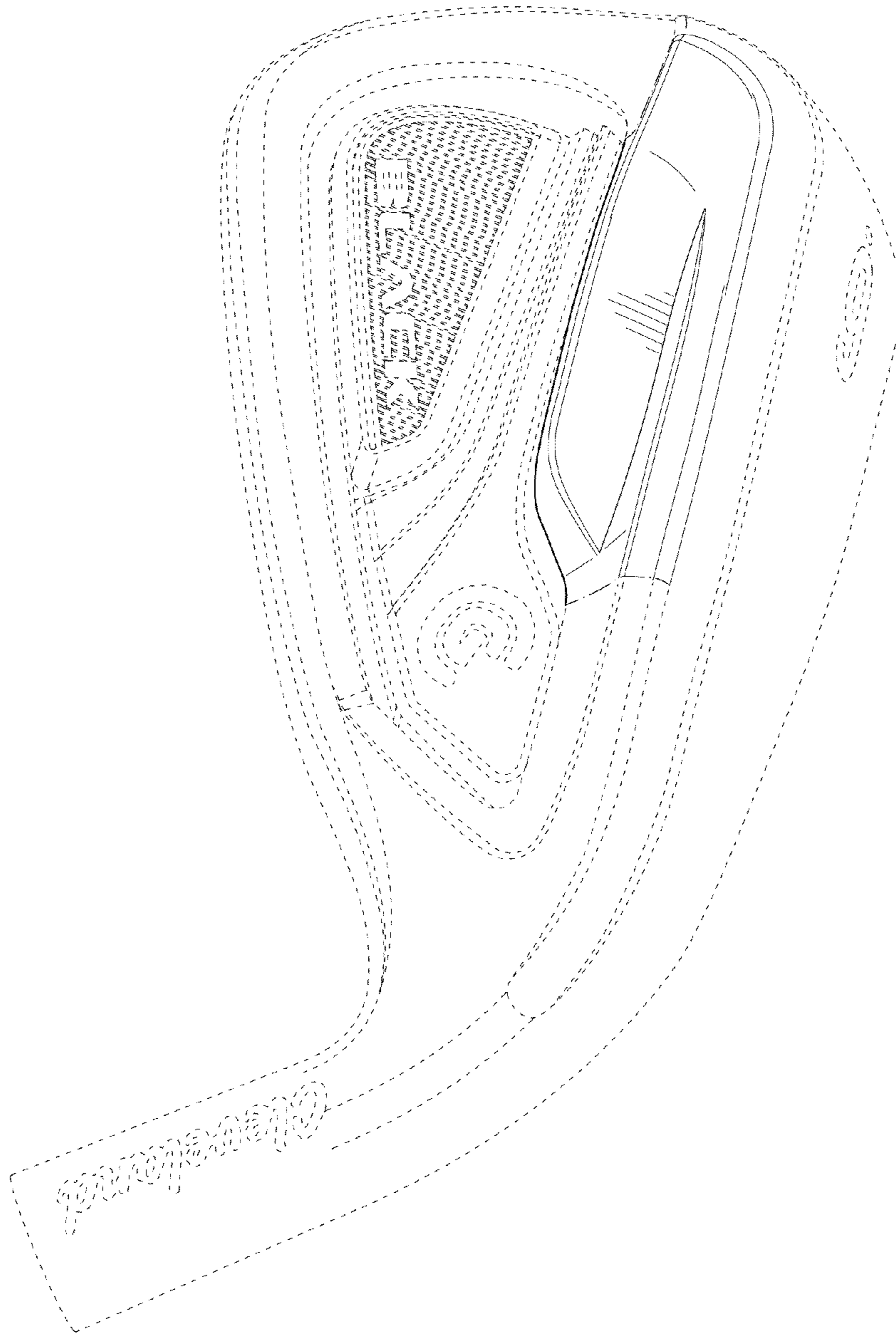

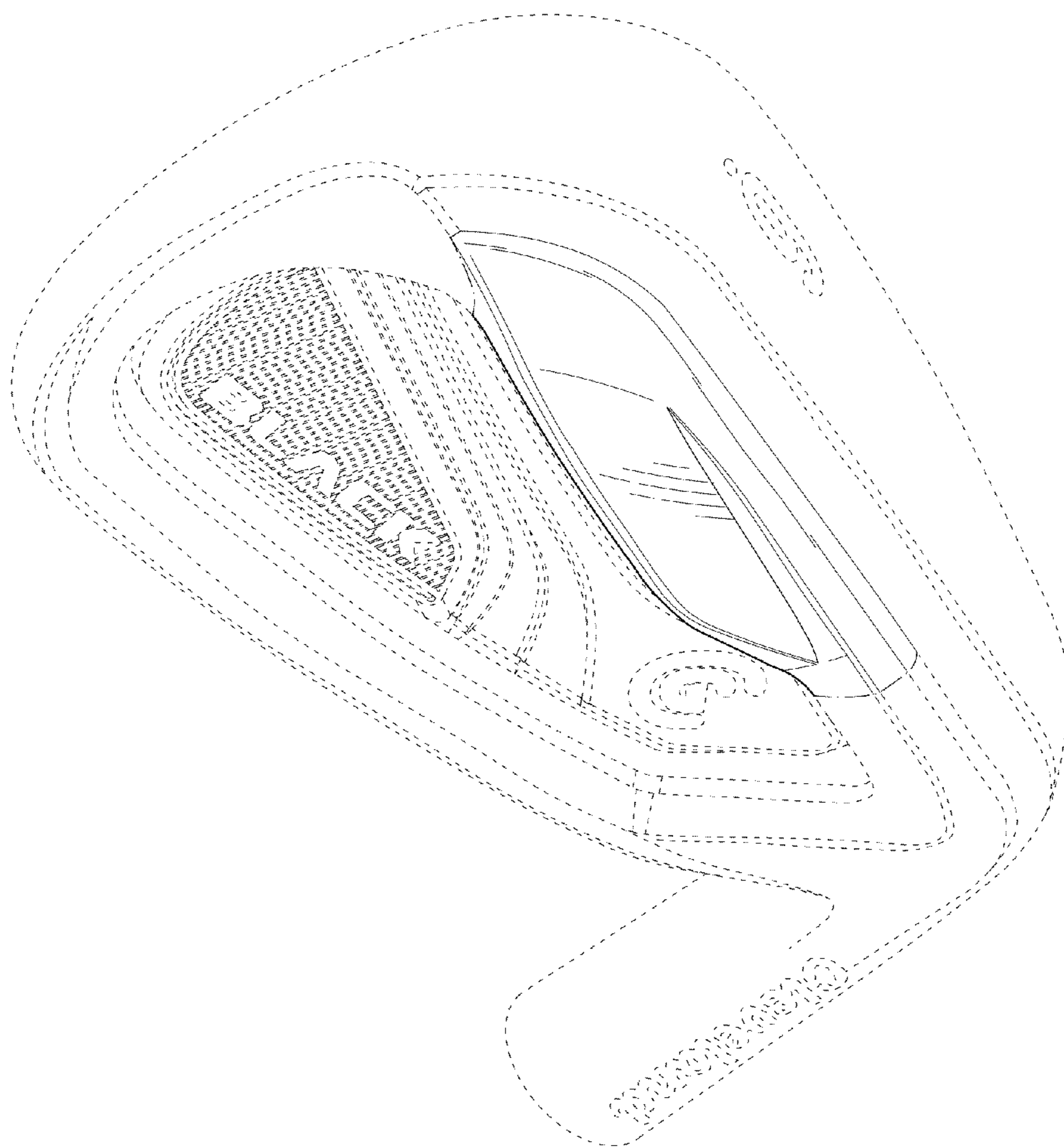
