FIG. 7 illustrates a bottom view of the dermatological device of FIG. 1.

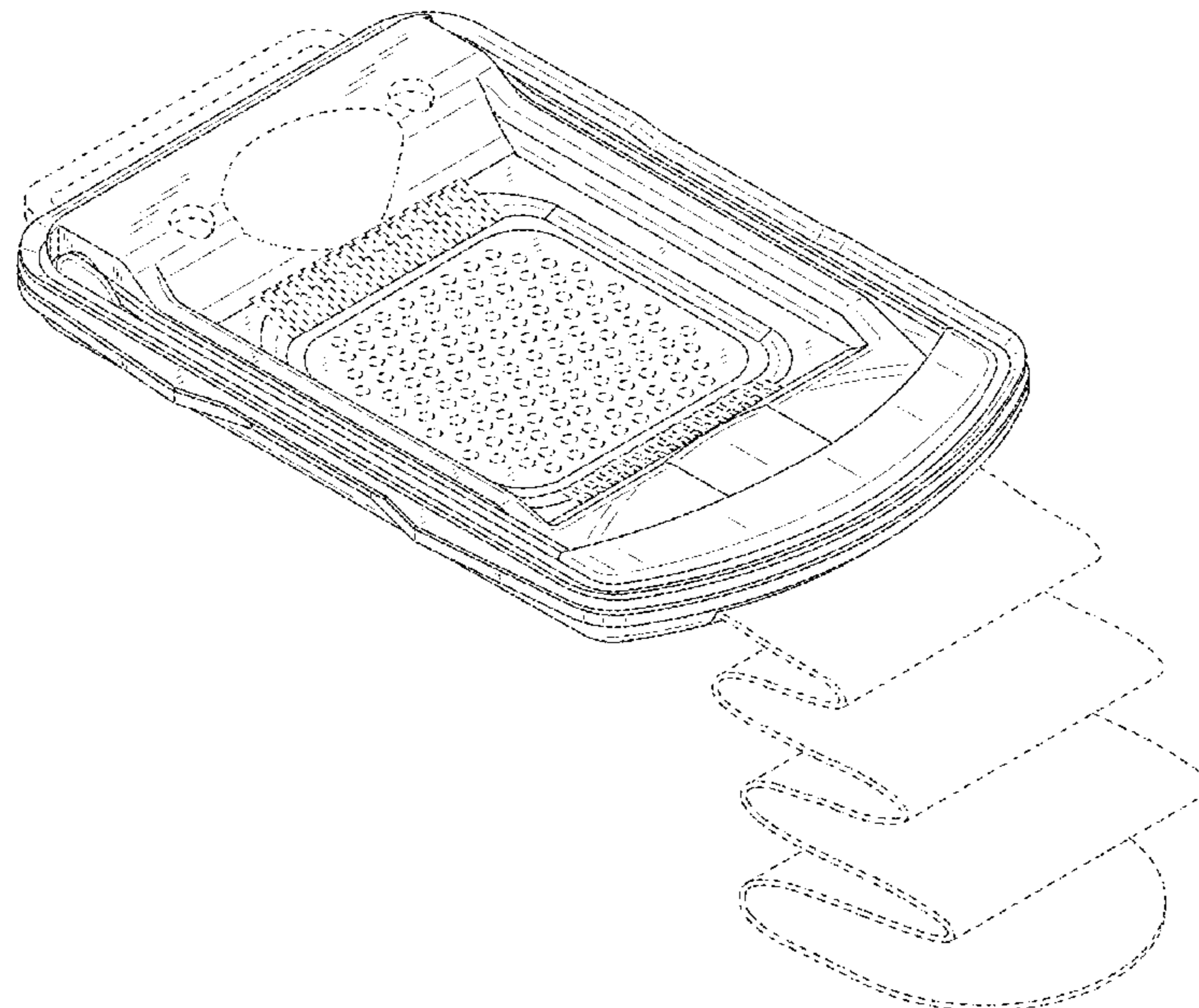

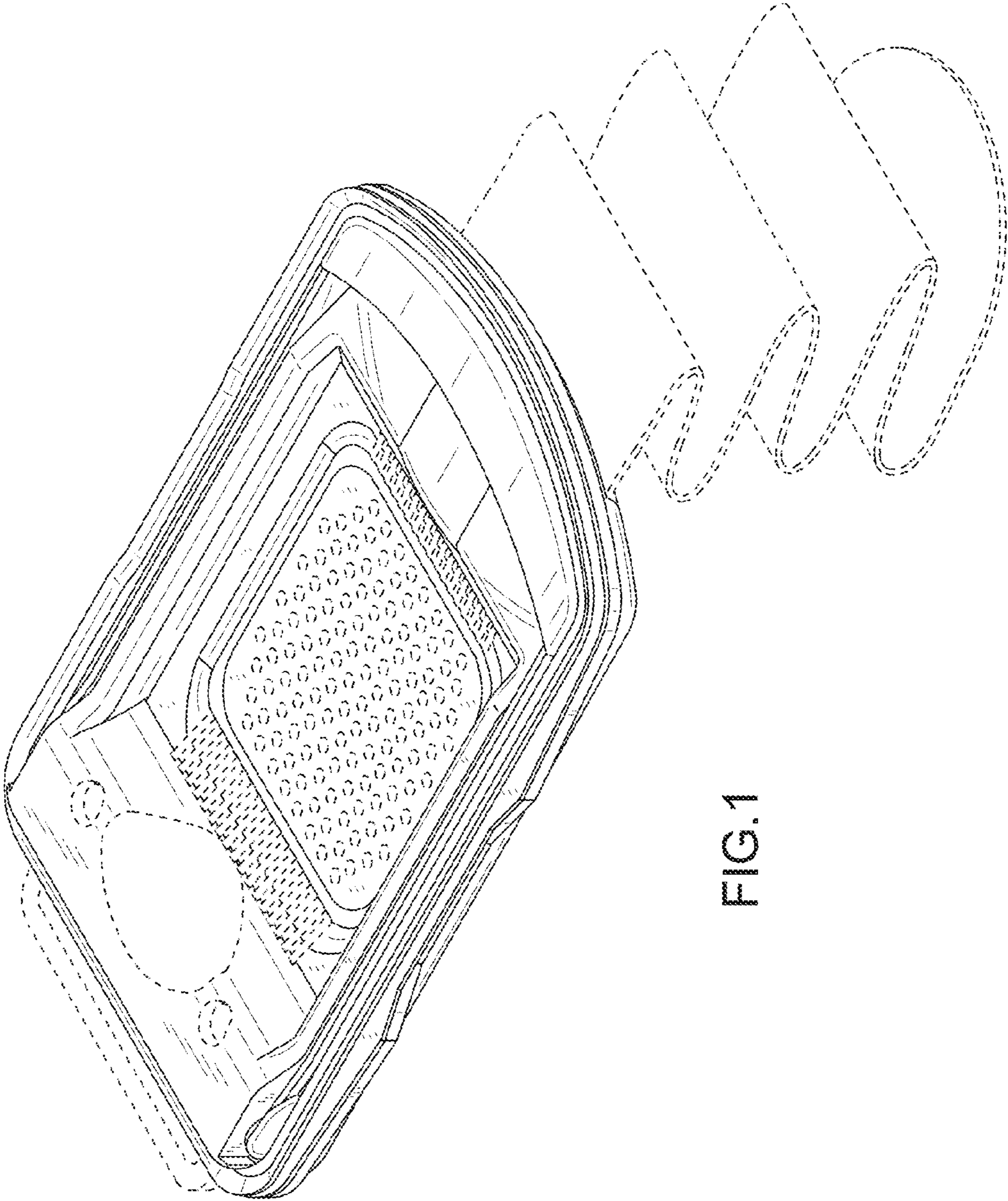

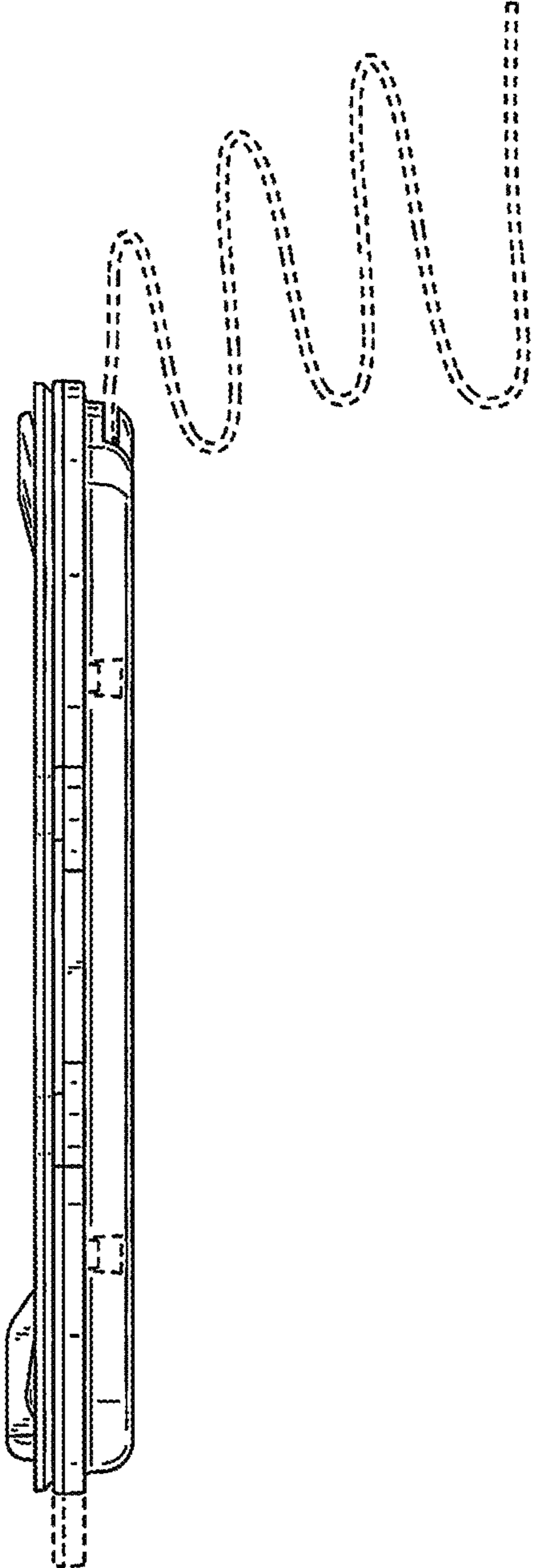

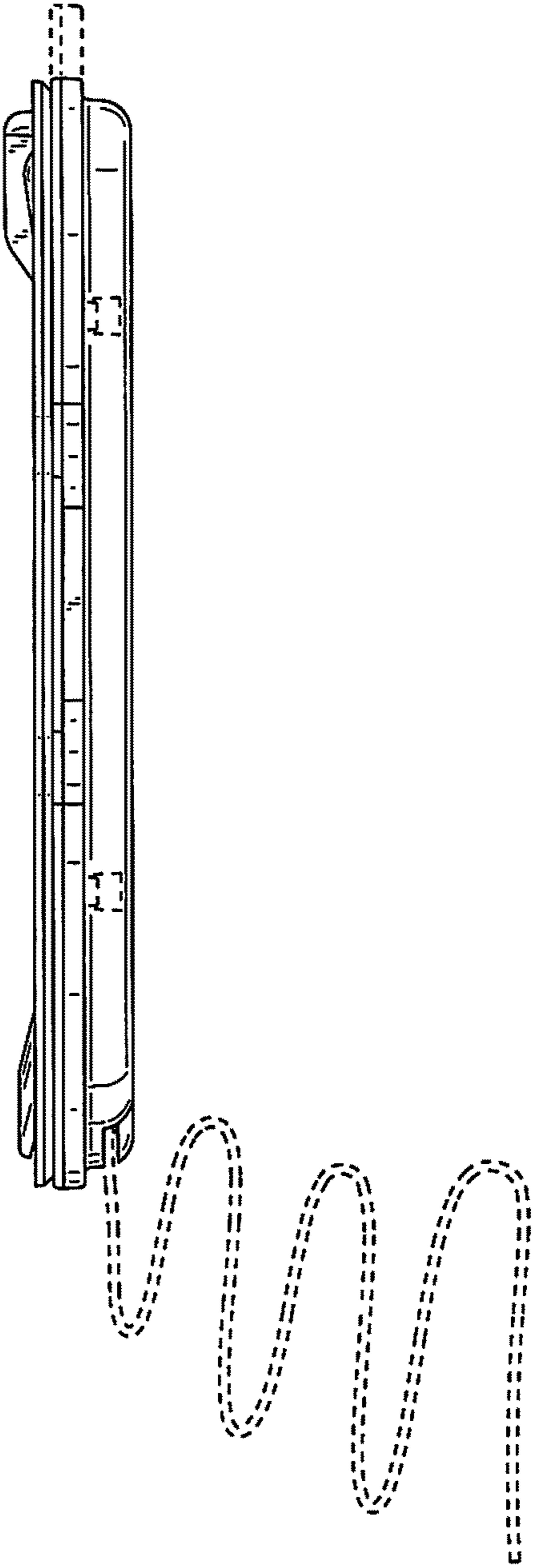

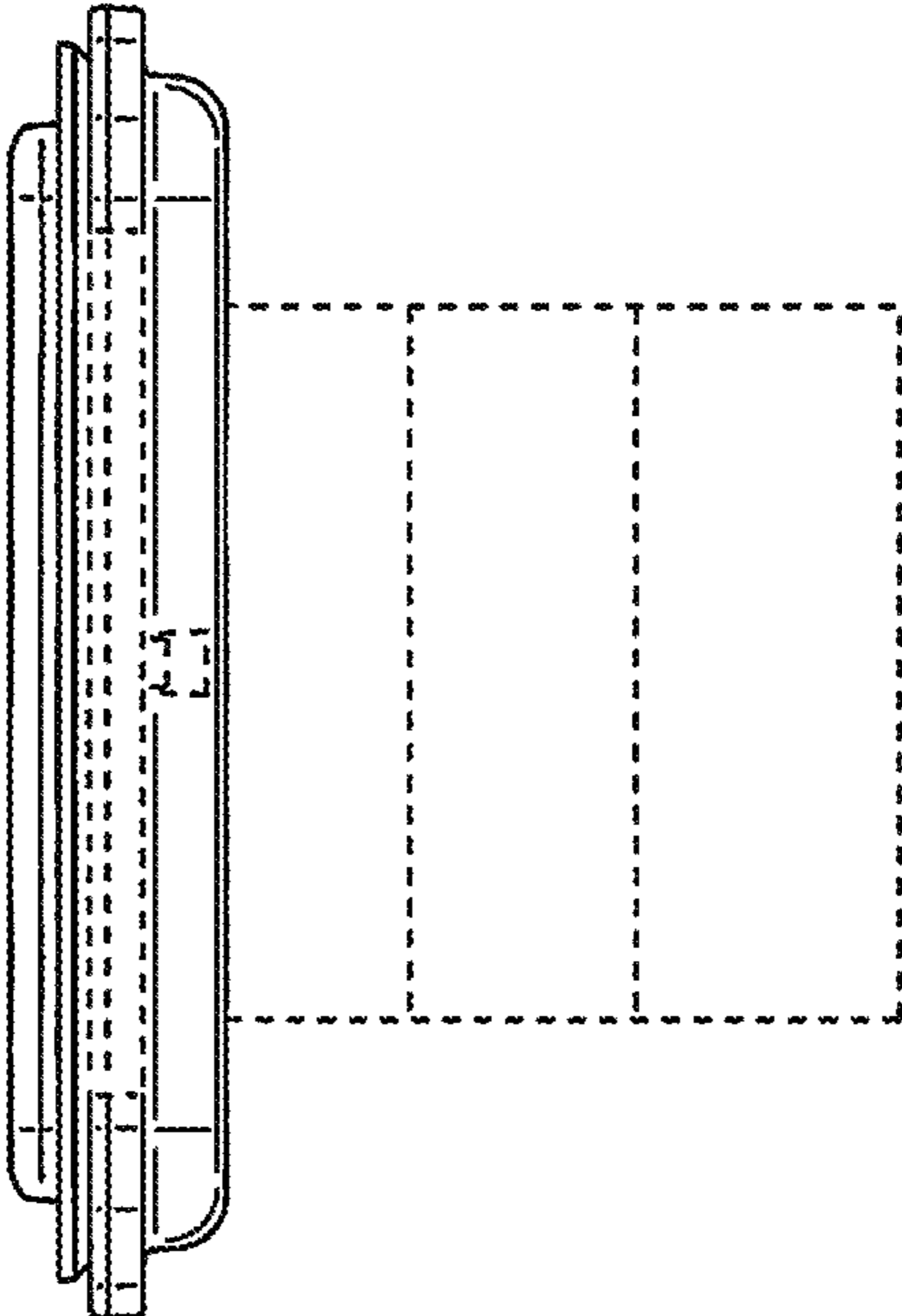

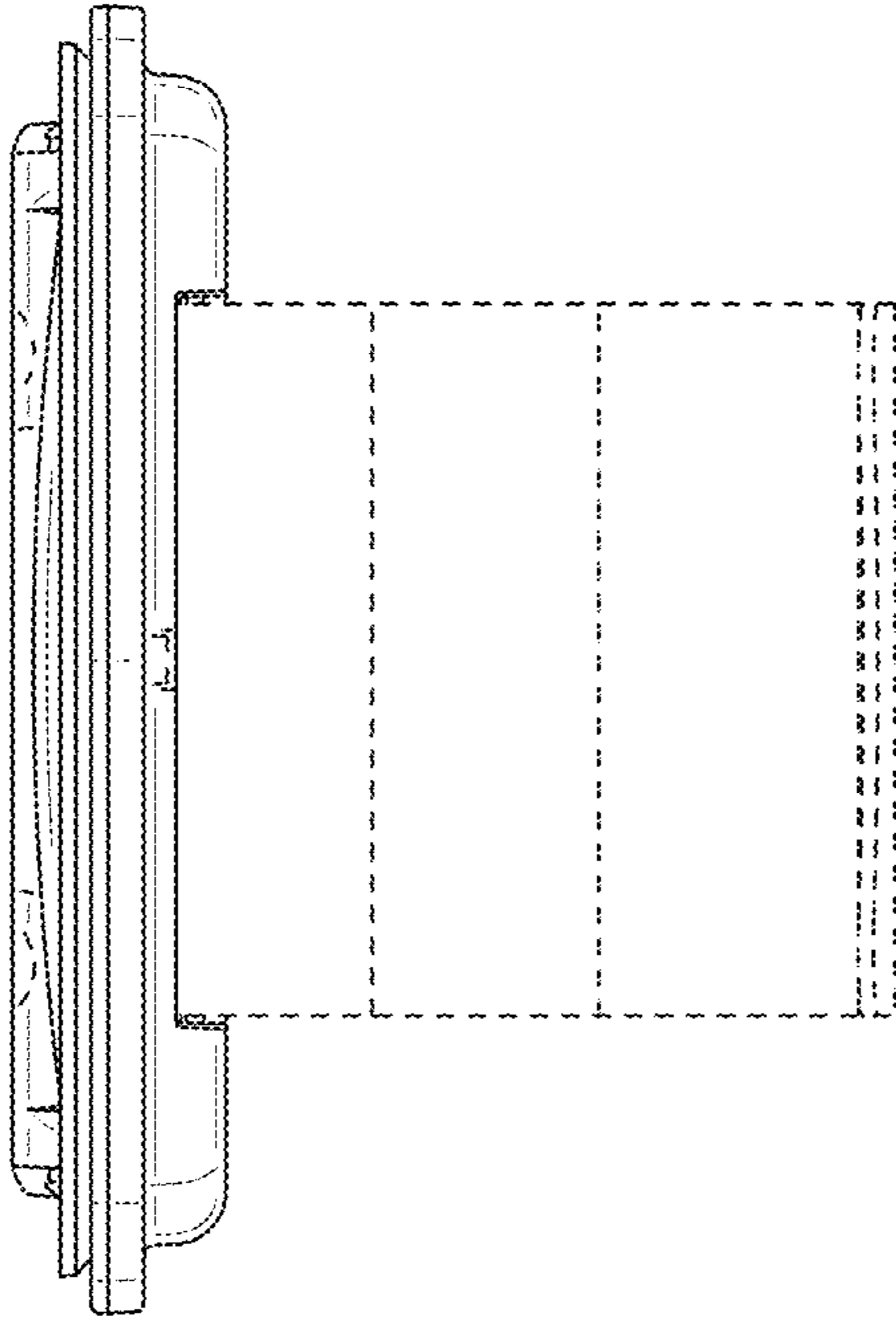

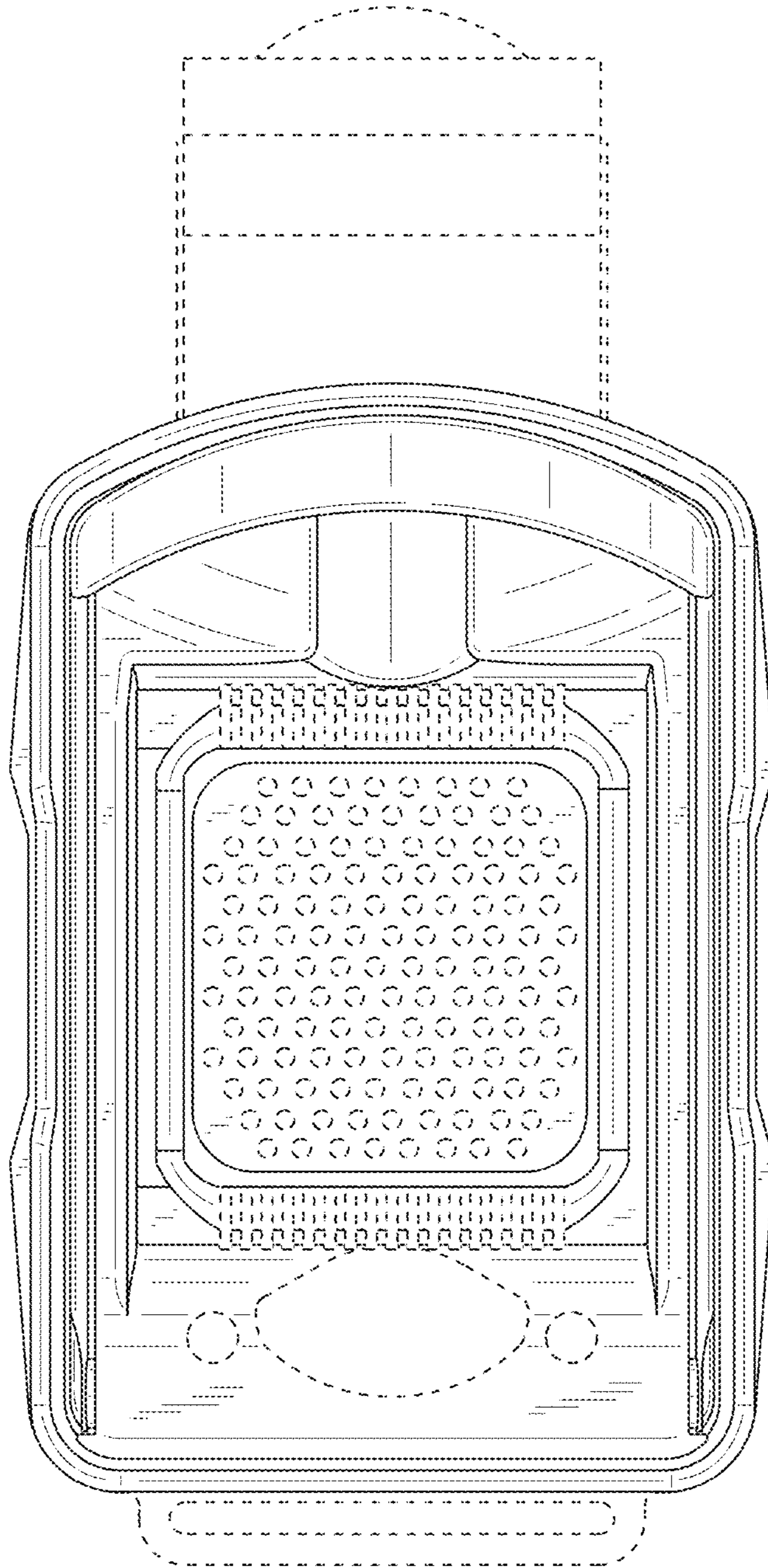

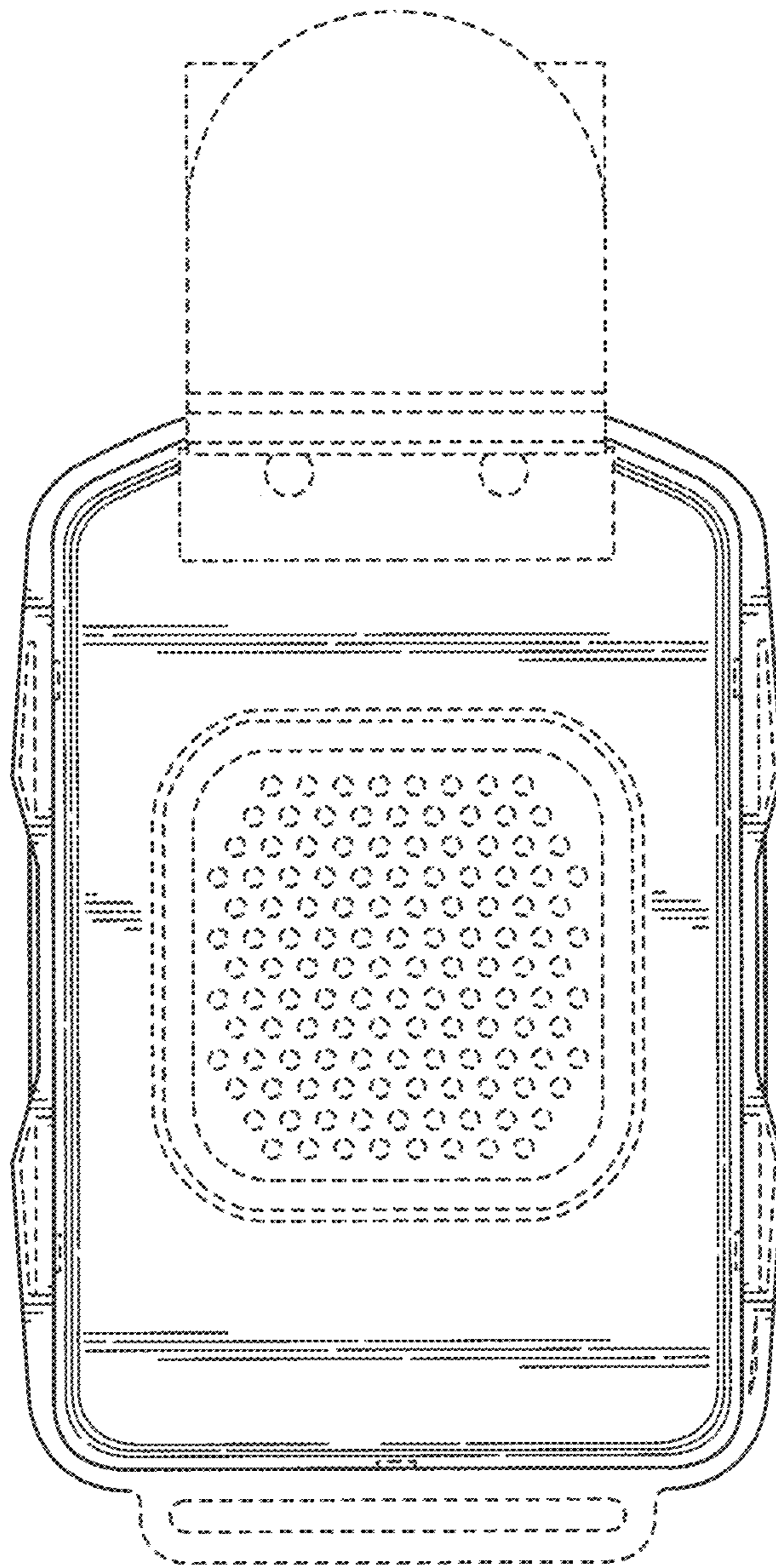
