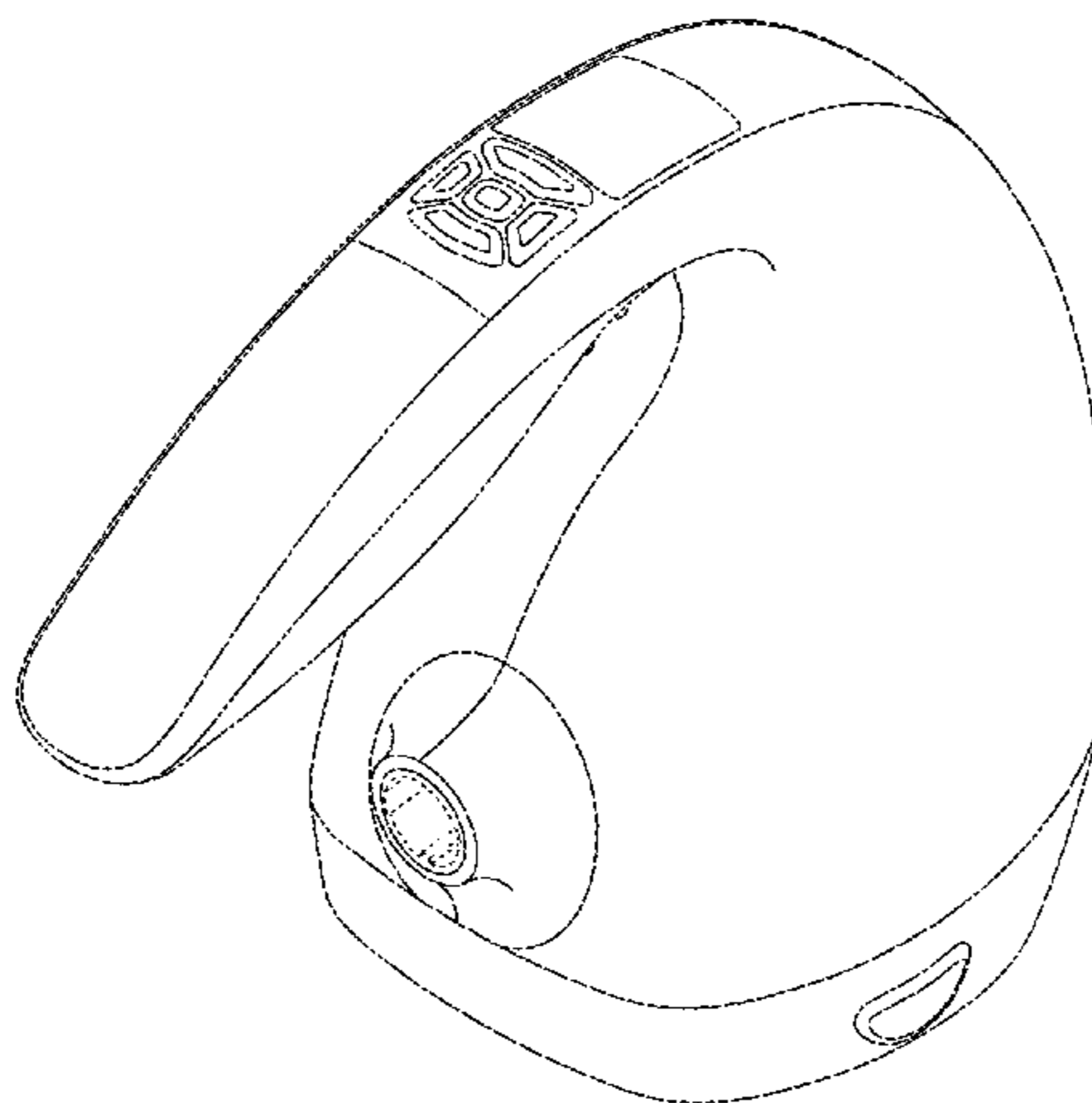

The broken lines showing of the recessed detailing is included for the purpose of illustrating portions of the article and forms no part of the claimed design.

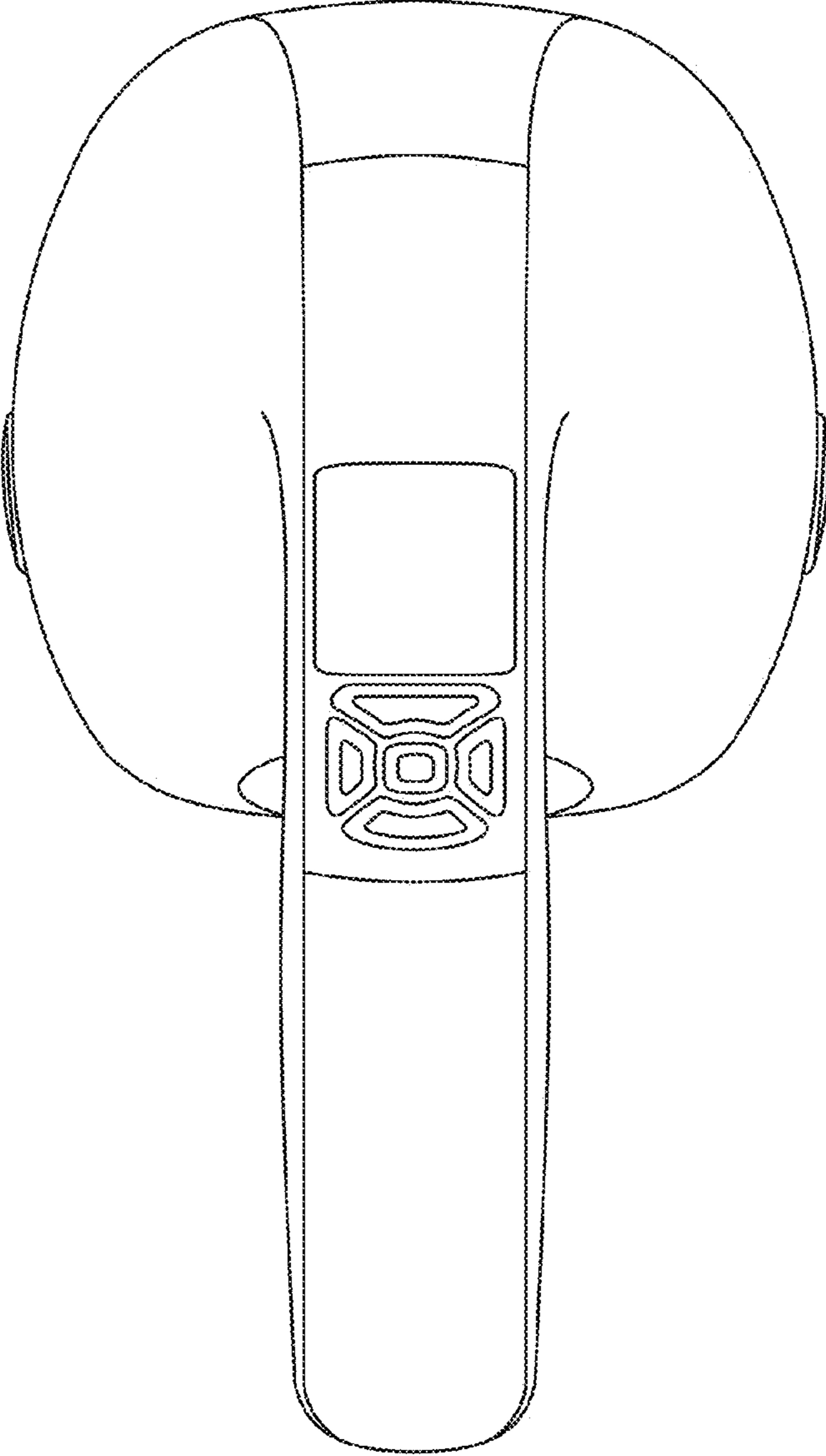

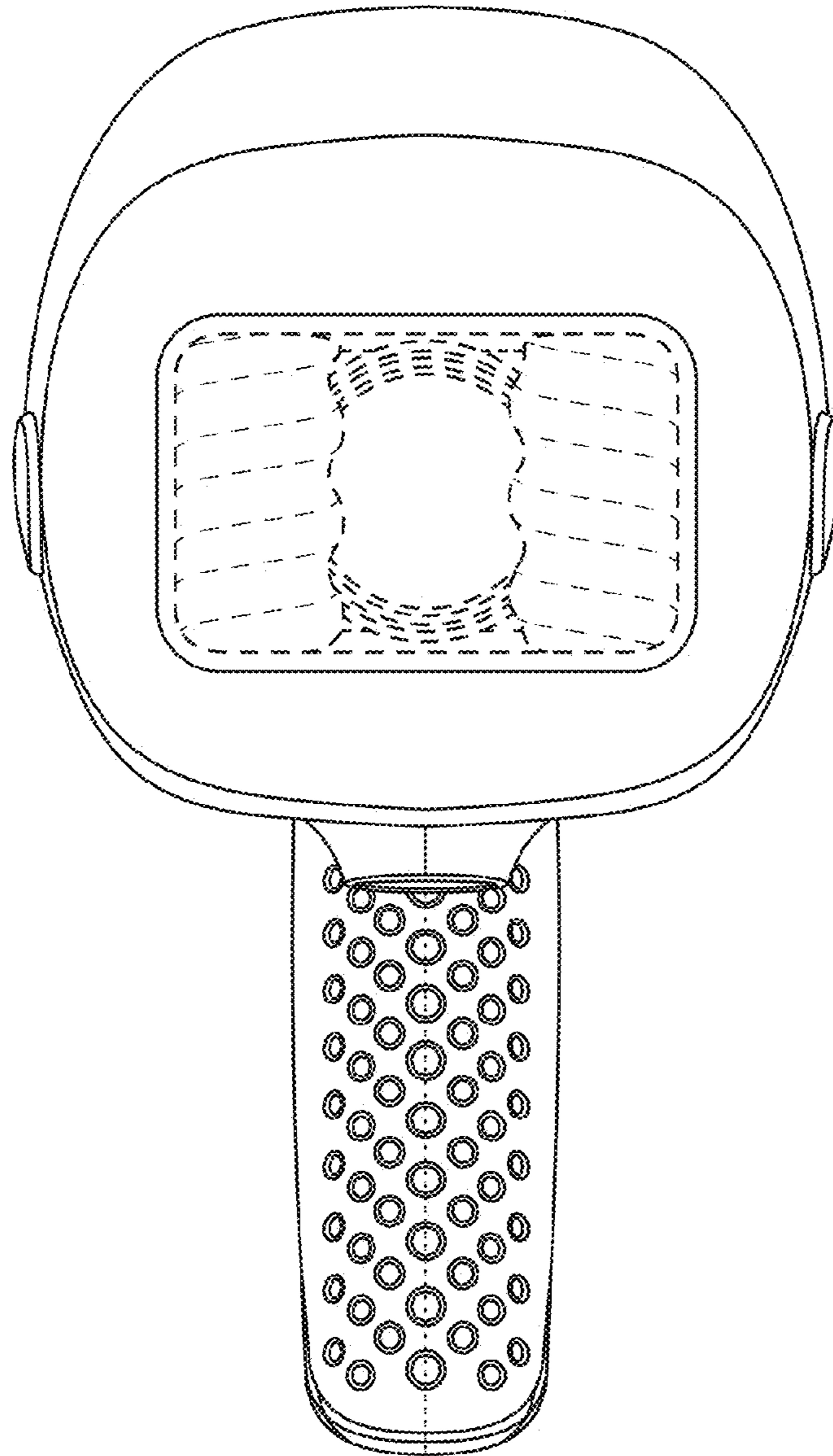




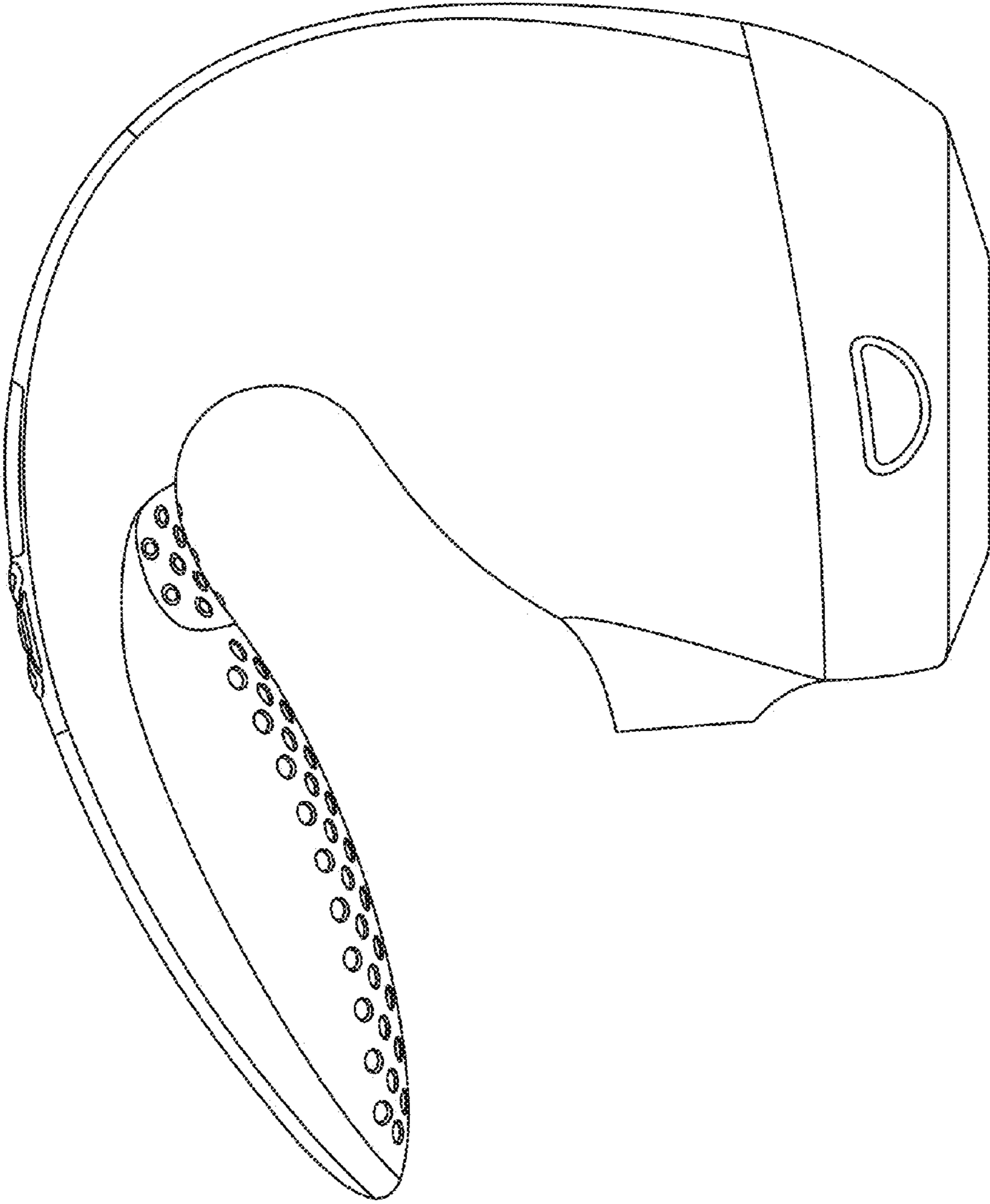

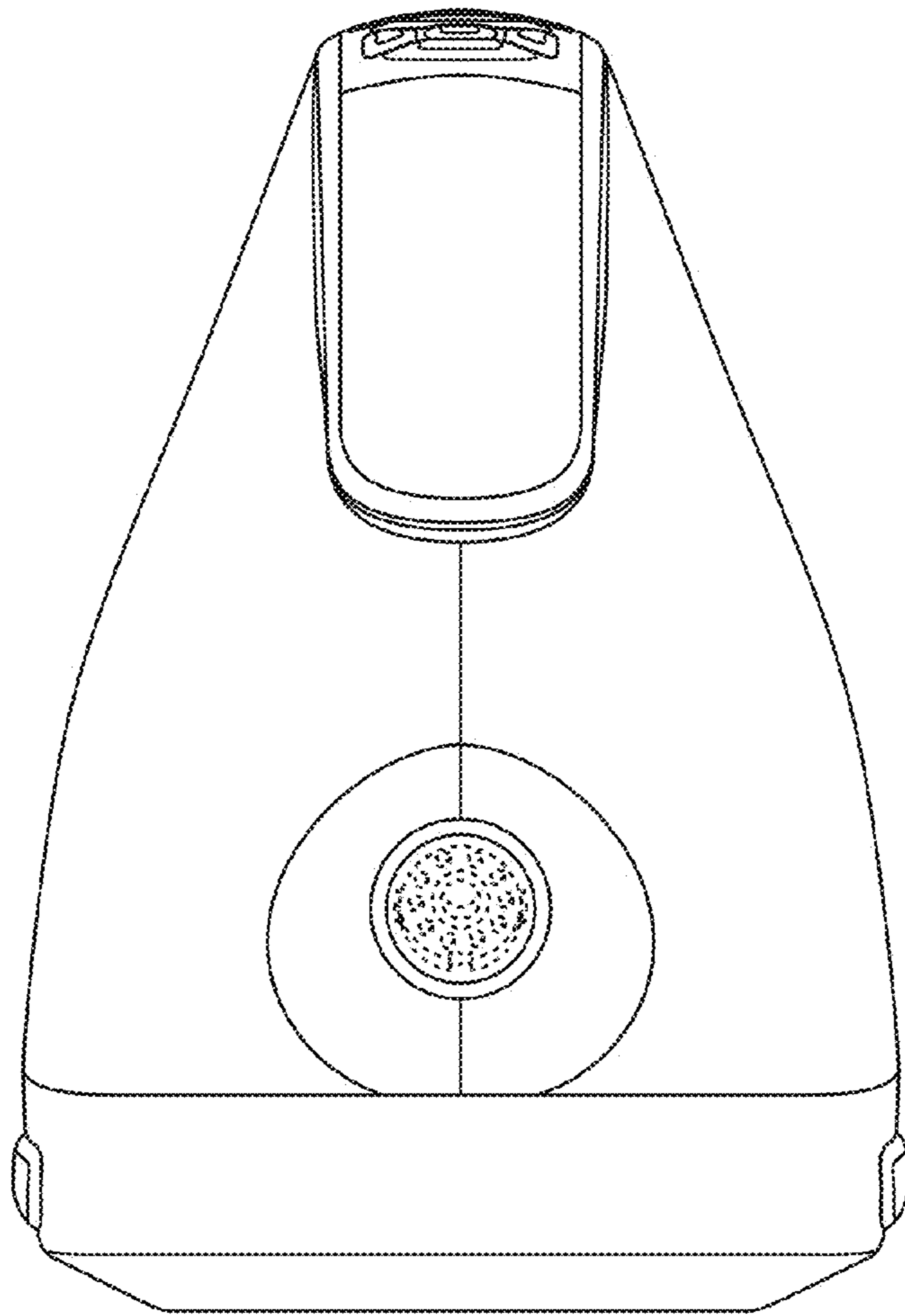

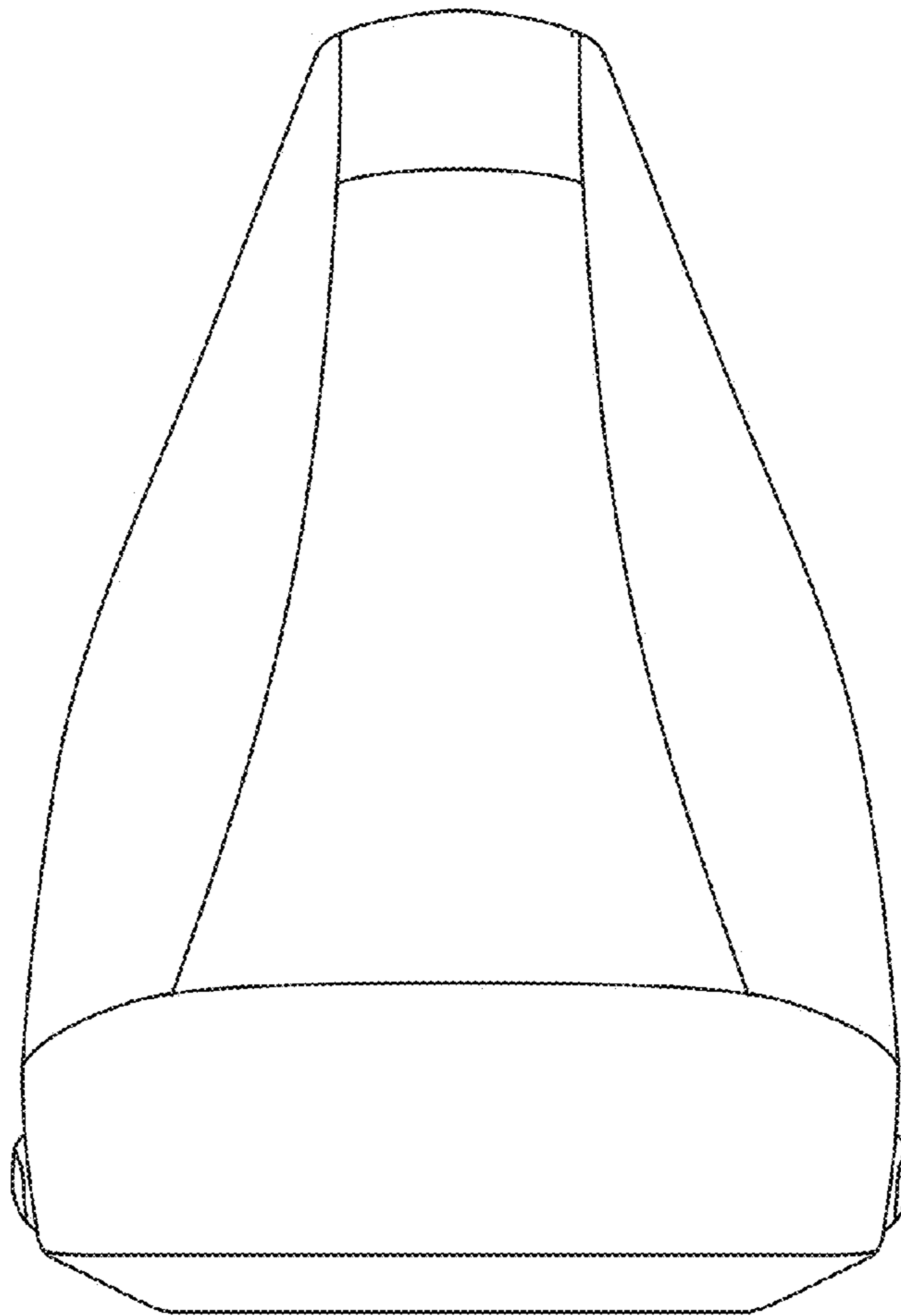
