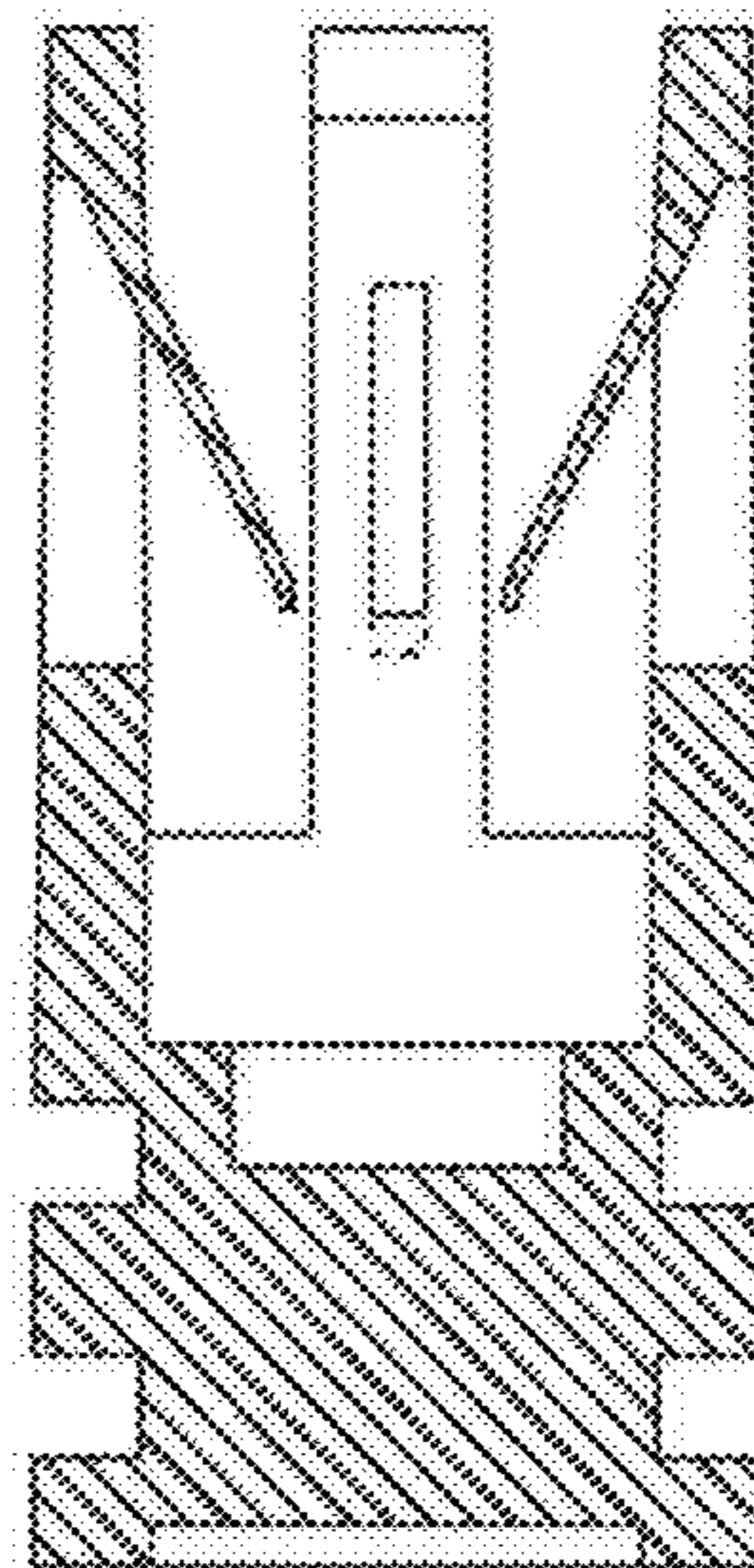
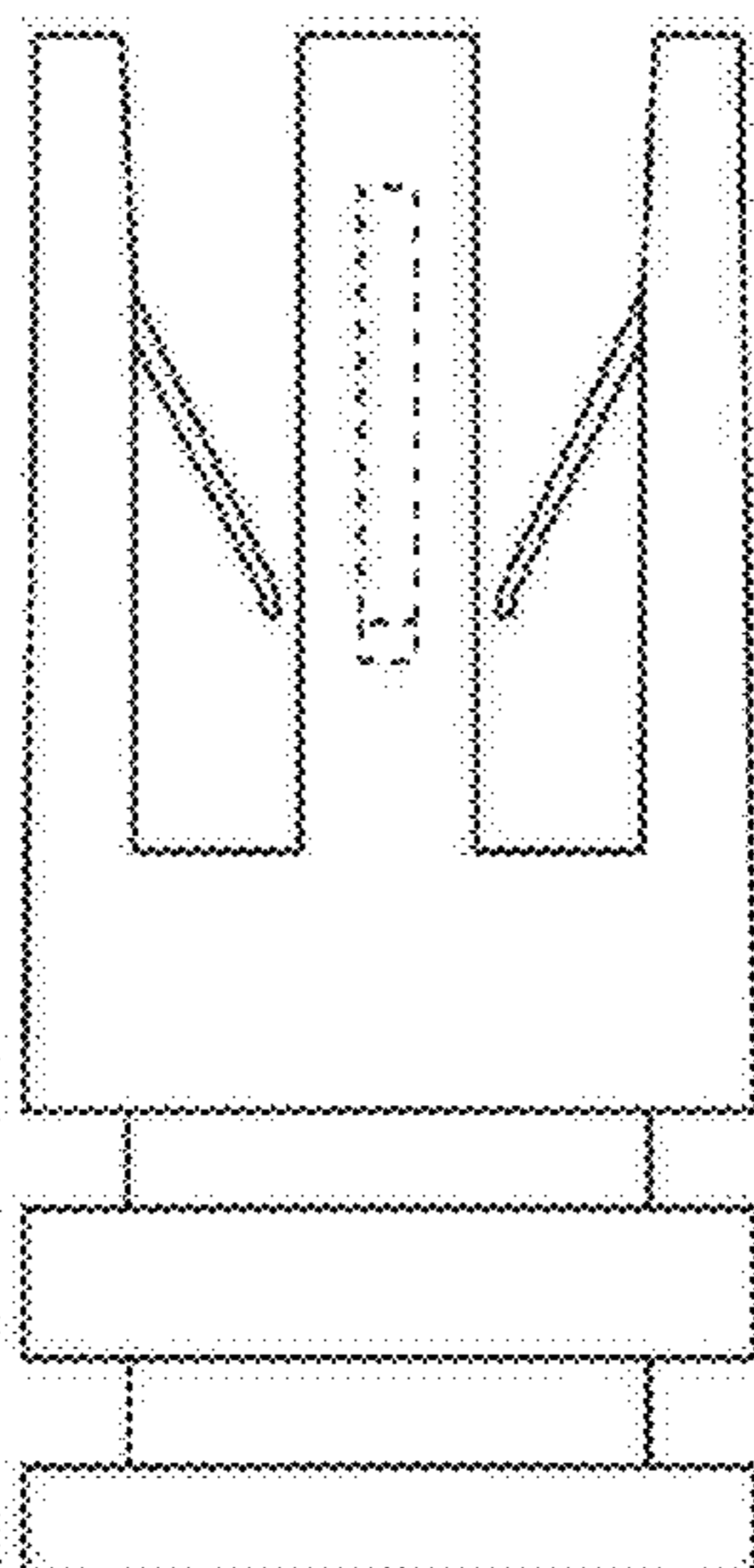
(57) **CLAIM**

The ornamental design for a radio-frequency identification specimen transport puck, as shown and described.

DESCRIPTION

FIG. 1 is a top view of a radio-frequency identification specimen transport puck showing my new design;
FIG. 2 is a bottom view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a cross sectional view taken along the line 4-4 seen in FIG. 1. The opposing cross section is a mirror image thereof;
FIG. 5 is a right-side view thereof; and,
FIG. 6 is a left-side view thereof.

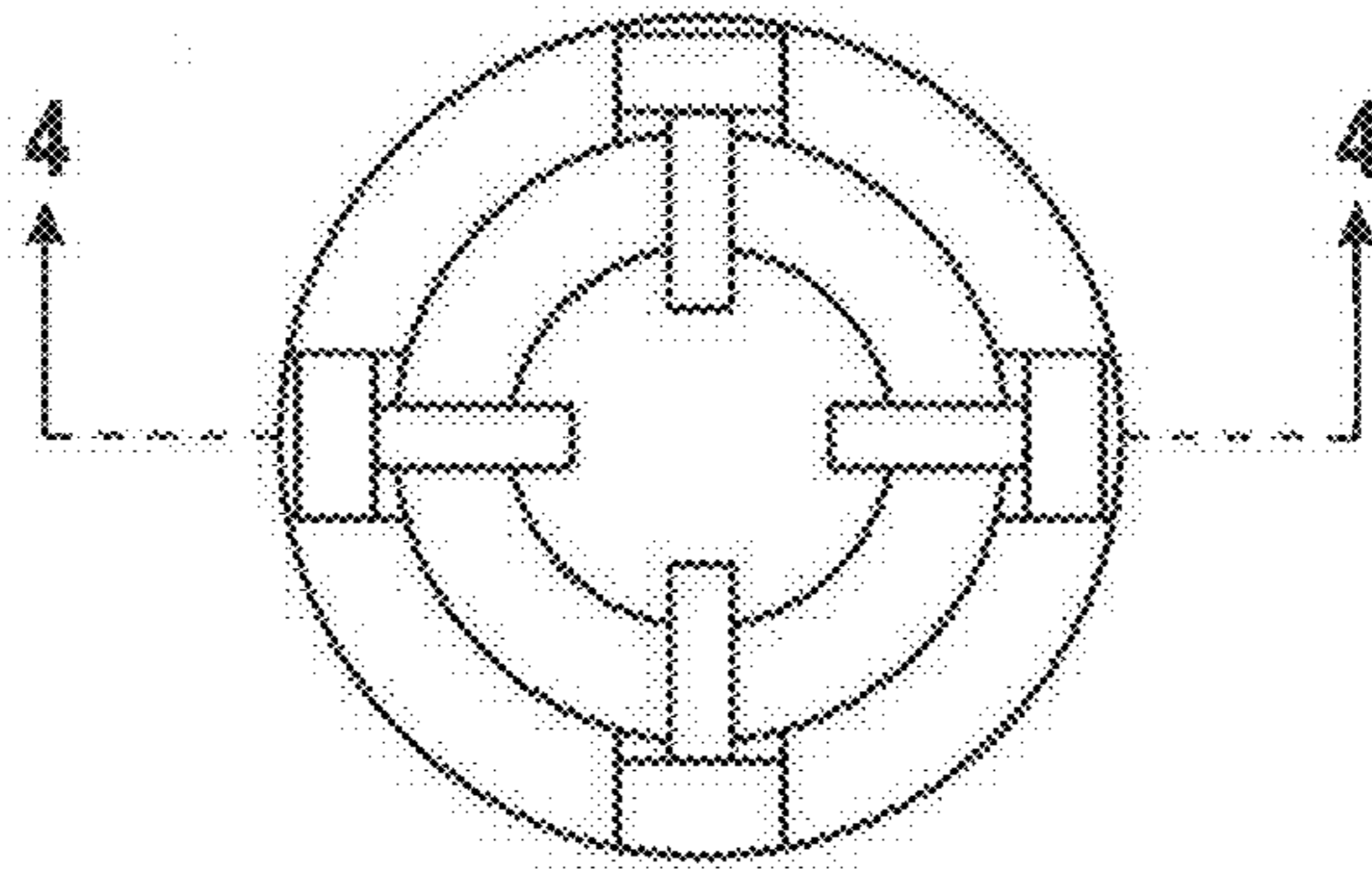

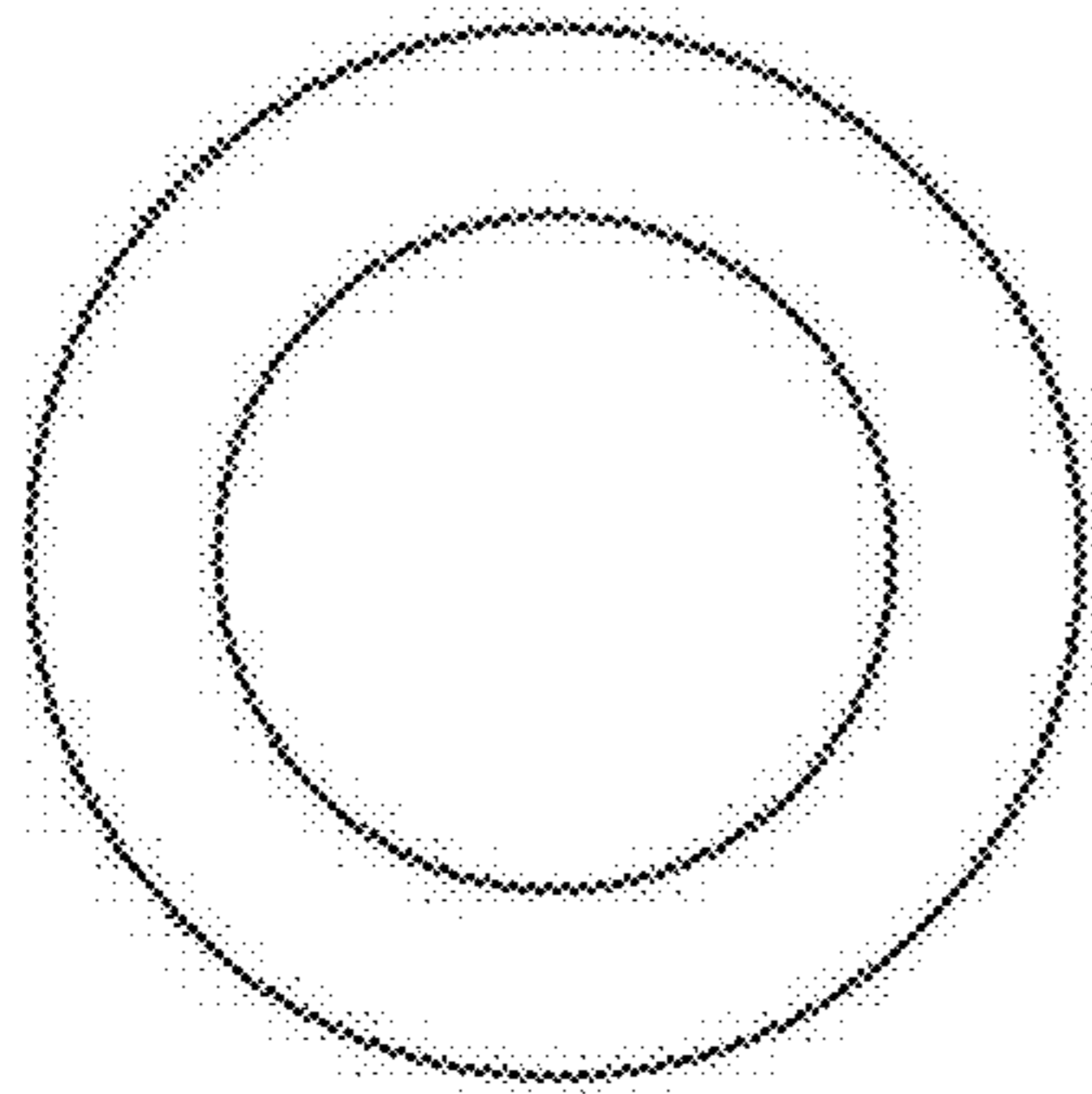

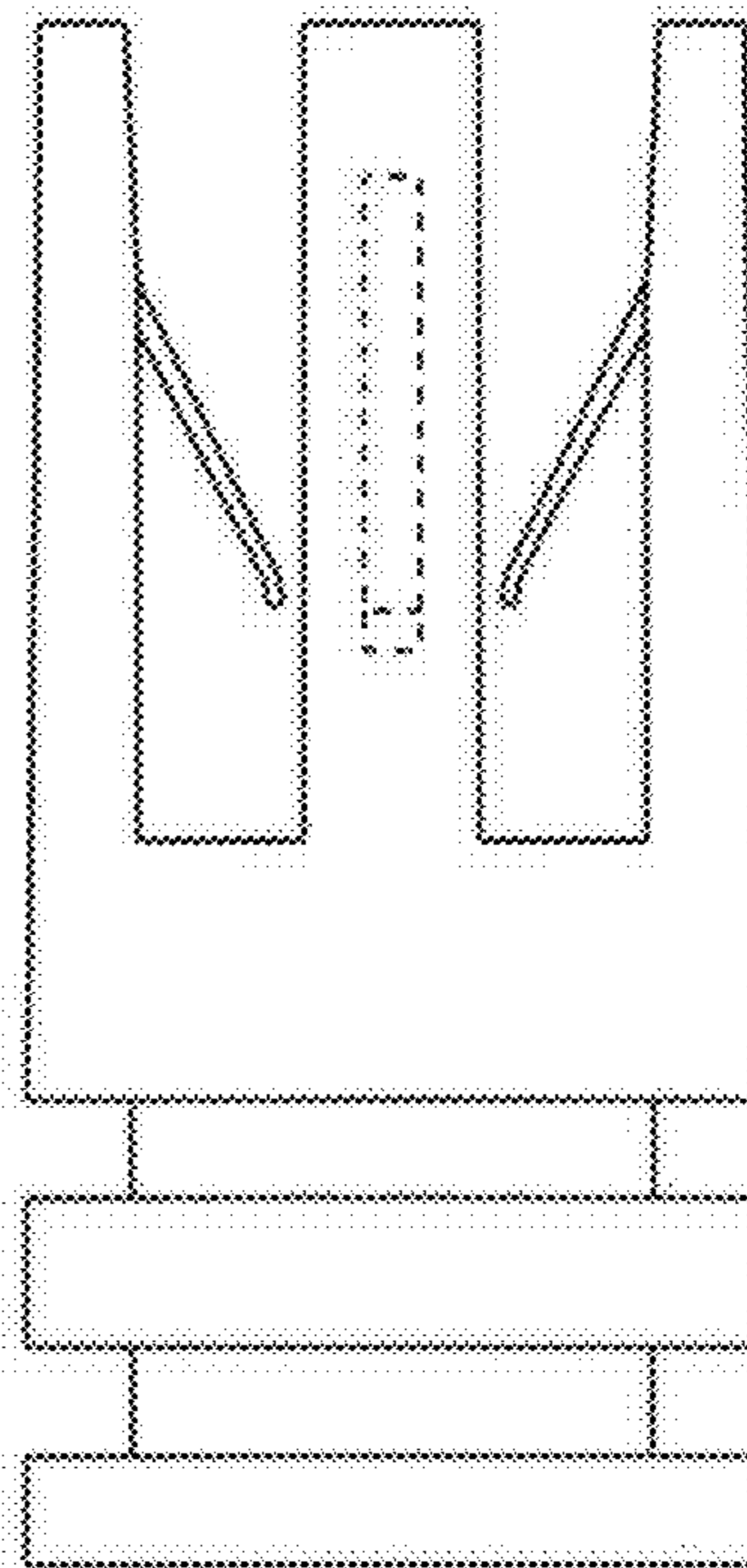

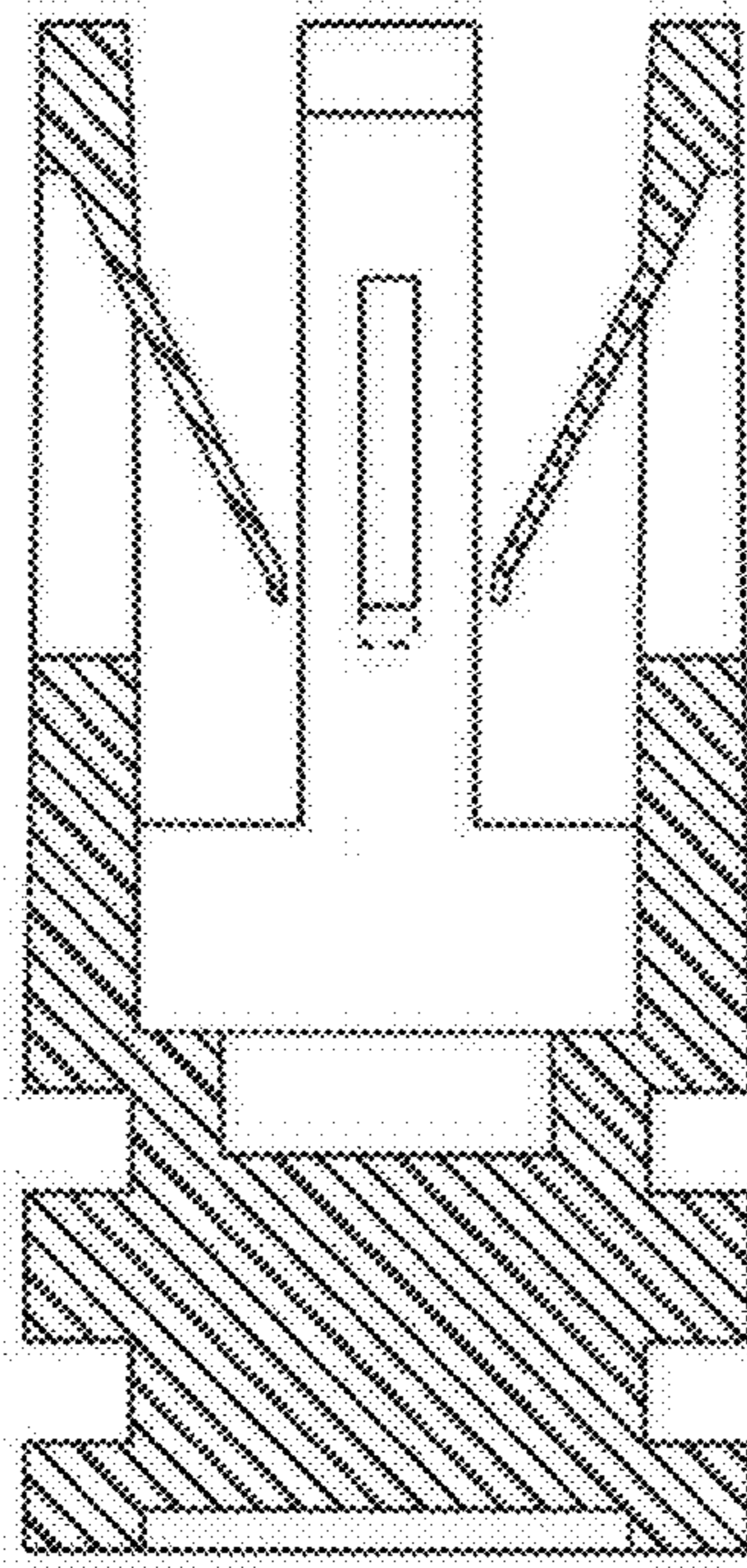

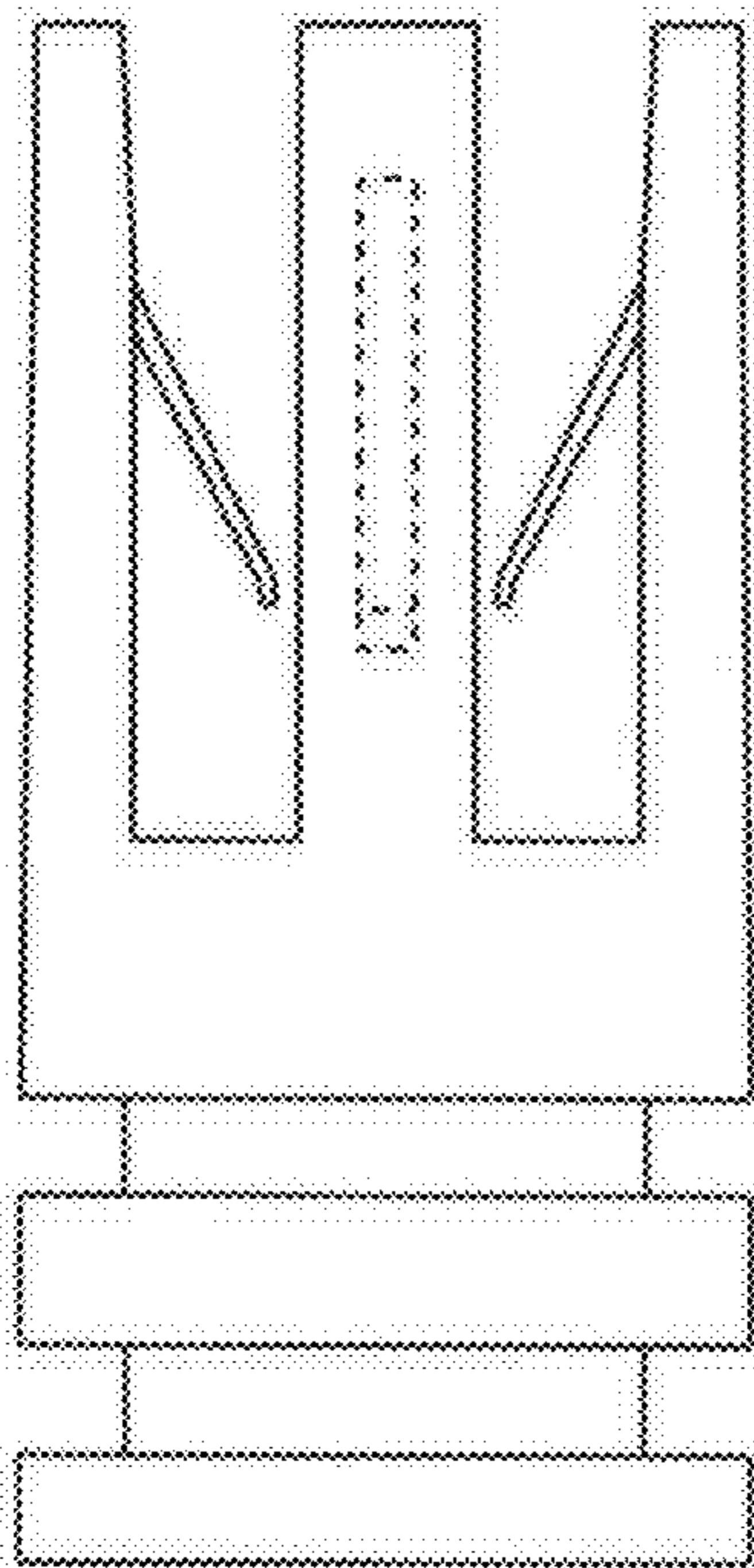

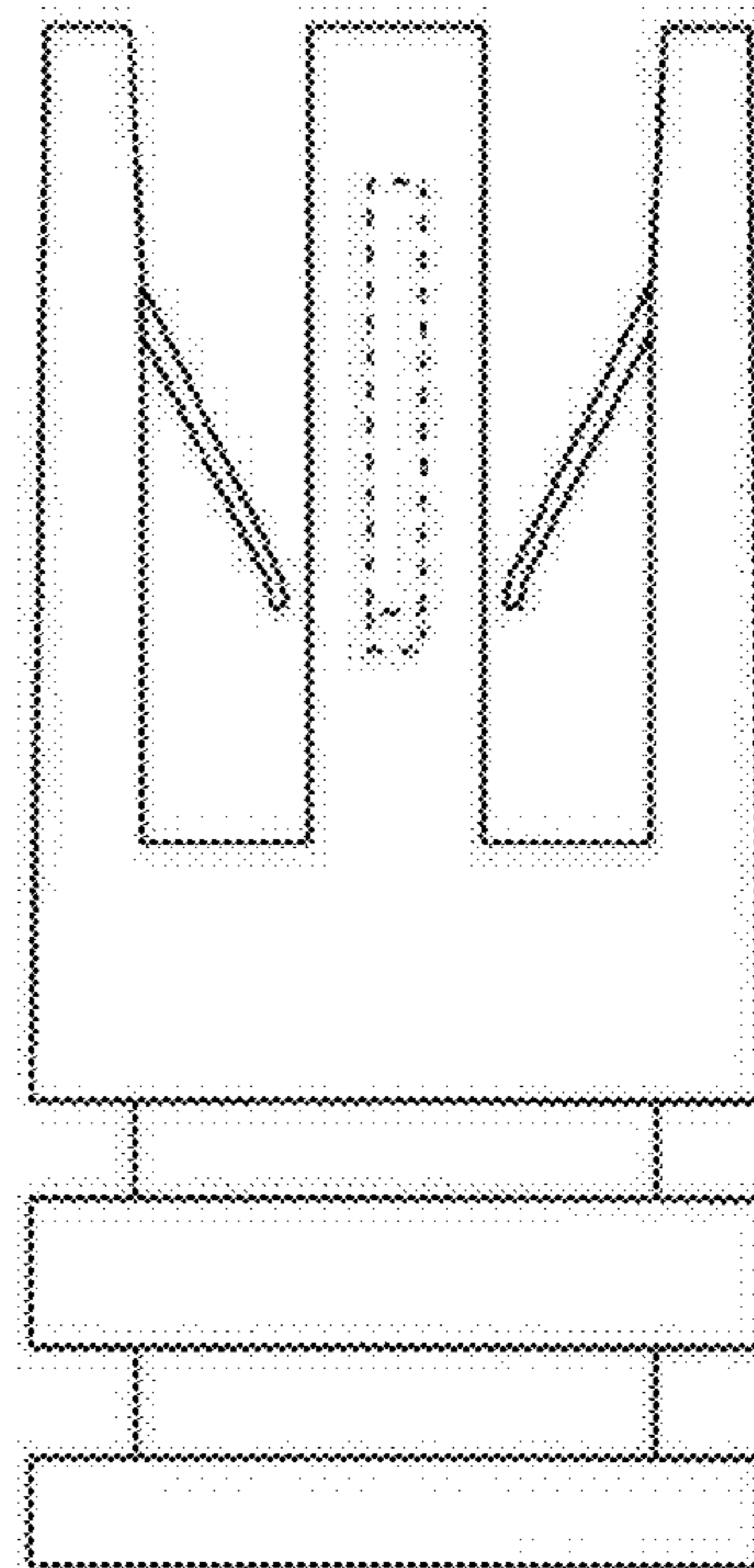
