The ornamental design for a LED lamp with stippled lens, as shown and described.

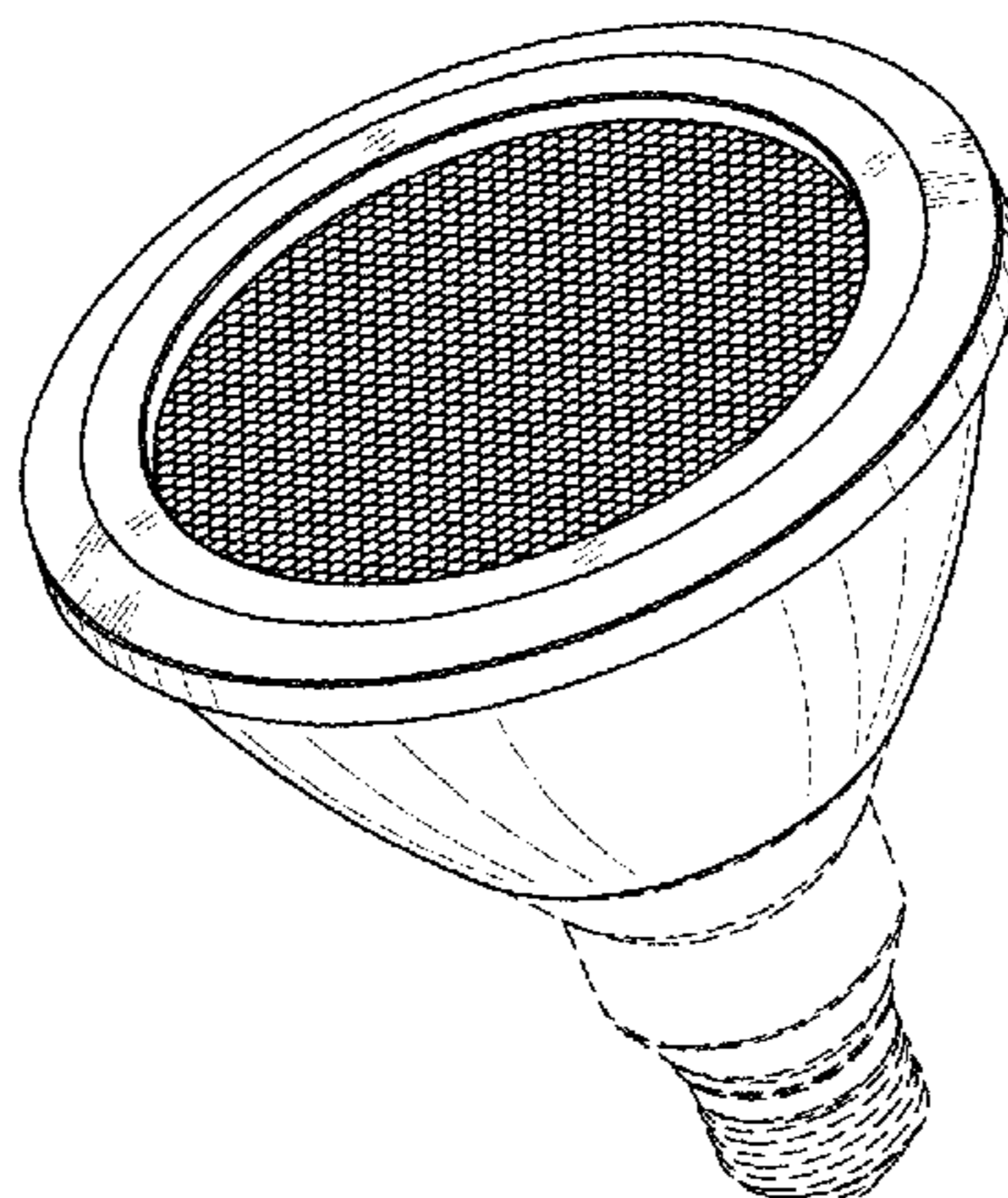
DESCRIPTION

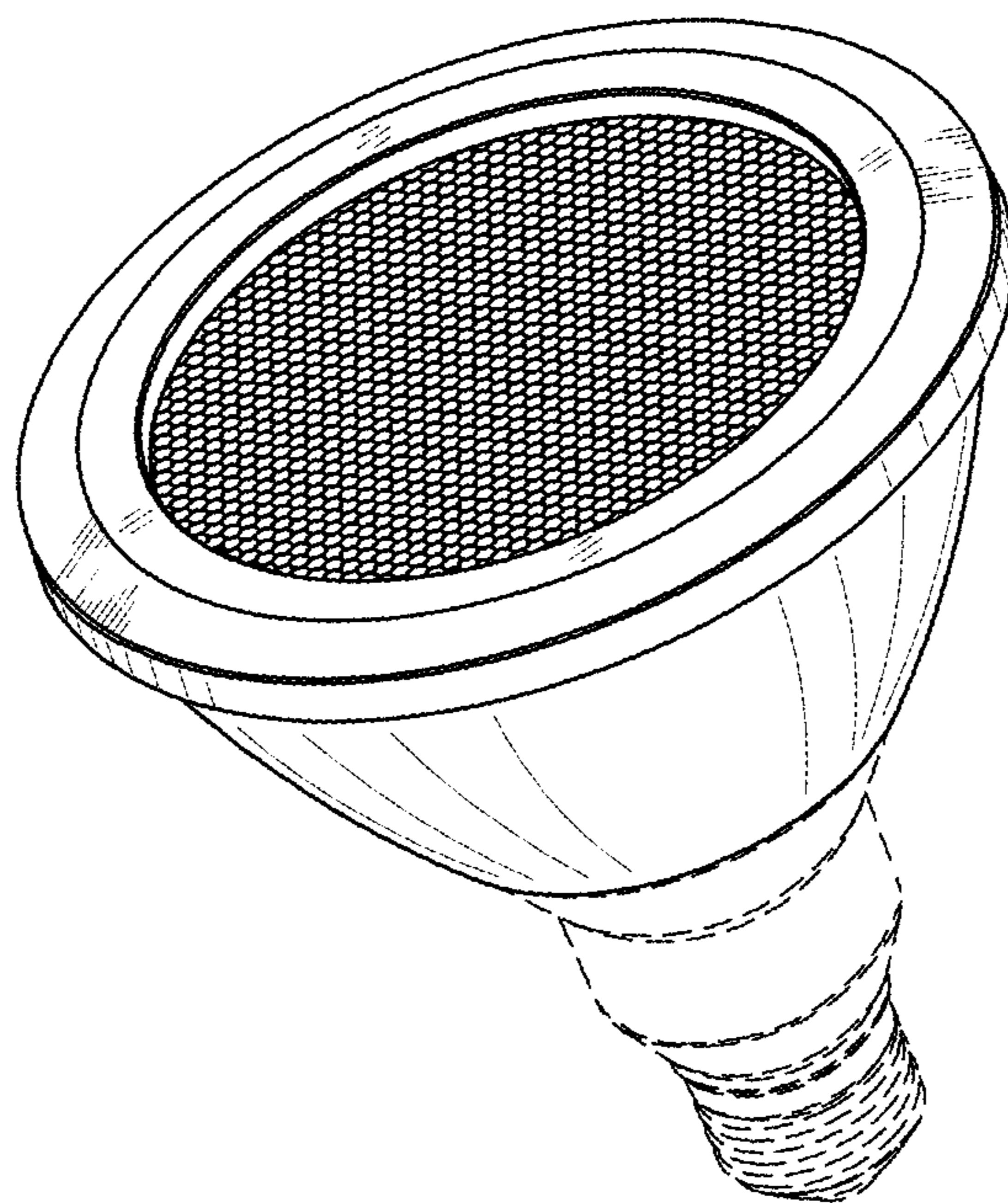

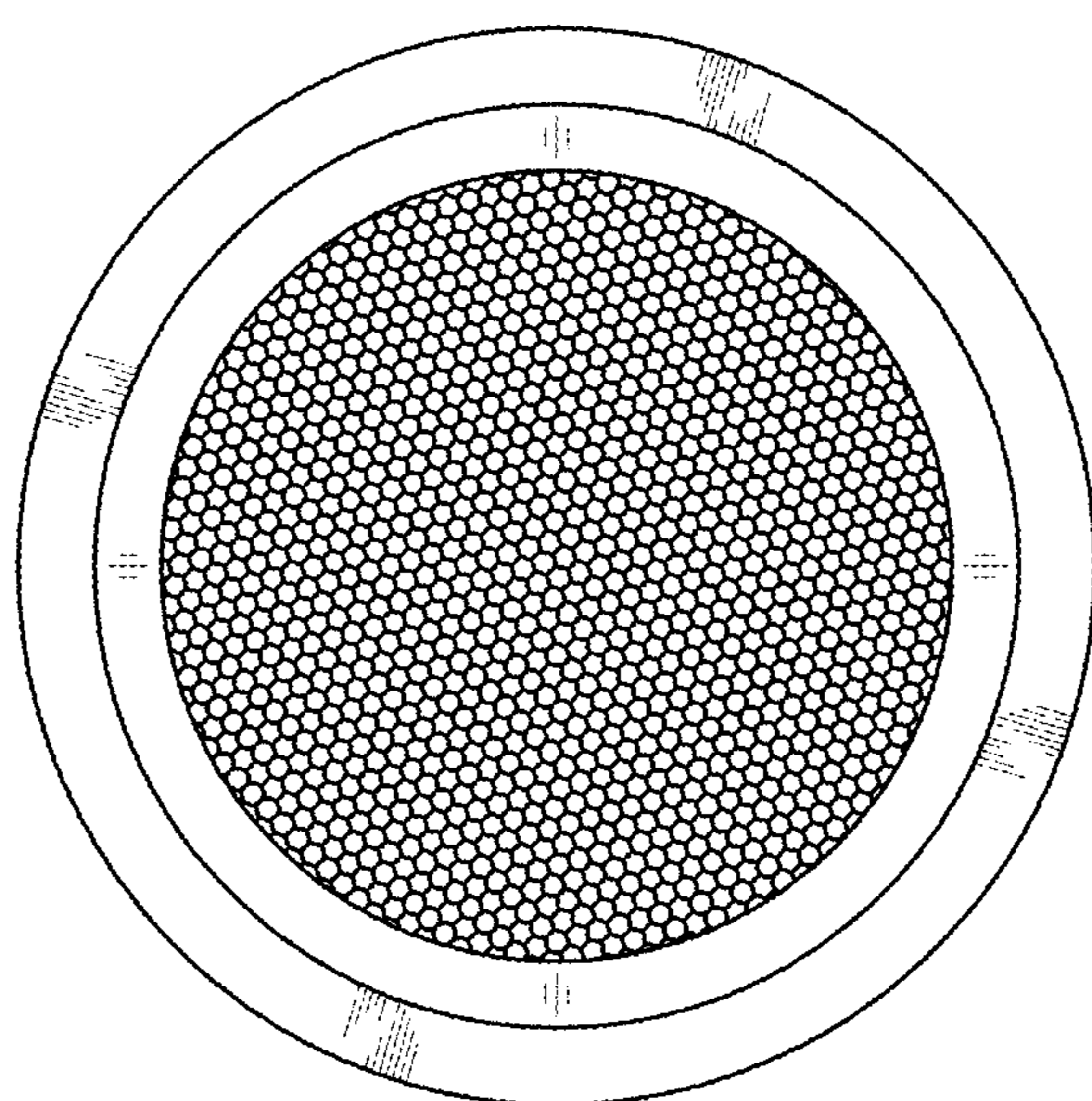

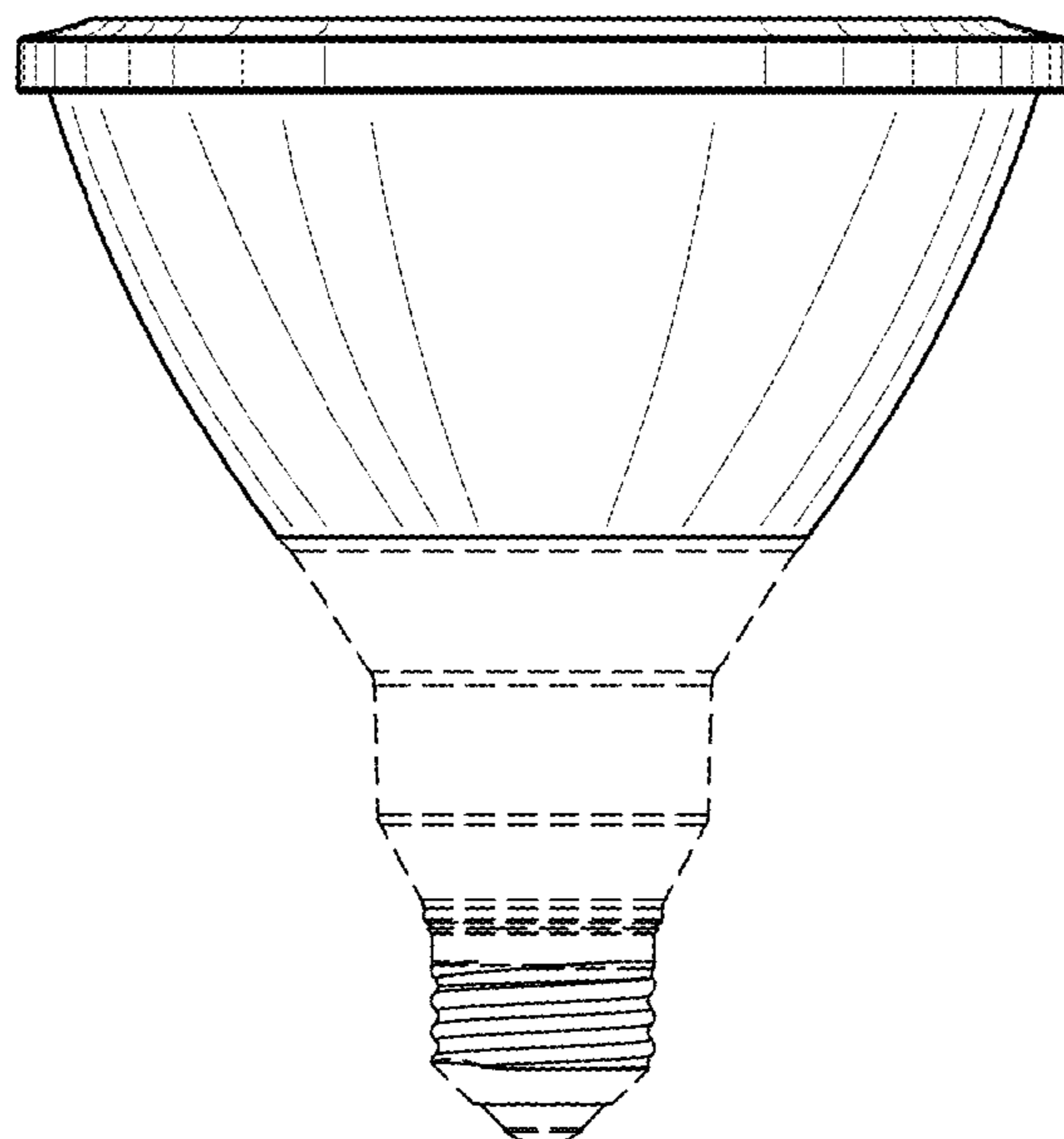

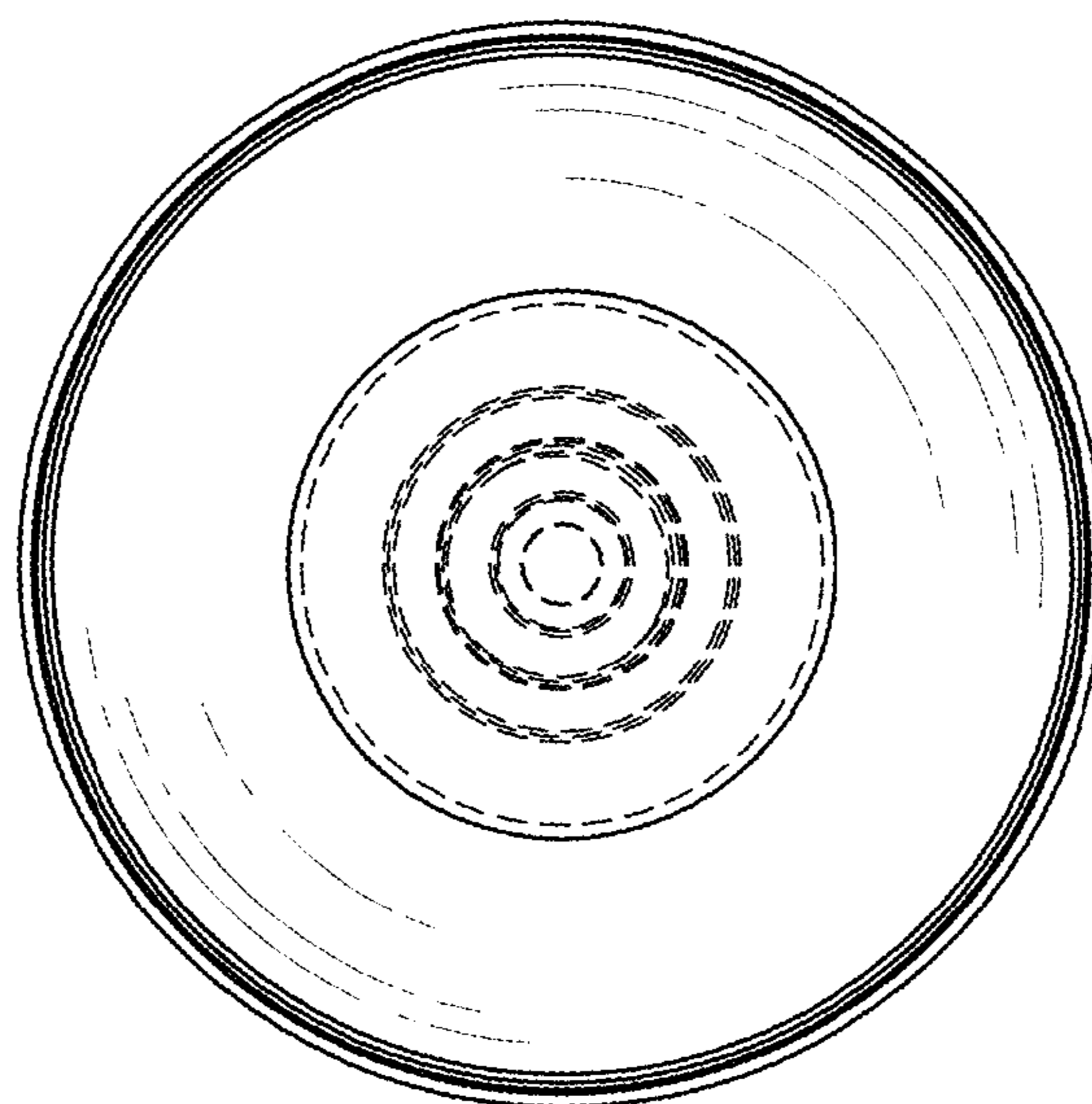
