**DESCRIPTION**

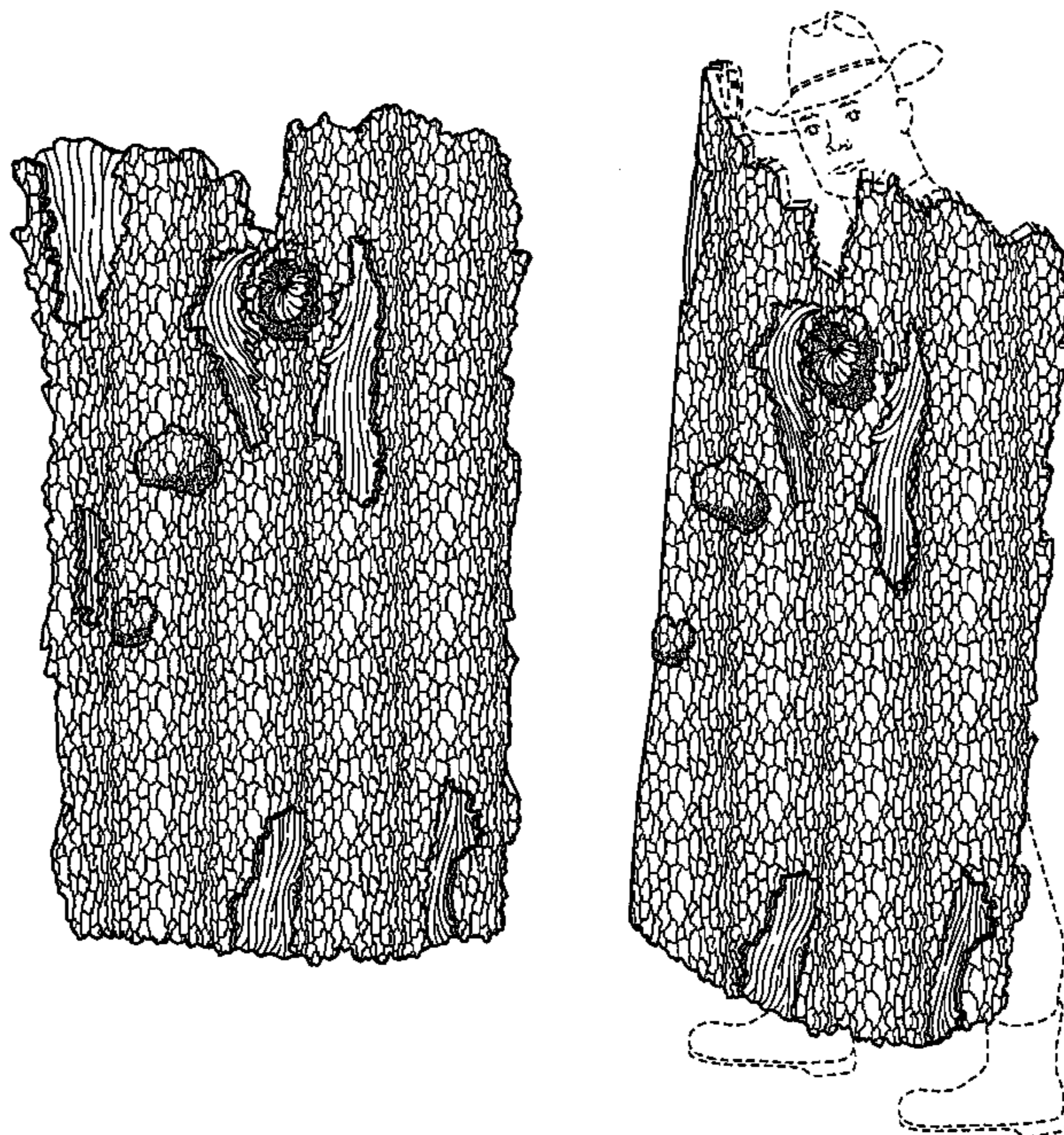

The broken lines depict portions of the portable hunting blind that form no part of the claimed design. The hunter shown in broken lines illustrates environment and likewise forms no part of the claimed design.

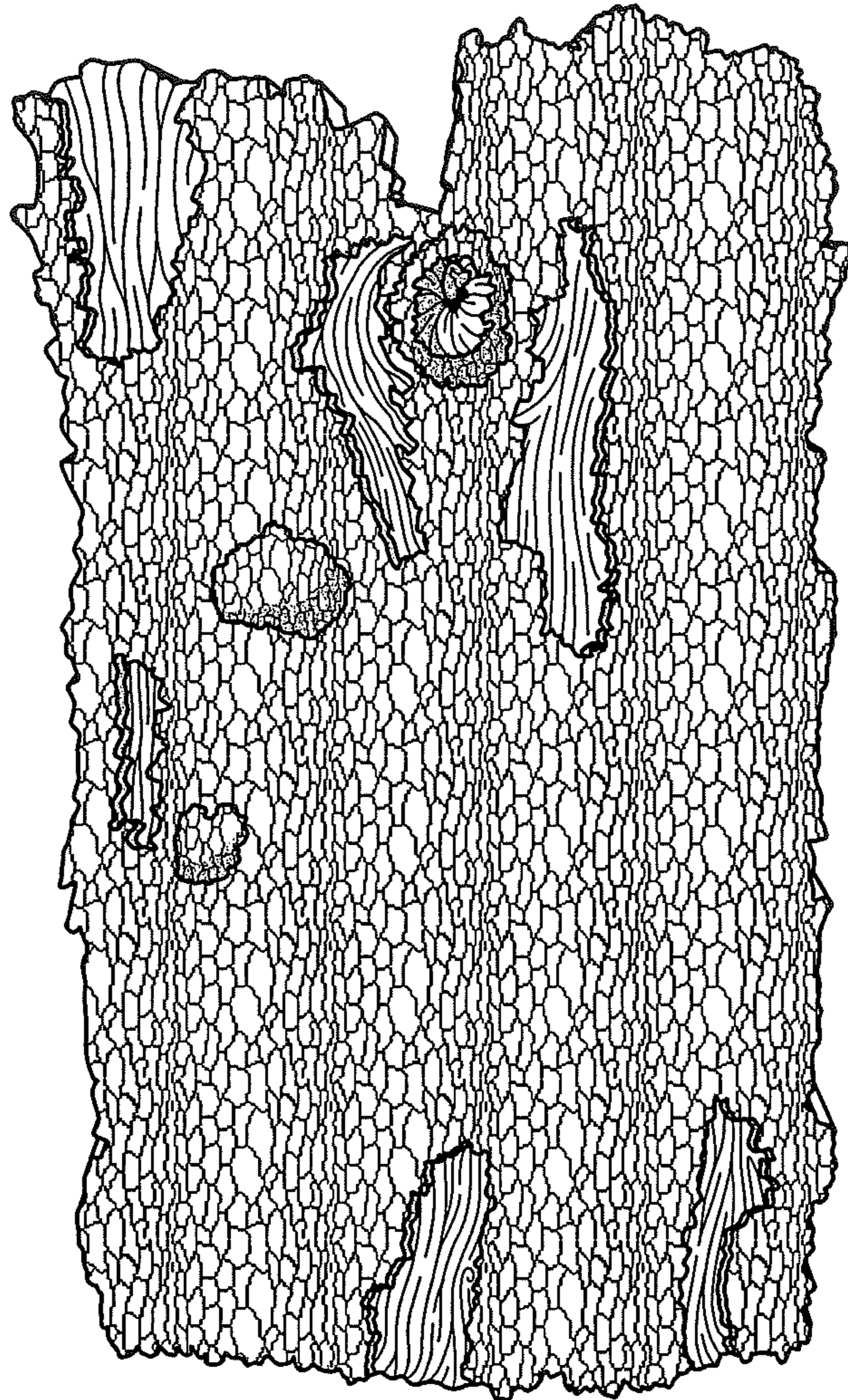

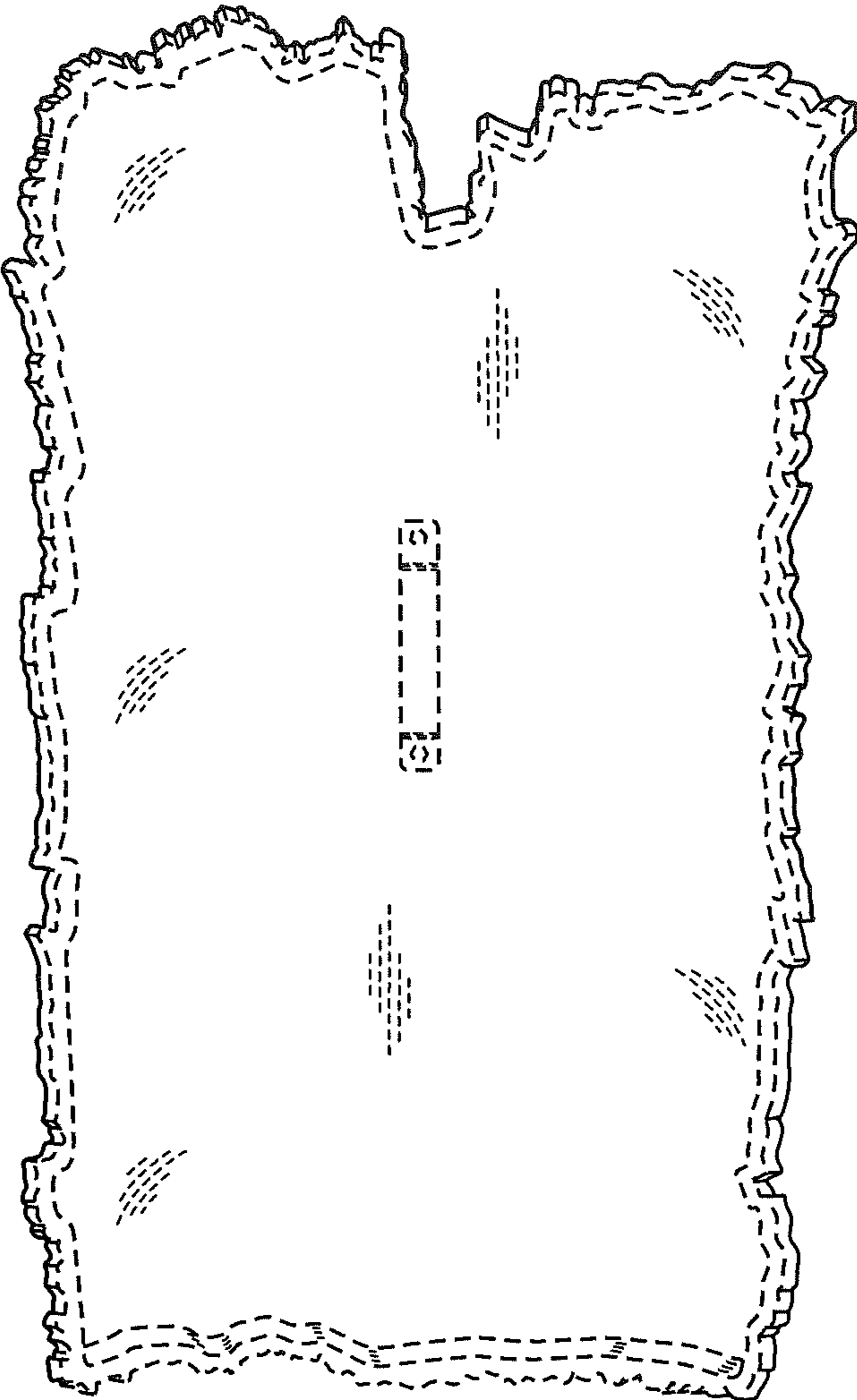

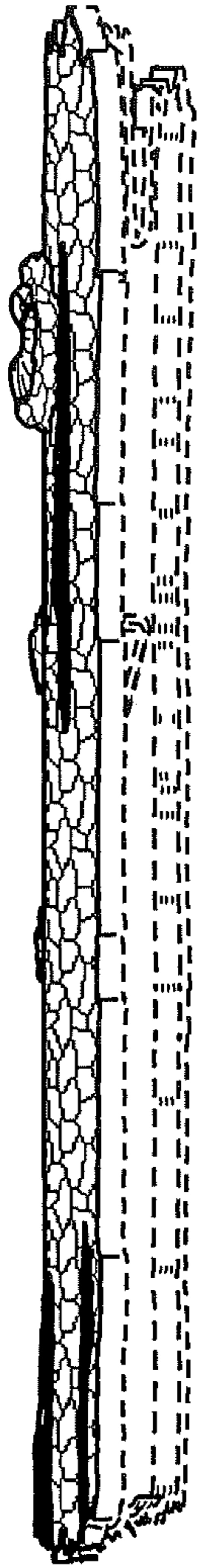

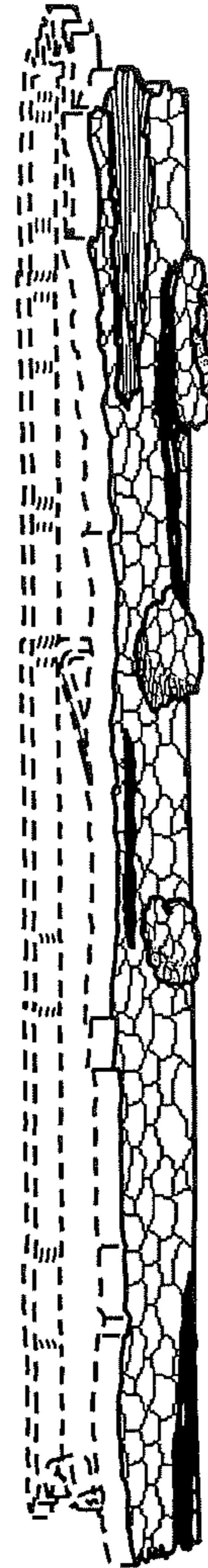

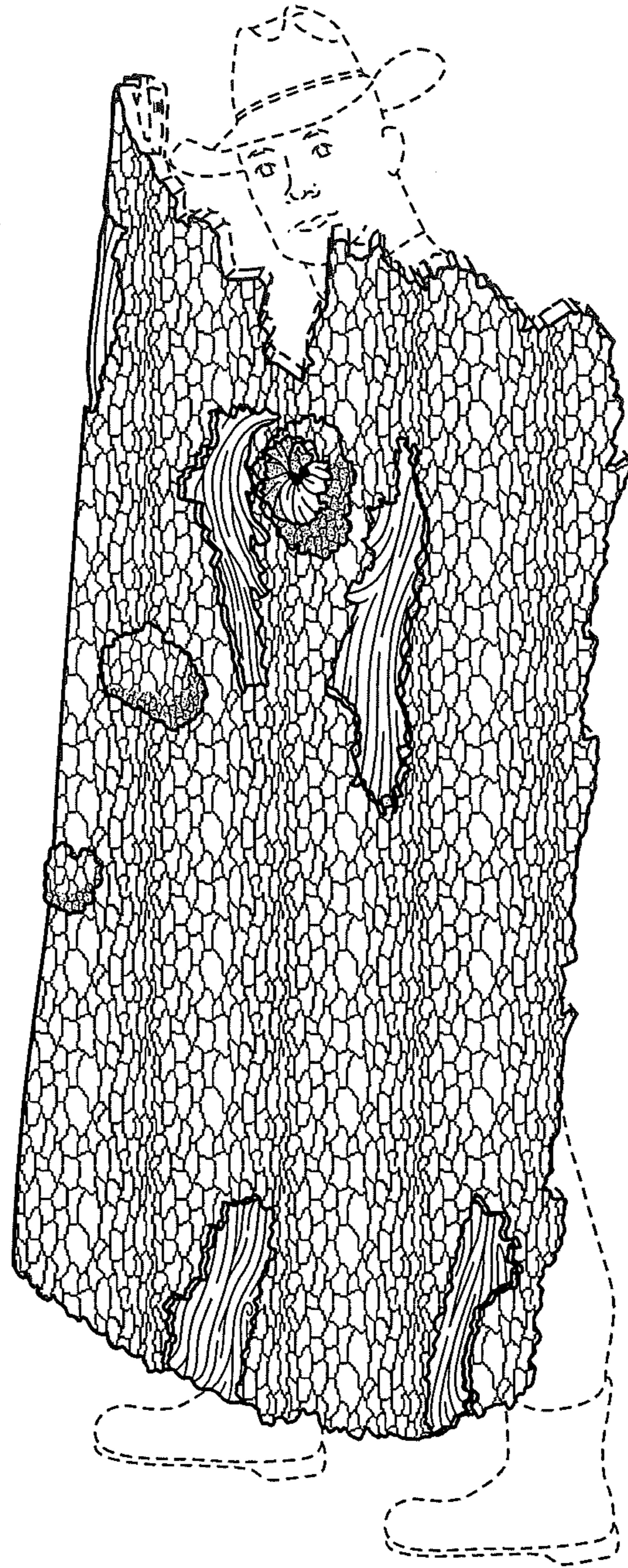

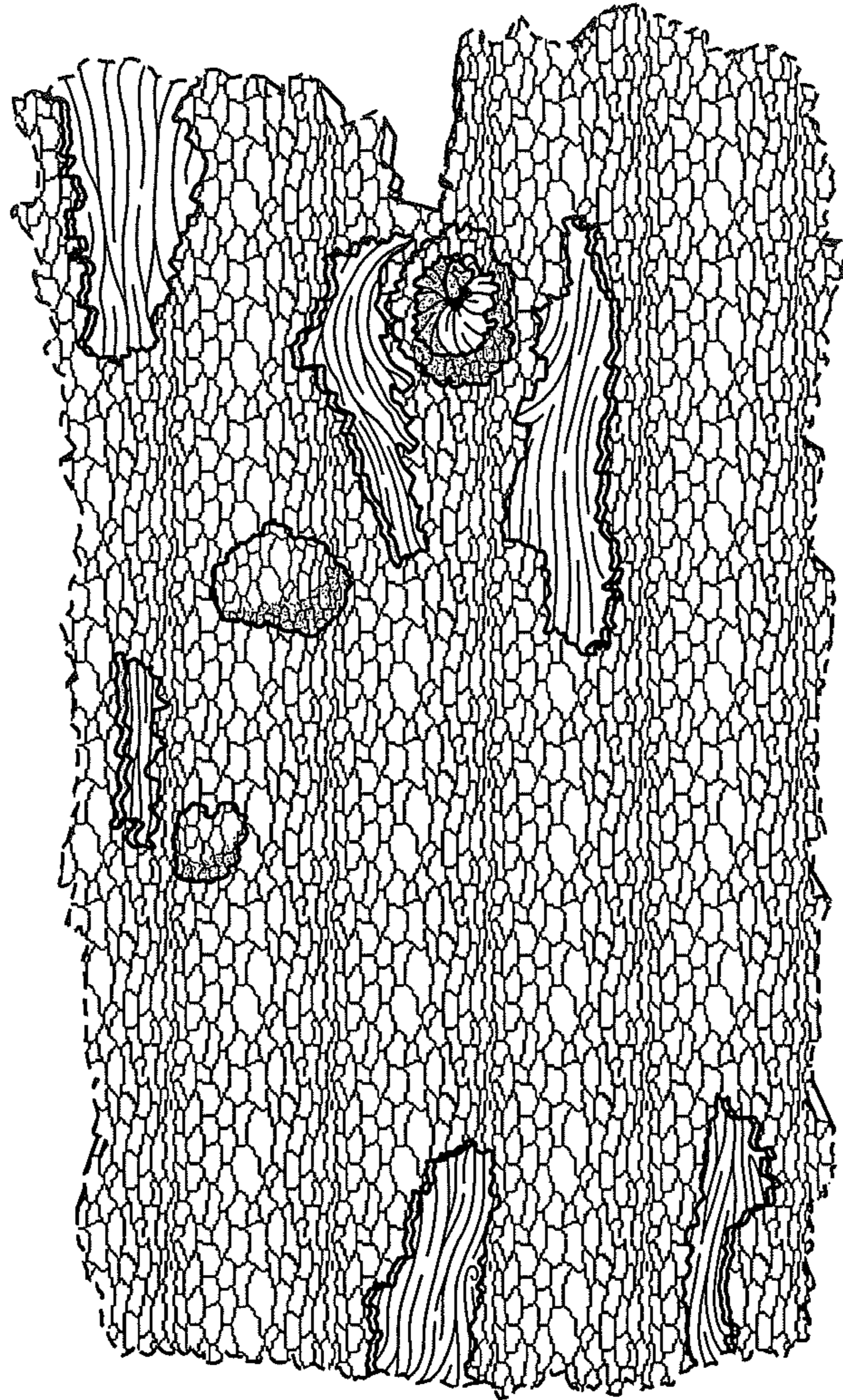

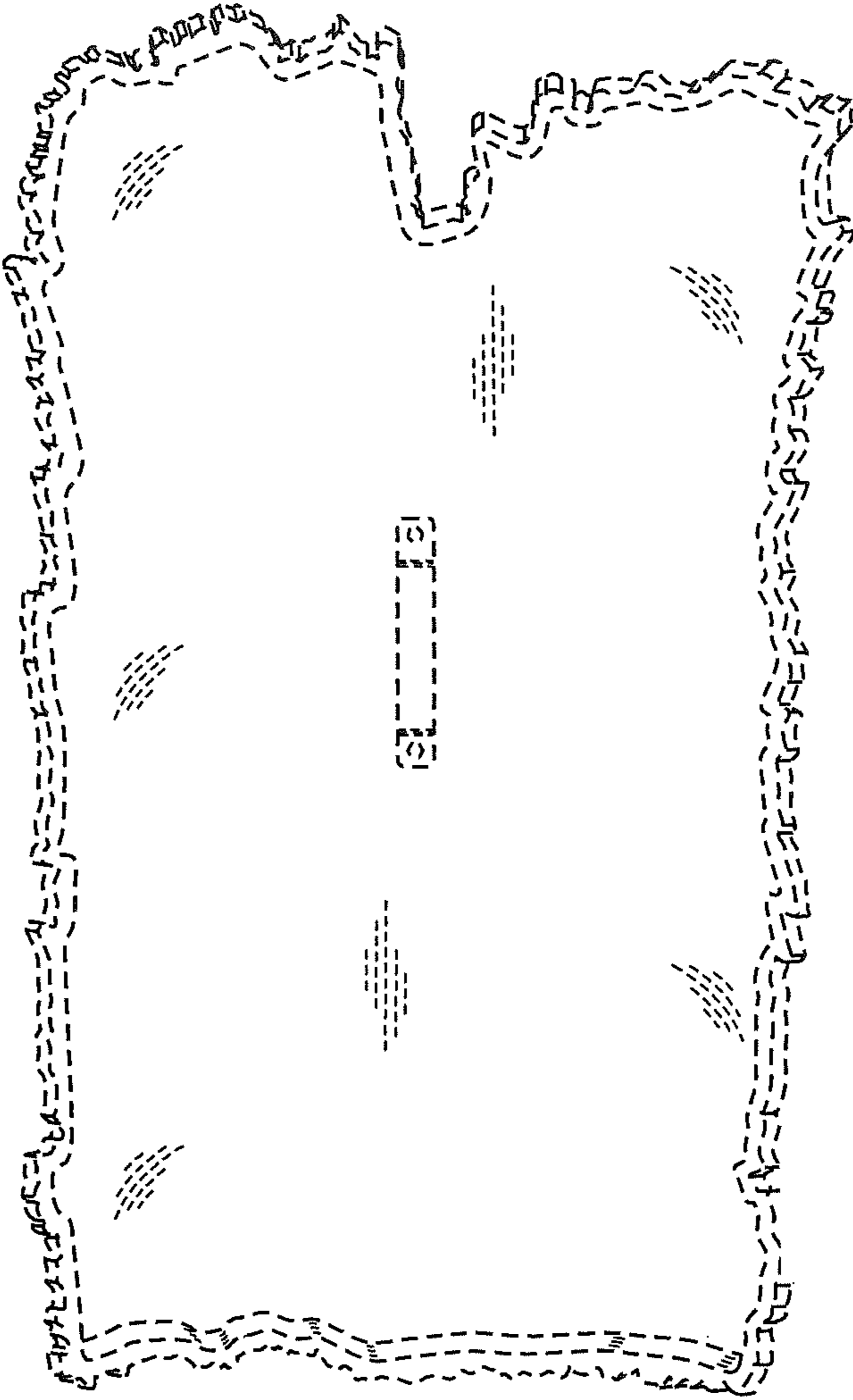

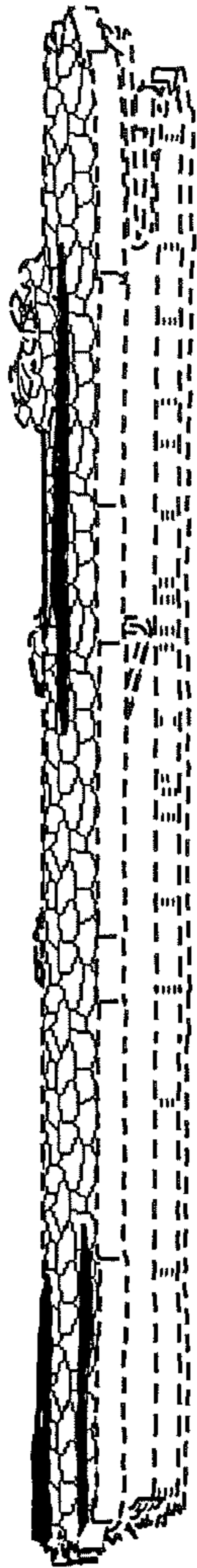

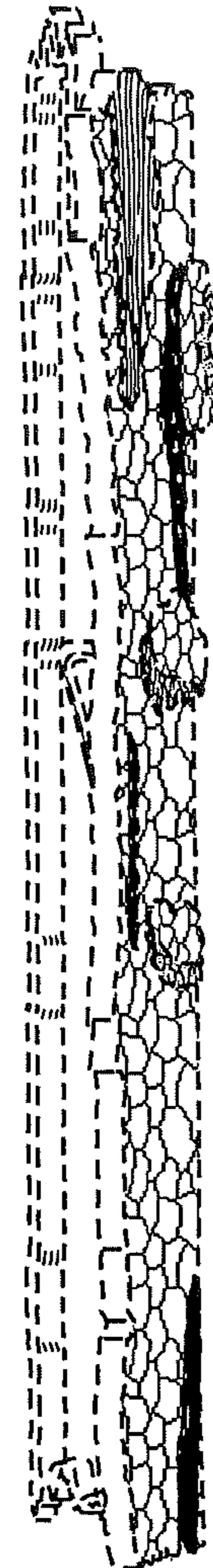

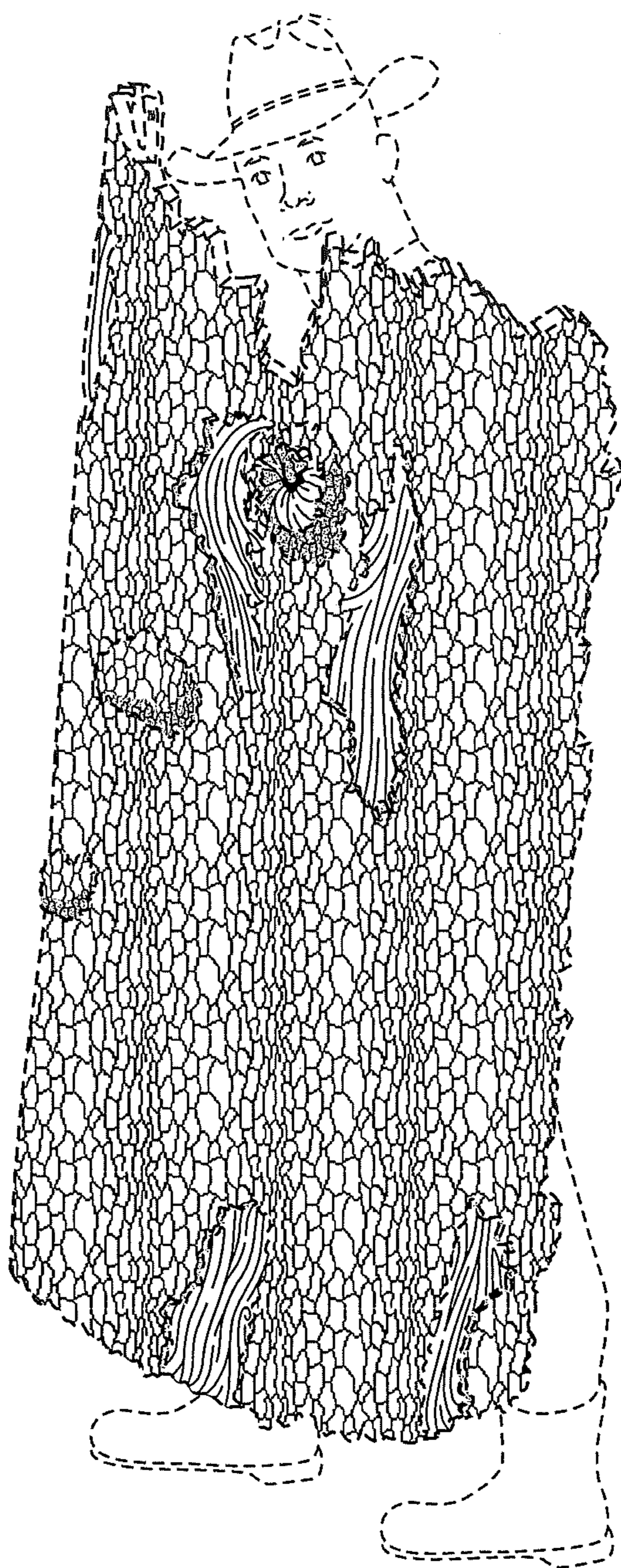
