(57) **CLAIM**

The ornamental design for a crystal embellished golf glove, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a crystal embellished golf glove.

FIG. 2 is a top plan view of the crystal embellished golf glove of FIG. 1.

FIG. 3 is a bottom plan view of the crystal embellished golf glove of FIG. 1.

FIG. 4 is a right side elevation view of the crystal embellished golf glove of FIG. 1.

FIG. 5 is a left side elevation view of the crystal embellished golf glove of FIG. 1.

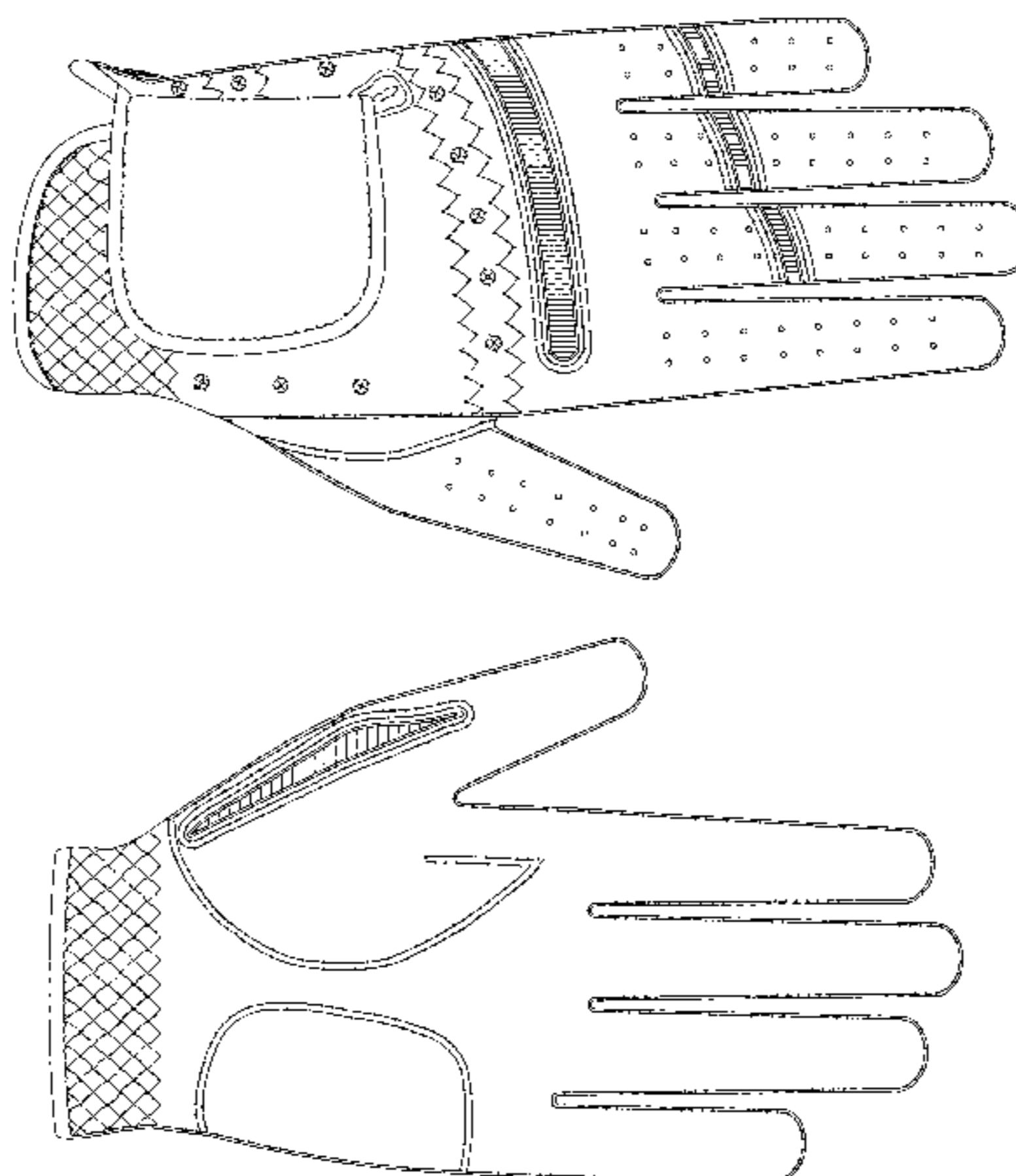
FIG. 6 is a front elevation view of the crystal embellished golf glove of FIG. 1; and,

FIG. 7 is a rear elevation view of the crystal embellished golf glove of FIG. 1.

The circular broken lines shown in FIGS. 5 and 7 illustrate features of the article in which the design is embodied that form no part of the claimed design.

The broken line shown just inside the edge of the hand opening of the glove in FIG. 7 and that defines the bounds of the claimed design, forms no part thereof.

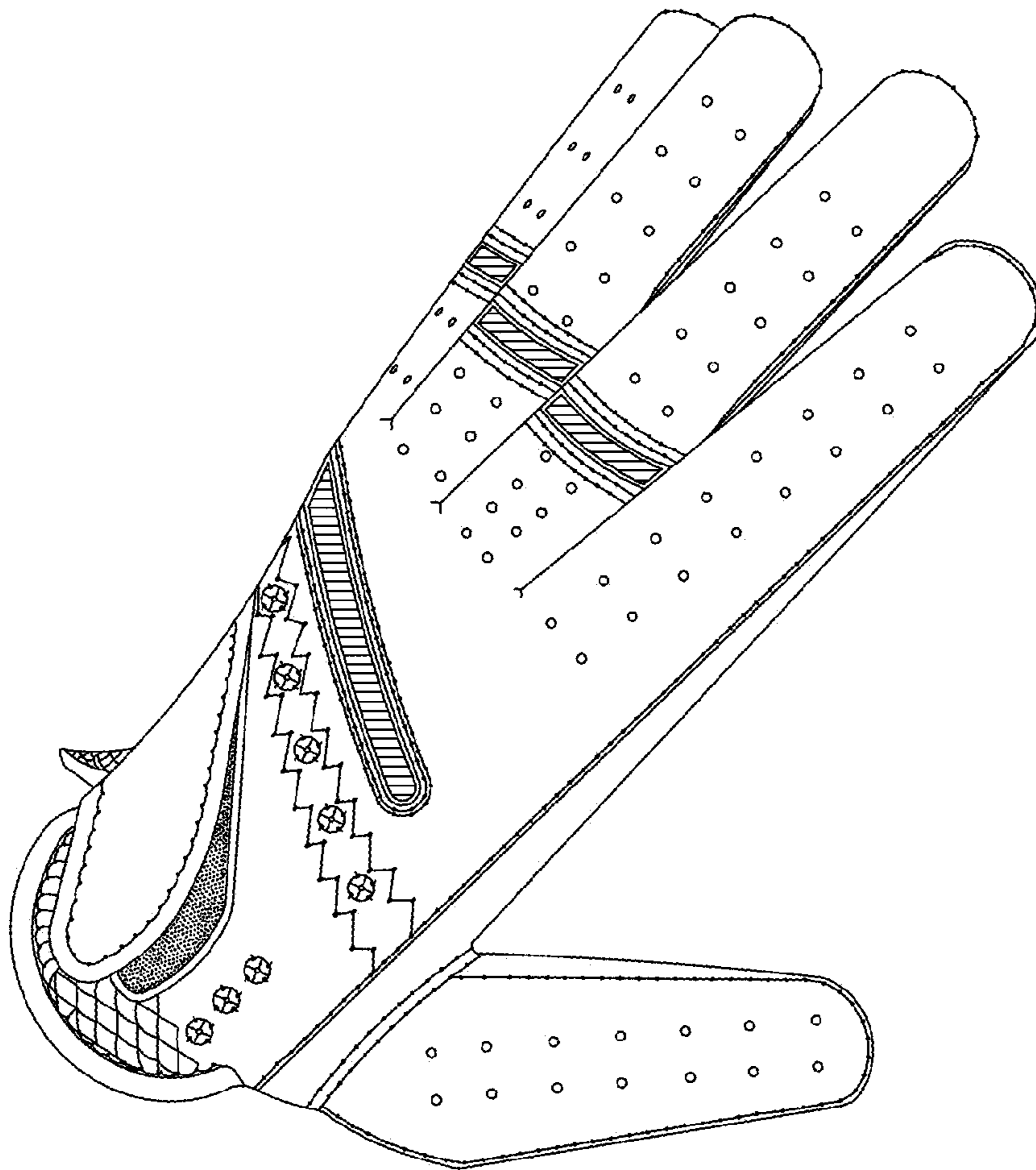

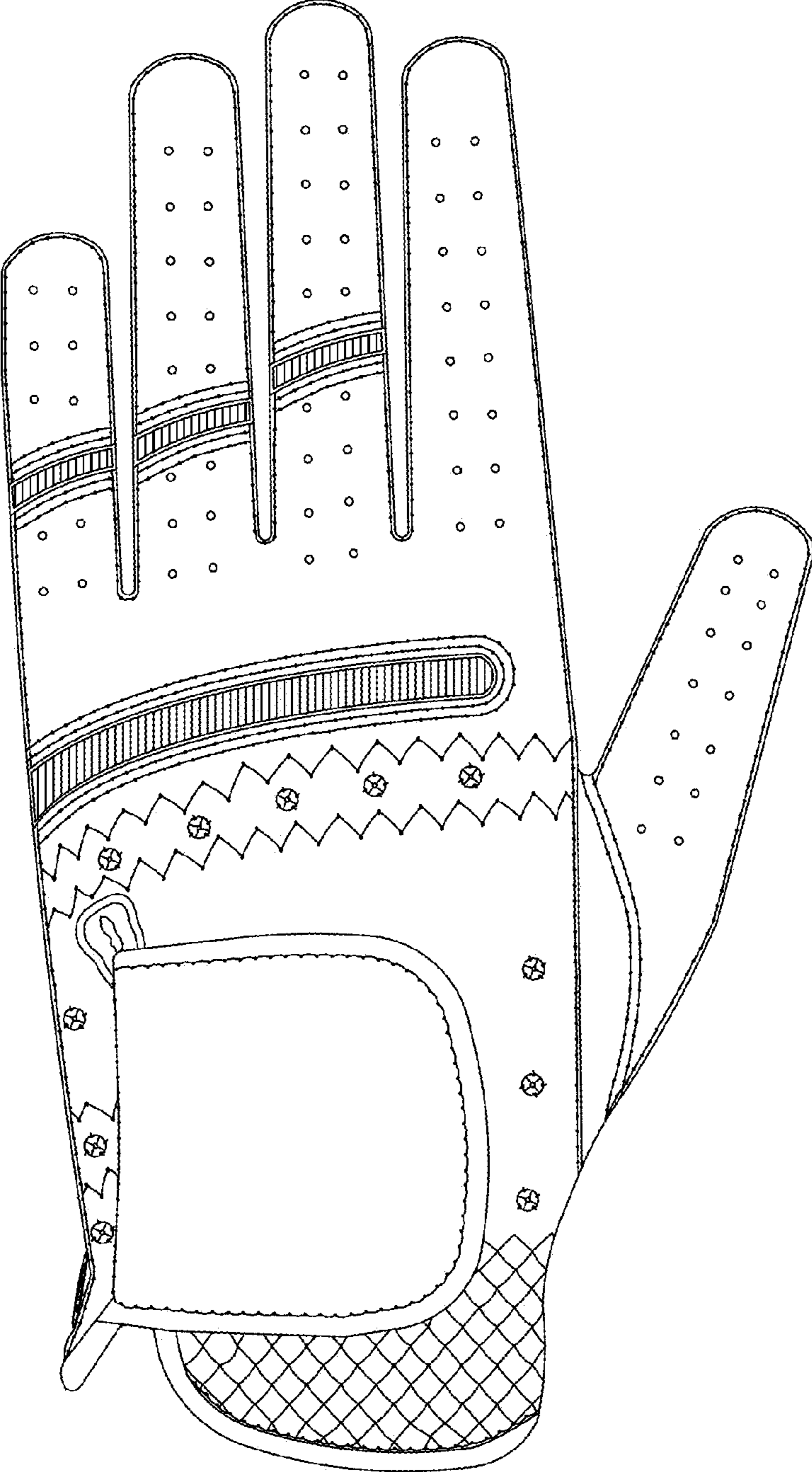

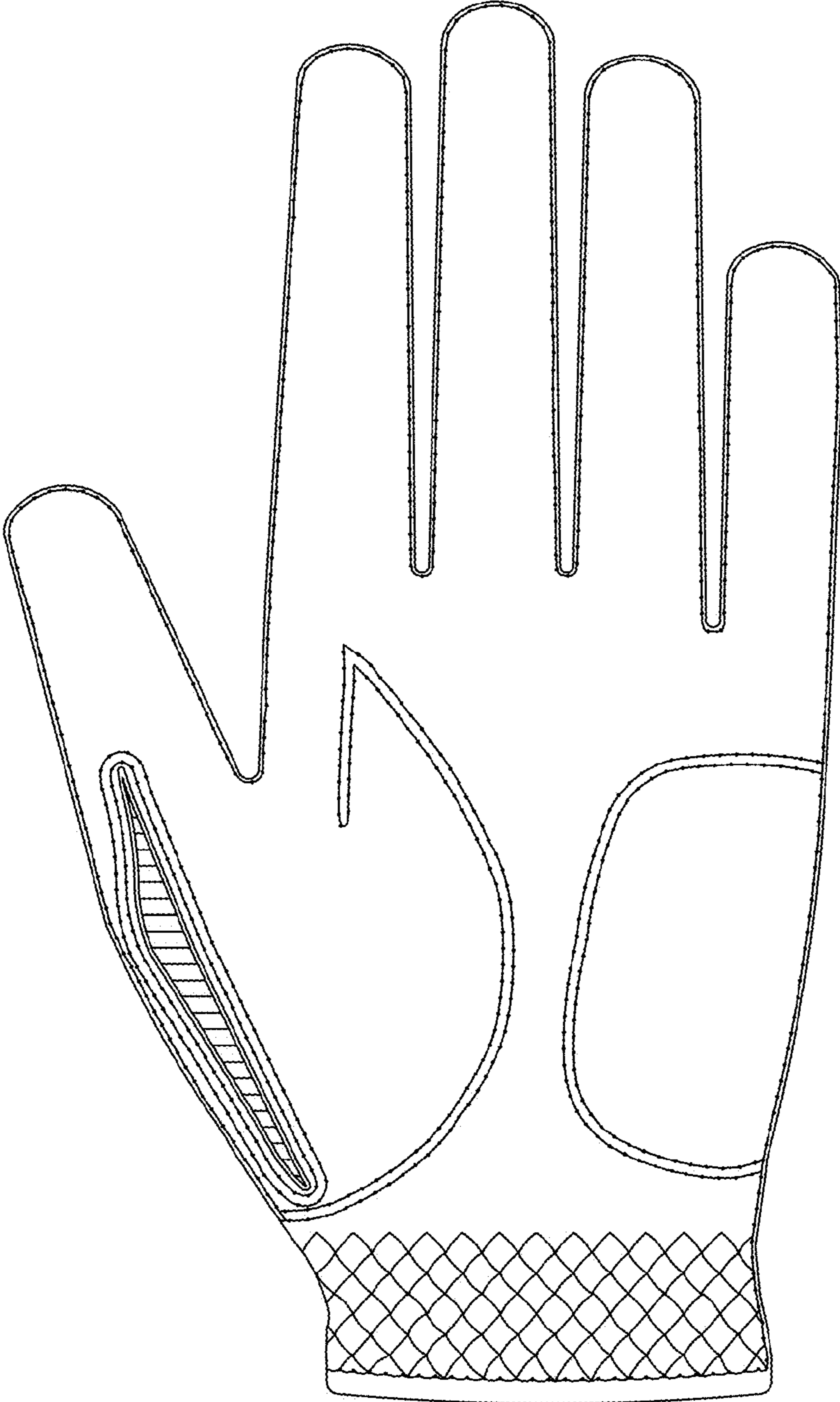

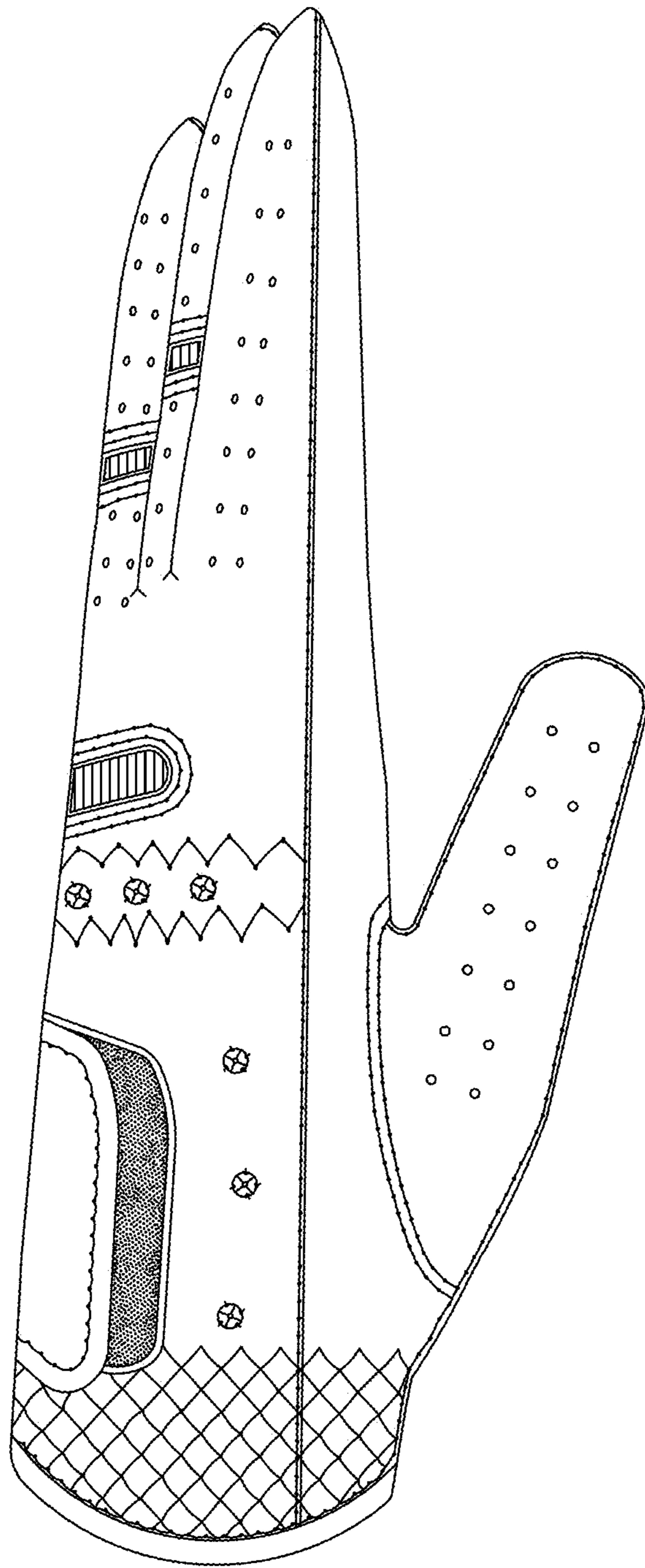

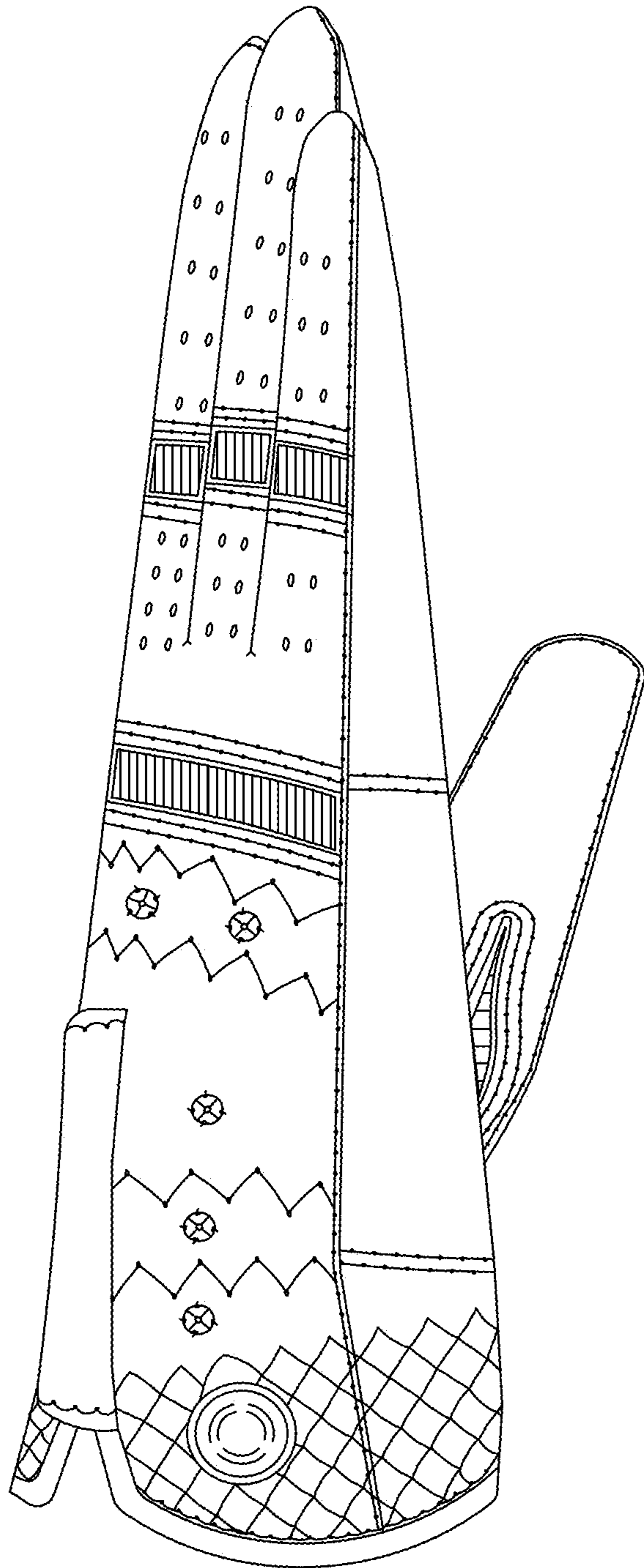

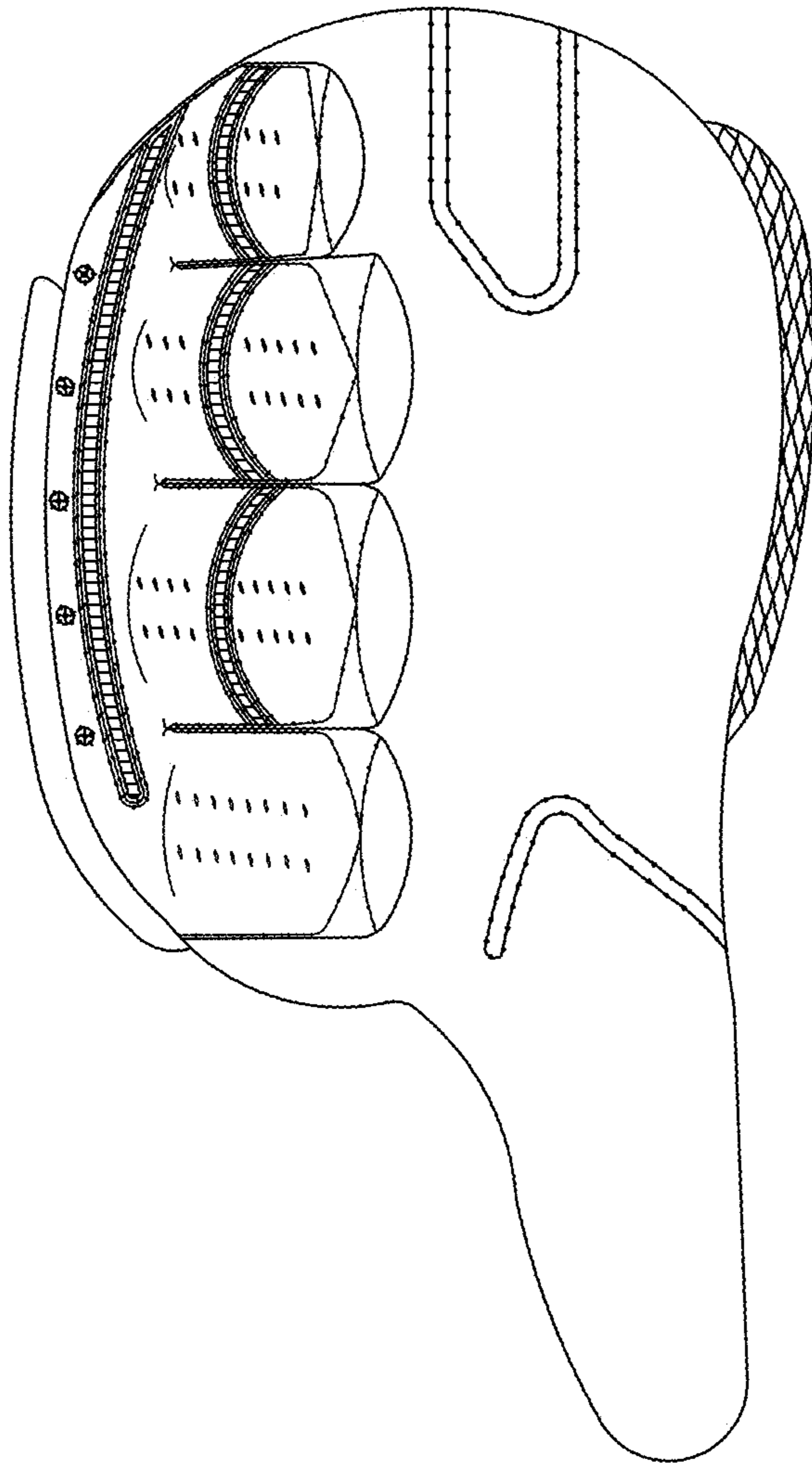

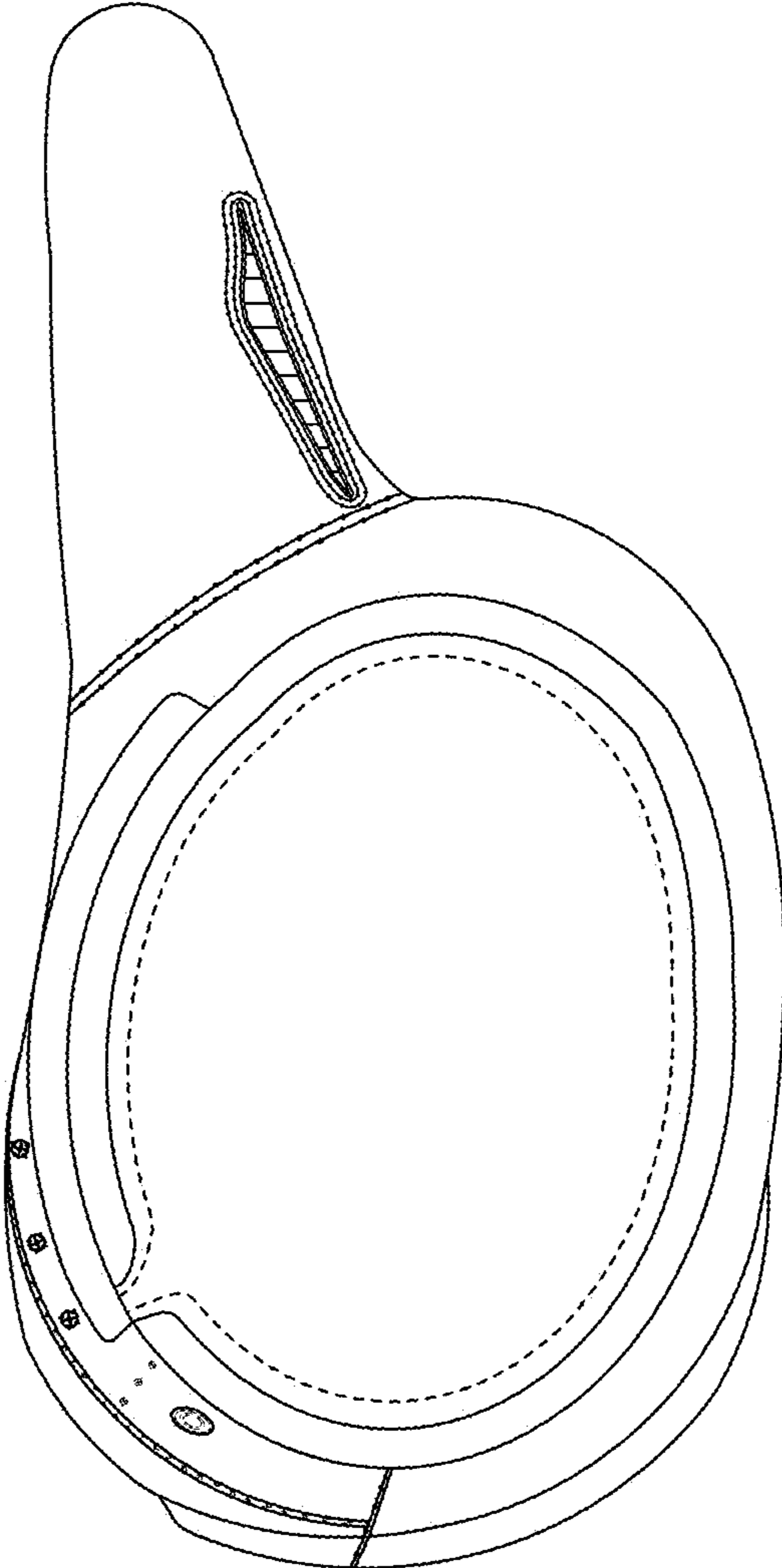
