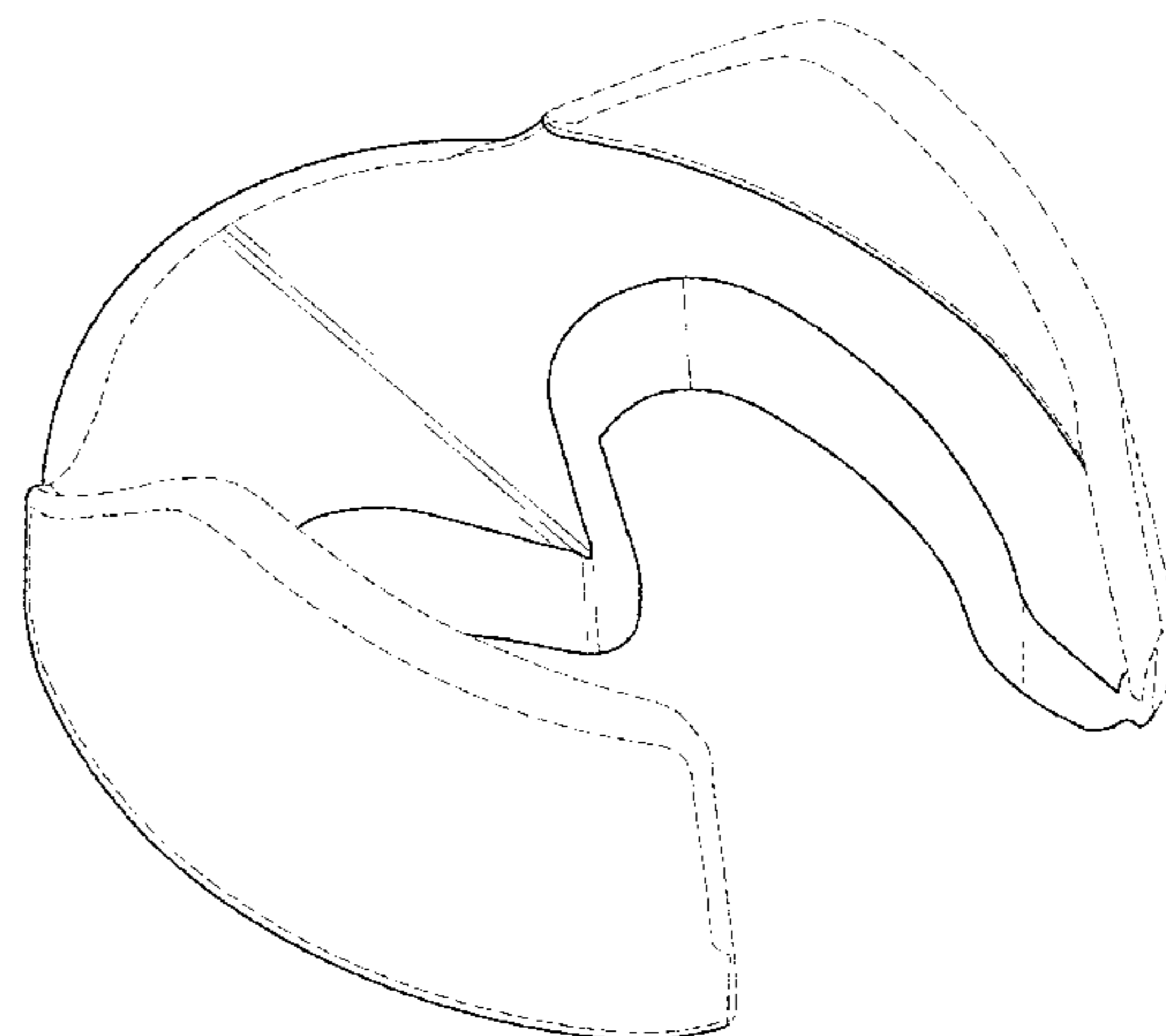
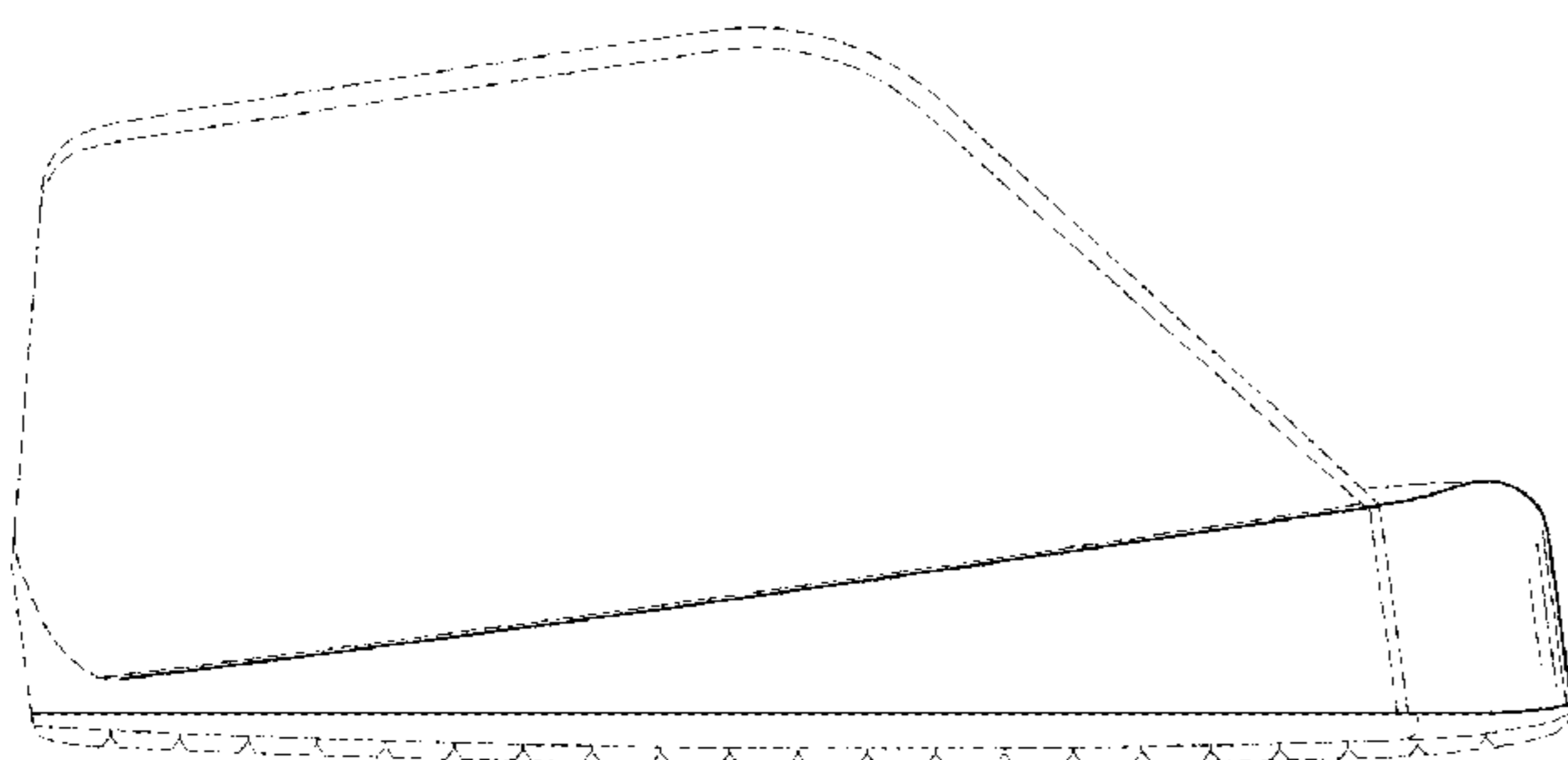
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a bottom view of a horse orthotic configured in accordance with the present invention;  
FIG. 2 is a side view thereof;  
FIG. 3 is a perspective view thereof;  
FIG. 4 is a top view thereof;  
FIG. 5 is a front view thereof; and,  
FIG. 6 is a back view thereof.

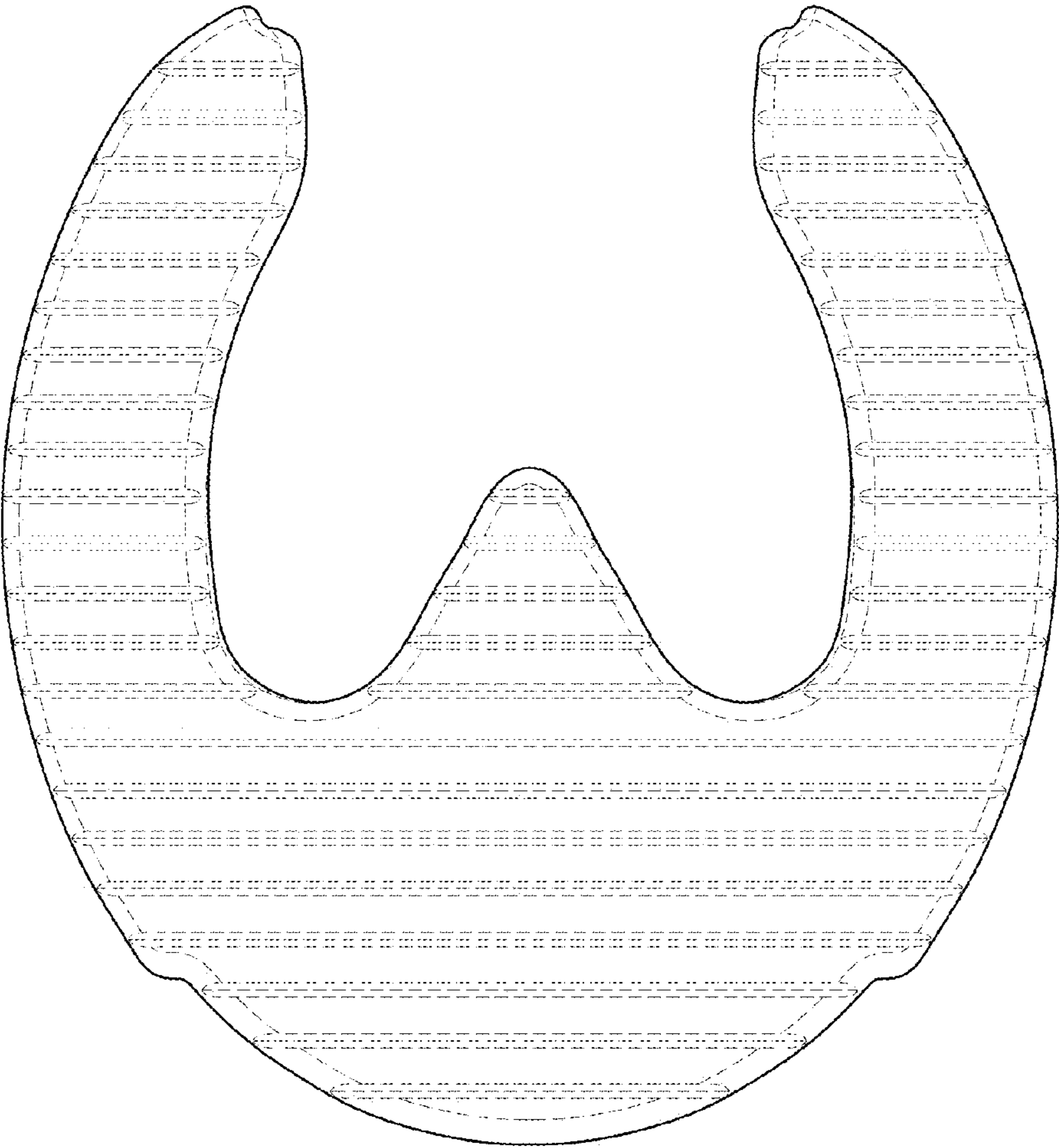

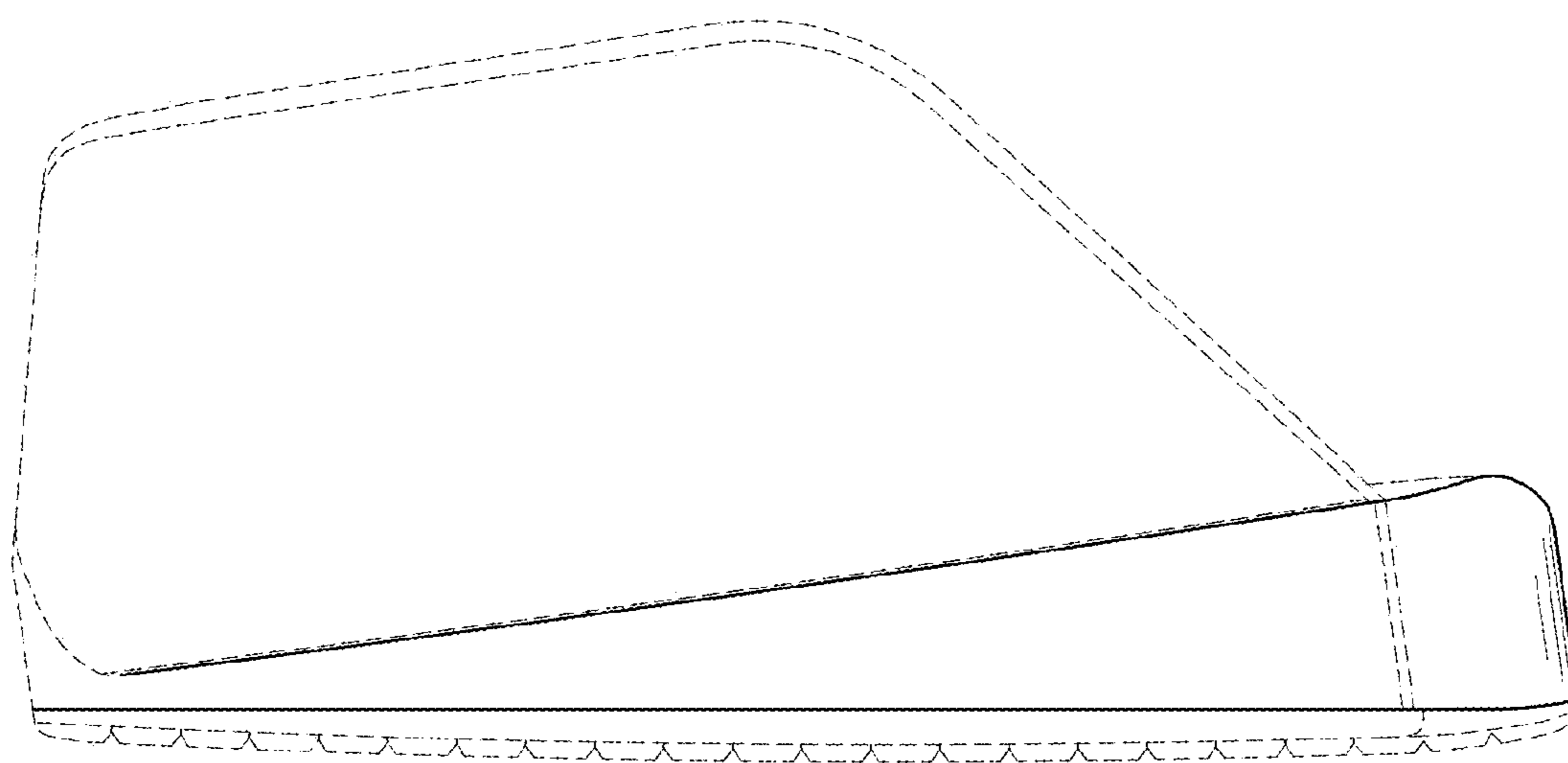

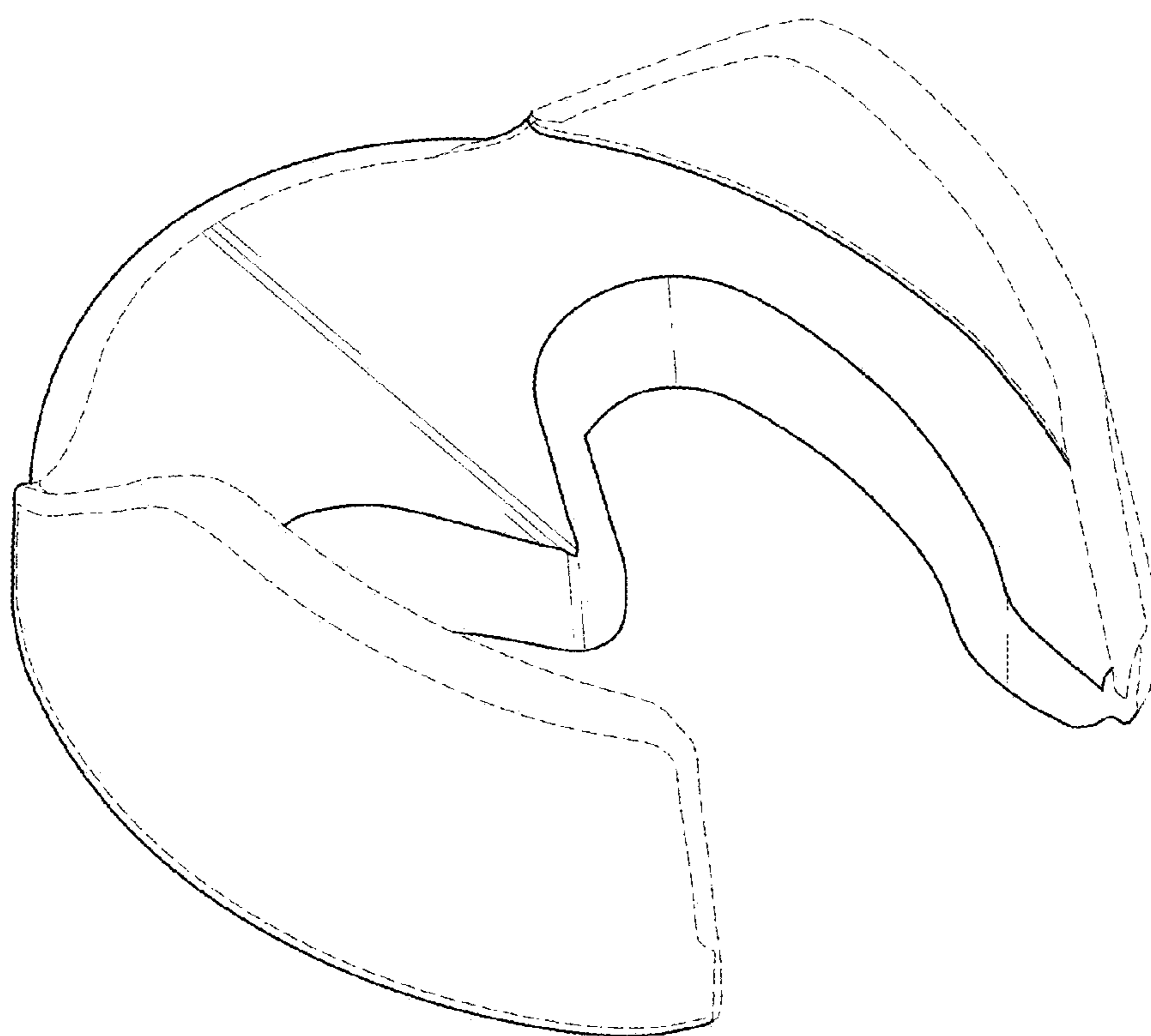

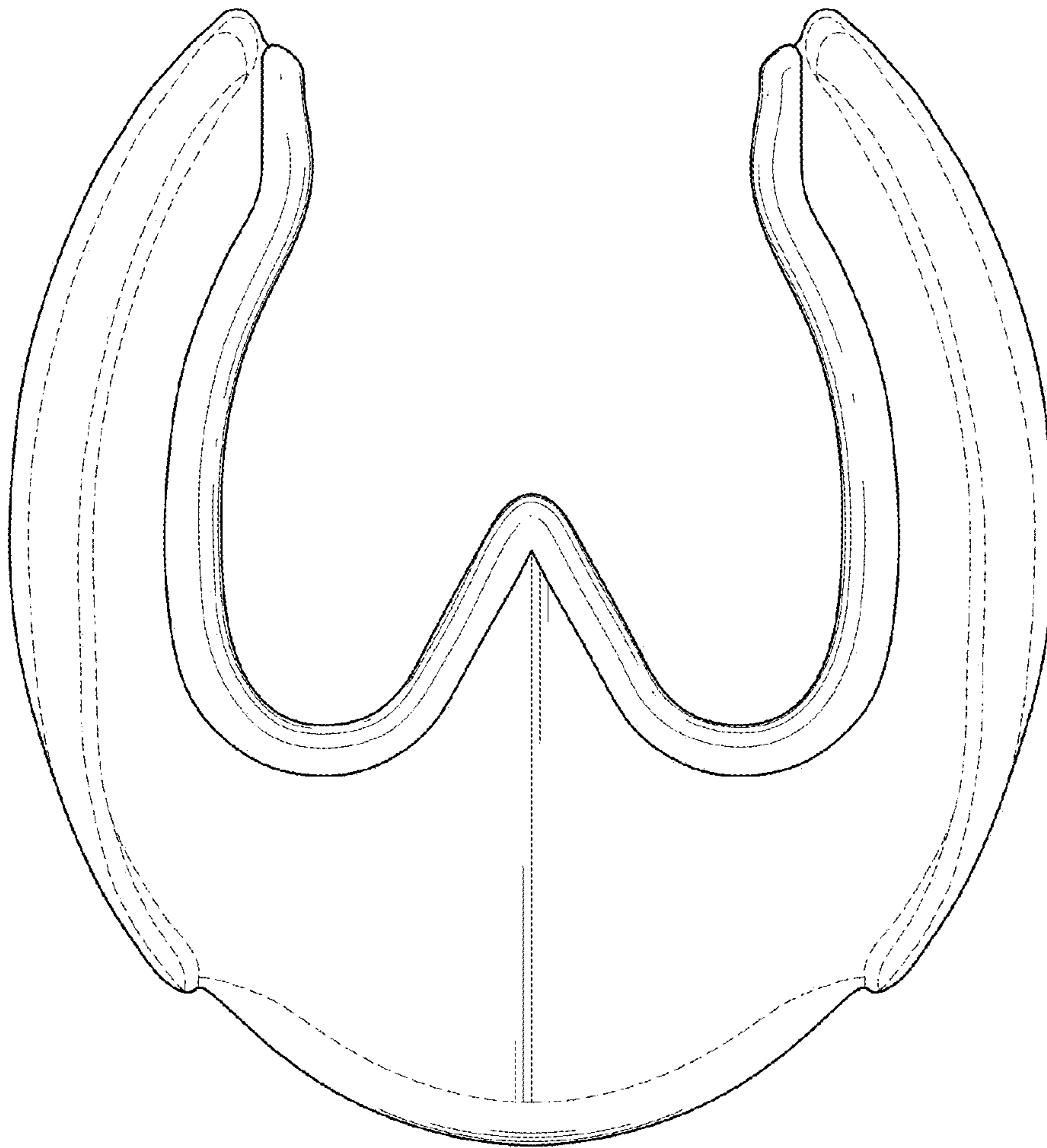

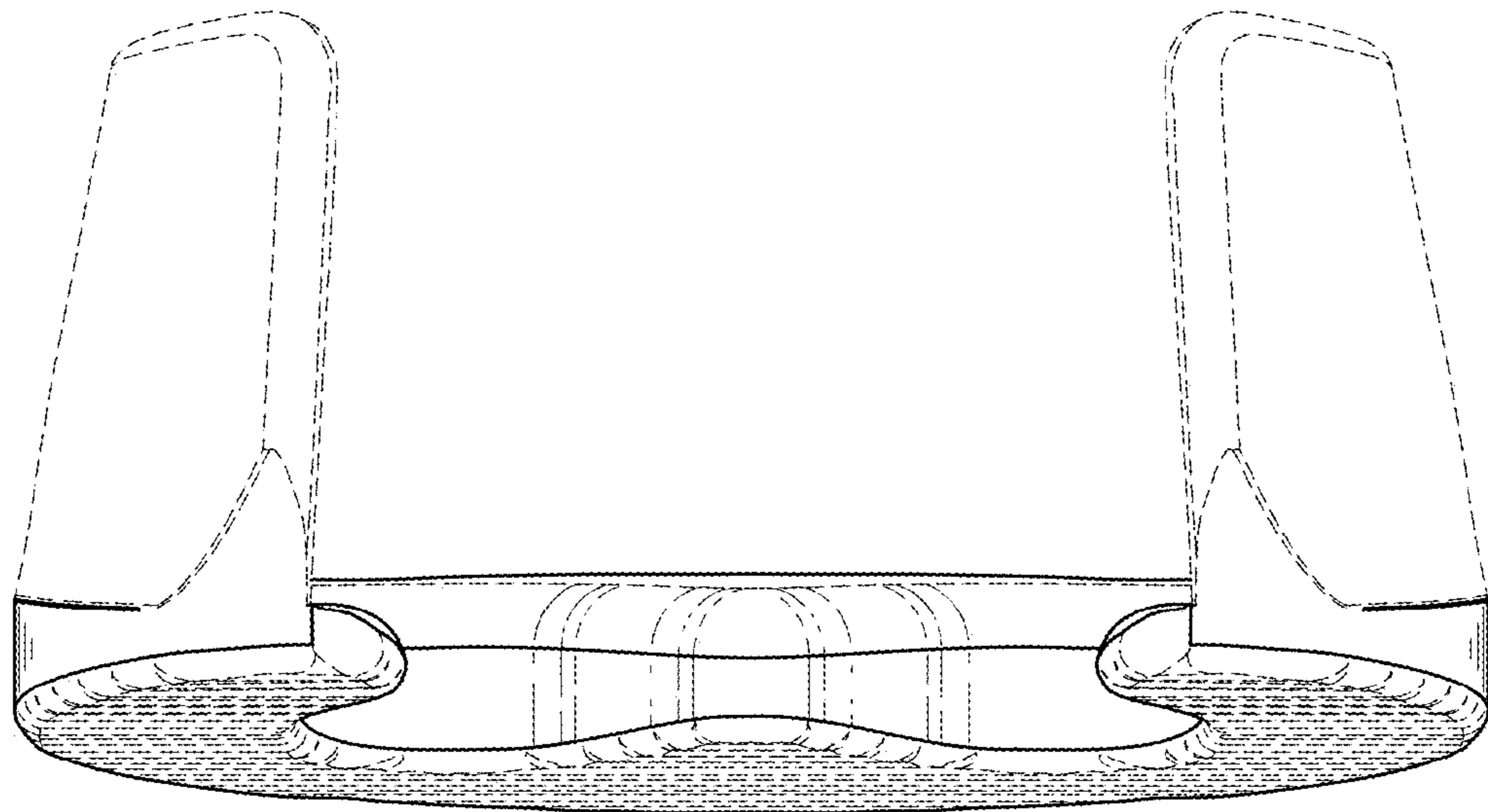

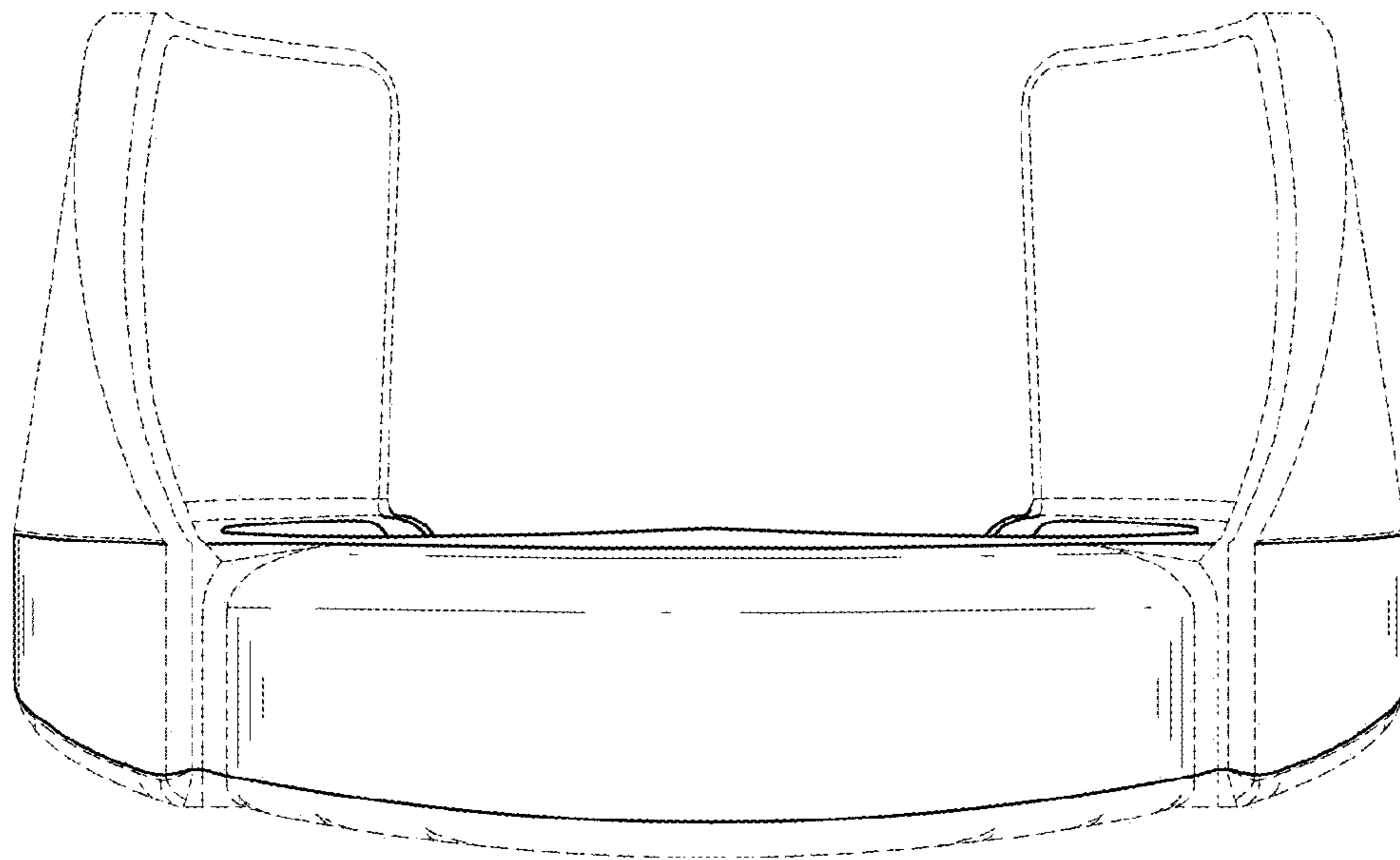
