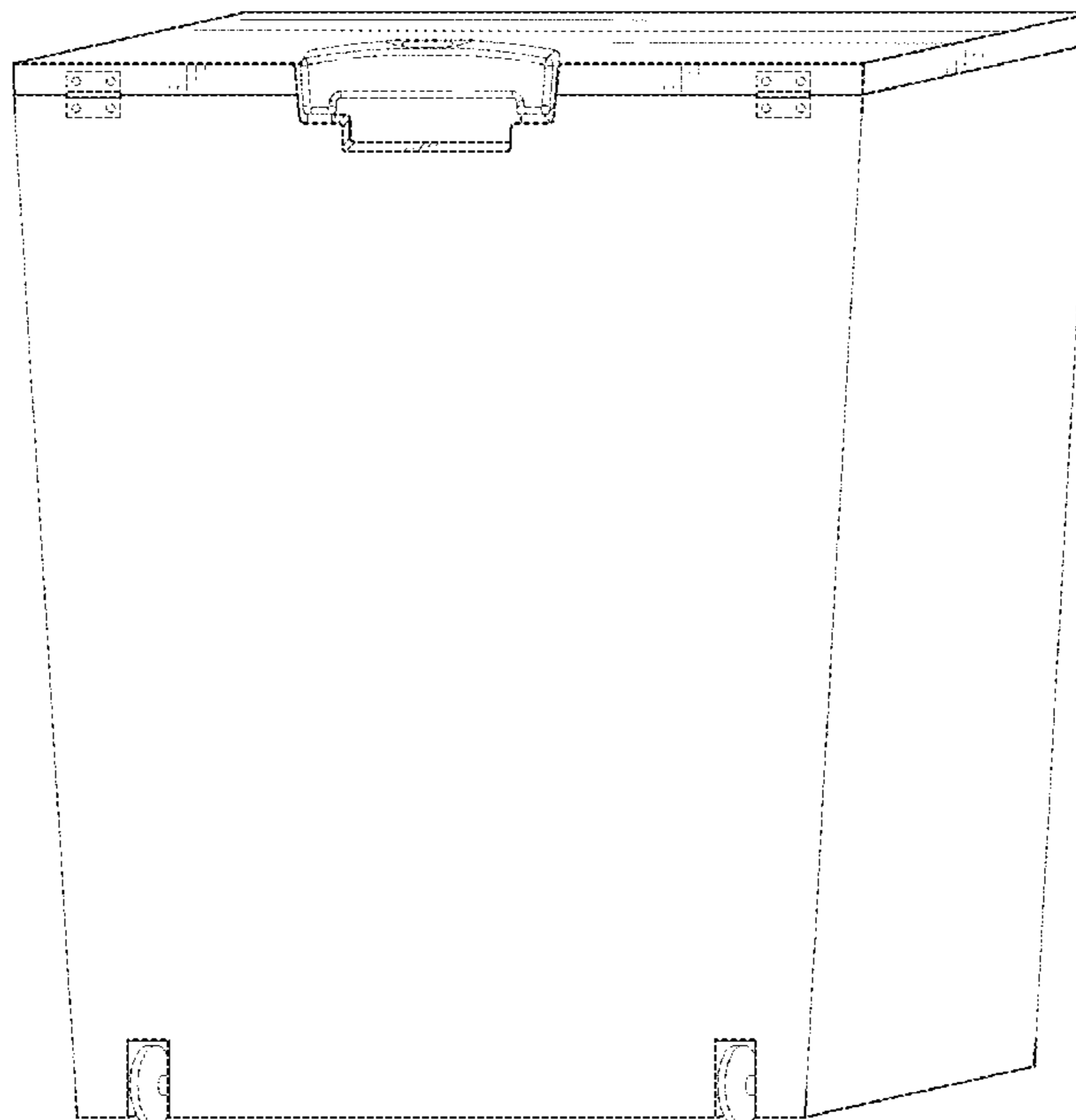
(57) **CLAIM**  
The ornamental design for the portable clothes hamper, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the portable clothes hamper showing my new design;  
FIG. 2 is a perspective top view of the portable clothes hamper showing the lid in an open position;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a front view thereof;  
FIG. 5 is a top view thereof;  
FIG. 6 is a bottom view thereof;  
FIG. 7 is a side view thereof; and,  
FIG. 8 is a rear view of the portable clothes hamper showing the telescoping handle in an up position.  
The broken lines in the drawings illustrate portions of the portable clothes hamper which form no part of the claimed design.

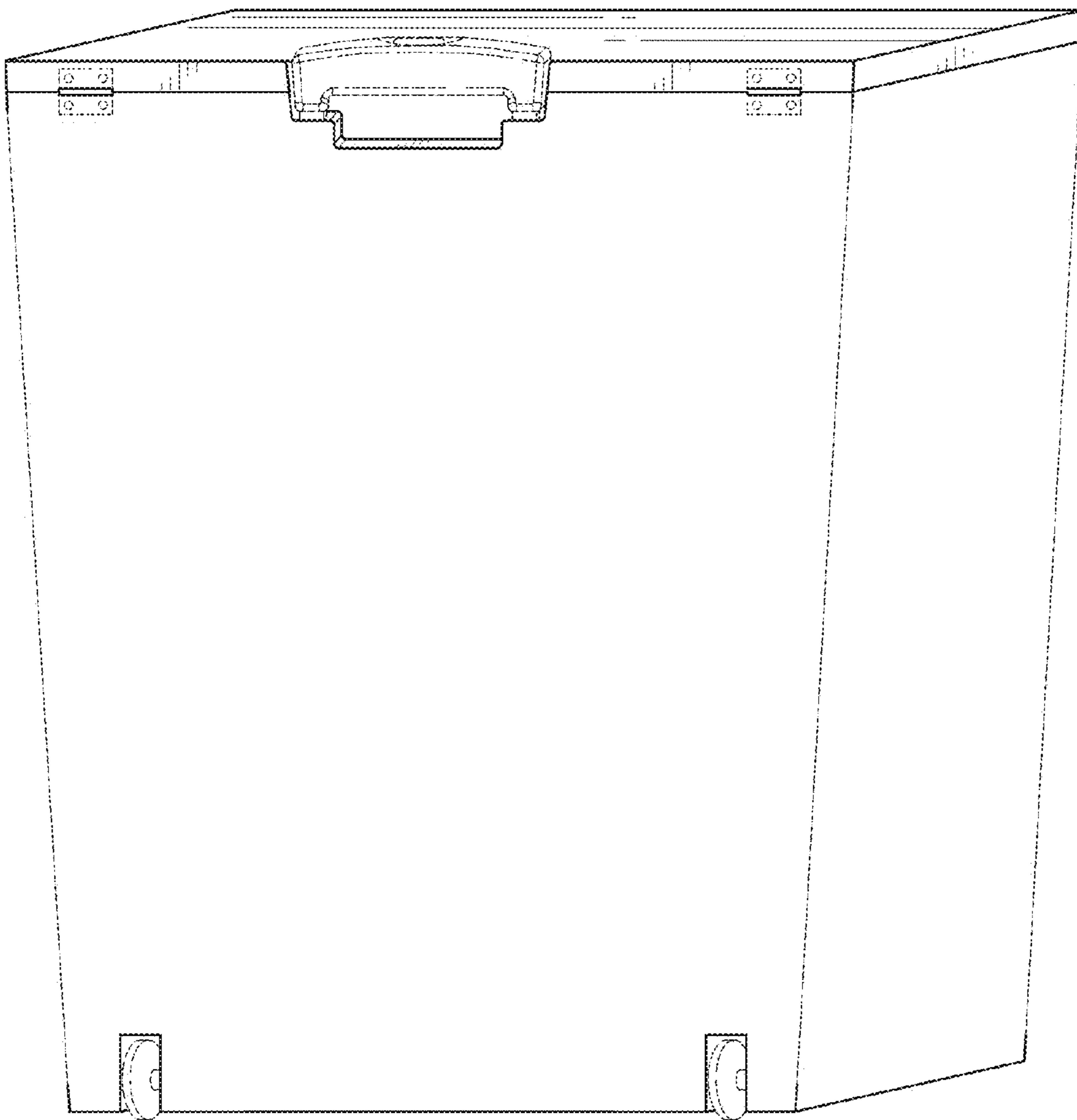

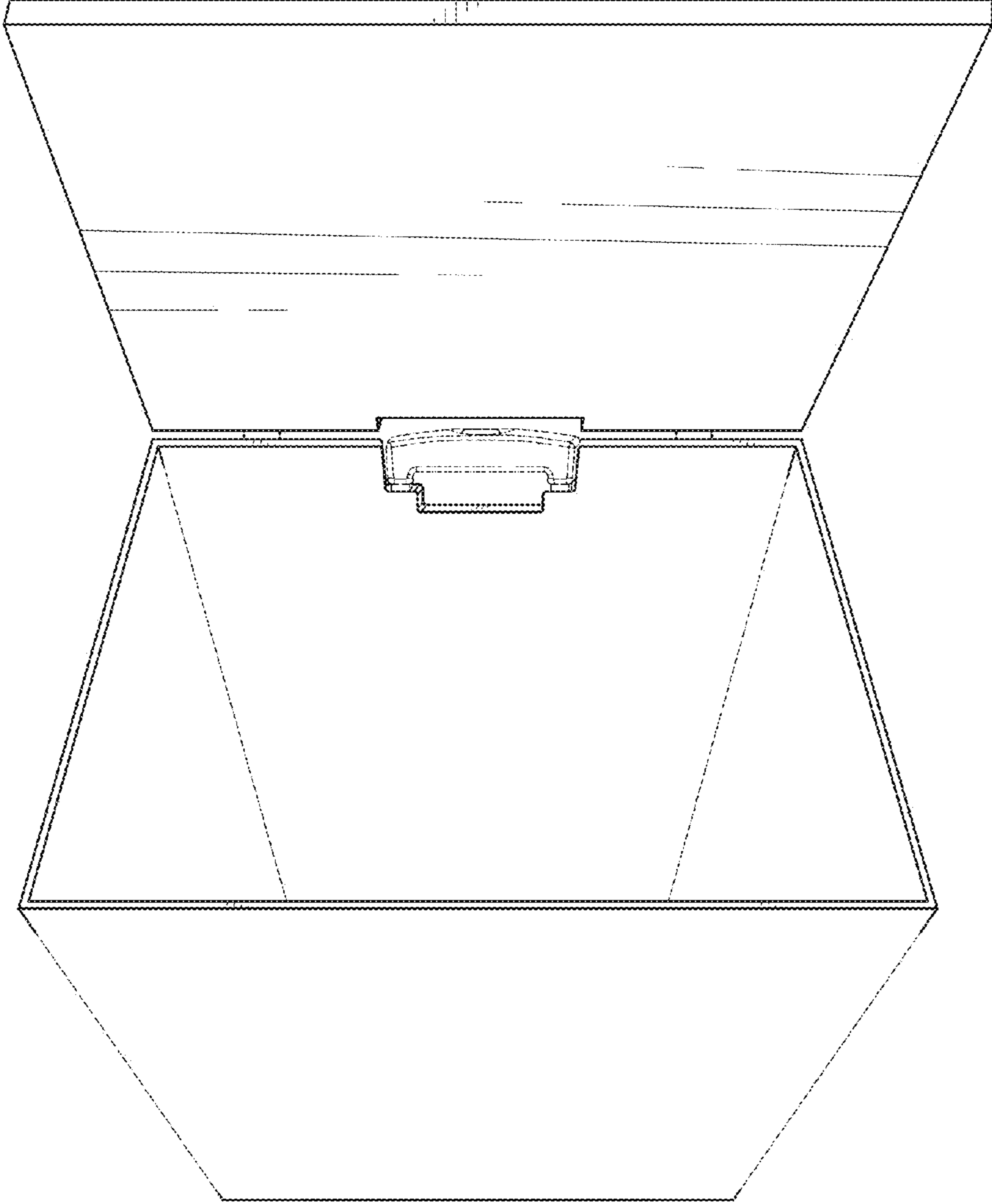

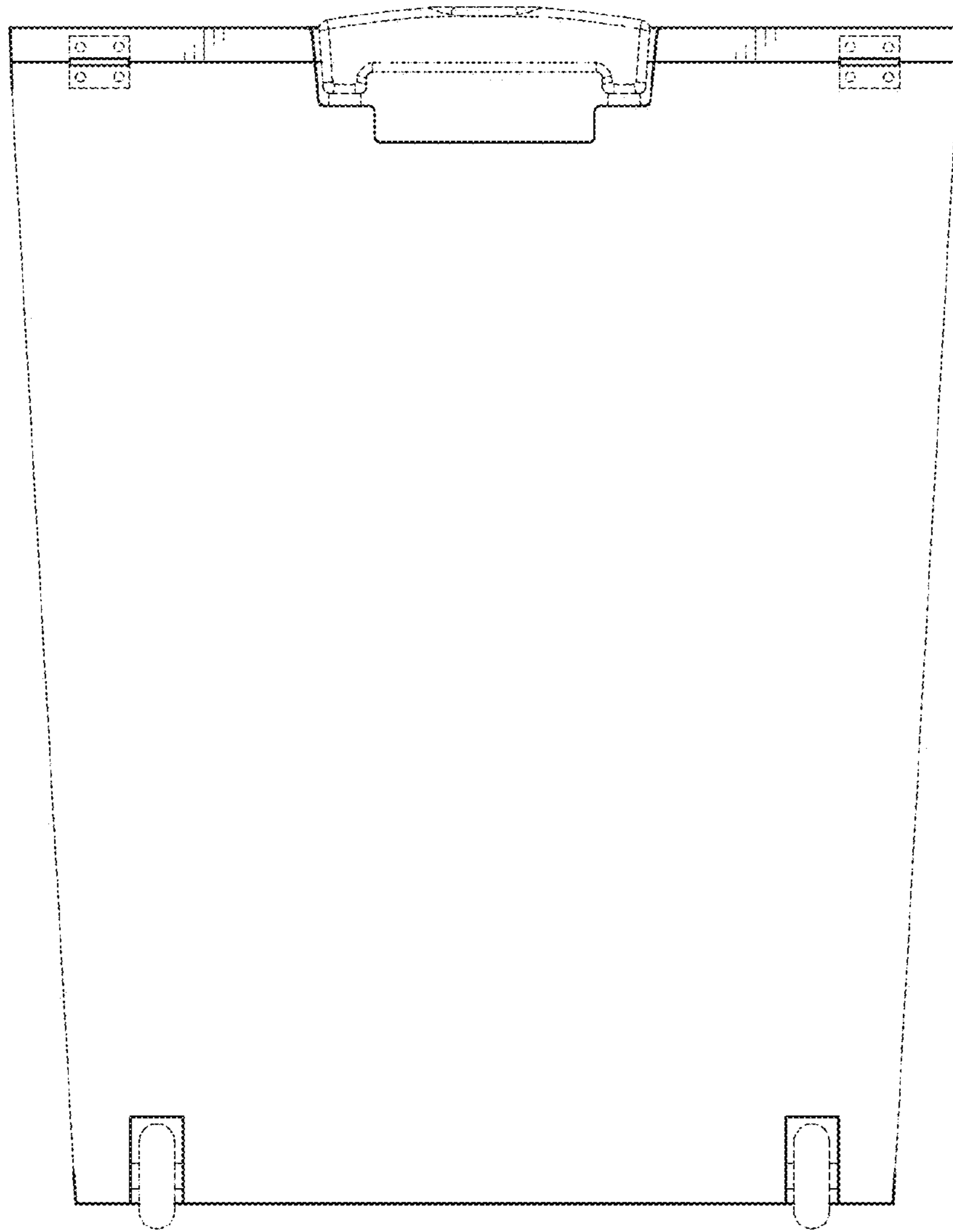

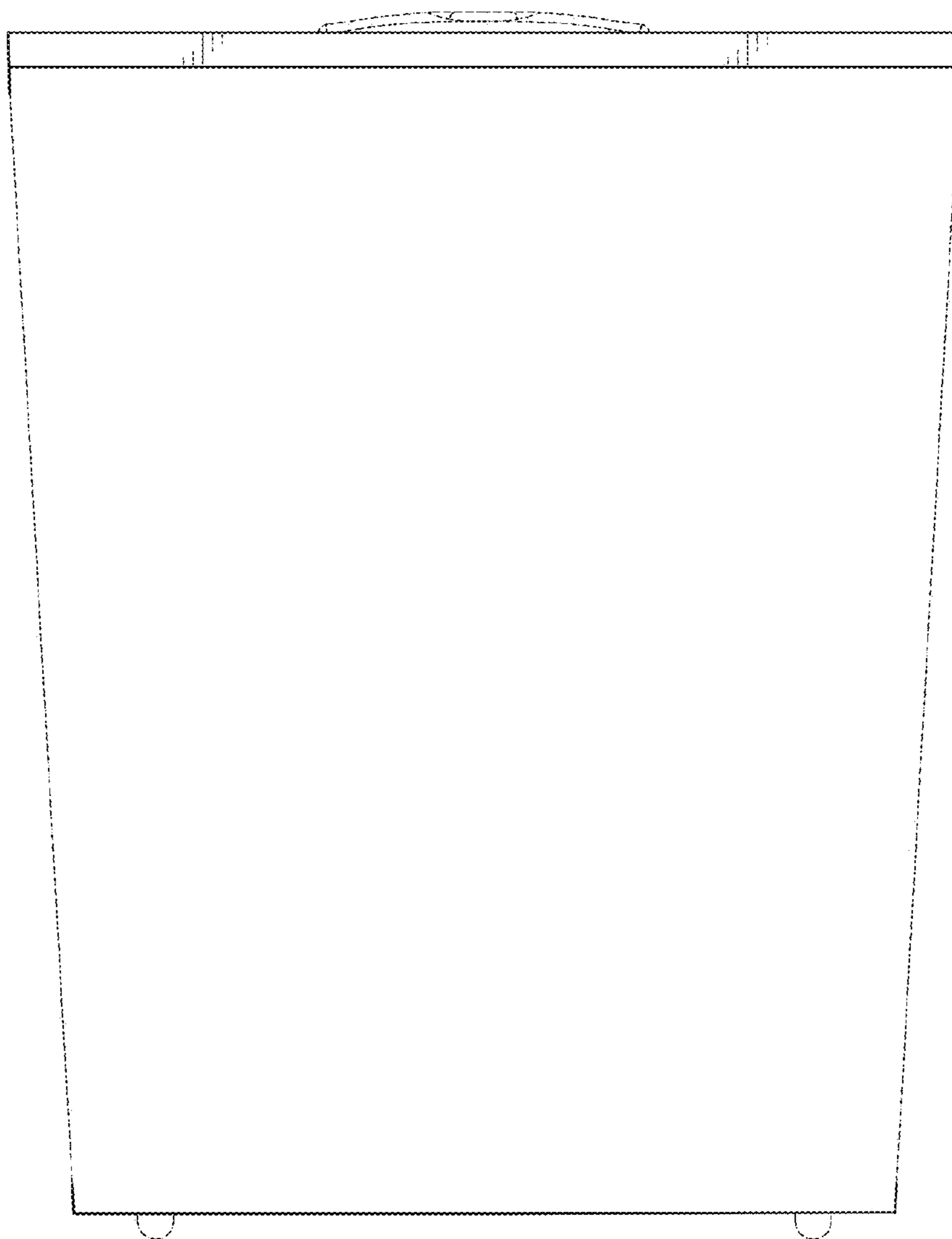

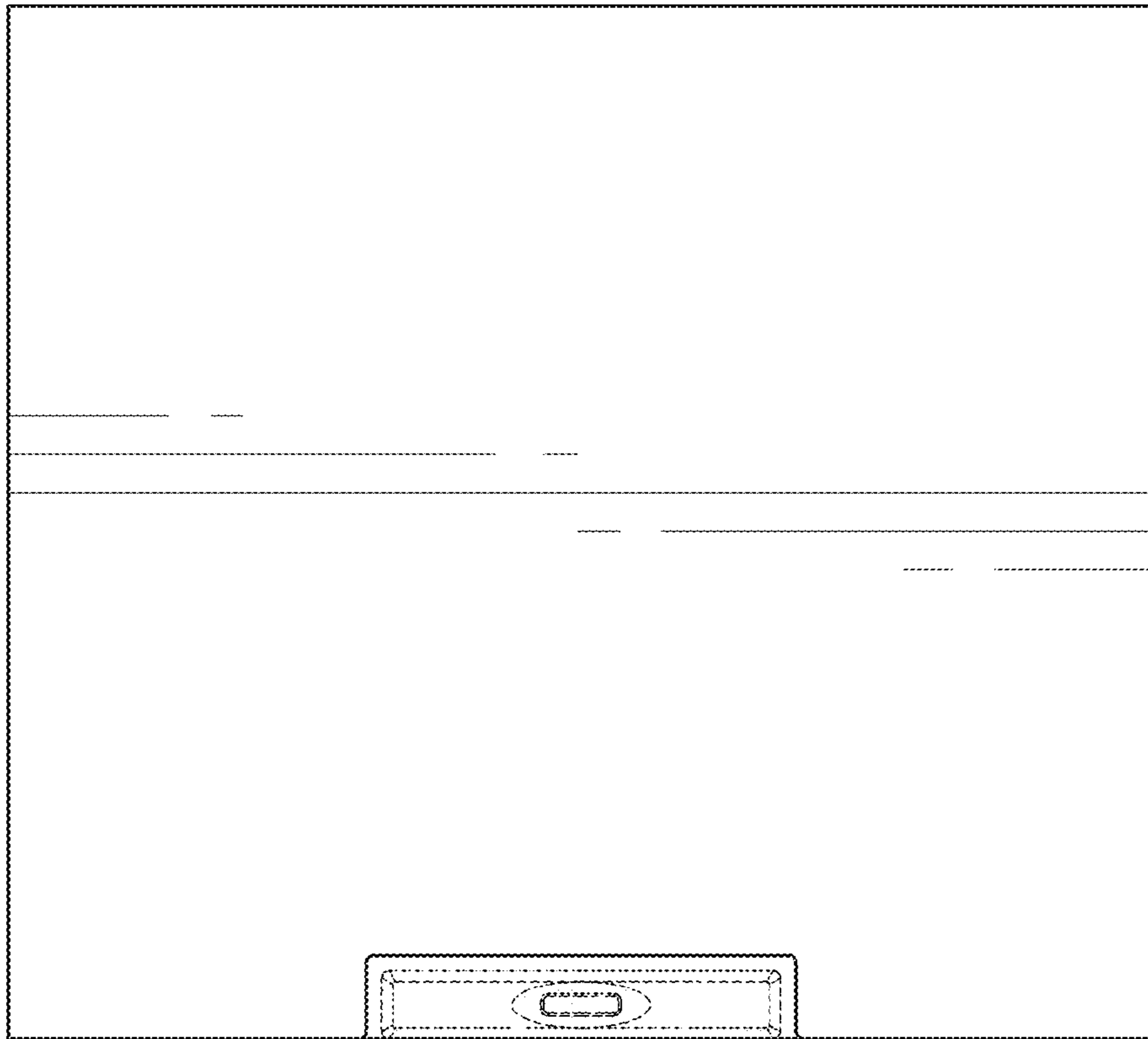

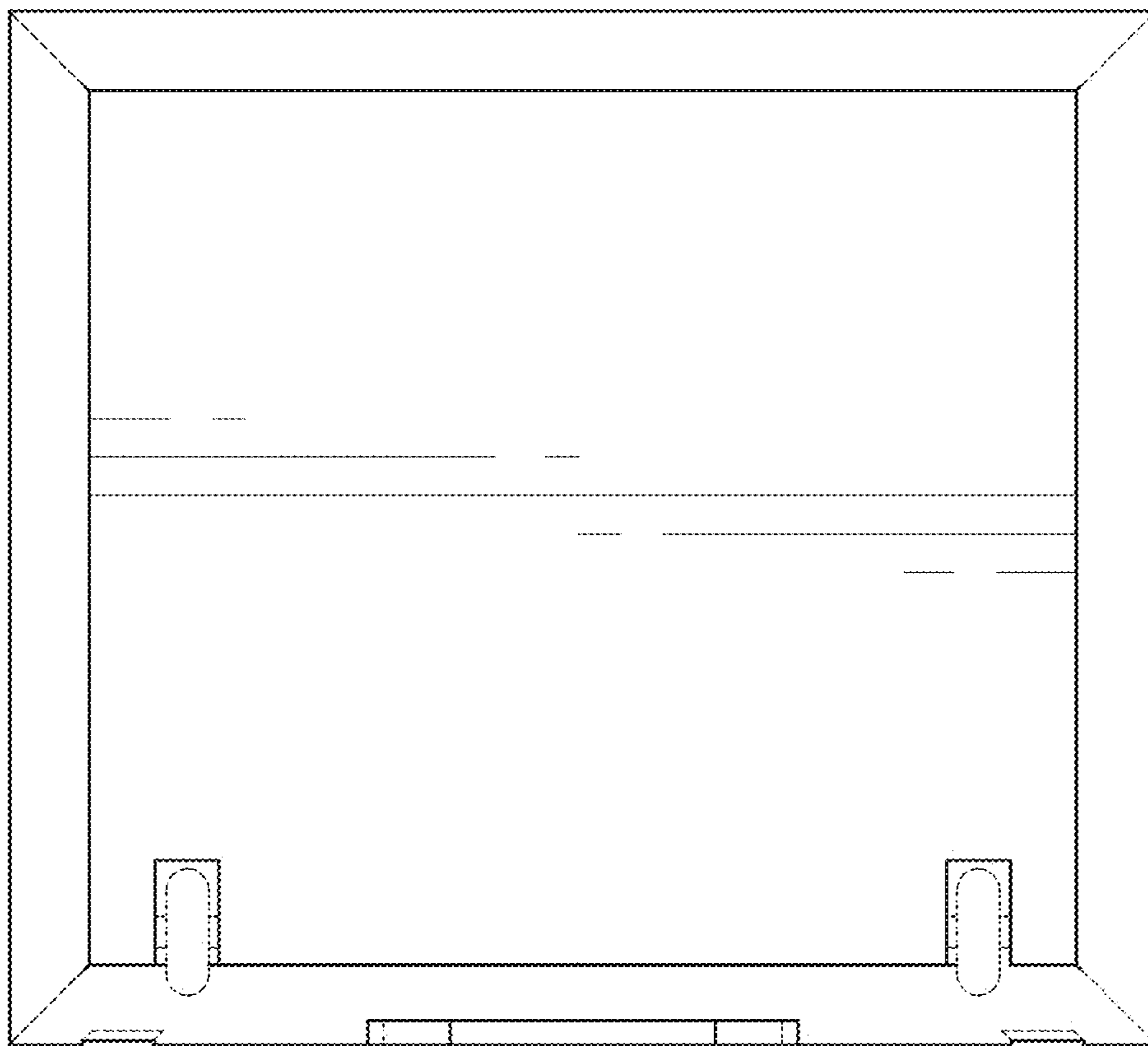

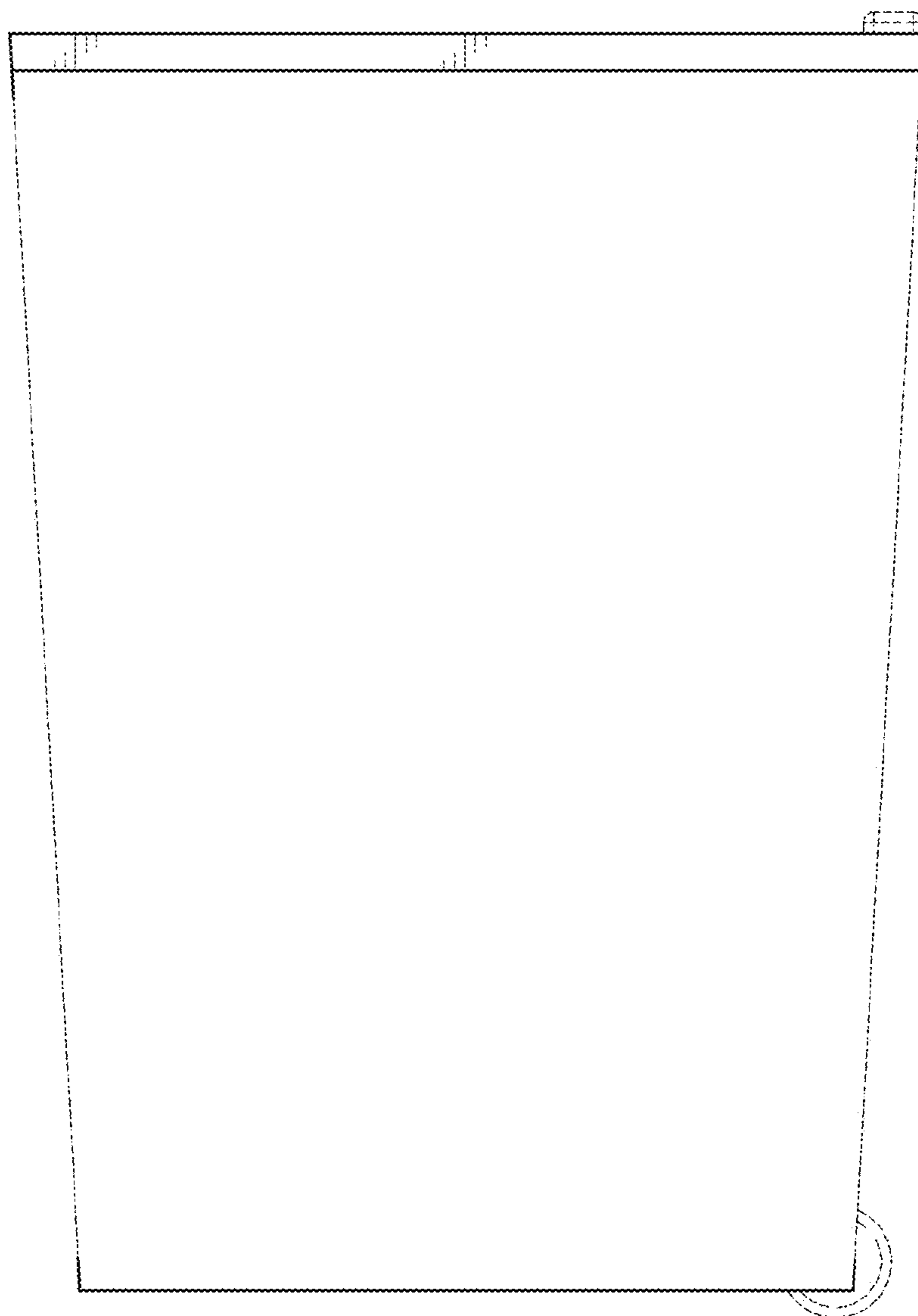

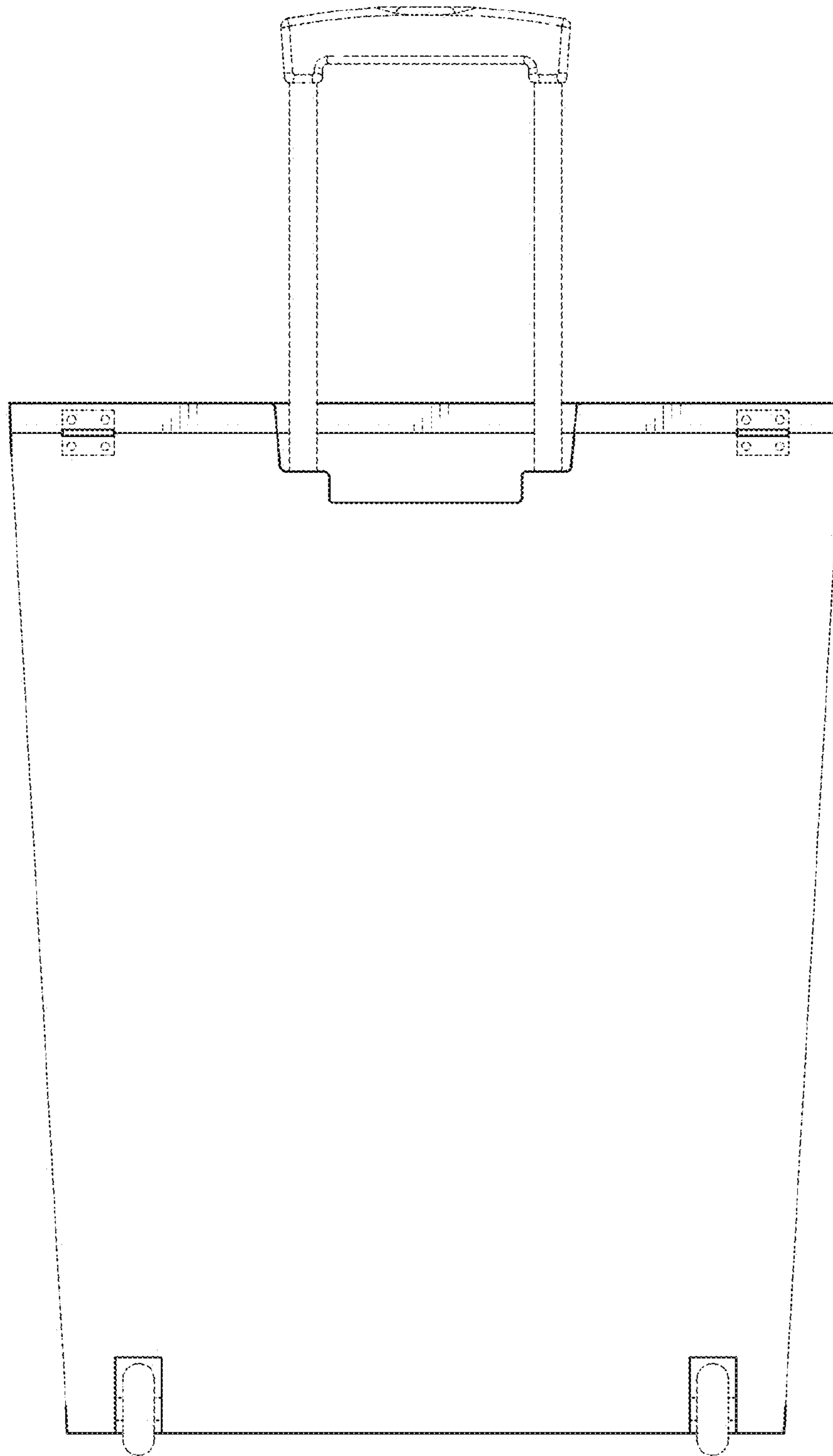
