(57) **CLAIM**

I claim the ornamental design for an apertured shirt collar, as shown and described.

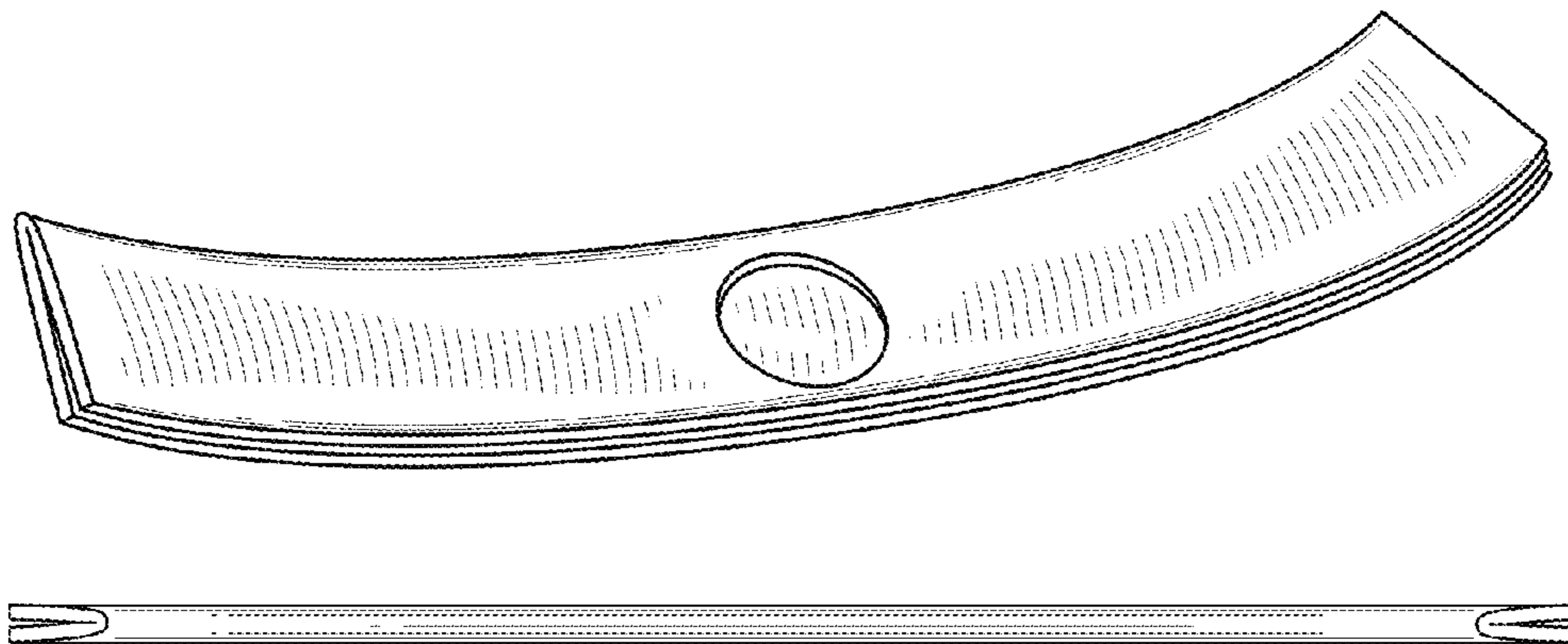
**DESCRIPTION**

FIG. 1 is a rear perspective view of an apertured shirt collar, showing my new design in a worn configuration;  
 FIG. 2 is a rear perspective view thereof, illustrated in a flat configuration, the remainder of the shirt omitted for clarity of illustration;  
 FIG. 3 is a rear elevational view of FIG. 2;  
 FIG. 4 is a front elevational view of FIG. 2;  
 FIG. 5 is a right-side elevational view of FIG. 2, the left-side elevational view being a mirror image thereof;  
 FIG. 6 is a top plan view of FIG. 2; and,  
 FIG. 7 is a bottom plan view of FIG. 2.  
 The broken lines showing a person and remainder of a shirt in FIG. 1 depict environmental matter and form no part of the claimed design.

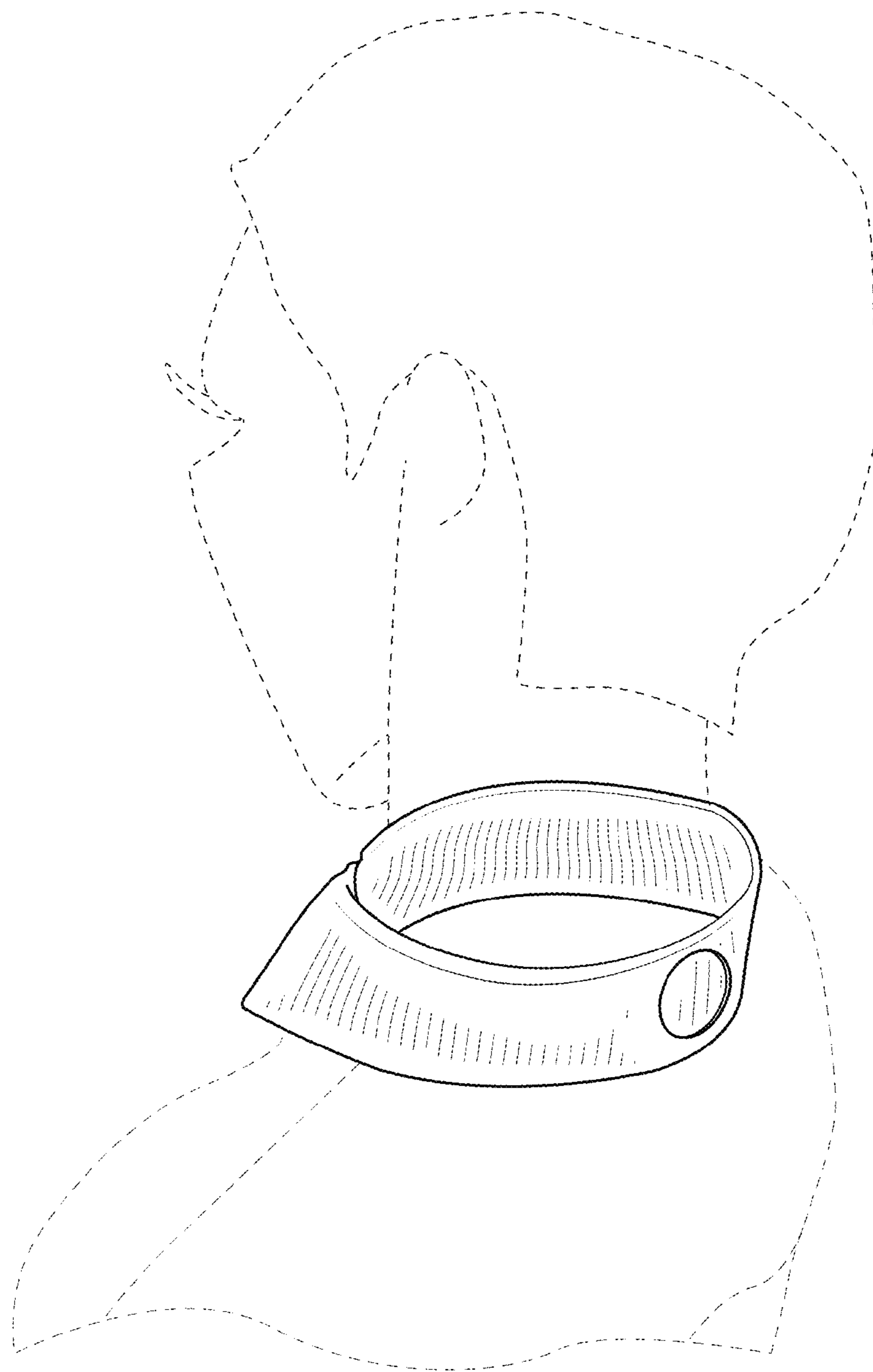

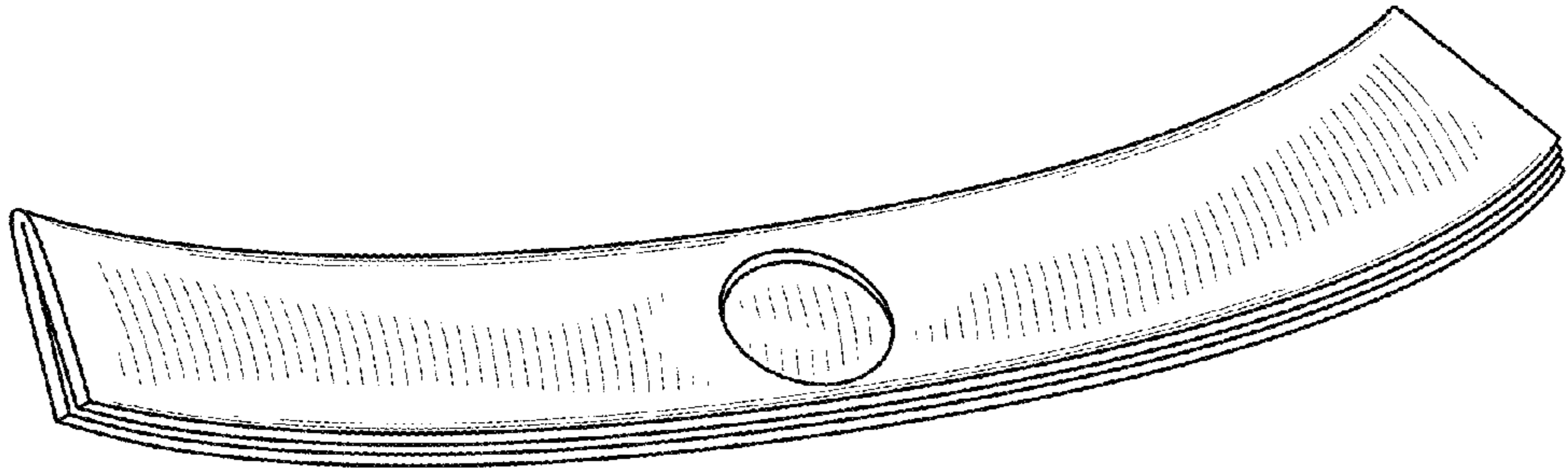

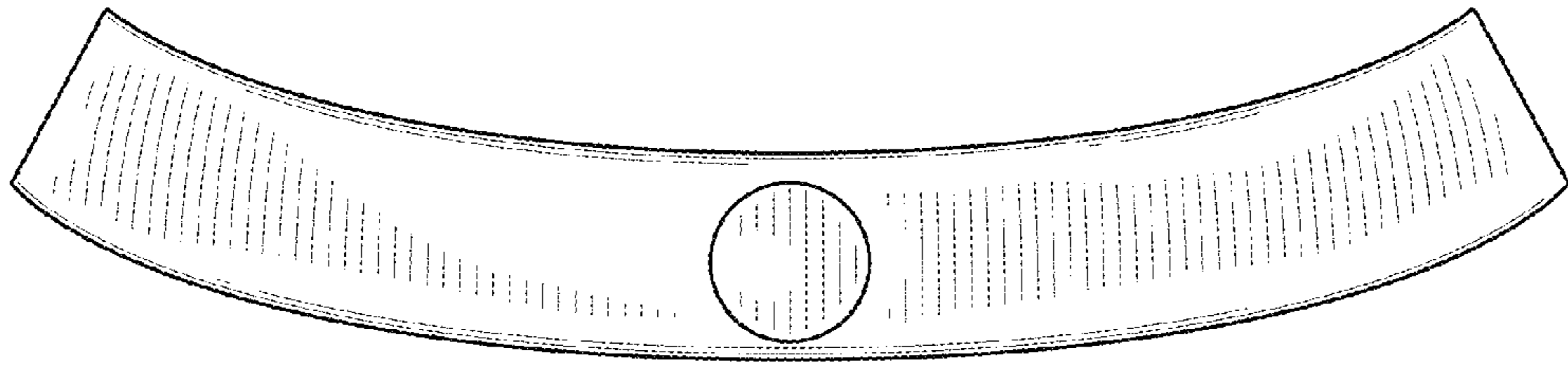

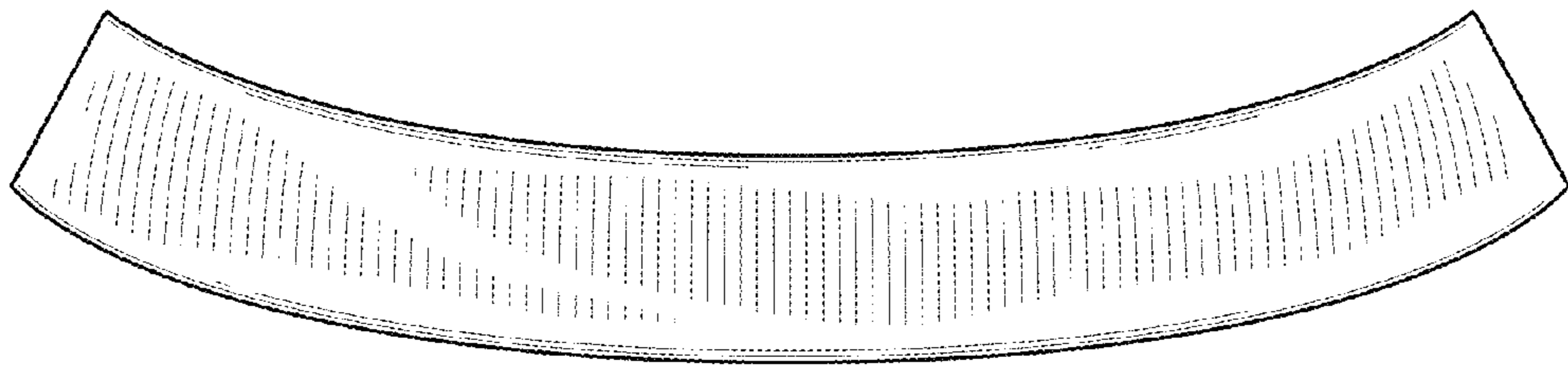

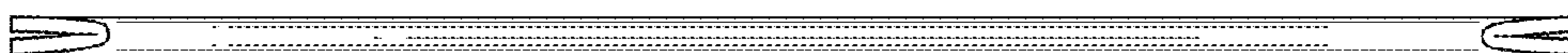

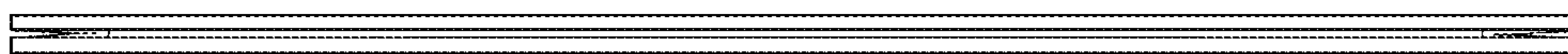
