(57) **CLAIM**

I claim the ornamental design for a glove, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a glove.
FIG. 2 is a top plan view of the glove shown in FIG. 1.
FIG. 3 is a bottom plan view of the glove shown in FIG. 1.
FIG. 4 is a left side elevation view of the glove shown in FIG. 1.
FIG. 5 is a right side elevation view of the glove shown in FIG. 1.
FIG. 6 is a front elevation view of the glove shown in FIG. 1; and,
FIG. 7 is a rear elevation view of the glove shown in FIG. 1.

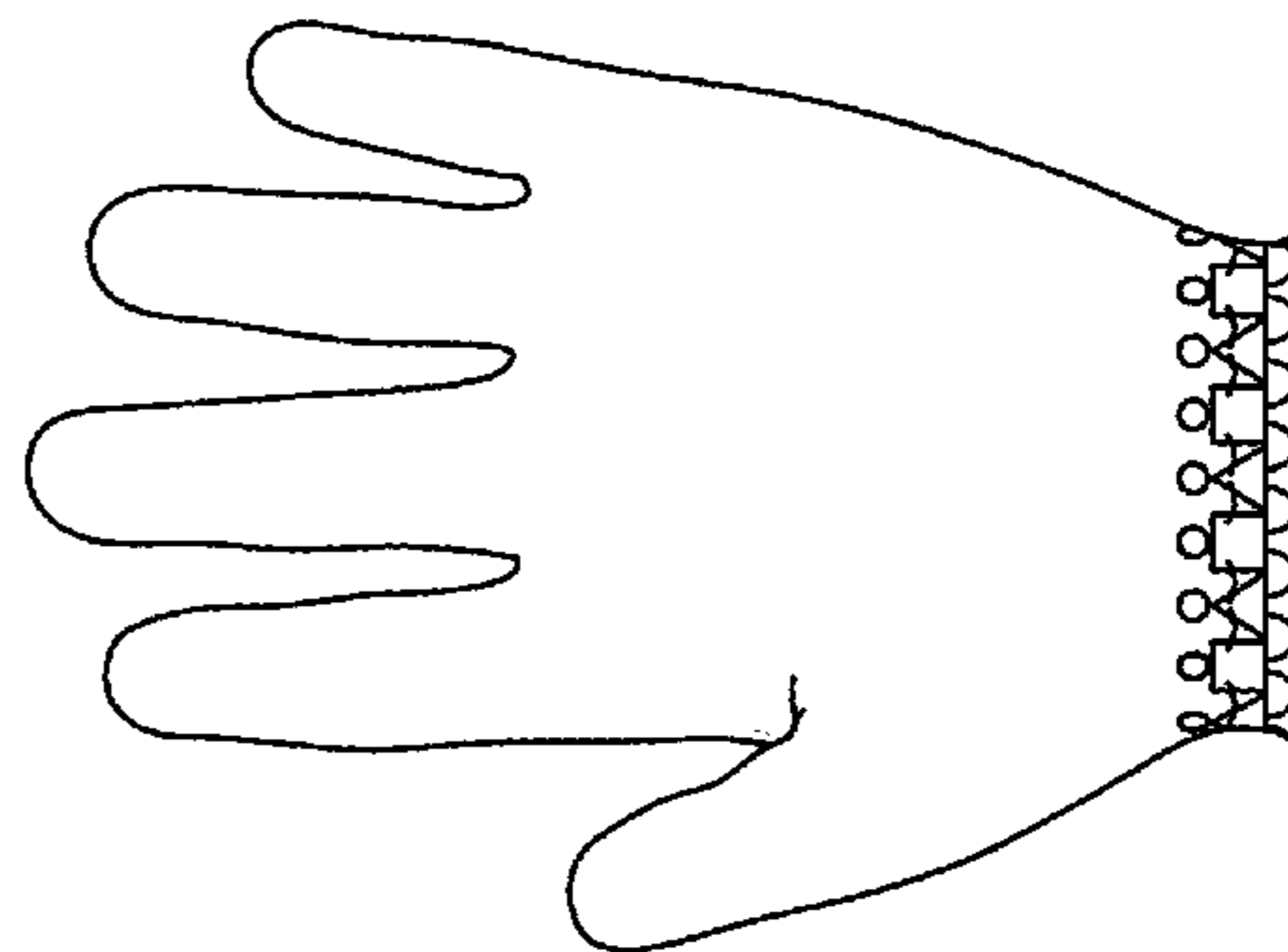

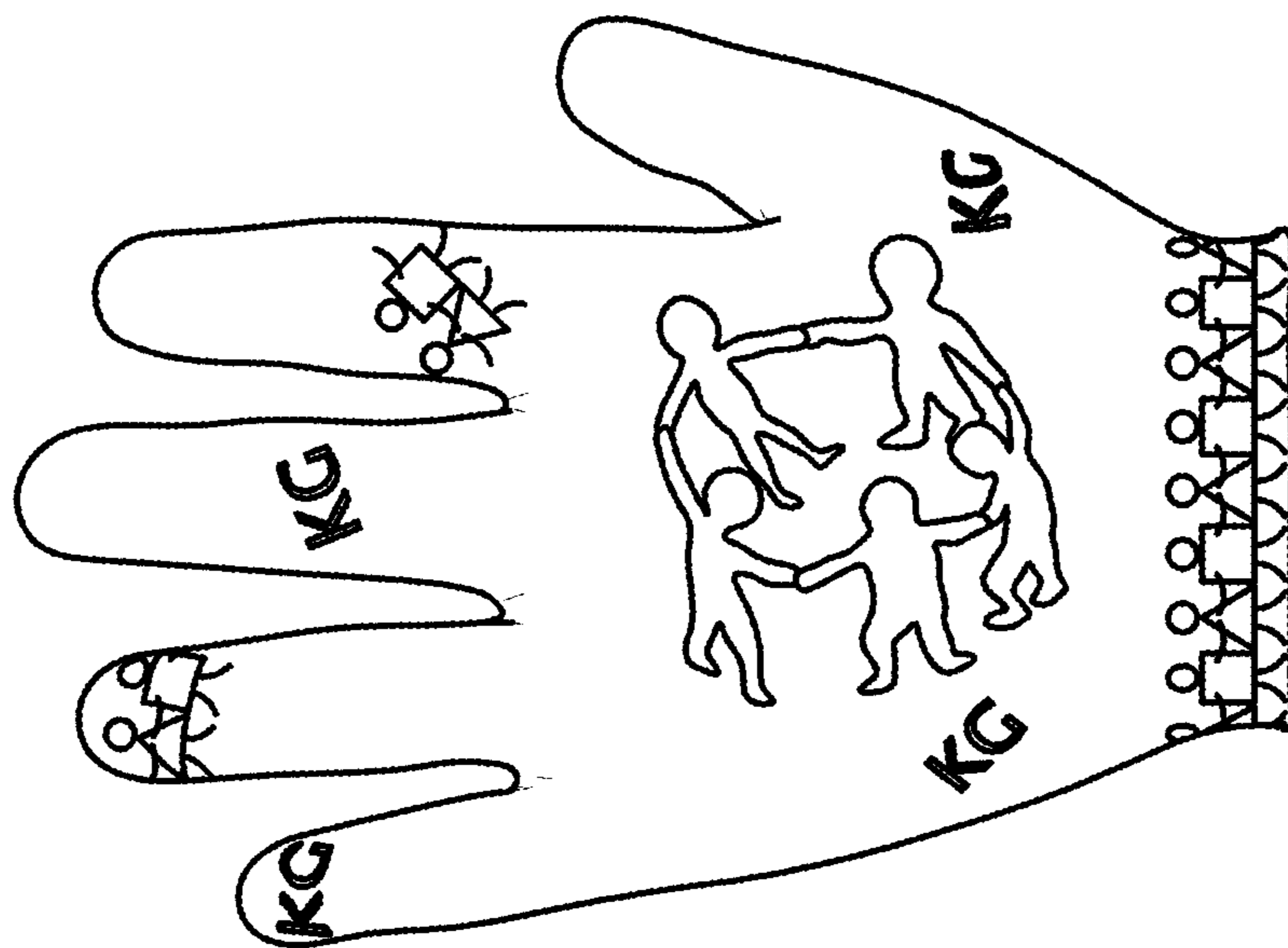

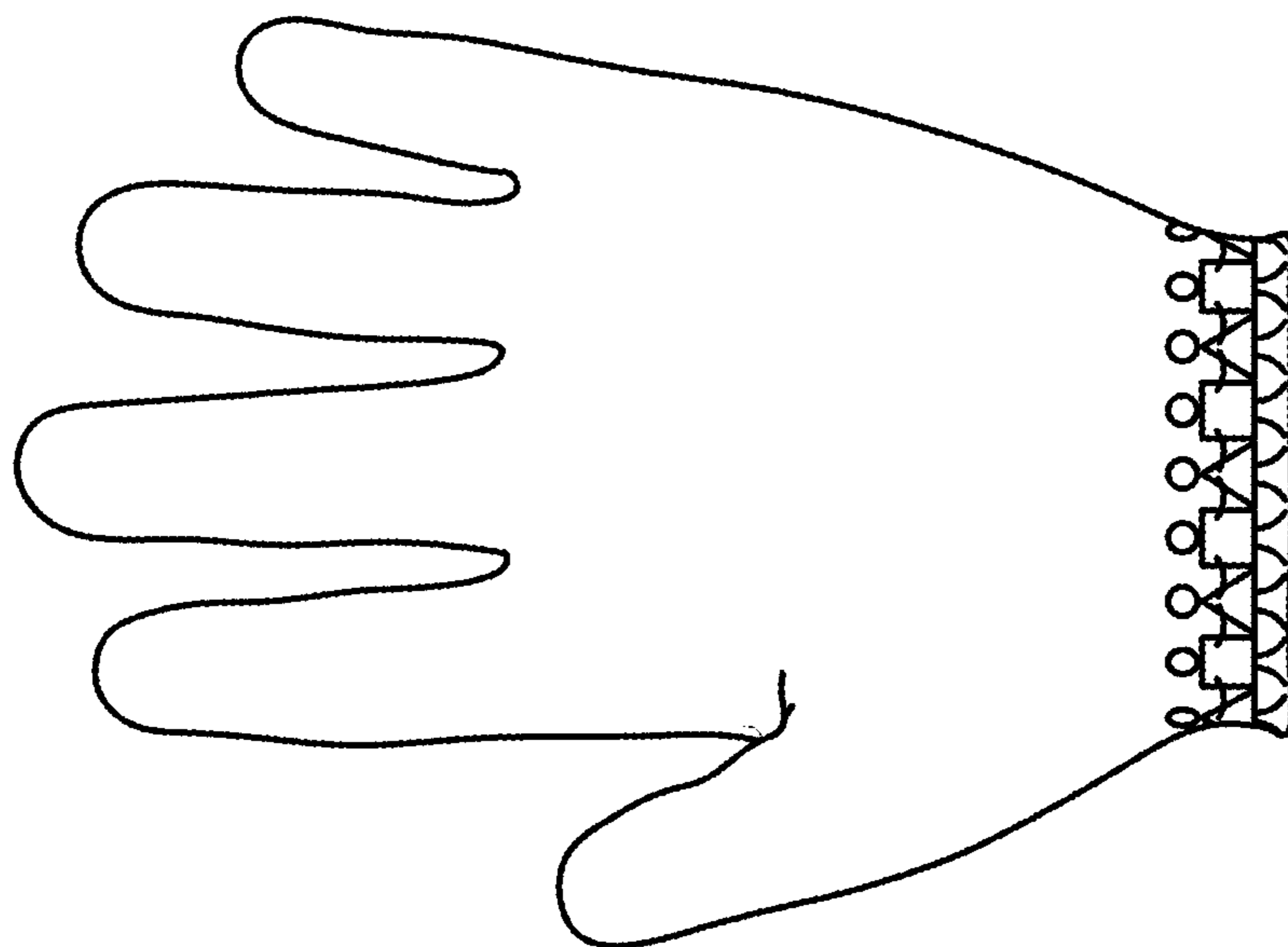

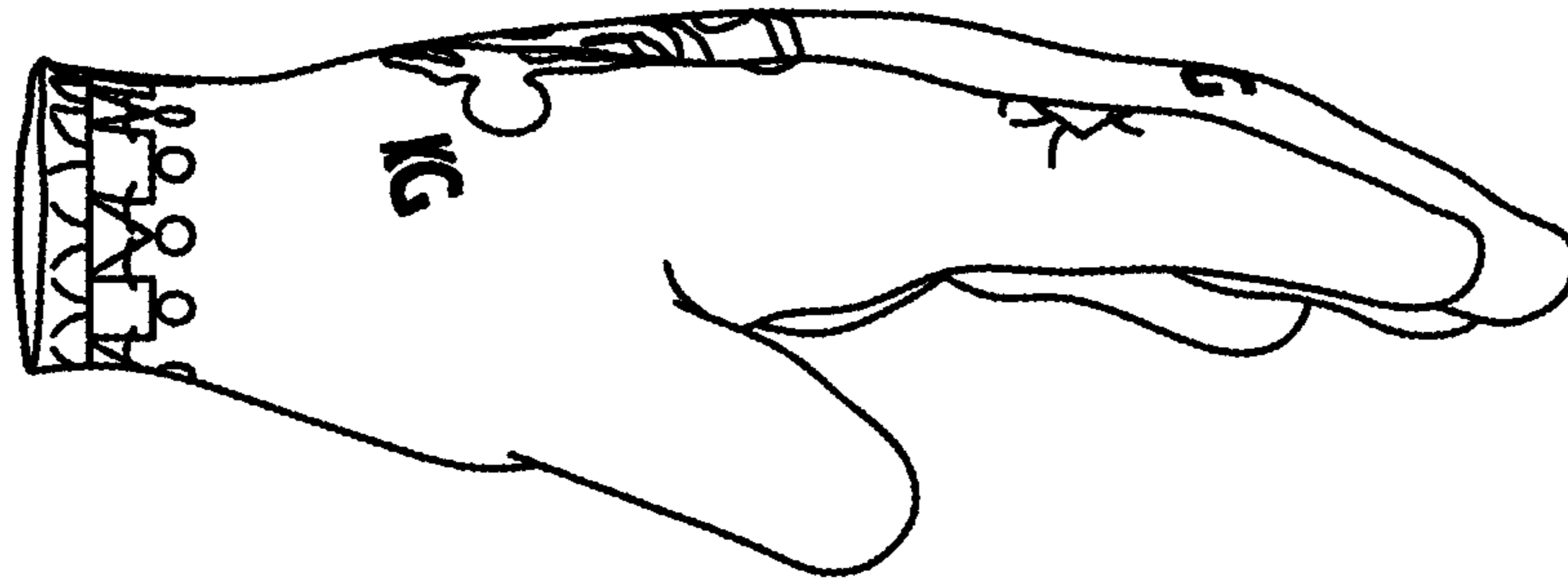

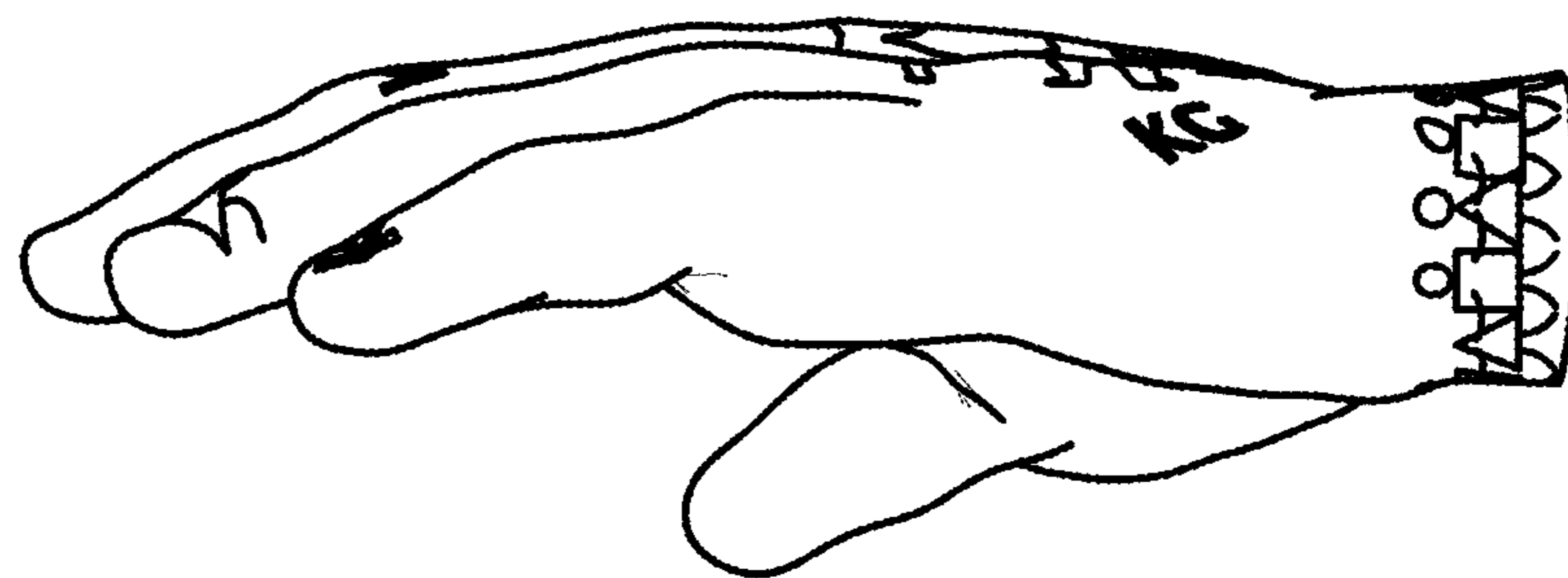

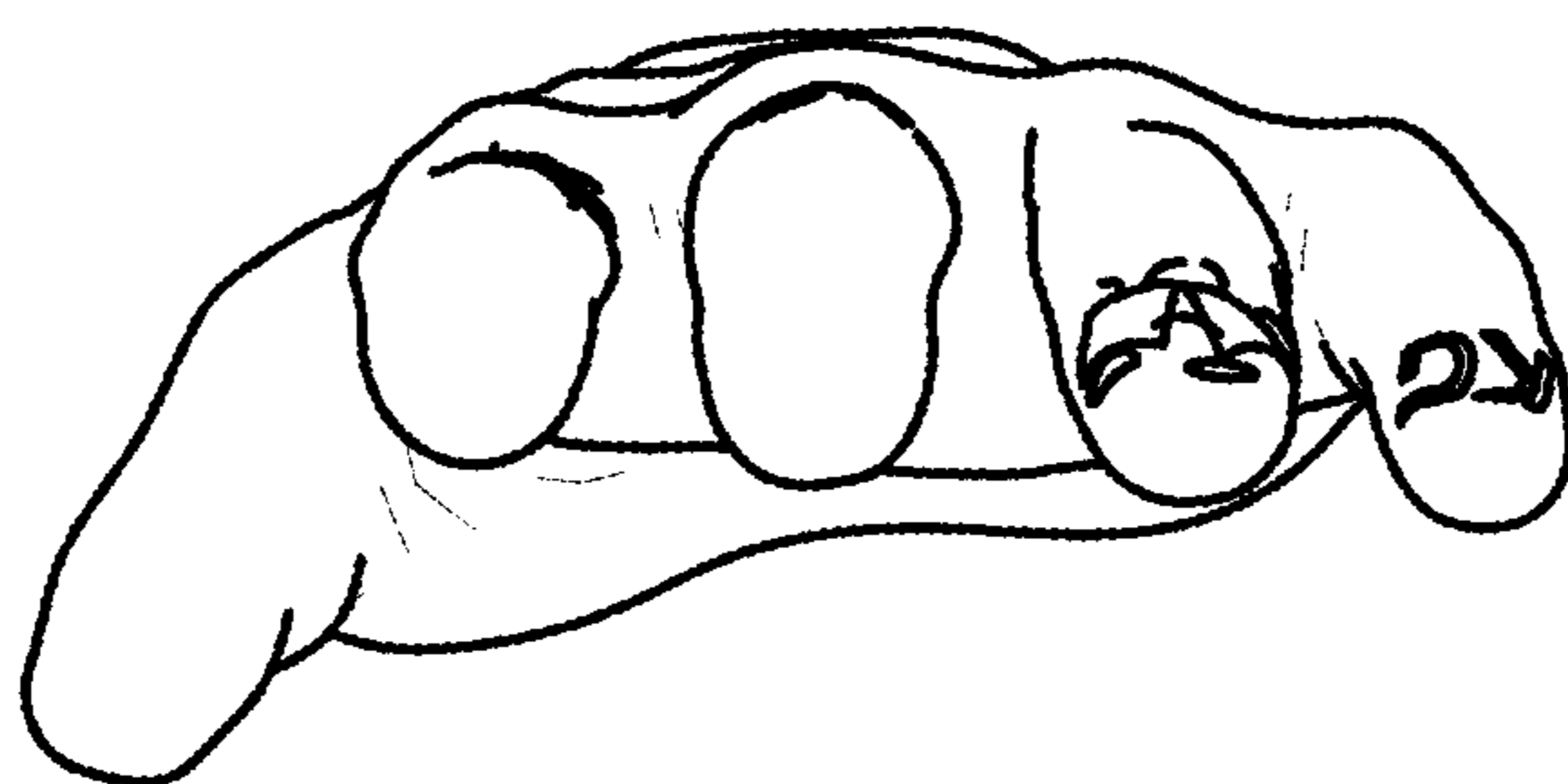

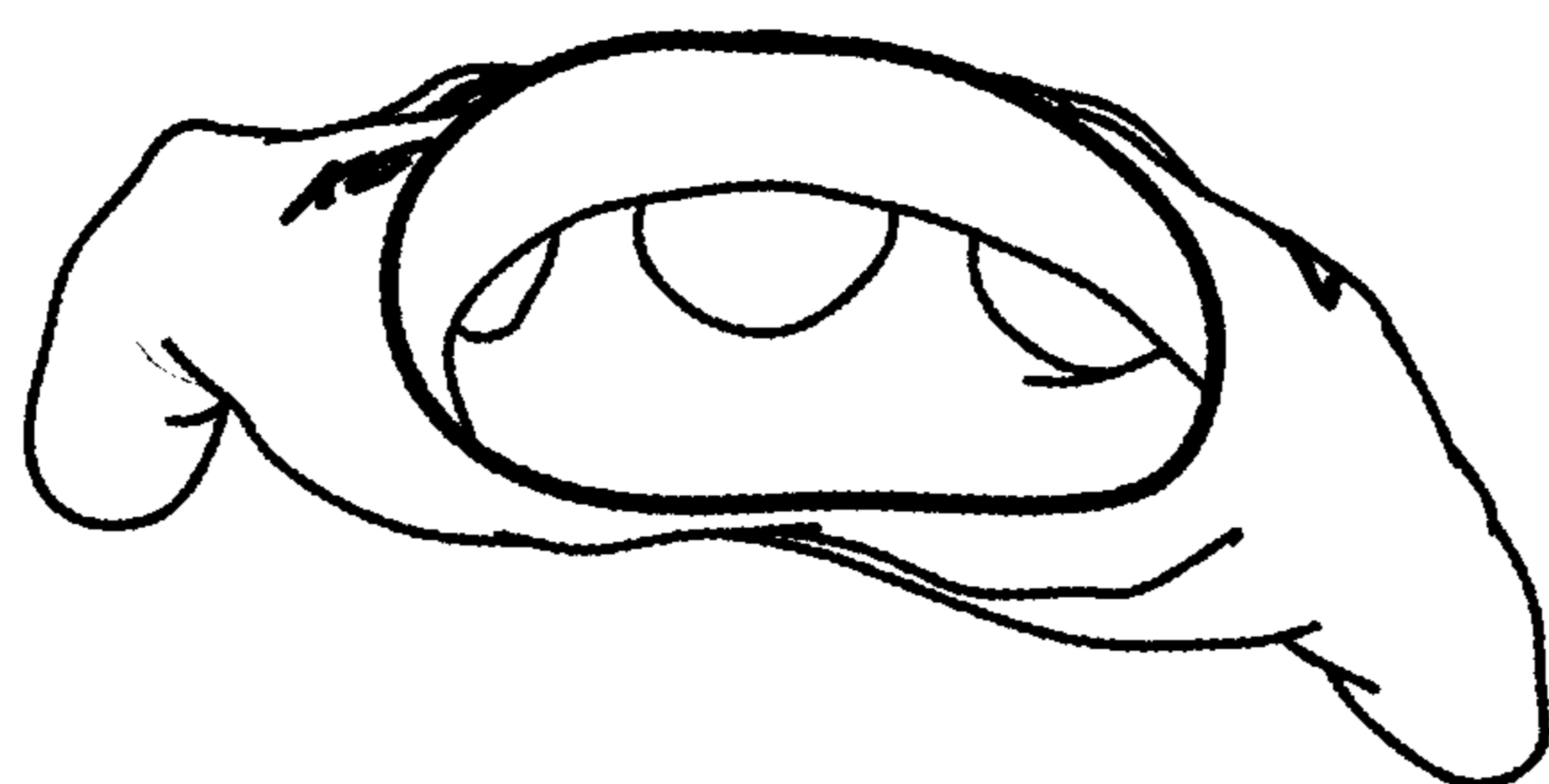
