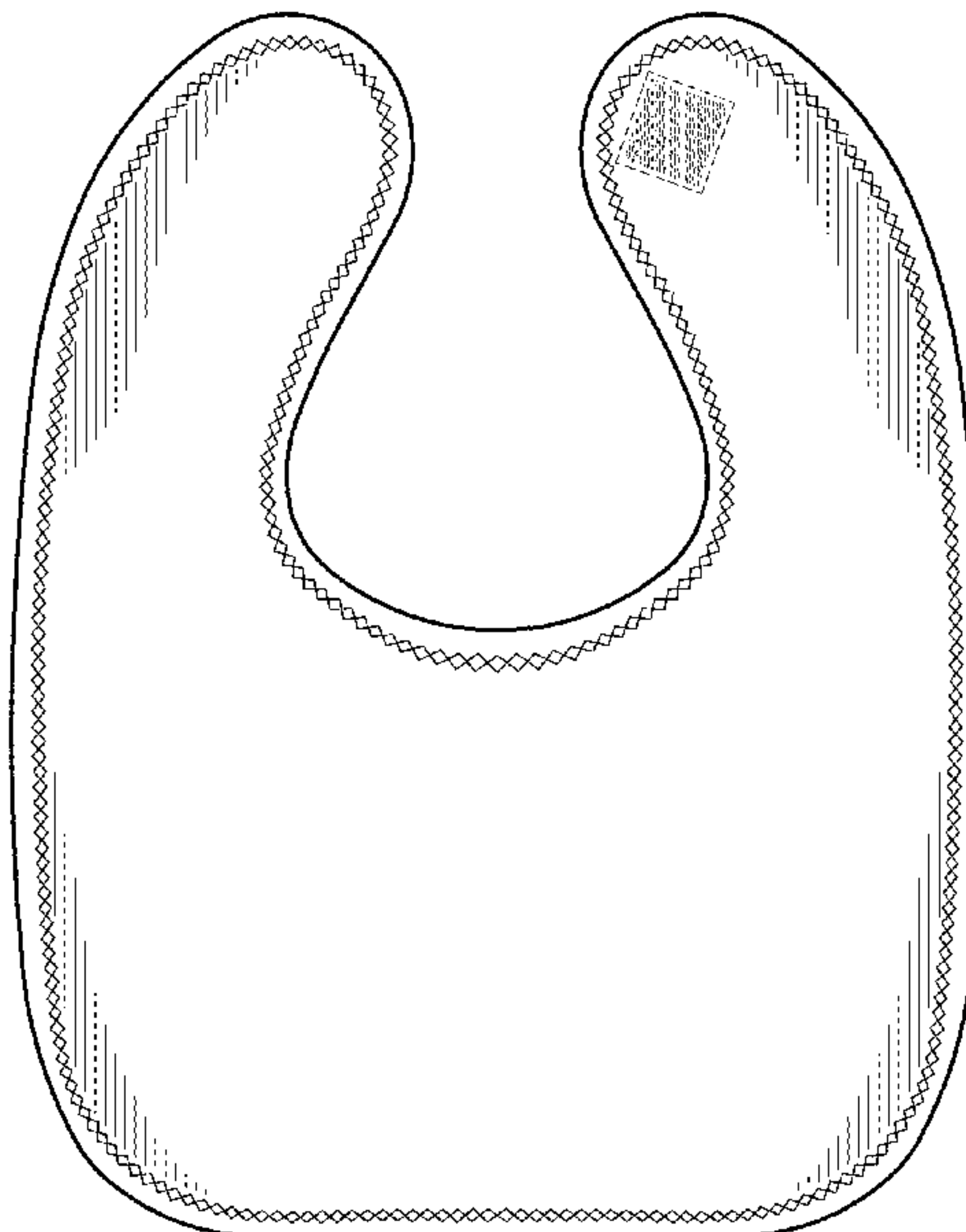
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a side perspective view of a wearable washcloth in accordance with the present invention;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a bottom view thereof; and,
FIG. 6 is a side elevation view thereof.

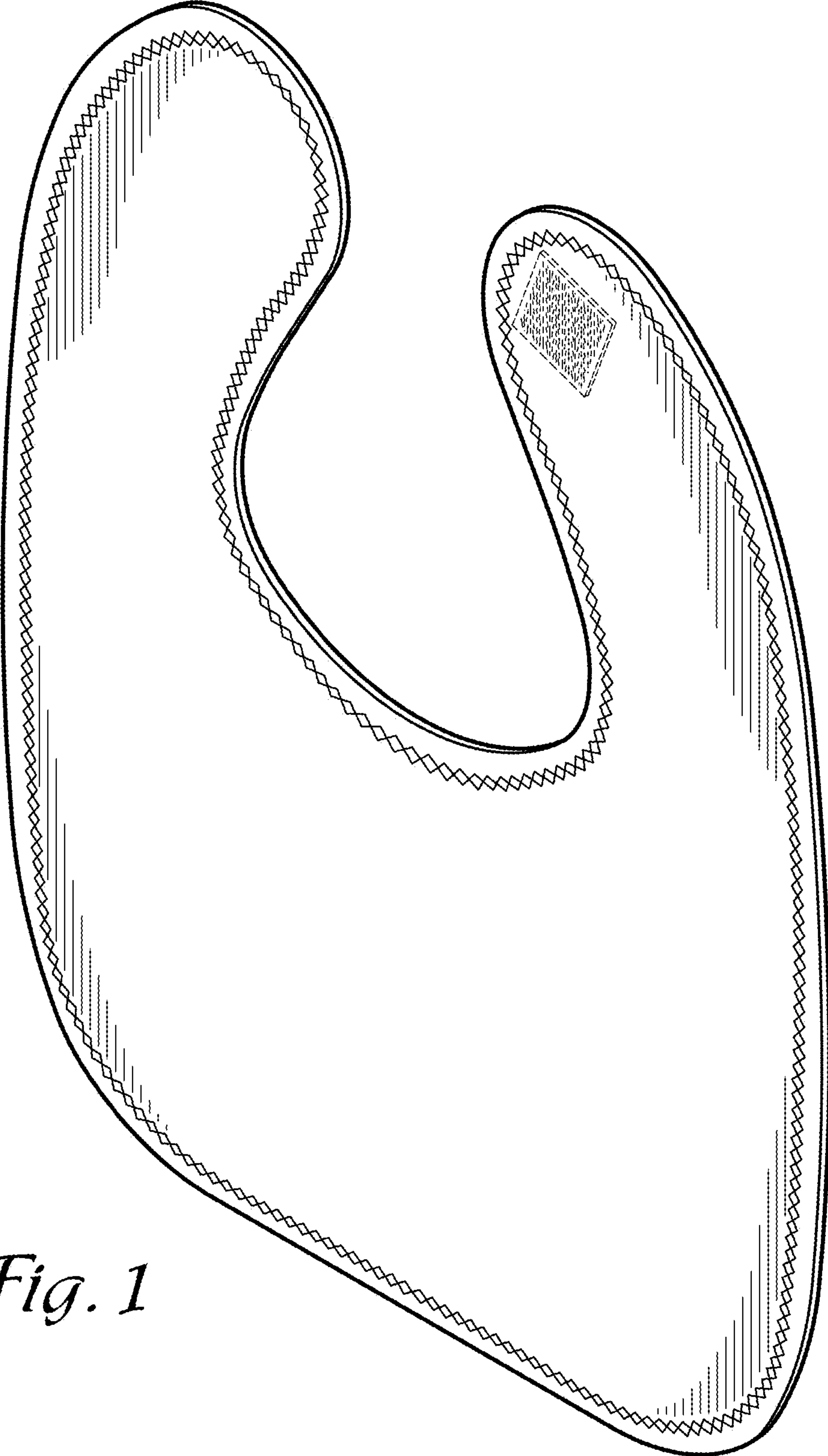

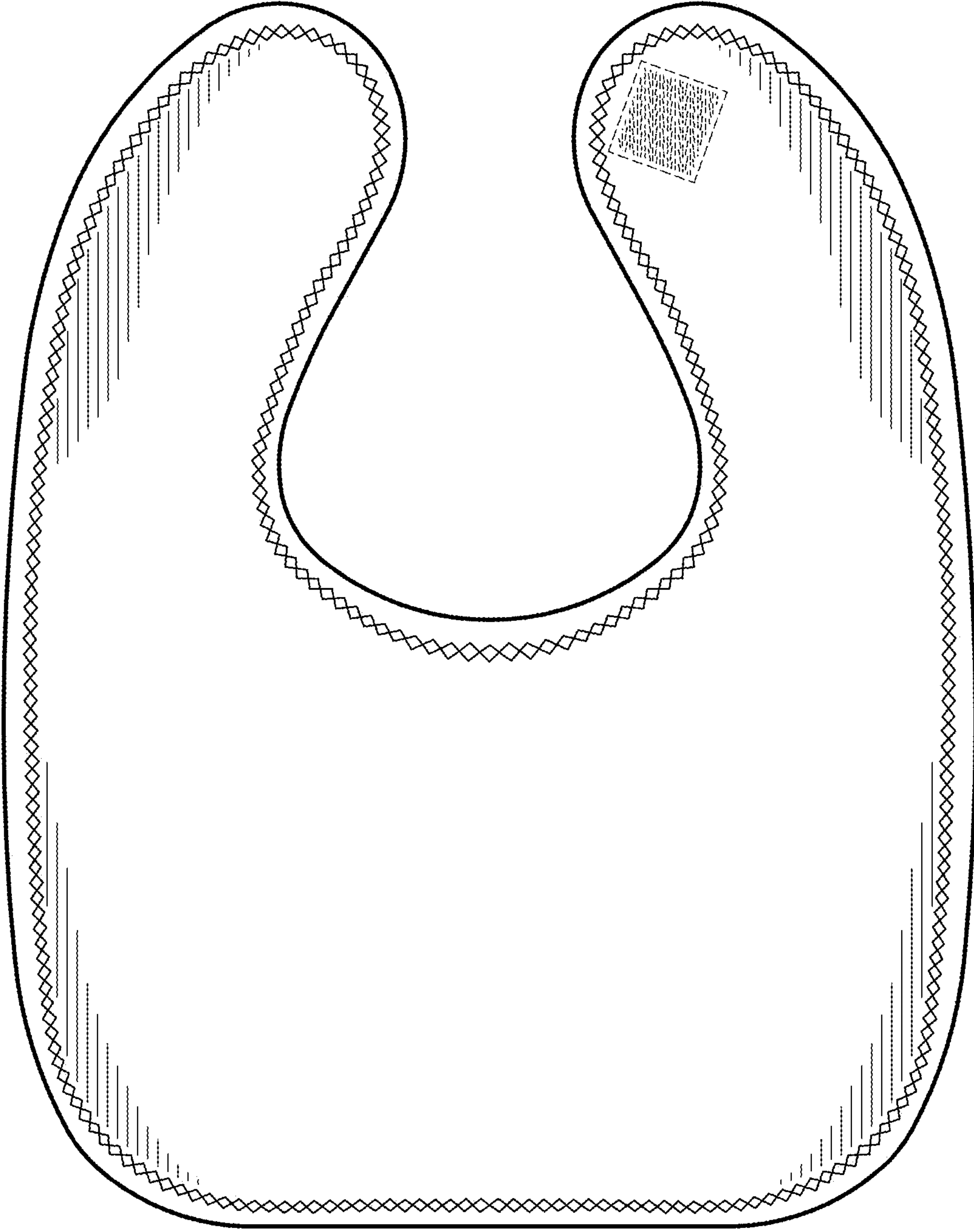

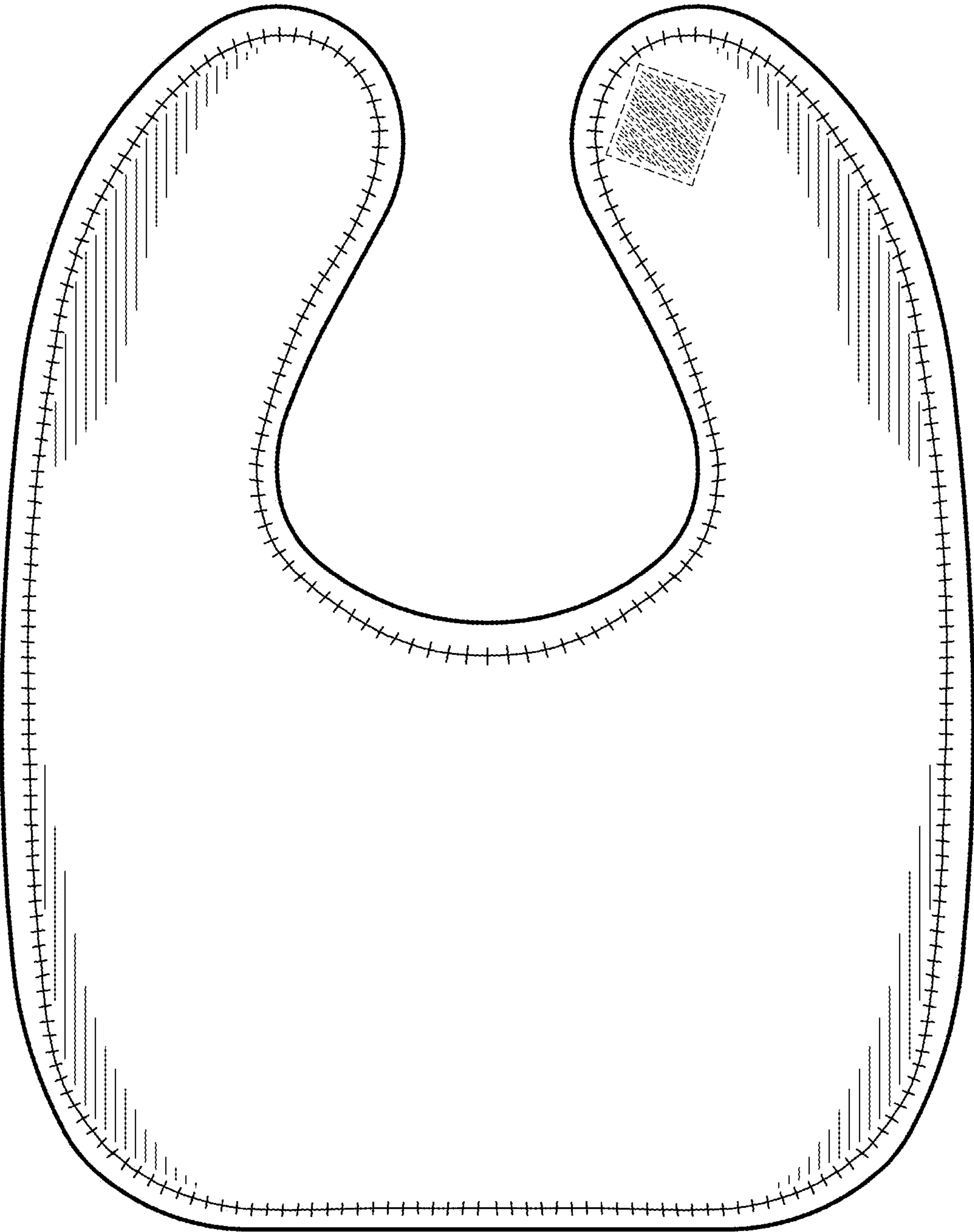

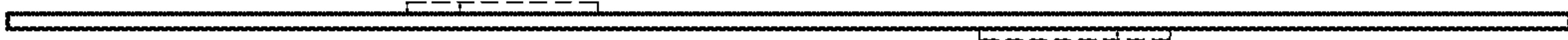

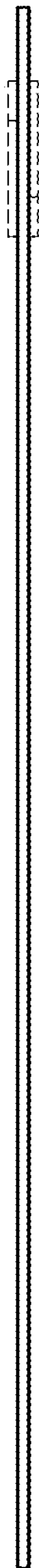
