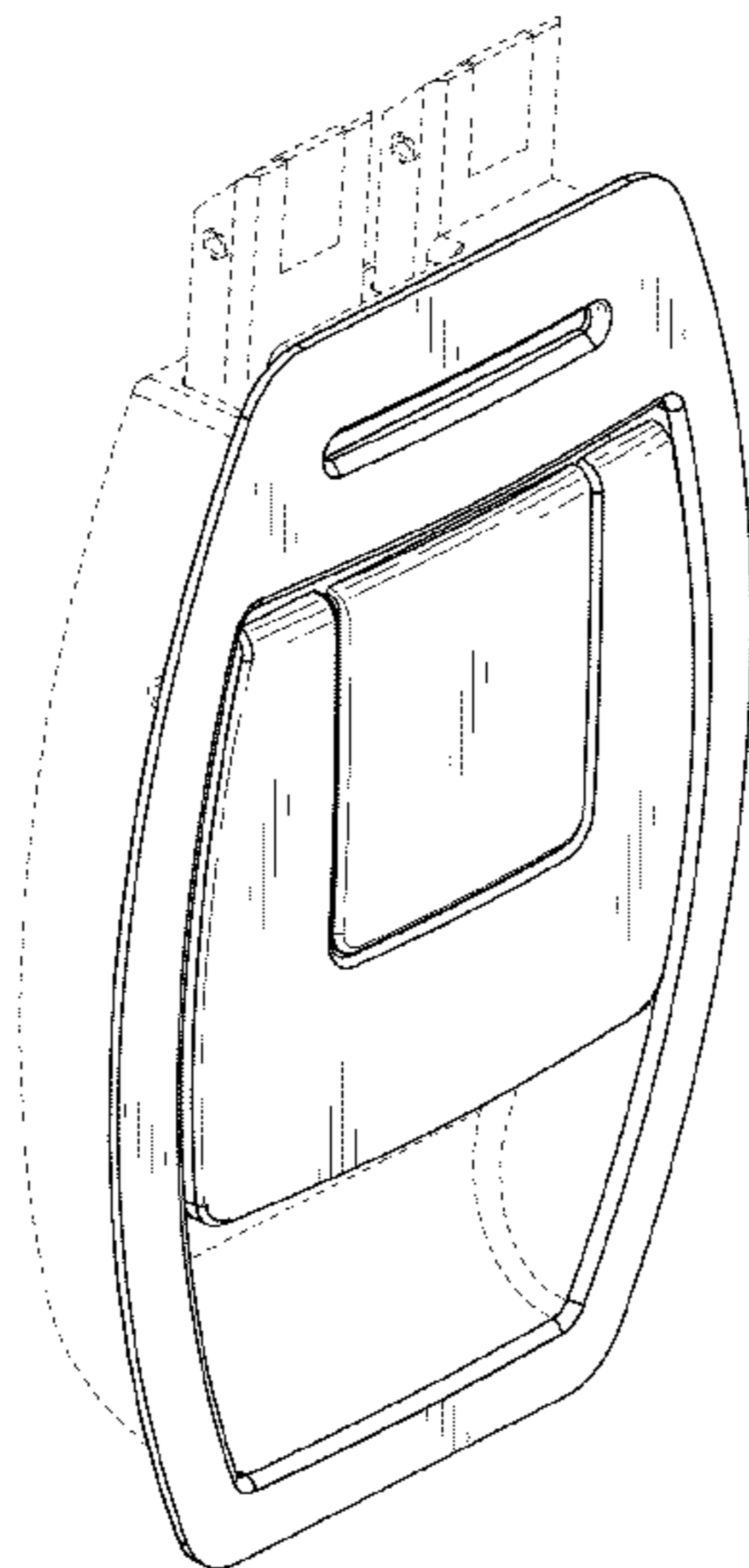

**DESCRIPTION**

FIG. 1 is a perspective view of a latch showing our new design;  
FIG. 2 is a front elevational view thereof;

FIG. 5 is a bottom plan view thereof; and,

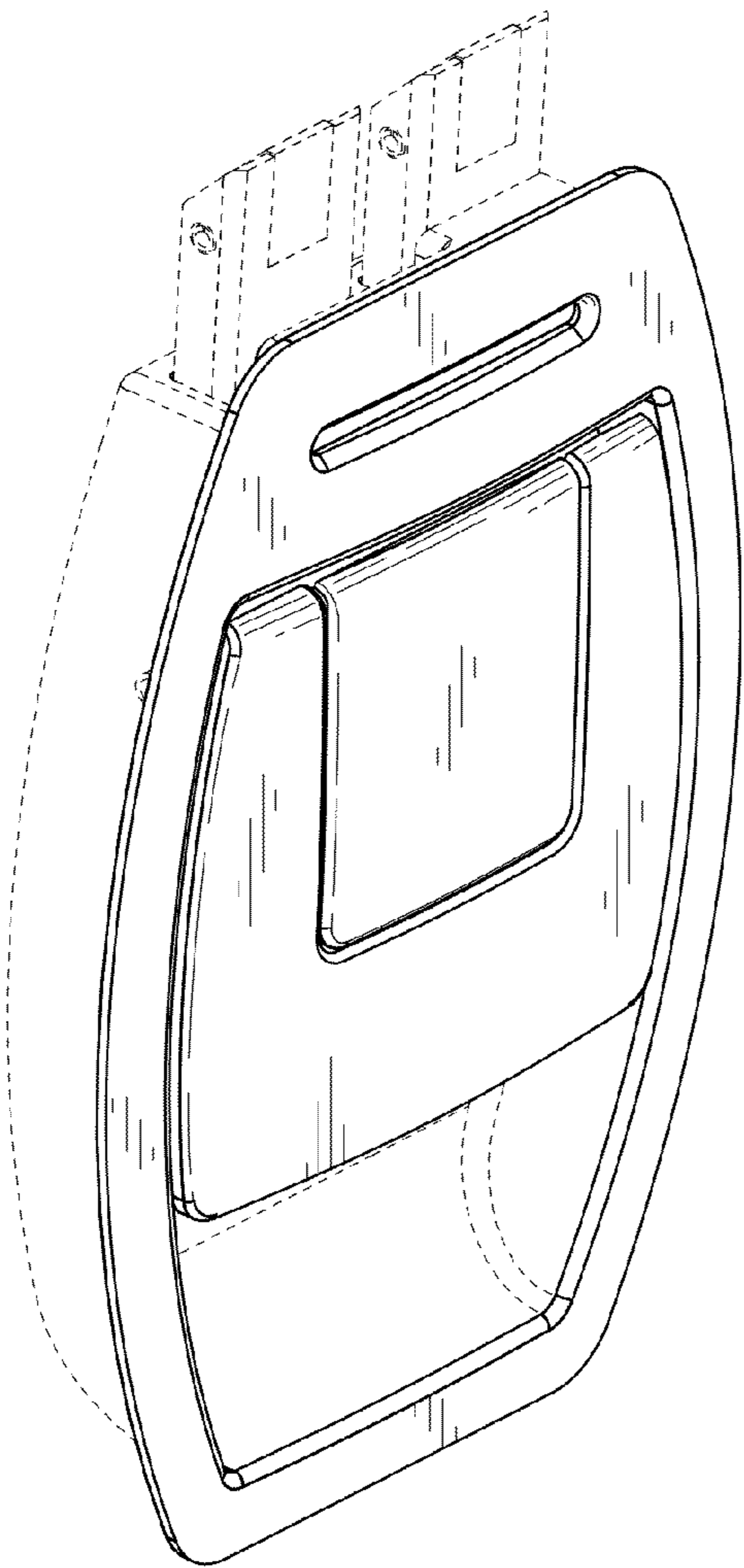

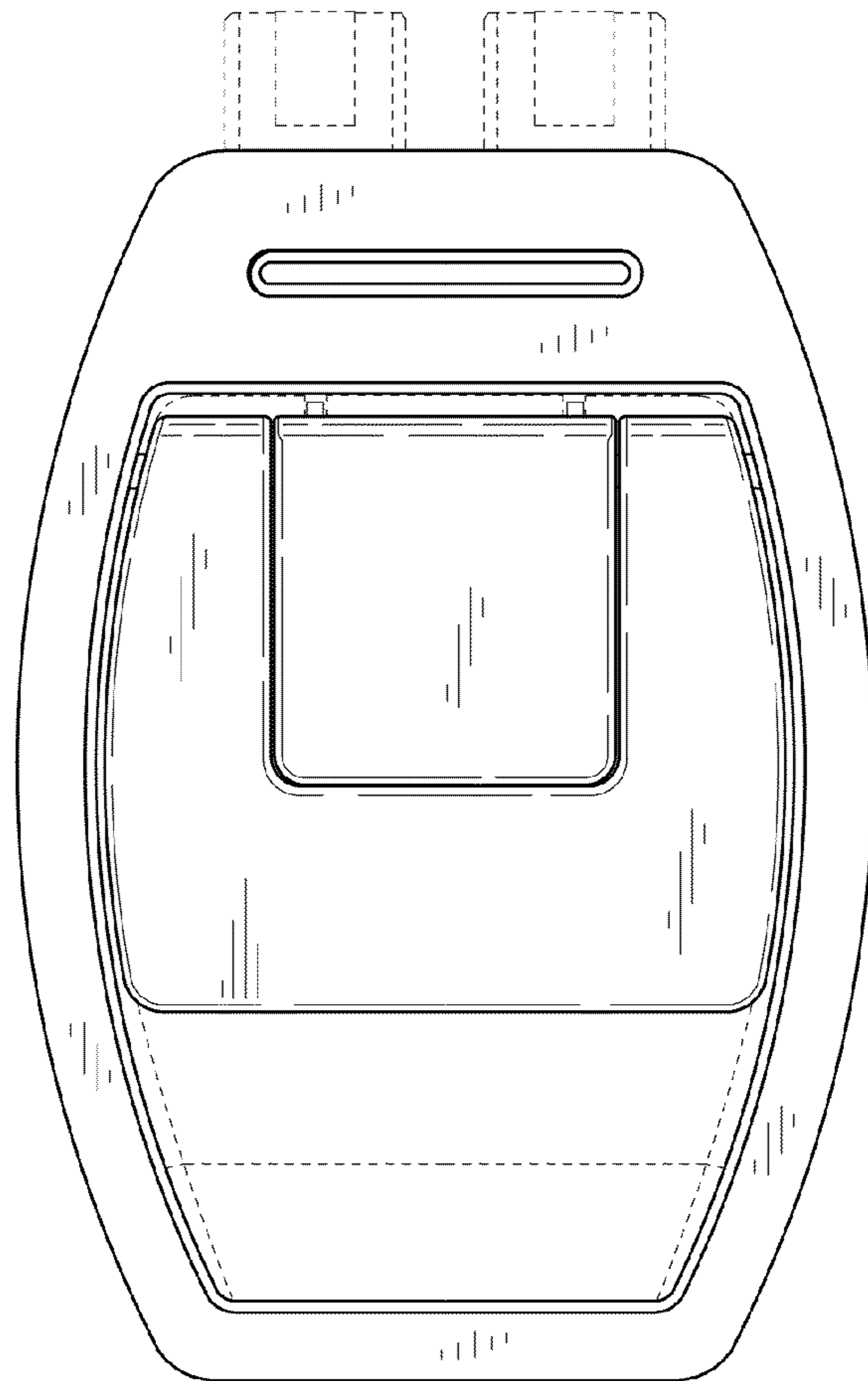

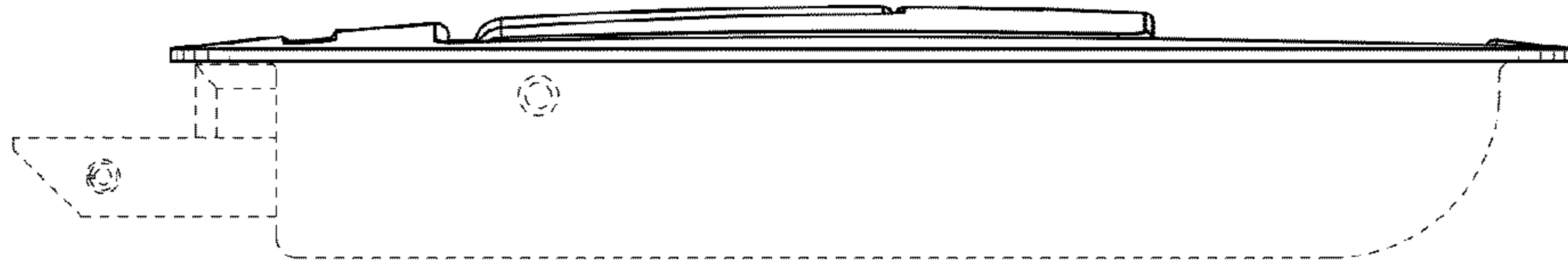

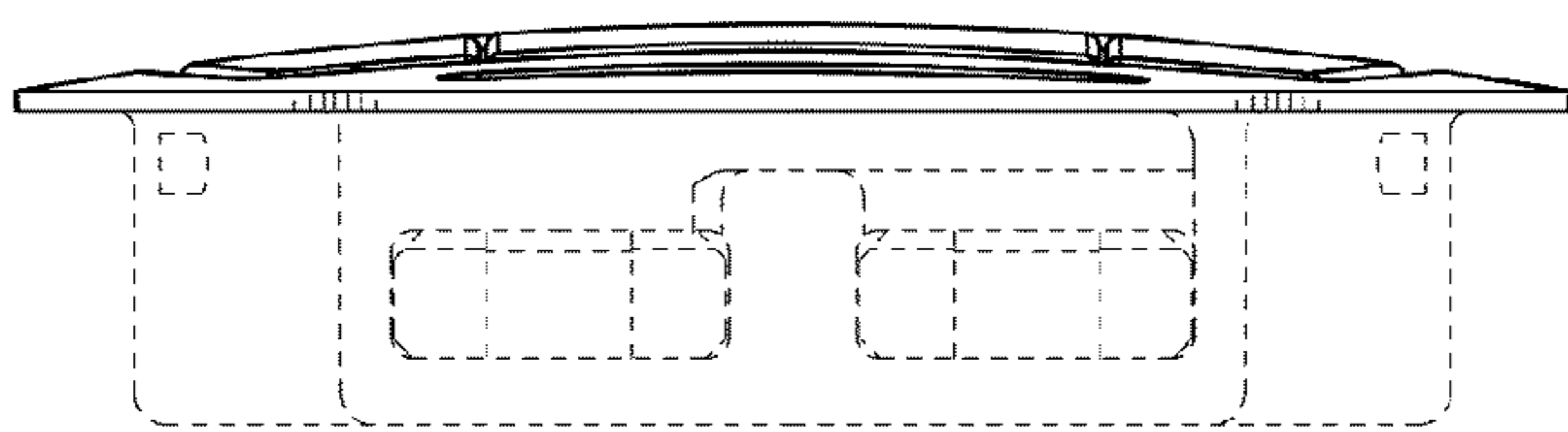

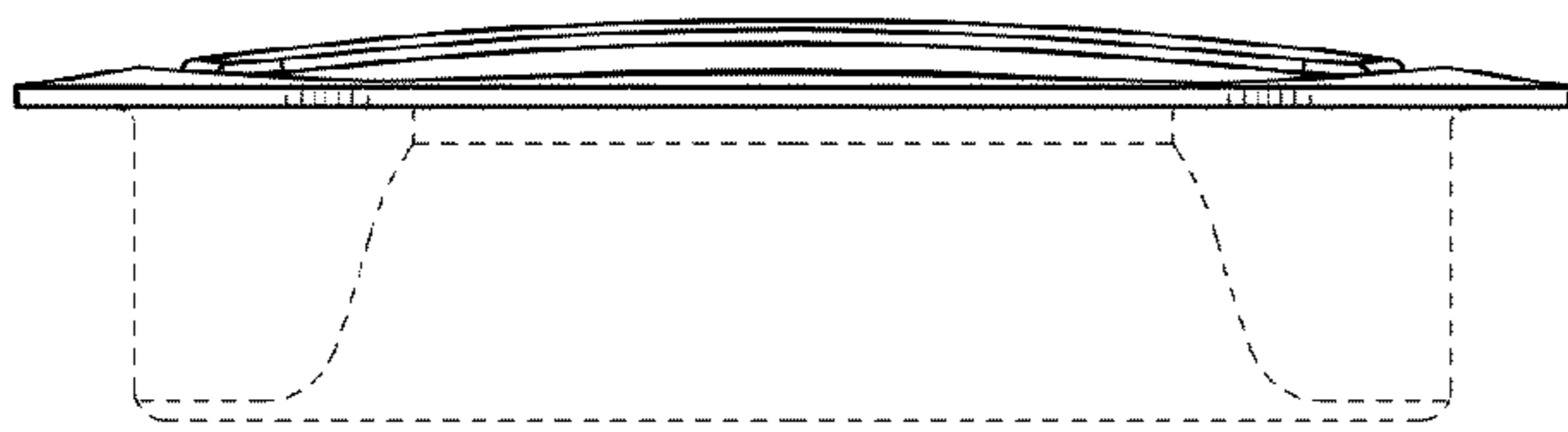

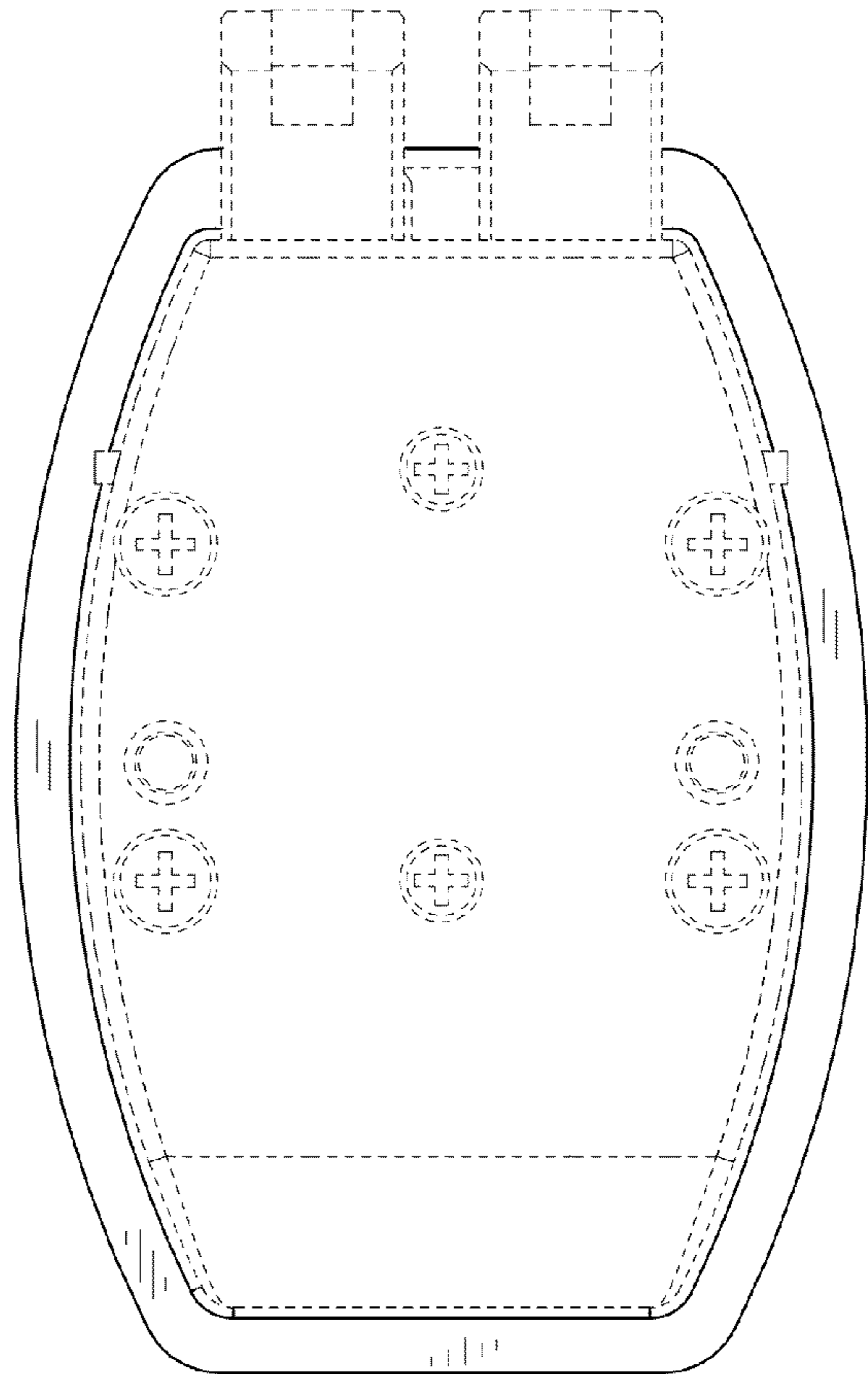
