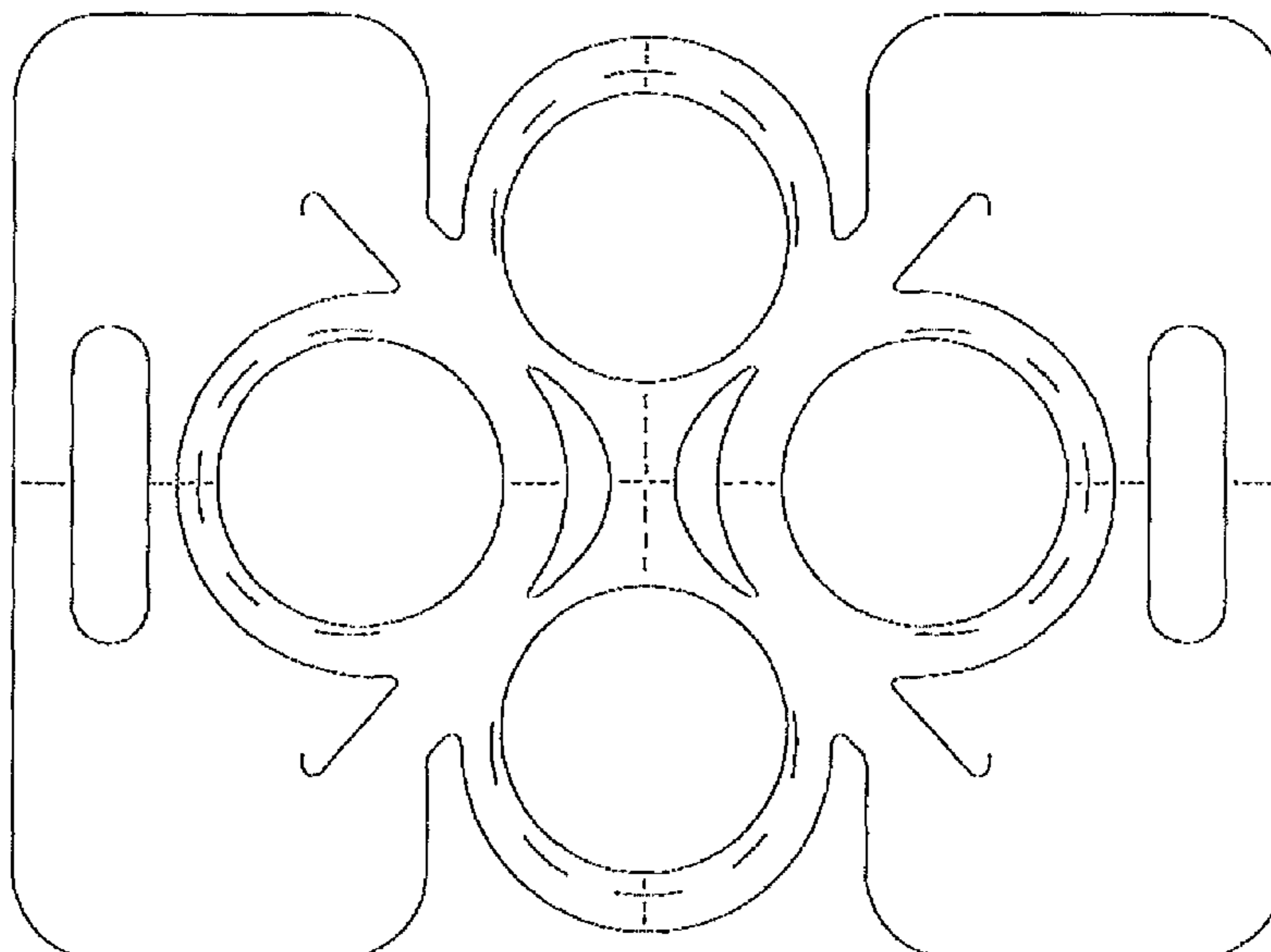

FIG. 2 is a perspective view thereof shown in use condition with a broken line showing of a food product in broken line;
FIG. 3 is a perspective view thereof shown in use condition with a broken line showing of a food product and hands and arms of a user in broken line;
FIG. 4 is a side perspective view thereof;
FIG. 5 is a top perspective view thereof;
FIG. 6 is another top perspective view thereof; and,

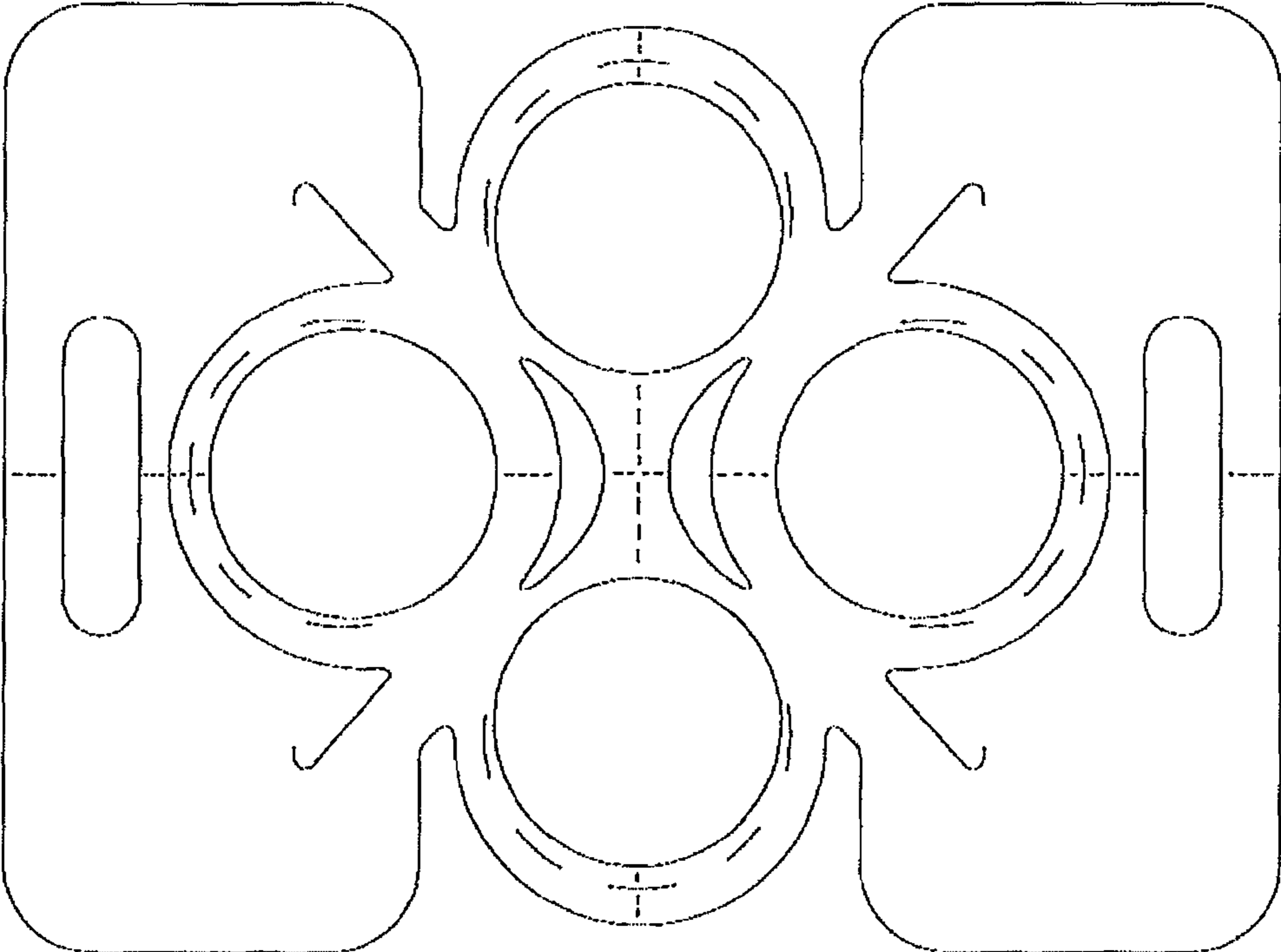

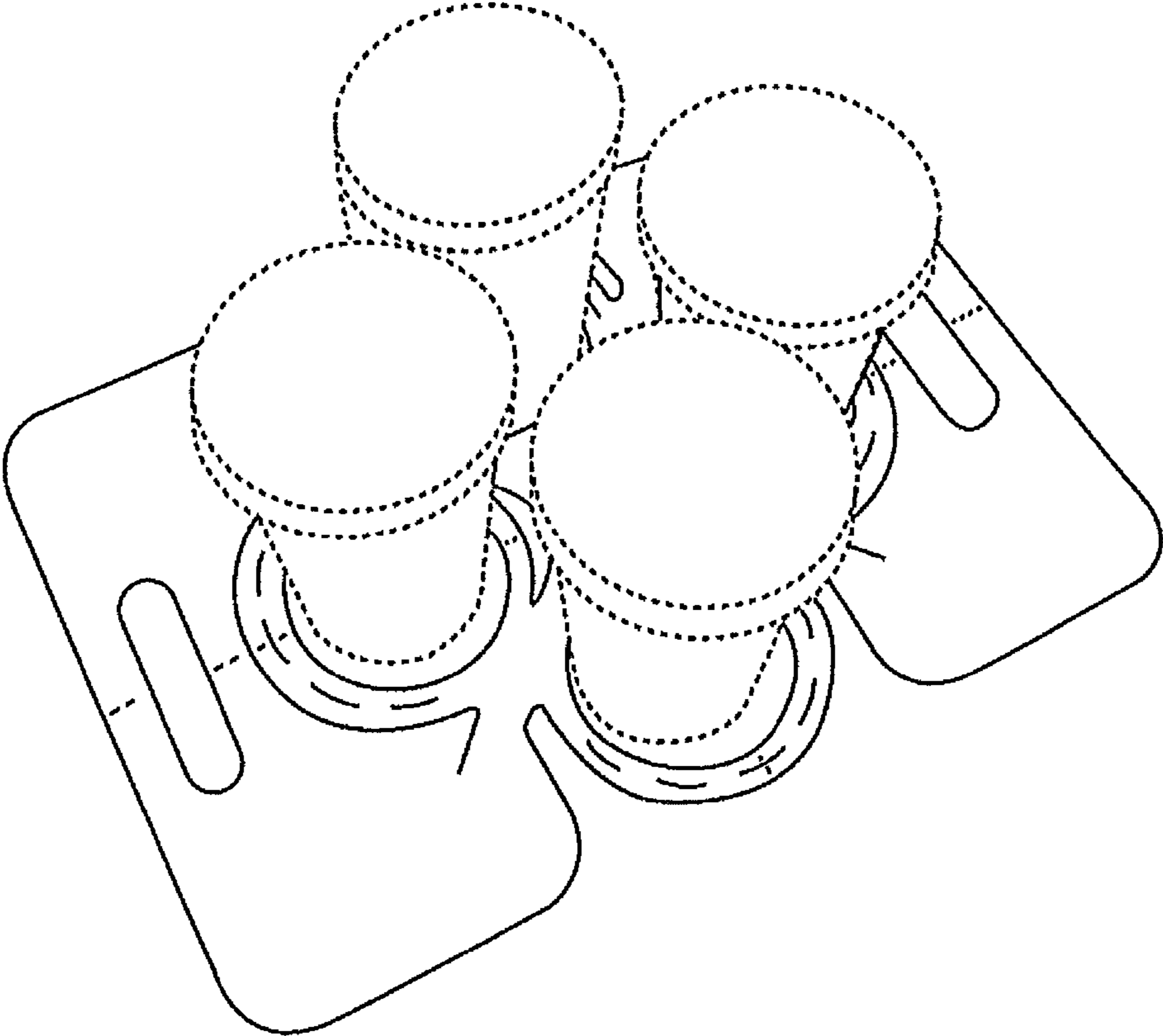

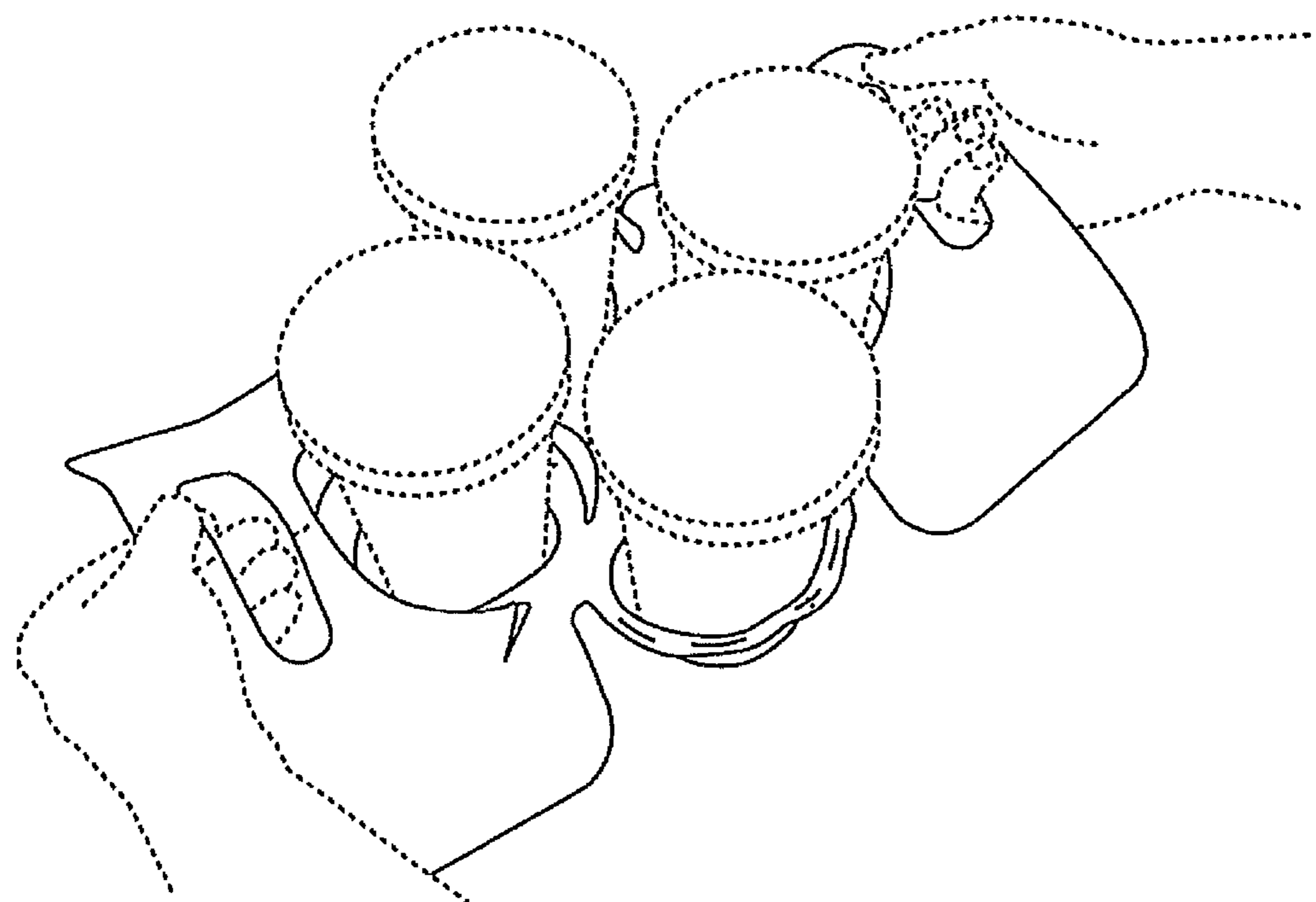

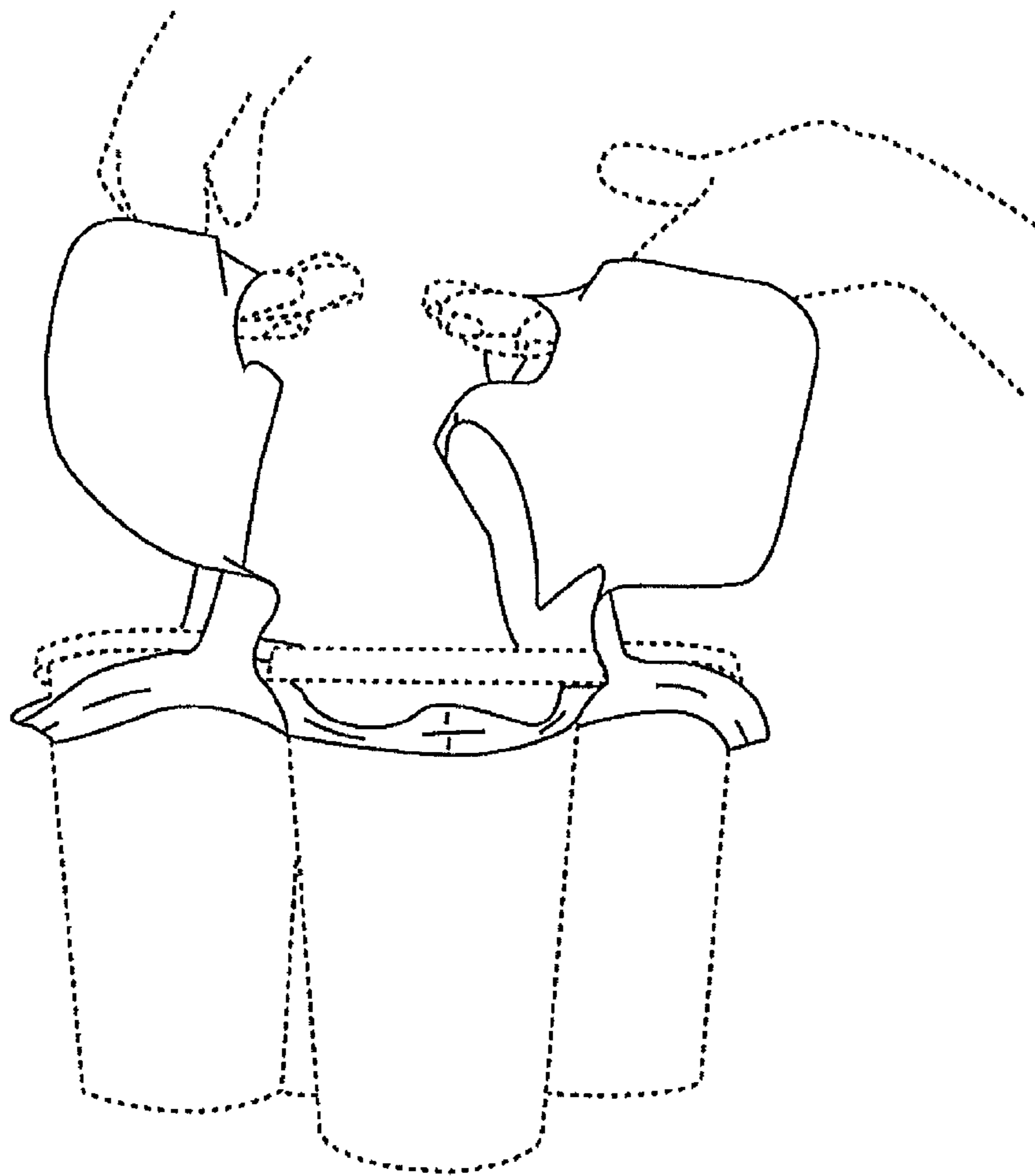

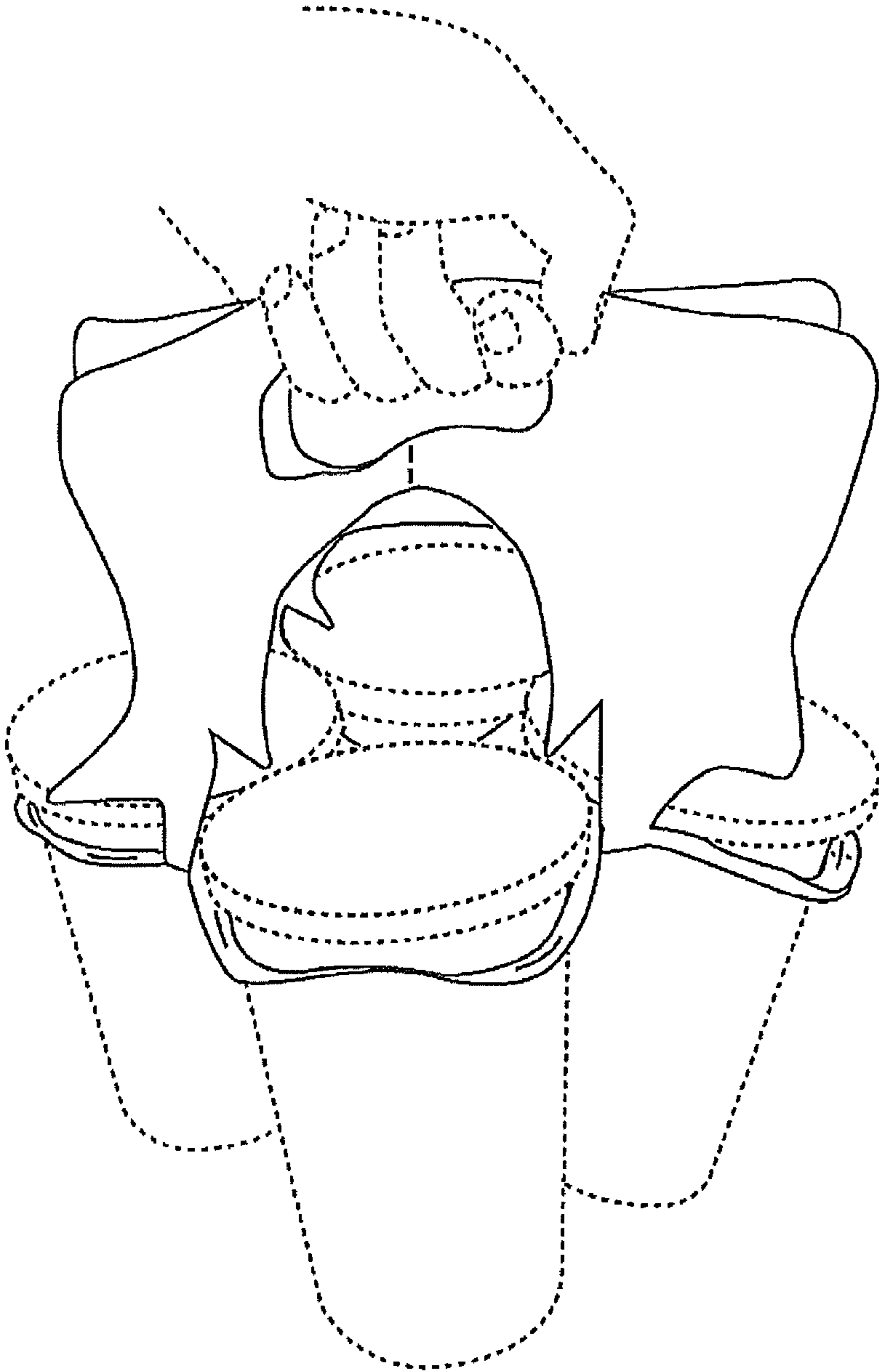

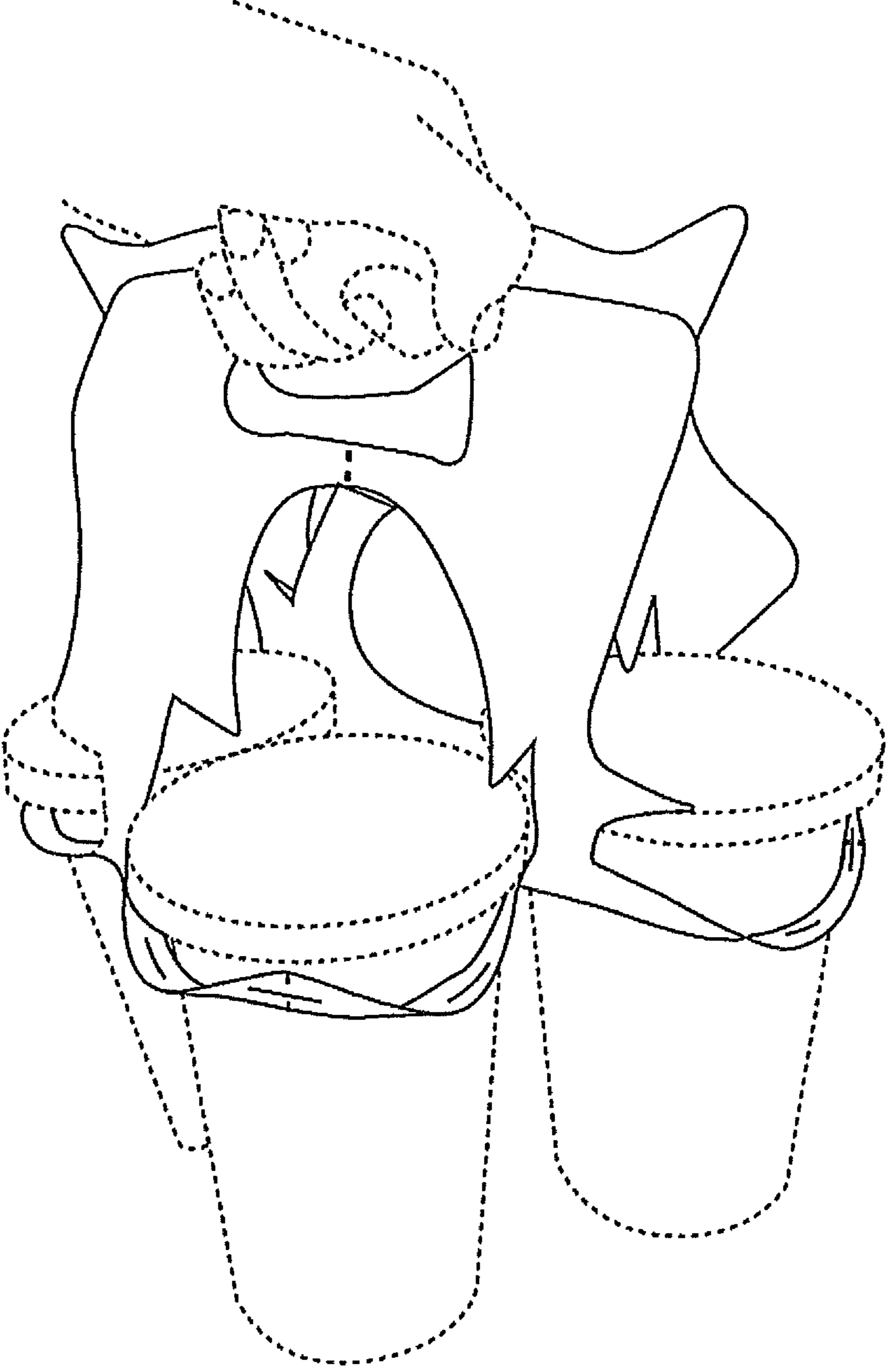

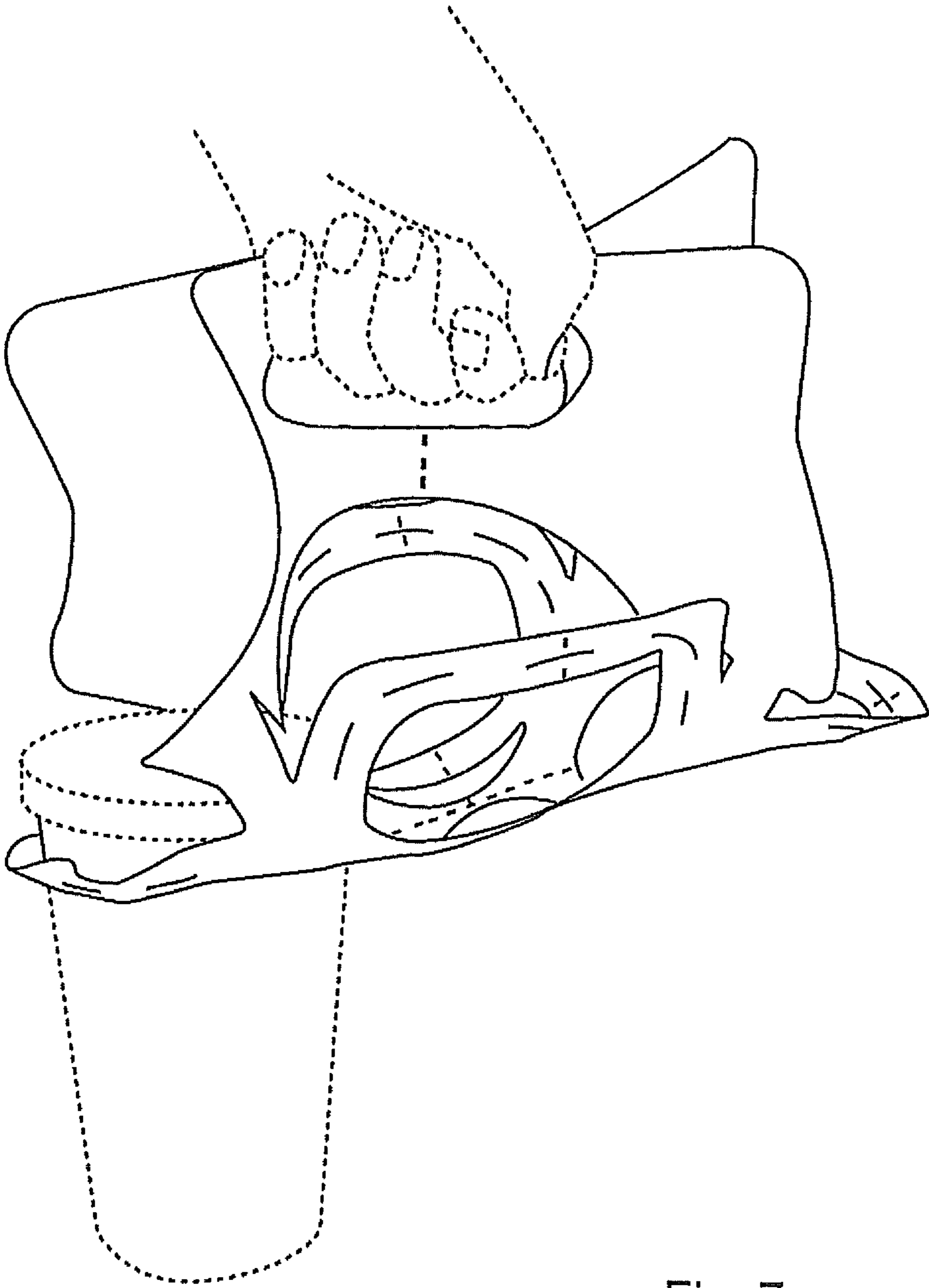
