The ornamental design for a front portion of a passenger car, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view for a “front portion of a passenger car” showing my new design, FIG. 2 is a front perspective view thereof, FIG. 3 is a front view thereof, FIG. 4 is a rear view thereof, FIG. 5 is a left-side view thereof, FIG. 6 is a right-side view thereof; and, FIG. 7 is a top view thereof.

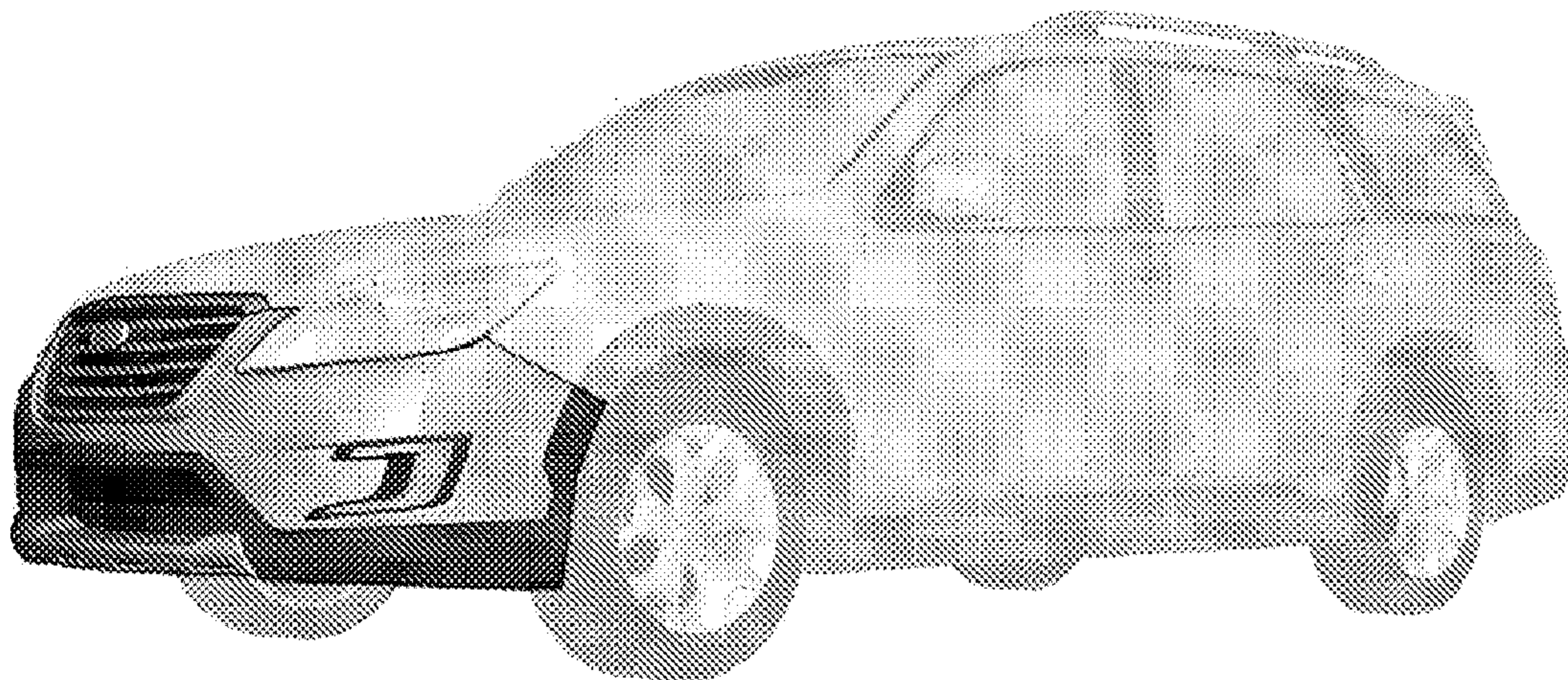

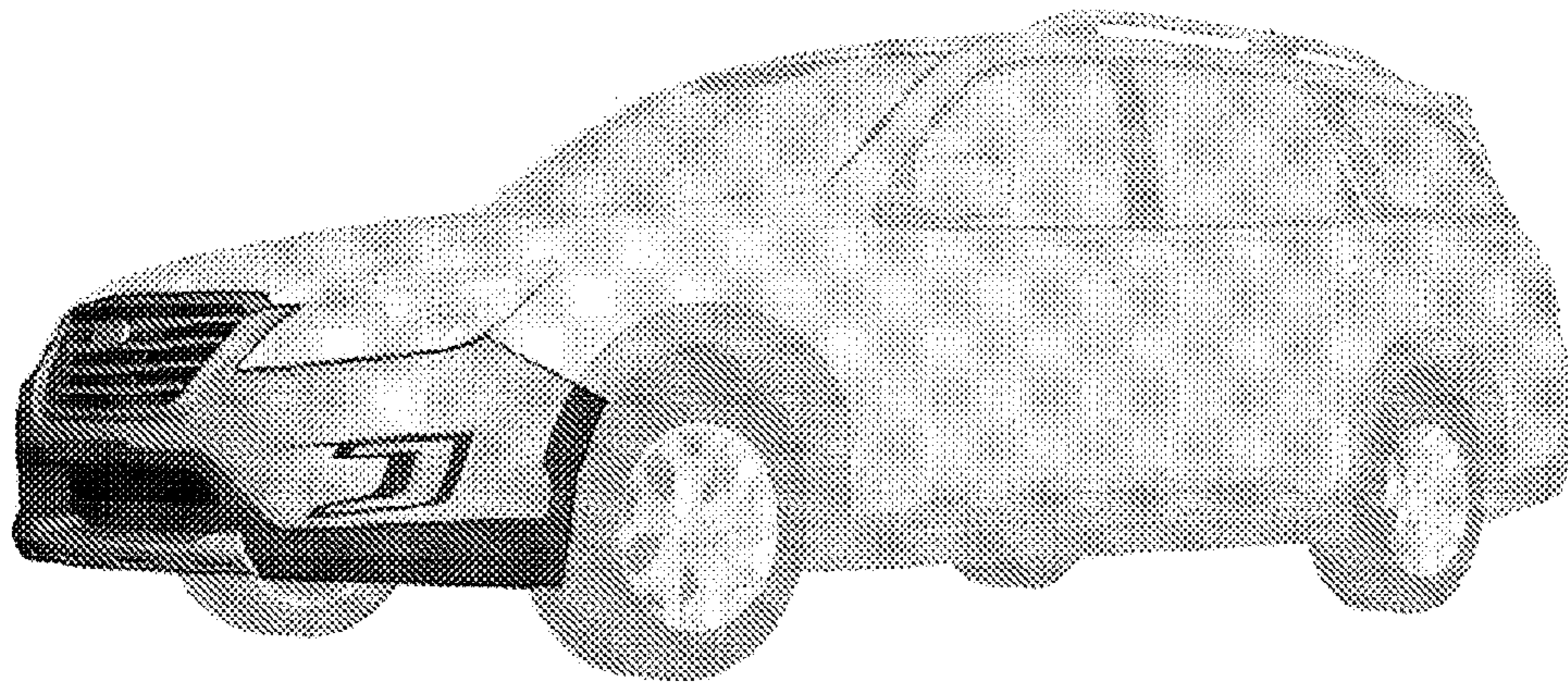

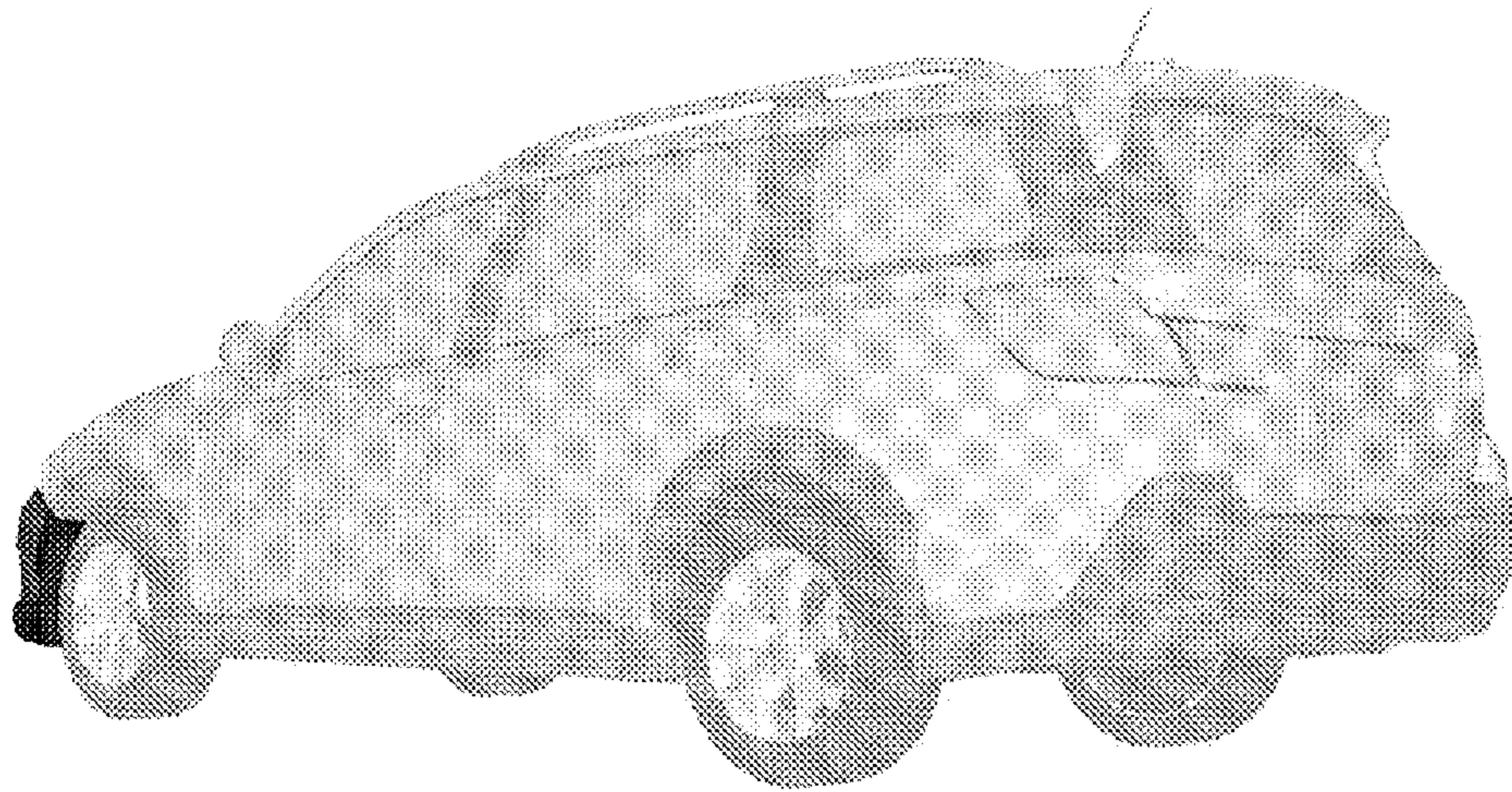

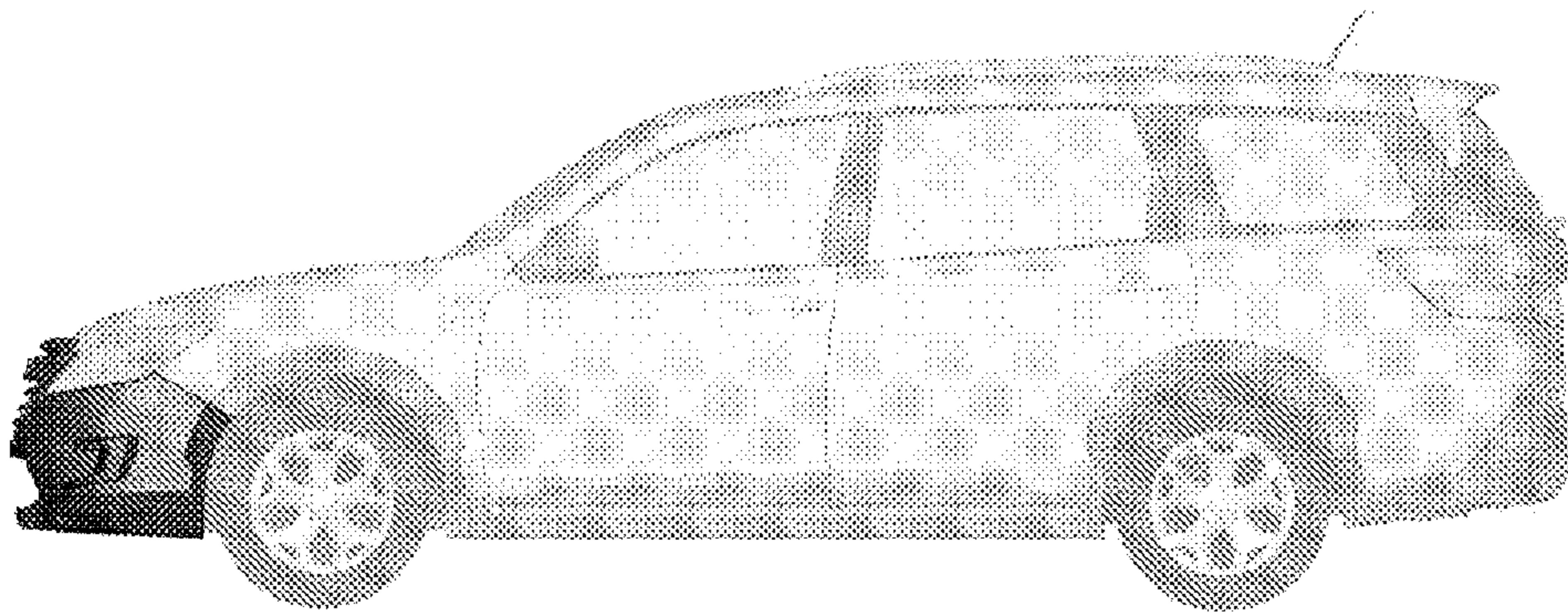

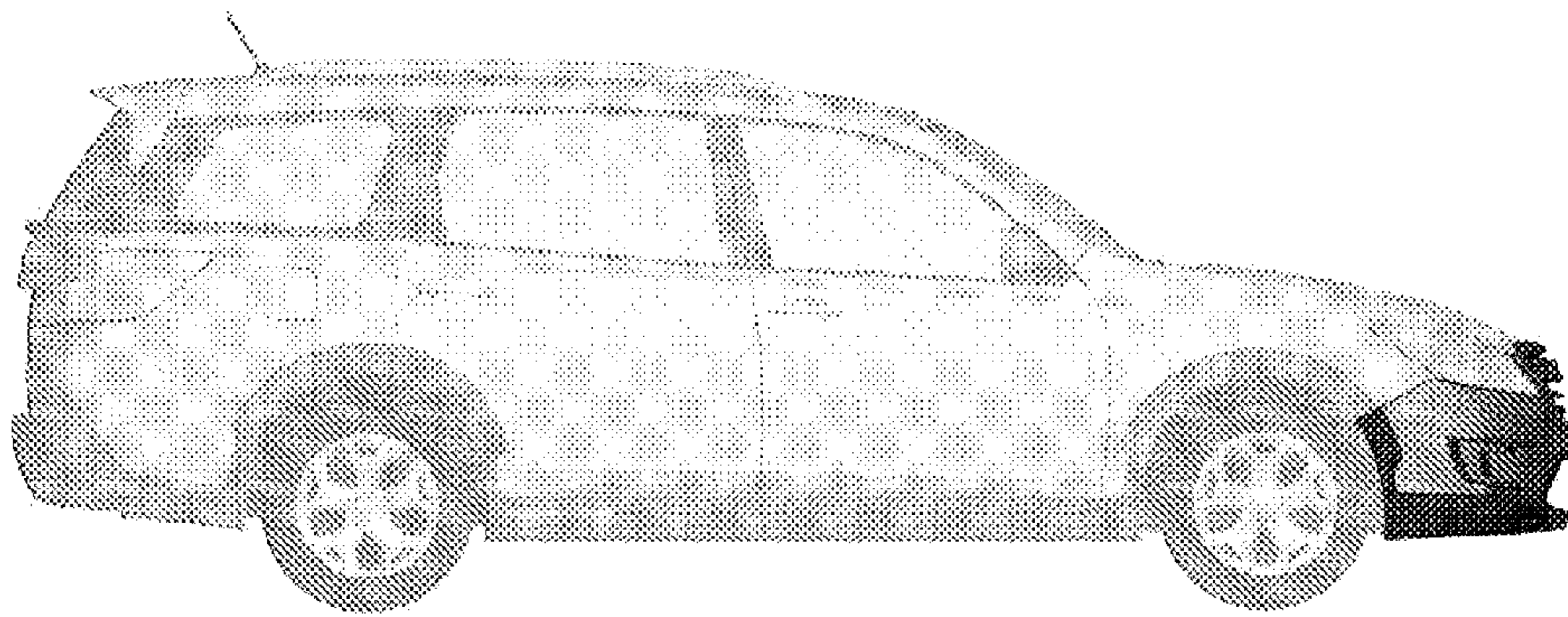

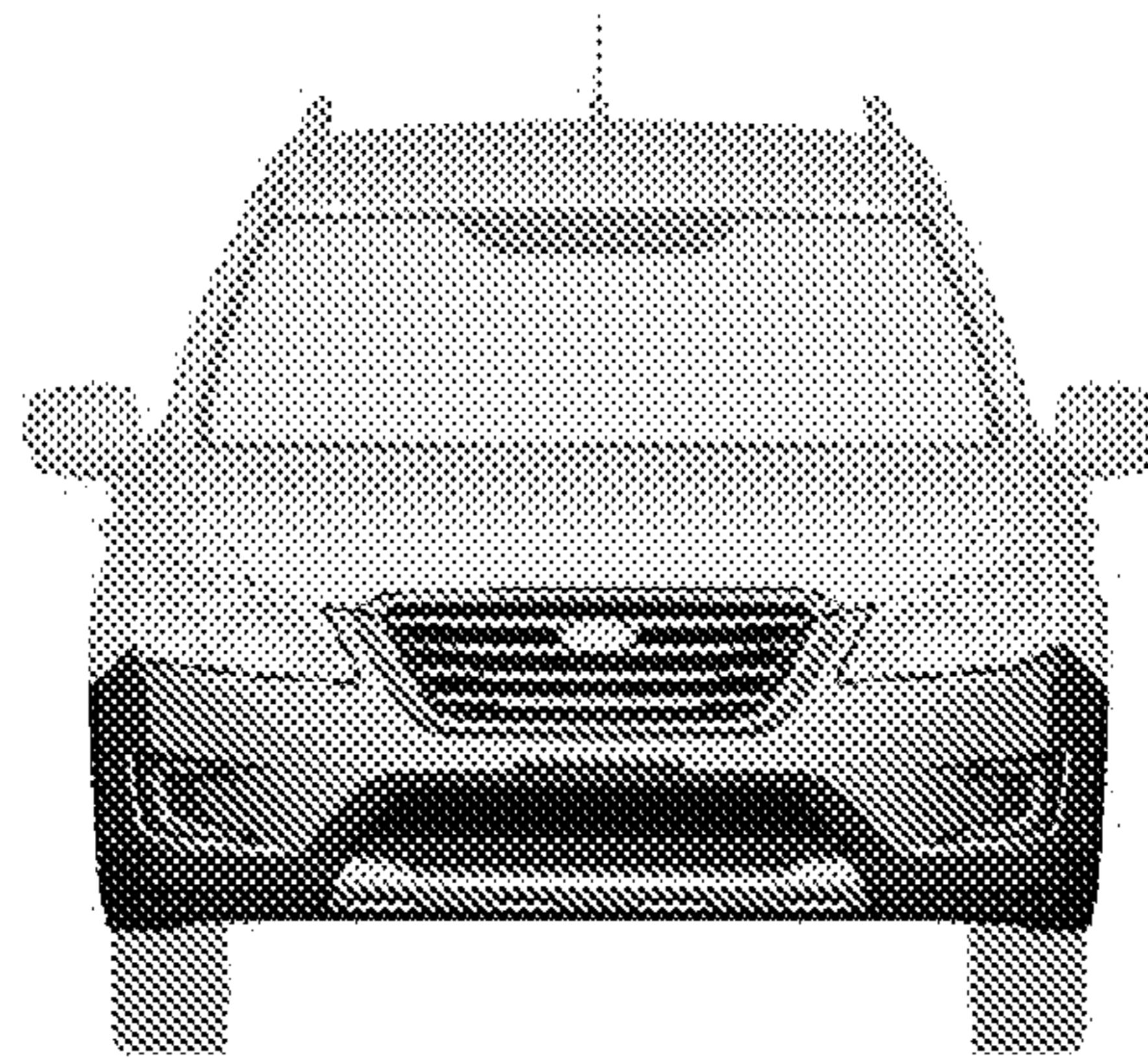

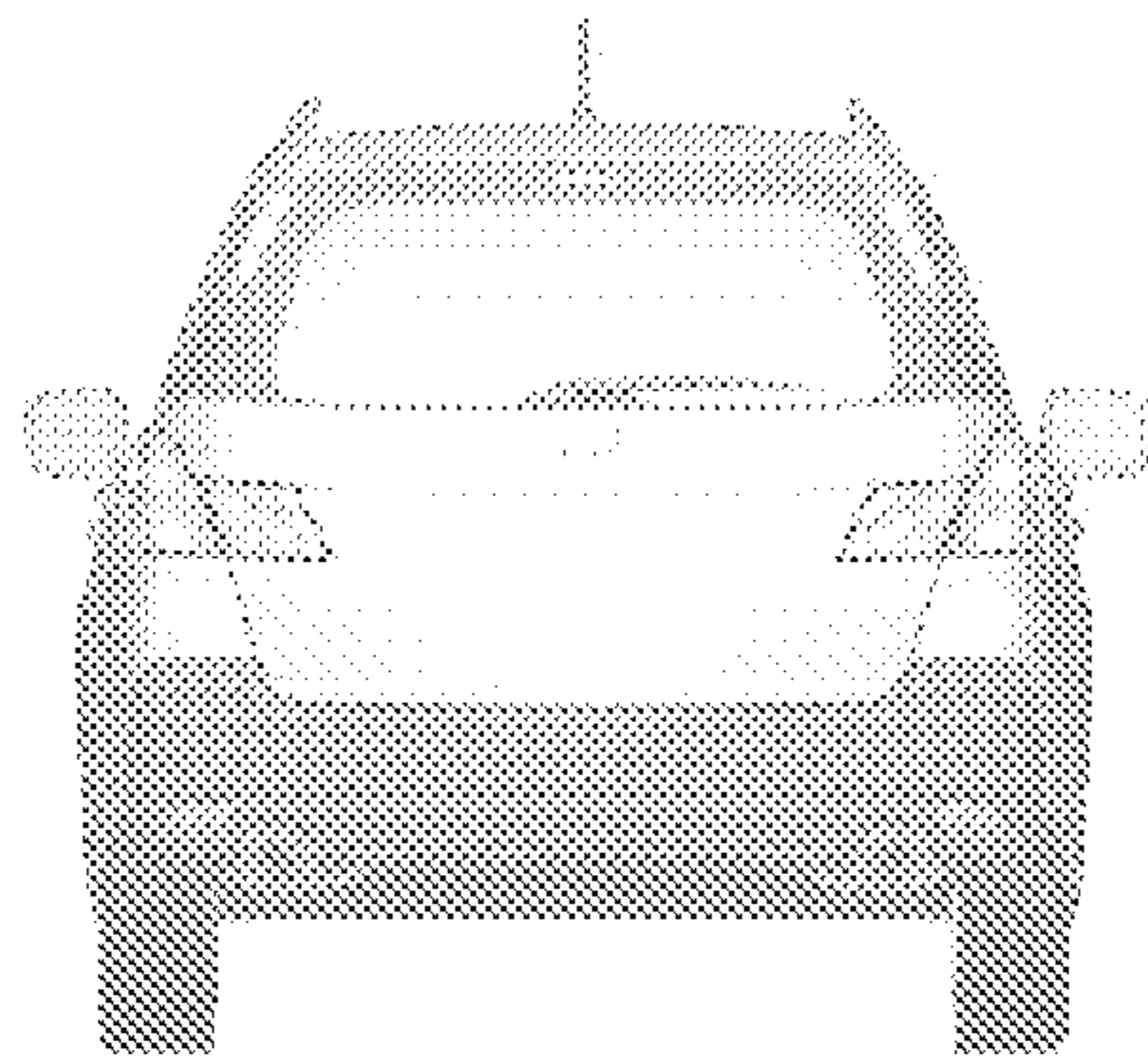
