(57) **CLAIM**

I claim the ornamental design for a tire tread, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a tire tread as defined by lines A-A and B-B;

FIG. 2 is an enlarged view of the tire tread defined by lines A-A and B-B in FIG. 1;

FIG. 3 is a front view of the tire tread as defined by lines C-C and D-D;

FIG. 4 is an enlarged view of the tire tread defined by lines C-C and D-D in FIG. 3;

FIG. 5 is a side view of the tire tread as defined by lines E-E and F-F;

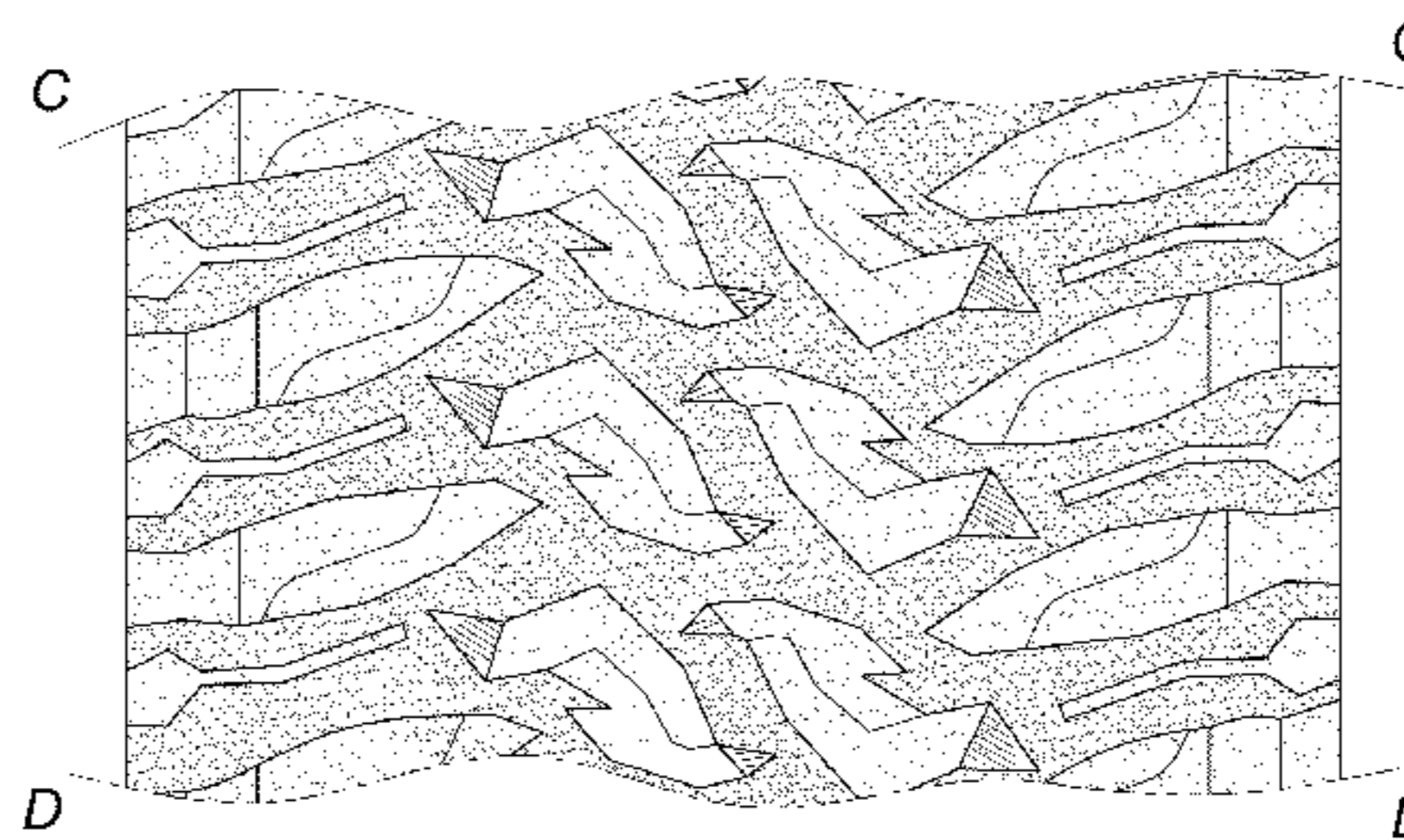
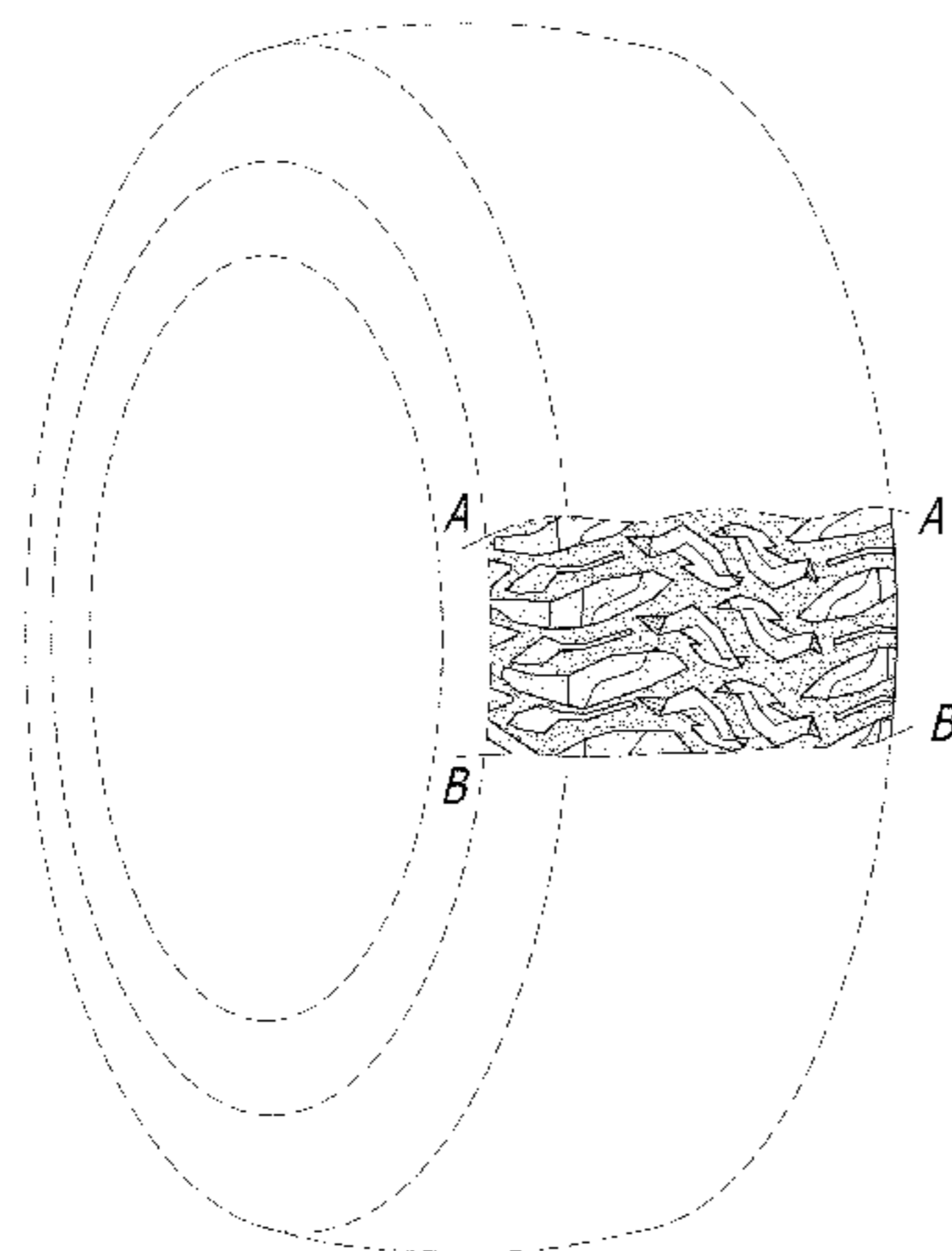
FIG. 6 is an enlarged view of the tire tread defined by lines E-E and F-F;

FIG. 7 is another side view of the tire tread as defined by lines G-G and H-H; and,

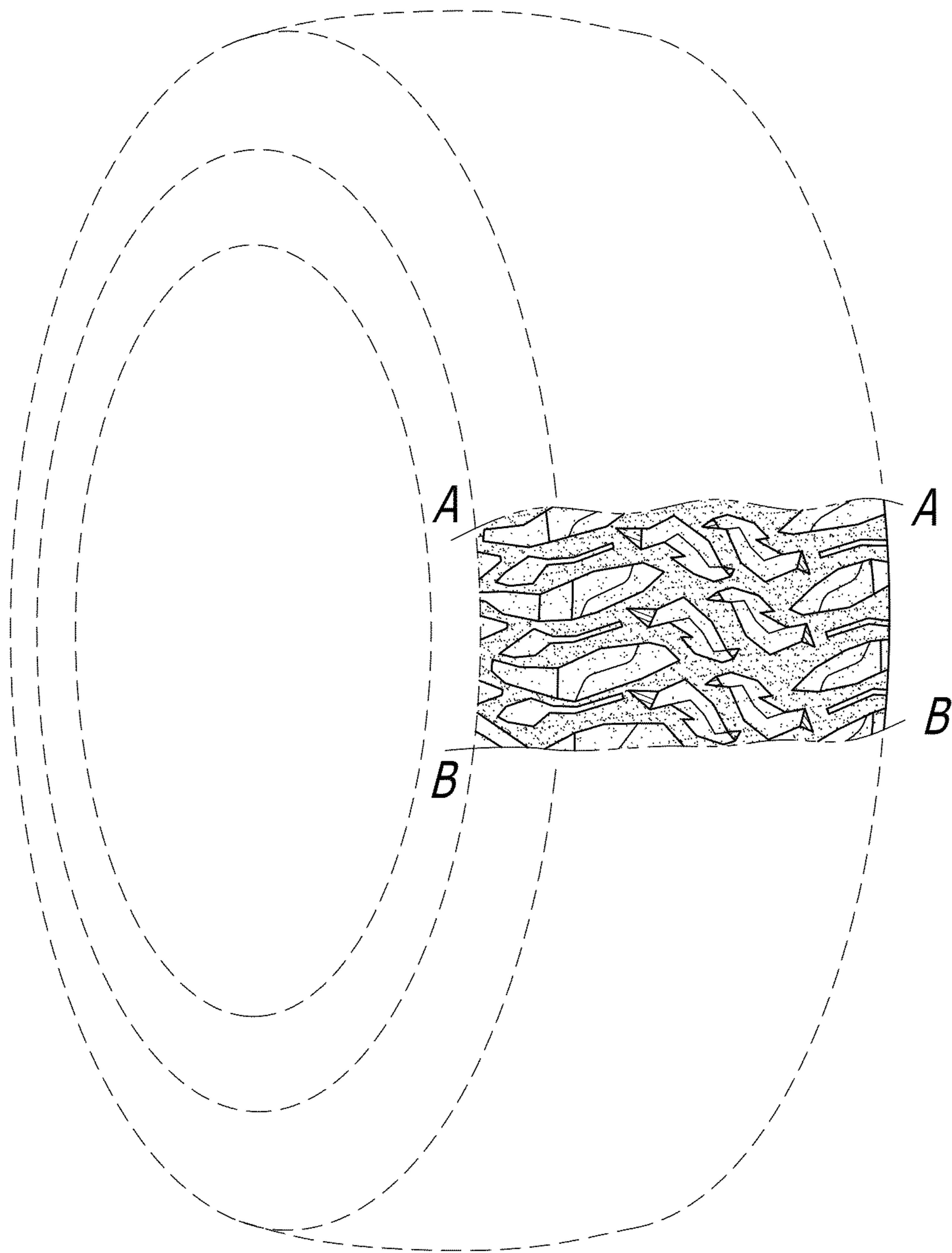
FIG. 8 is an enlarged view of the tire tread defined by lines G-G and H-H.

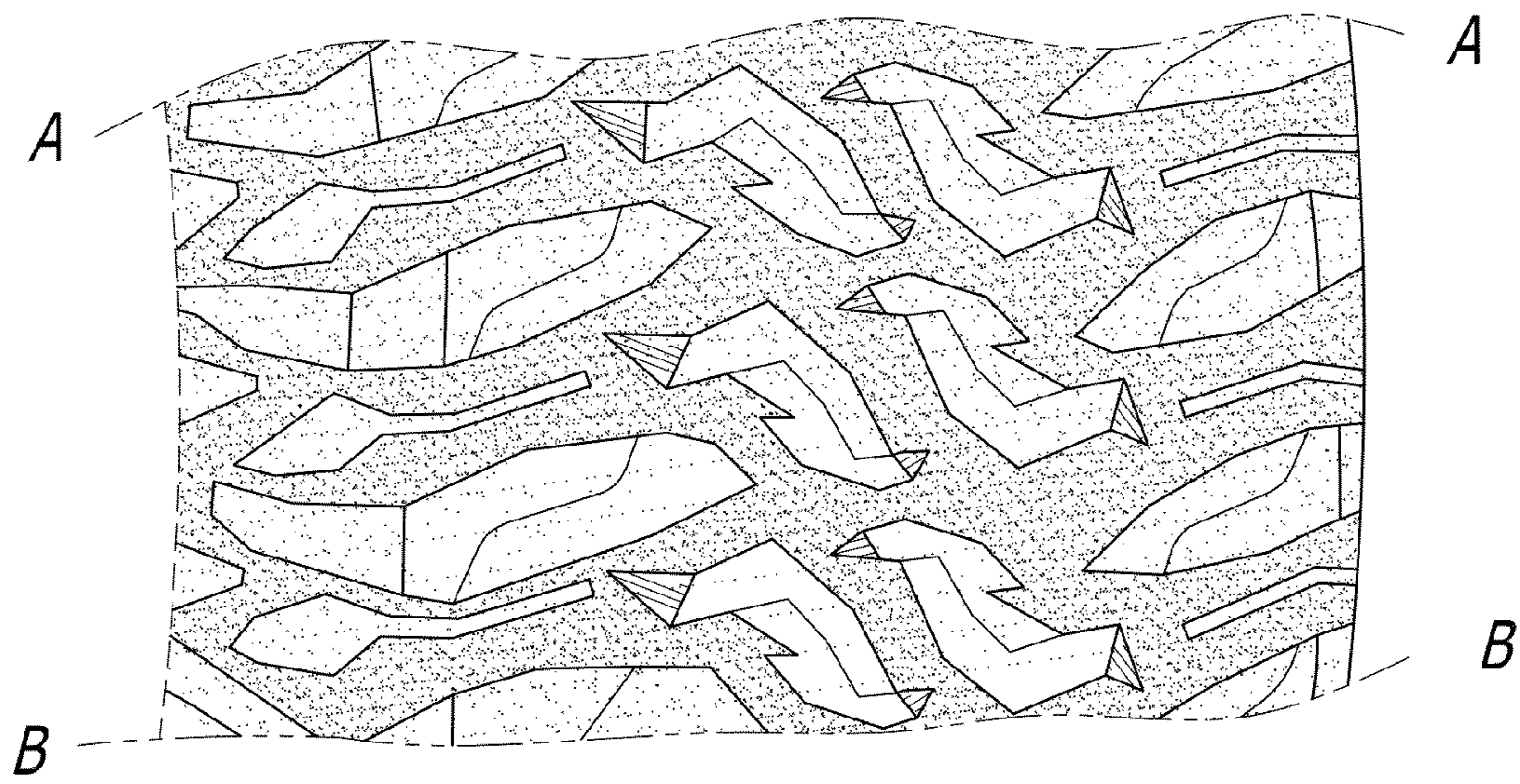
The broken line showing of the tire in FIGS. 1-8 is included for illustrative purposes only, and forms no part of the claimed design.

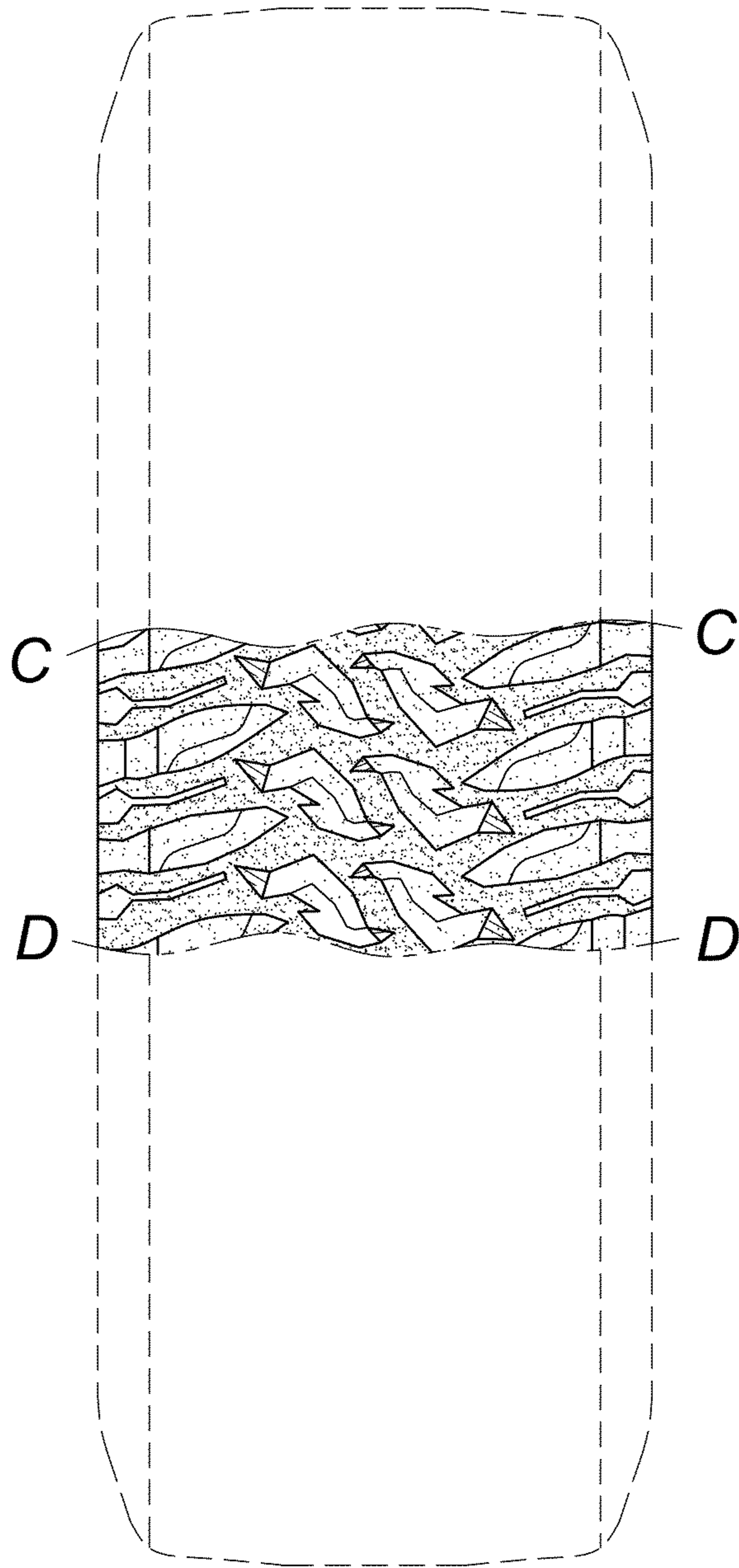

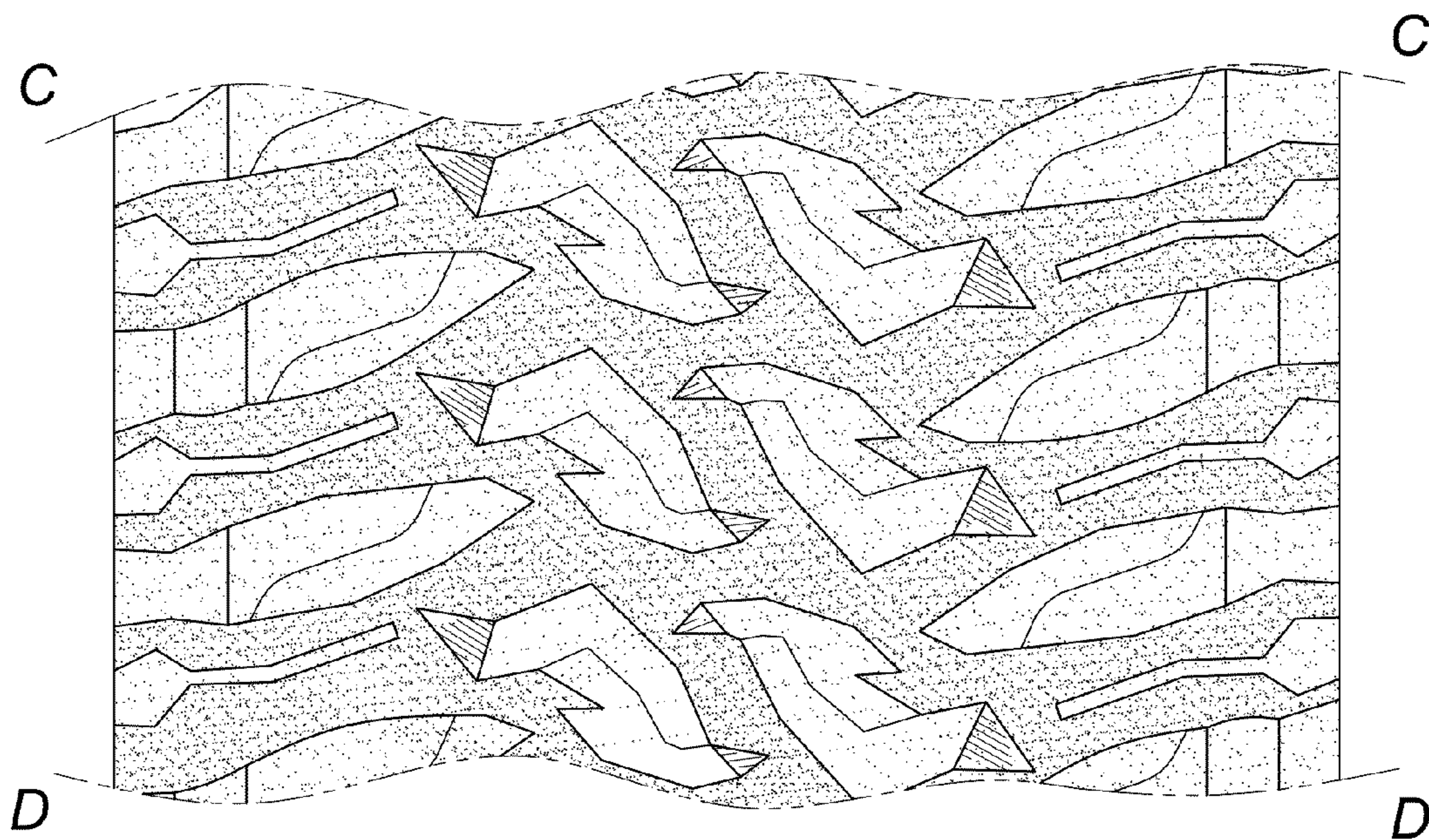

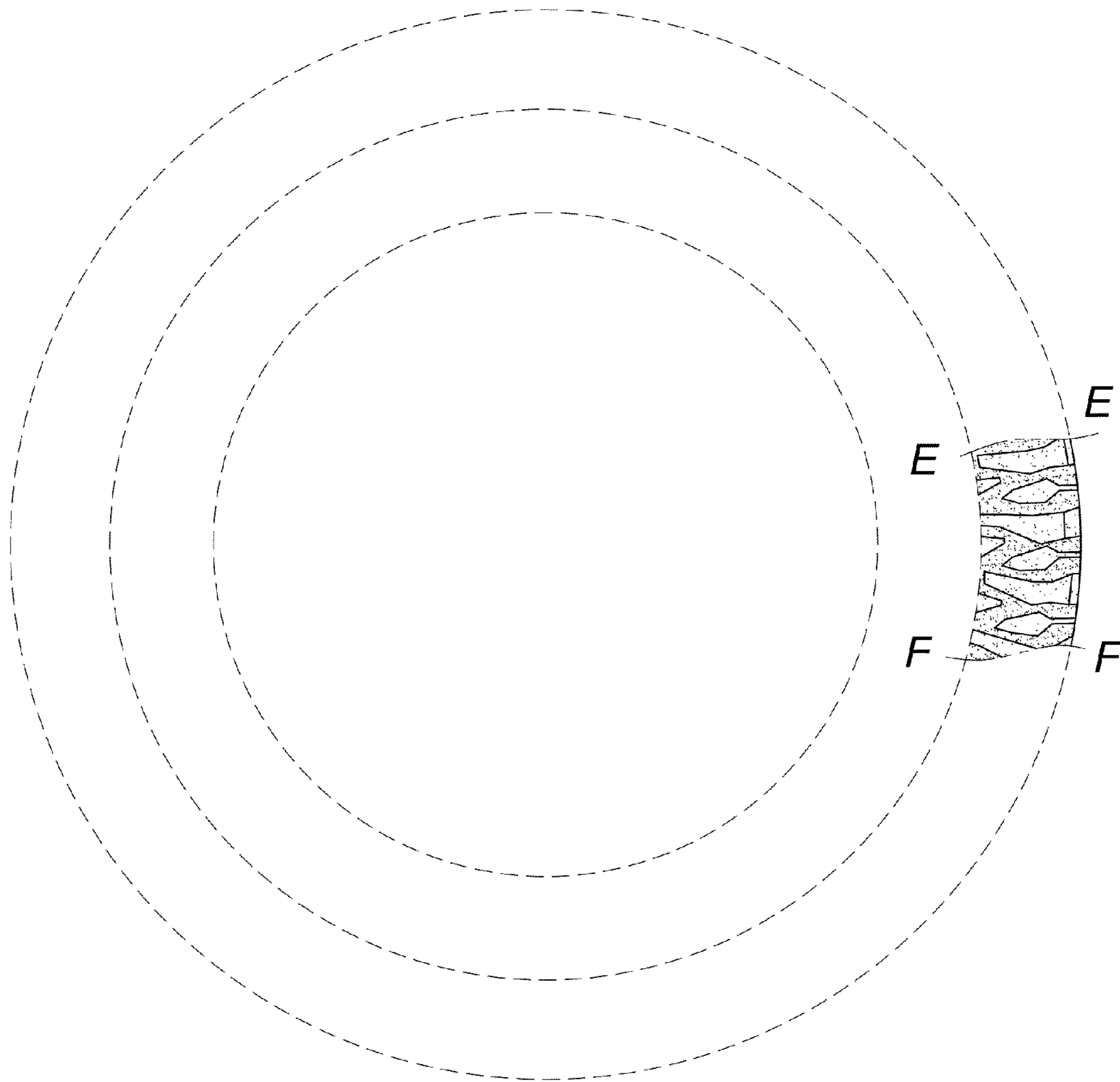

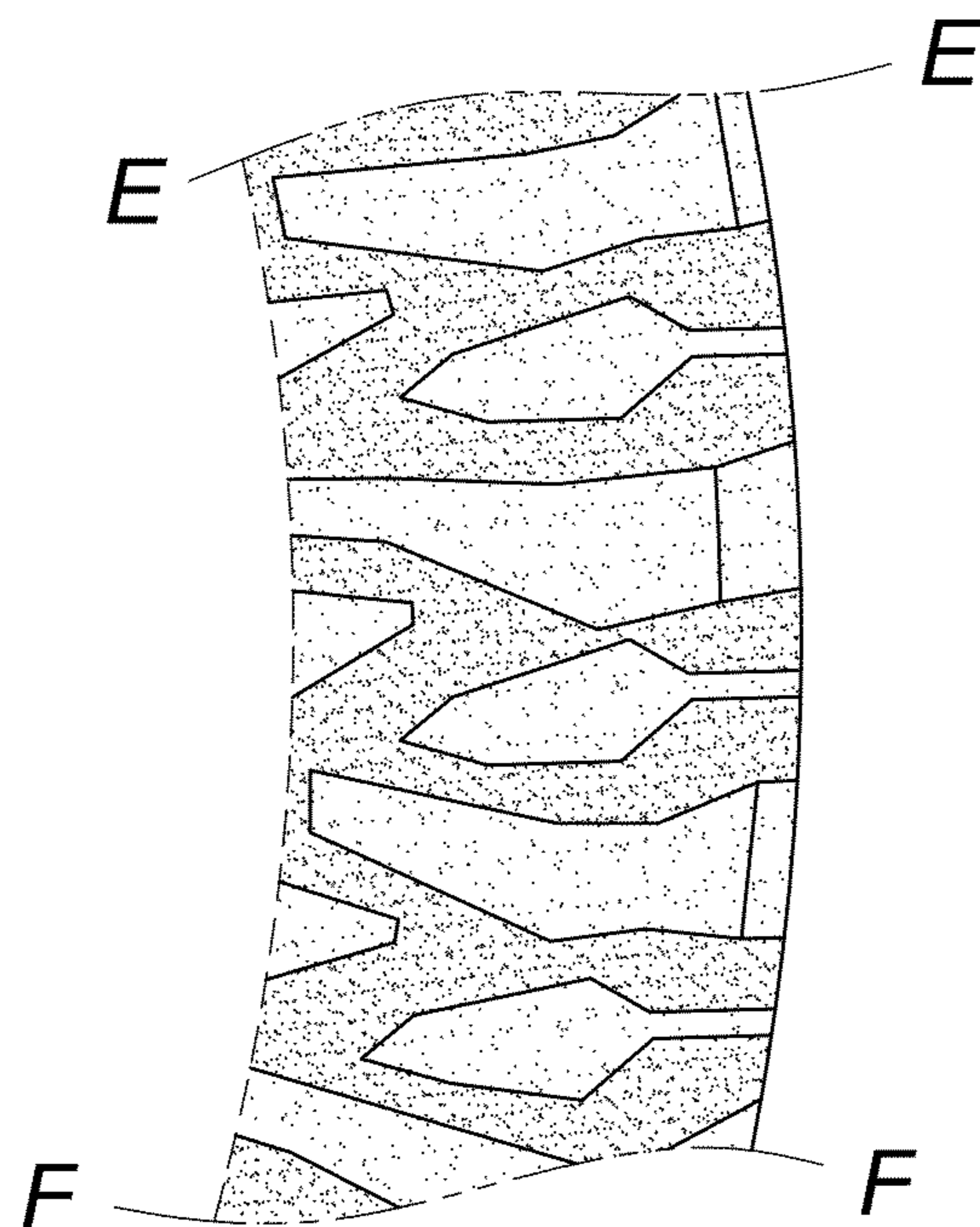

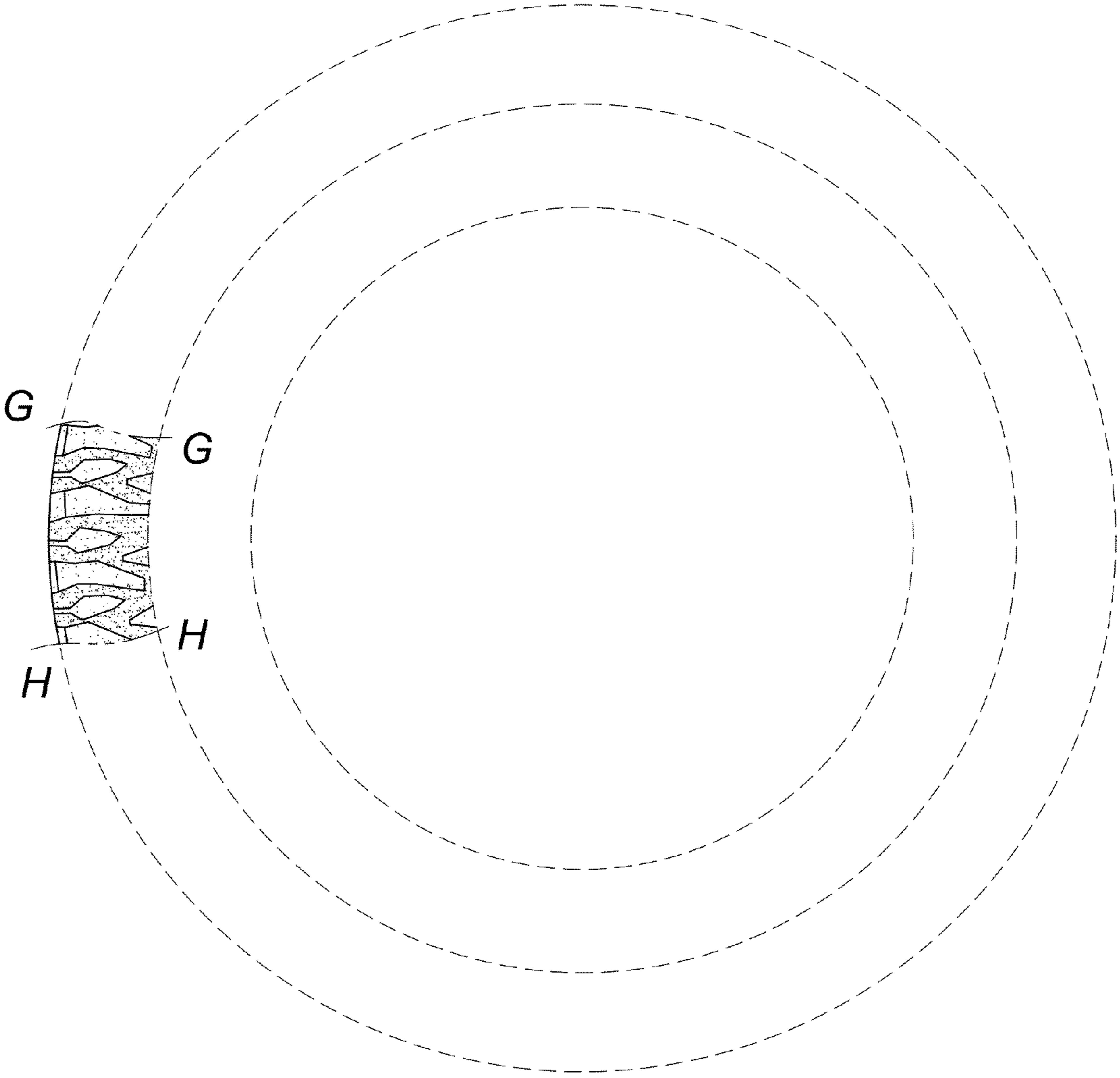
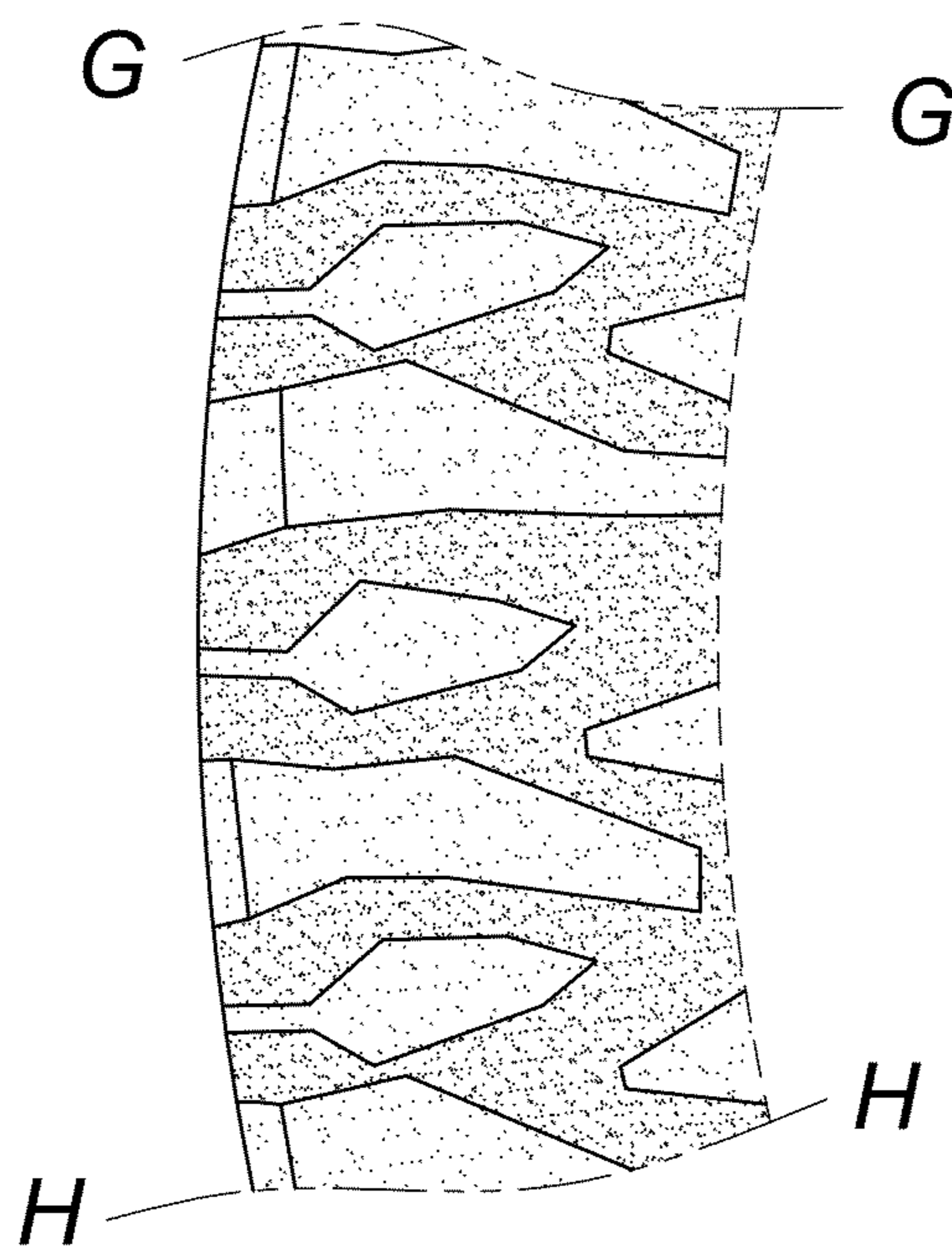
