DESCRIPTION

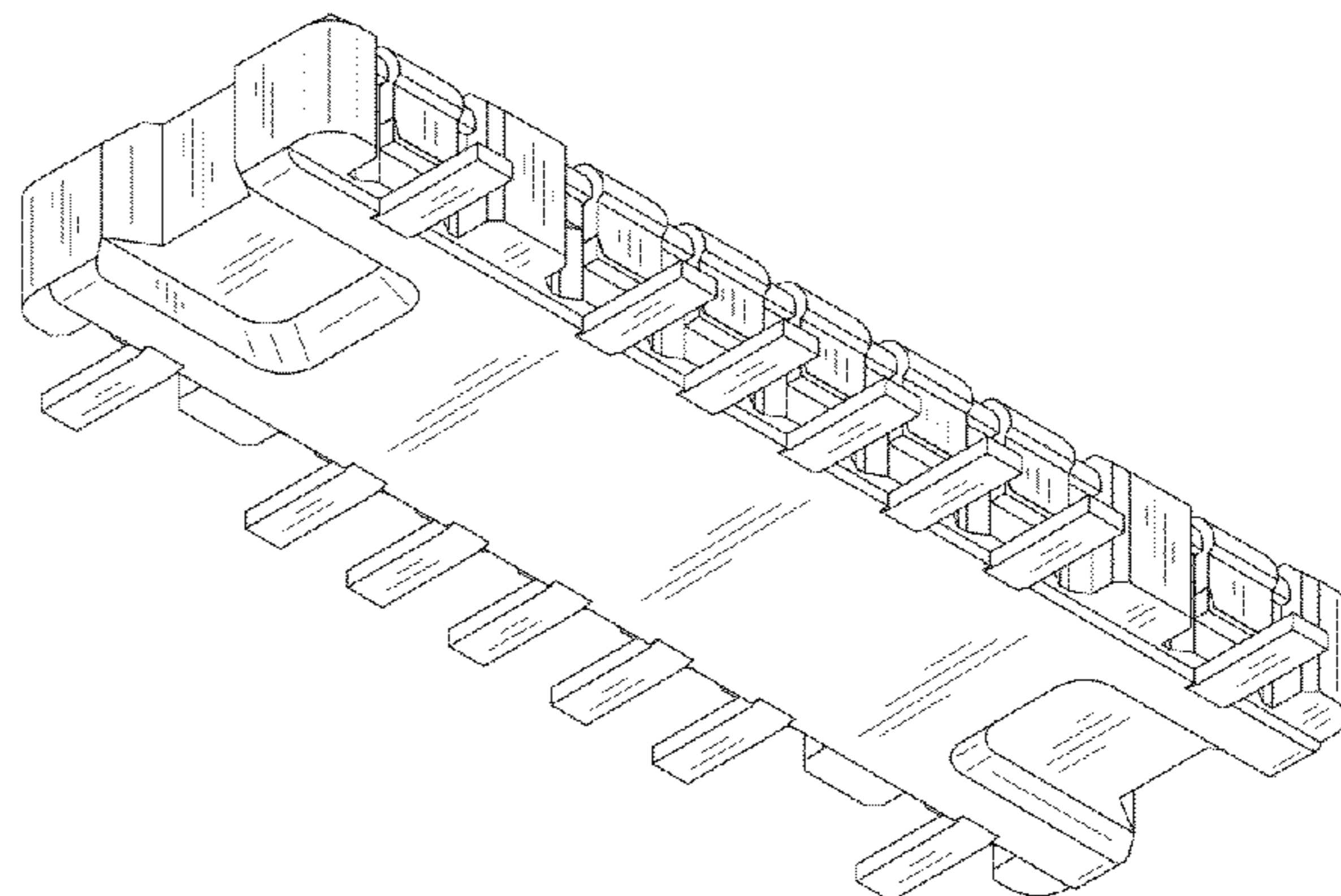
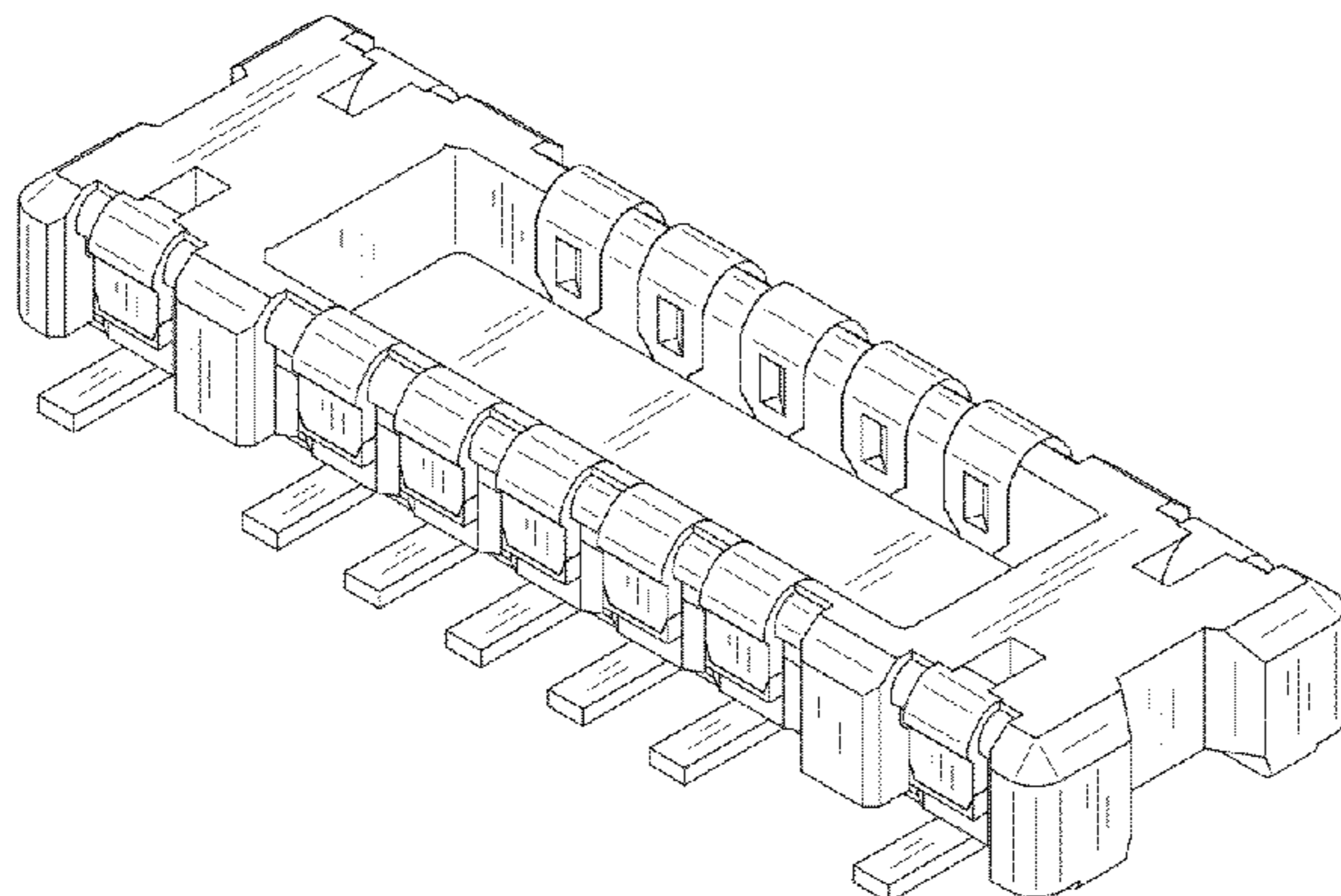

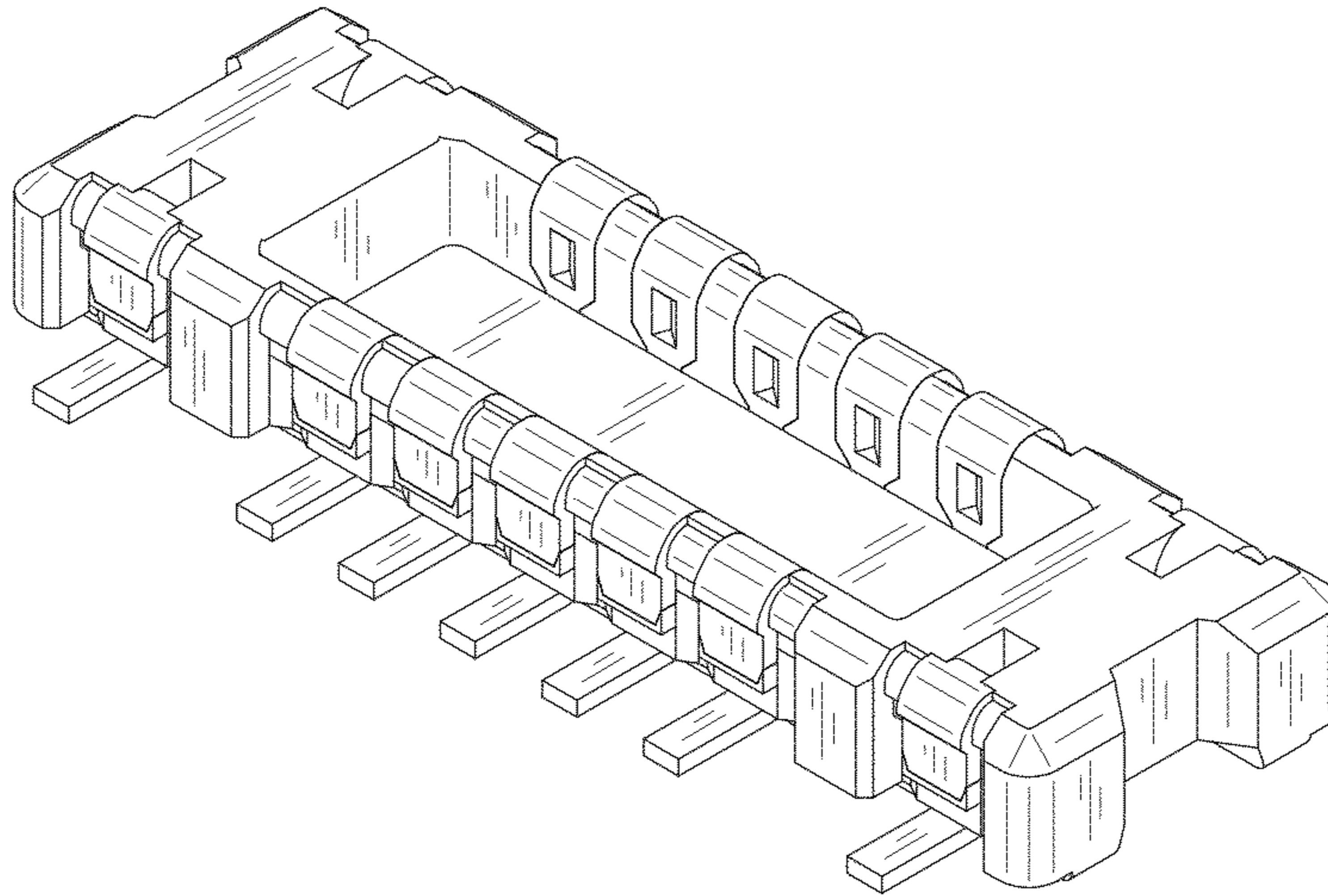

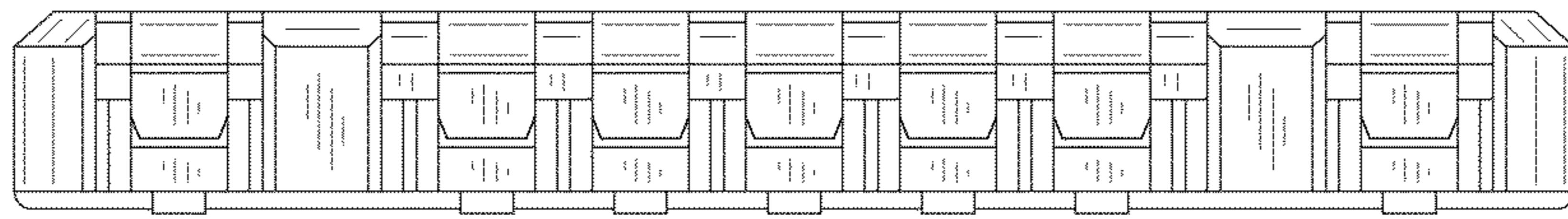

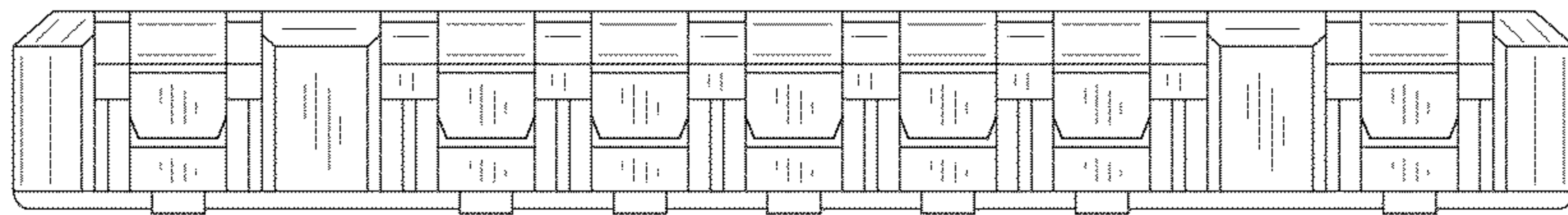

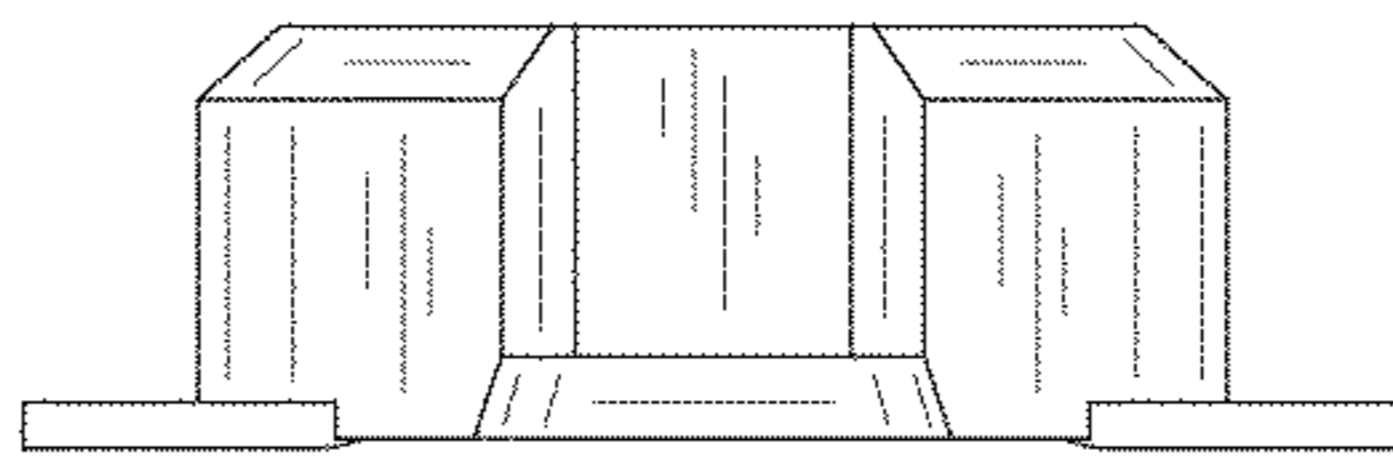

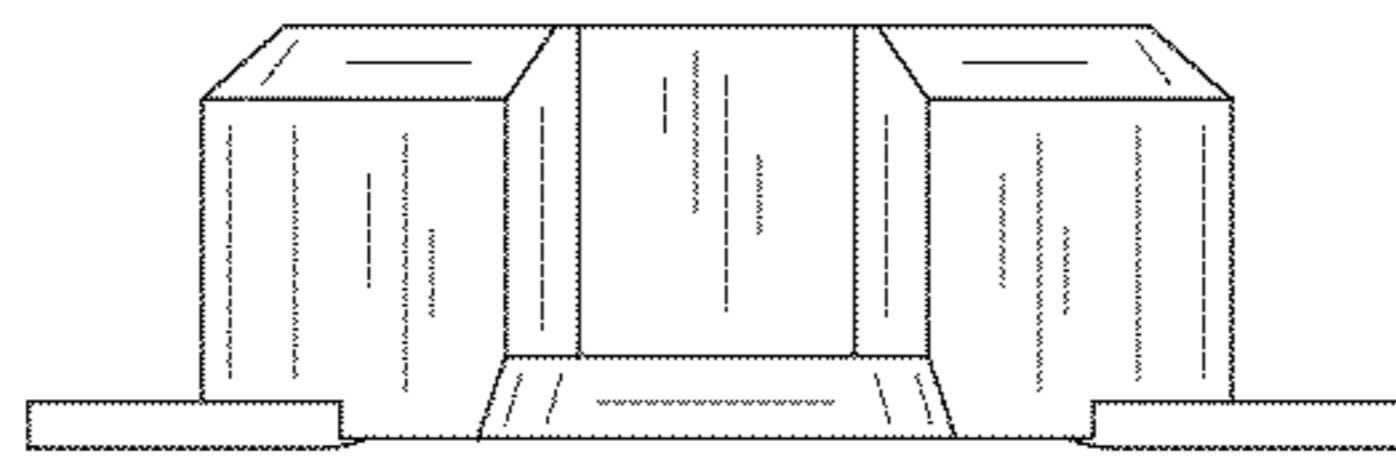

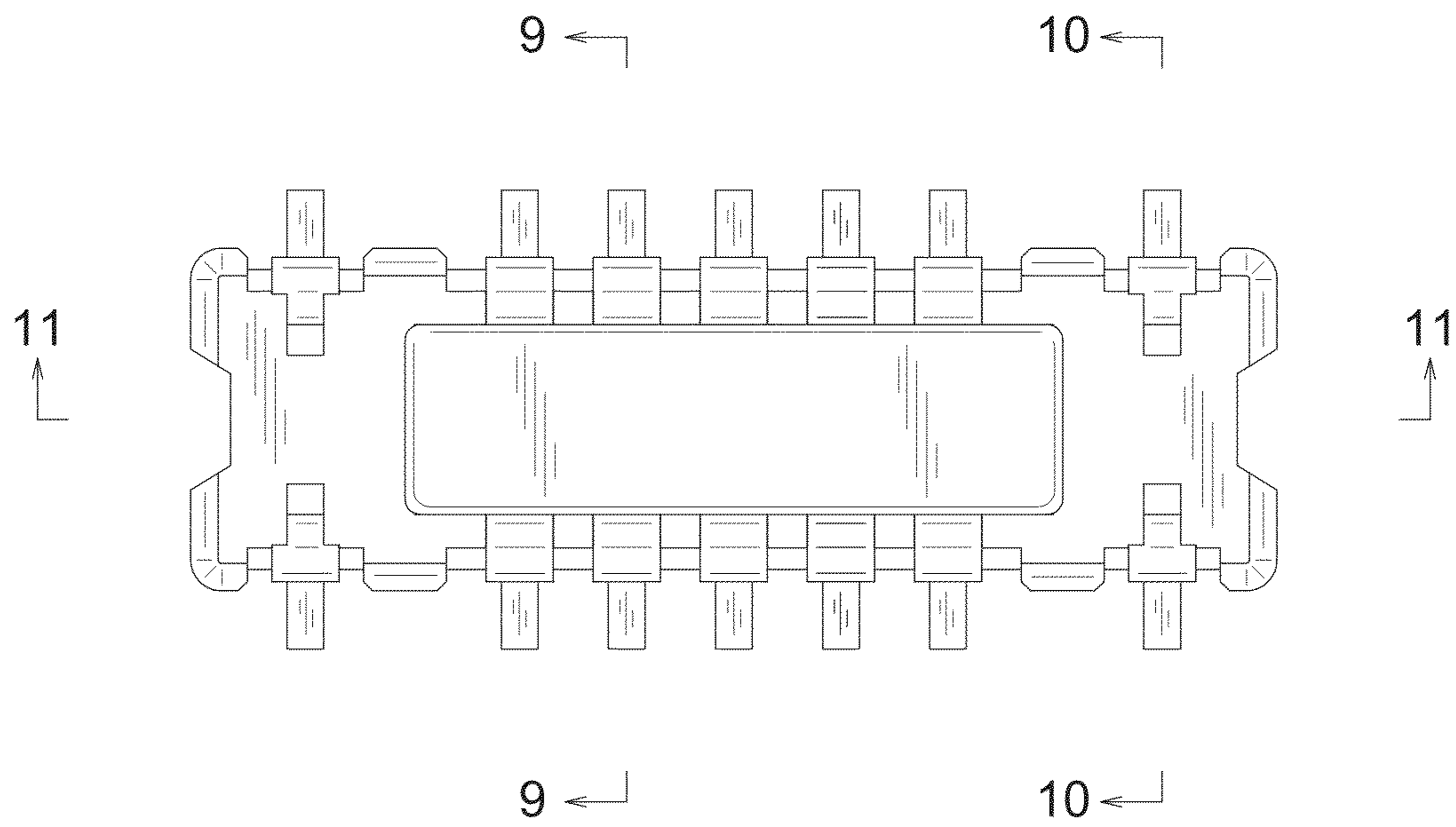

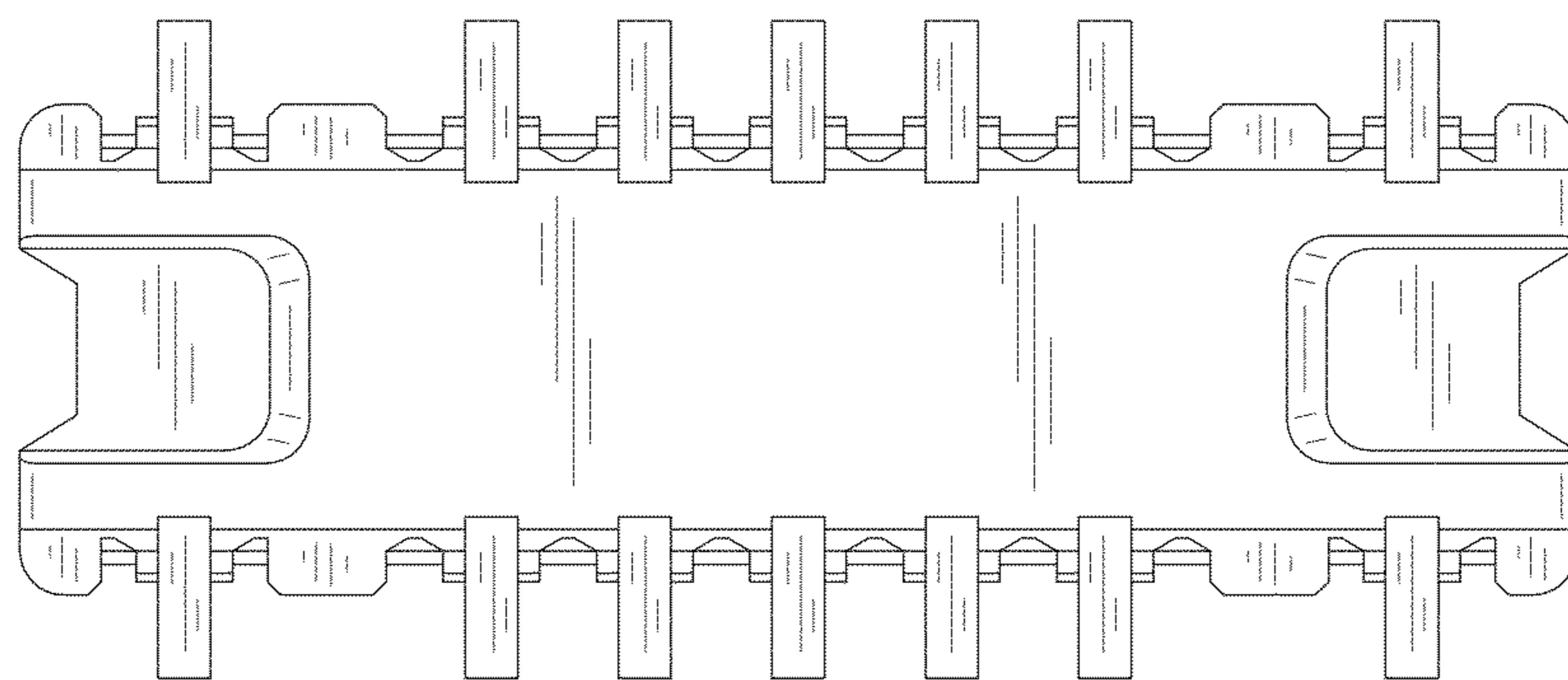

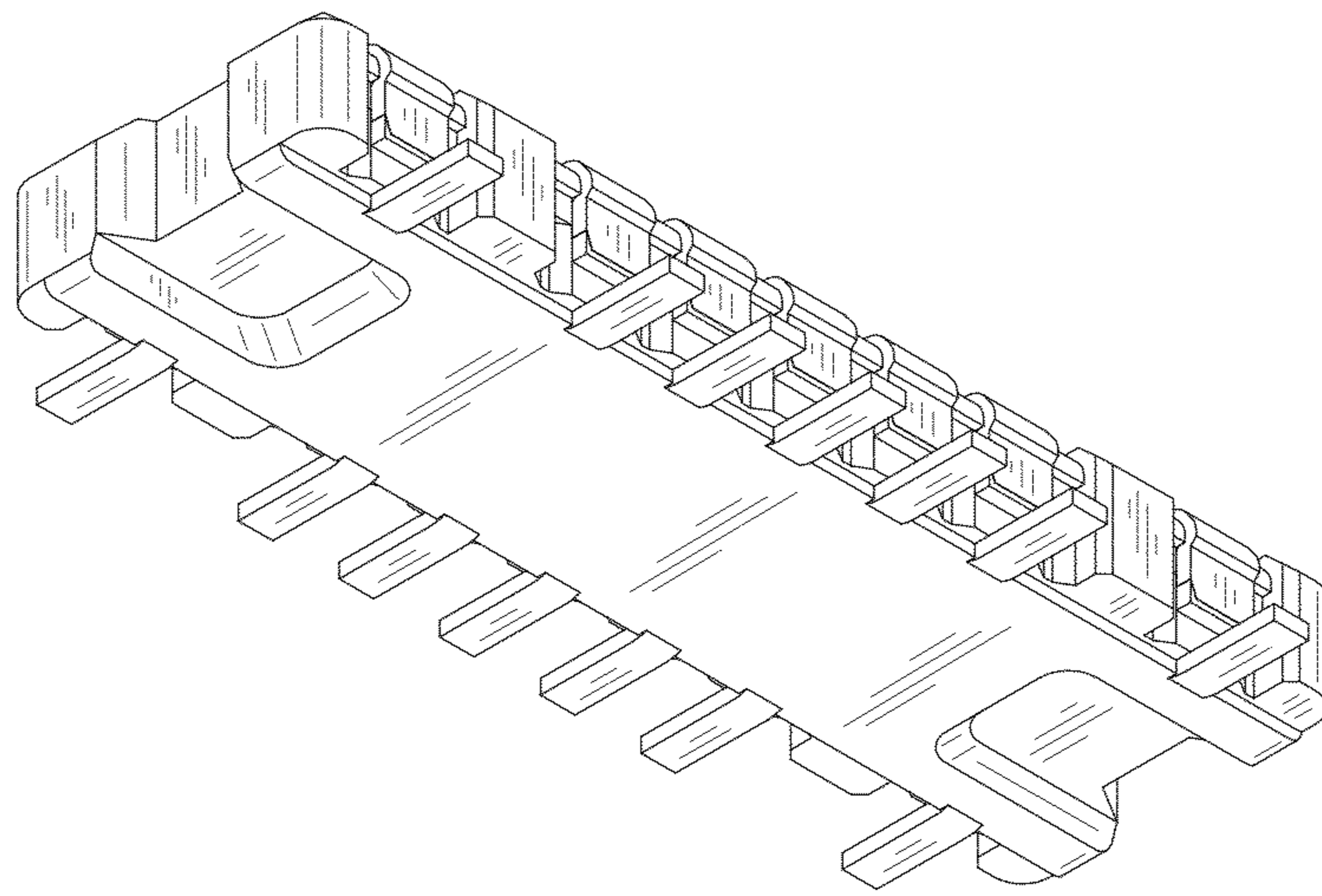

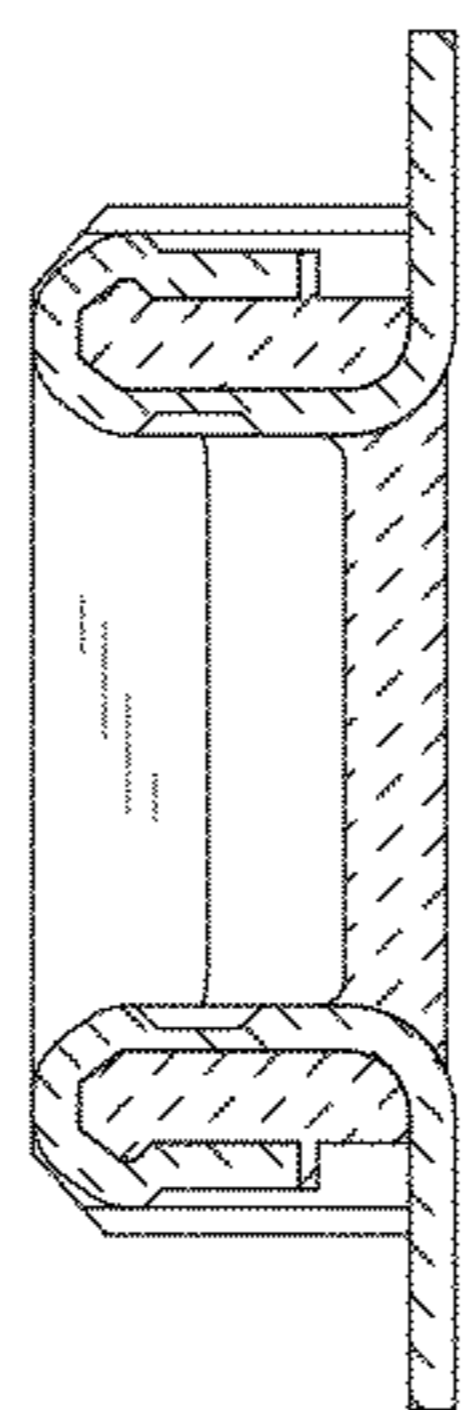

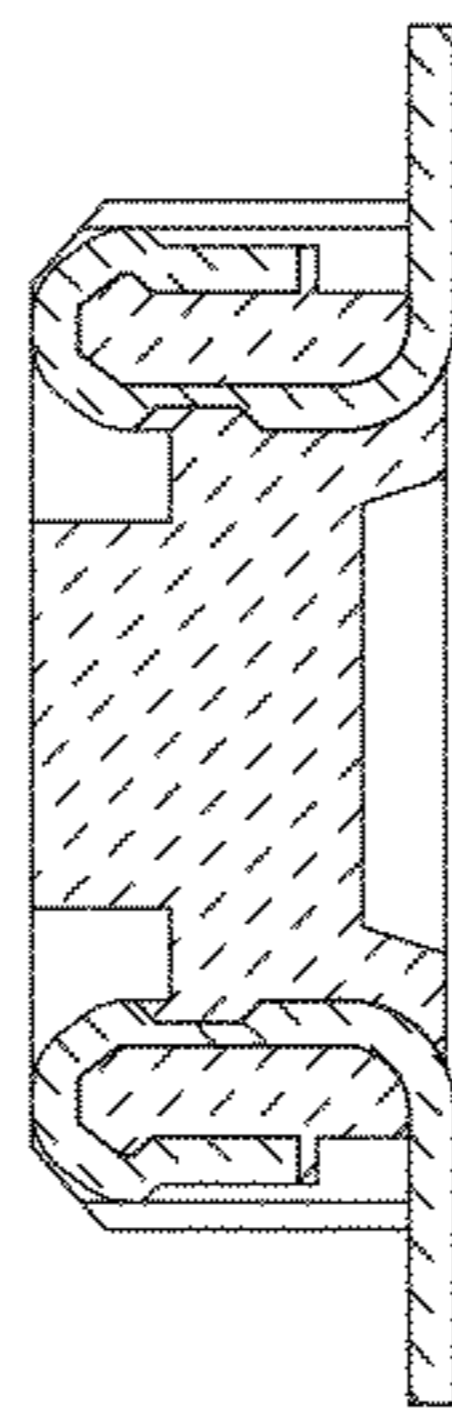
