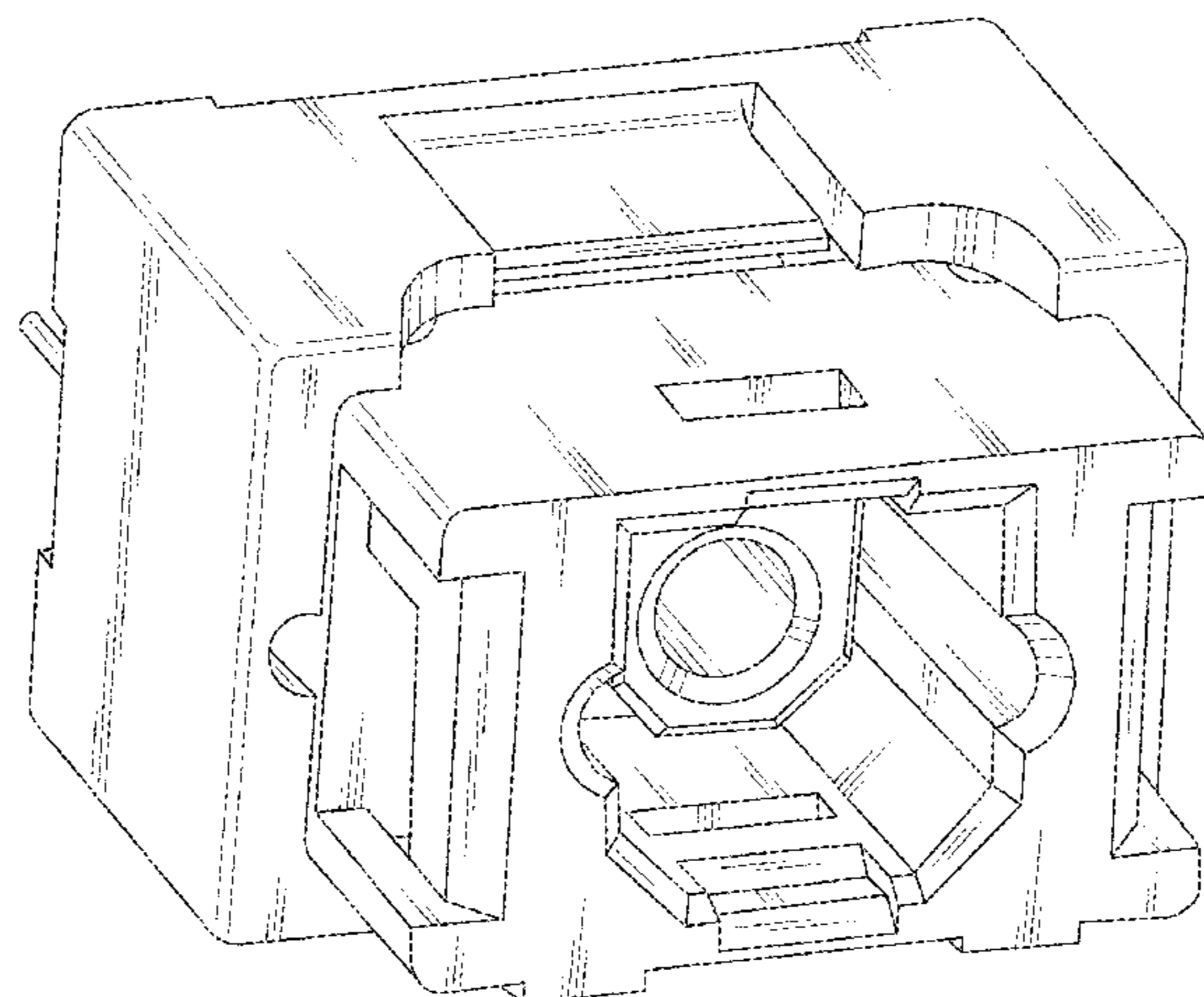
(57) **CLAIM**

The ornamental design for an optoelectronic converting connector for optical fibers, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and left side perspective view of an optoelectronic converting connector for optical fibers, showing our new design;
FIG. 2 is a rear, bottom and right side perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a right side elevational view thereof; the opposite side being a mirror image thereof; and,
FIG. 8 is an enlarged cross sectional view thereof, taken along the line 8-8 in FIG. 3.

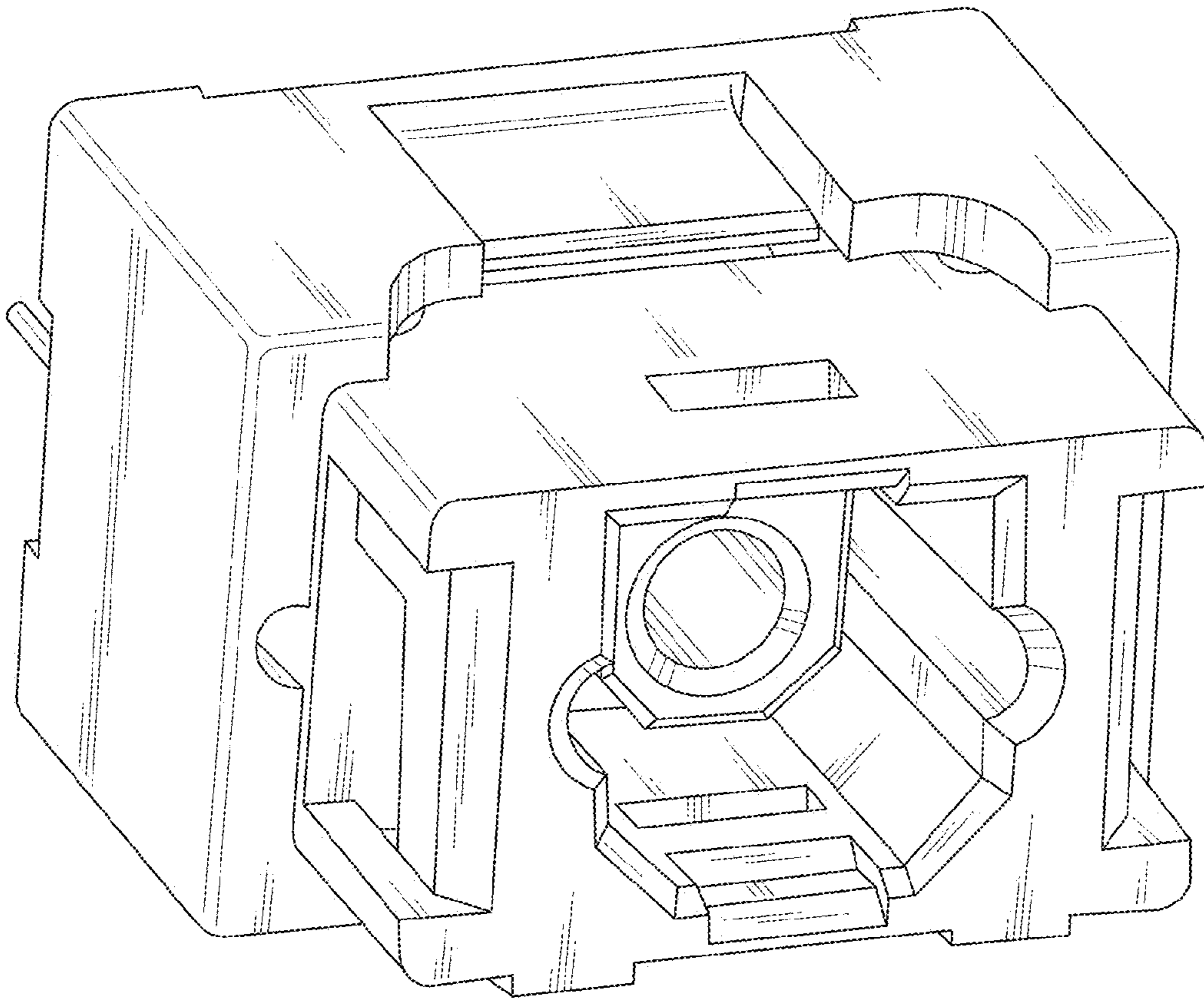

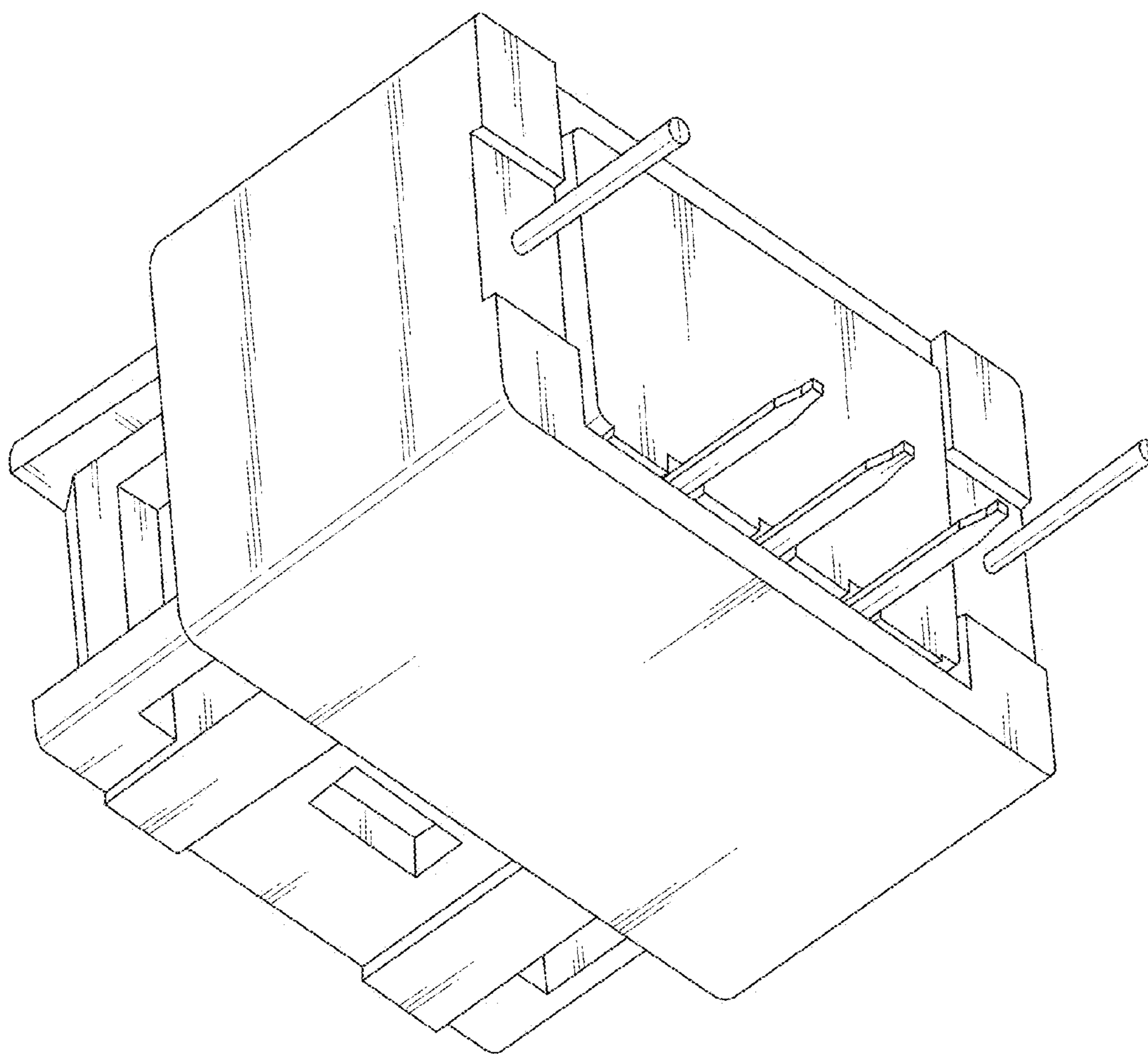

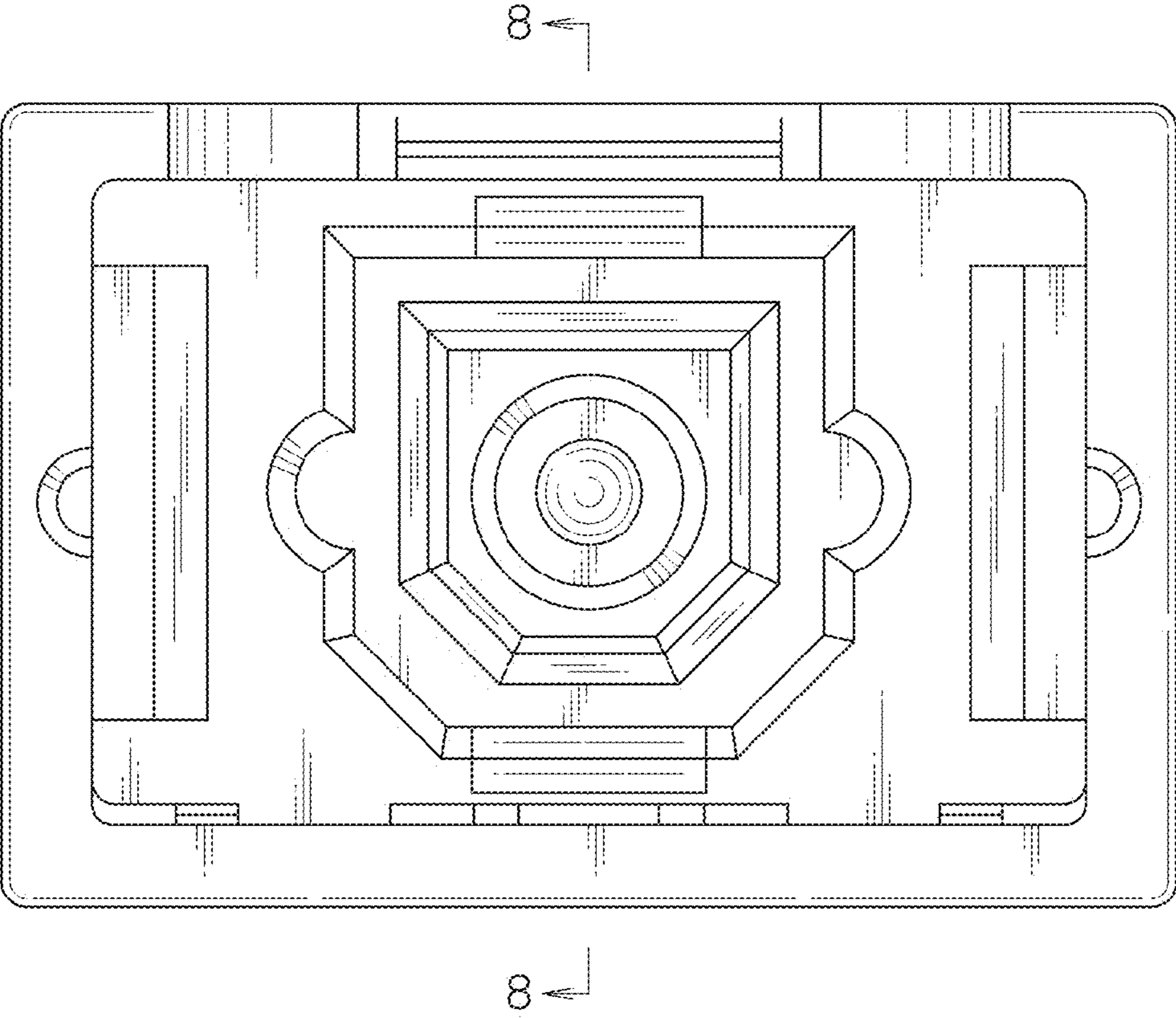

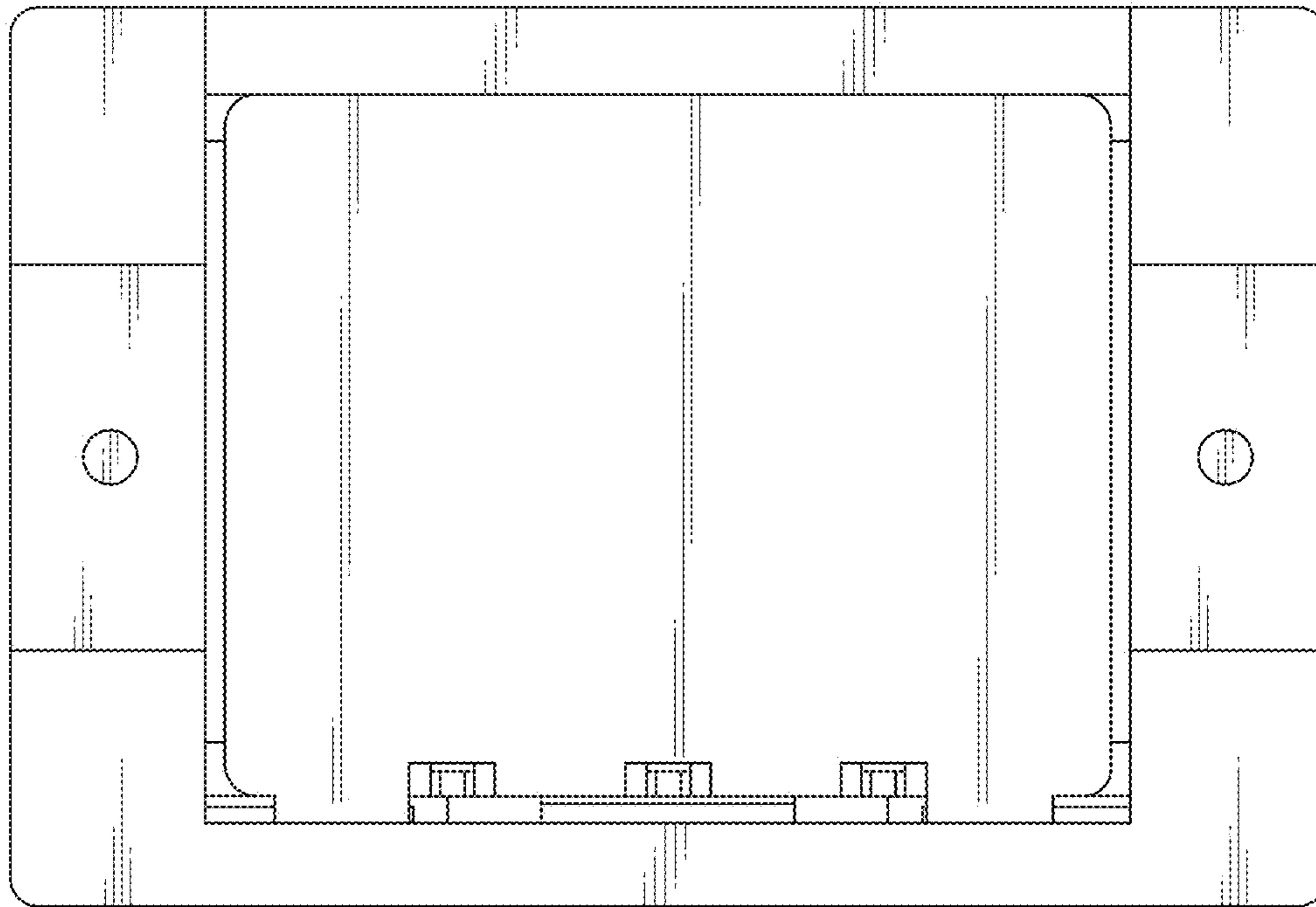

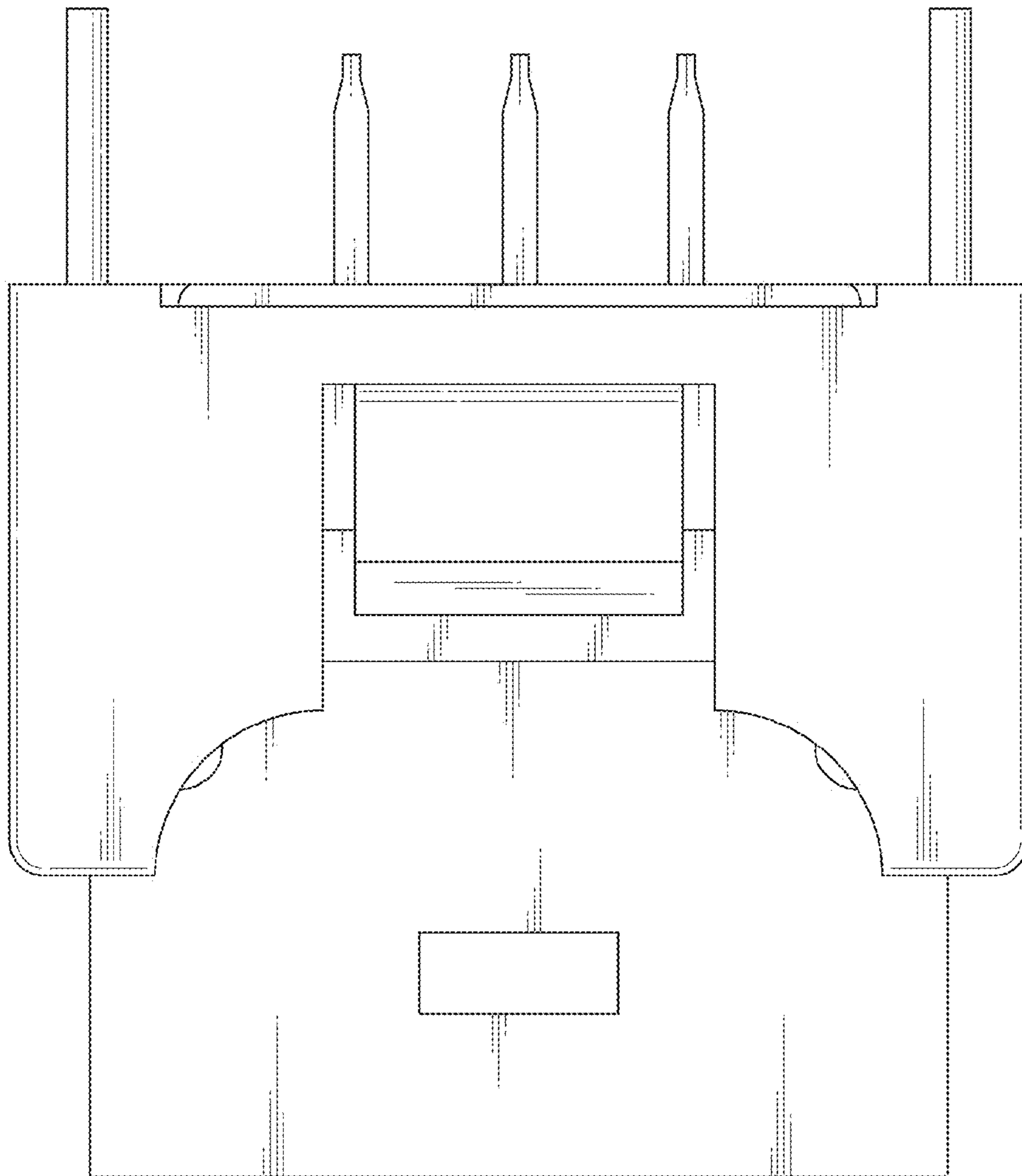

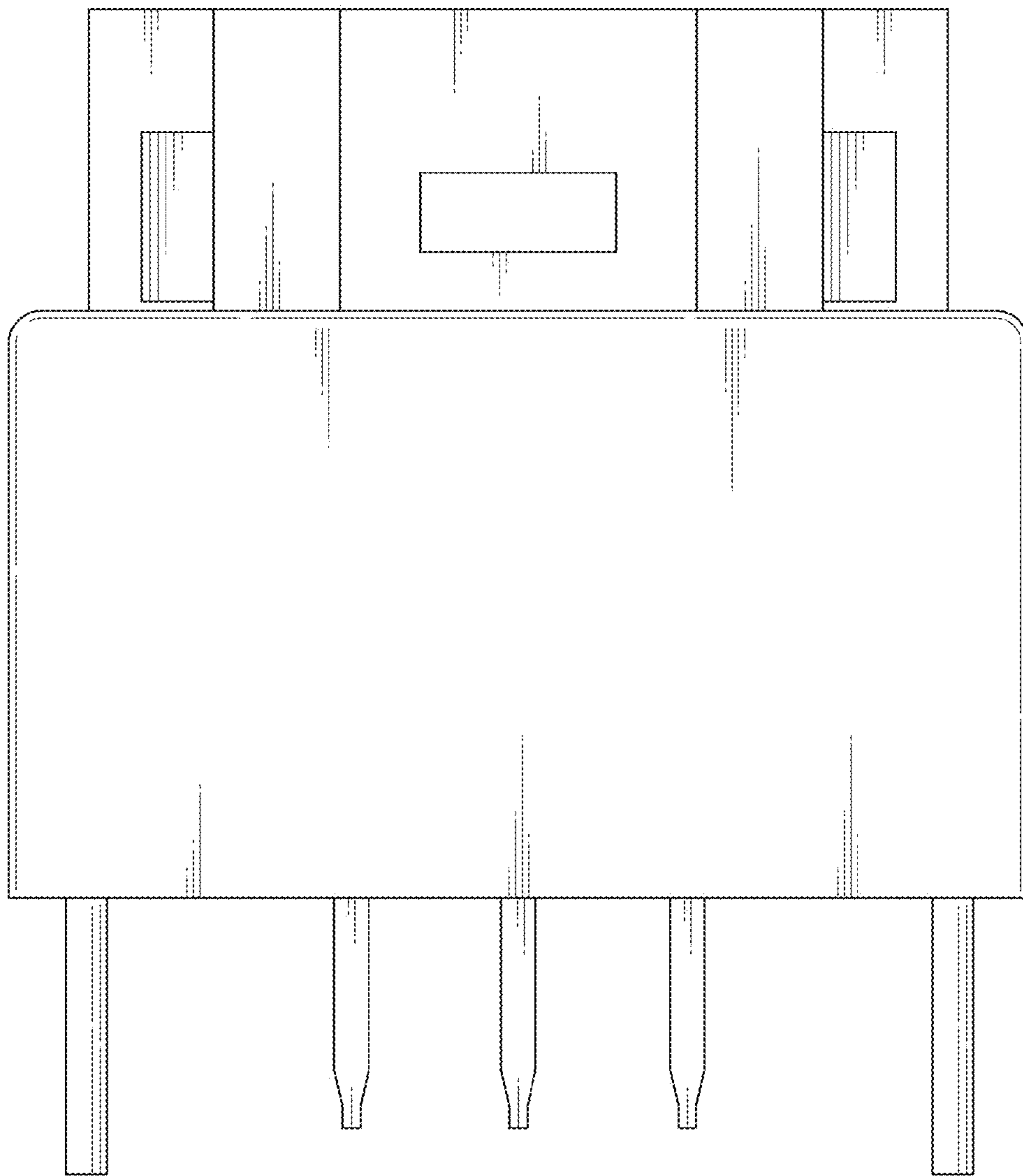

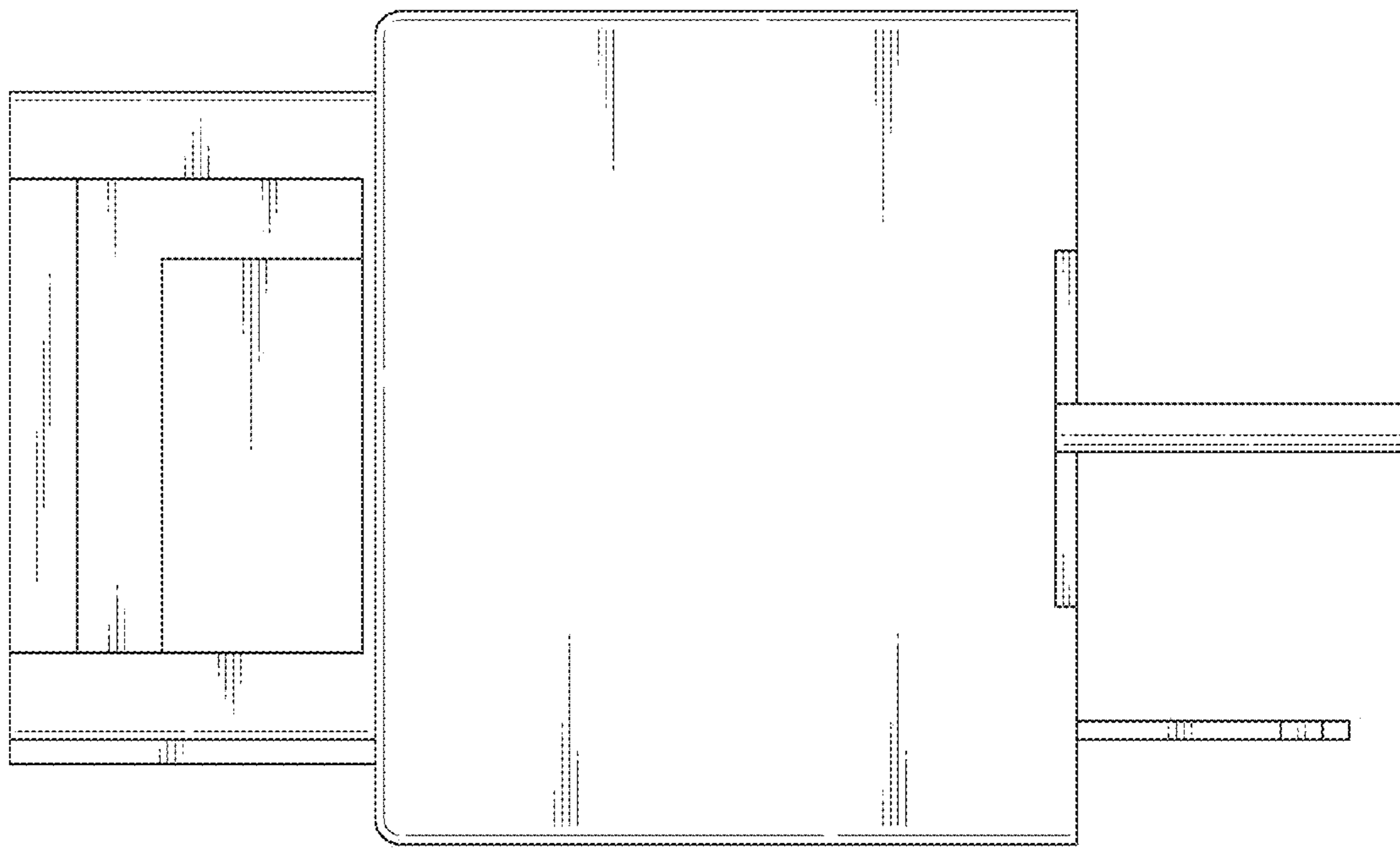

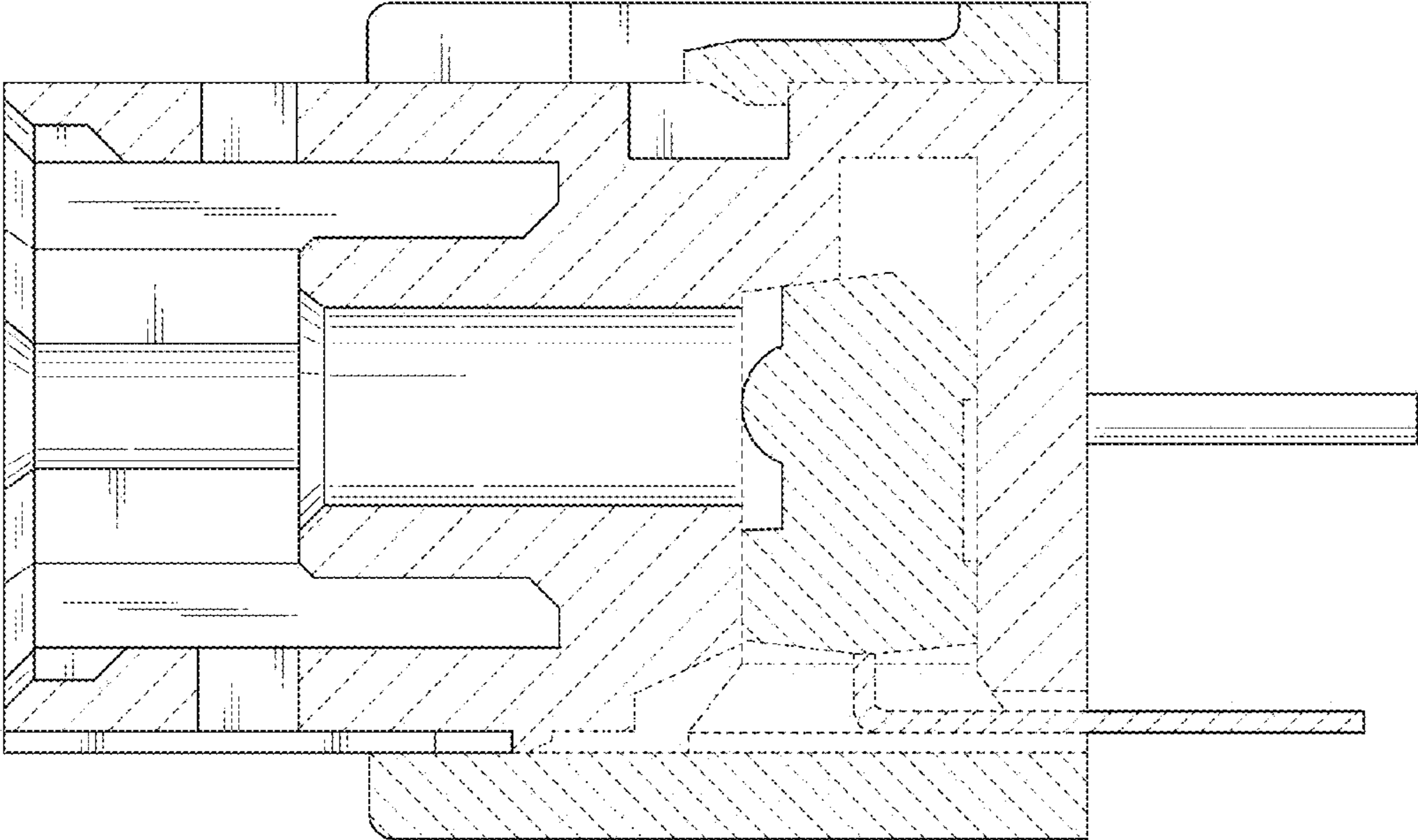
