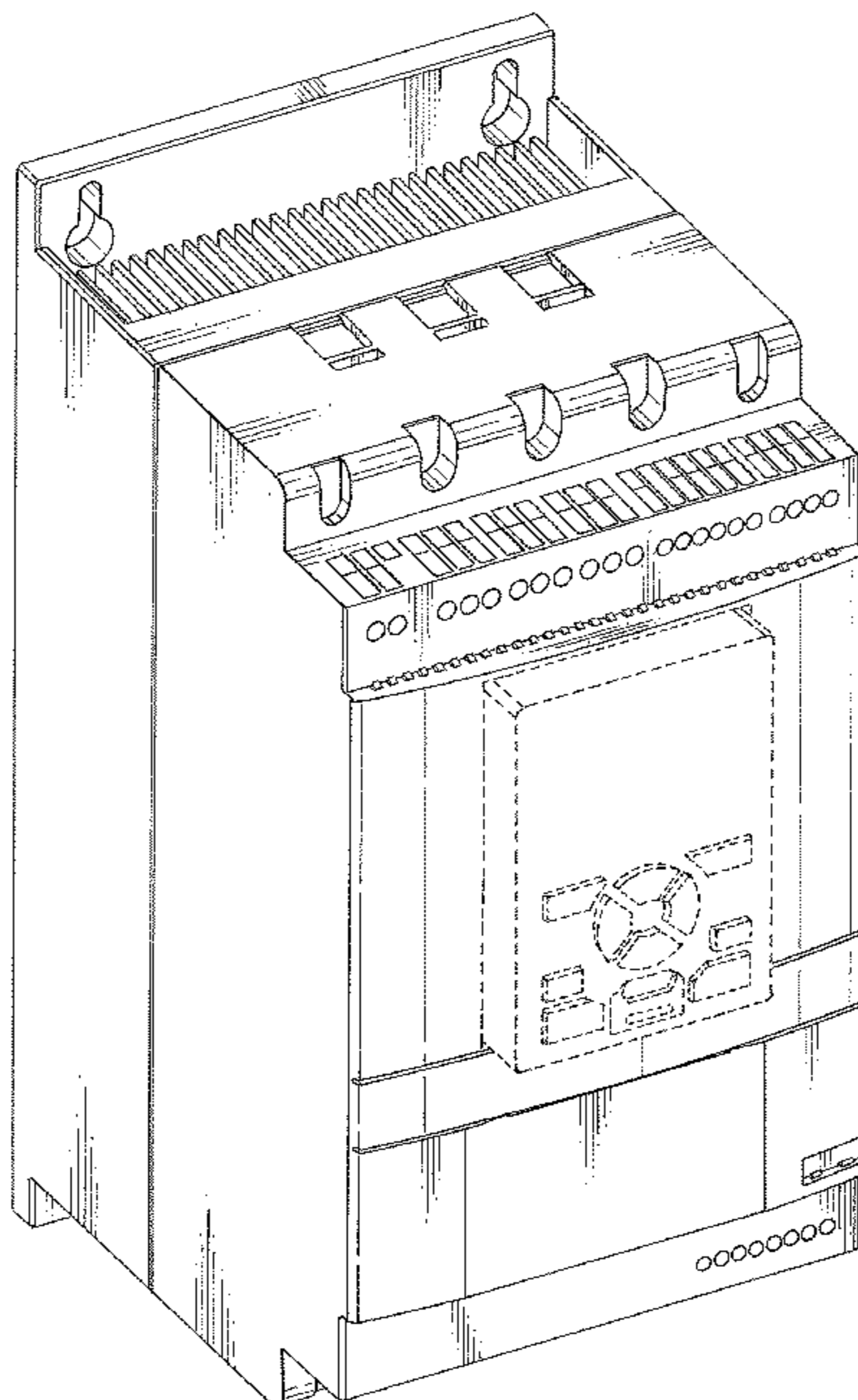
(57) **CLAIM**

The ornamental design for a softstarter, as shown and described.

DESCRIPTION

FIG. 1 is a front right side isometric view of a softstarter in accordance with the new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a right side elevation view thereof; and,
FIG. 7 is a left side elevation view thereof.
The broken lines shown in FIGS. 1-7 are for the purpose of illustrating unclaimed portions of the softstarter that form no part of the claimed design.

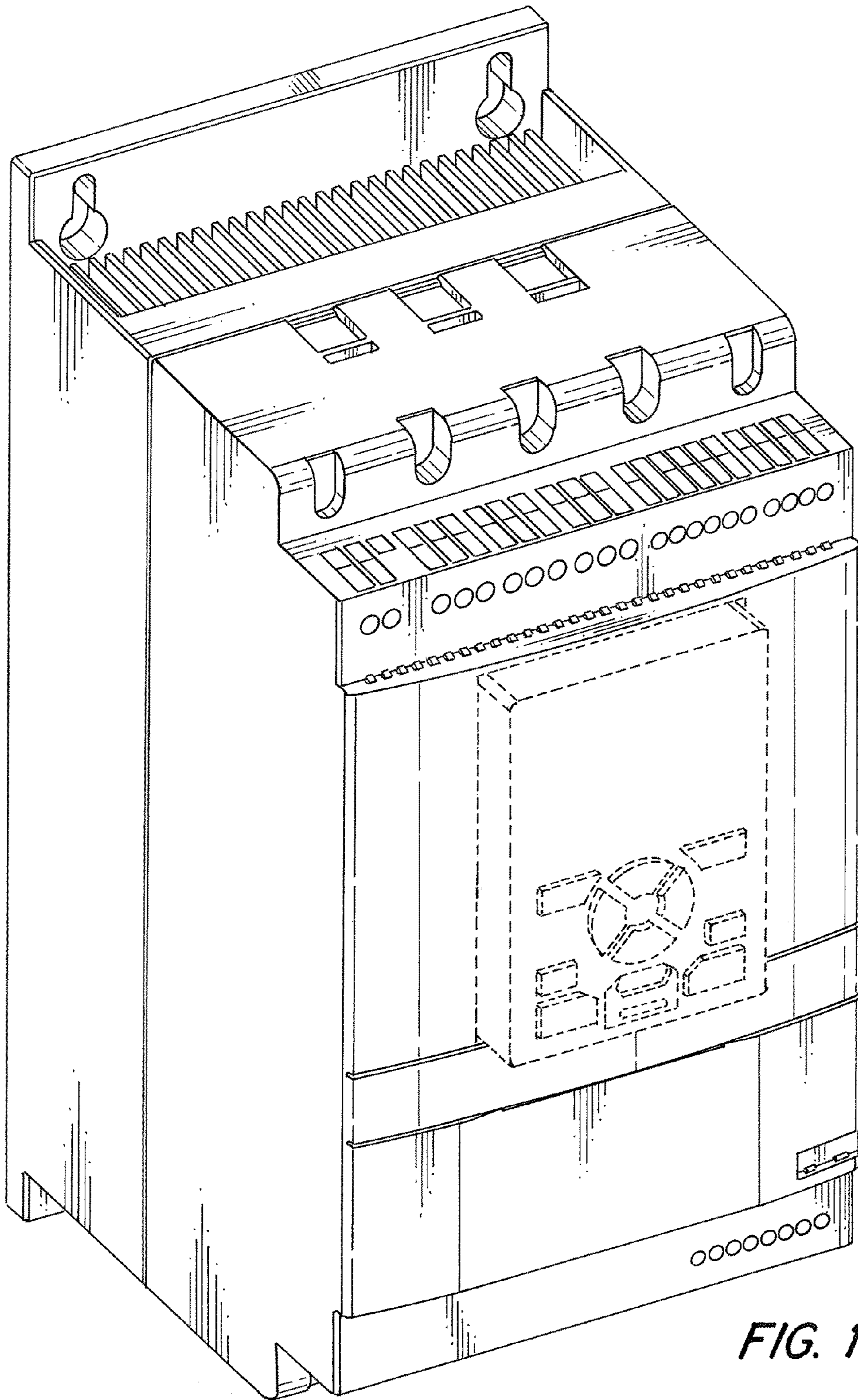

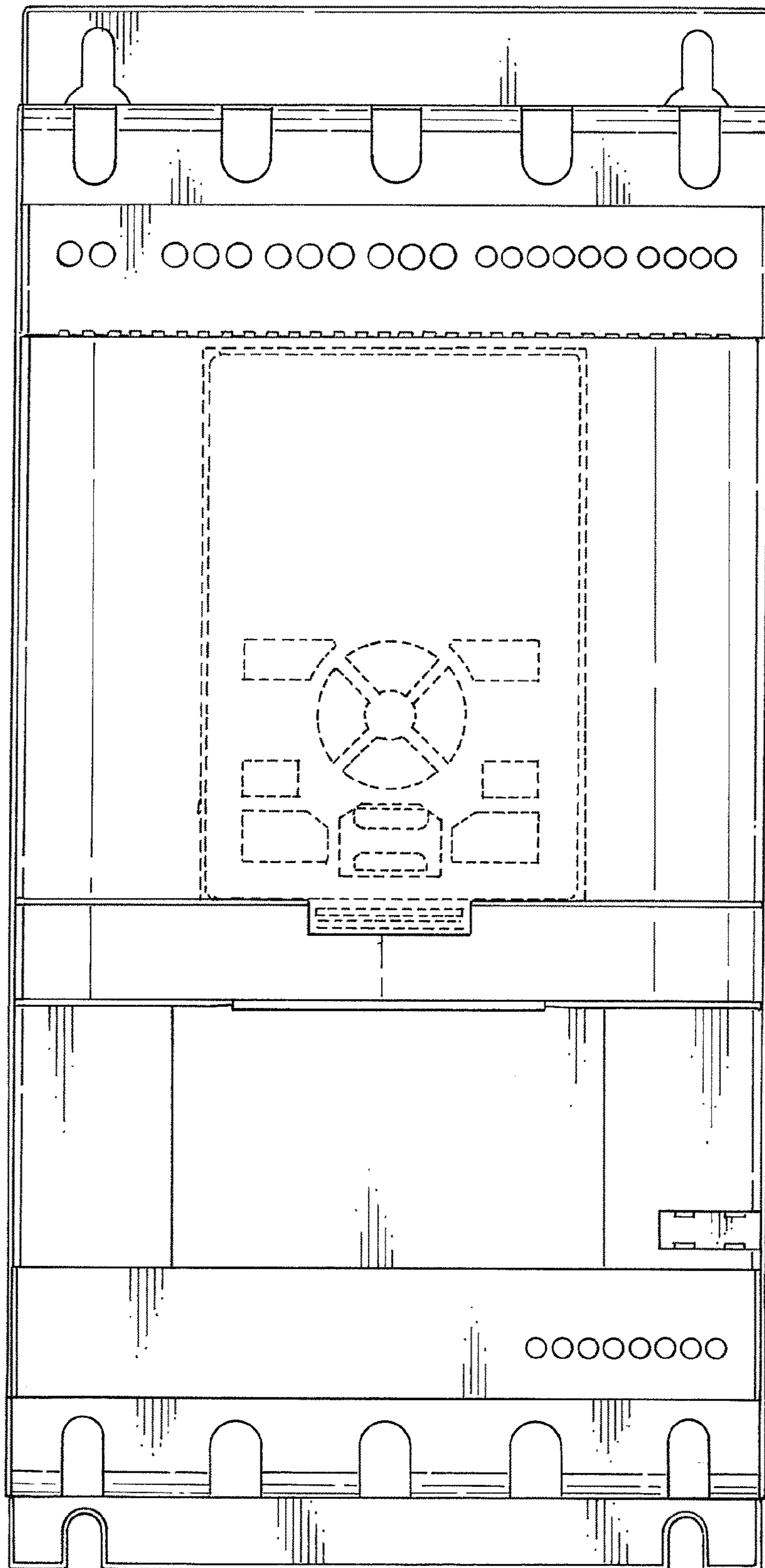

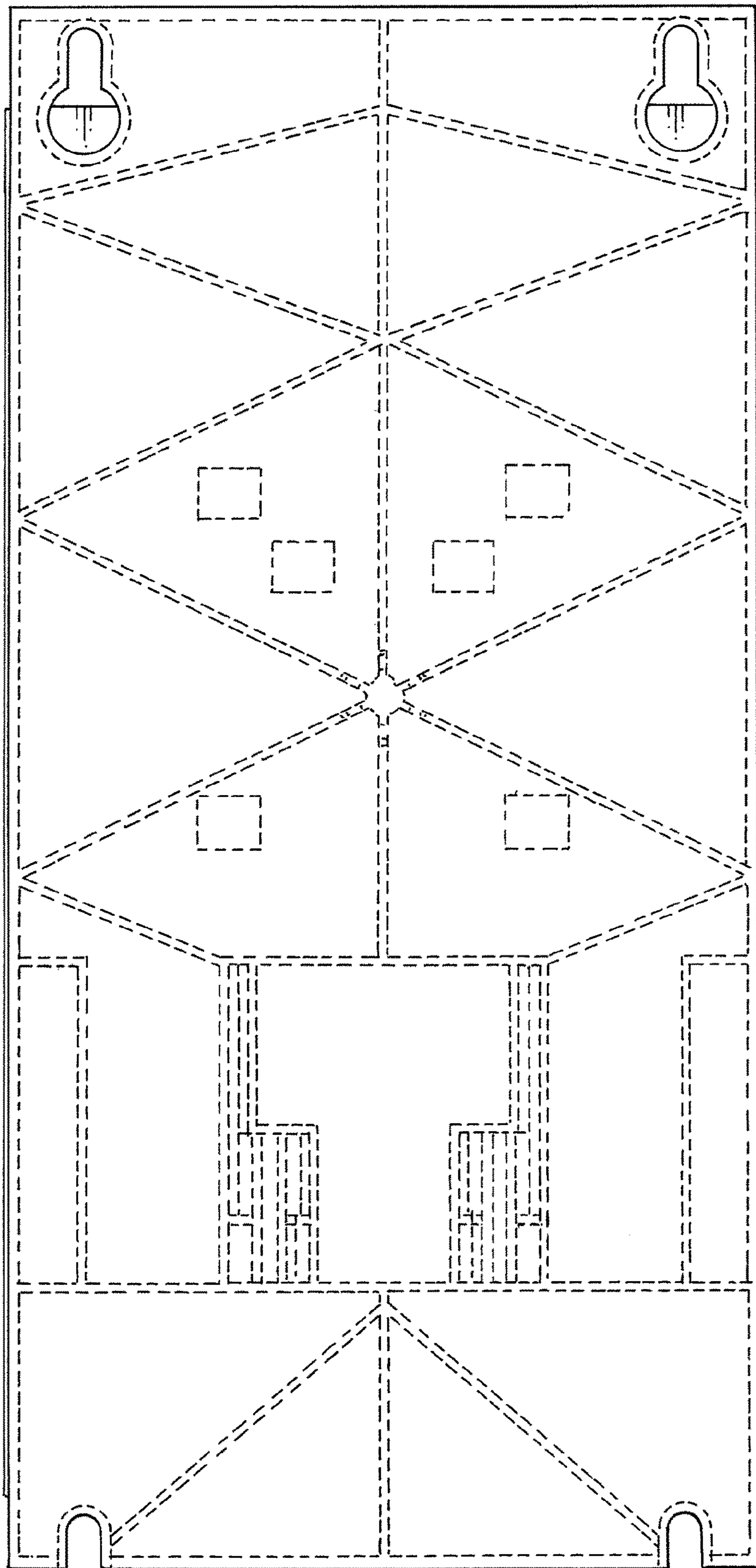

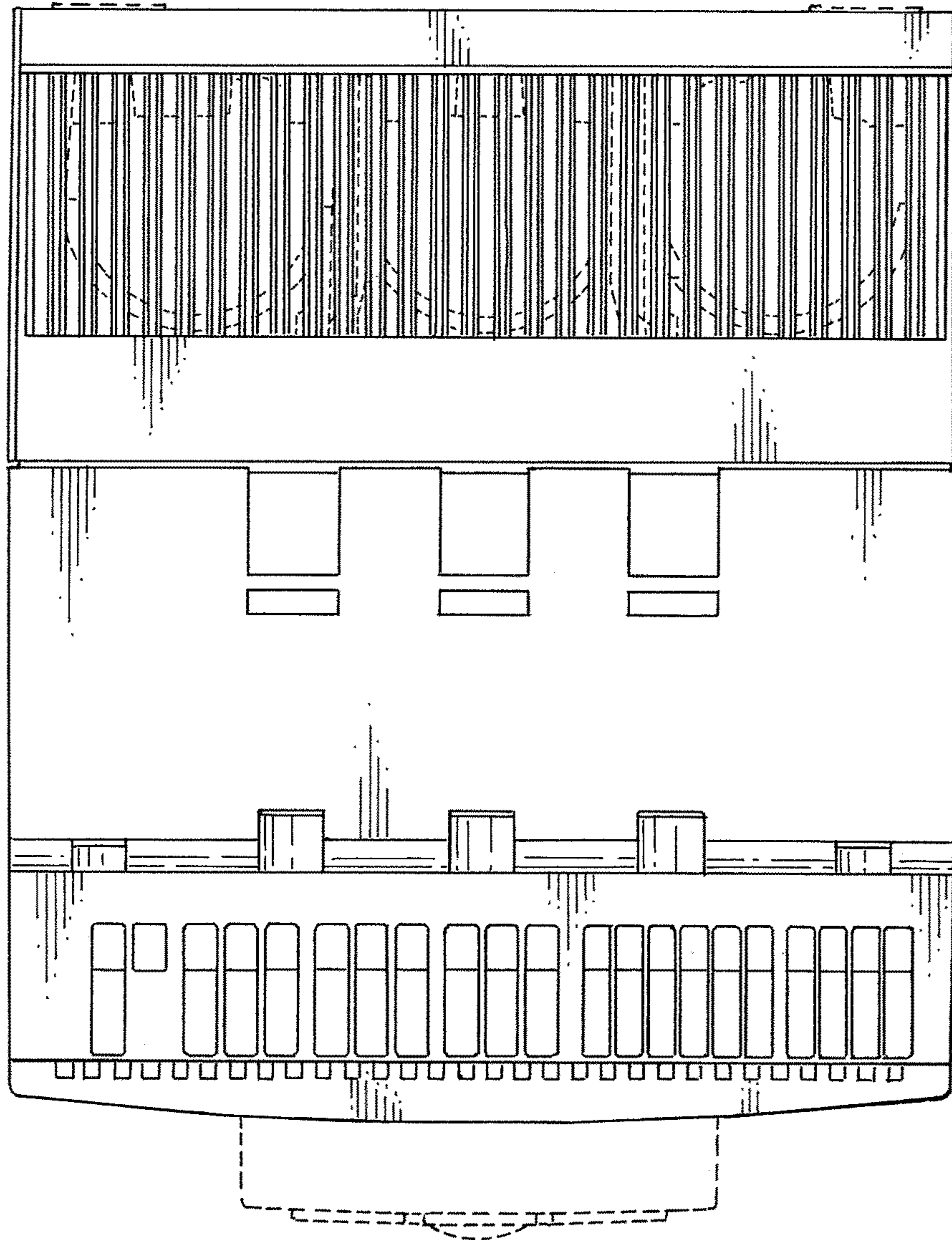

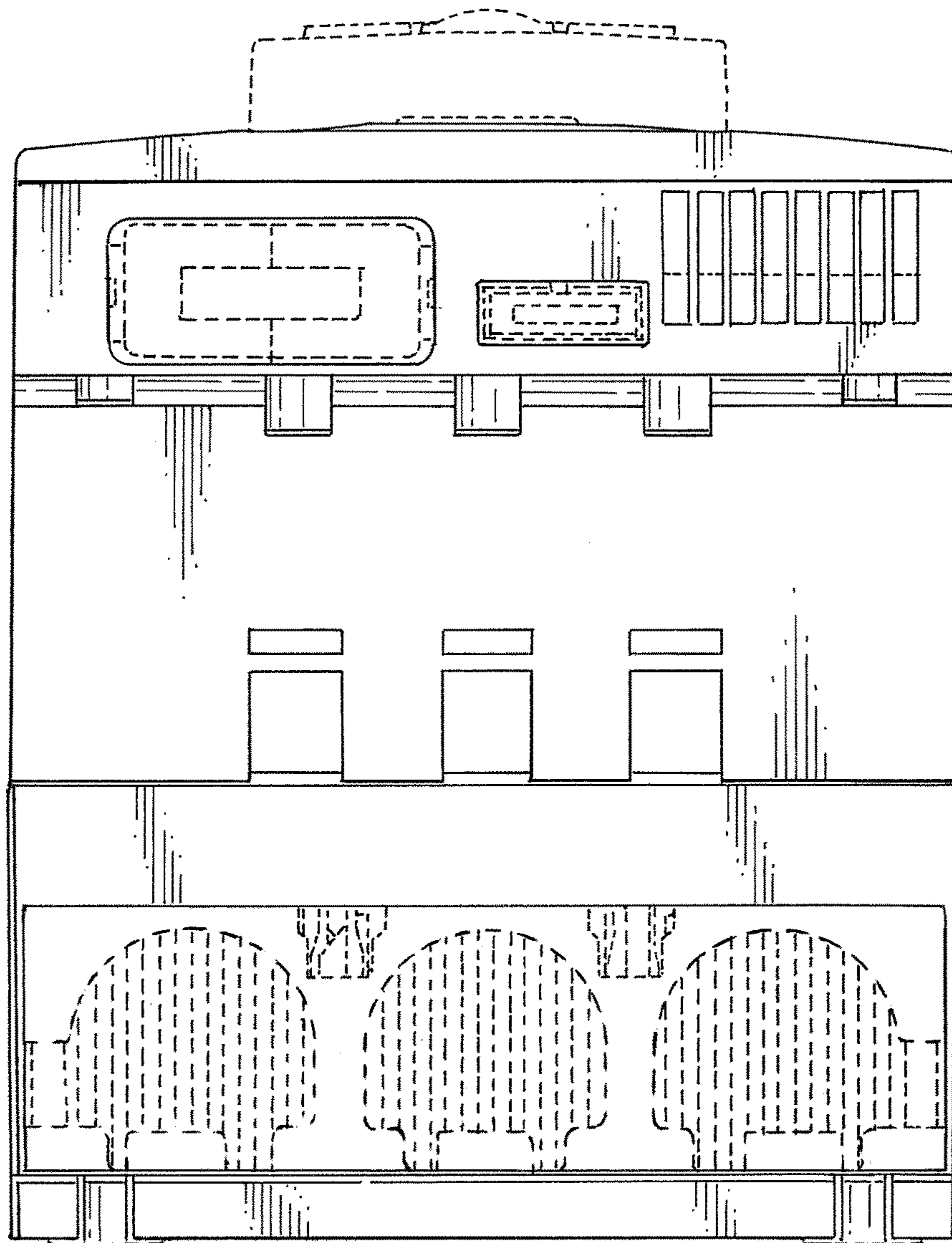

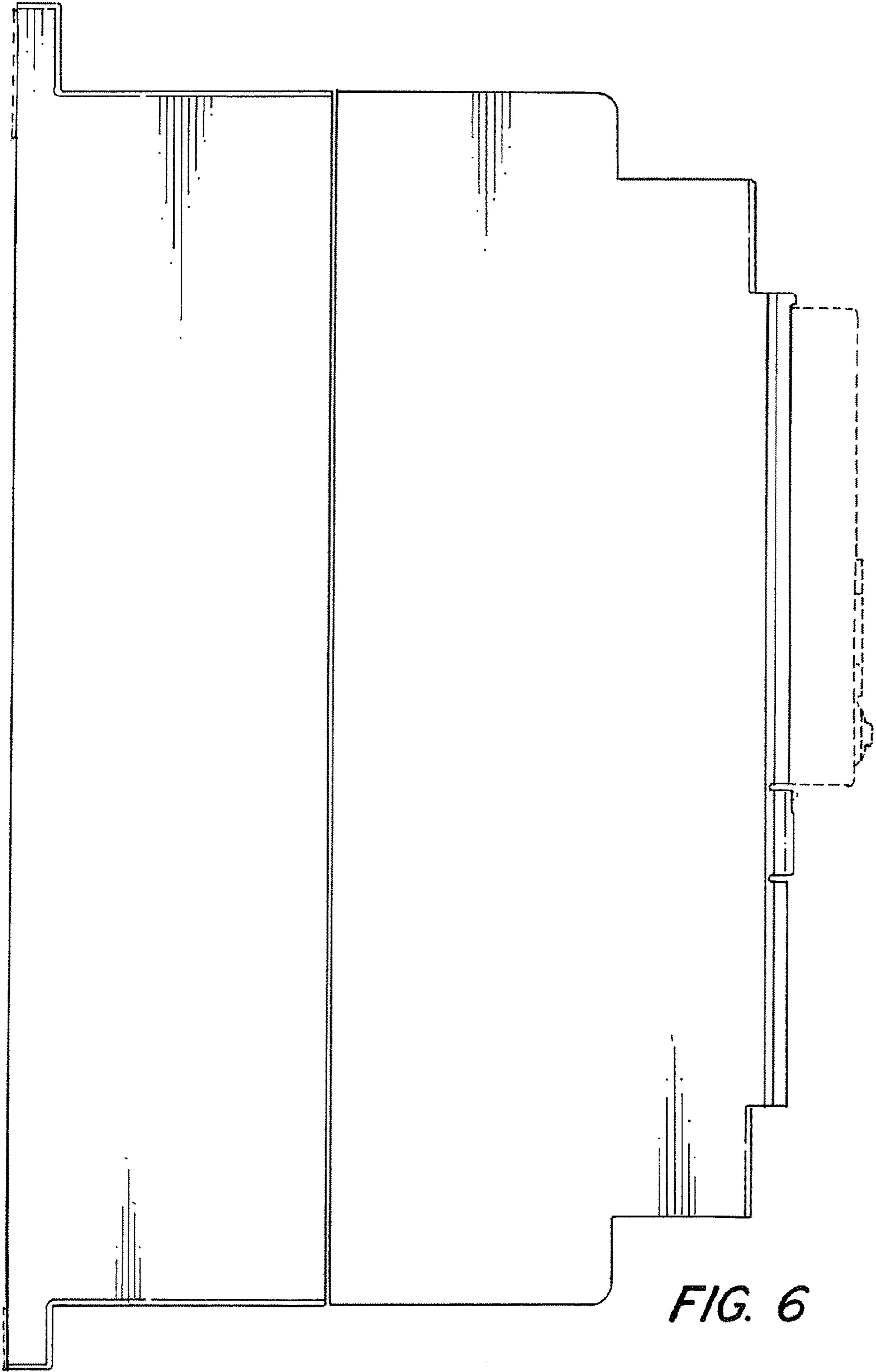

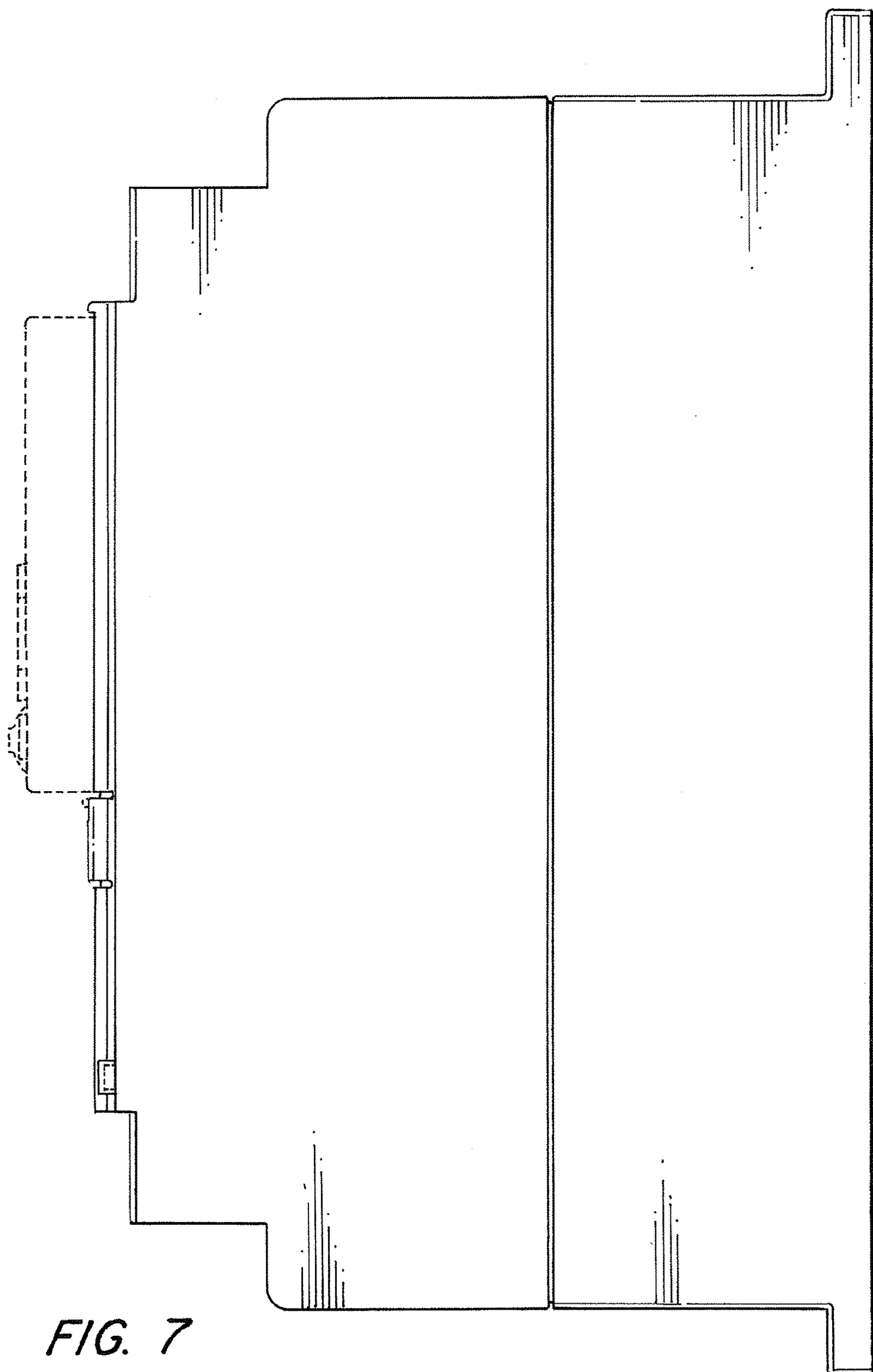
