I claim the ornamental design for a case for electronic device, as shown and described.

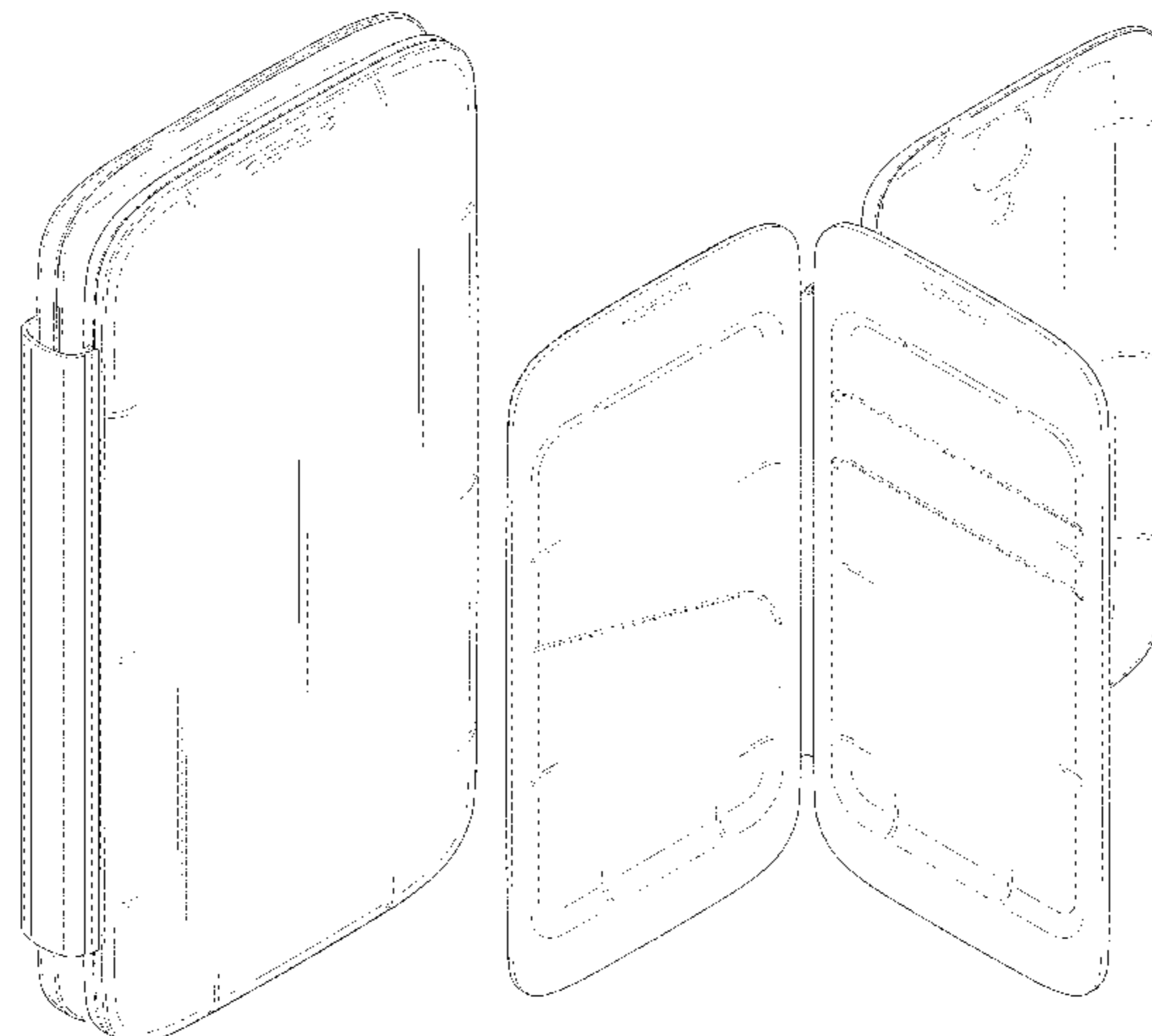
**DESCRIPTION**

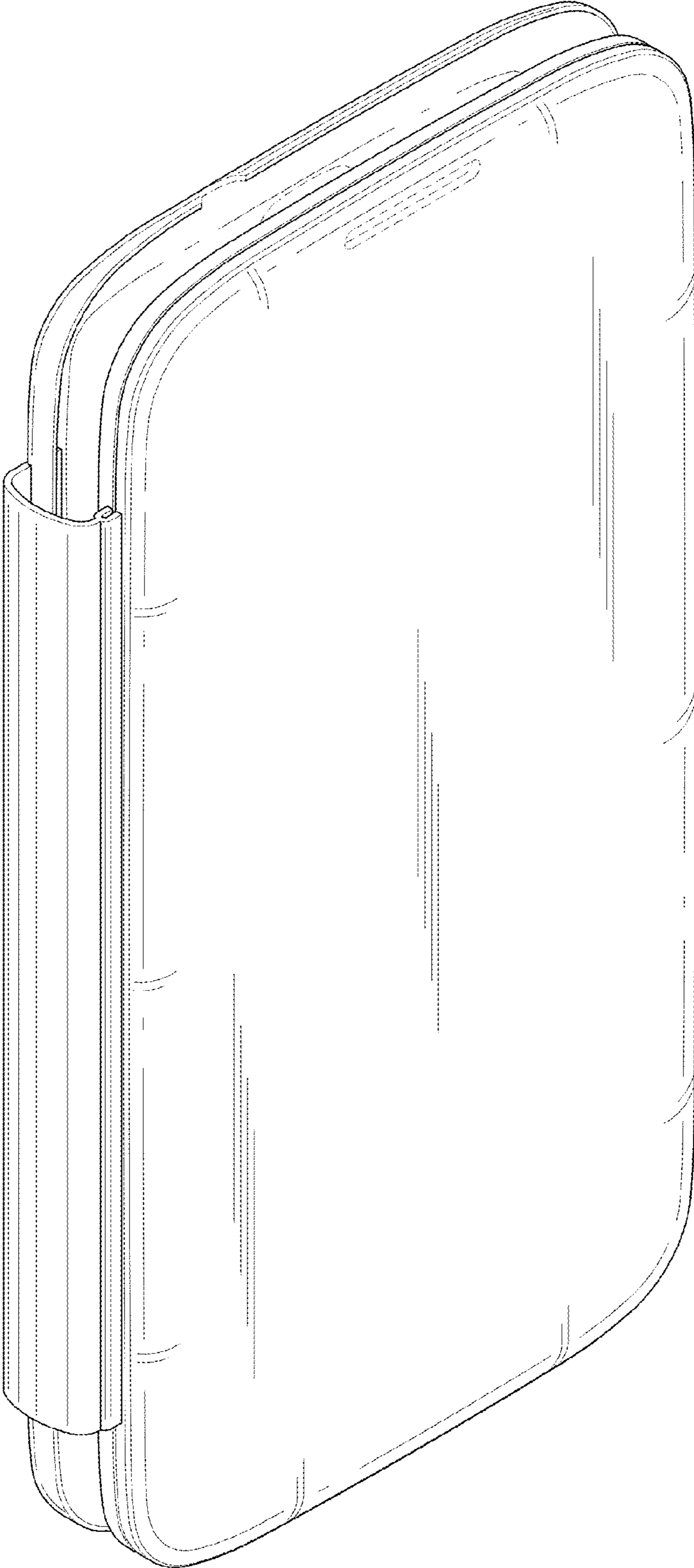

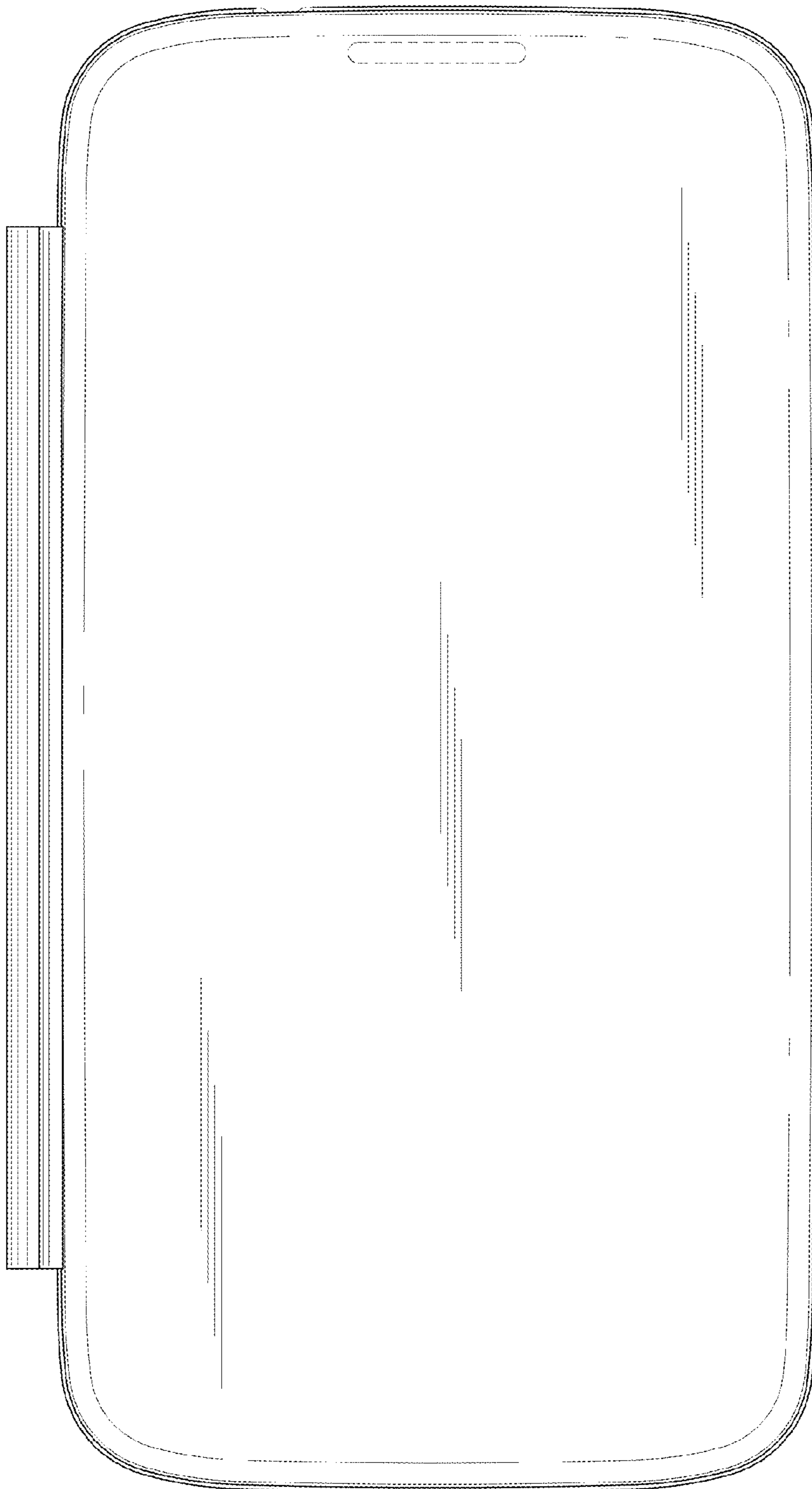

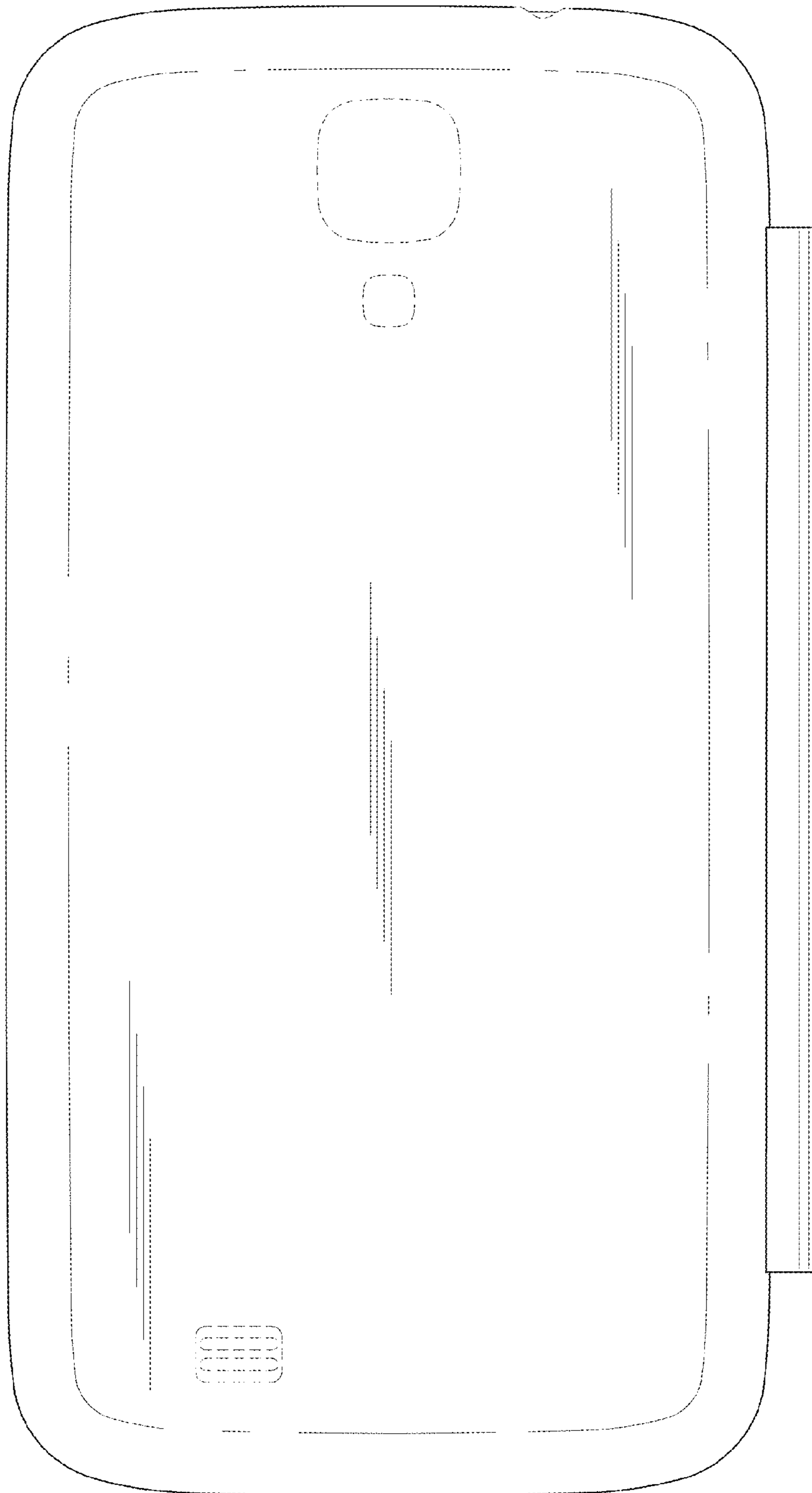

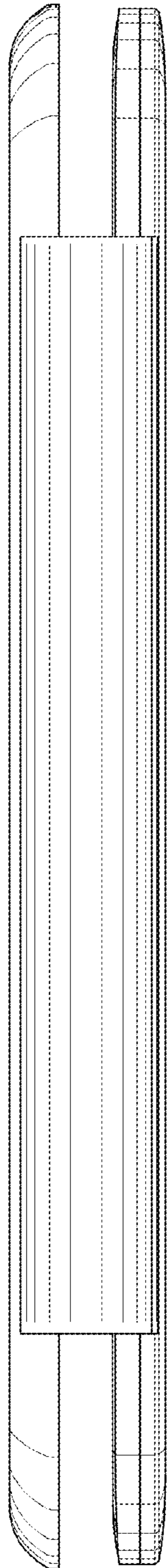

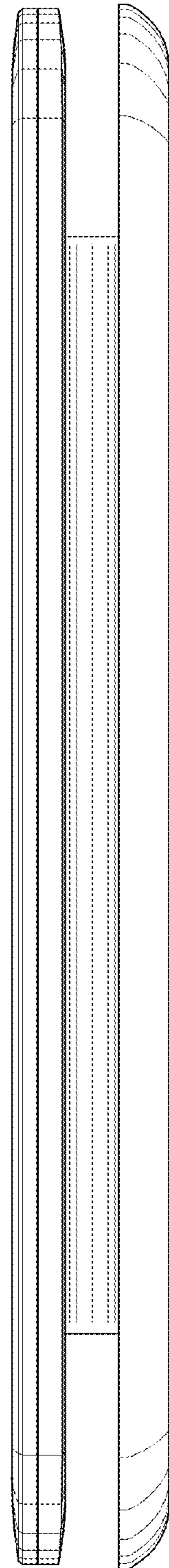

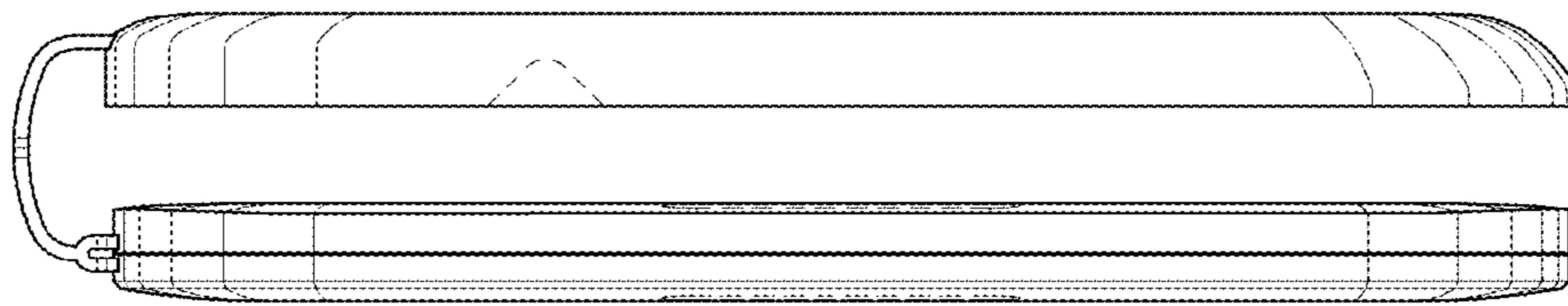

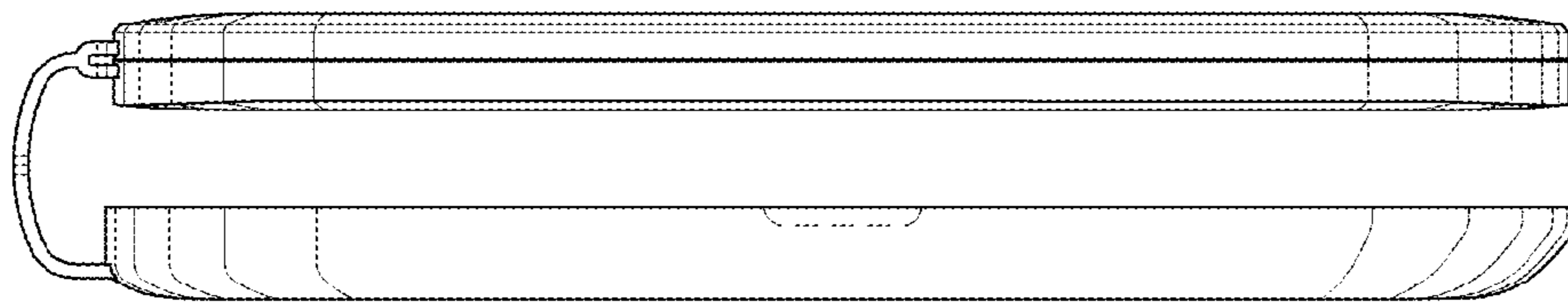

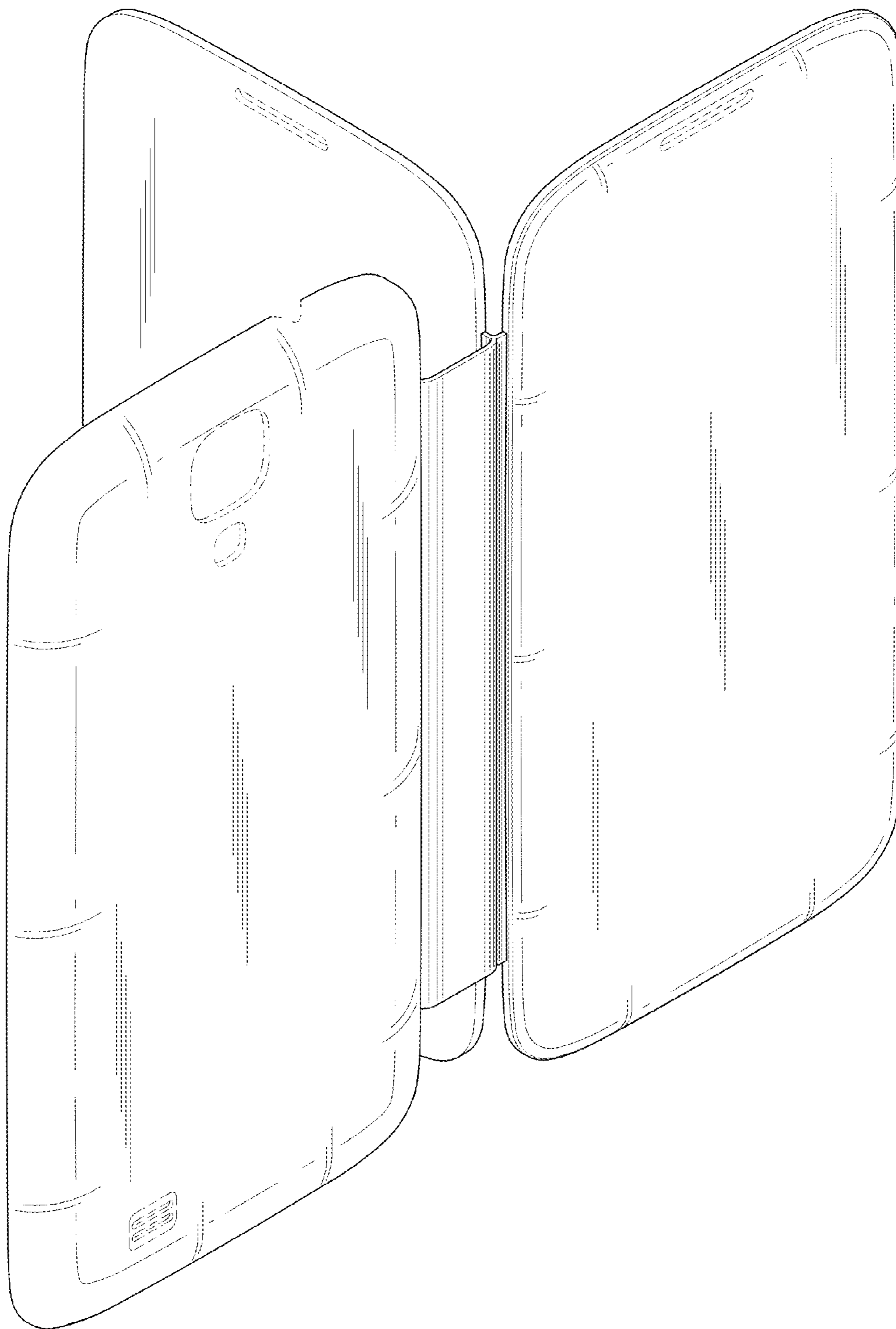
