(57) **CLAIM**

The ornamental design for a tablet computer, as shown and described.

DESCRIPTION

FIG. 1 is a front/right-side/top perspective view of a tablet computer showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left-side elevational view thereof;
FIG. 5 is a right-side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a rear/left-side/top perspective view thereof.
The broken lines shown in the drawings represent portions of the tablet computer that form no part of the claimed design.

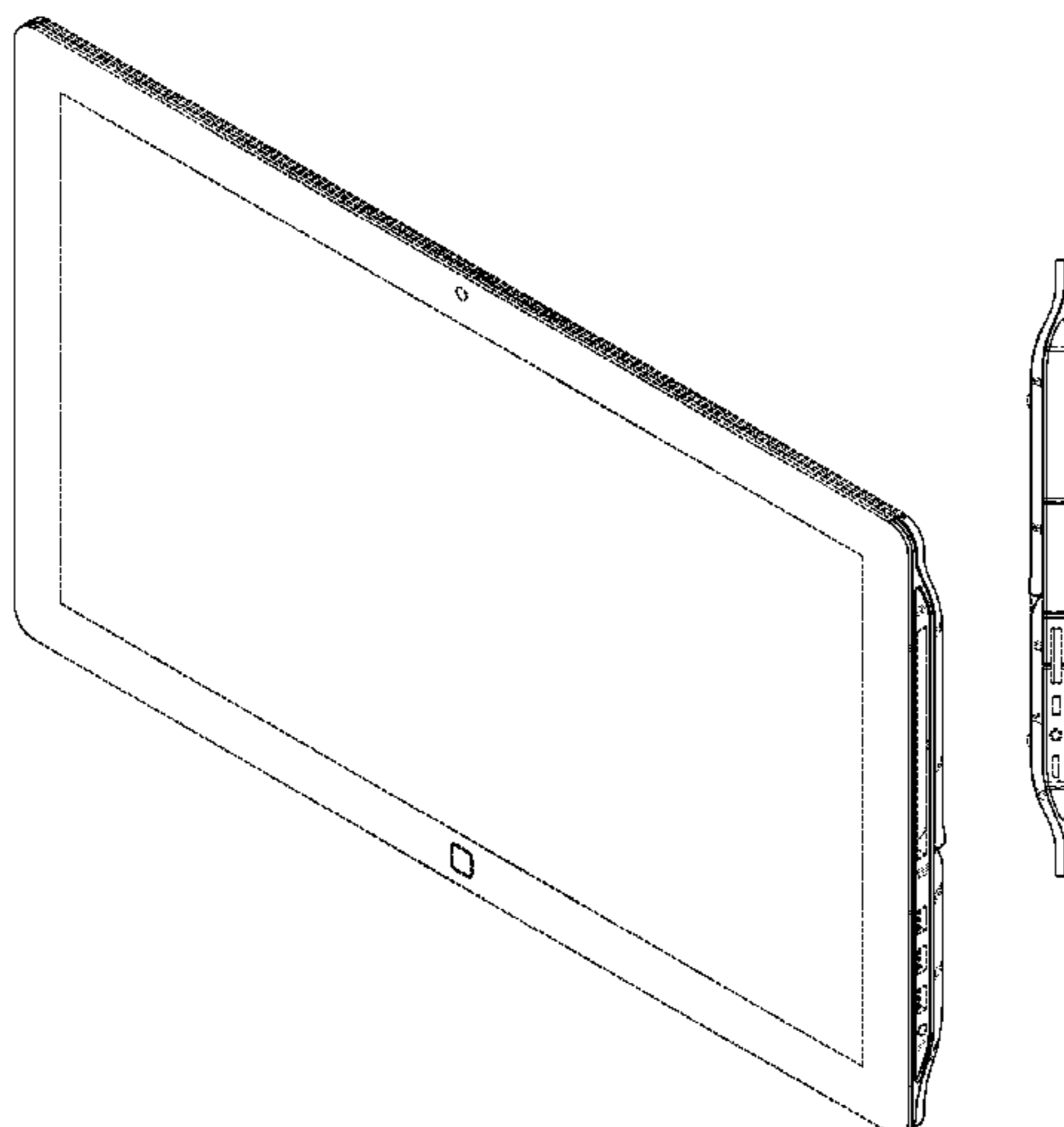

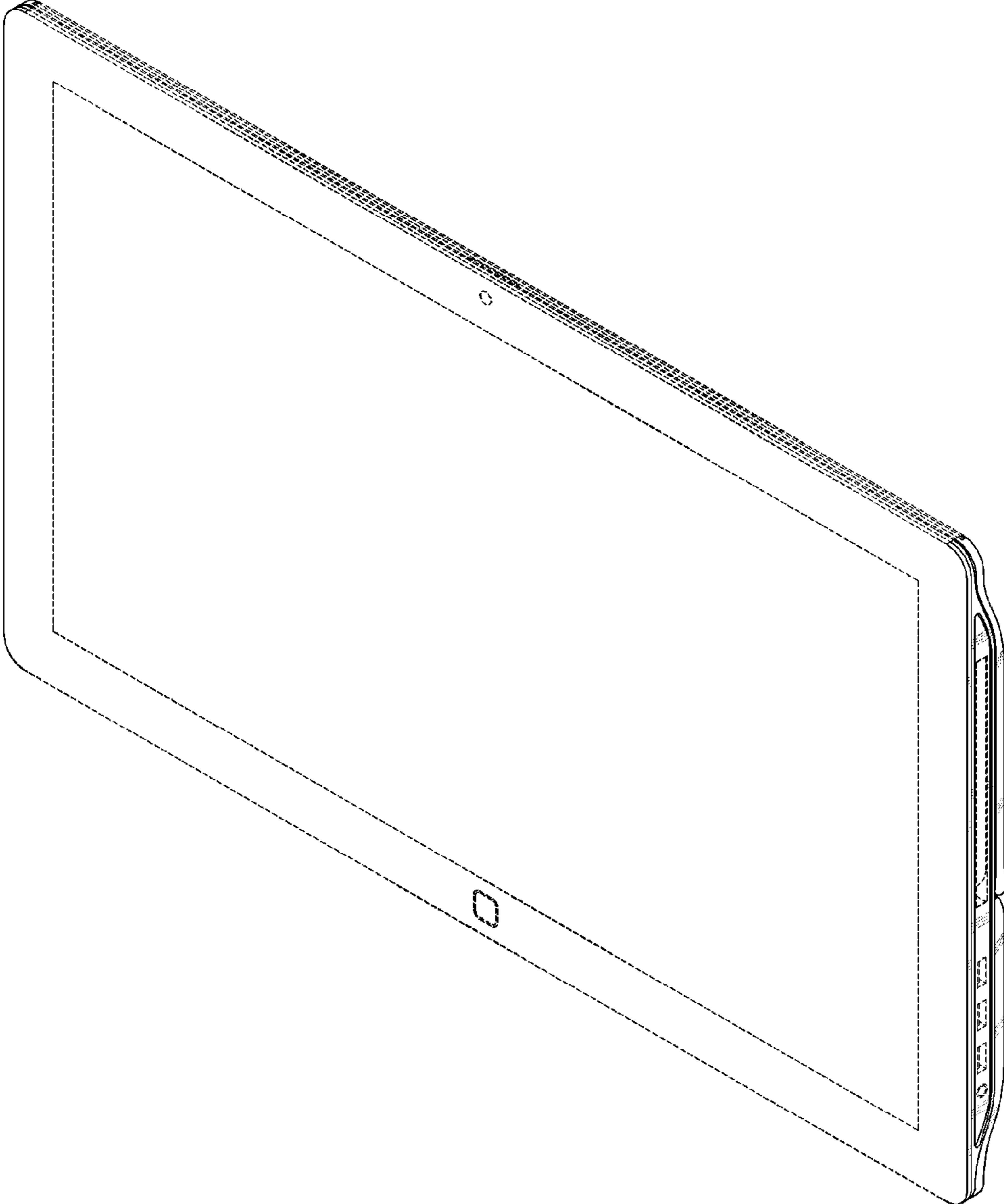

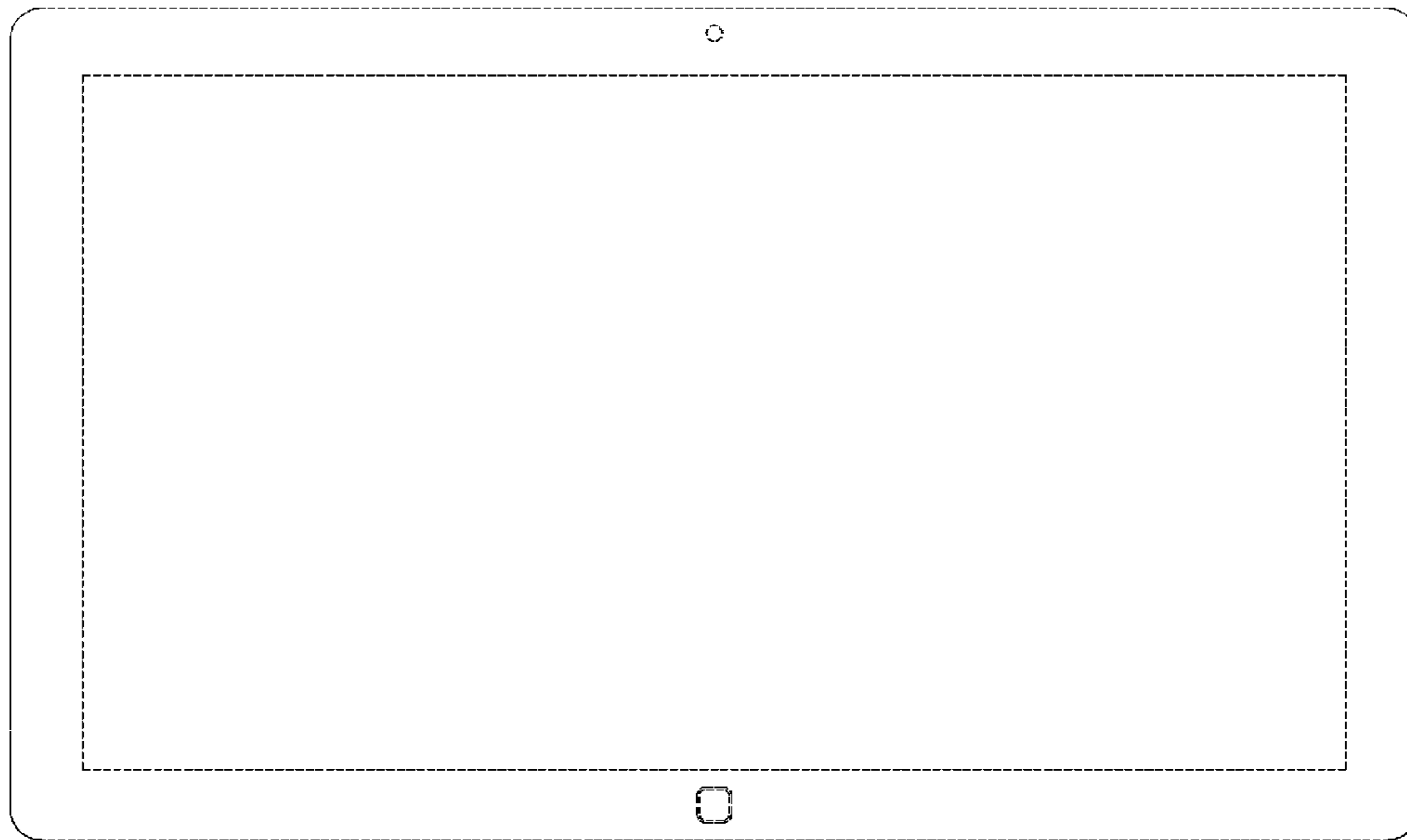

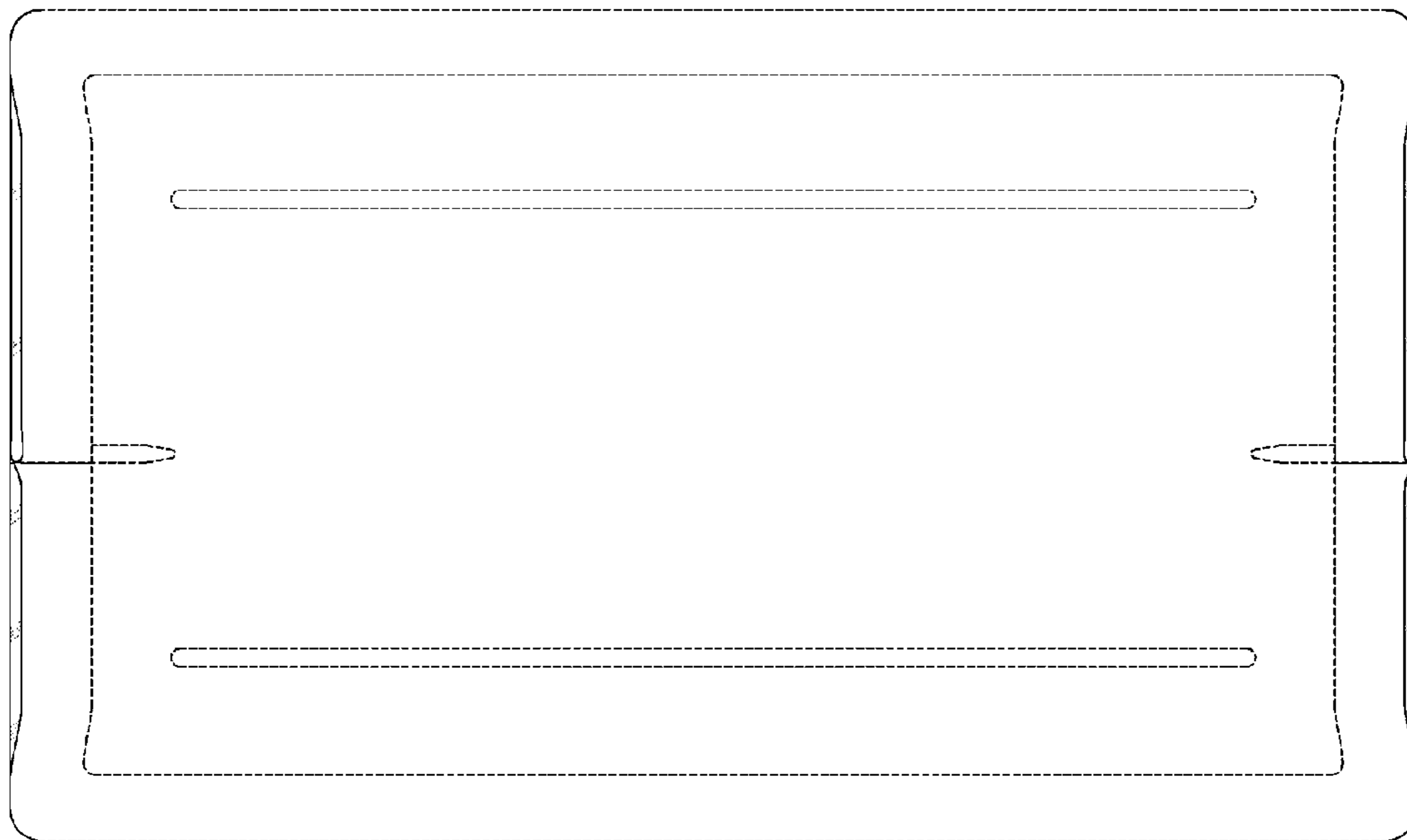

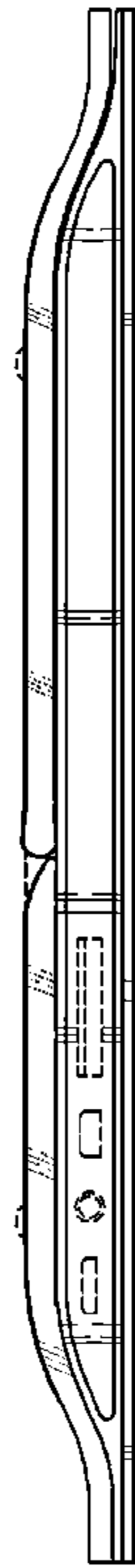

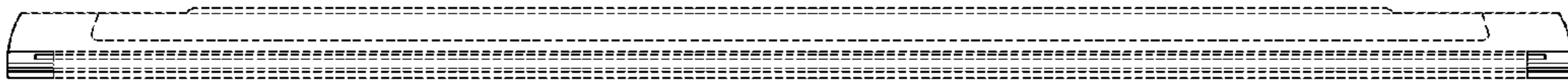

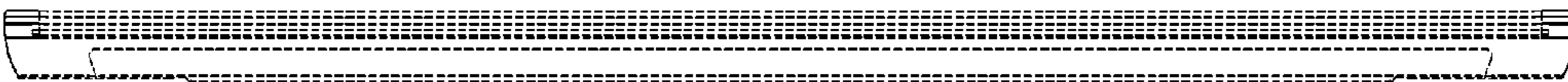
