DESCRIPTION

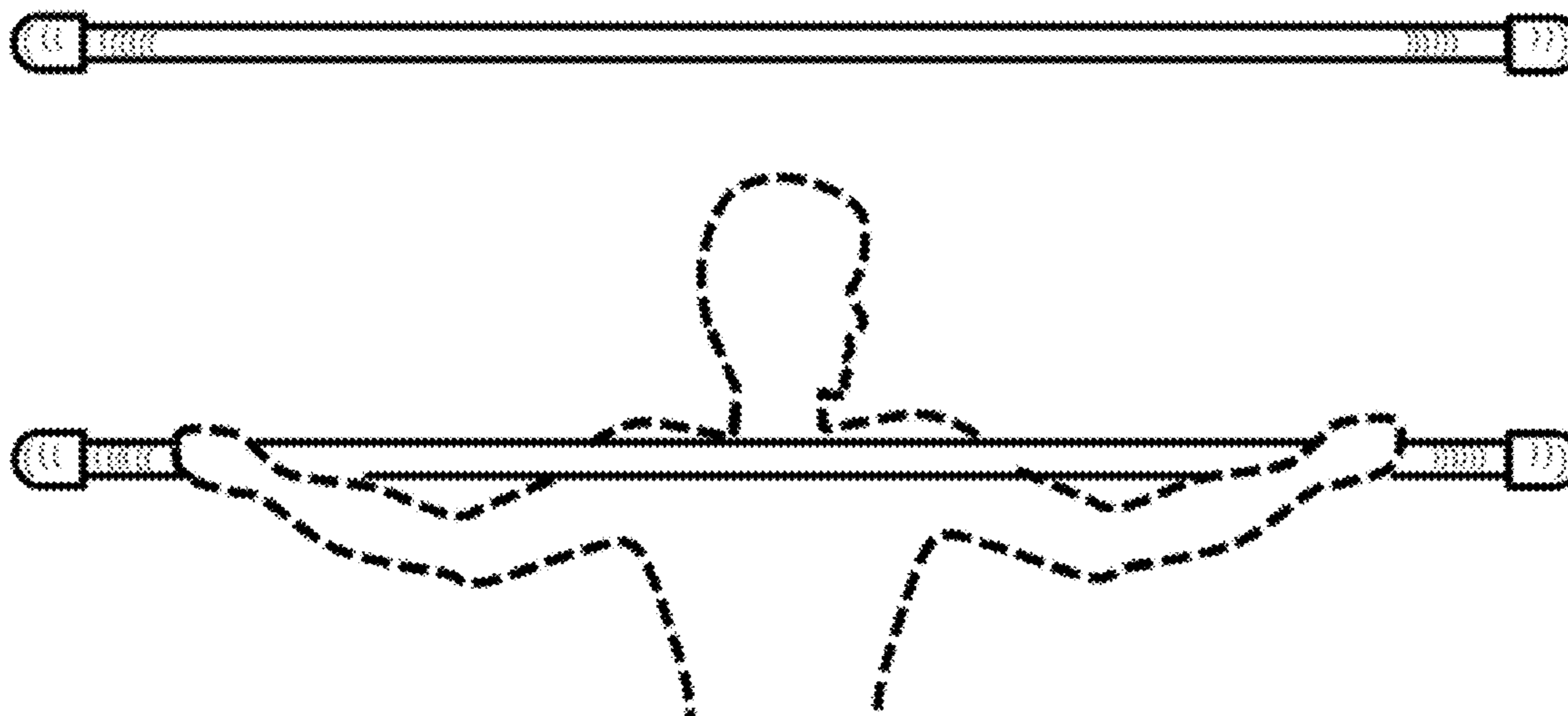
FIG. 1 is a top-down view of the fitness stick;

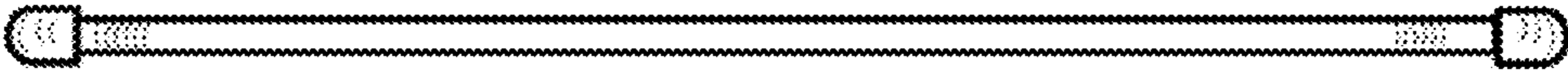

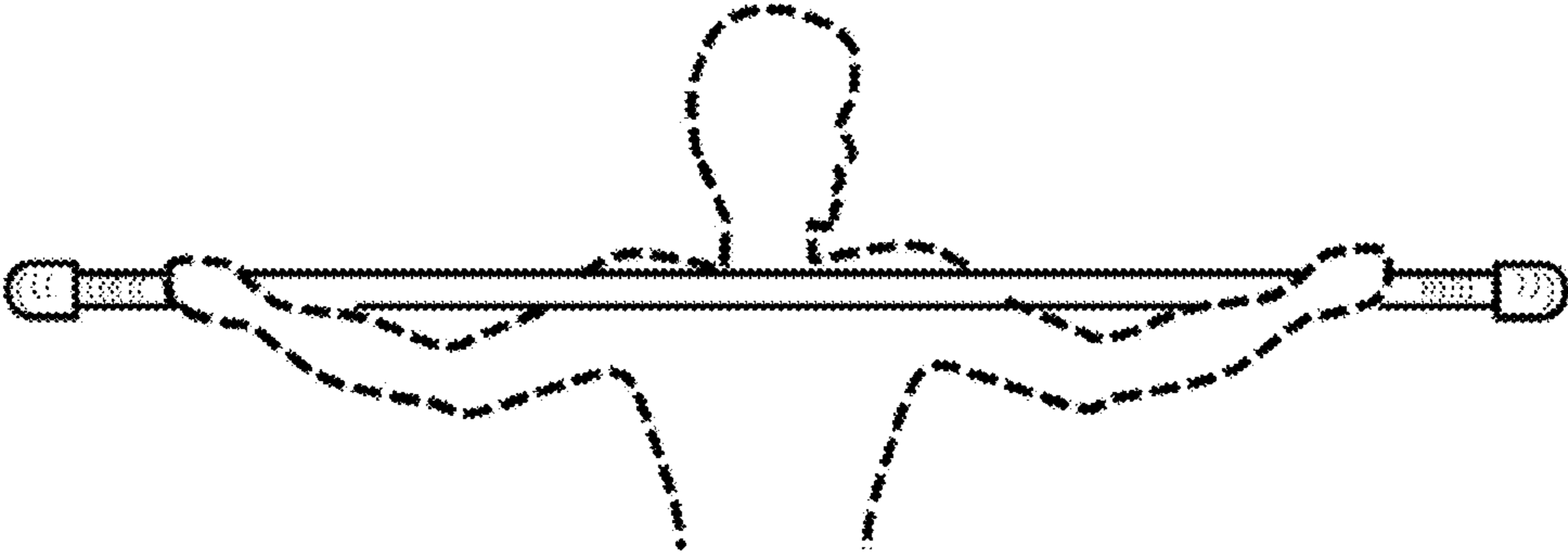

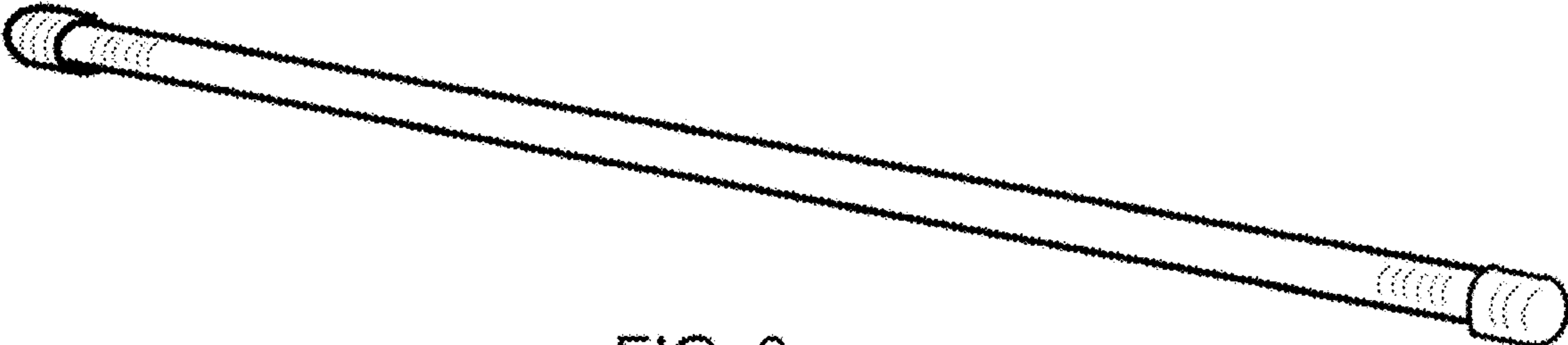

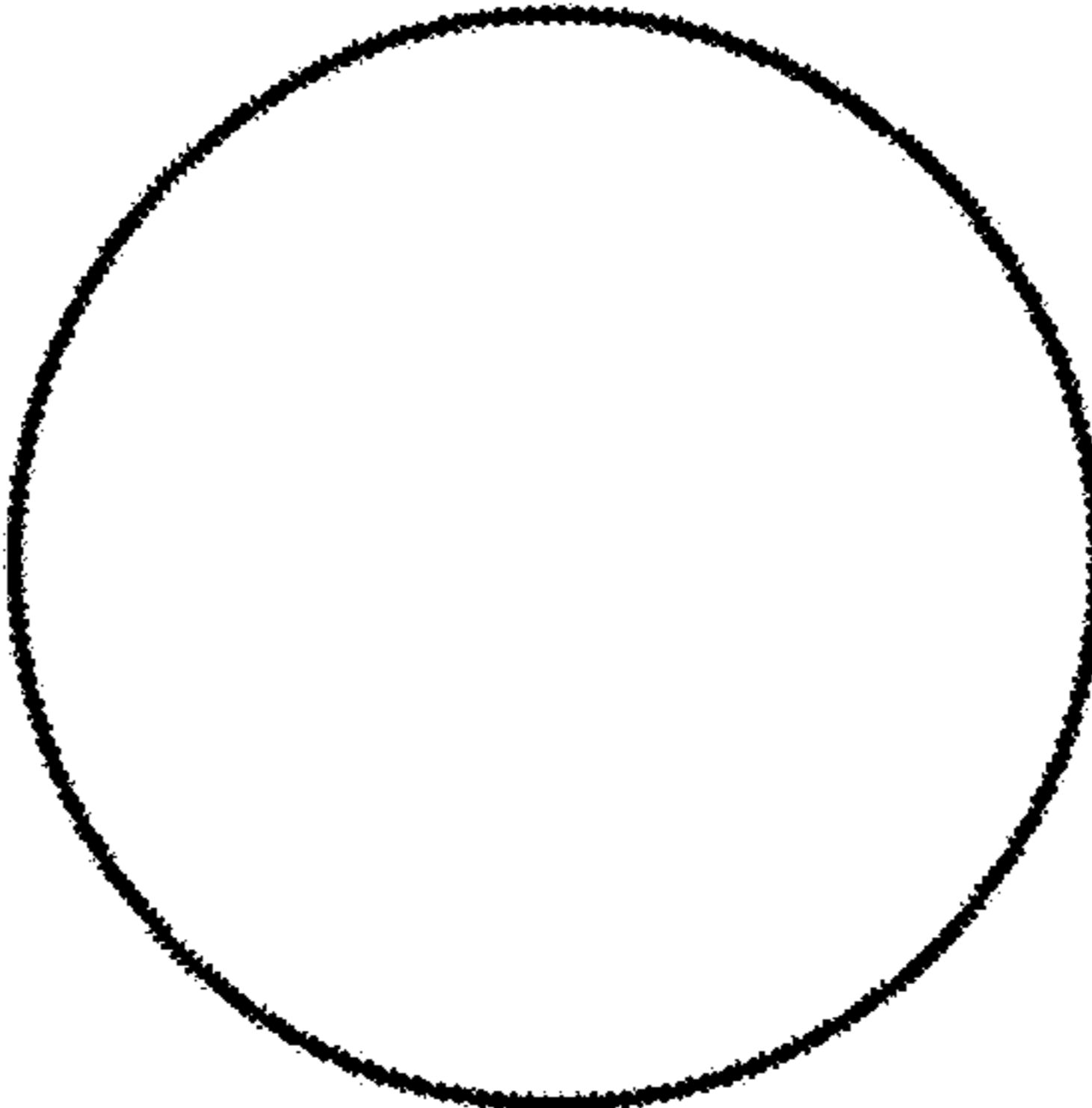

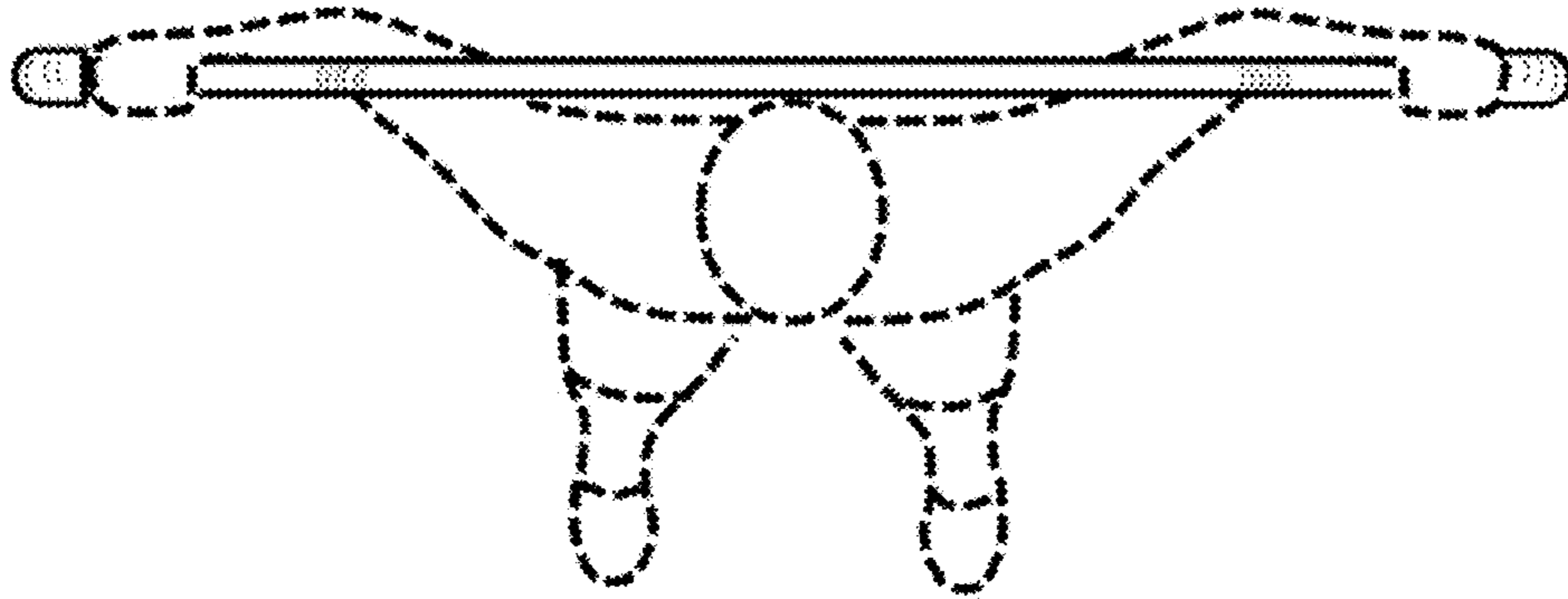

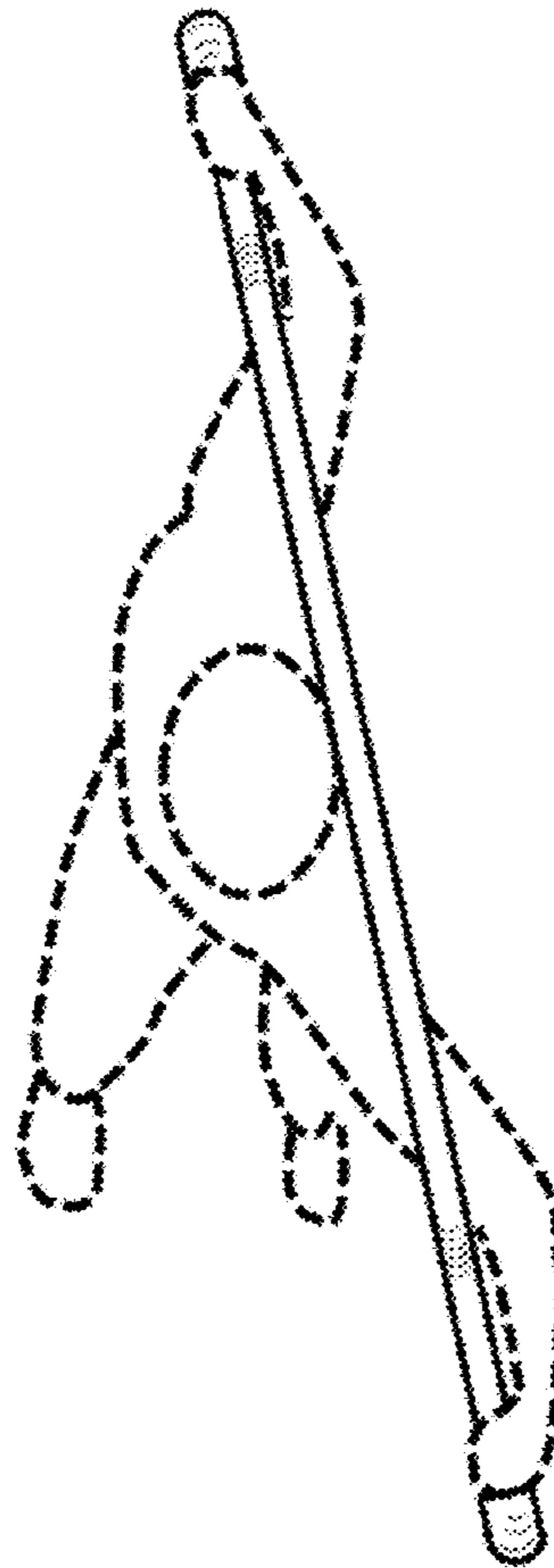
