I claim the ornamental design for a showerhead, as shown and described.

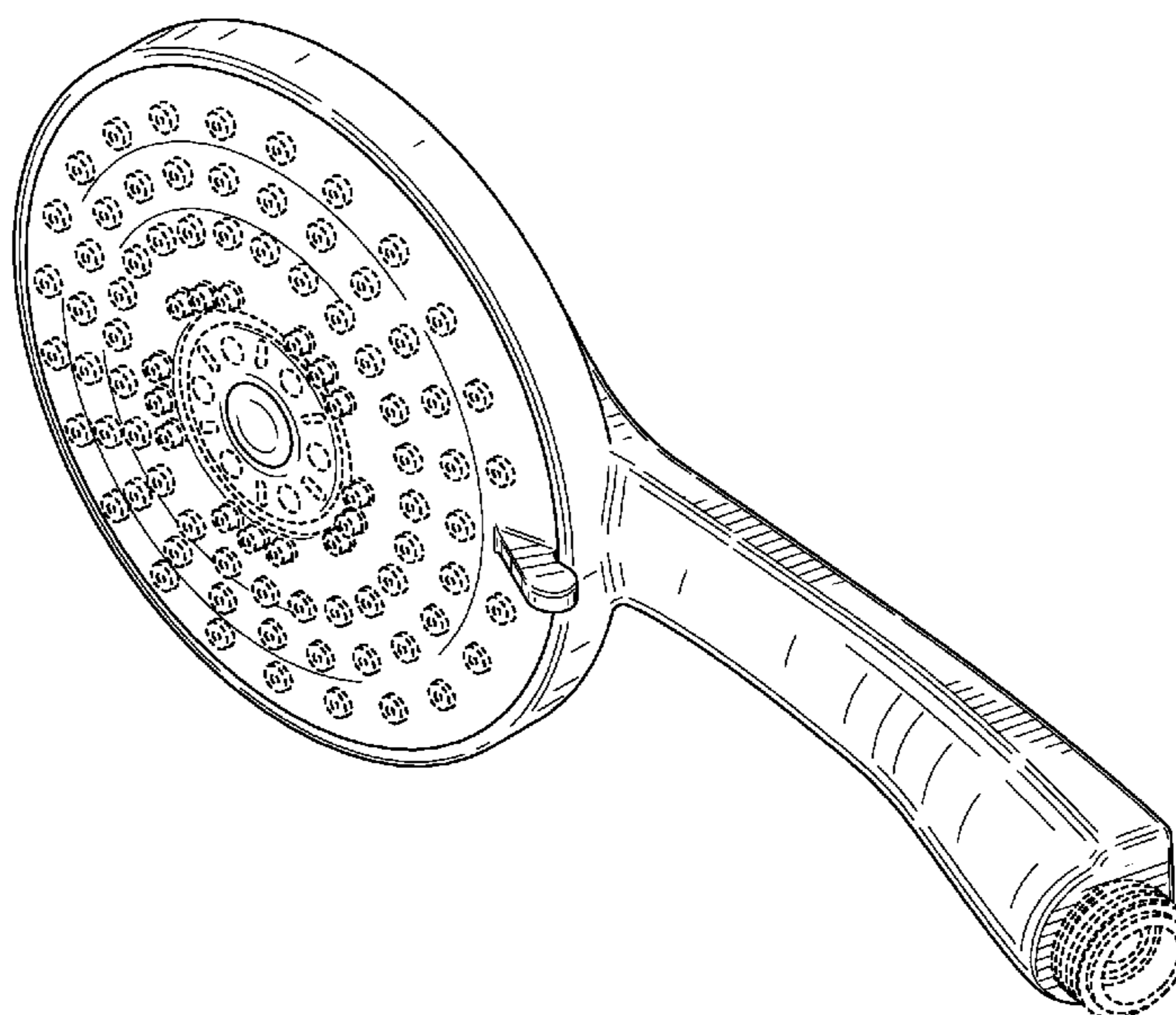
DESCRIPTION

FIG. 1 is a top, right, front perspective view of an embodiment of the claimed design;

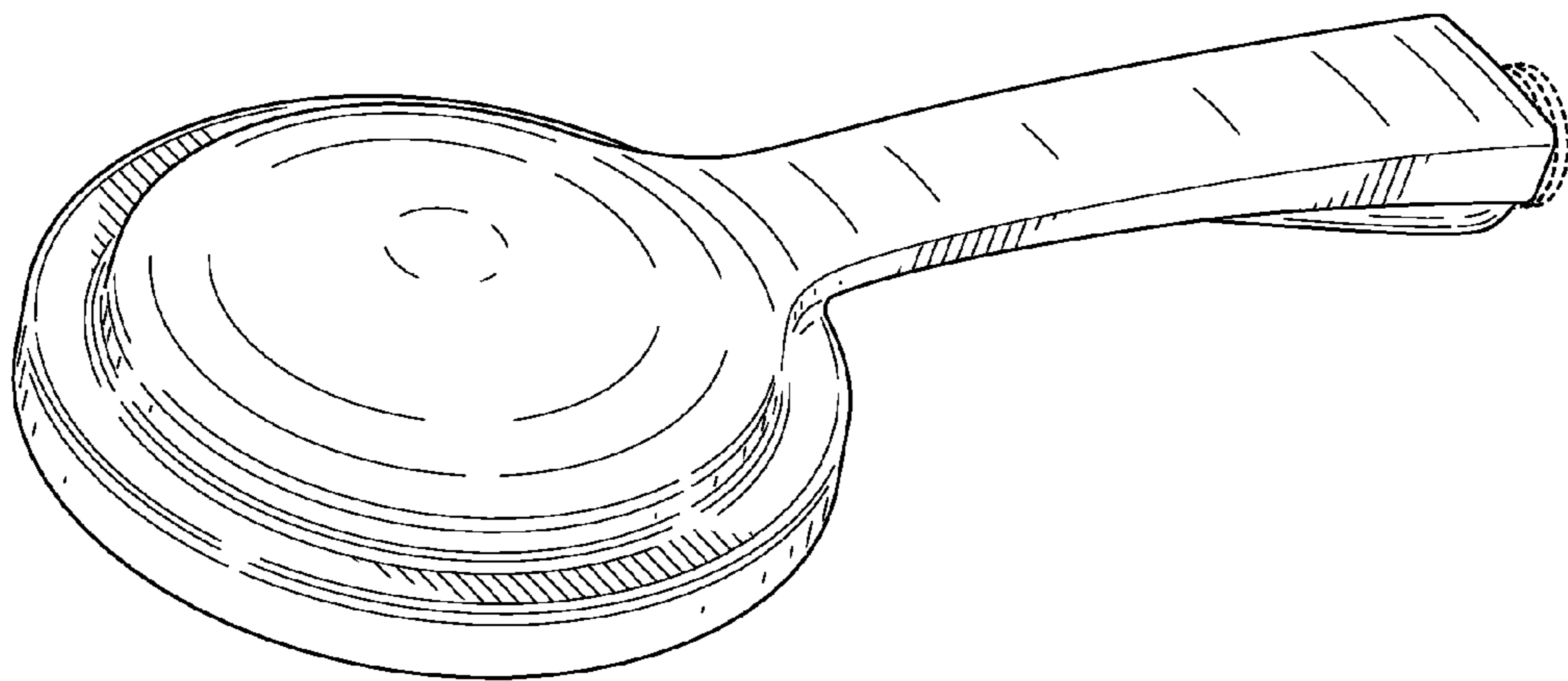

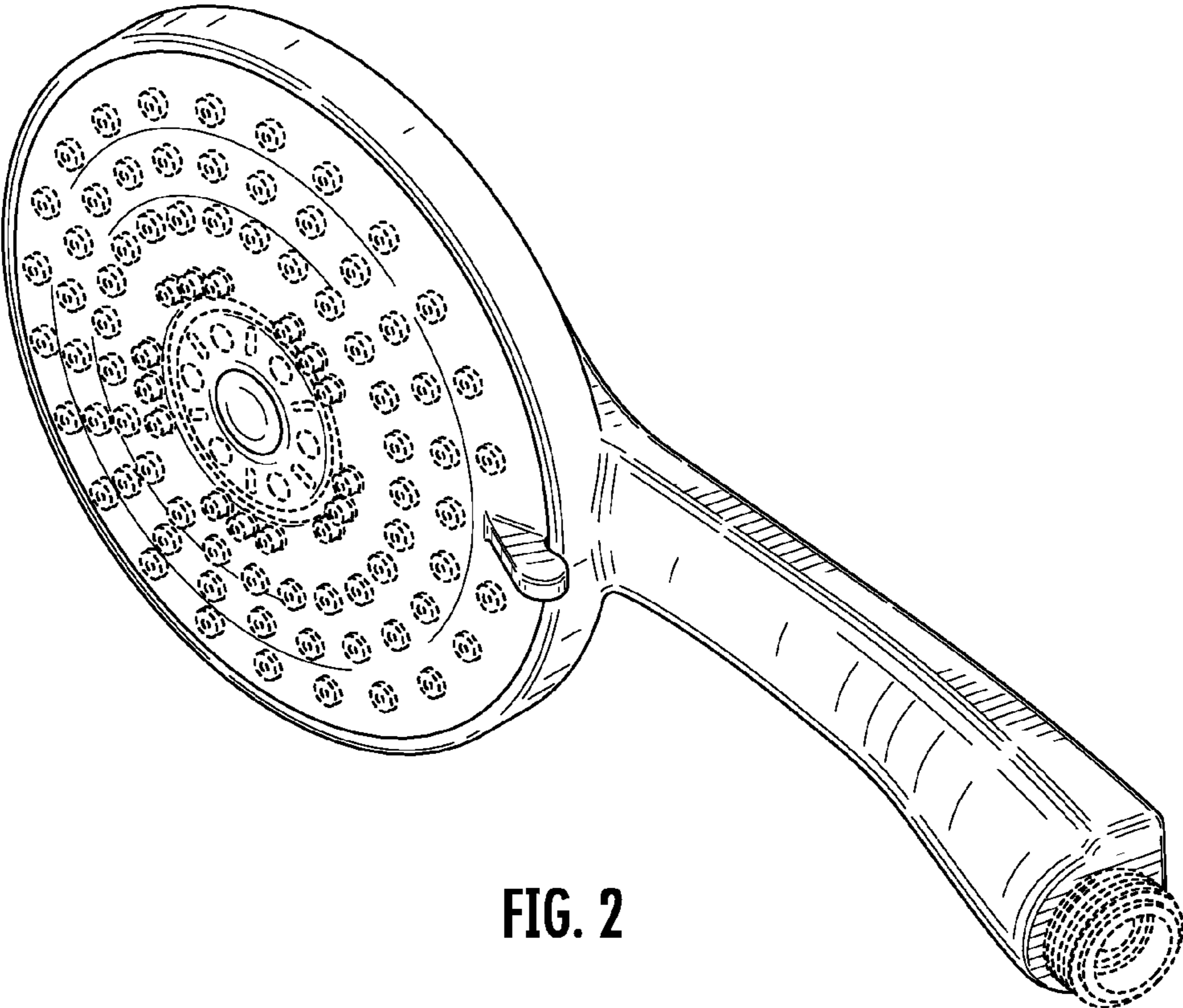

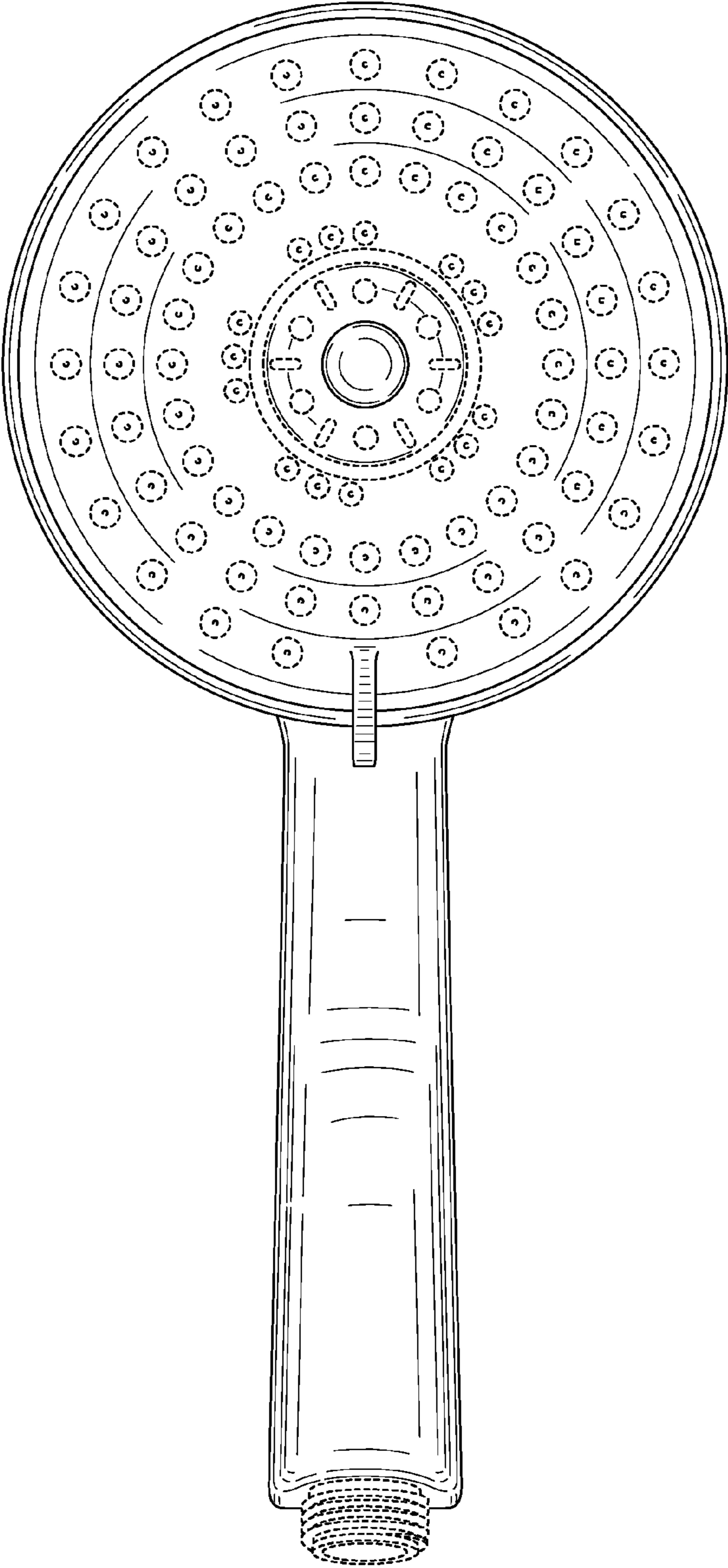

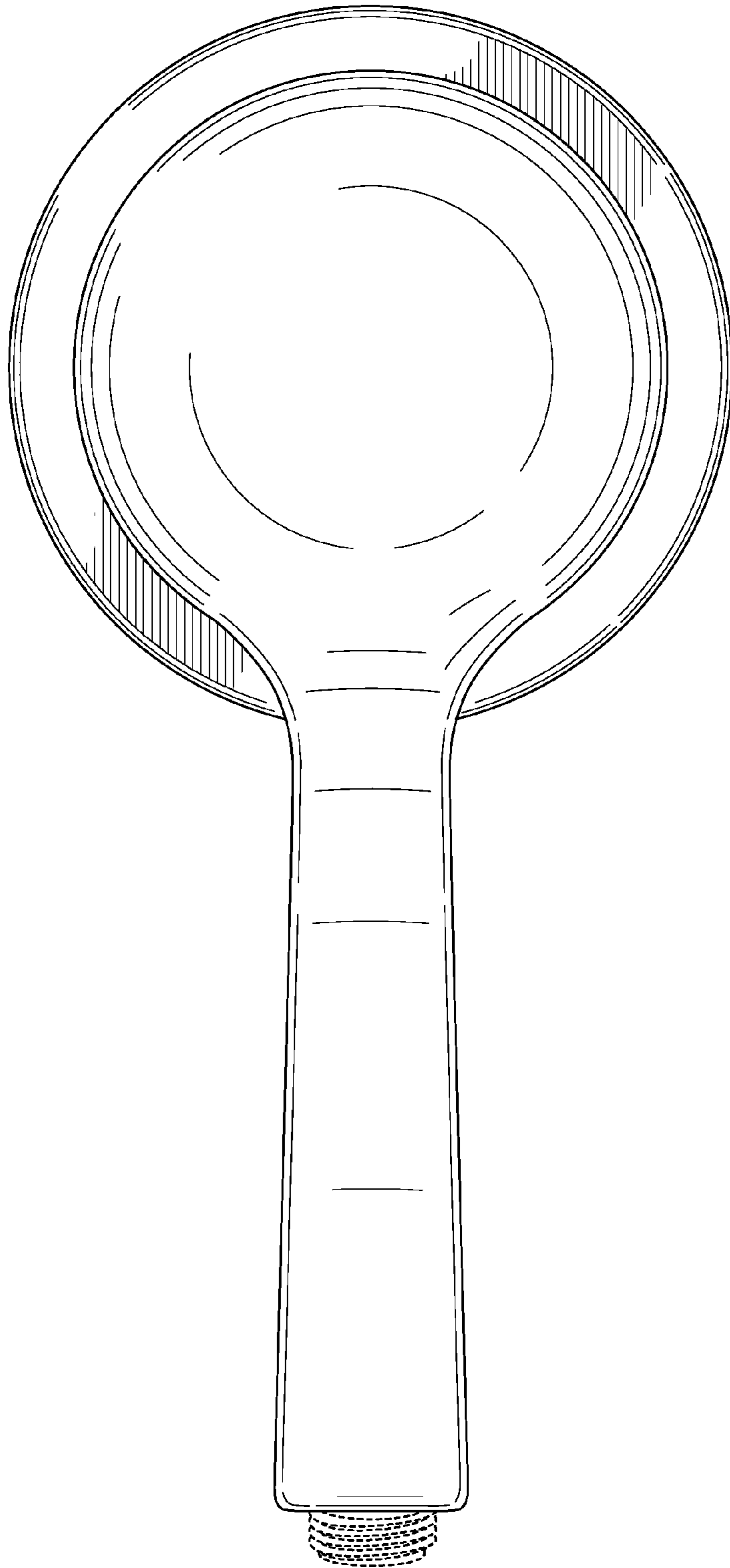

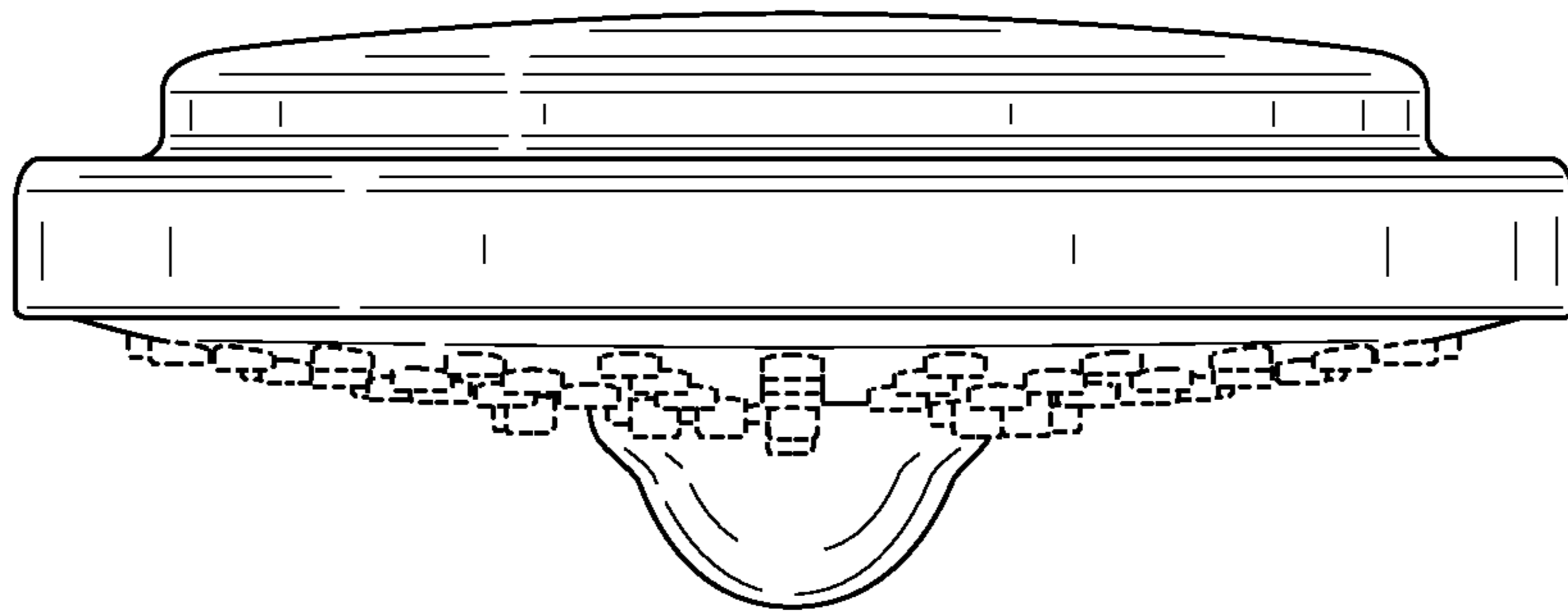

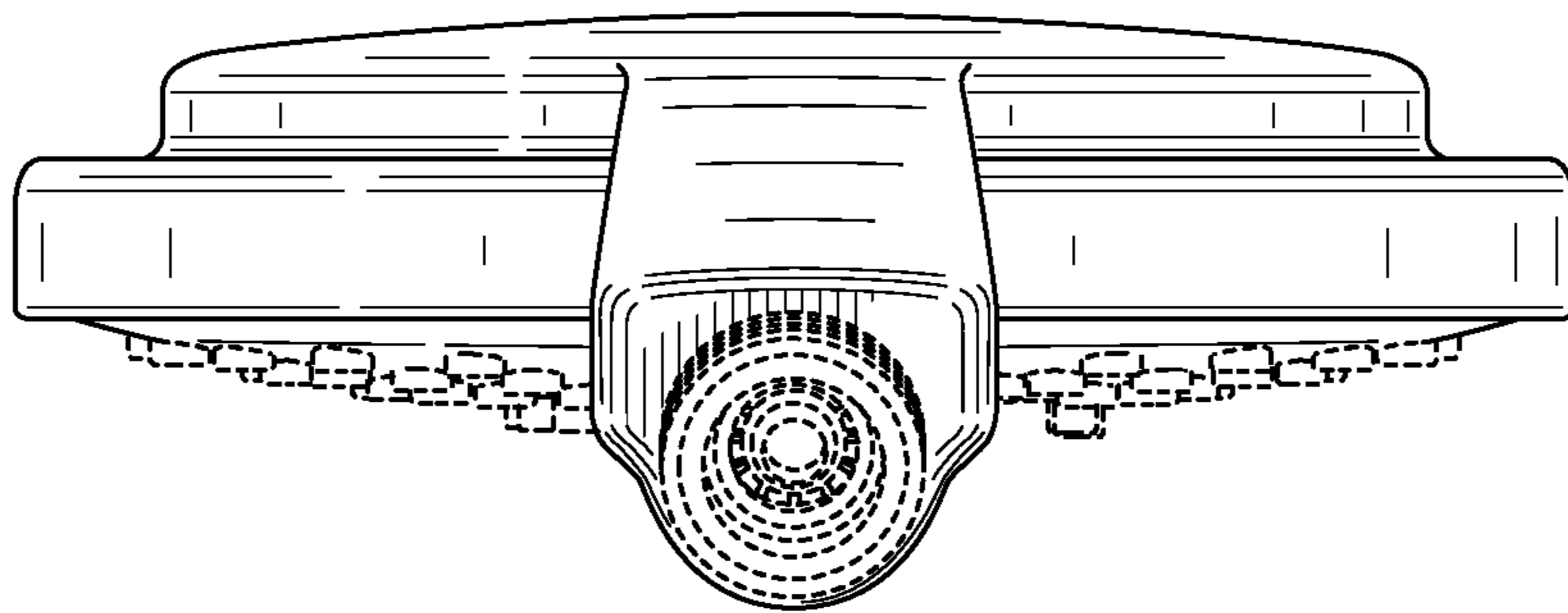

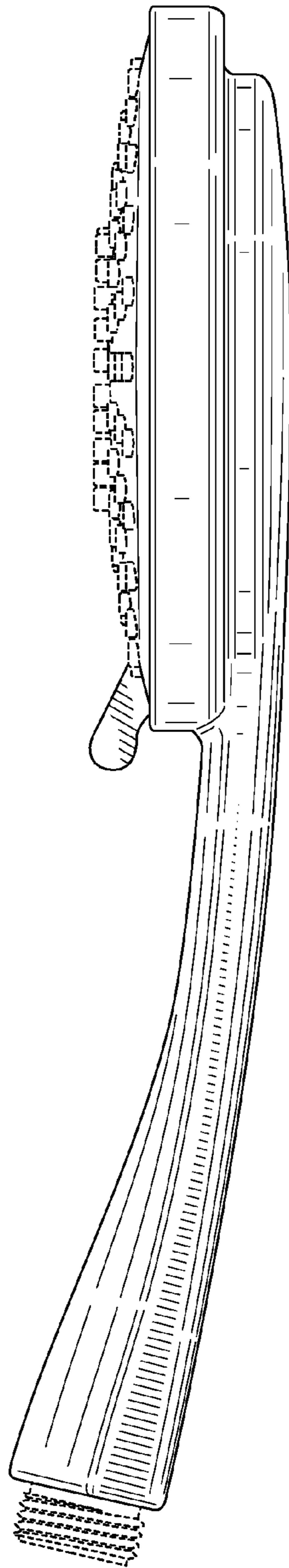

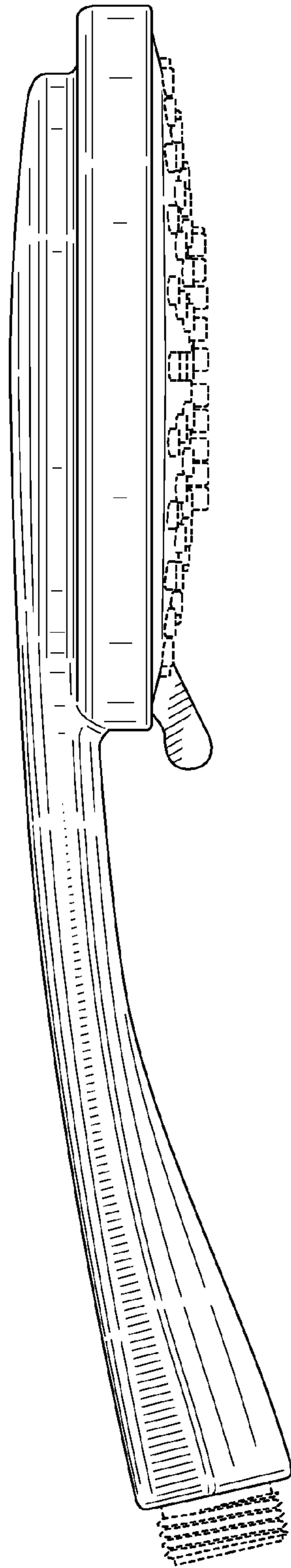
