DESCRIPTION

FIG. 1 is a front view of a particulate filter of the present invention;

FIG. 2 is a rear view thereof;

FIG. 5 is a right side view thereof;

FIG. 10 is a sectional view thereof, taken along the line X-X of FIG. 6;

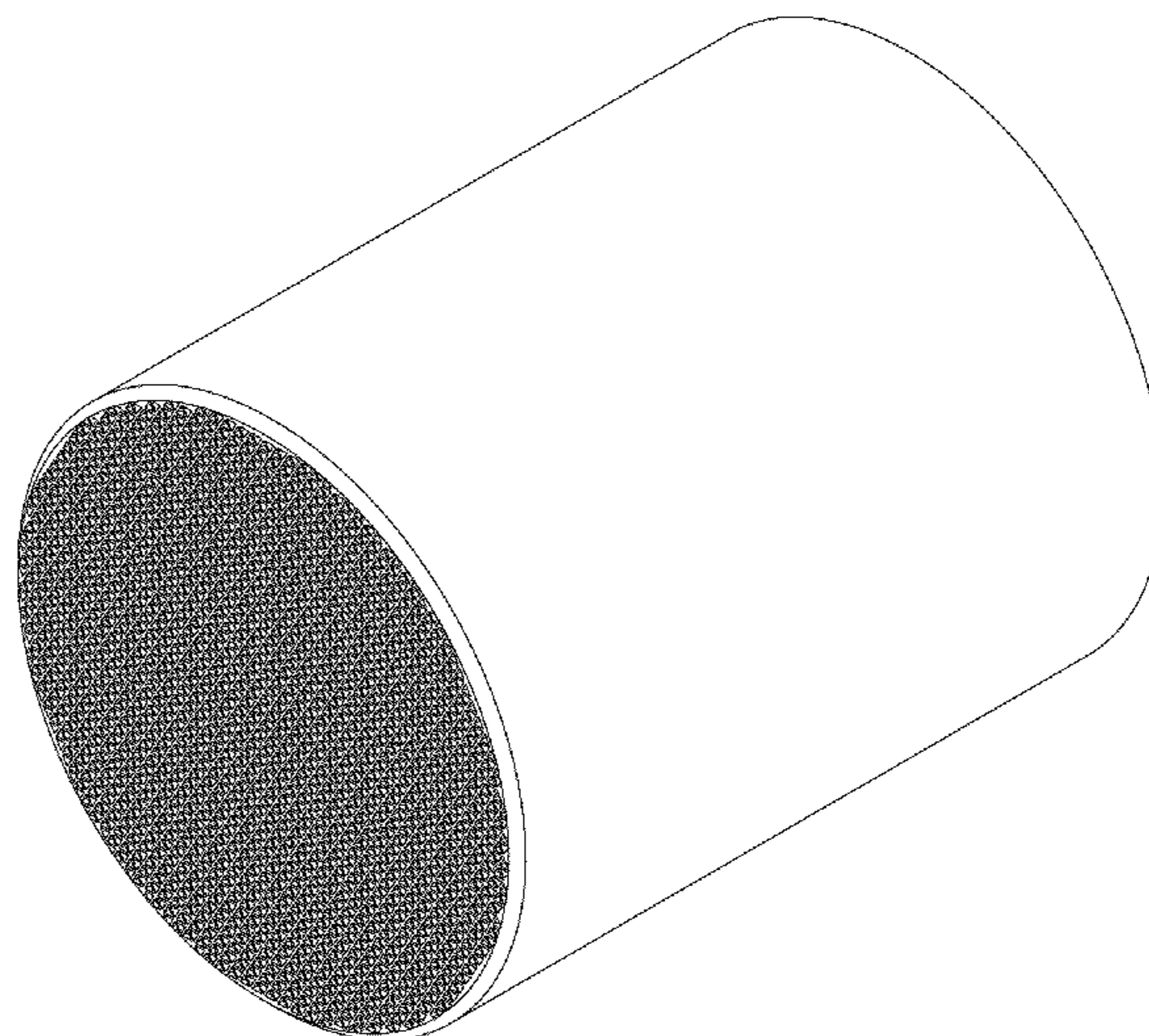
FIG. 11 is an enlarged sectional view thereof, taken along the line XI-XI of FIG. 10;

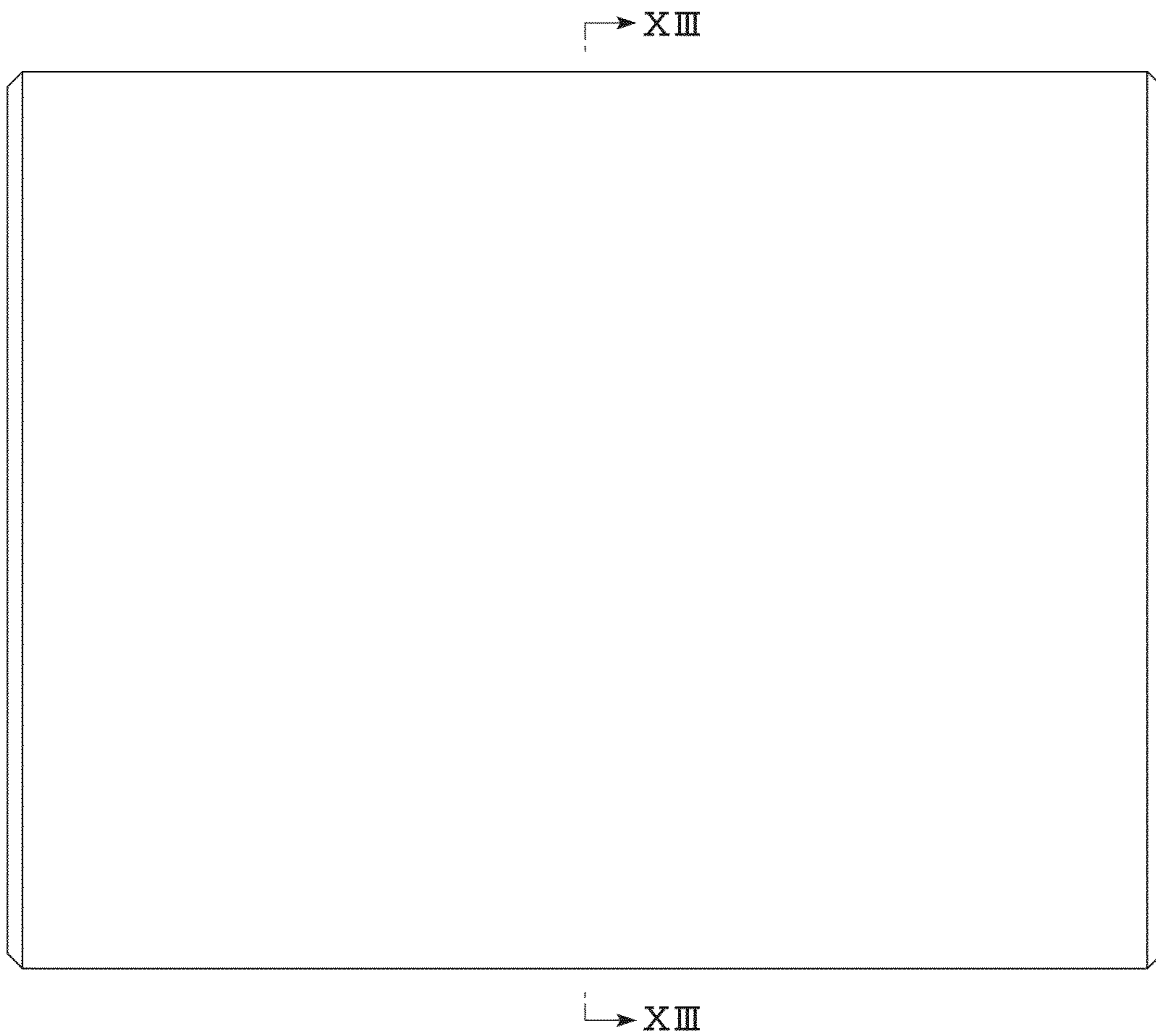

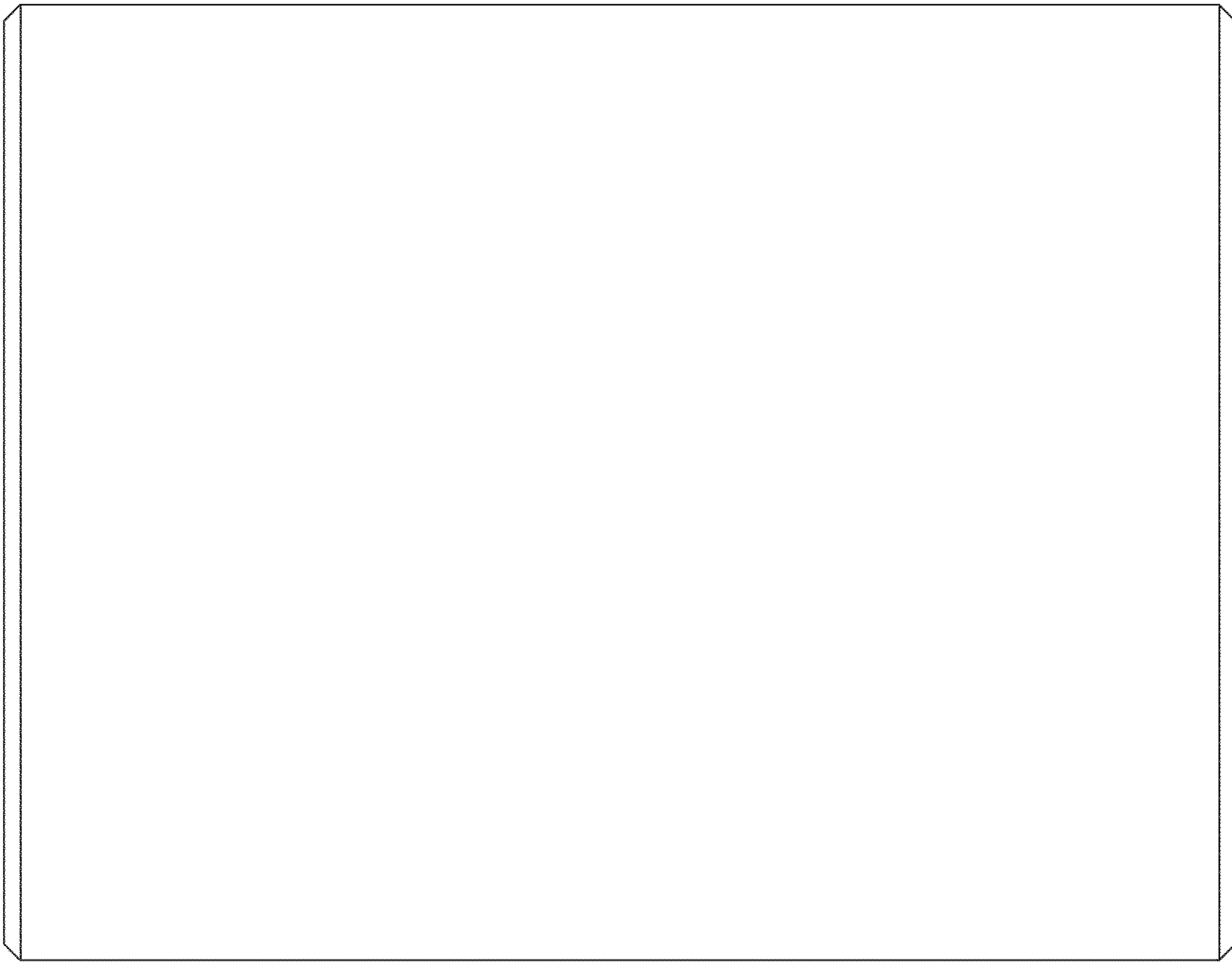

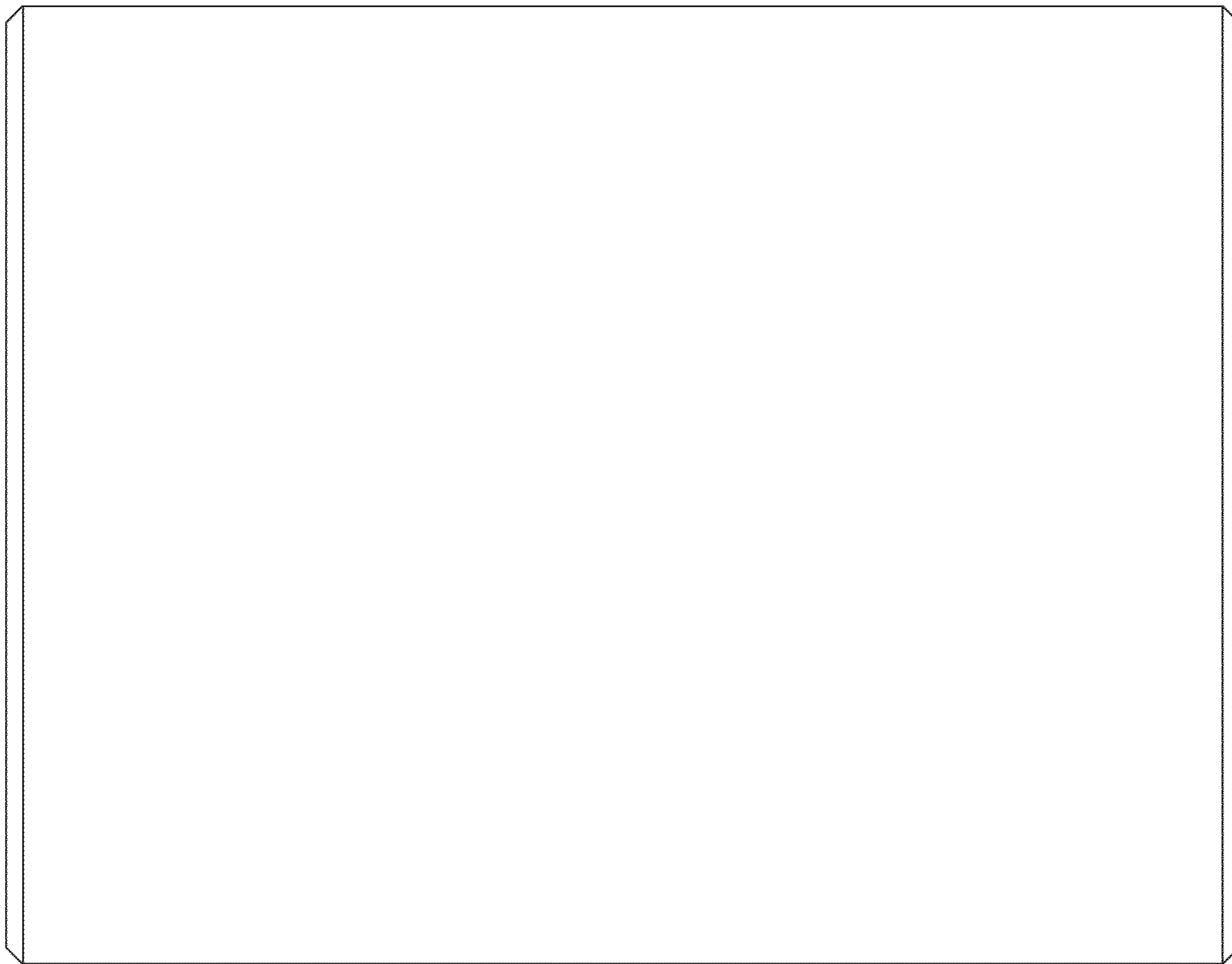

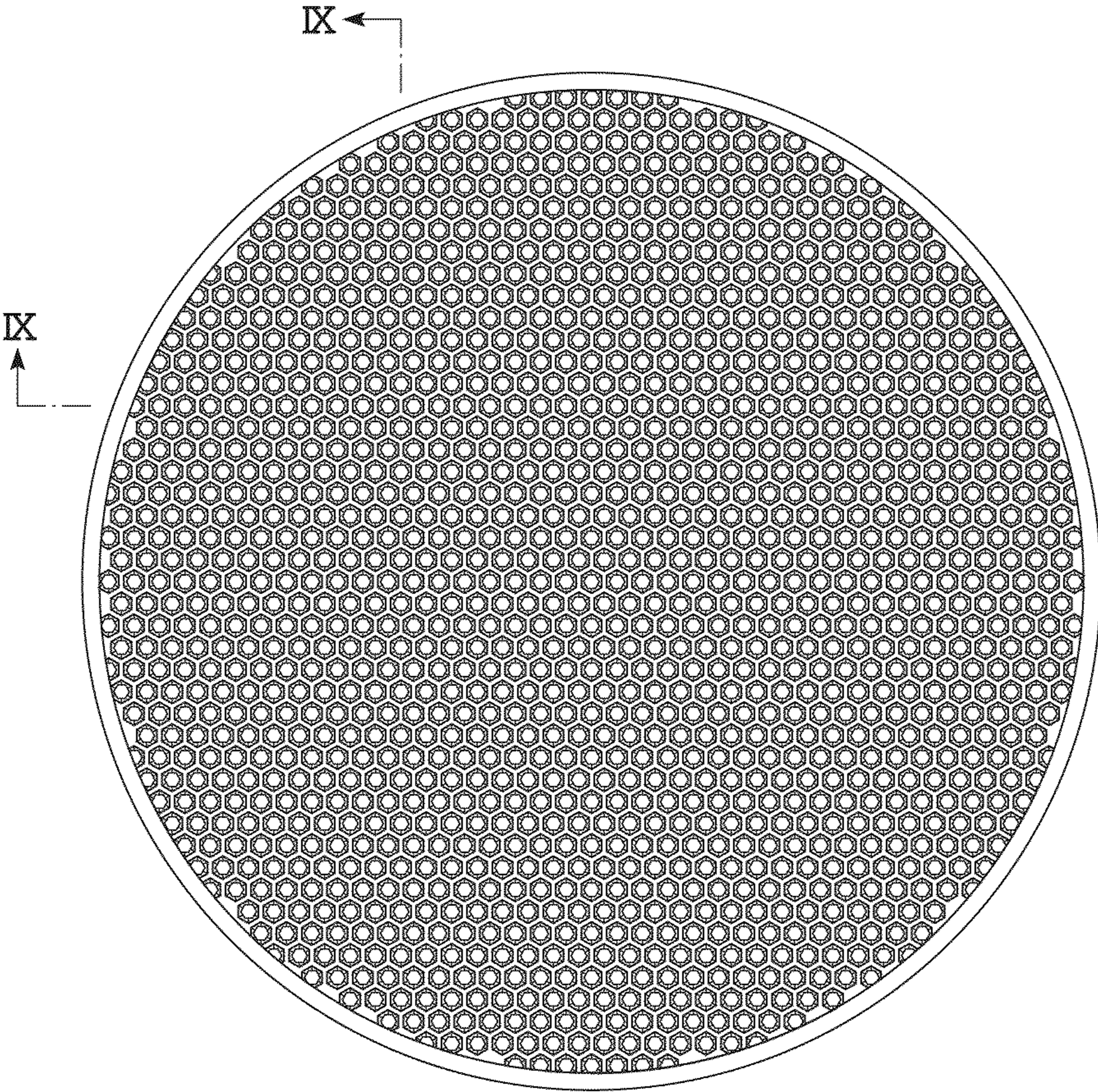

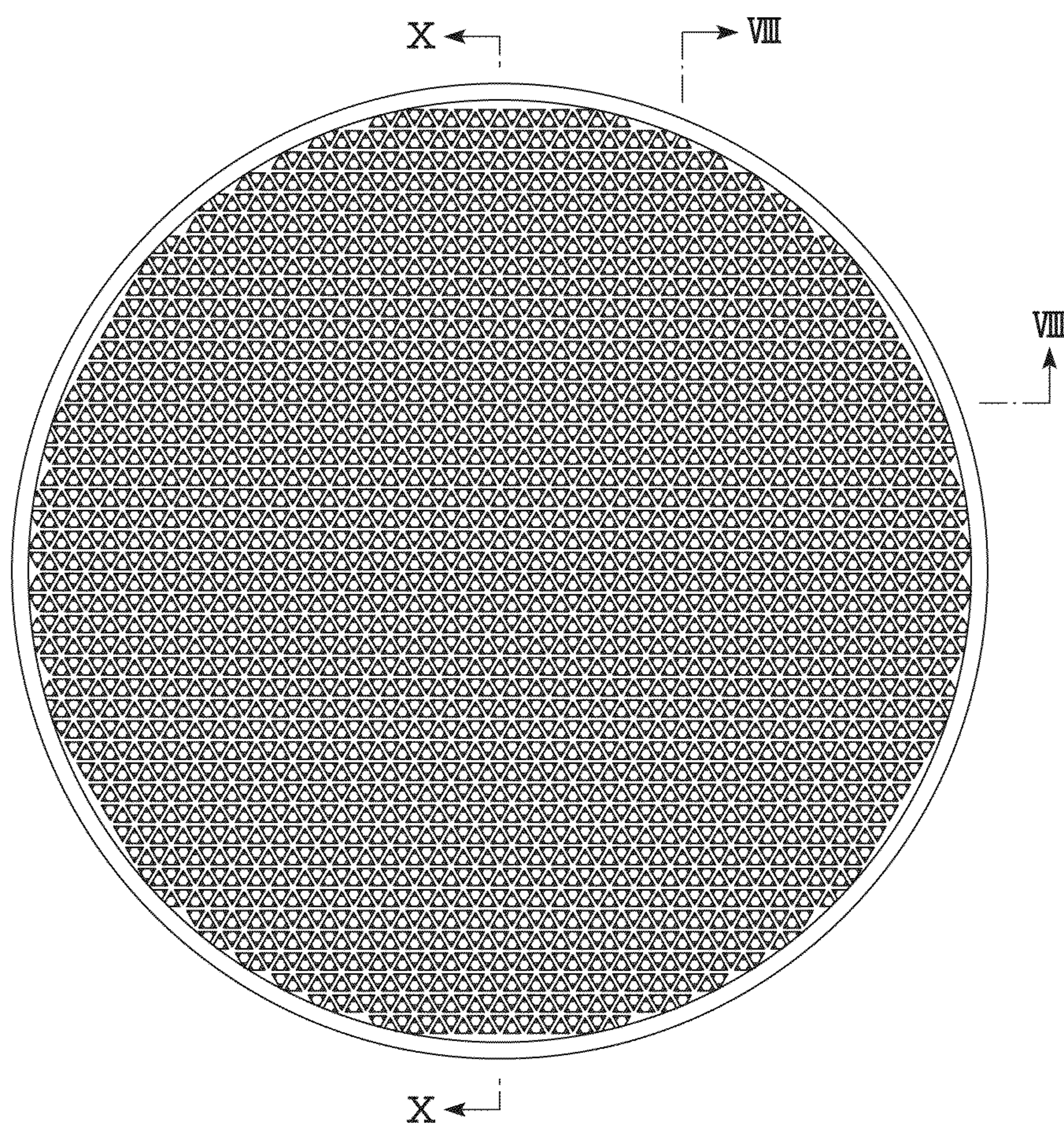

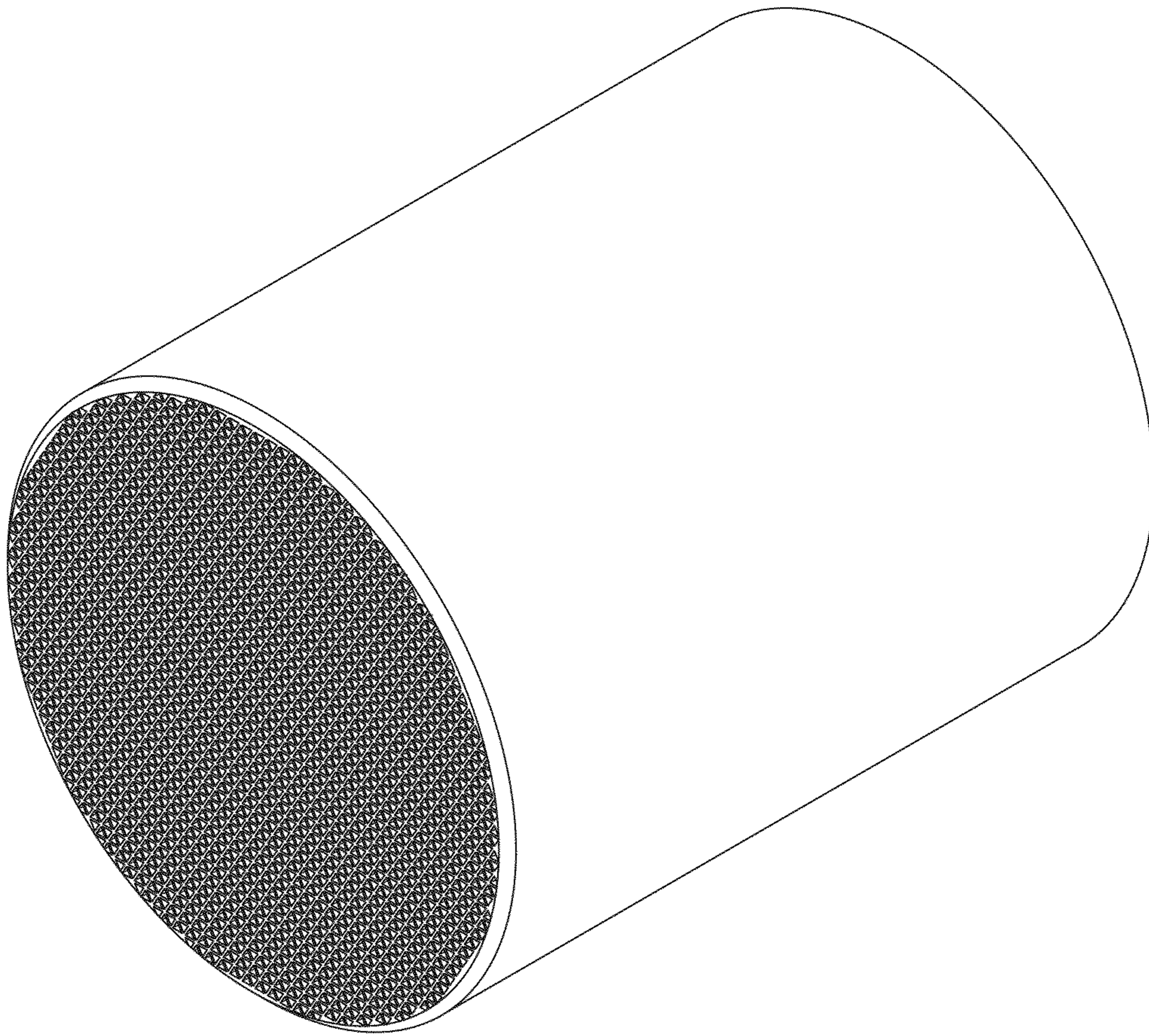

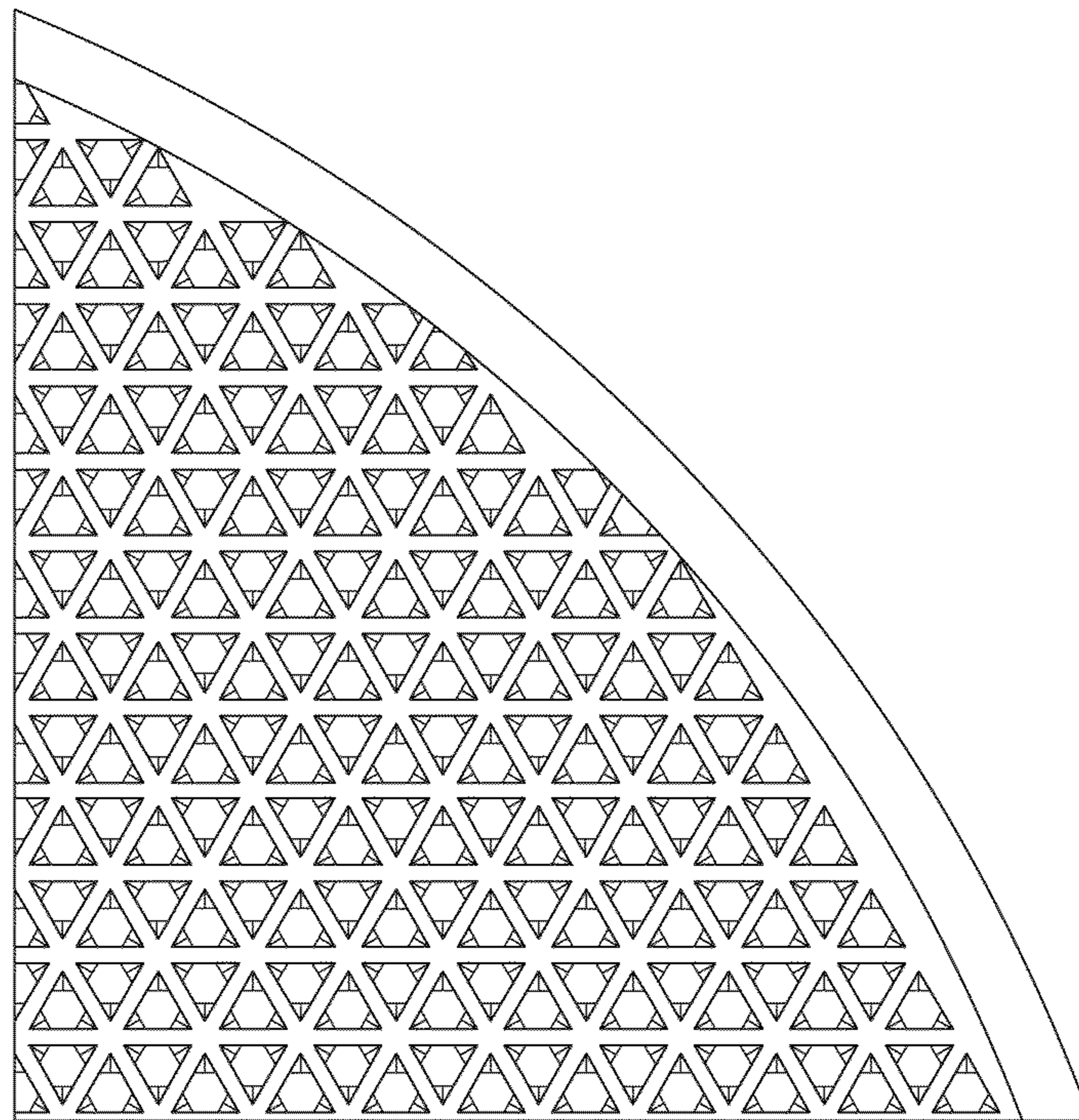

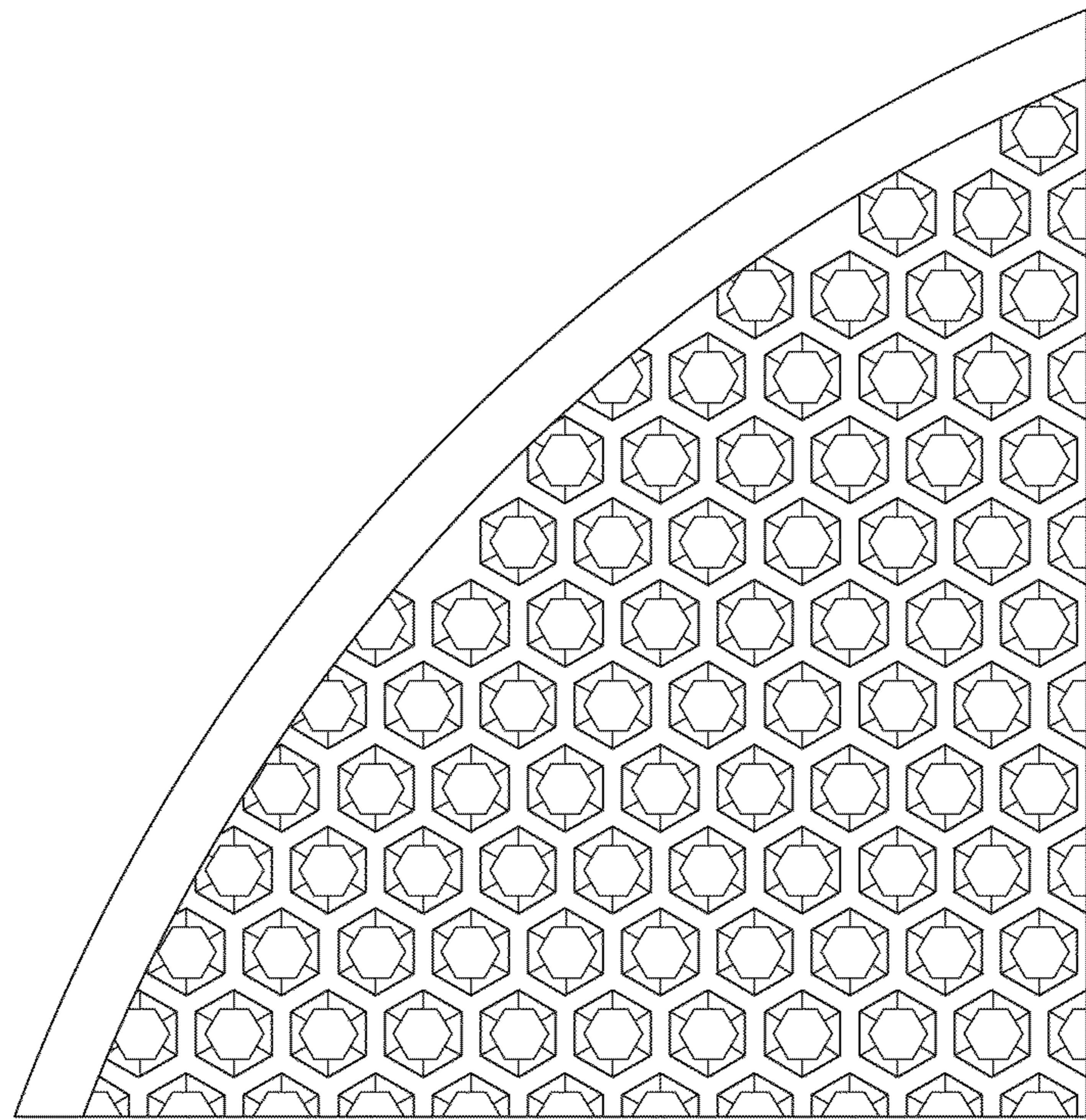

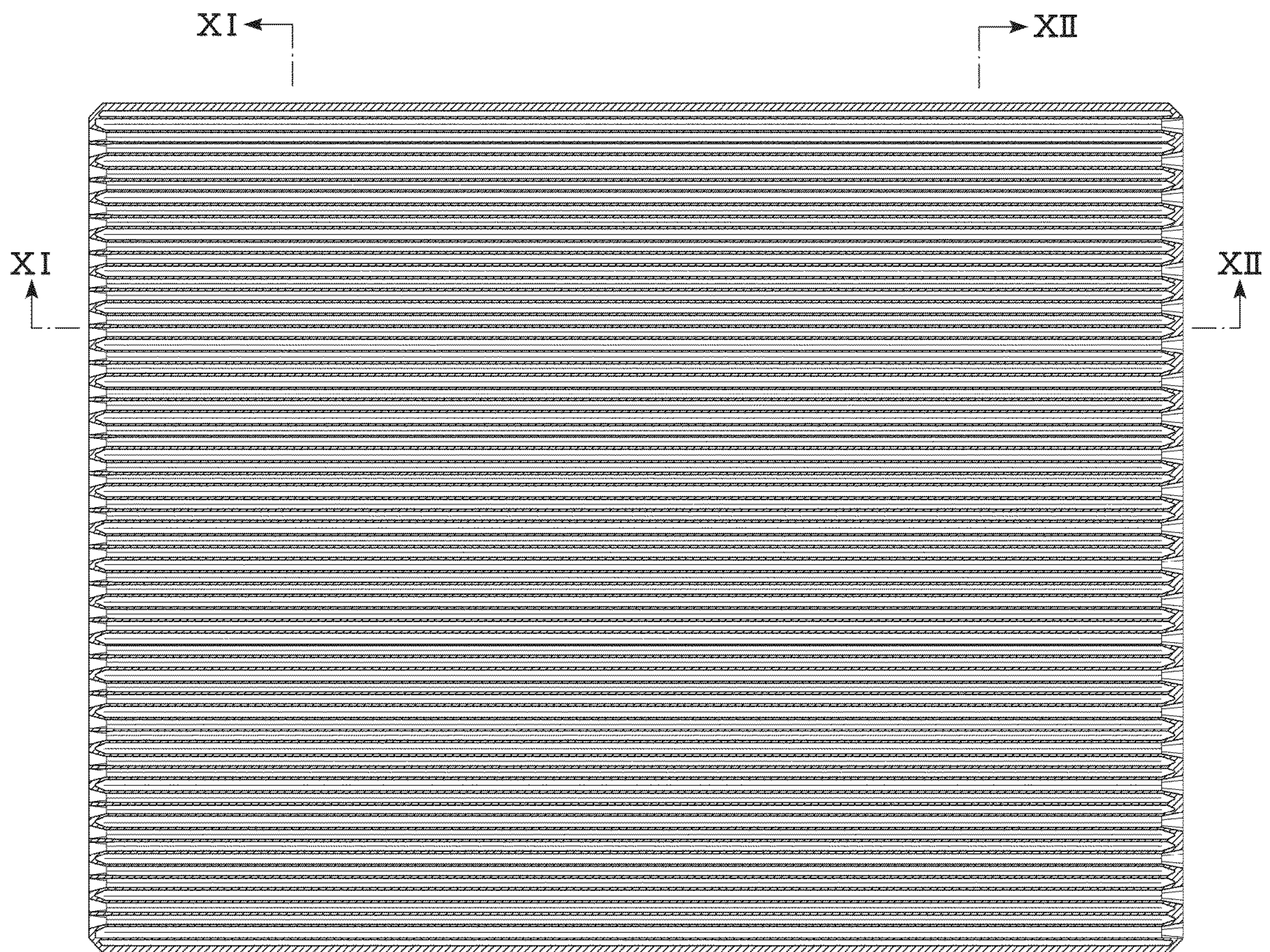

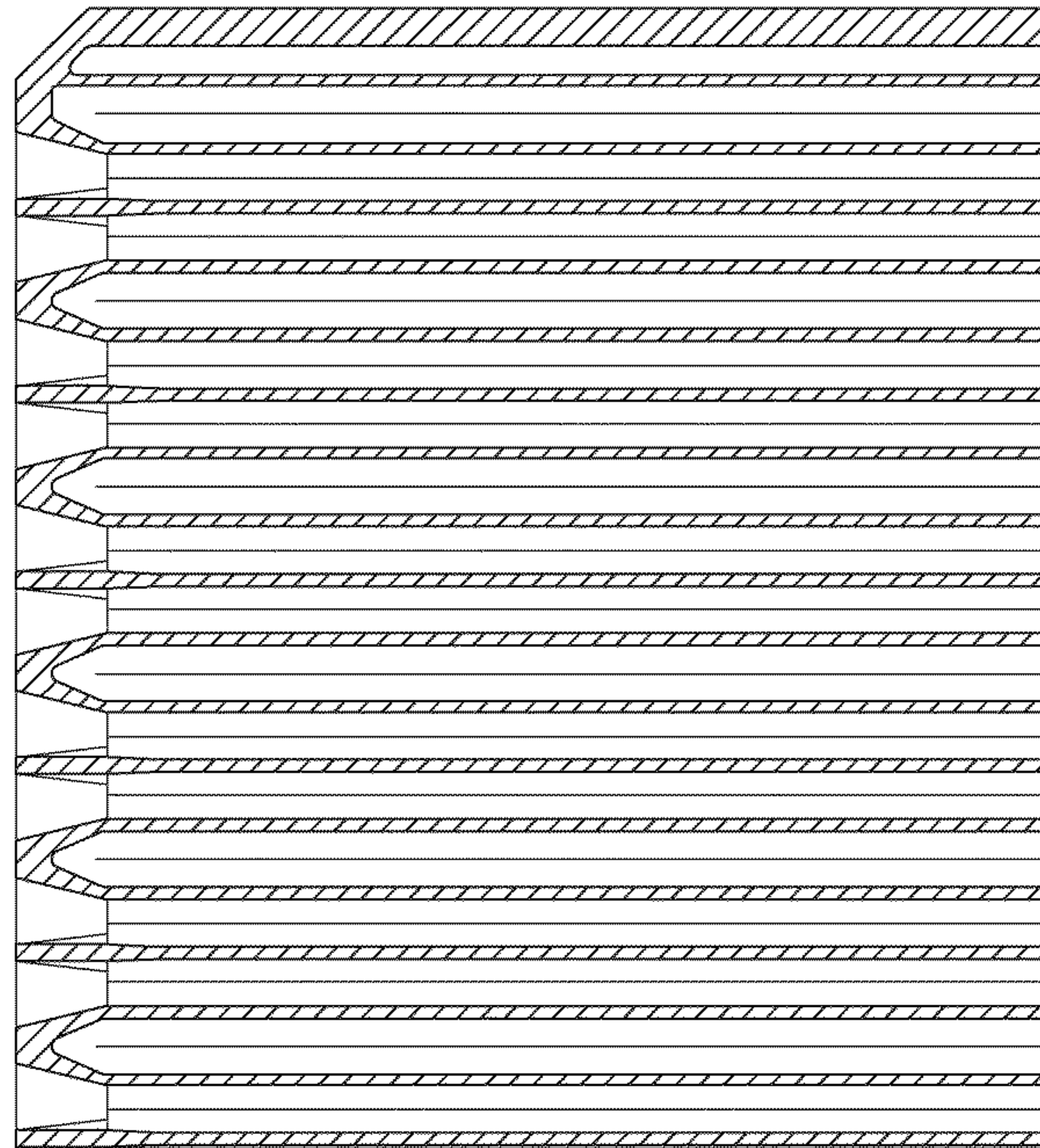

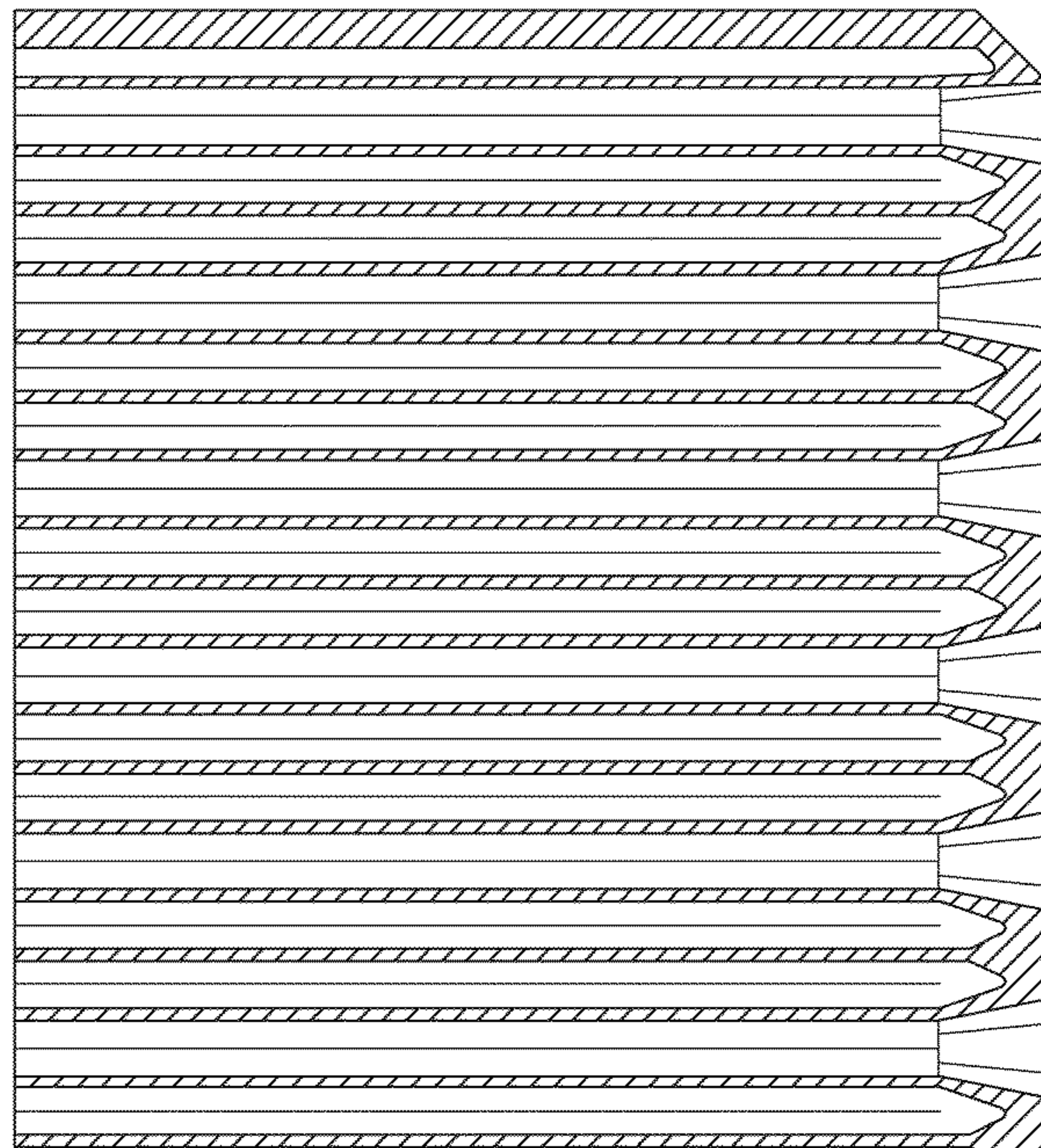

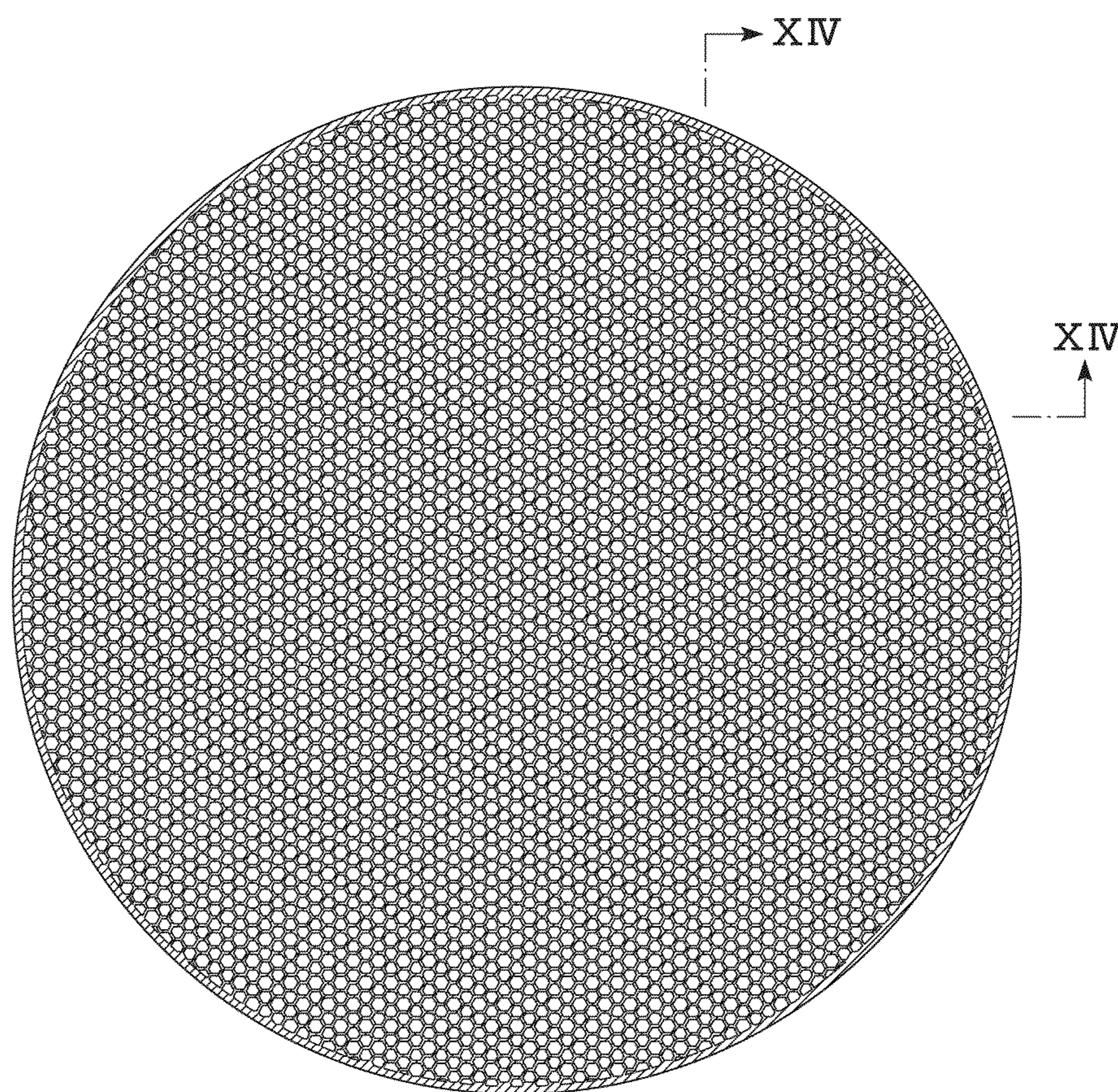

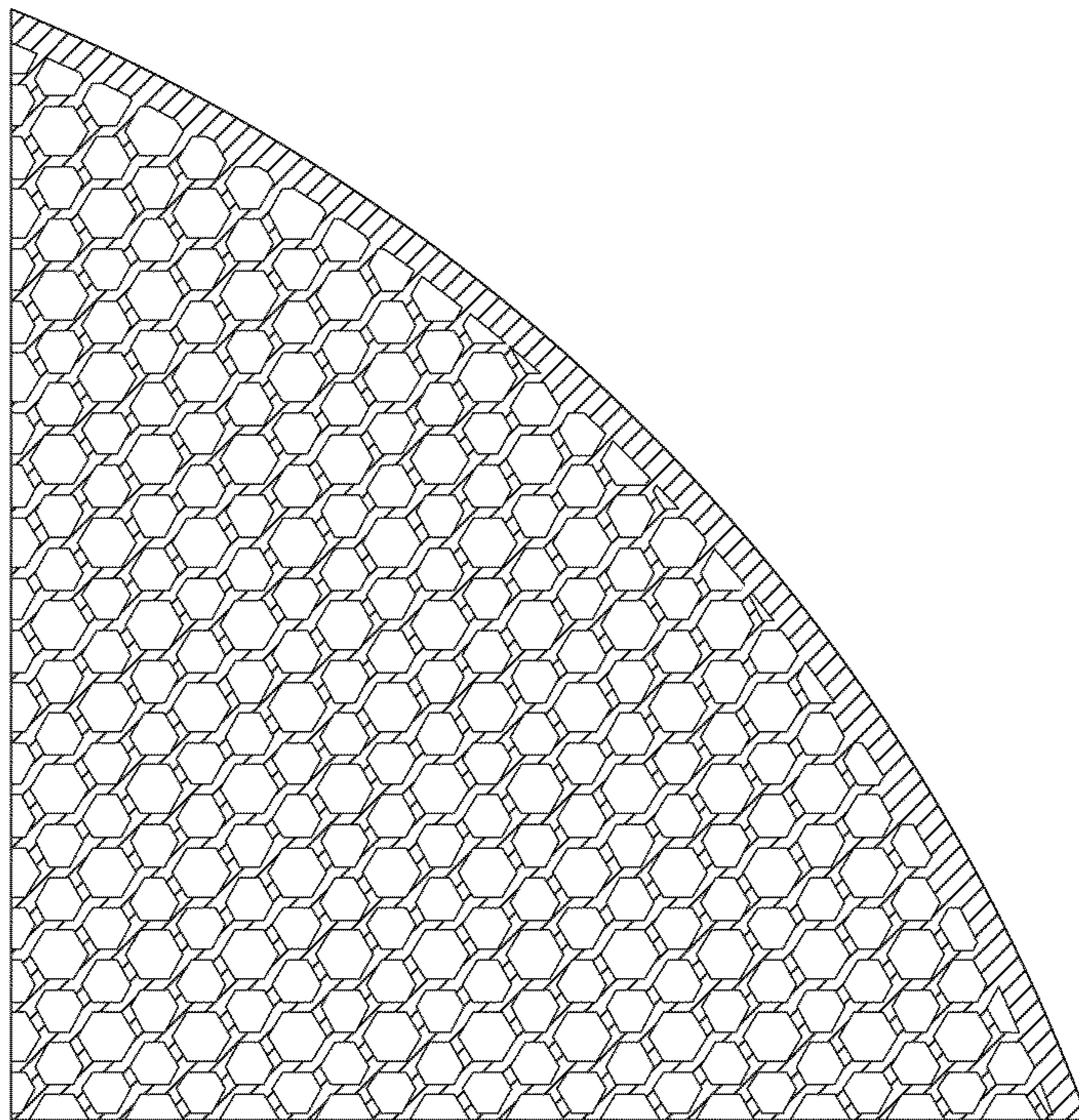
