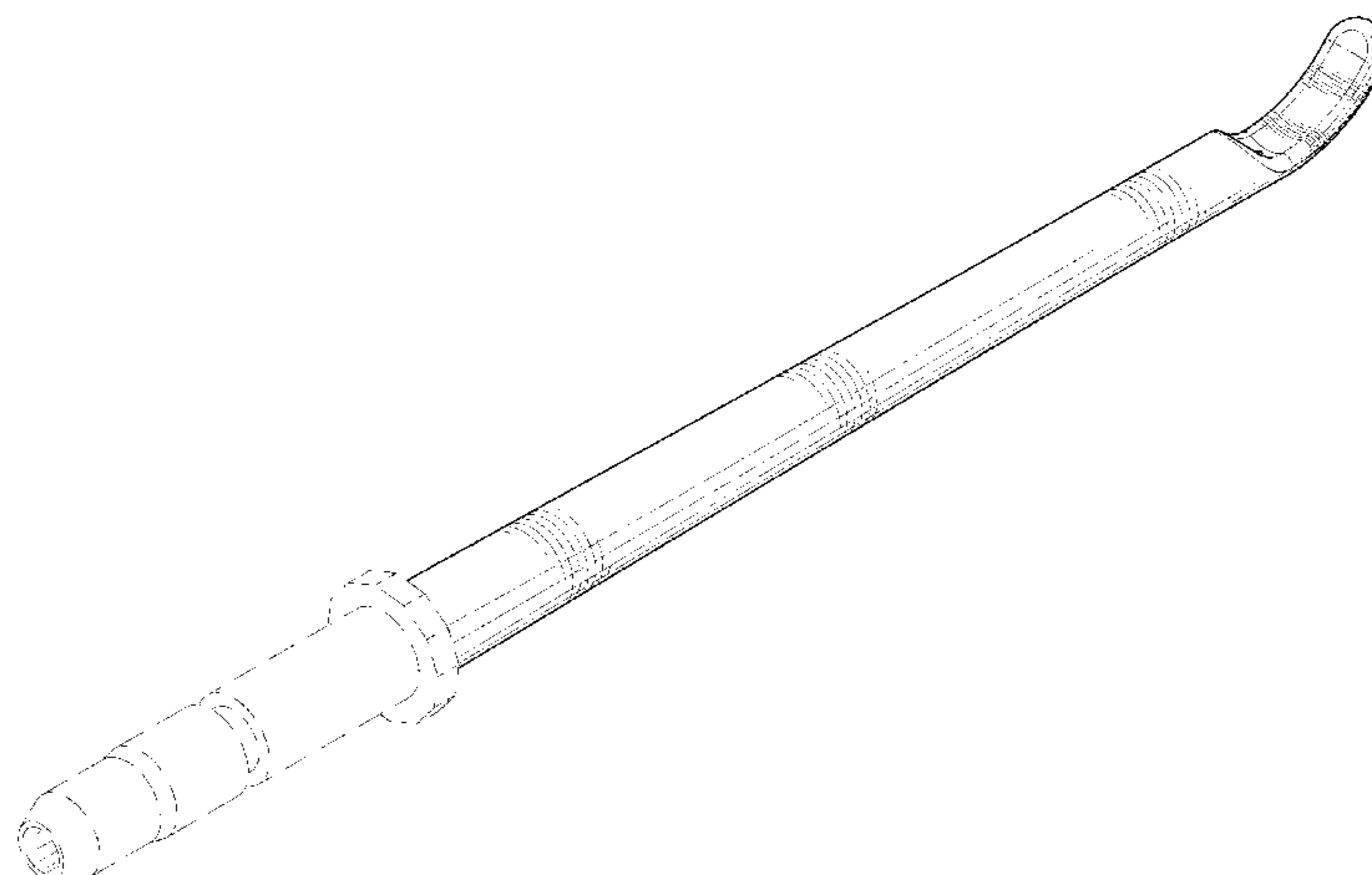
(57) **CLAIM**

The ornamental design for a tonsil cleaning device, as shown and described.

**DESCRIPTION**

FIG. 1 is a first perspective view of a tonsil cleaning device showing my new design;  
 FIG. 2 is a second perspective view of the tonsil cleaning device shown in FIG. 1;  
 FIG. 3 is a first side view of the tonsil cleaning device shown in FIG. 1;  
 FIG. 4 is a second side view of the tonsil cleaning device shown in FIG. 1;  
 FIG. 5 is a third side view of the tonsil cleaning device shown in FIG. 1;  
 FIG. 6 is a fourth side view of the tonsil cleaning device shown in FIG. 1;  
 FIG. 7 is a fifth side view of the tonsil cleaning device shown in FIG. 1; and,  
 FIG. 8 is a cross-sectional second side view of the tonsil cleaning device shown in FIG. 1, the cross-section taken along the section line -8- indicated in FIG. 2.  
 The broken lines in FIGS. 1-8 indicate environmental structure only that forms no part of the claimed design.

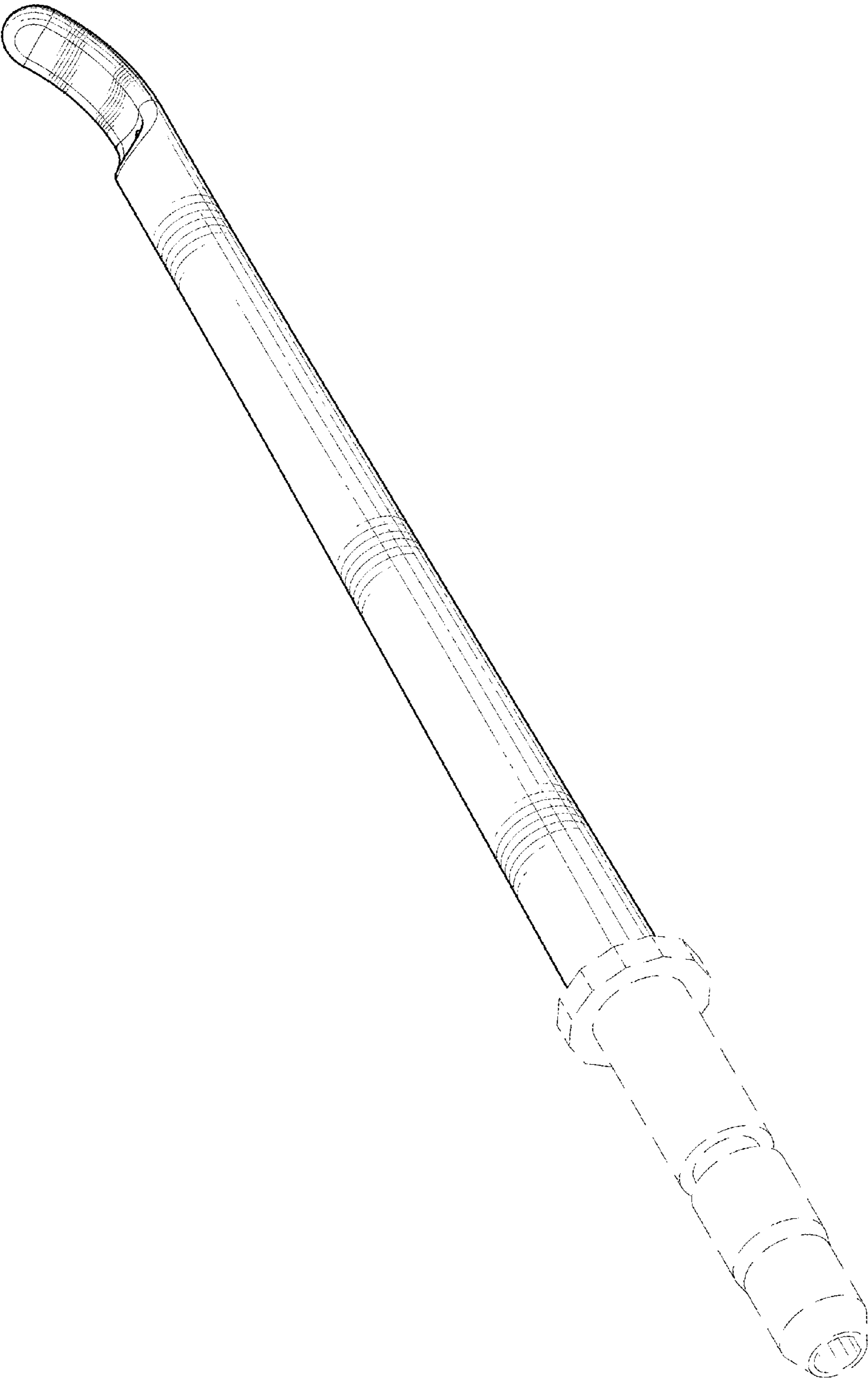

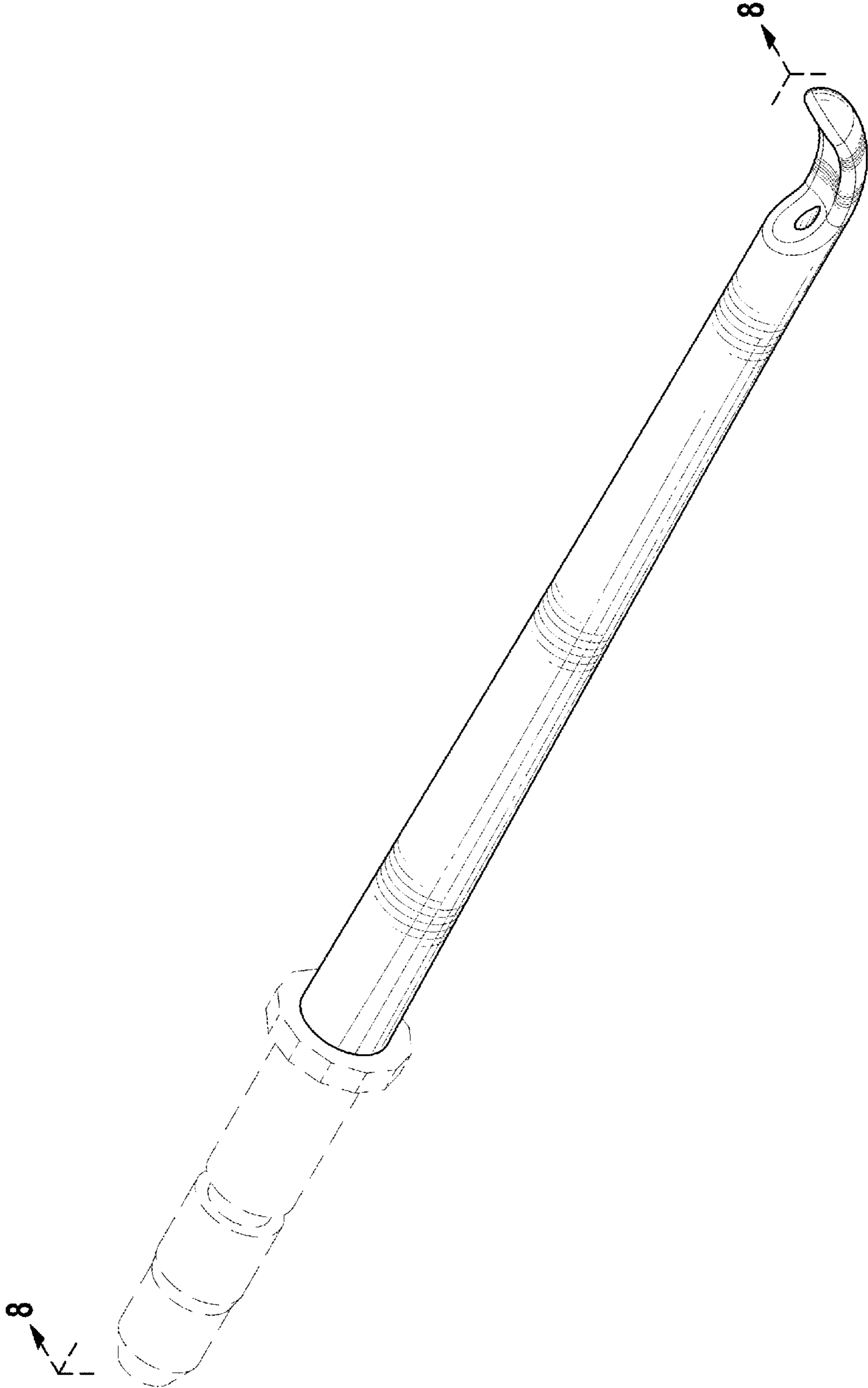
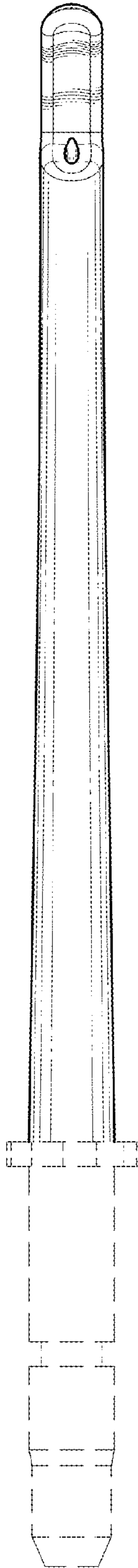
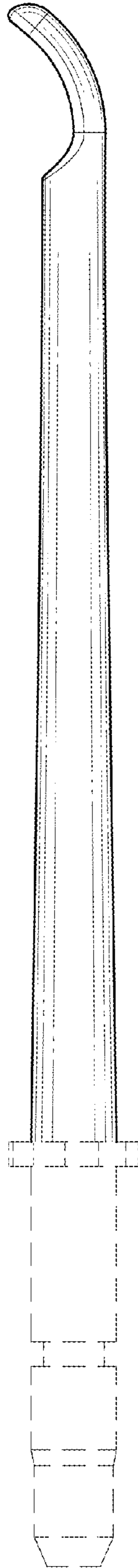


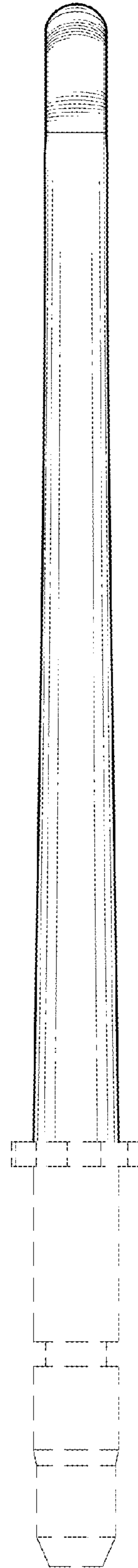

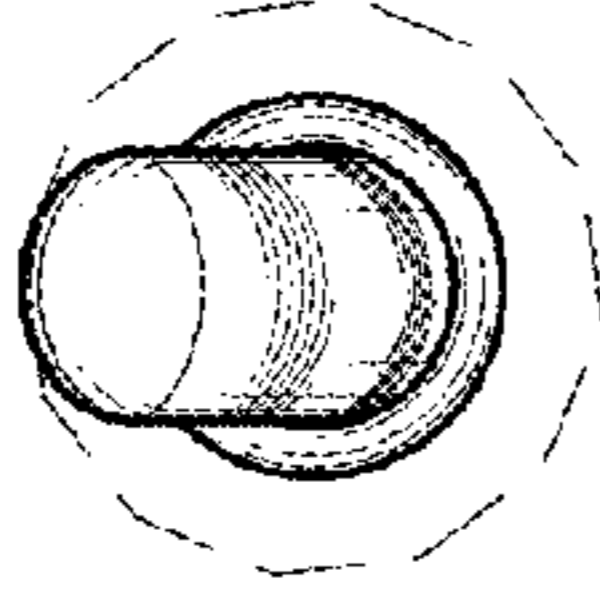

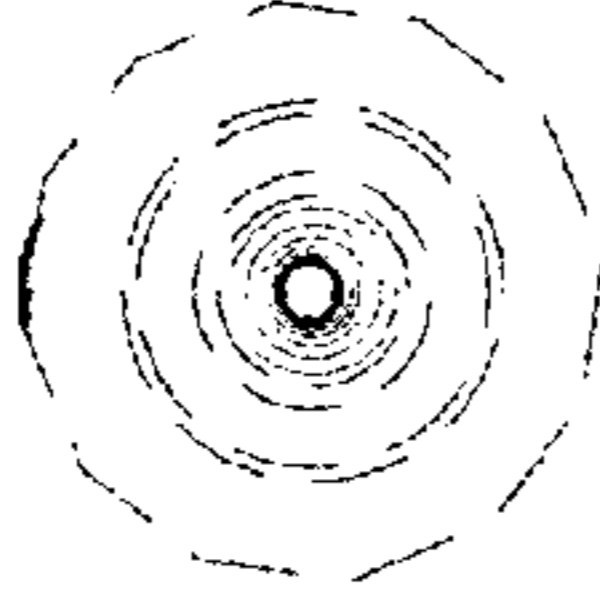

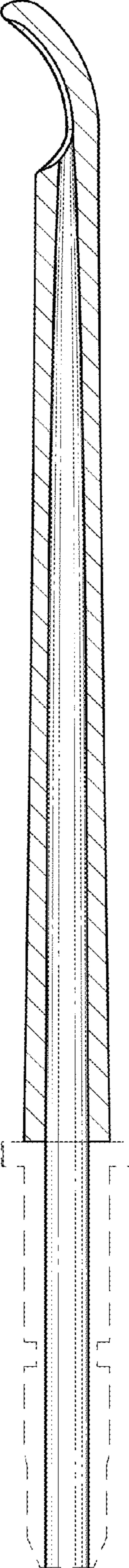
