DESCRIPTION

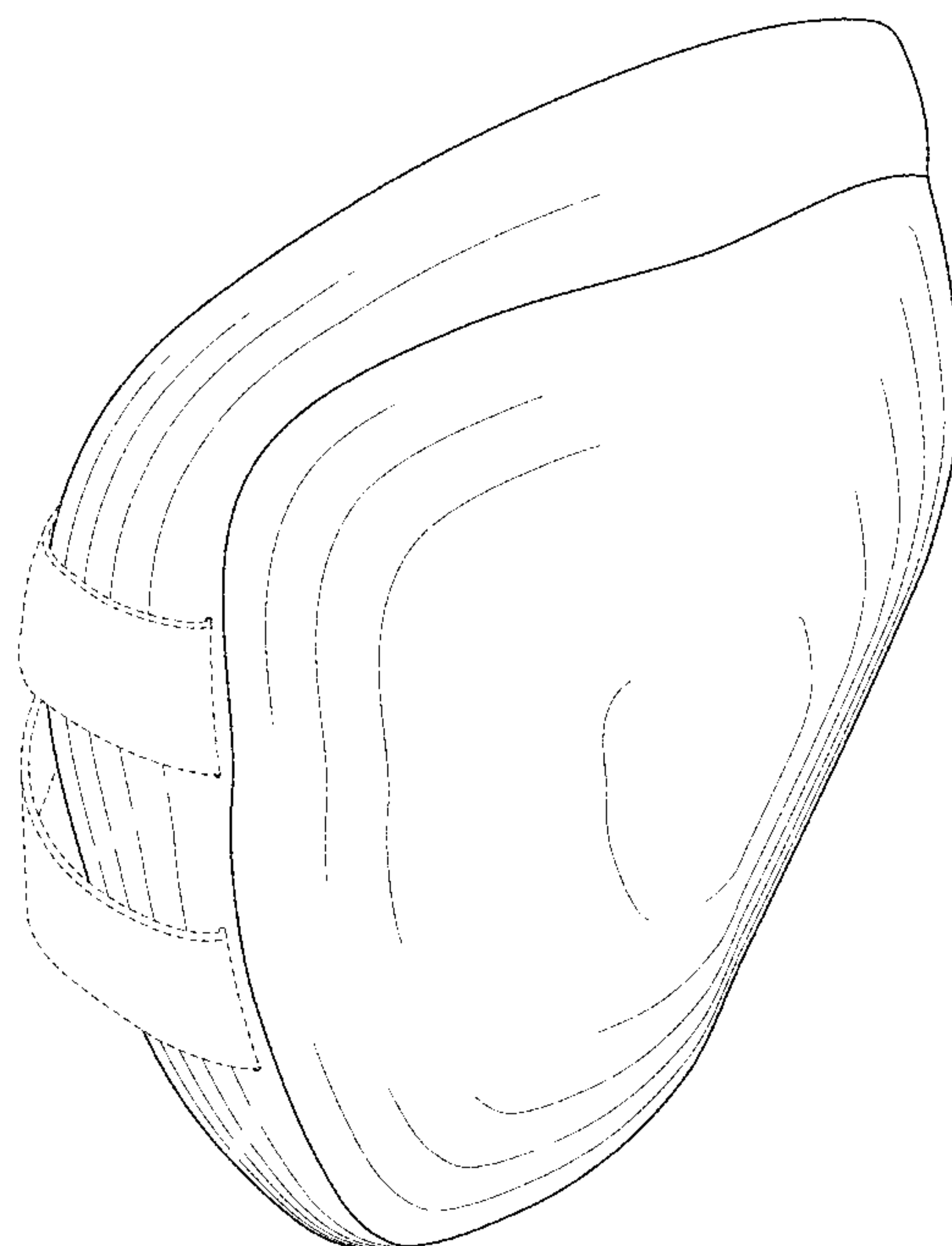
FIG. 1 is a perspective view (as seen from the front view) of the contoured kneepad.

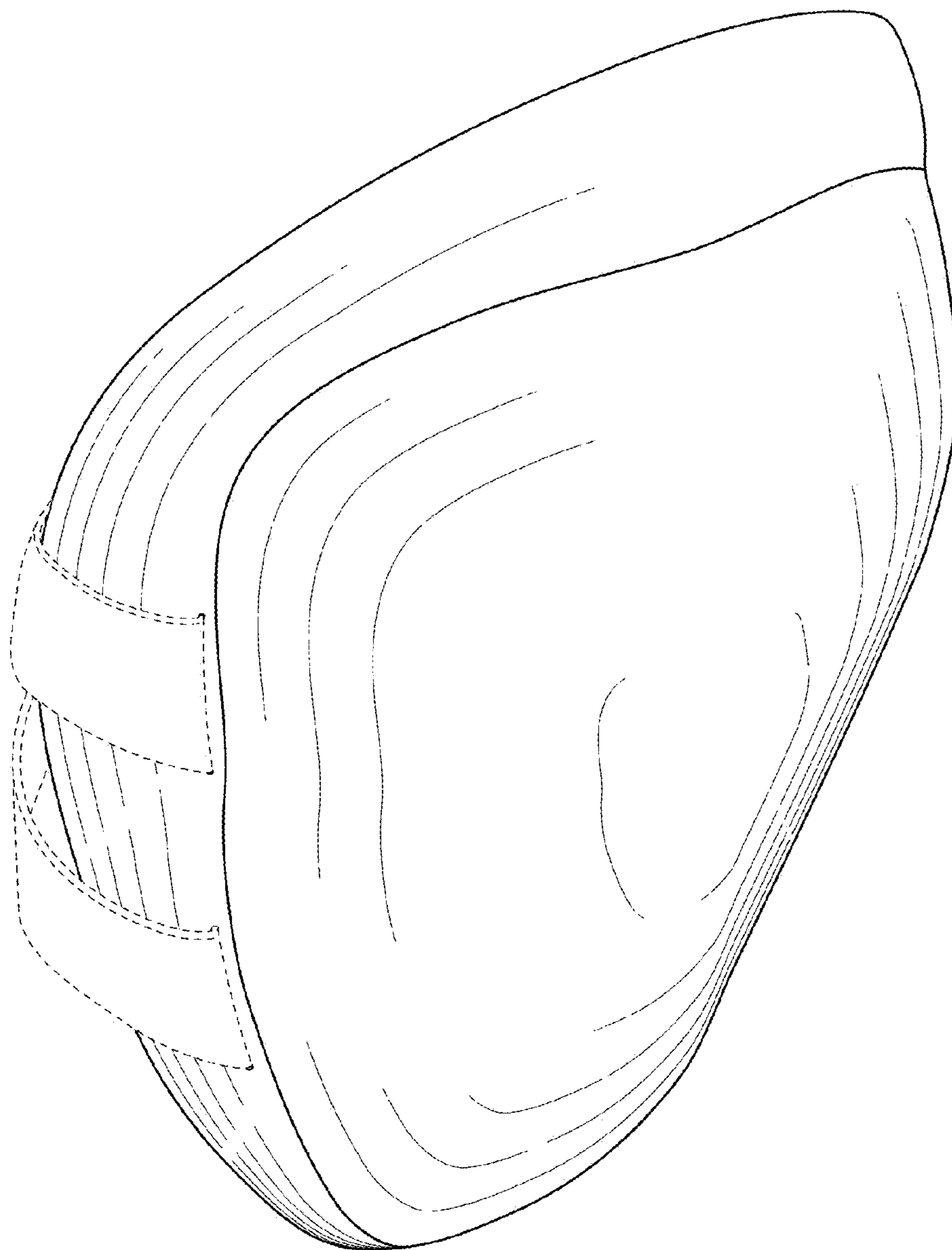

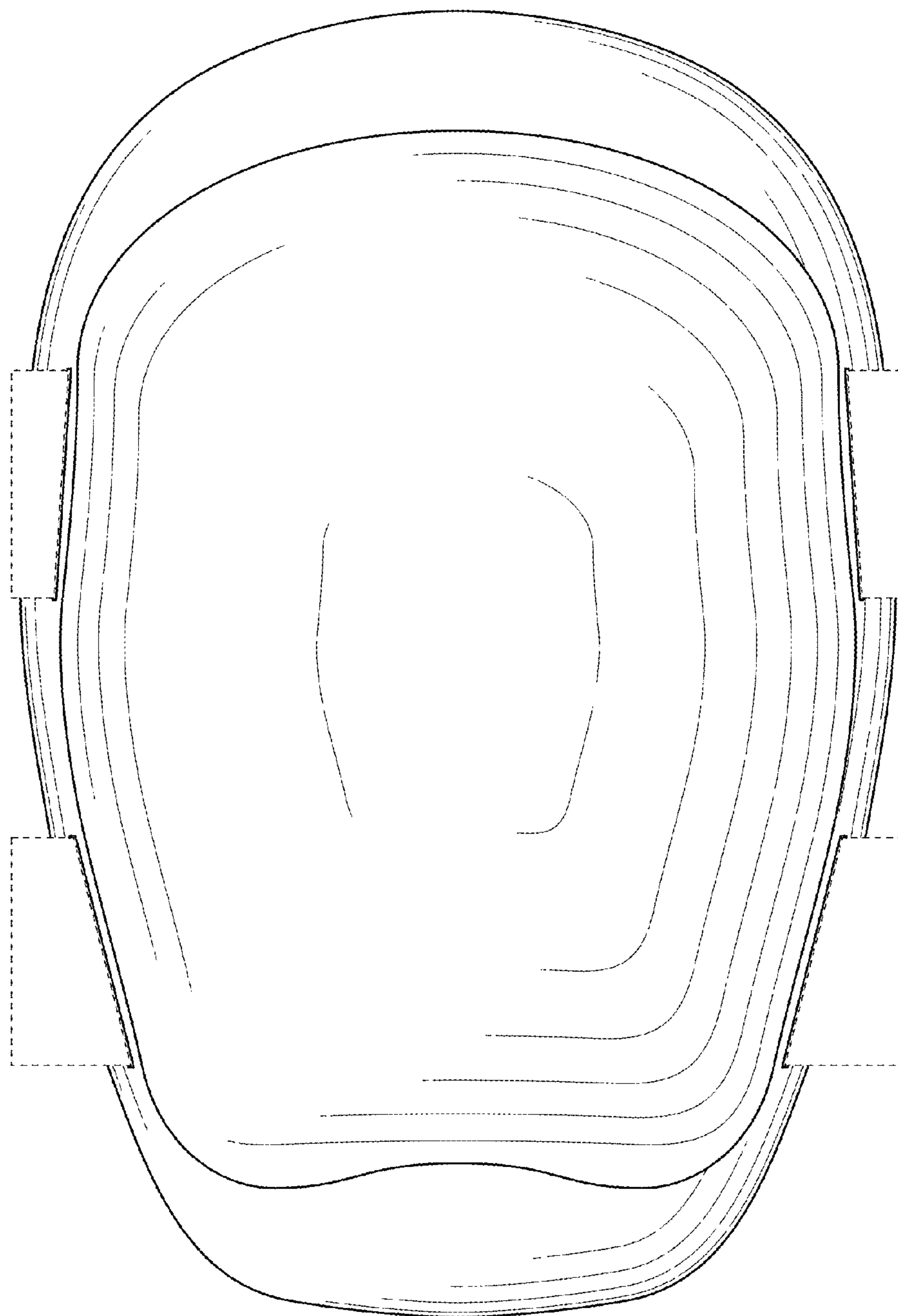

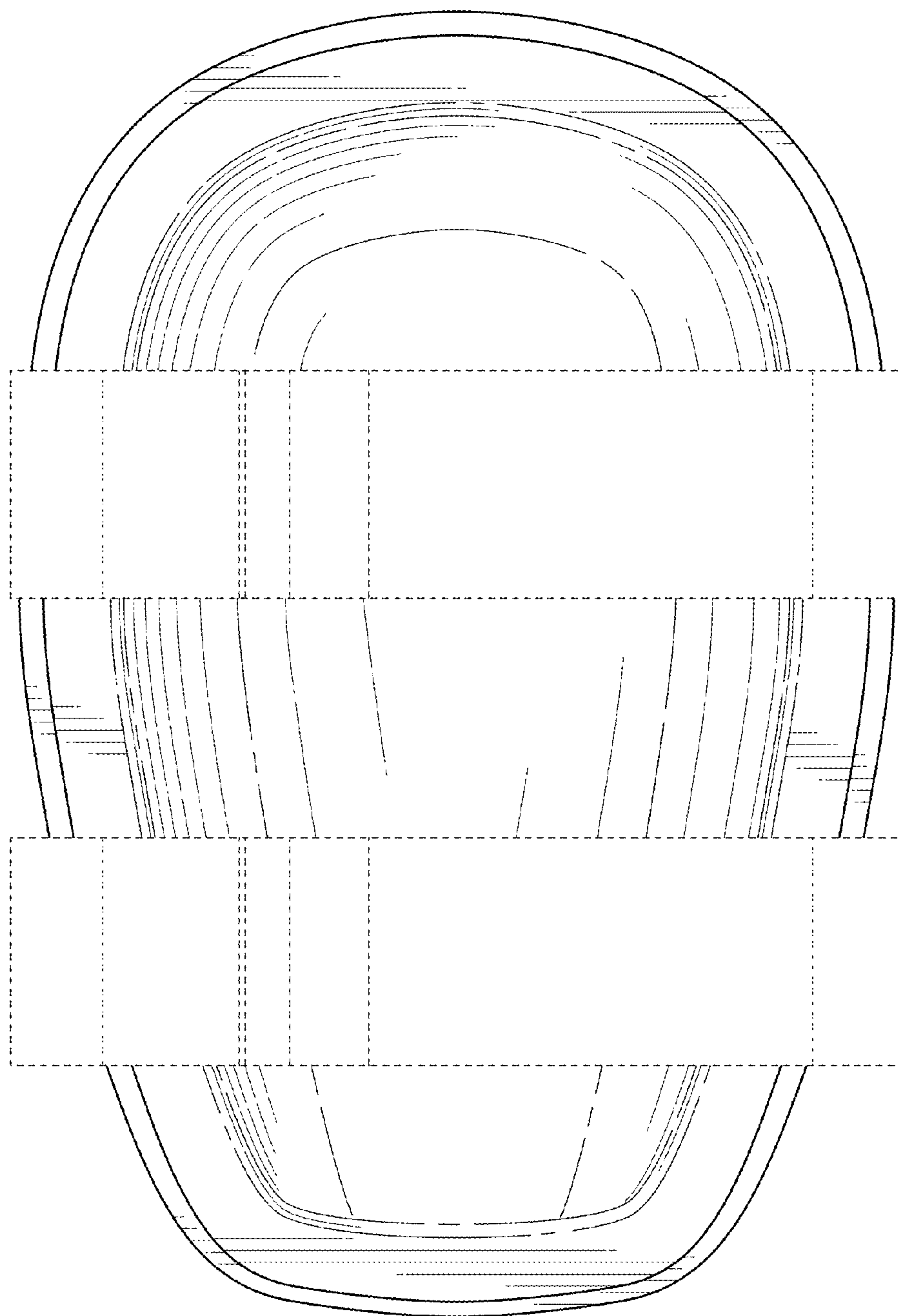

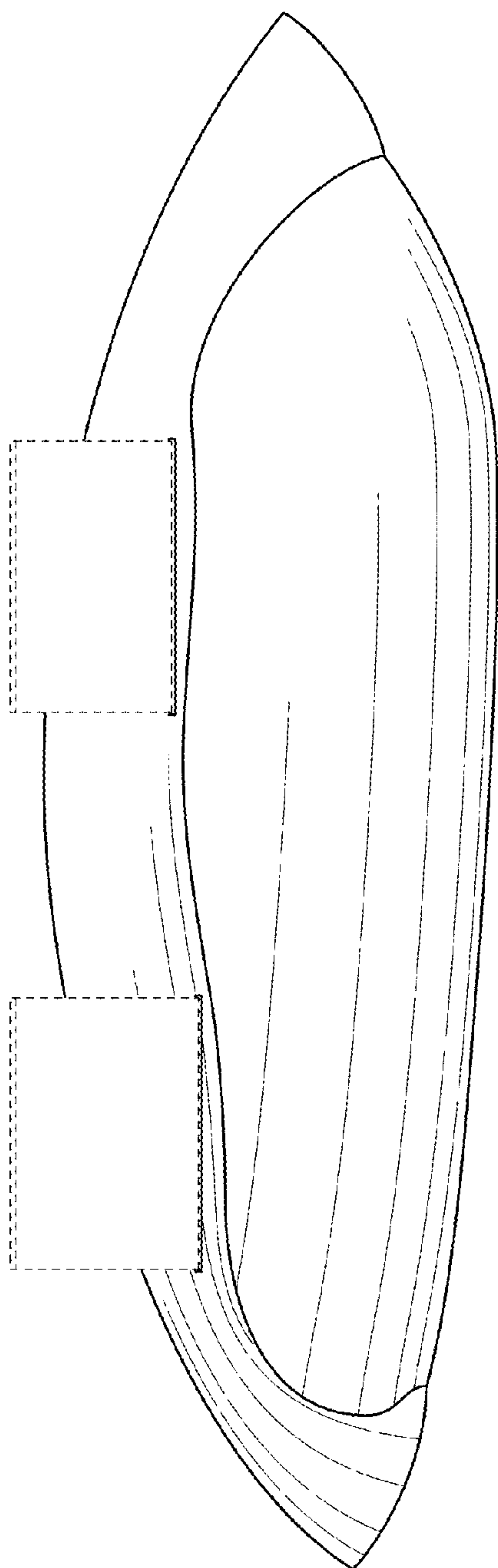

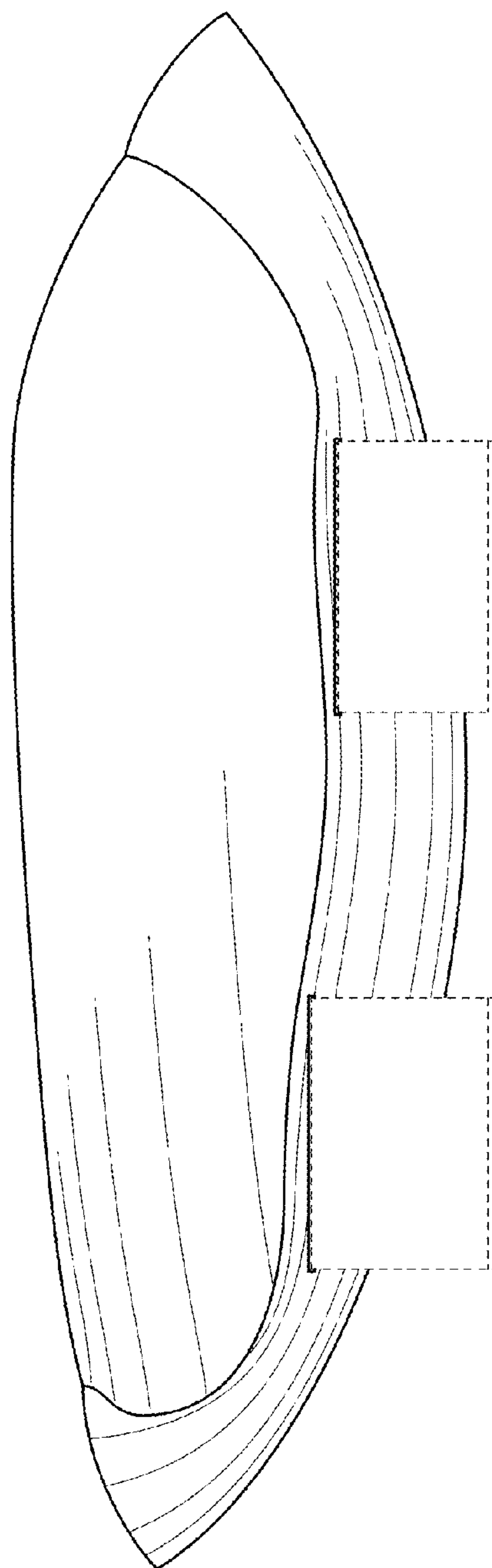

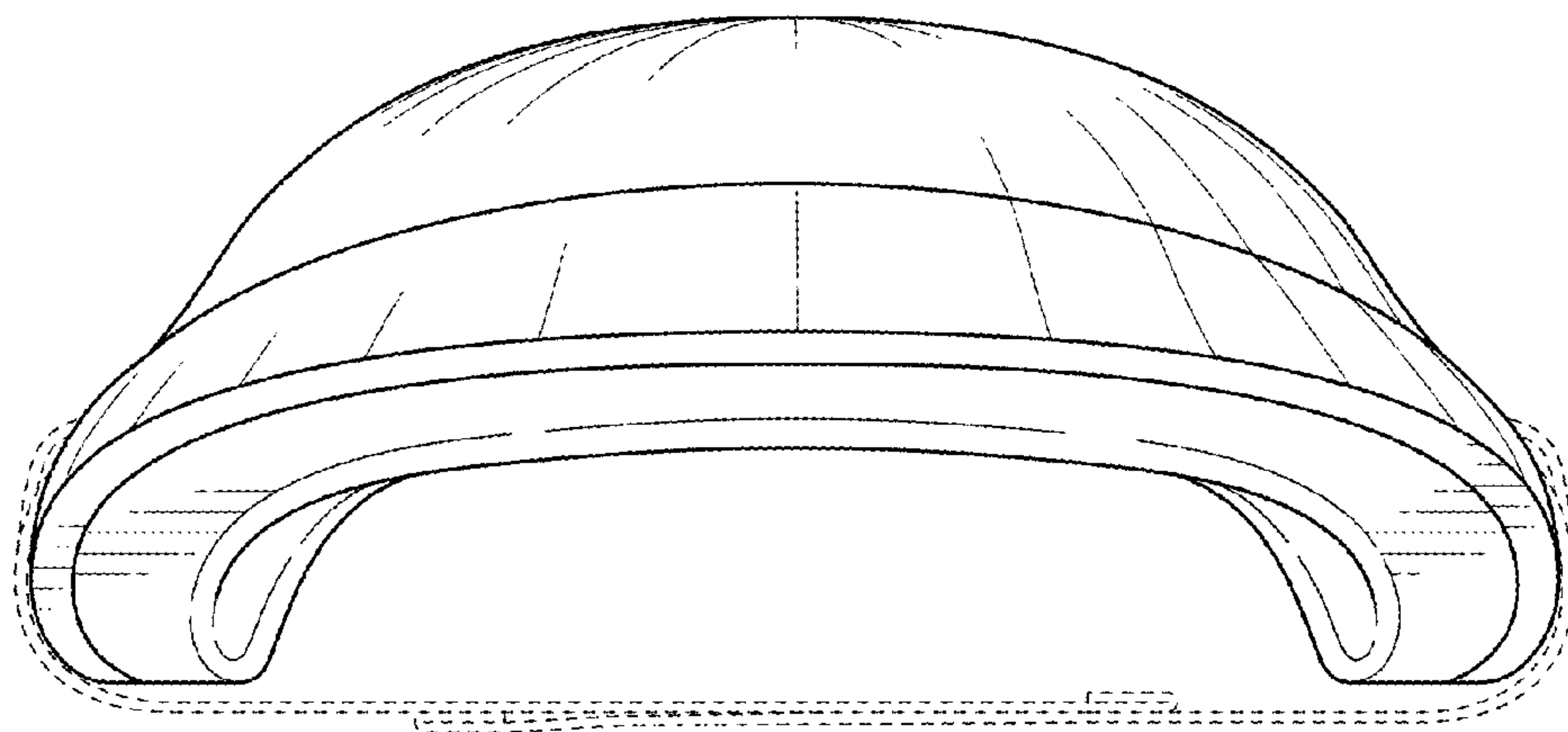

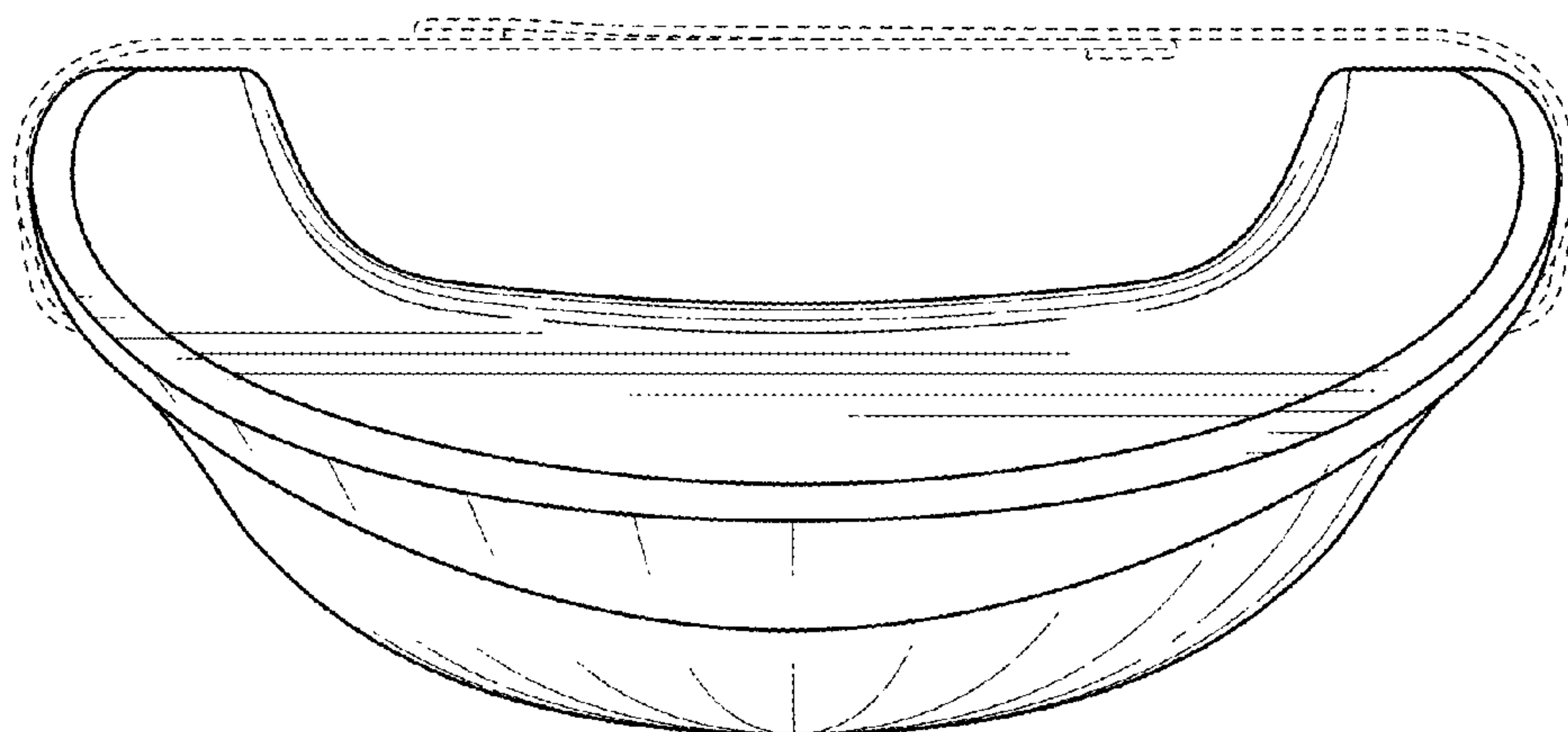

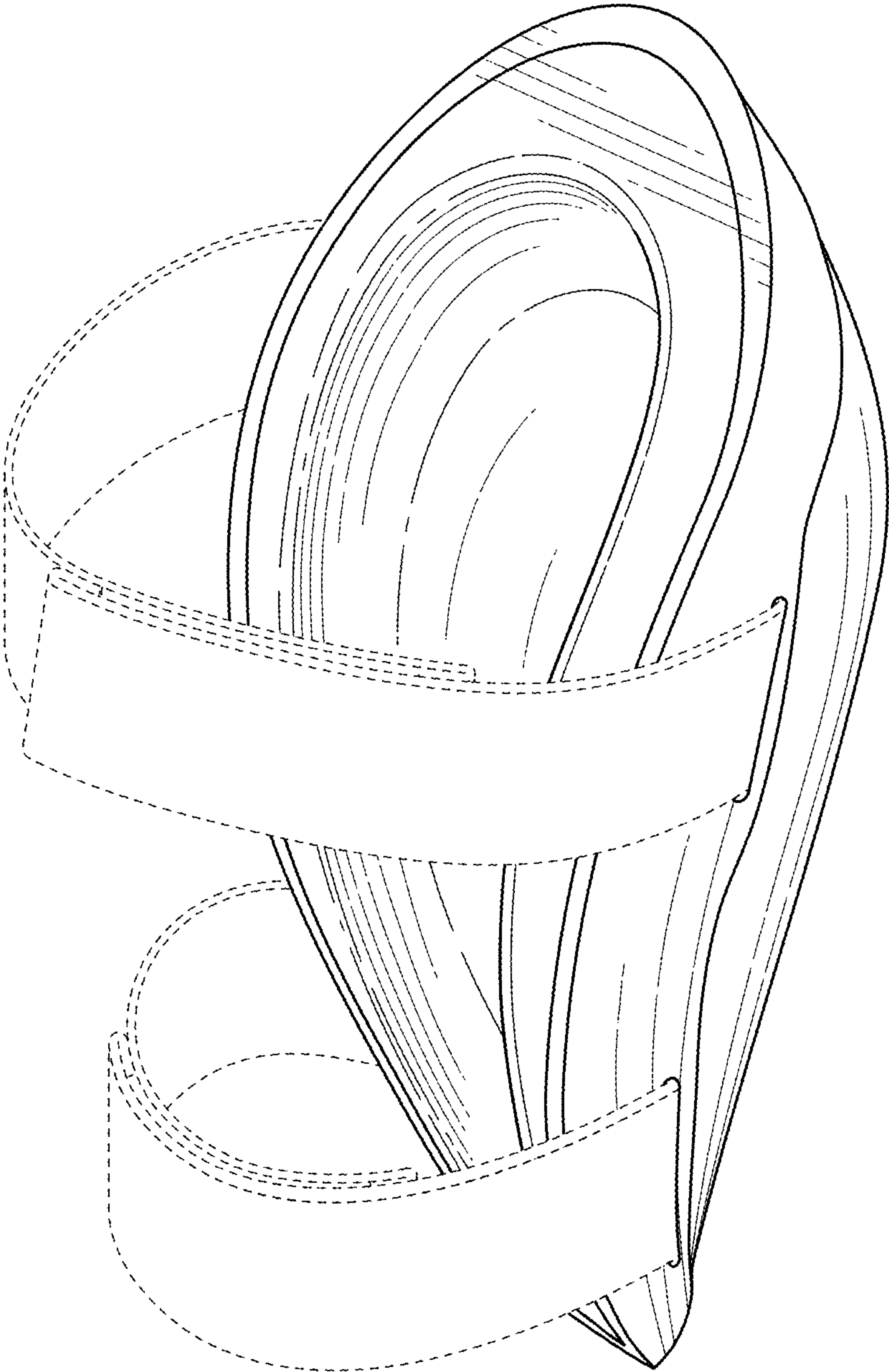
