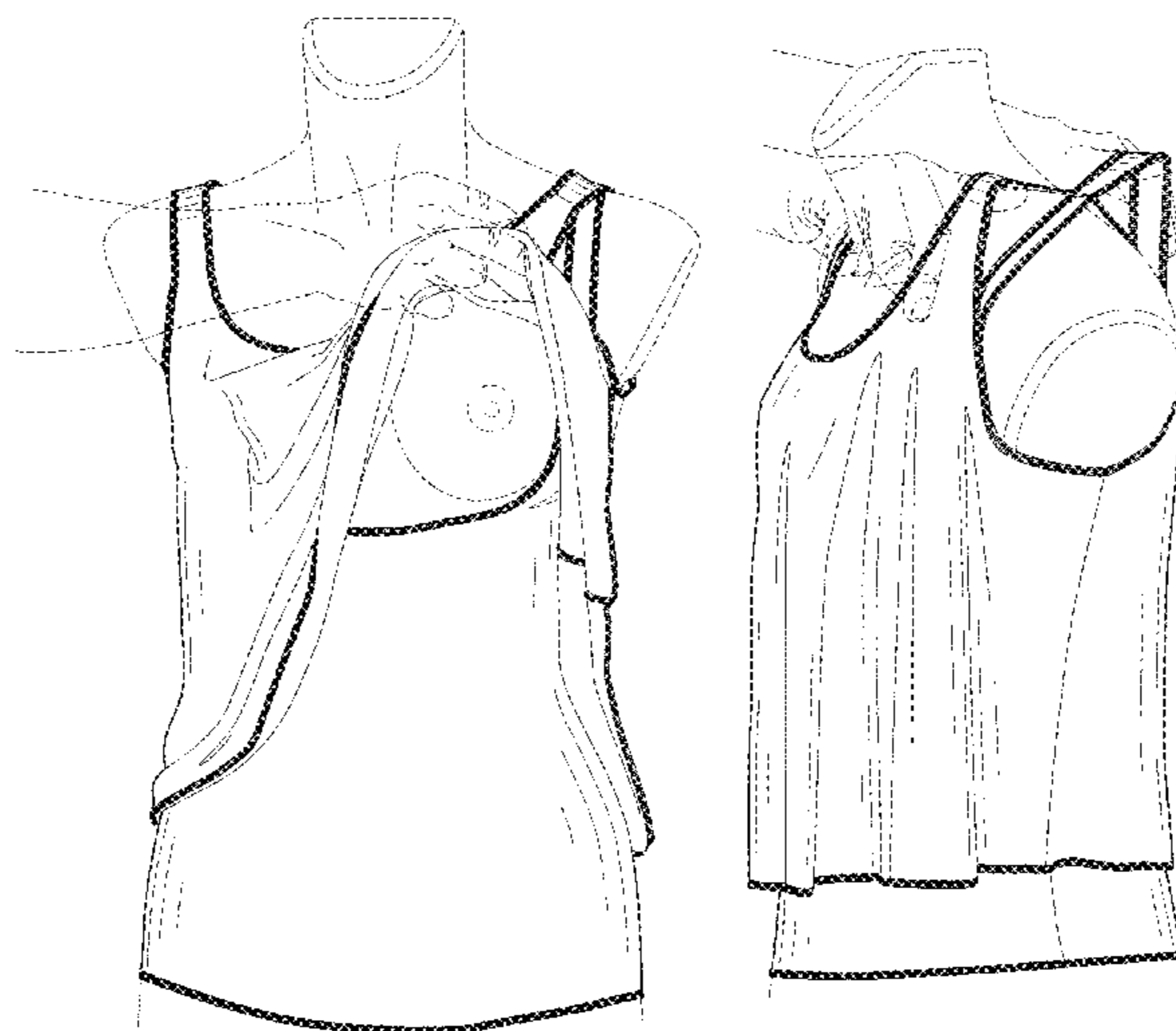
(57) **CLAIM**

The ornamental design for a breastfeeding top, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the breastfeeding top, wherein the underlay is shown without the overlay in order to show aspects of the design that are not otherwise apparent; FIG. 2 is a front perspective view of the breastfeeding top; FIG. 3 is a front perspective view thereof, wherein the overlay is in a lifted state; FIG. 4 is a side perspective view of the breastfeeding top; FIG. 5 is an alternate side perspective thereof, wherein the attachment site is shown; and, FIG. 6 is a back perspective view of the breastfeeding top. The broken lines shown in the views are directed to environment and form no part of the claimed design.

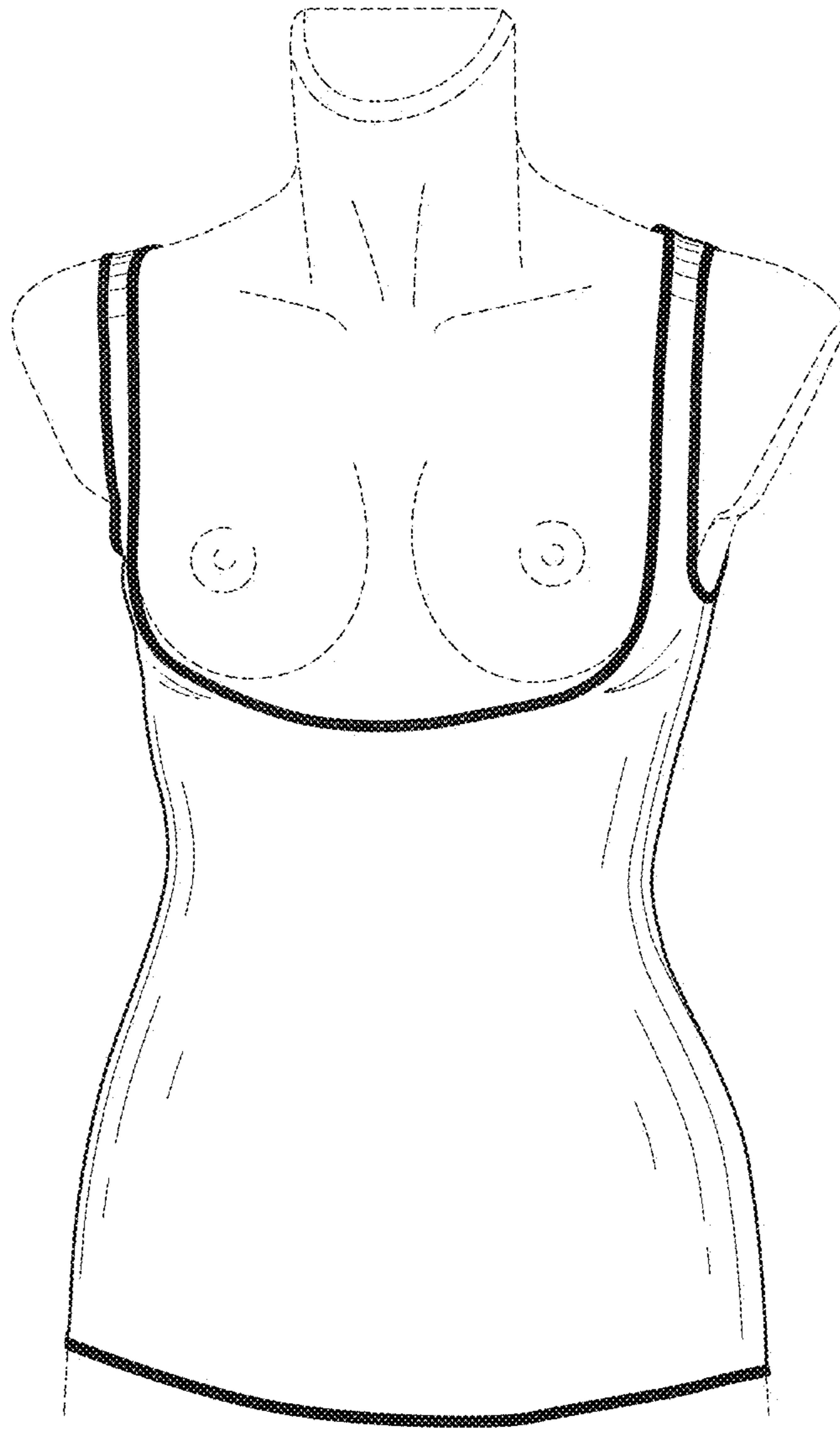

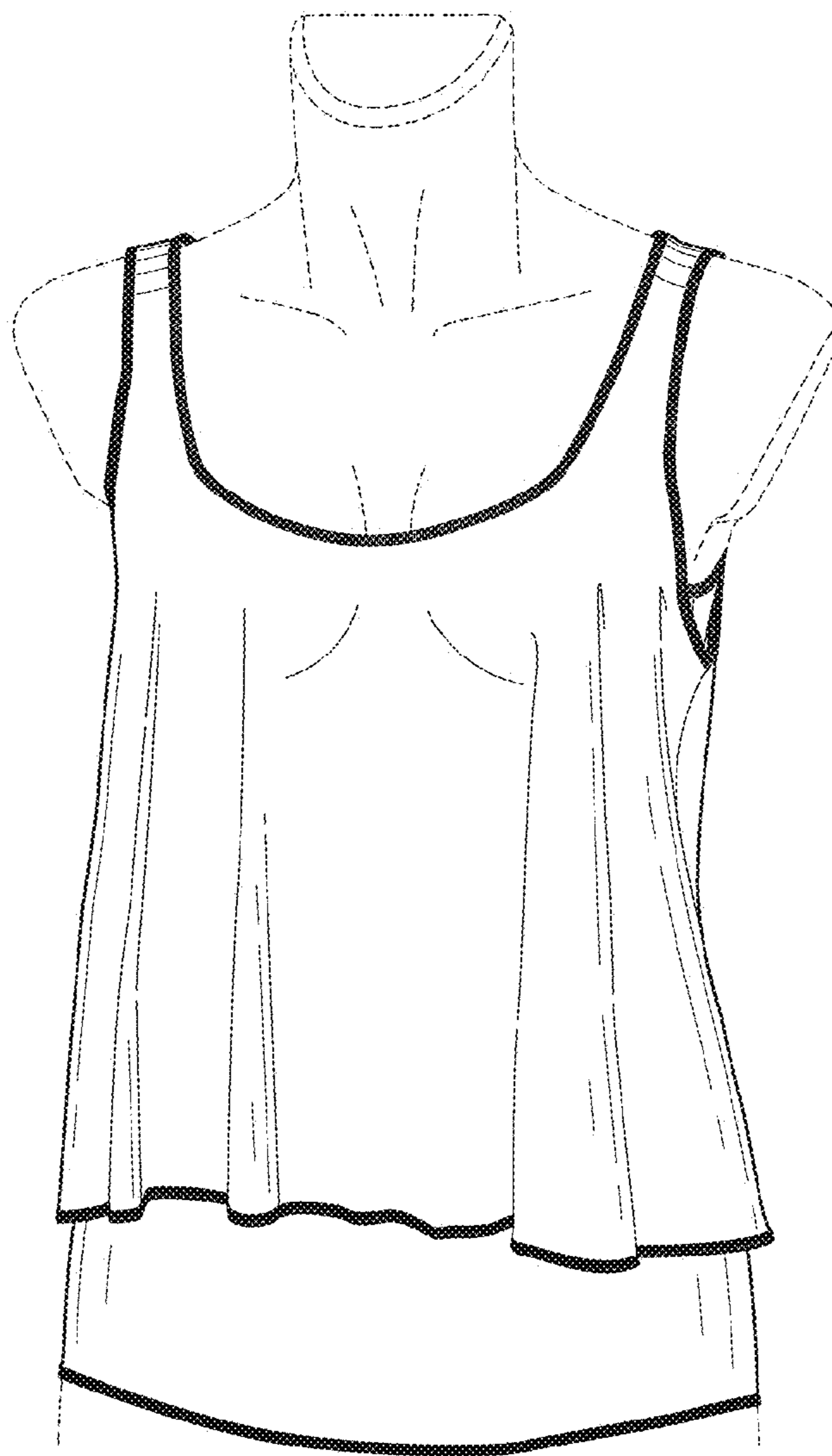

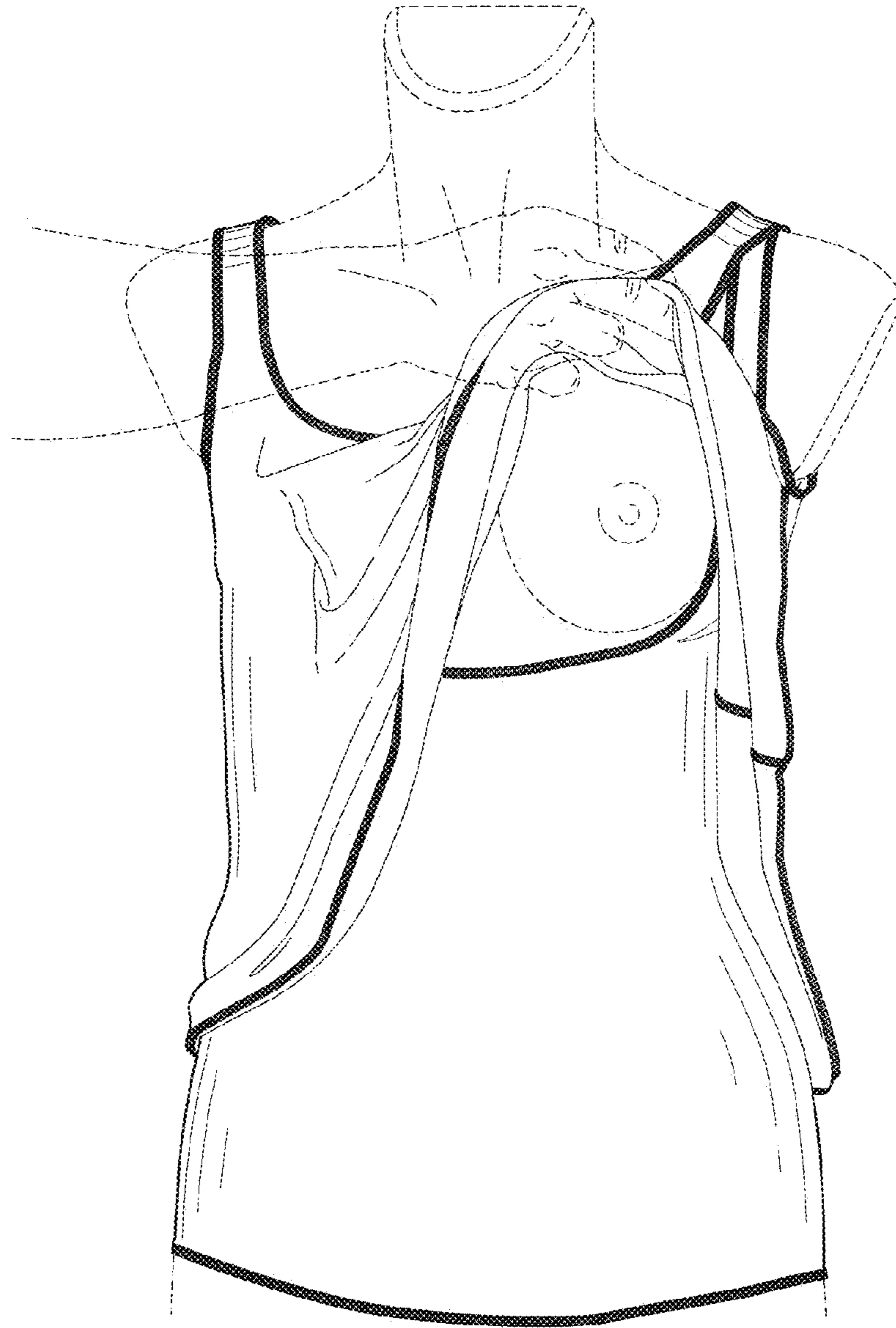

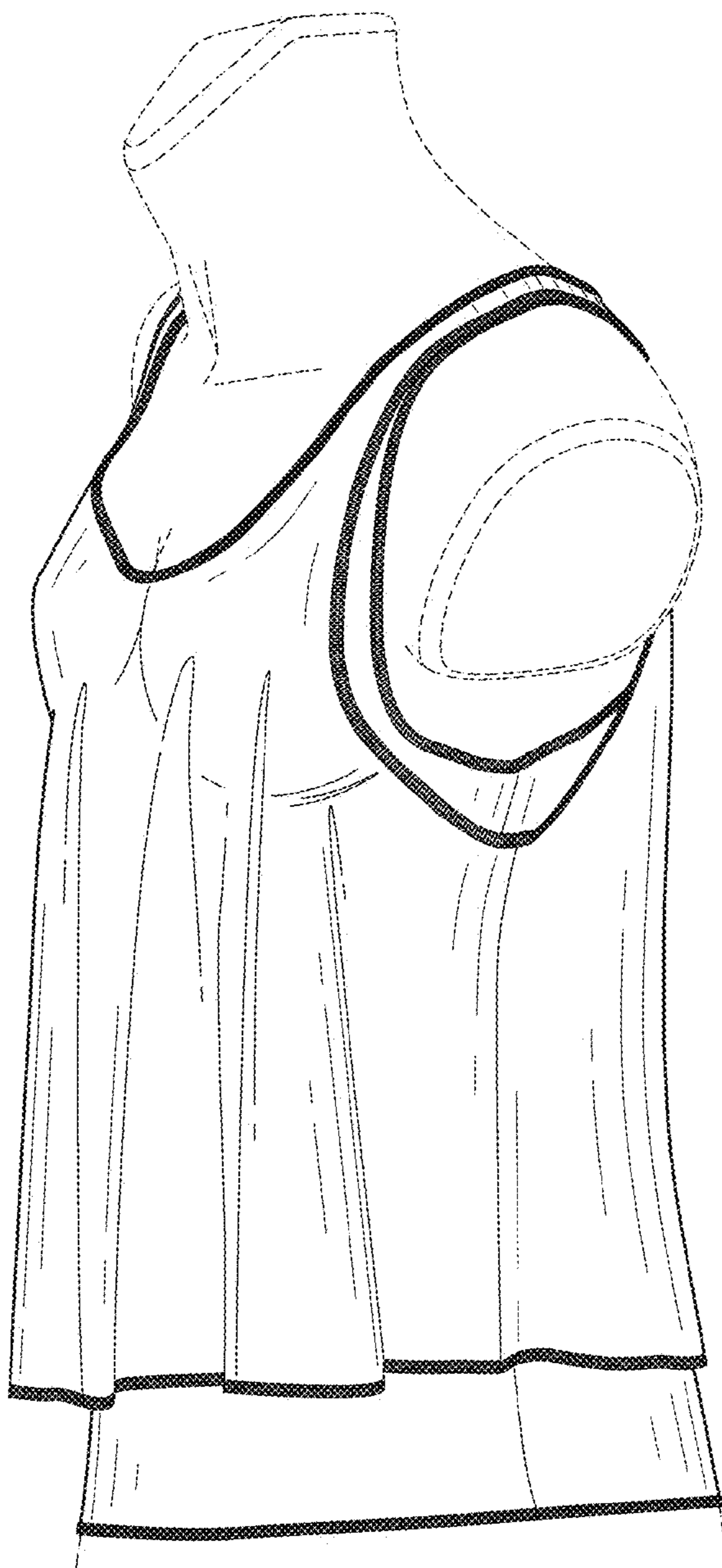

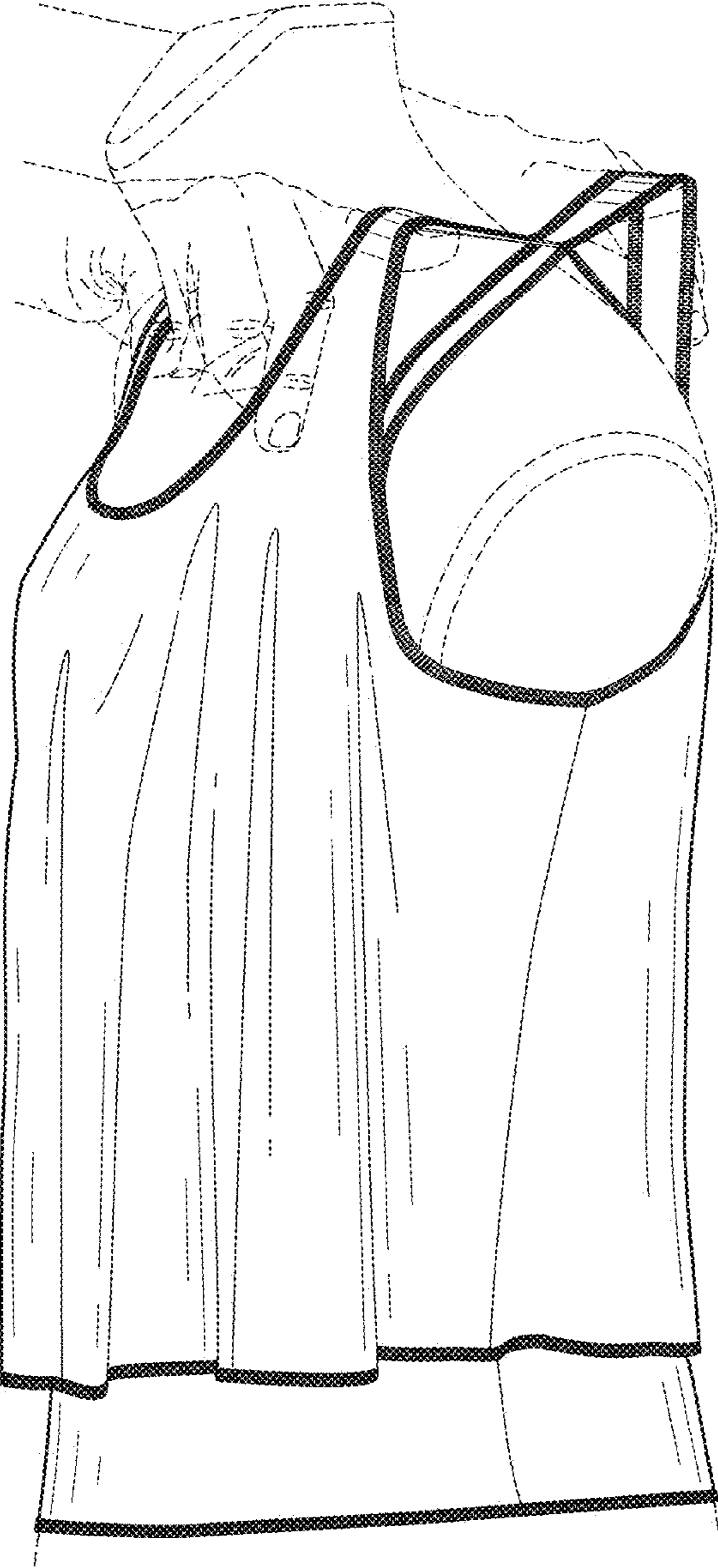

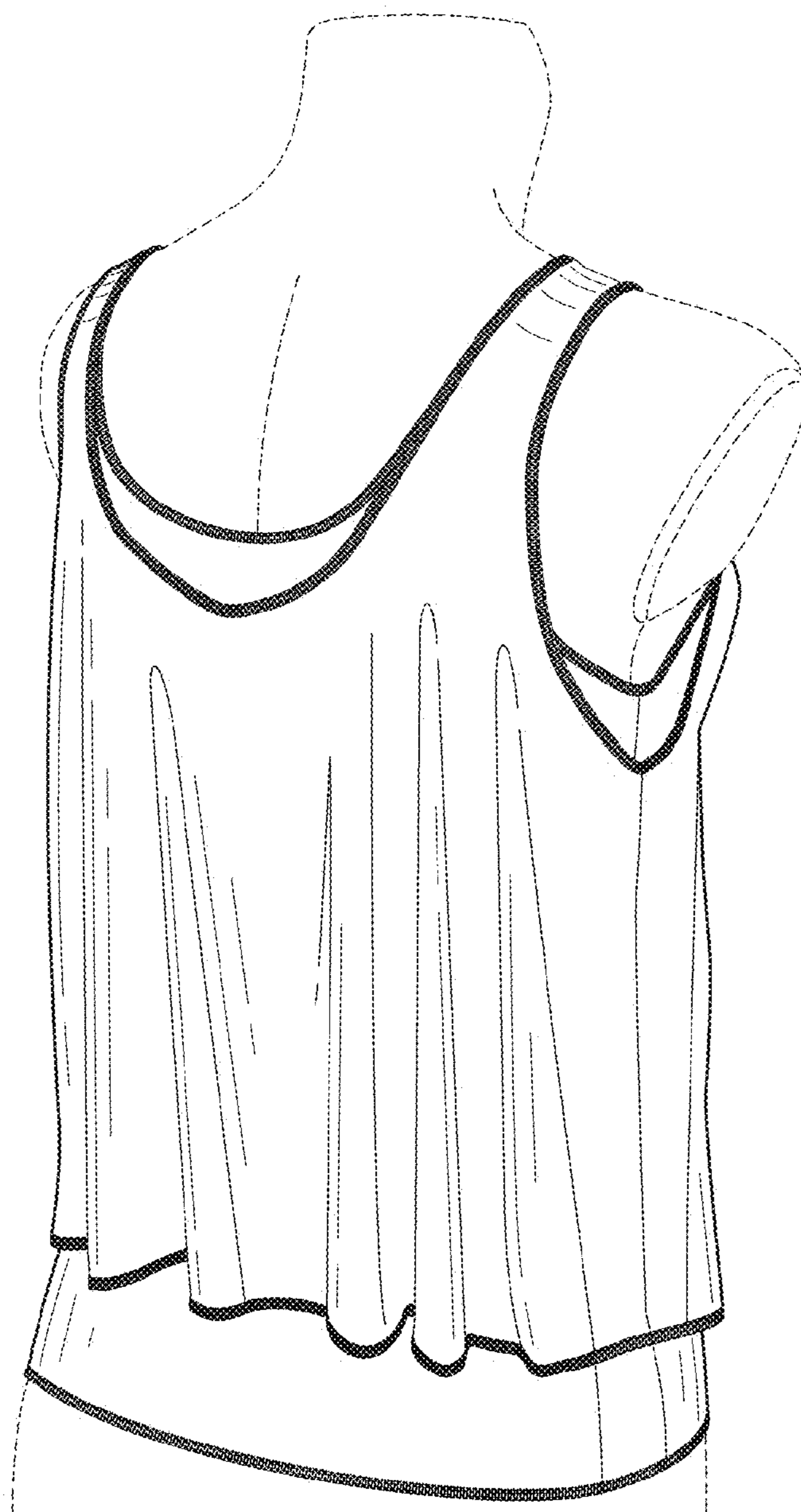
