FIG. 4 is a front view of the galosh of FIG. 1;

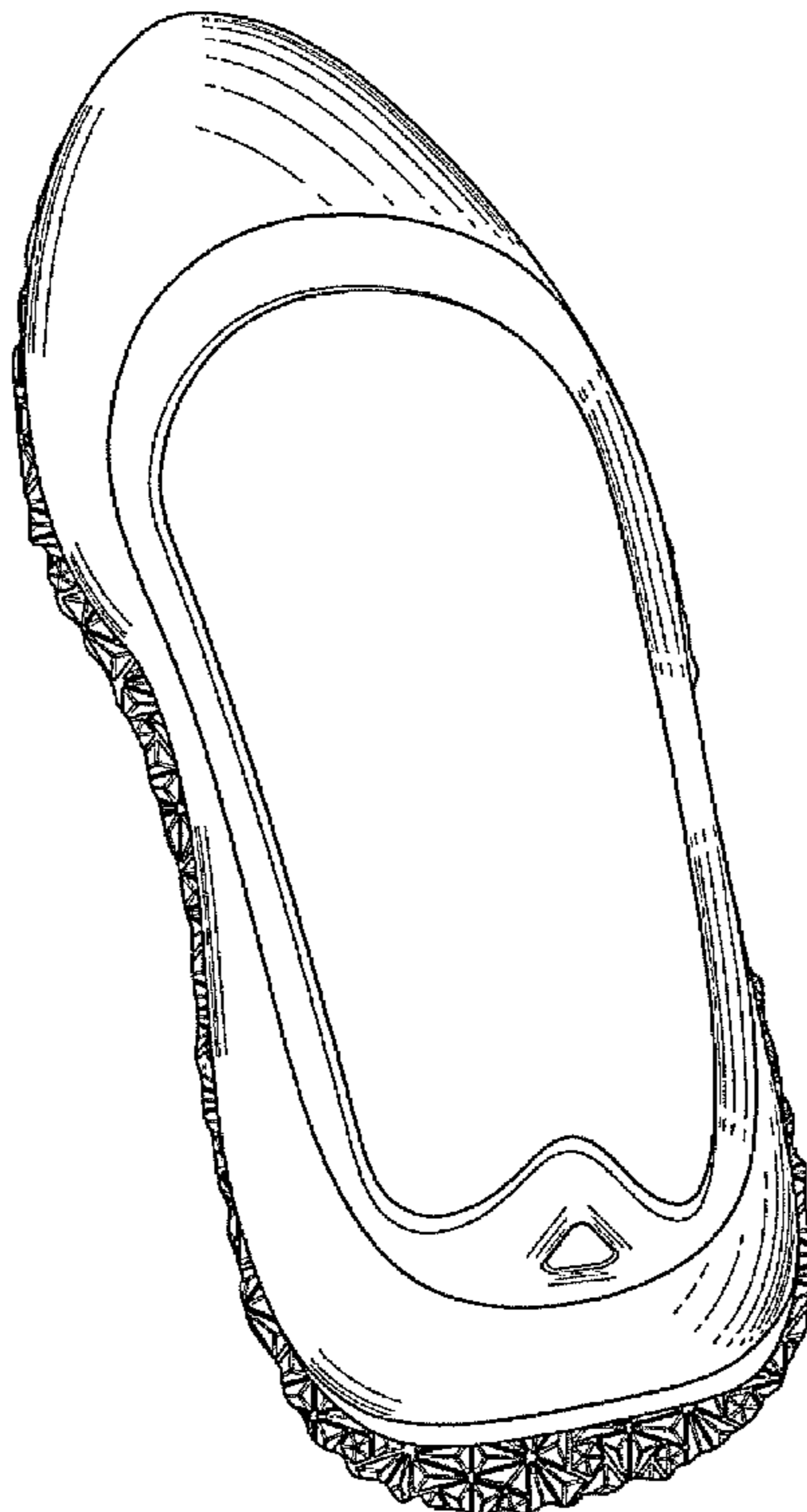
FIG. 5 is a back view of the galosh of FIG. 1;

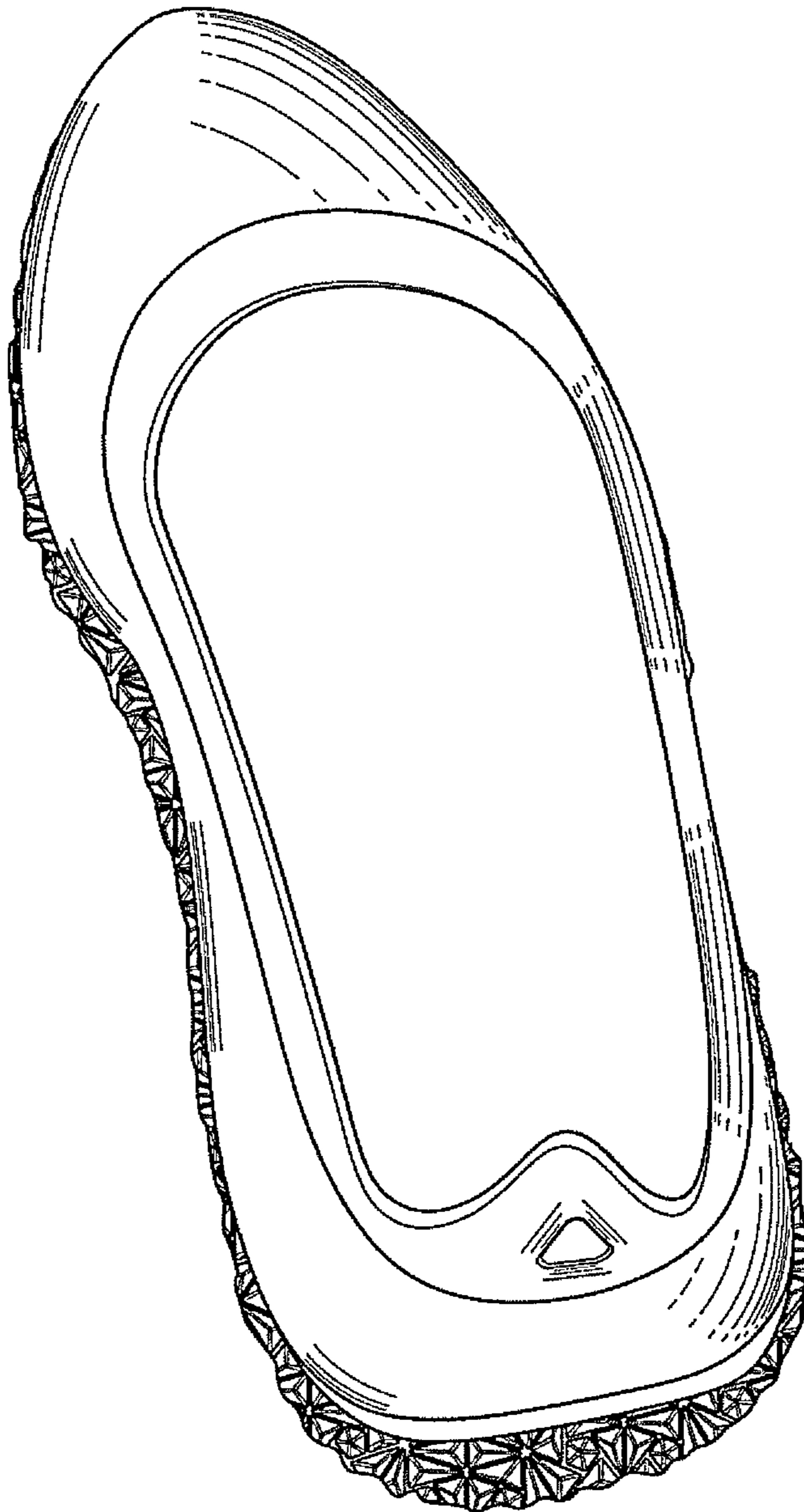

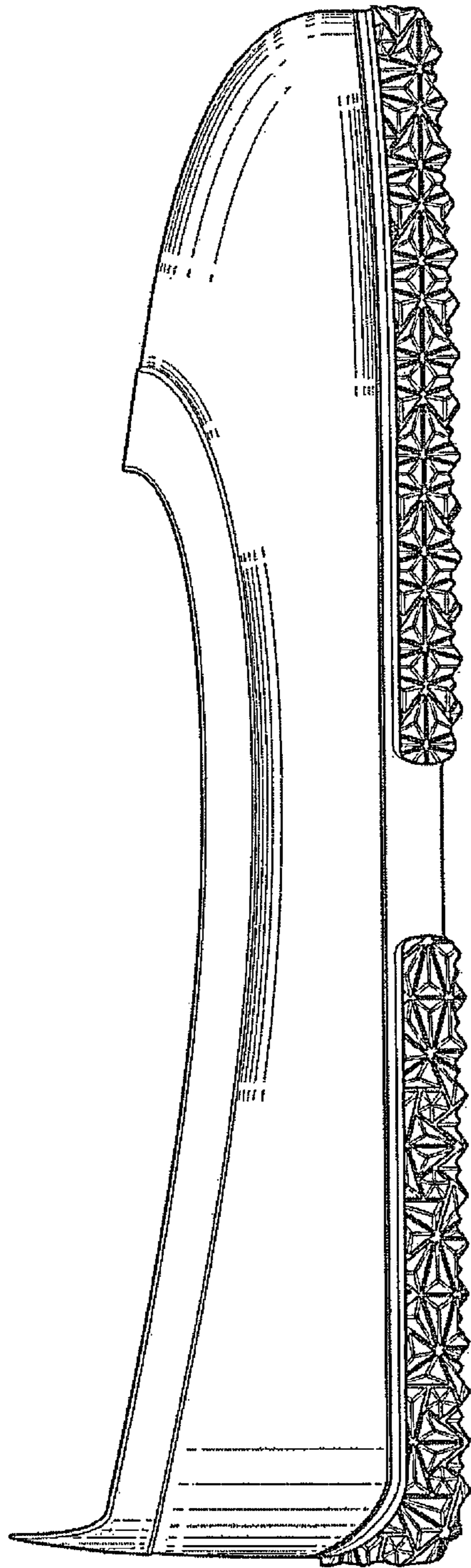

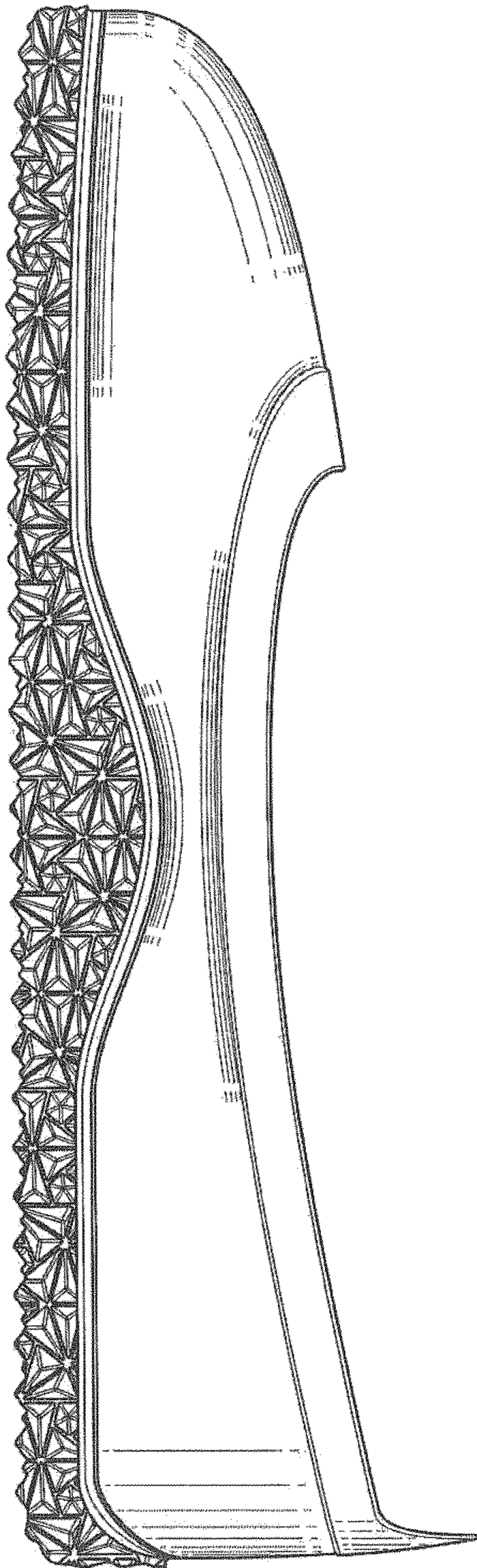

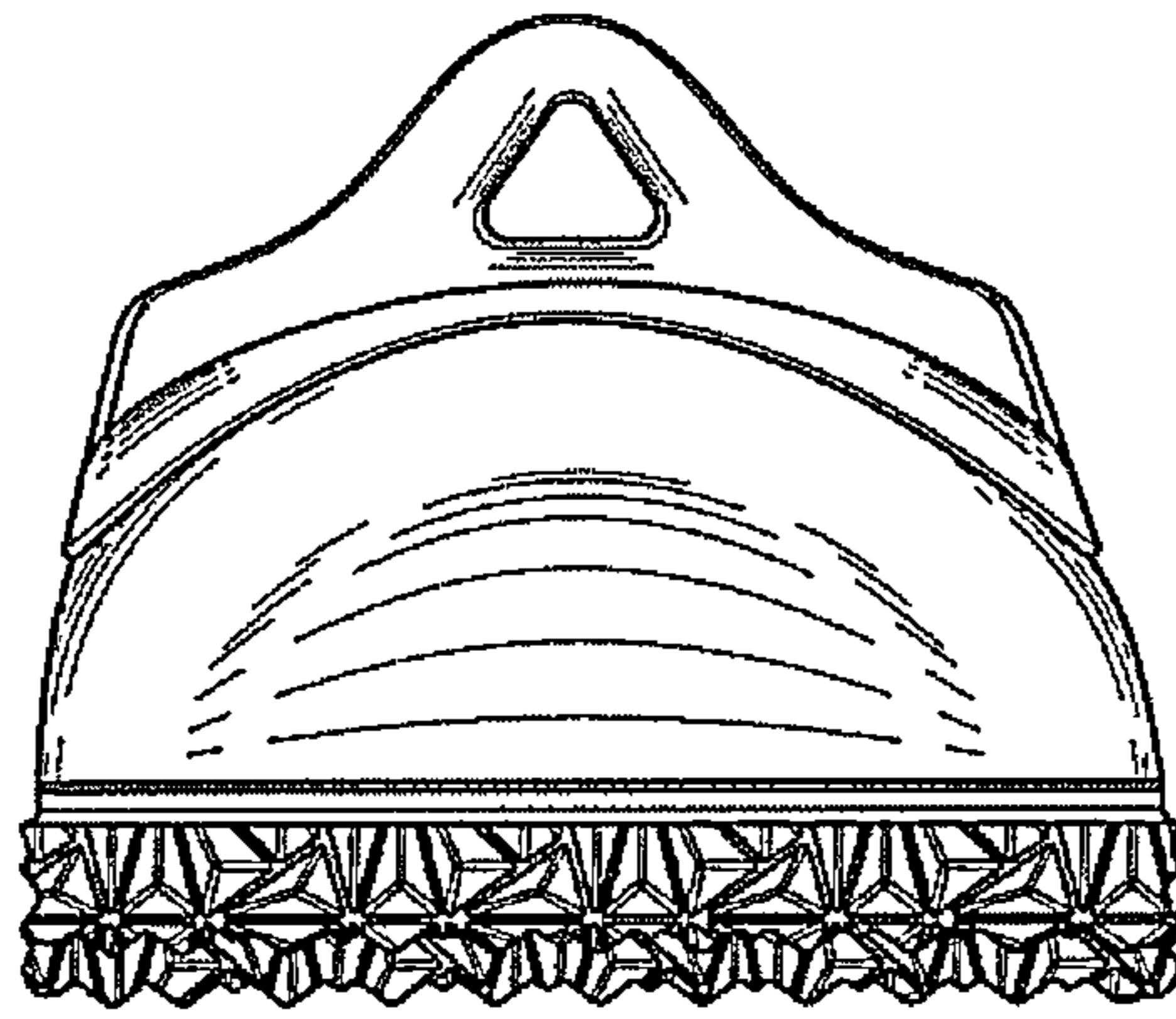

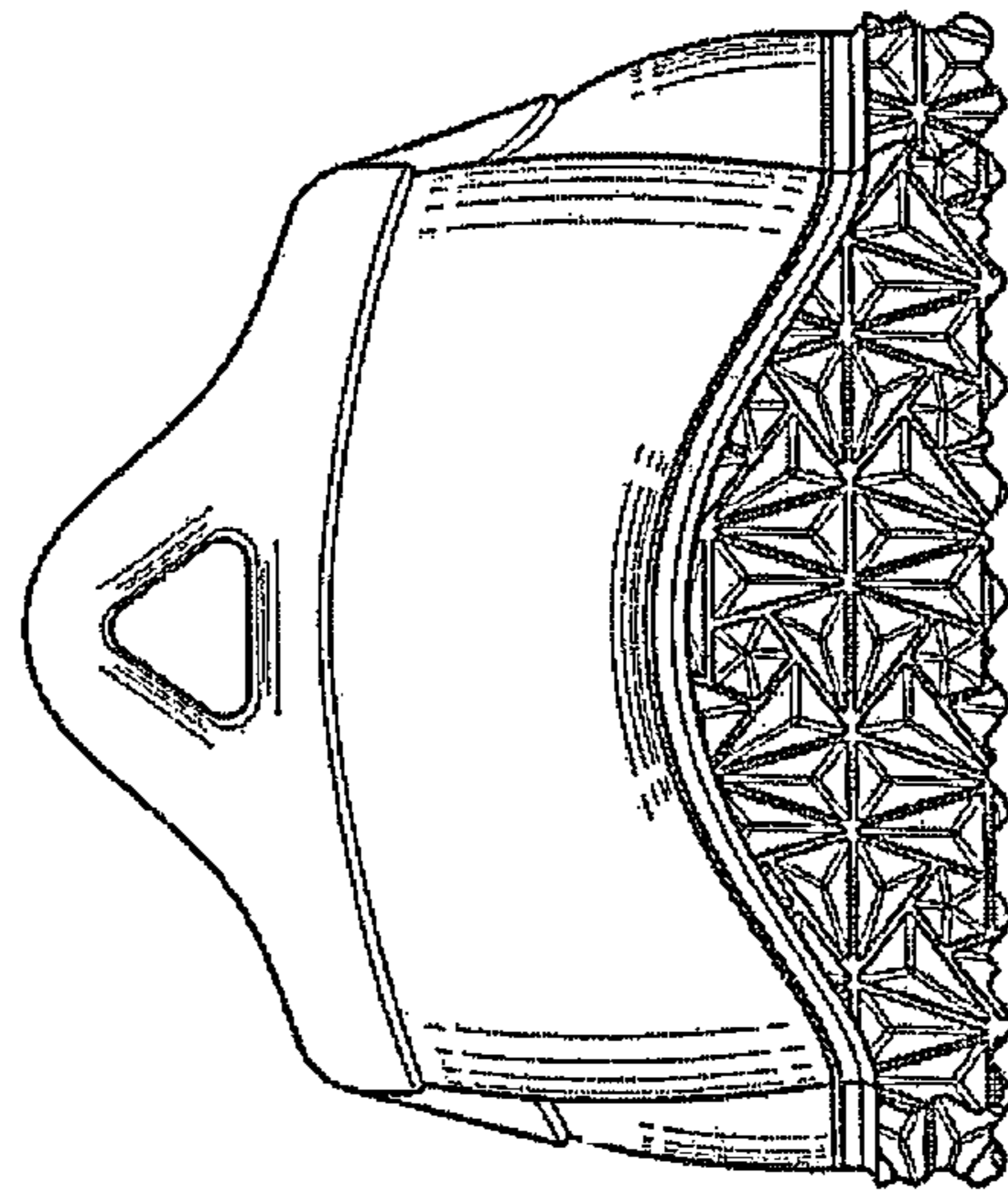

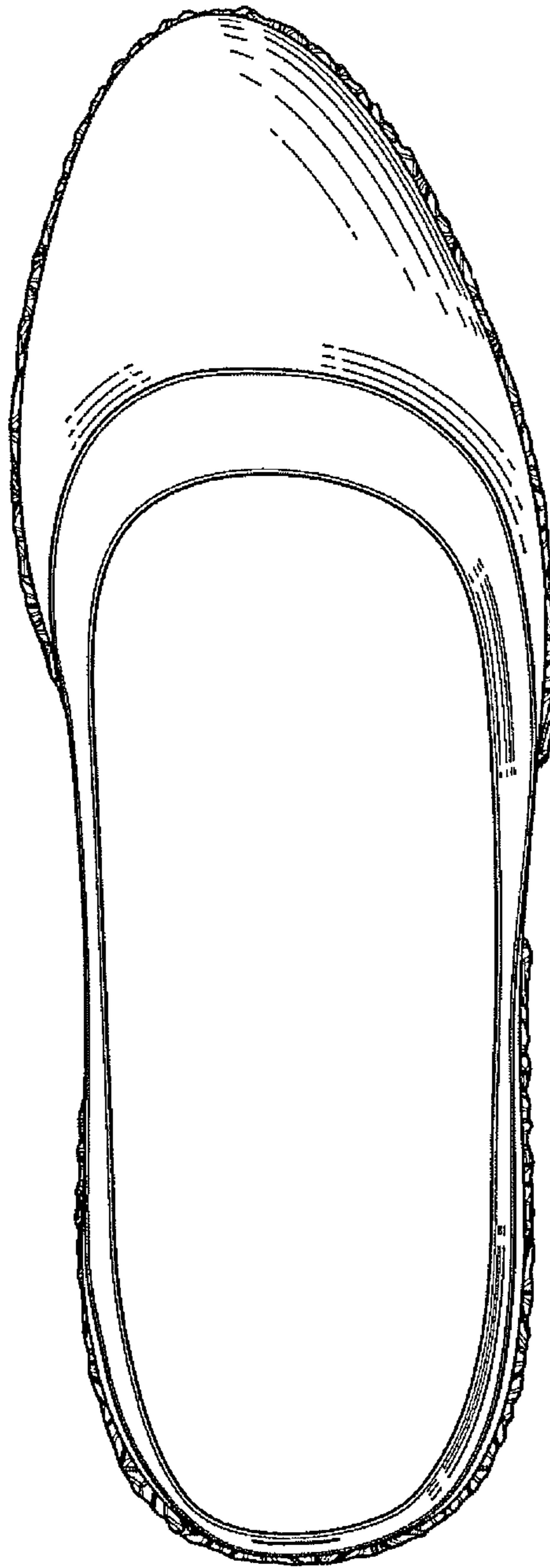

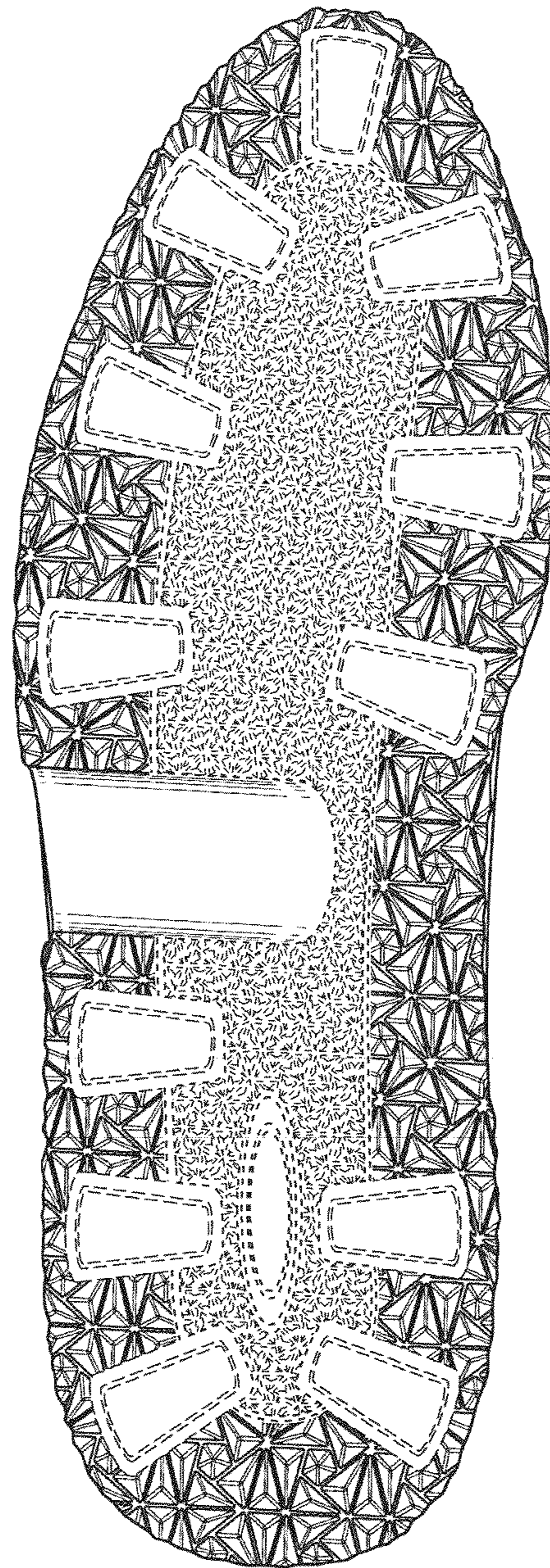
