FIG. 1 is a perspective view of the new design for a broom head;

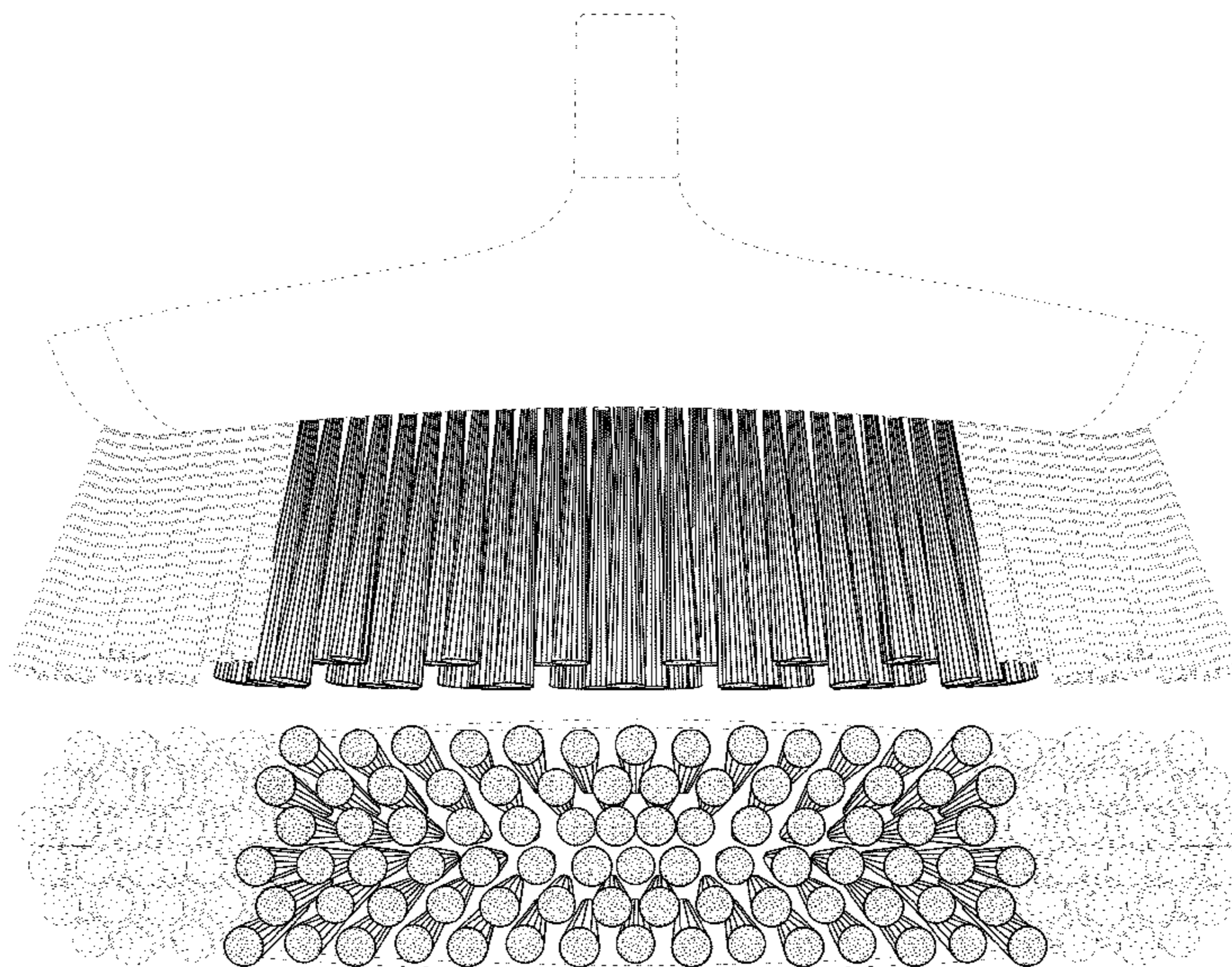

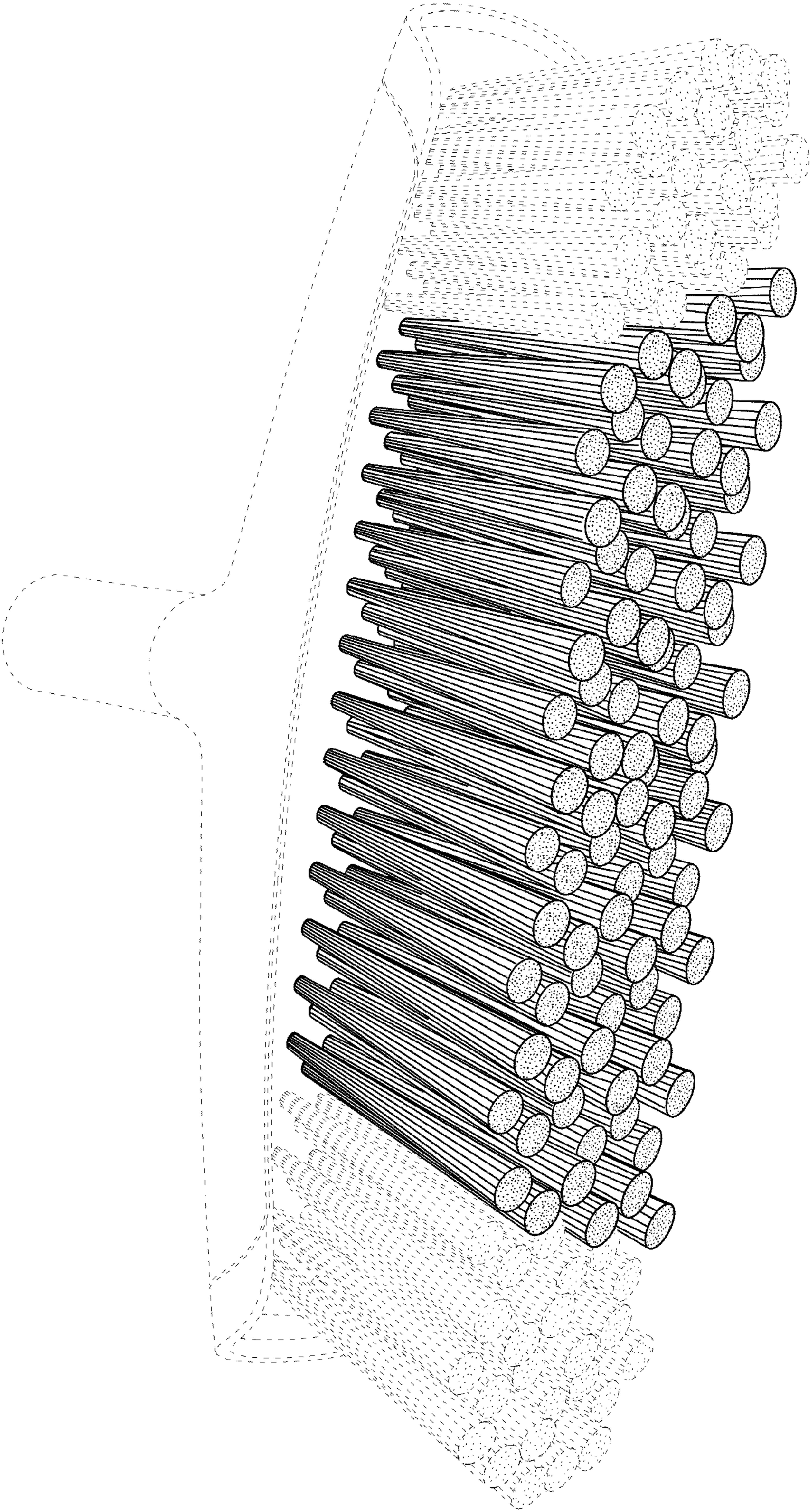

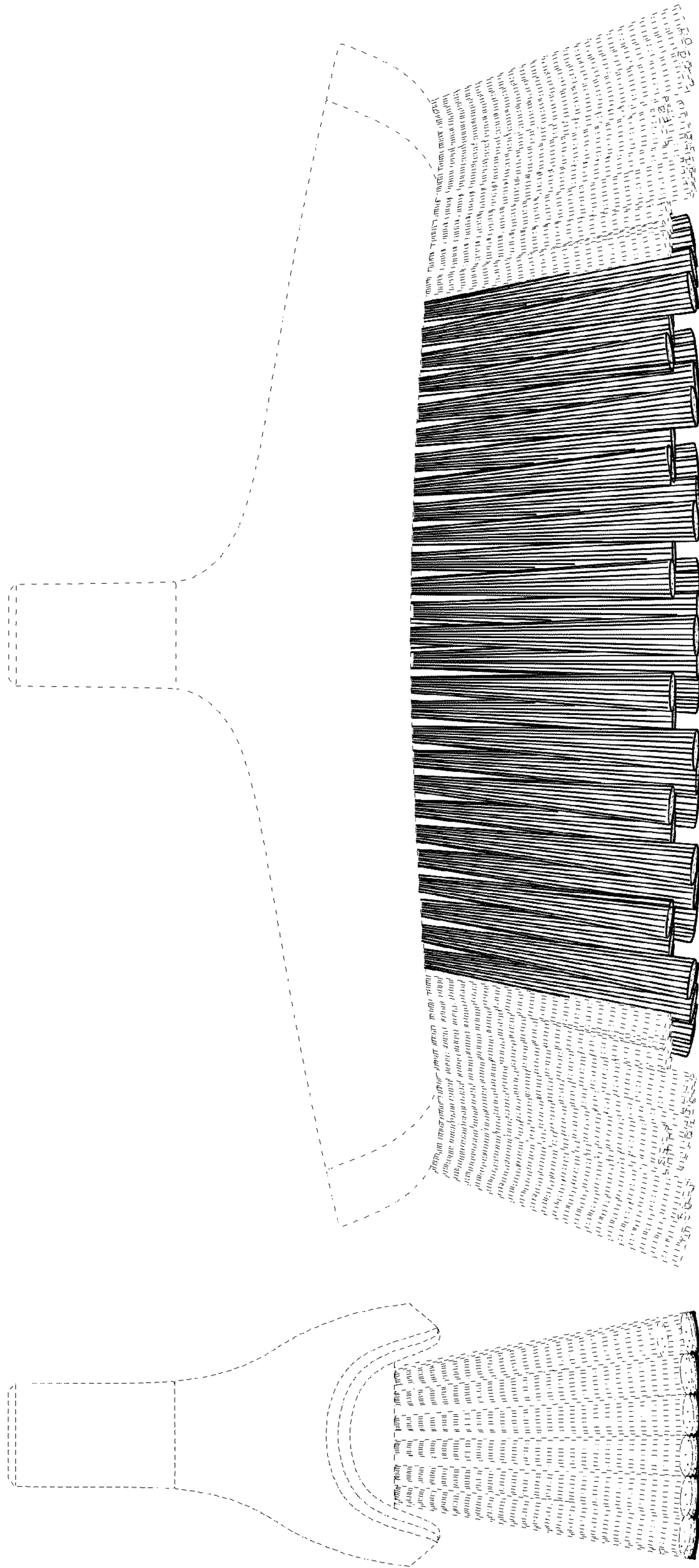
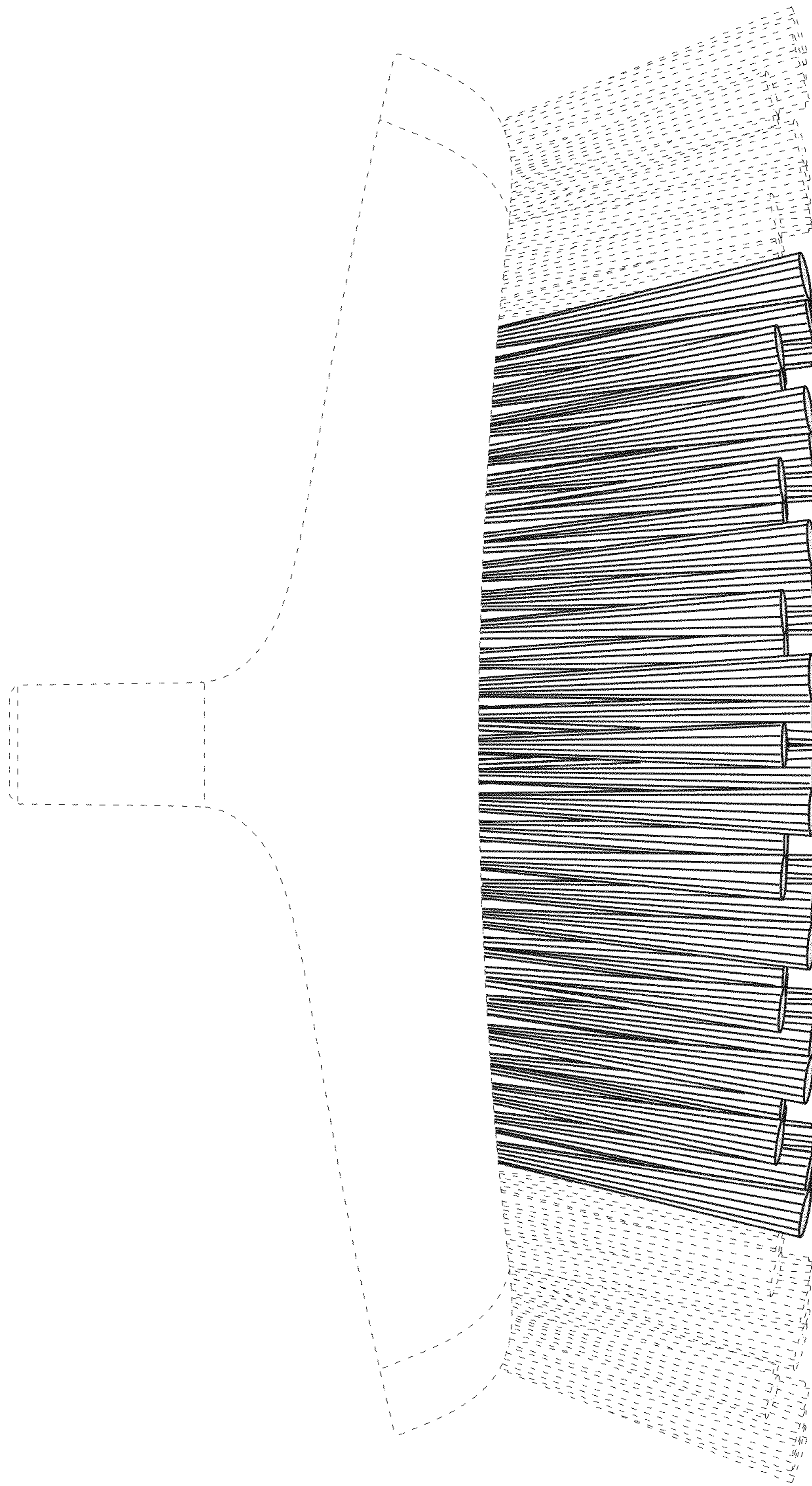


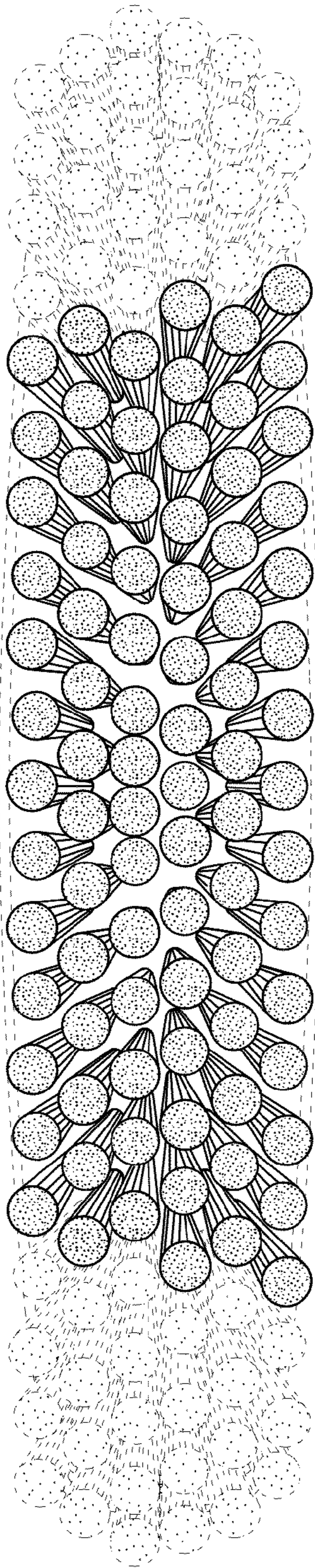

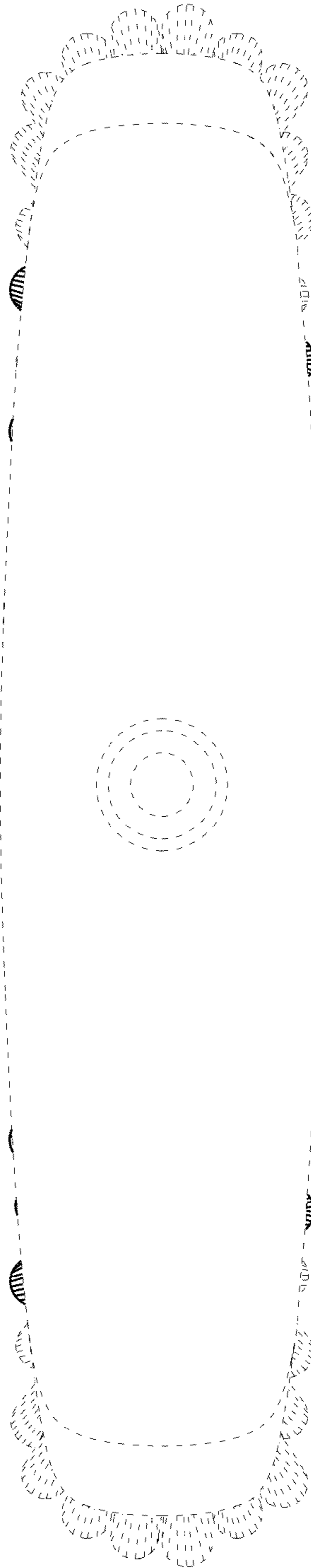

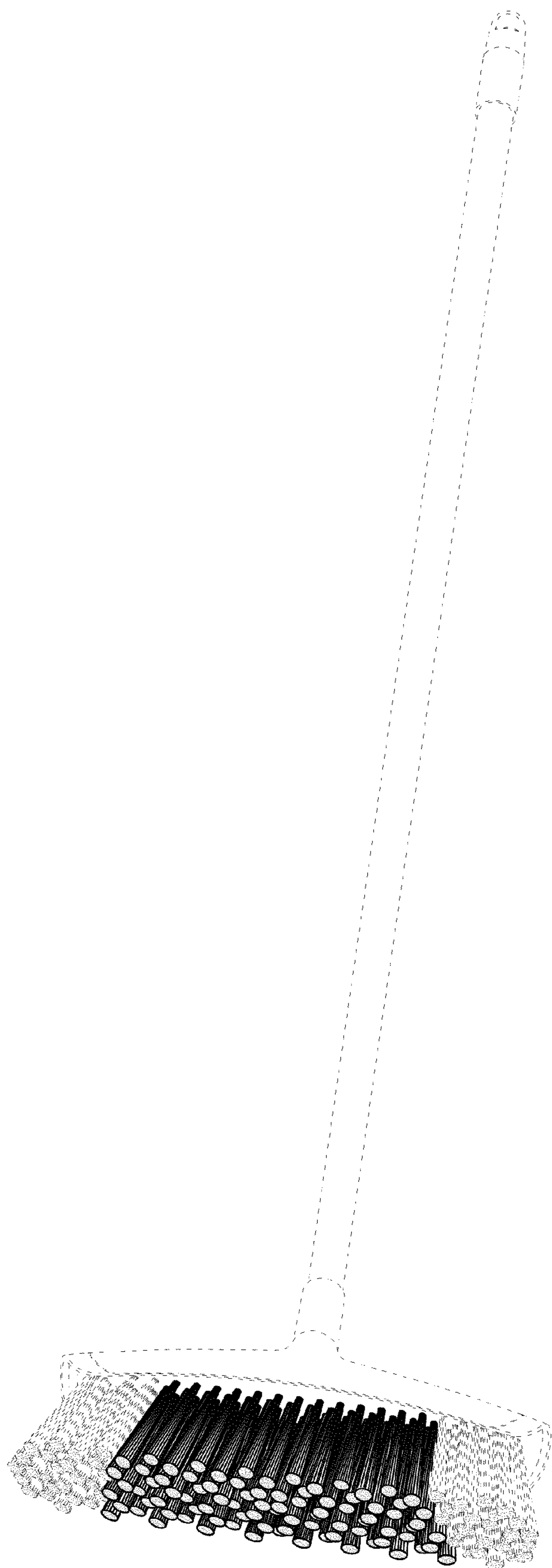
