FIG. 3 is a right side view of the mattress cover of FIG. 1 with the left side being a mirror image thereof.

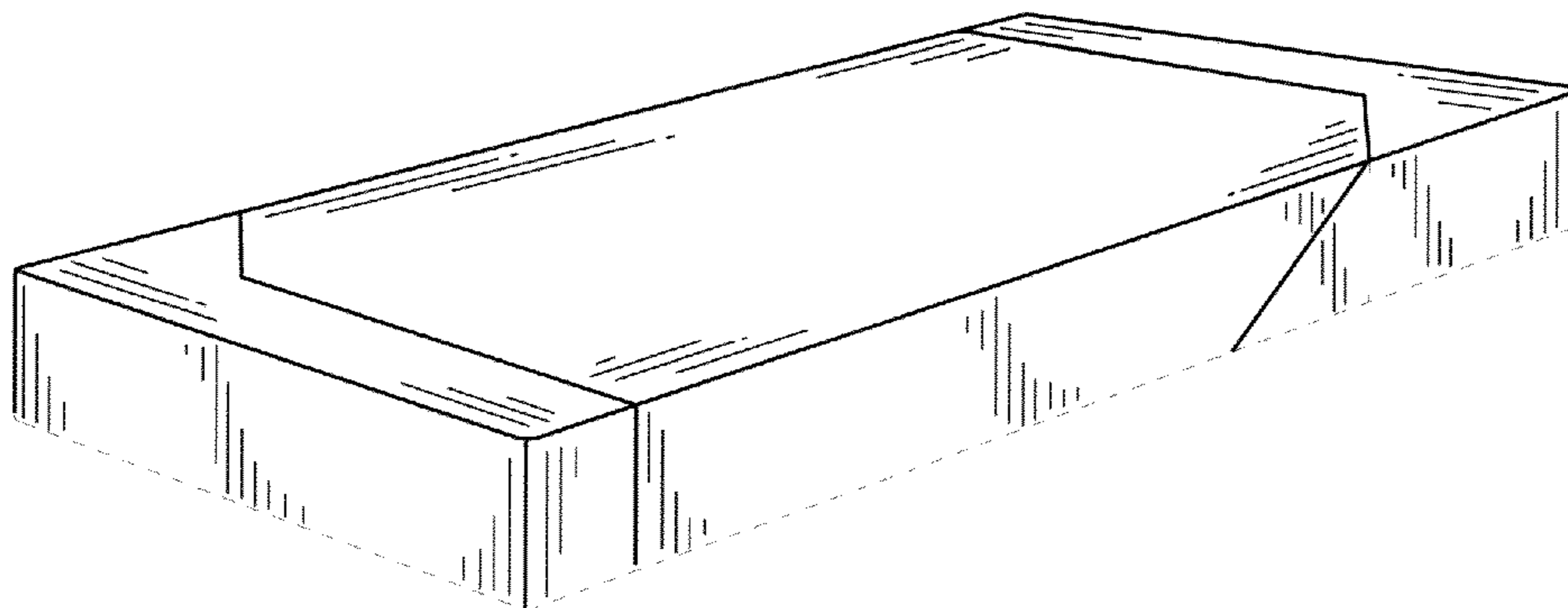
FIG. 4 is a right end view of the mattress cover of FIG. 1 with the left side being a mirror image thereof; and,

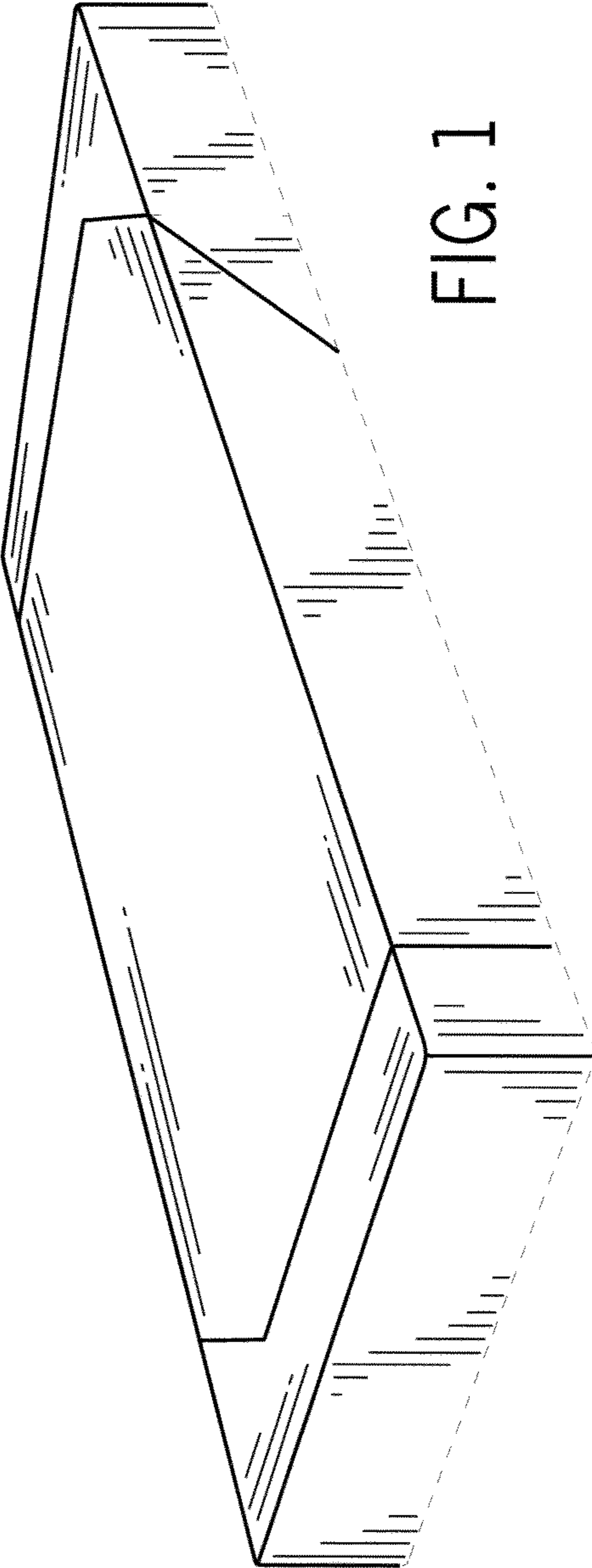

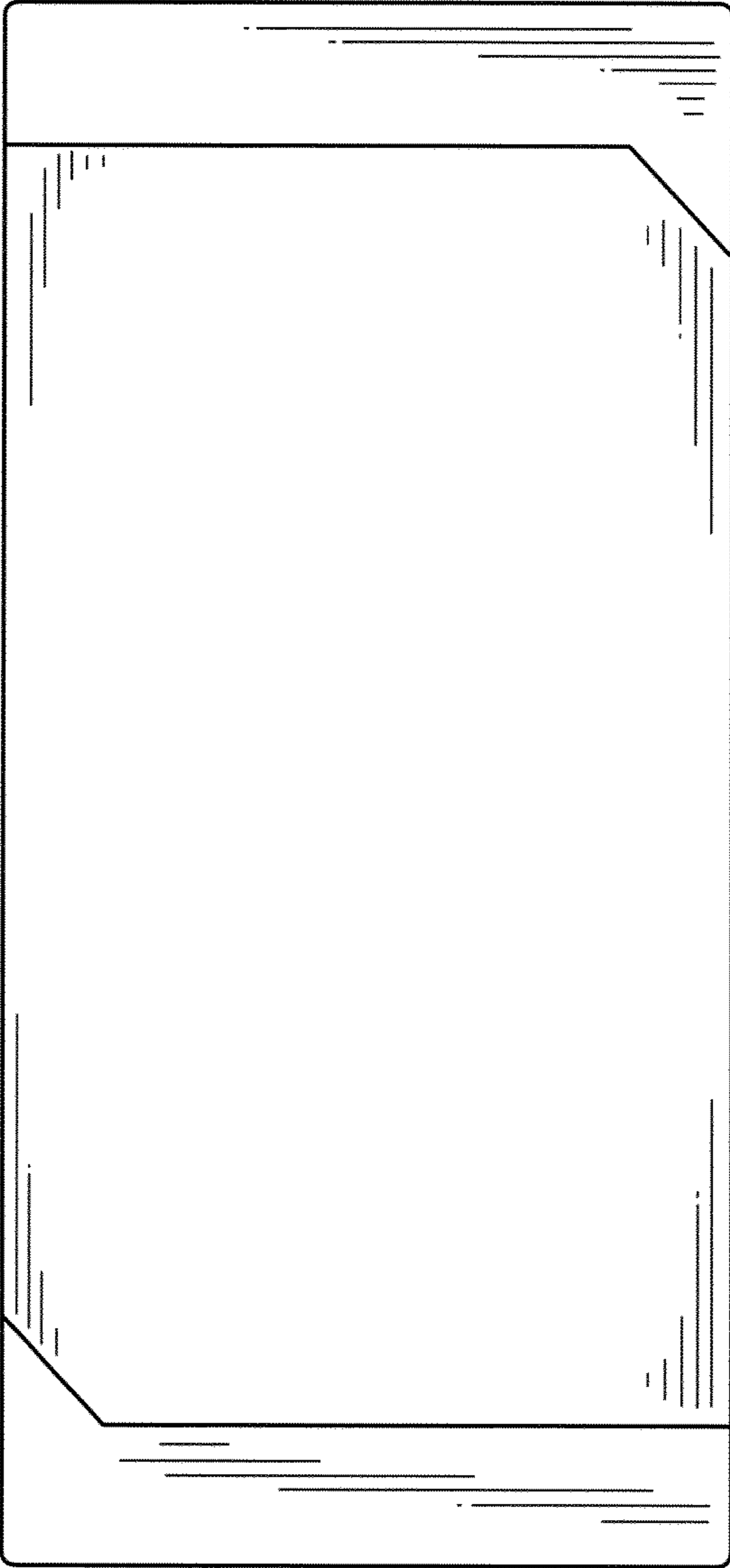

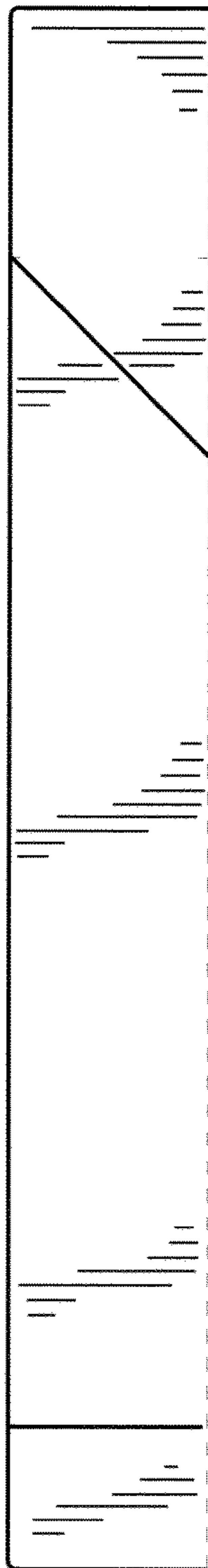

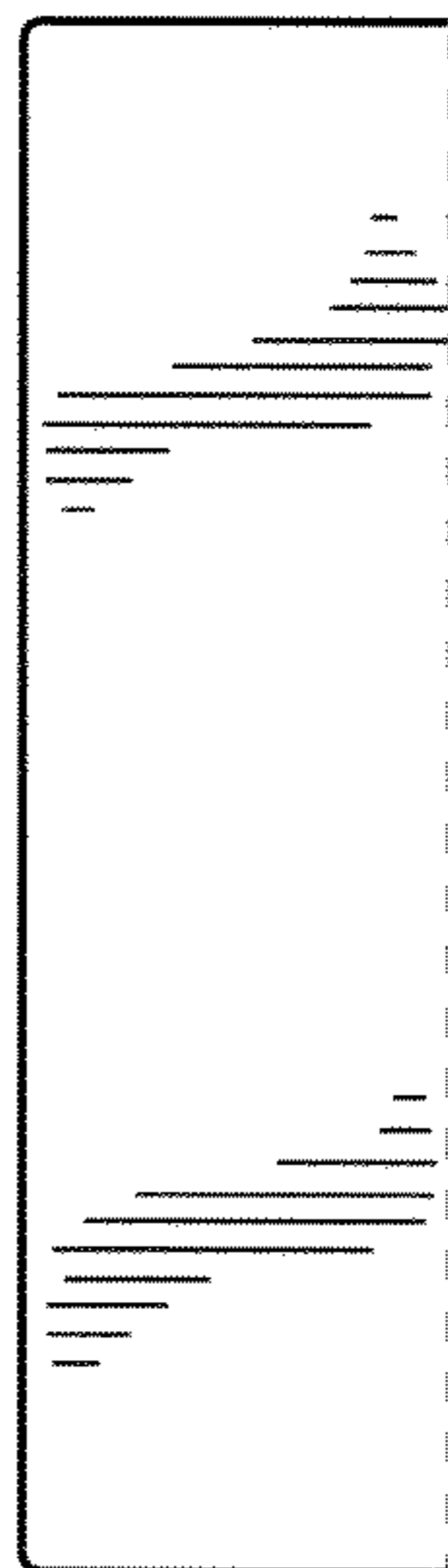

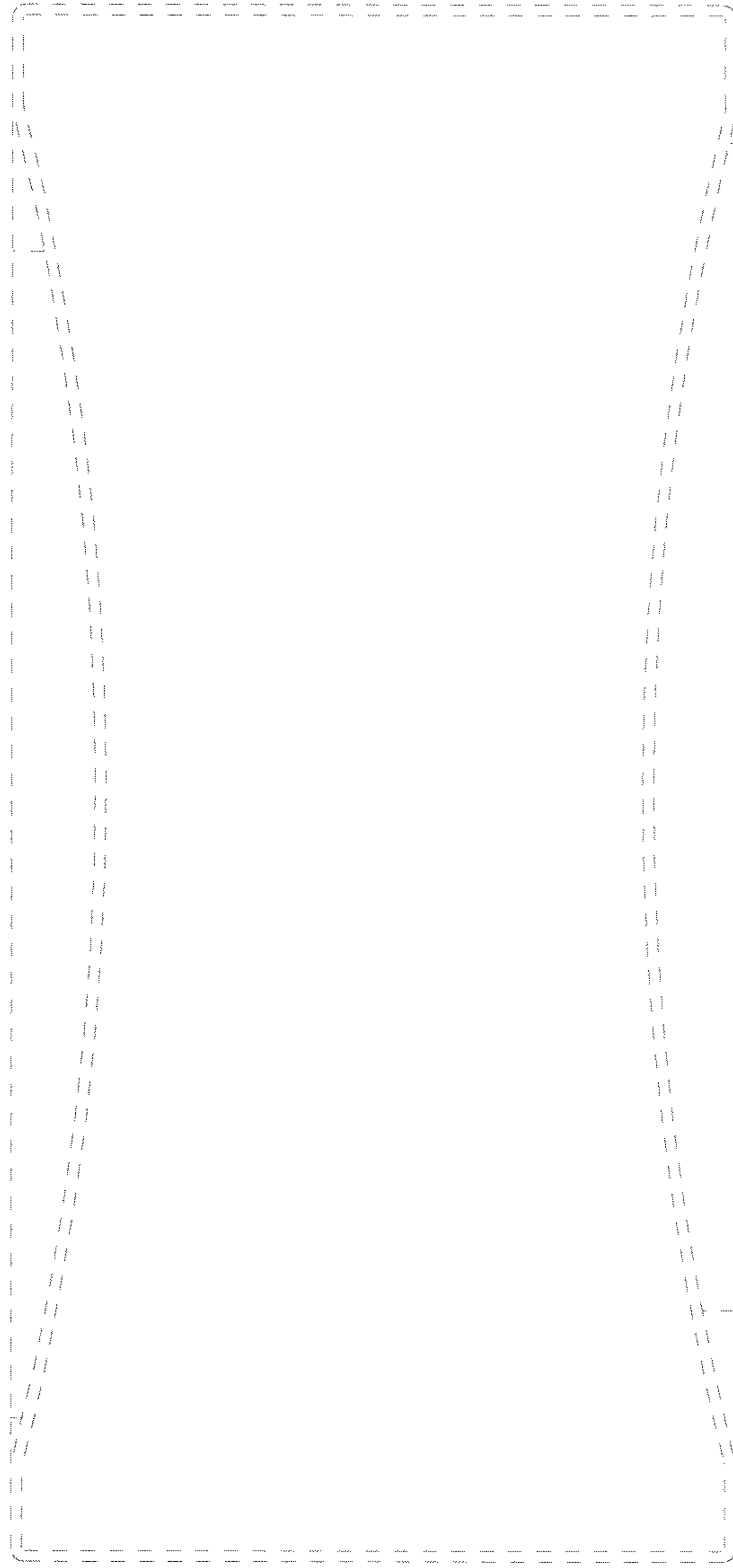
