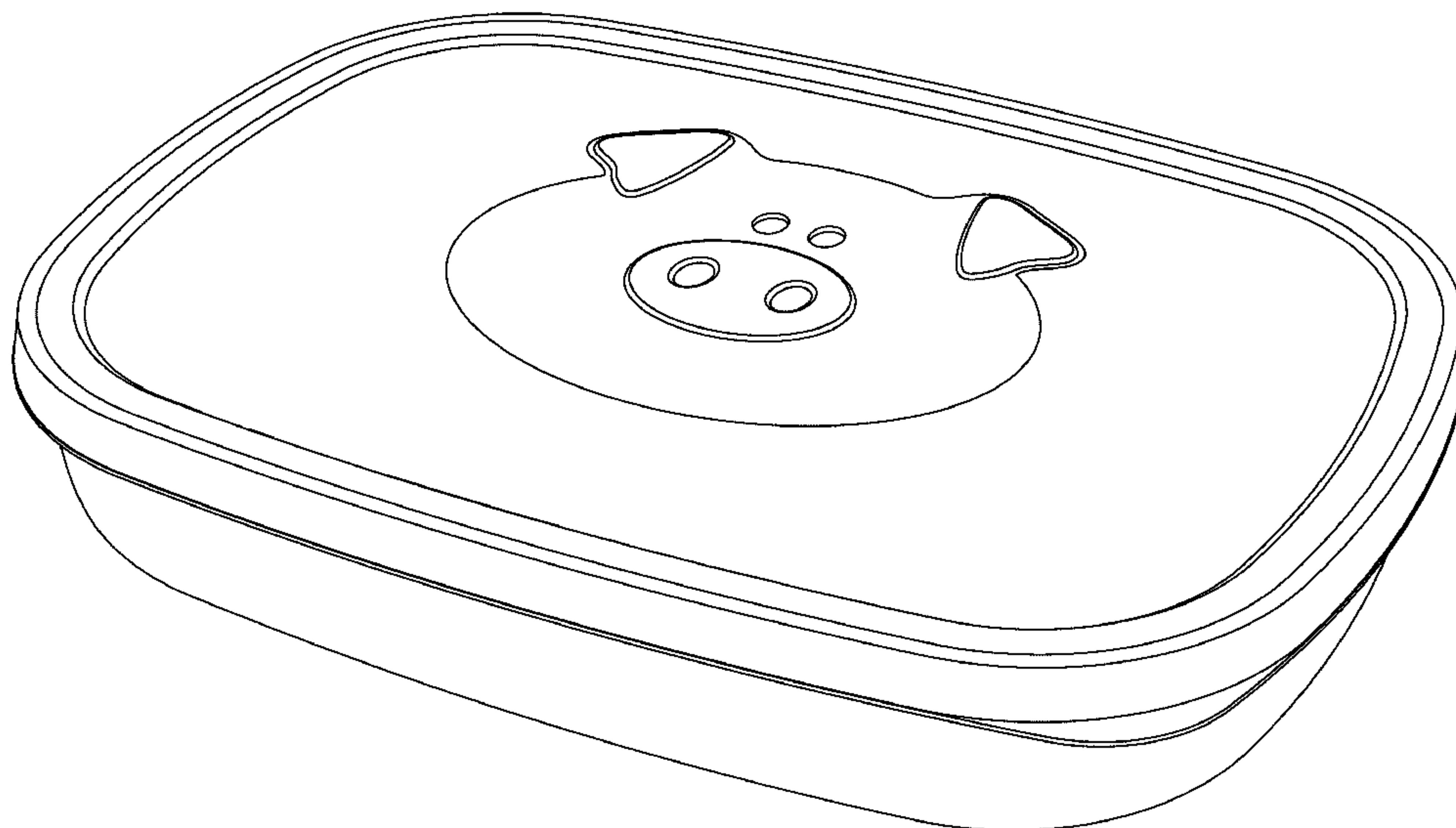

**DESCRIPTION**

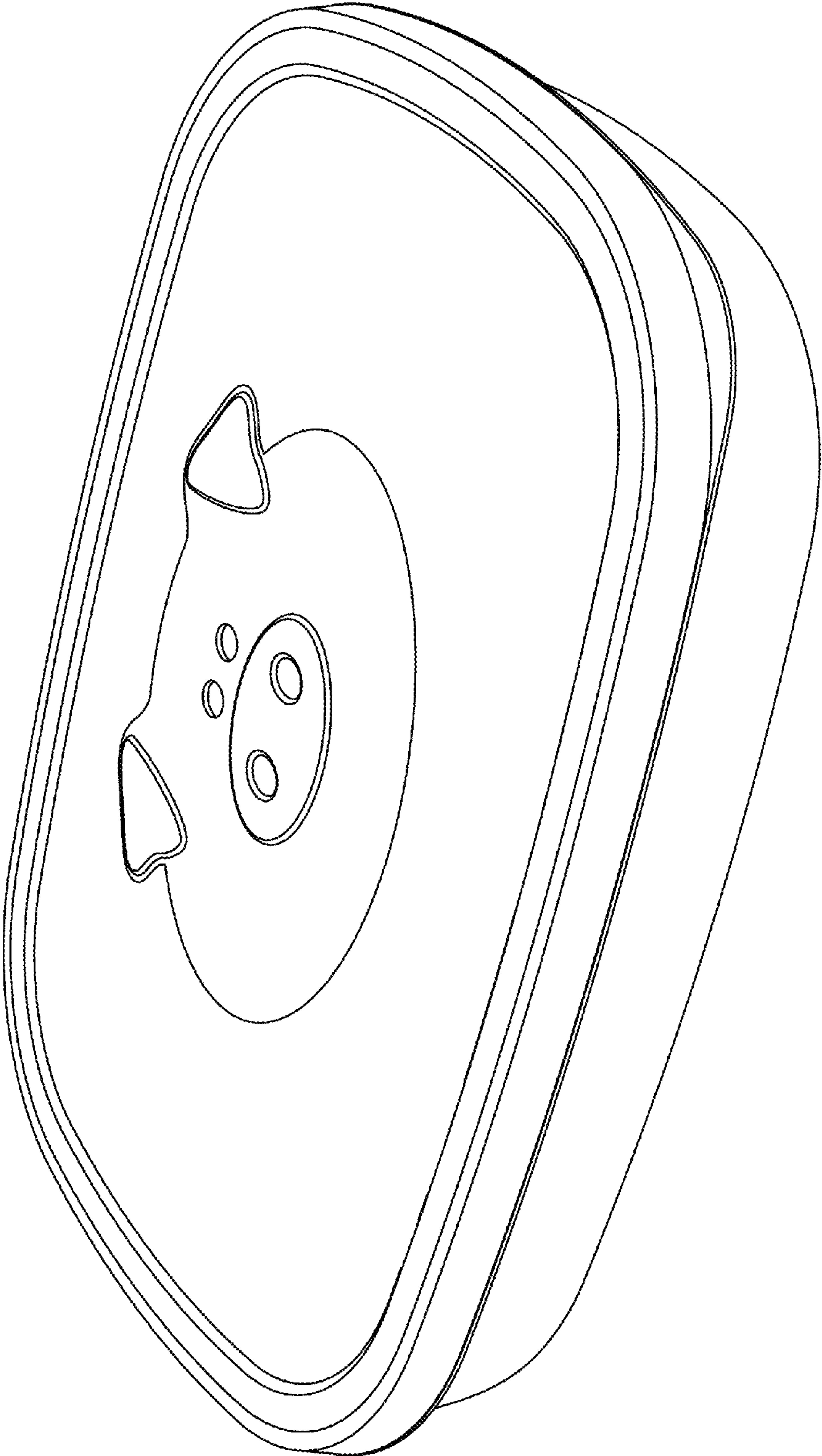

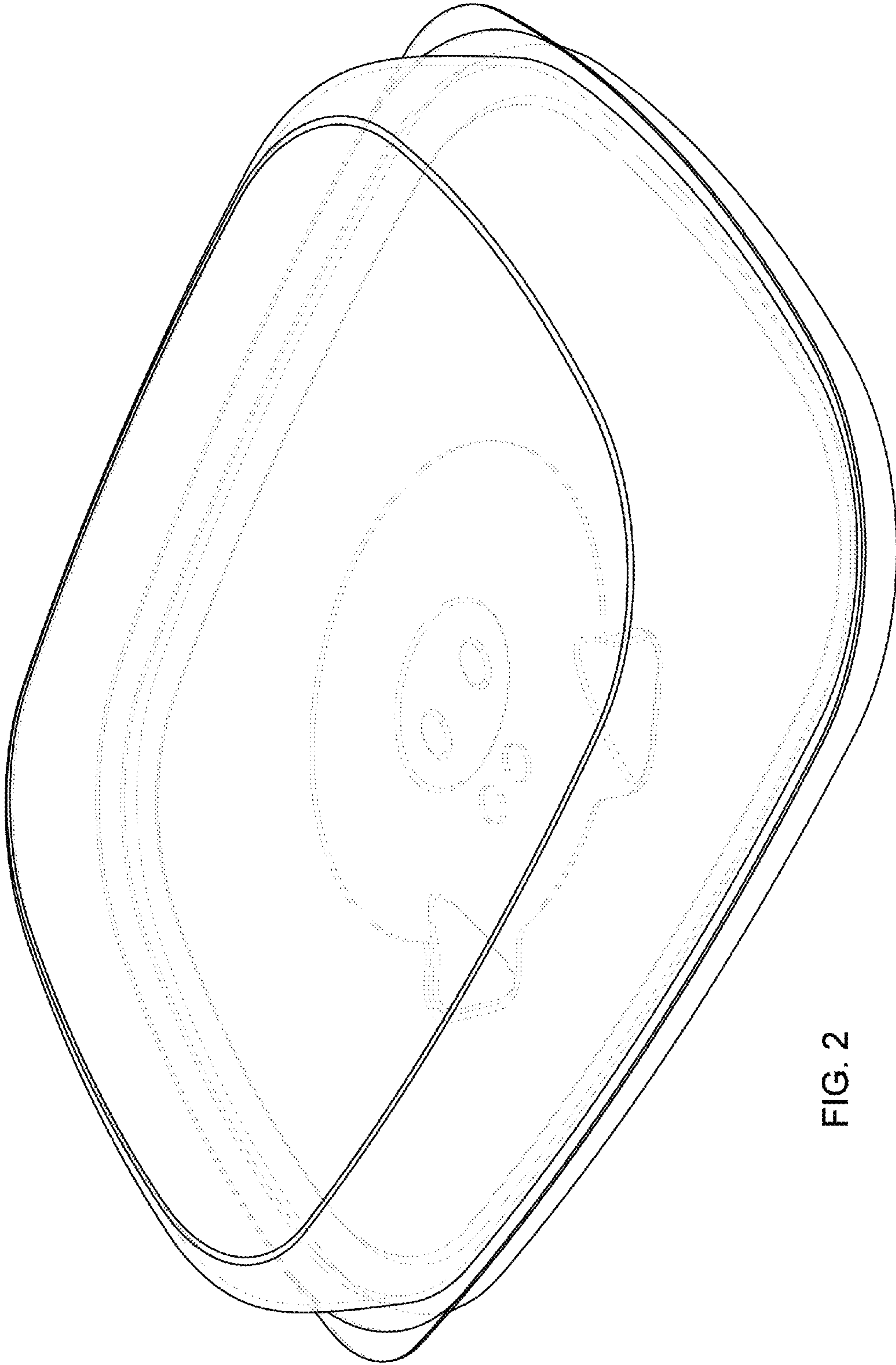

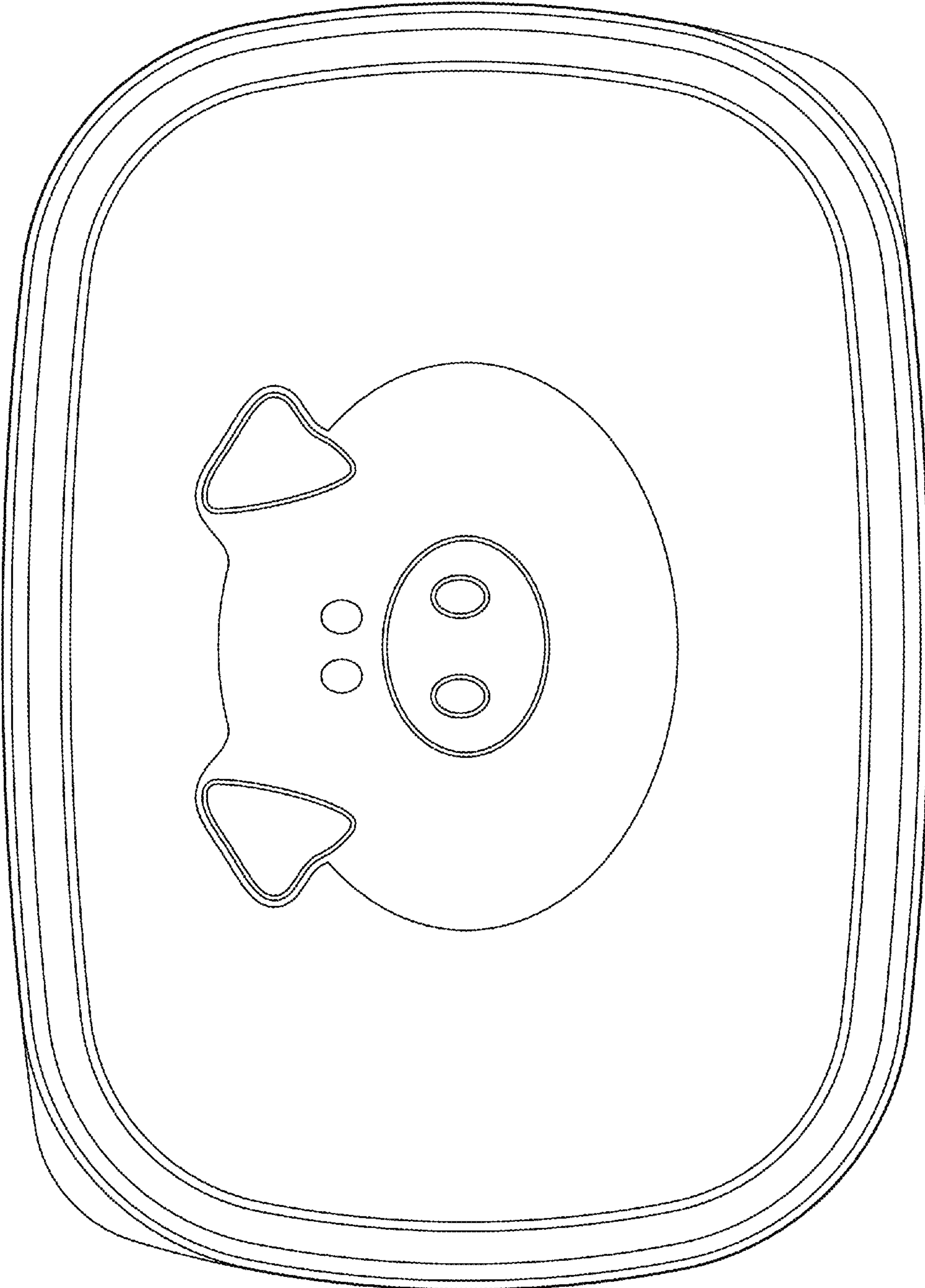

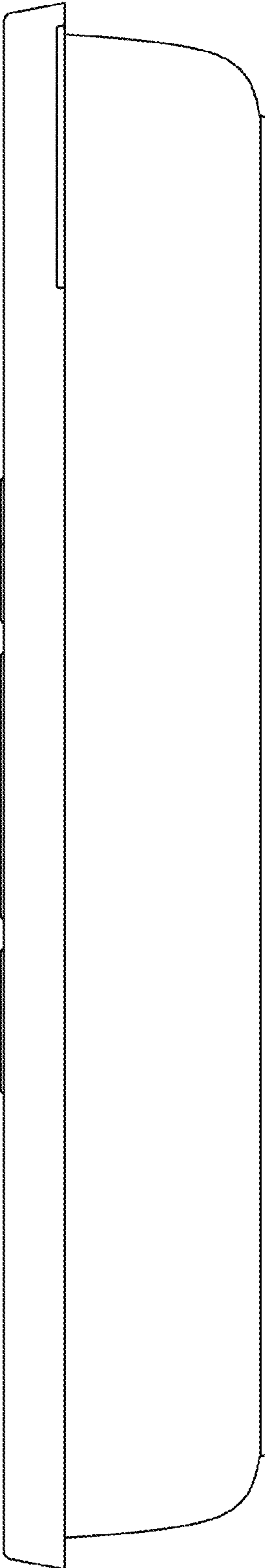

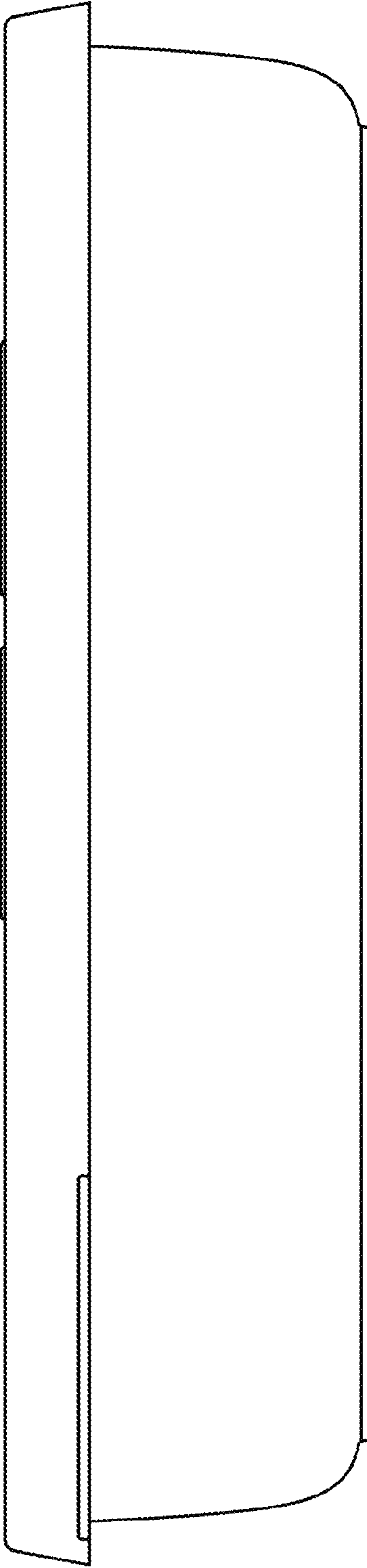
